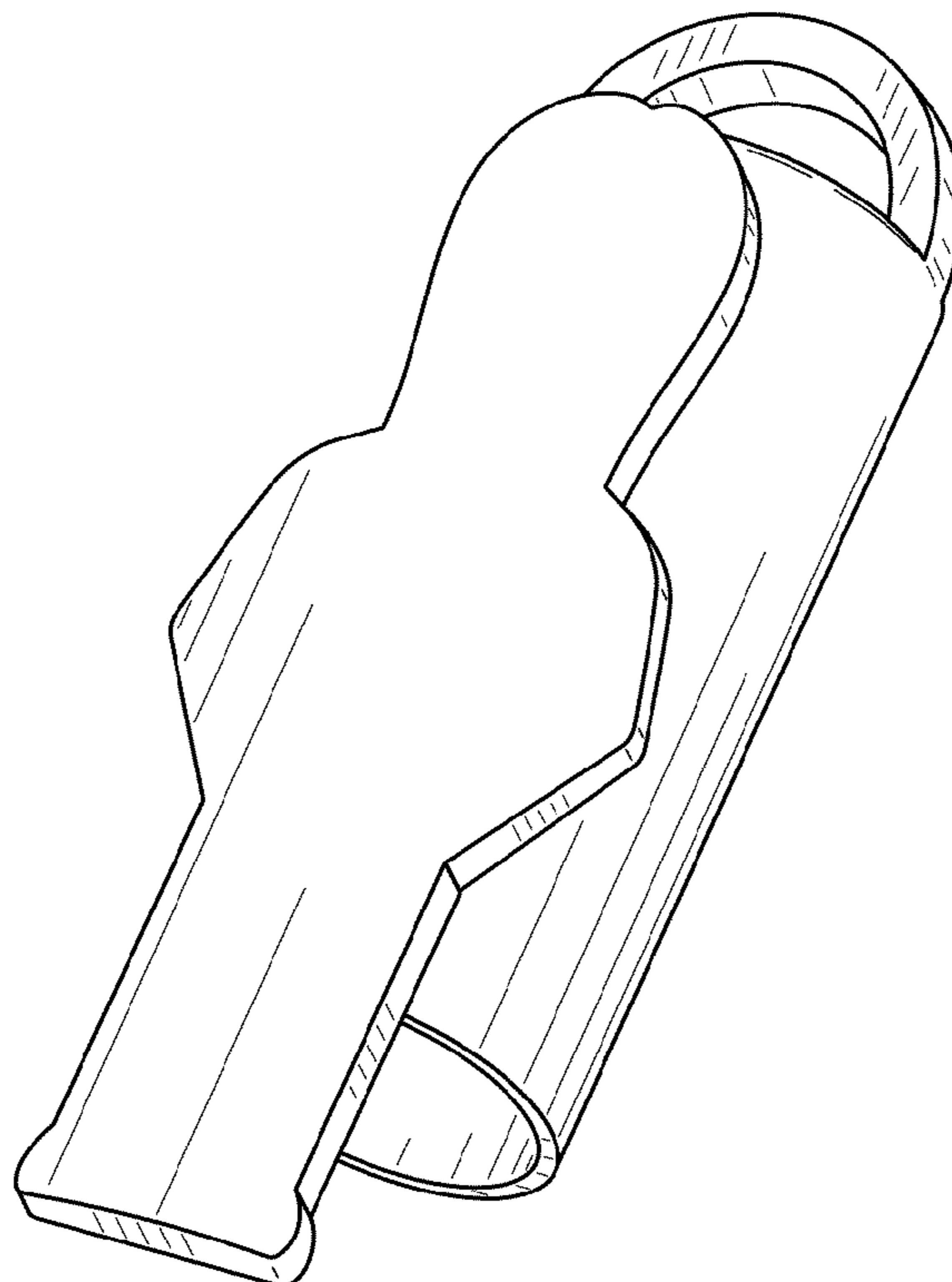
The broken line showing the inside in FIG. 7 is included for the purpose of showing a portion of the cap that forms no part of the claimed design.

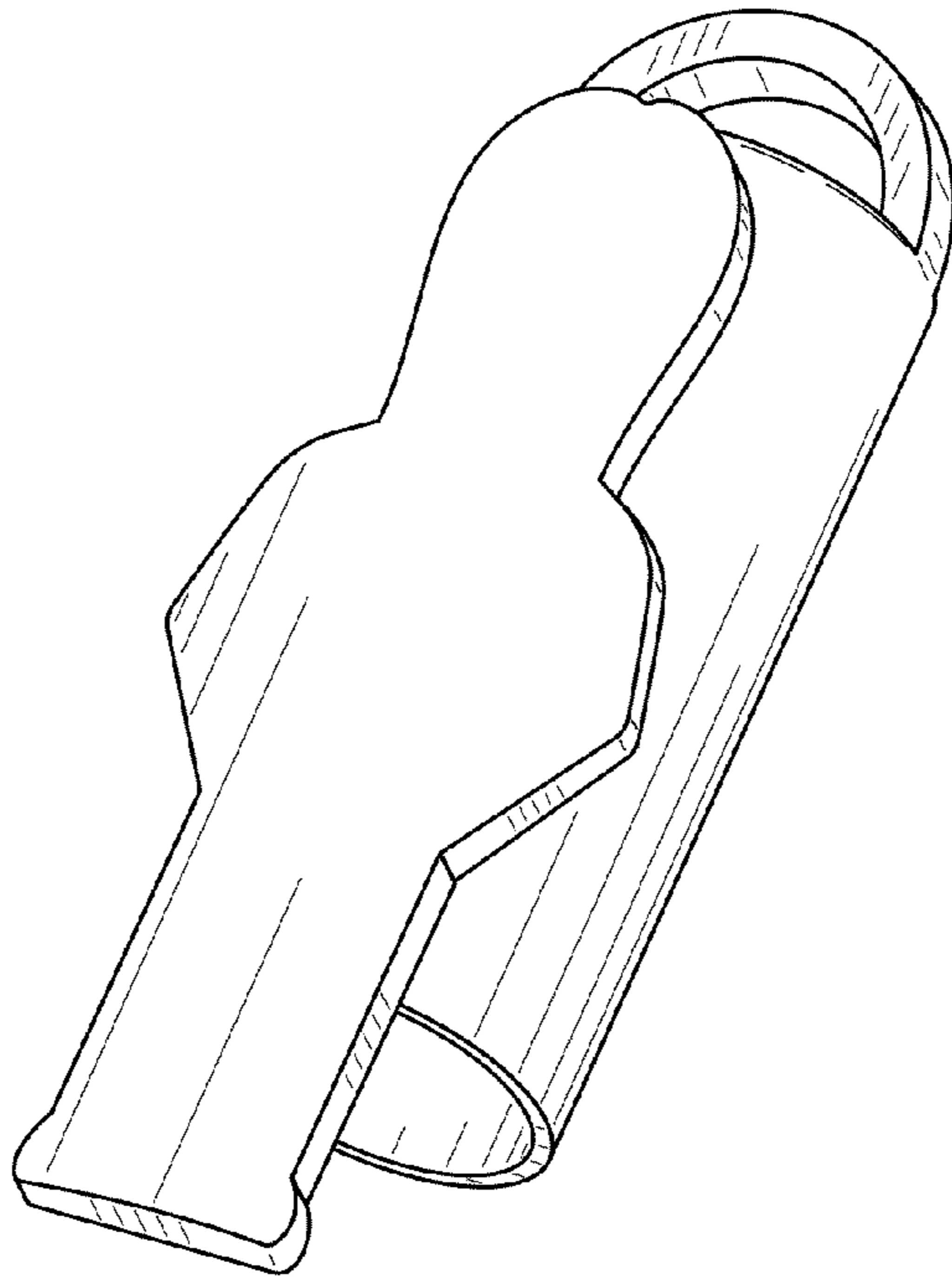

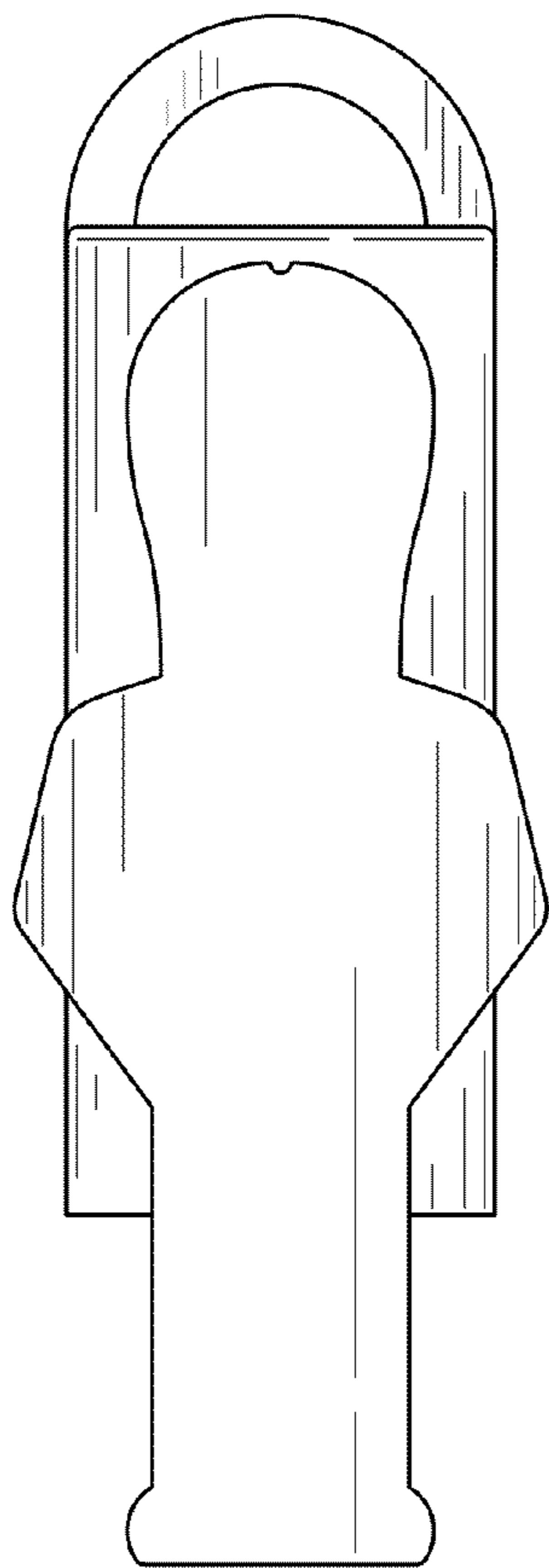

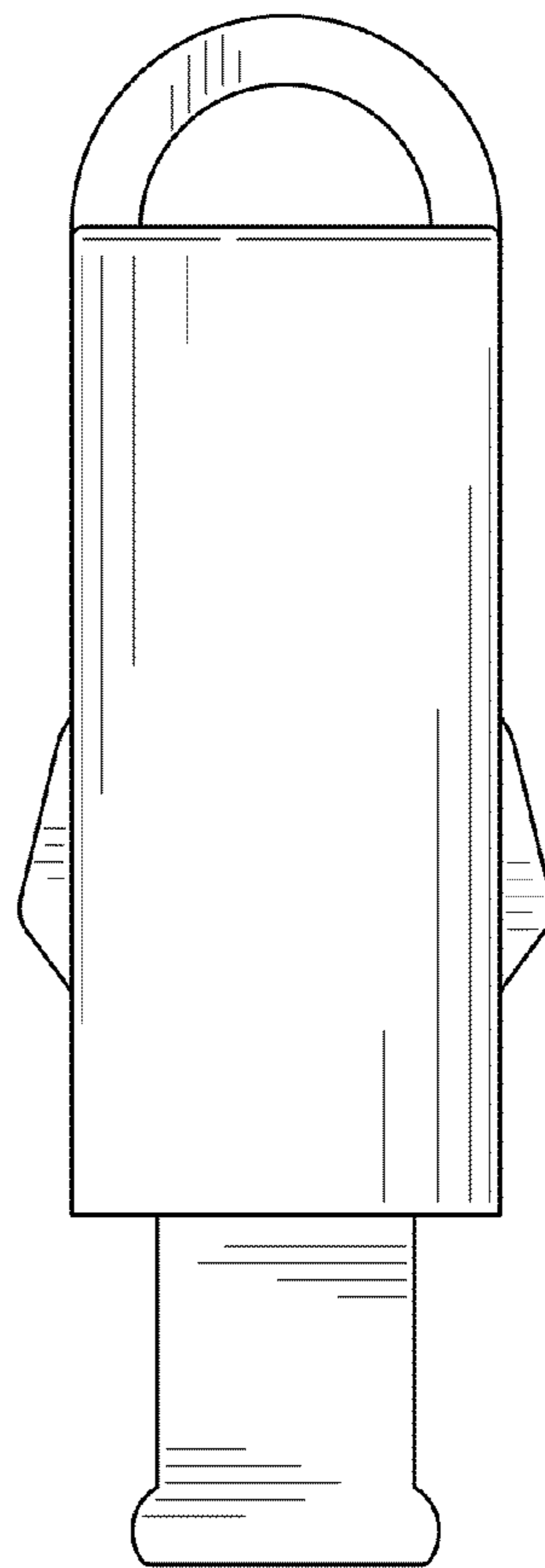

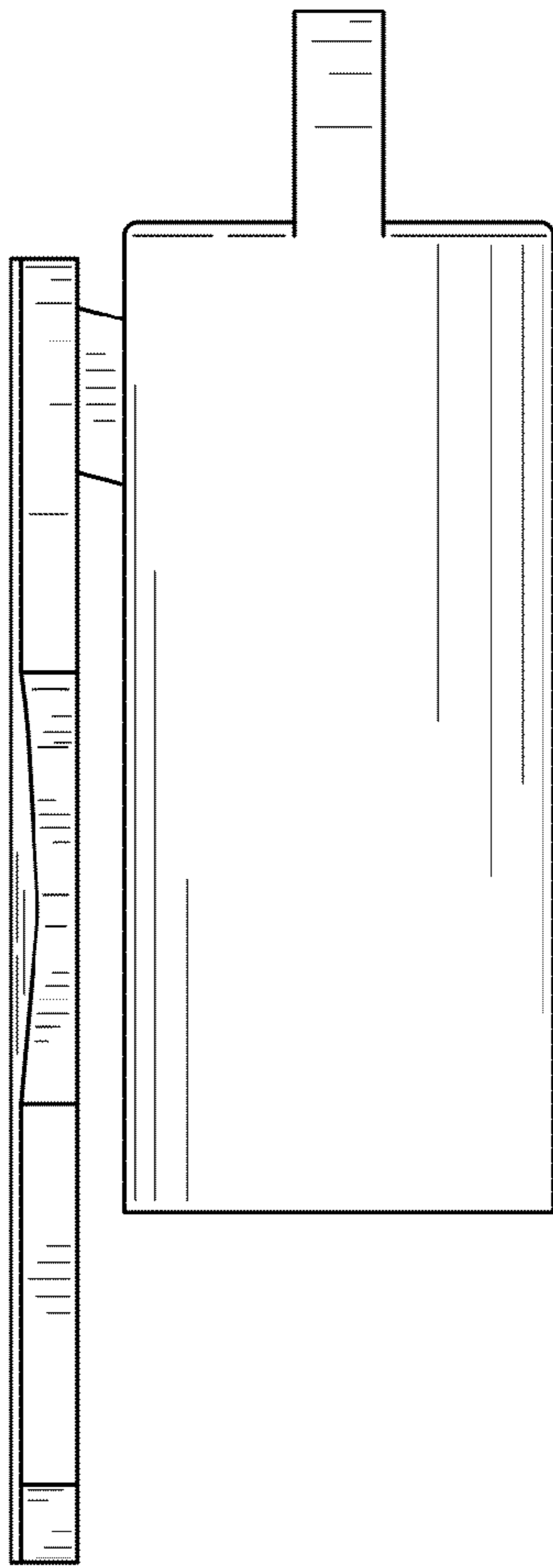

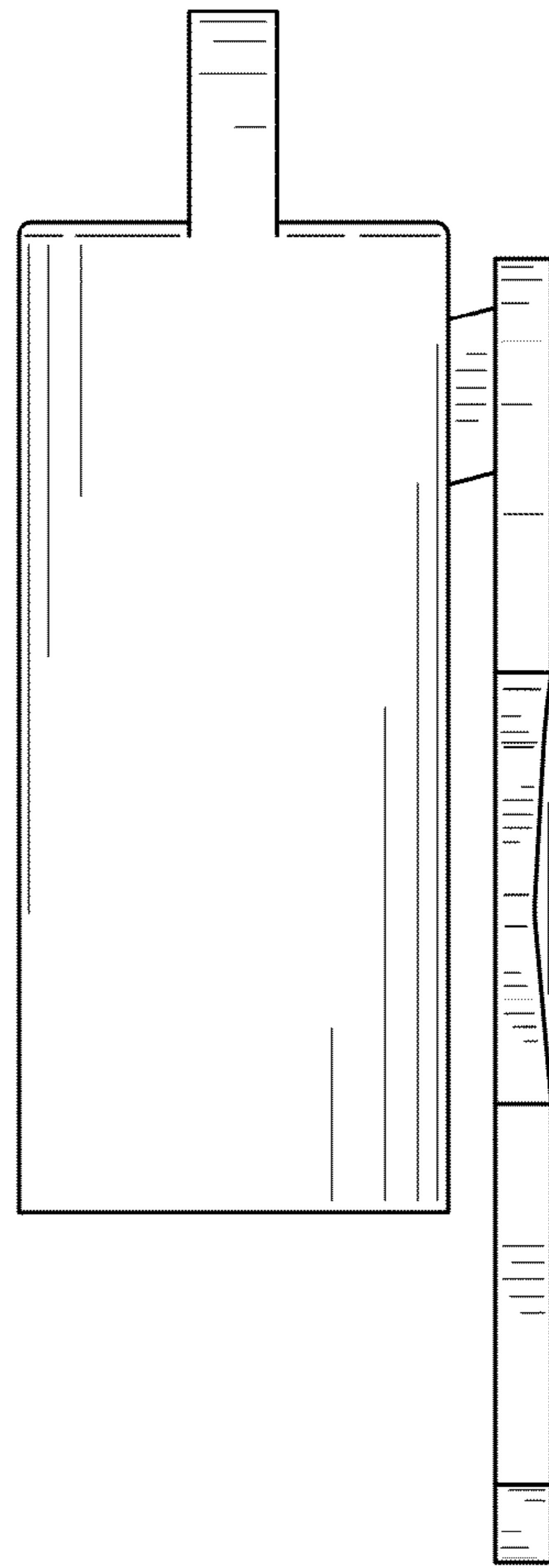

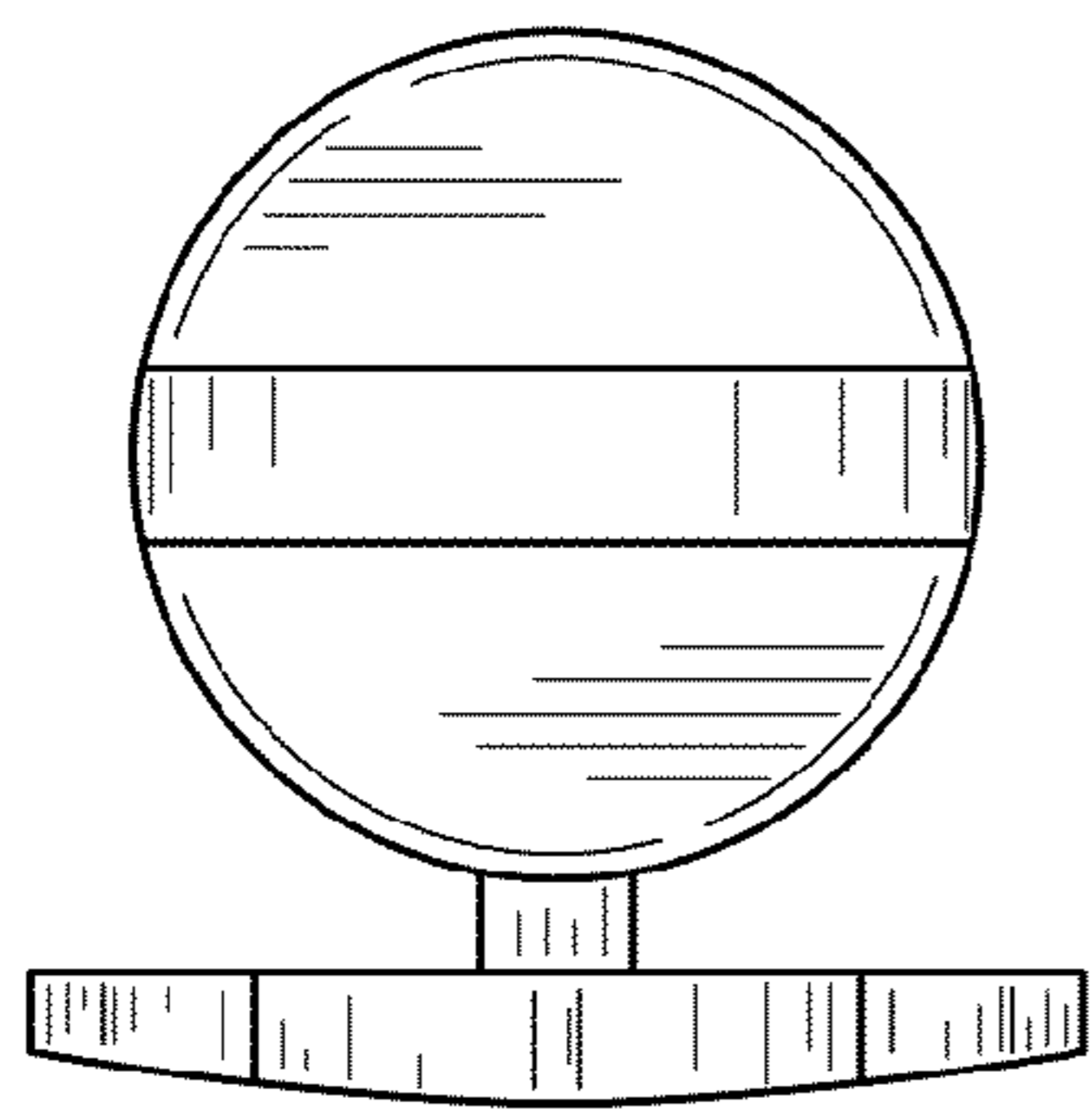

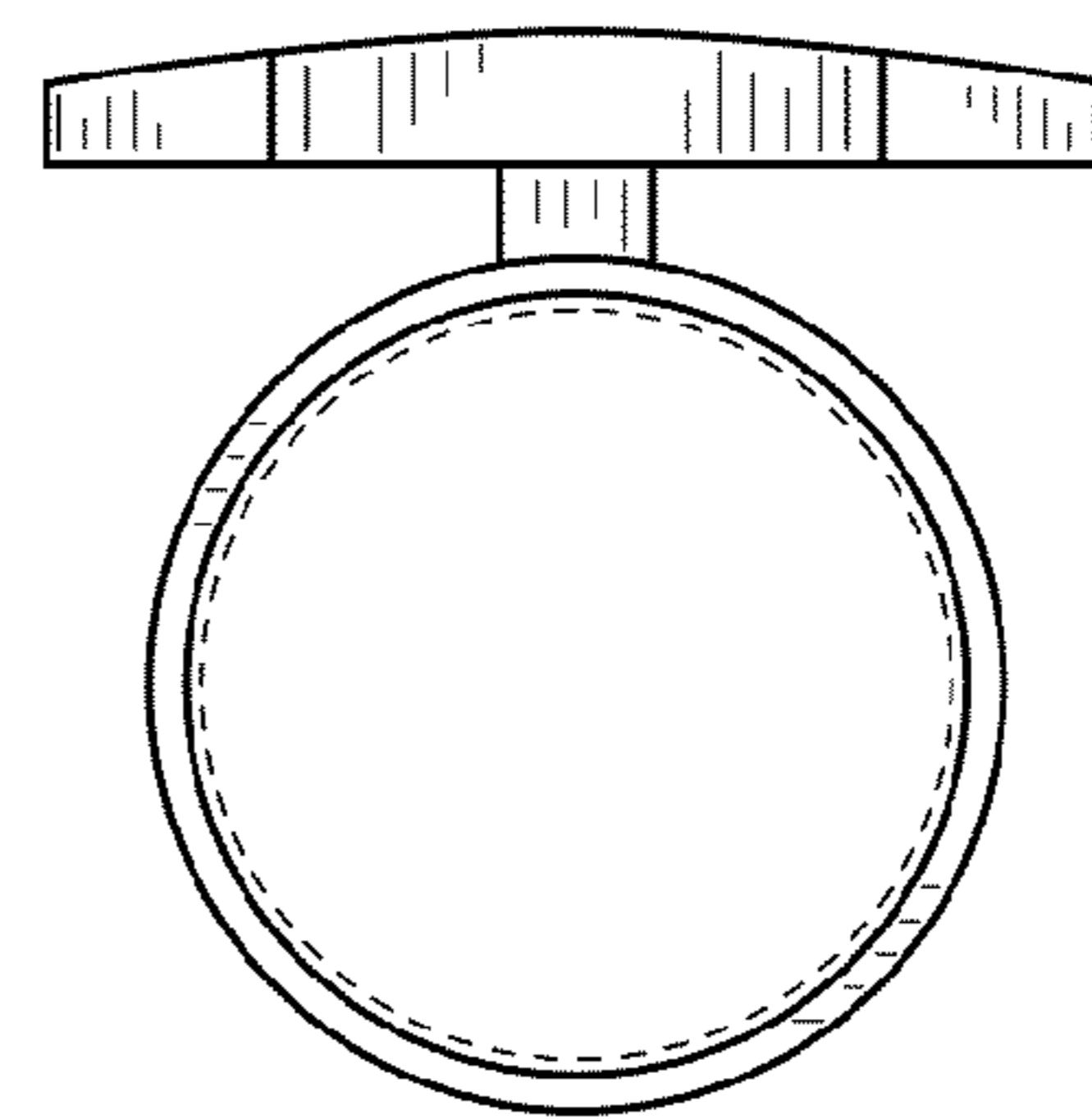
