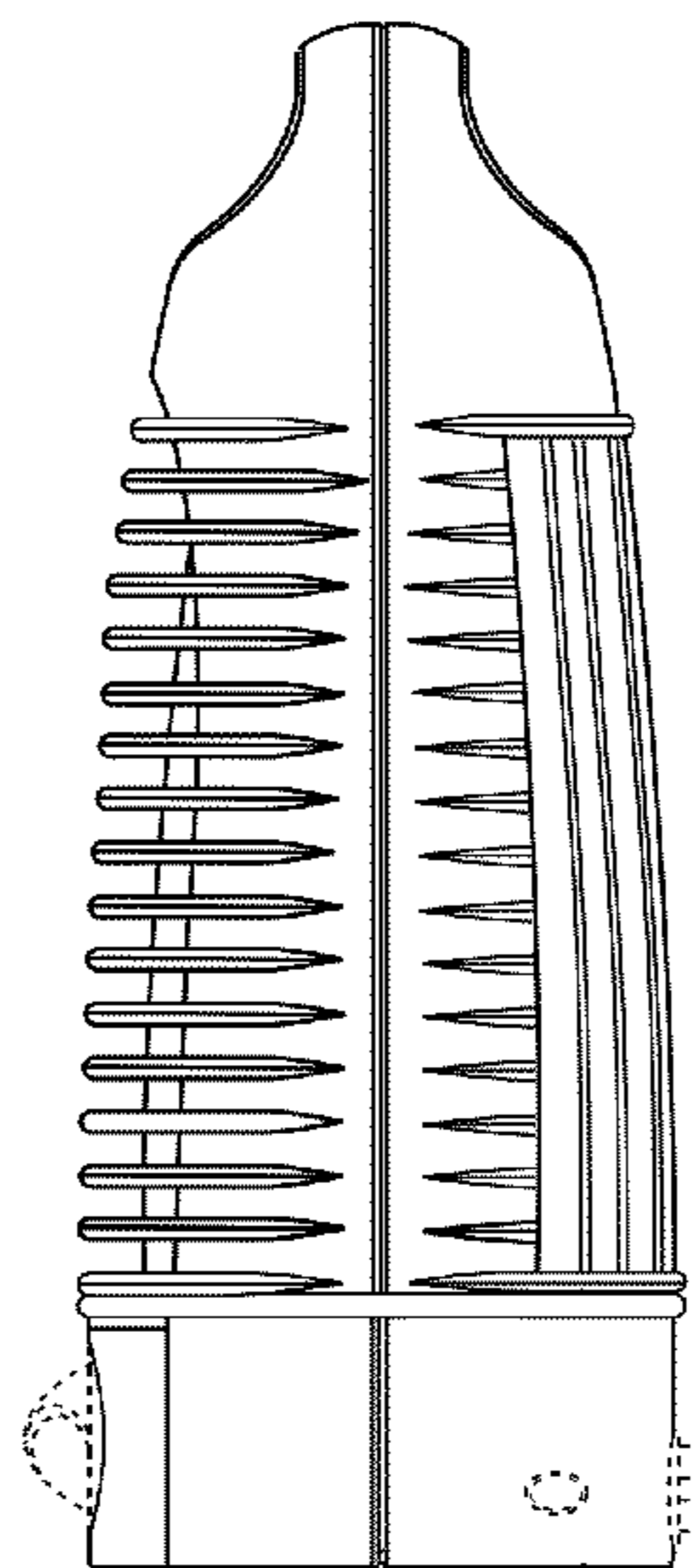
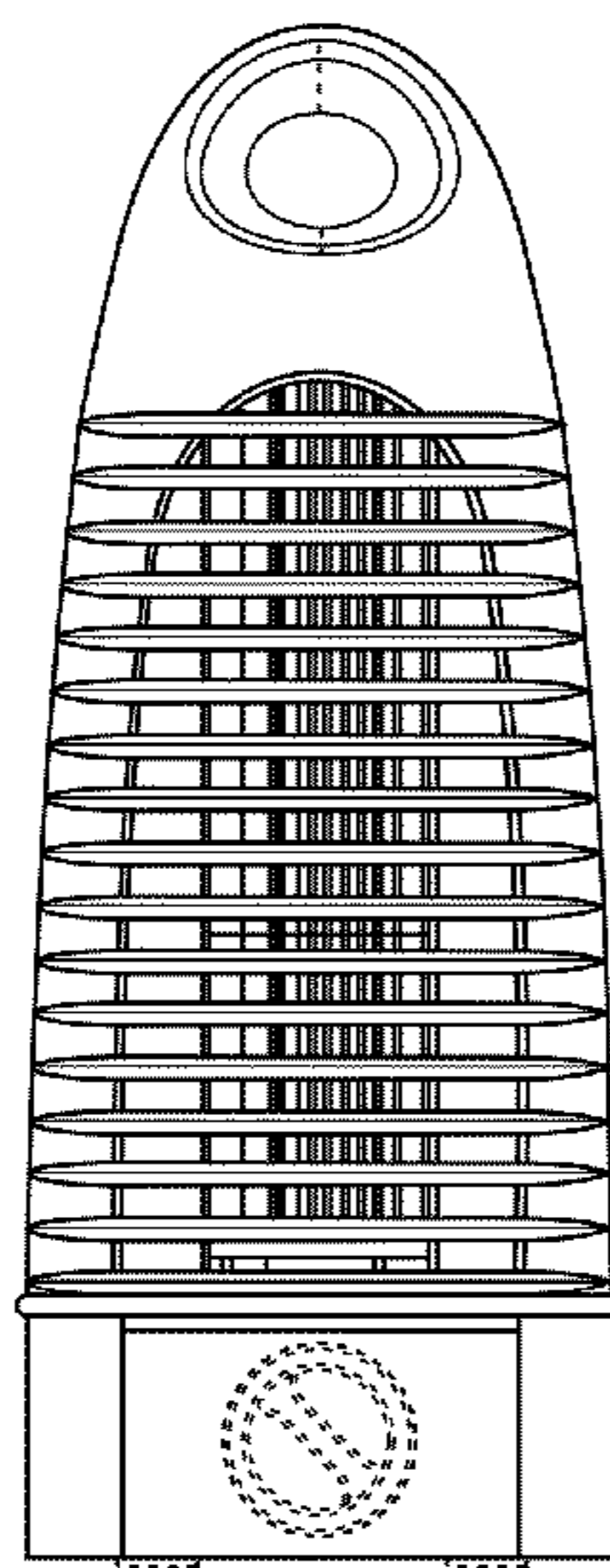
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a cross-flow fan of the present invention;
FIG. 2 is a rear perspective view of the cross-flow fan of FIG. 1;
FIG. 3 is a front view of the cross-flow fan of FIG. 1;
FIG. 4 is a right side view of the cross-flow fan of FIG. 1;

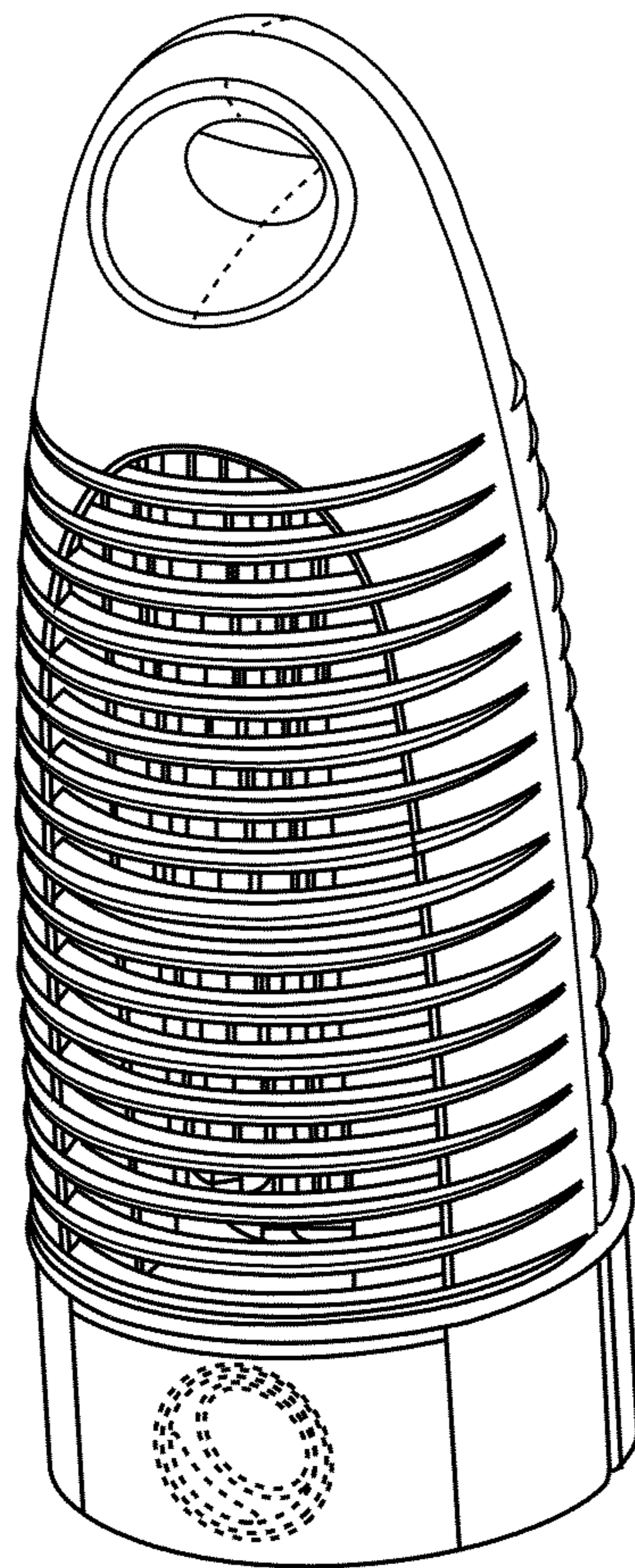

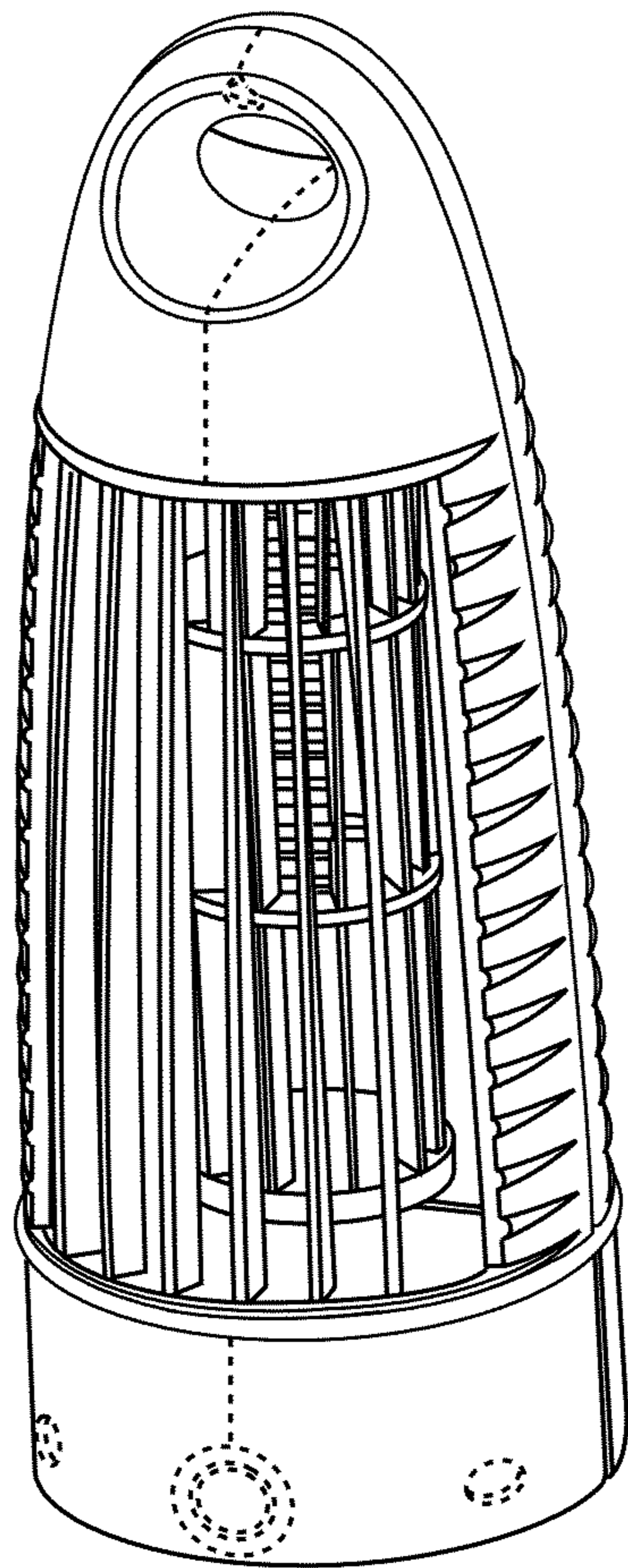

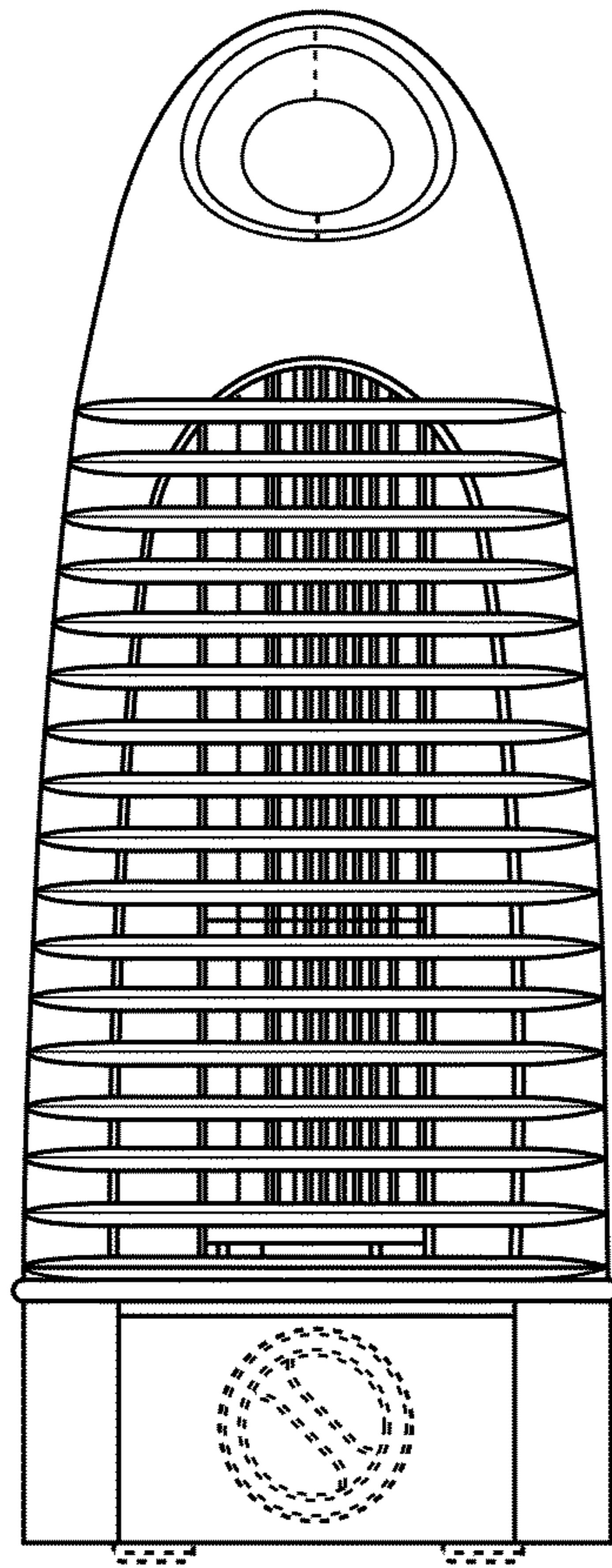

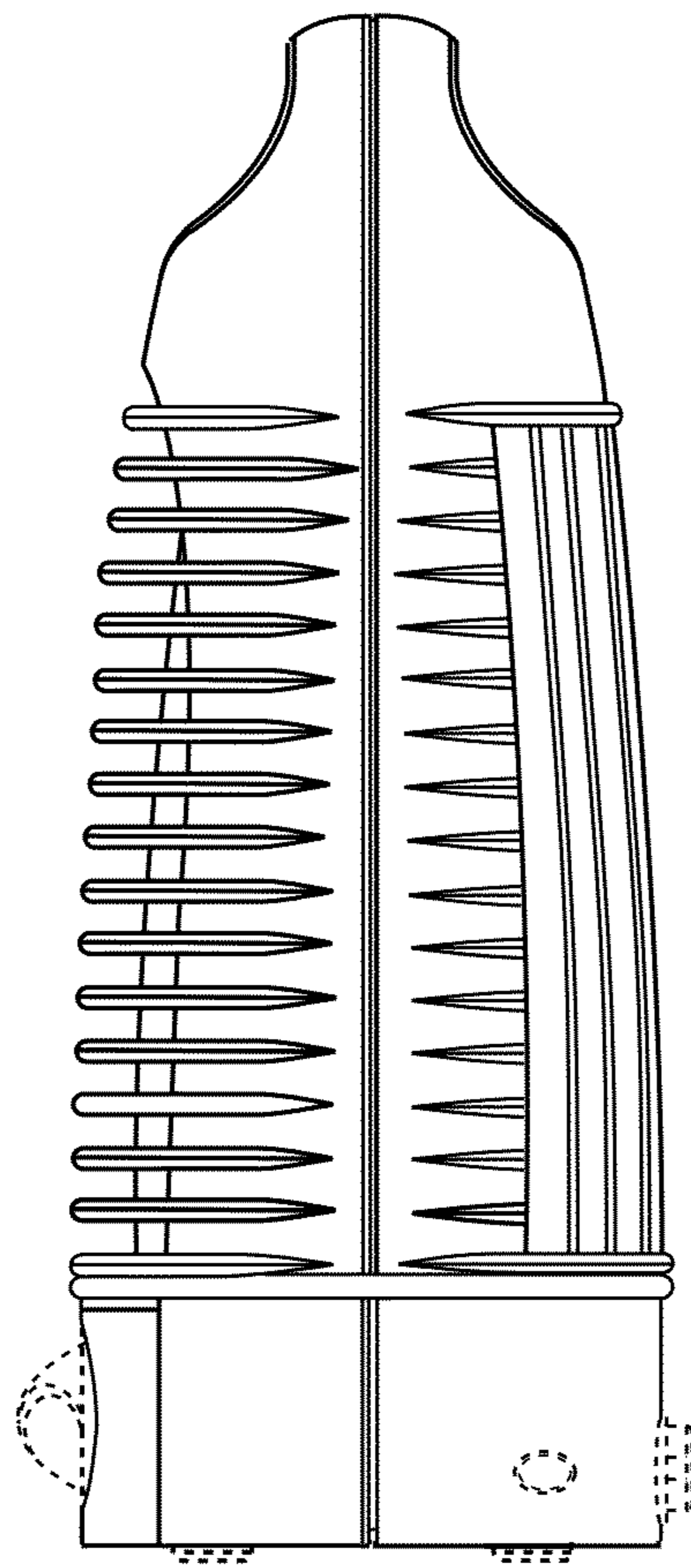

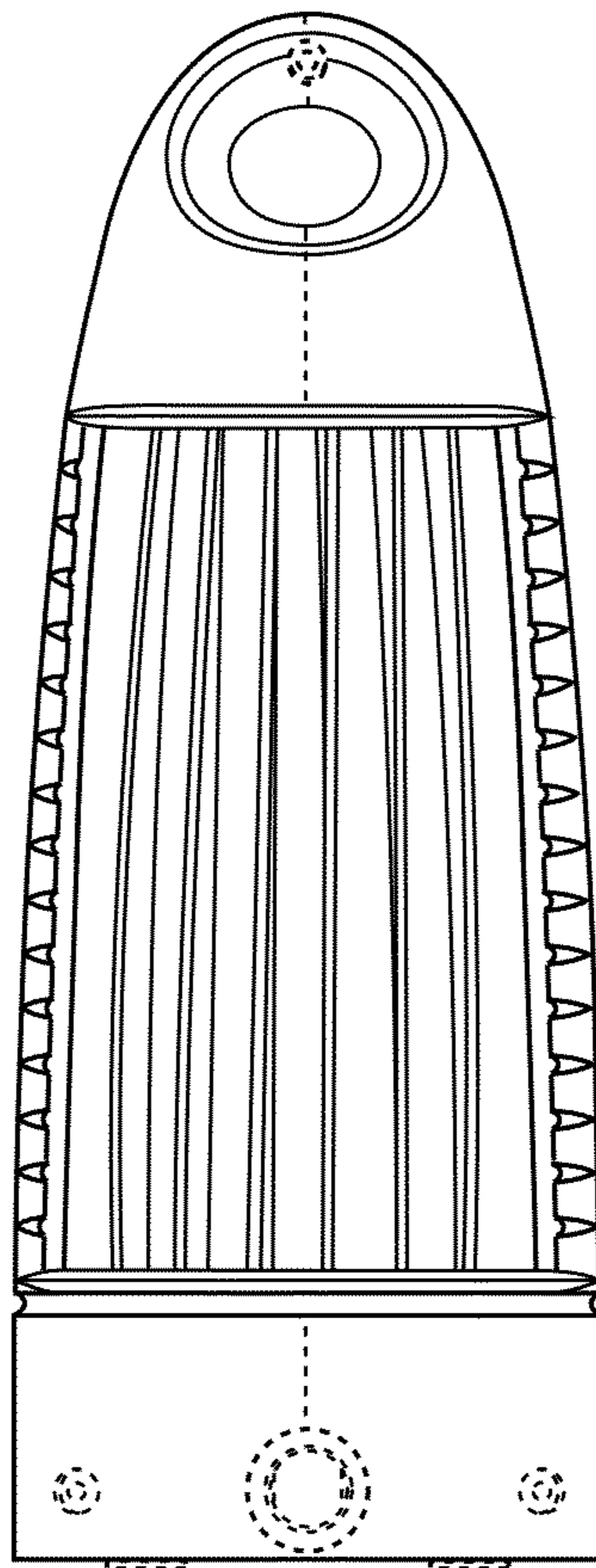

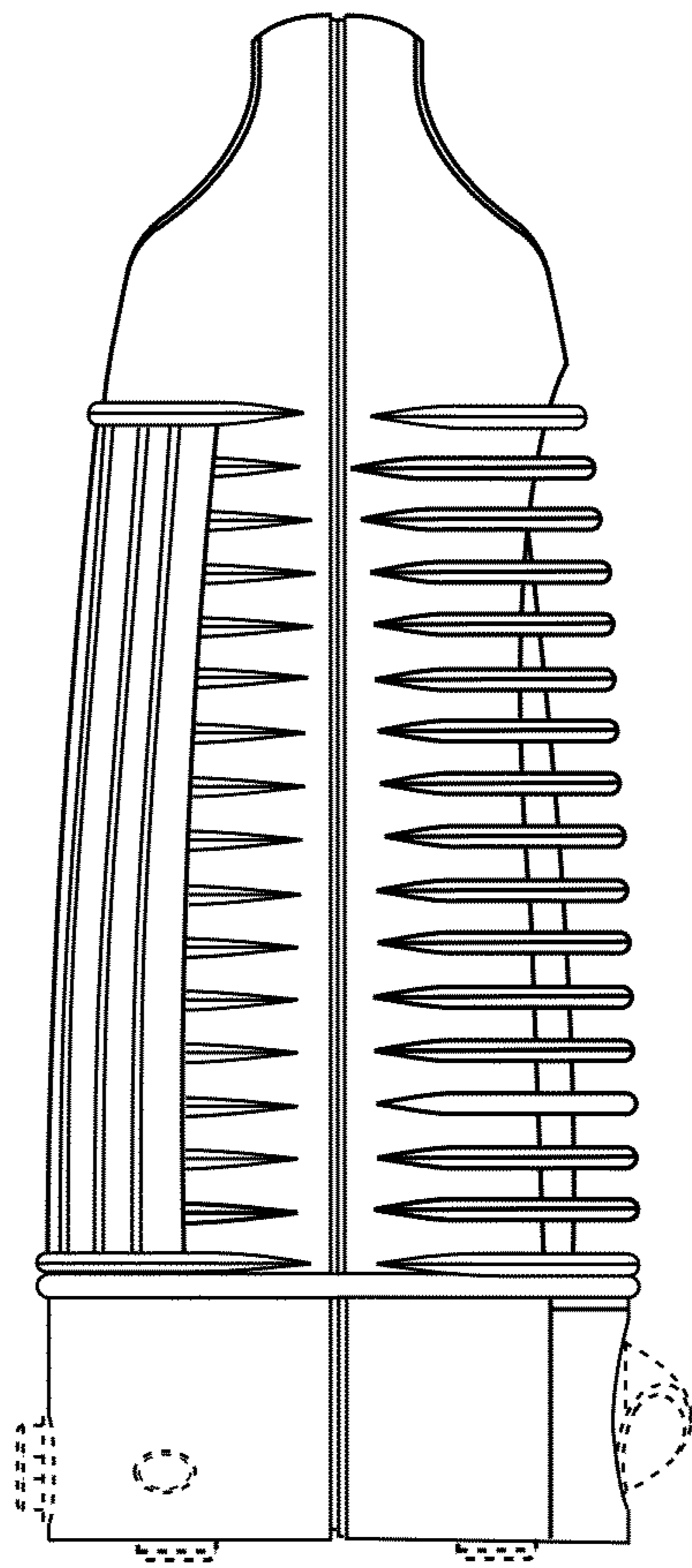

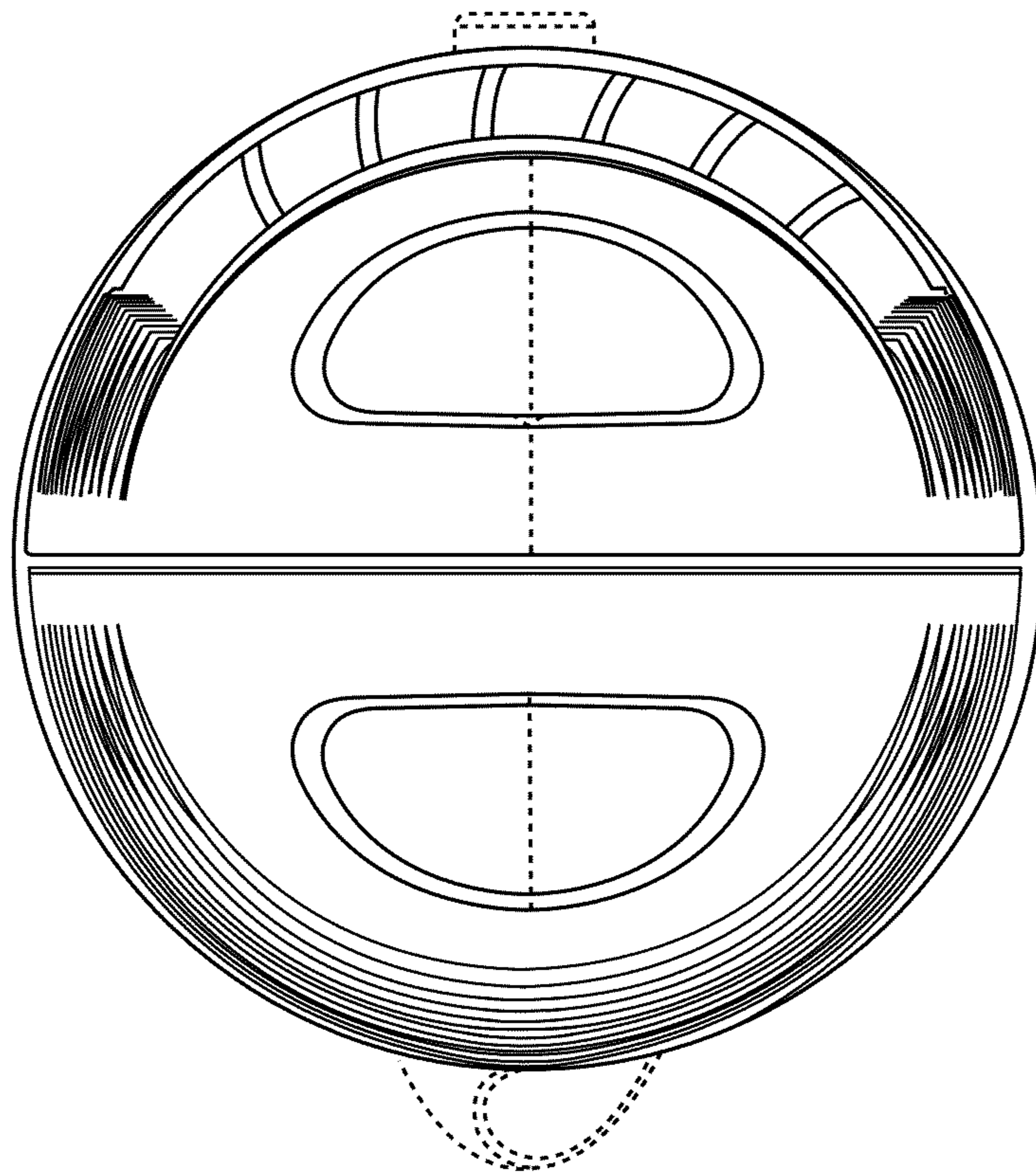

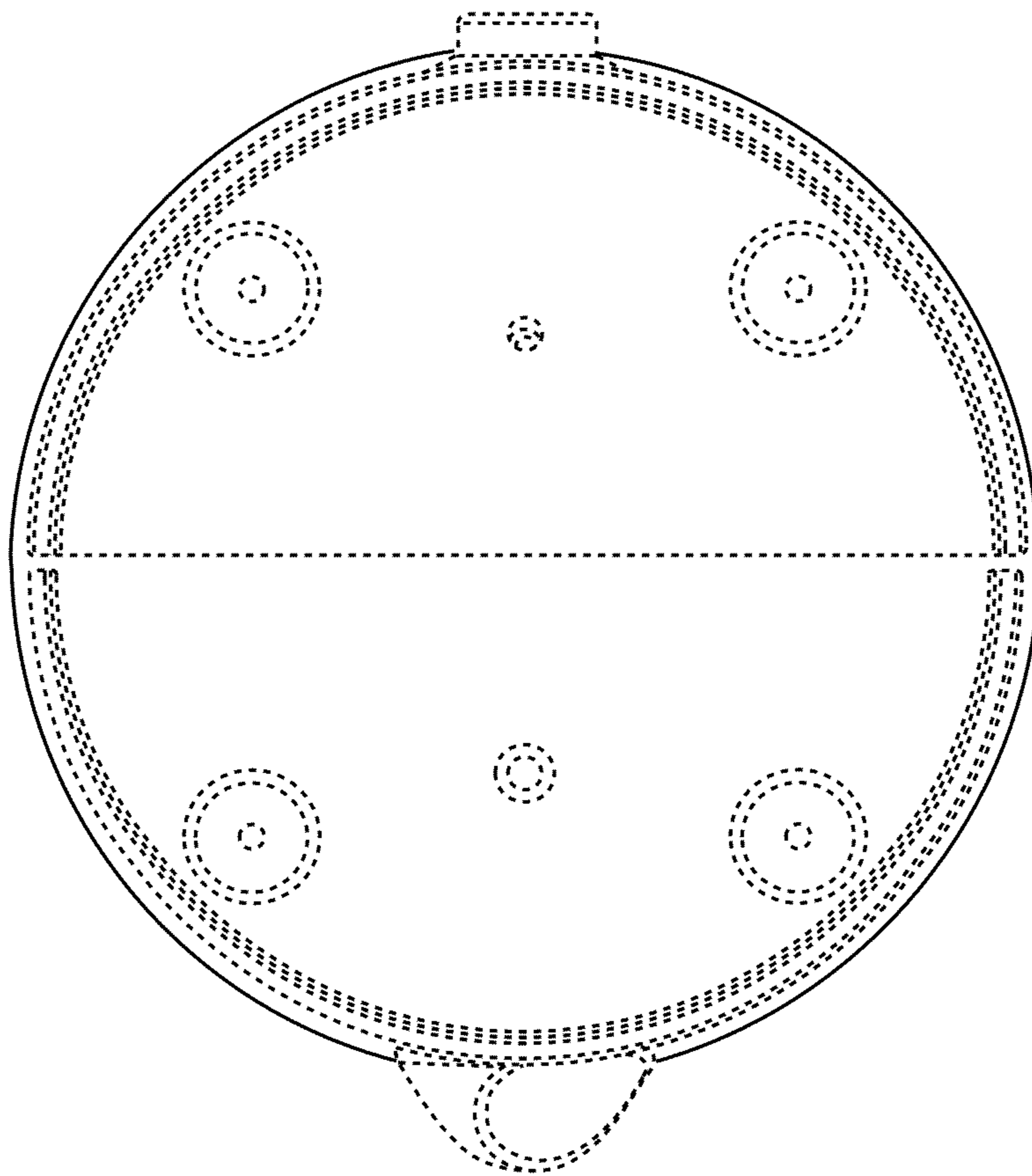
