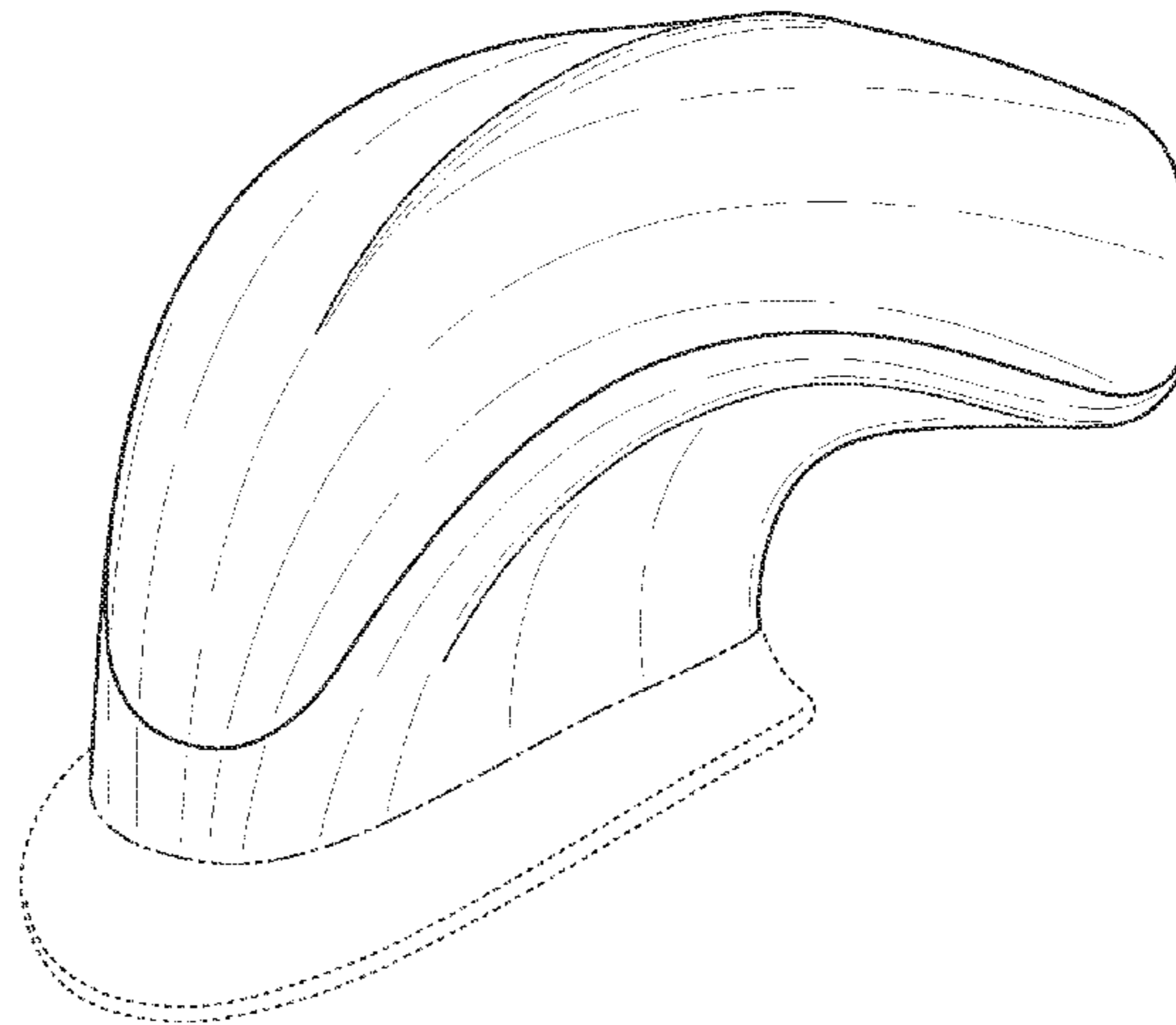
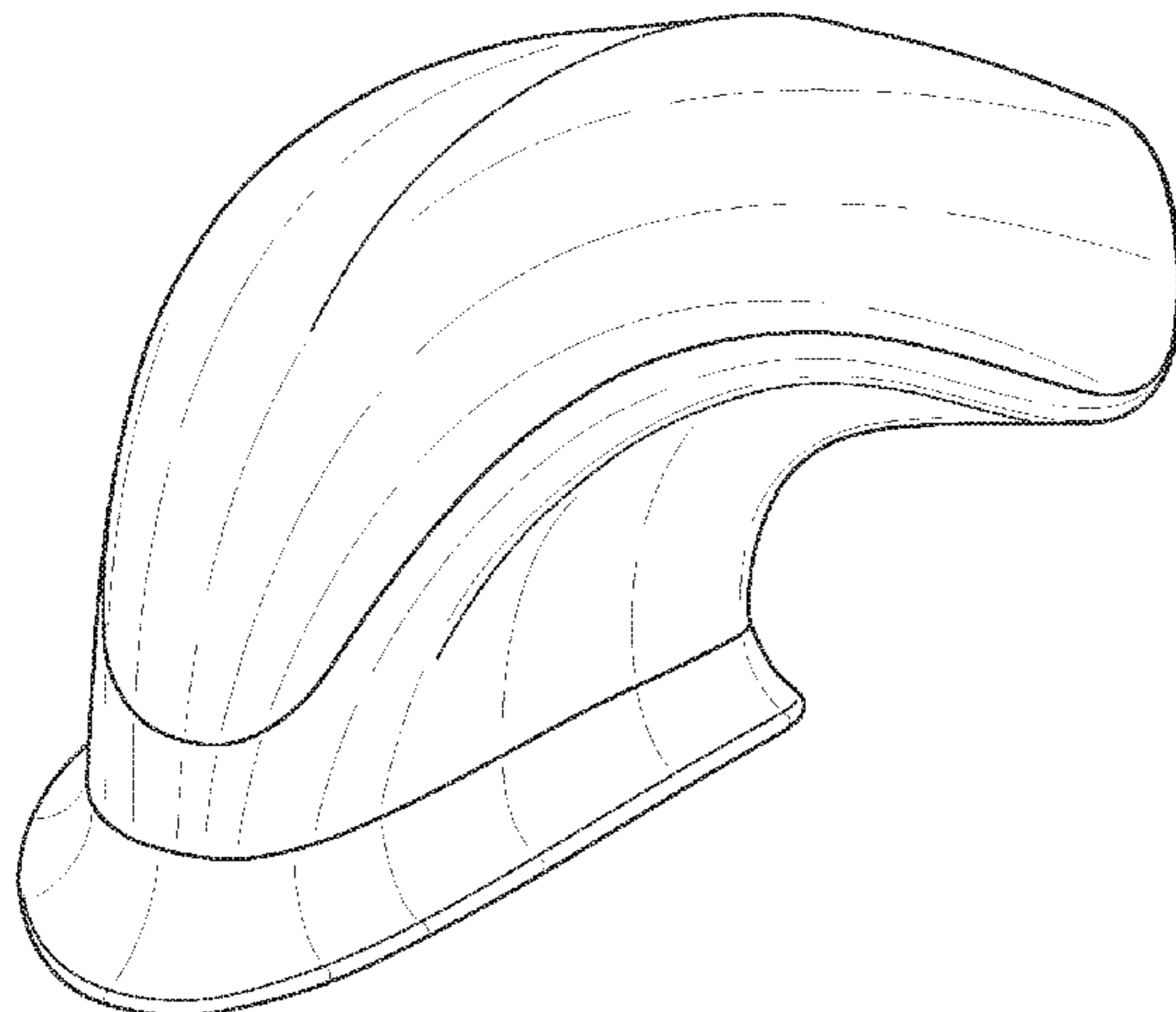
The ornamental design for a sexual wellness device, as shown and described.

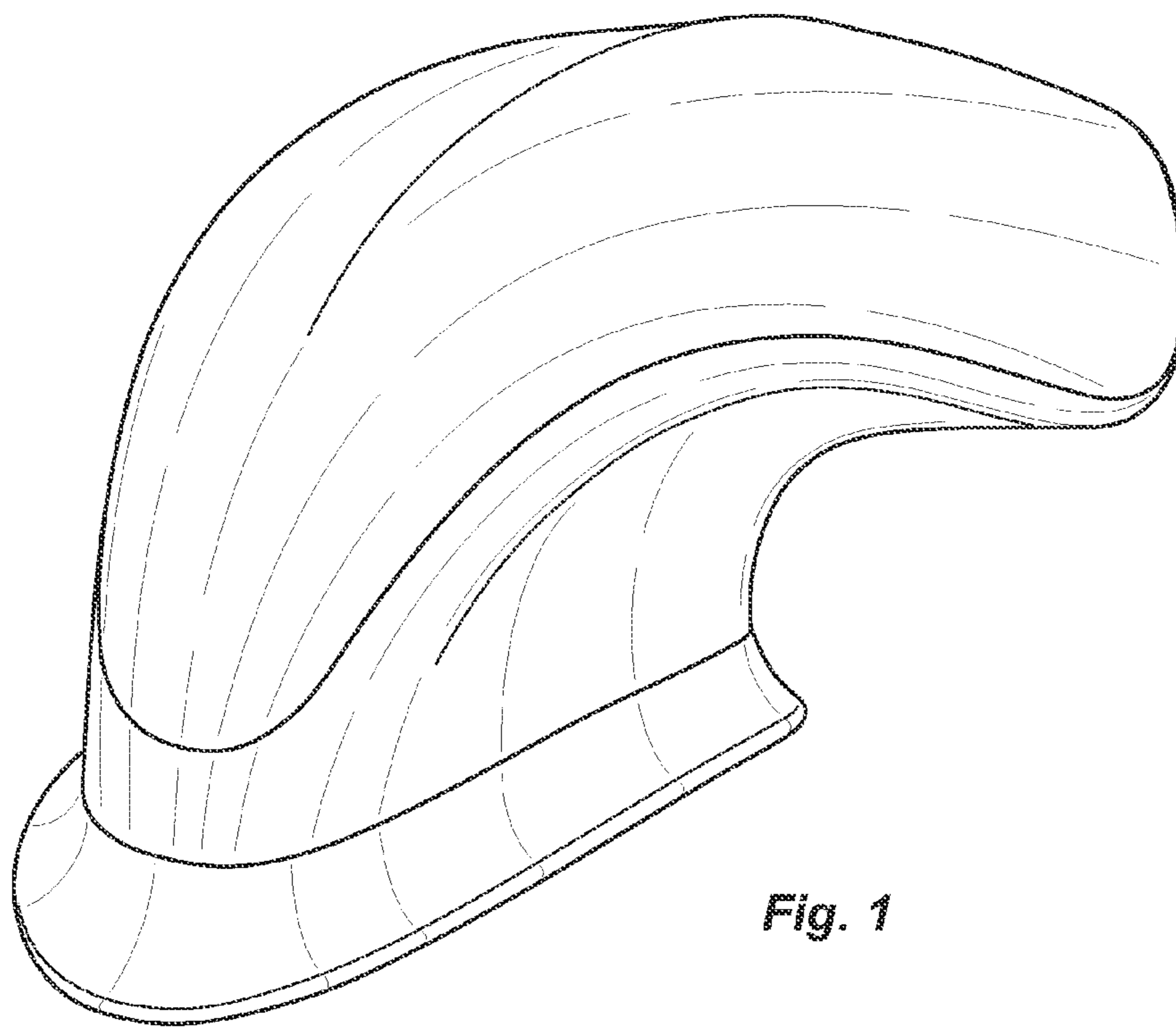

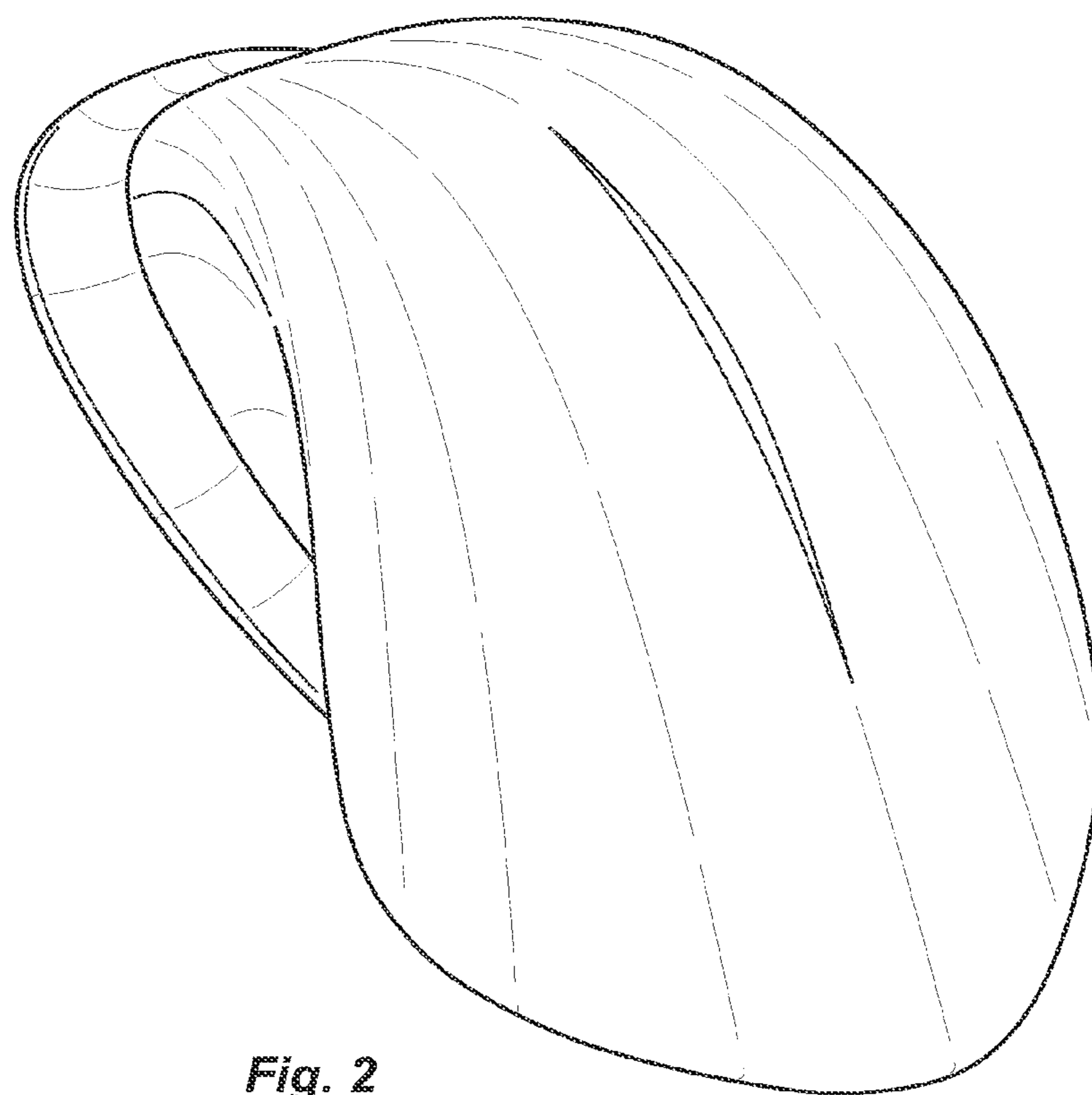

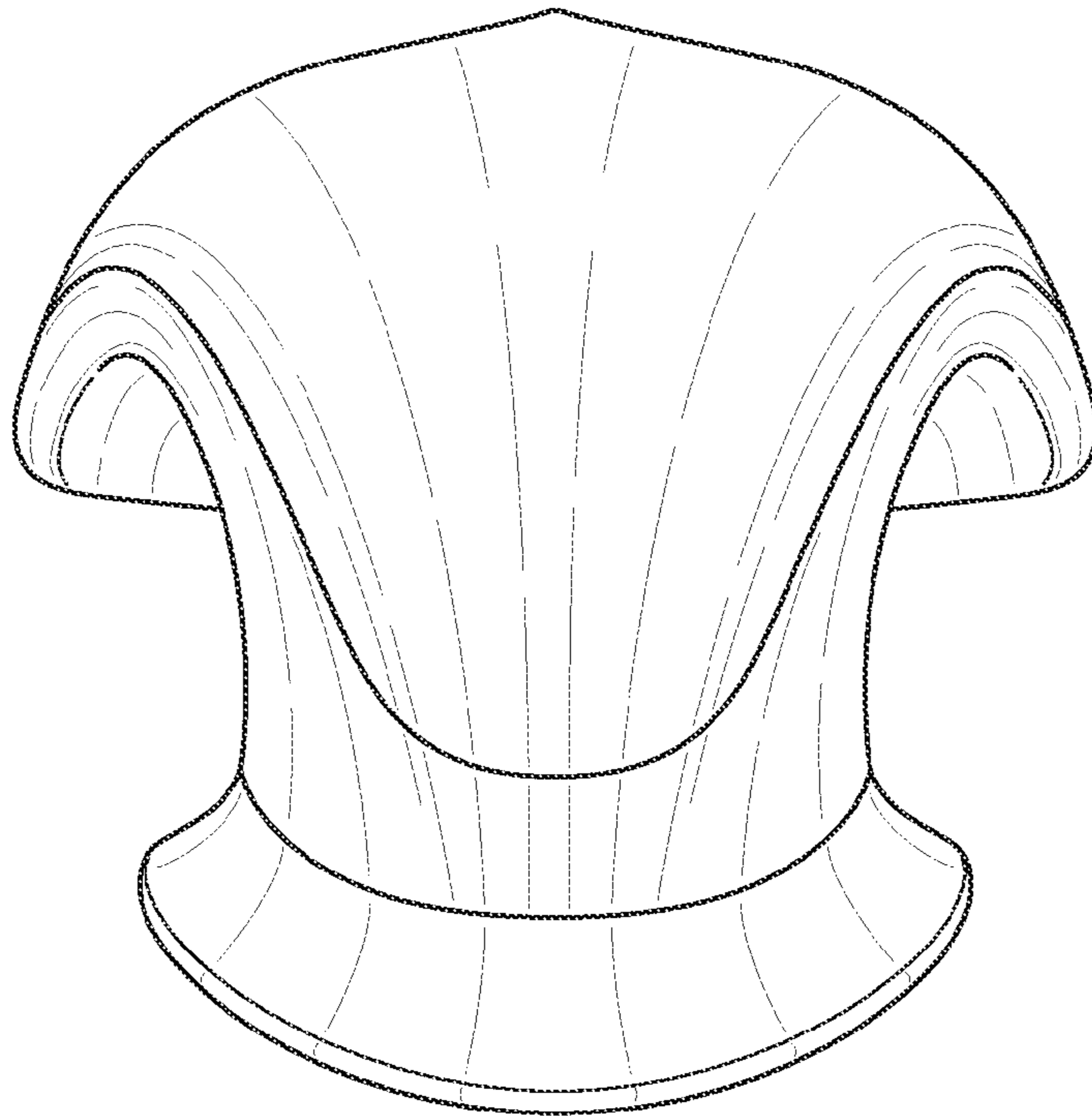

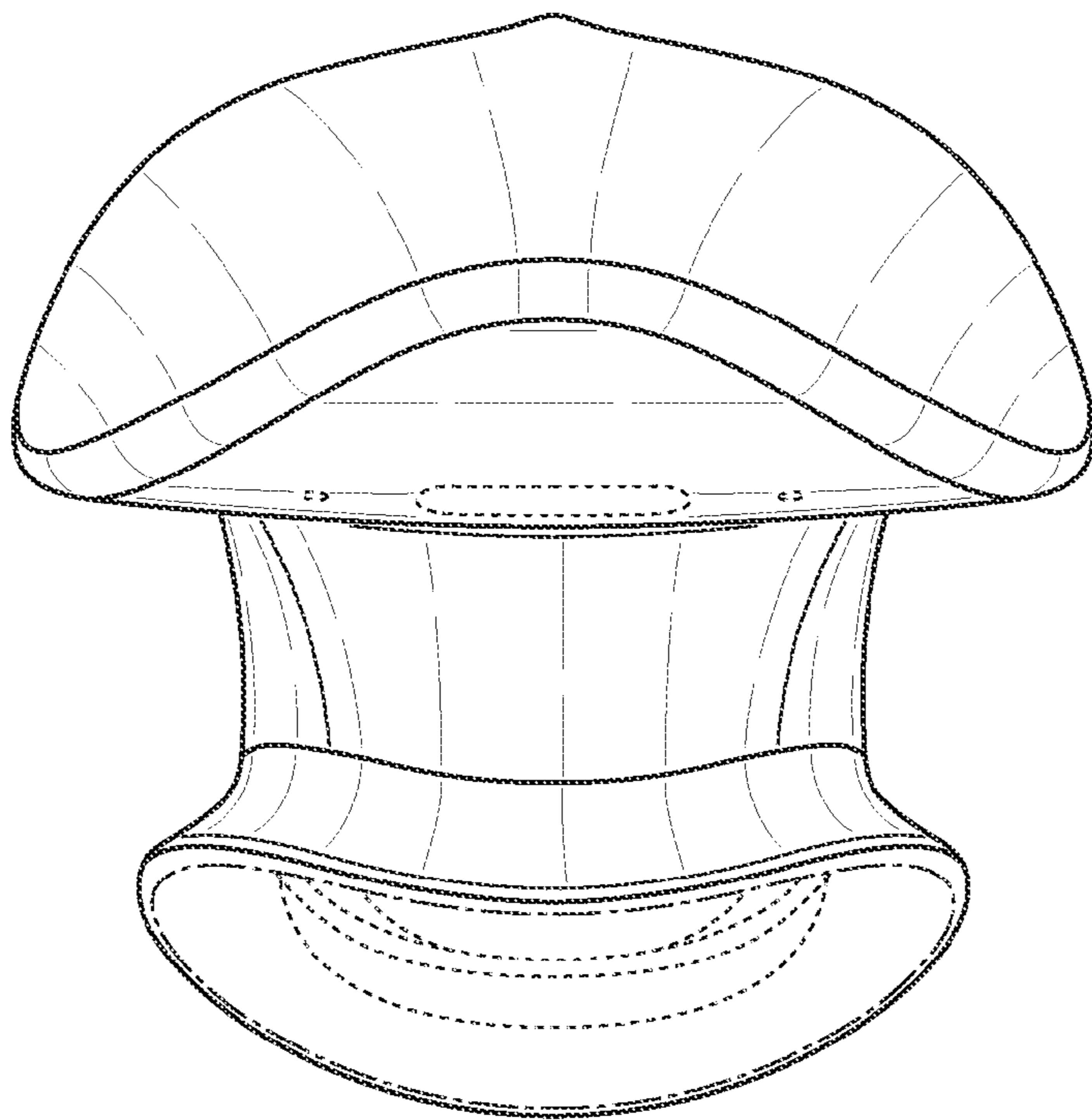

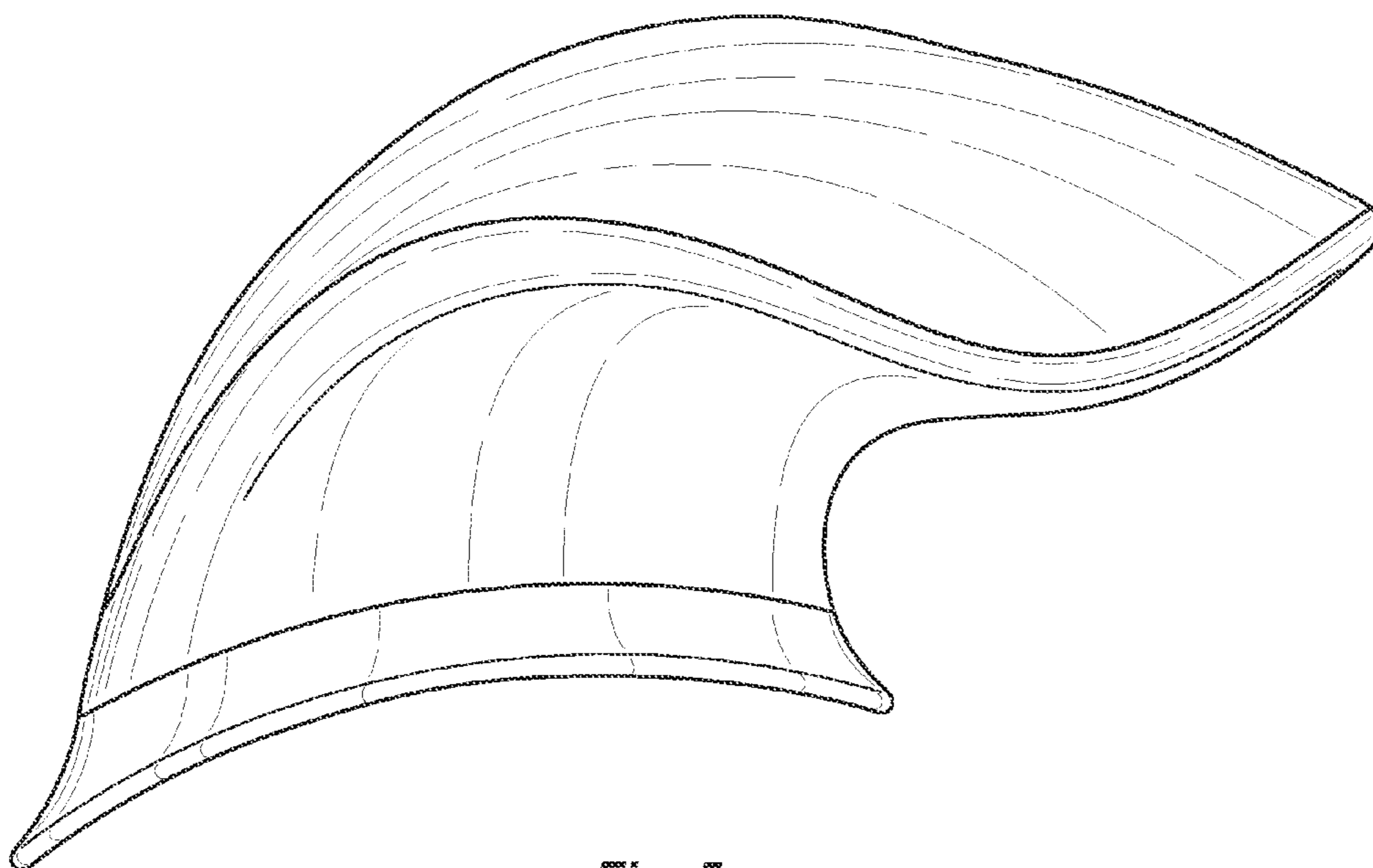

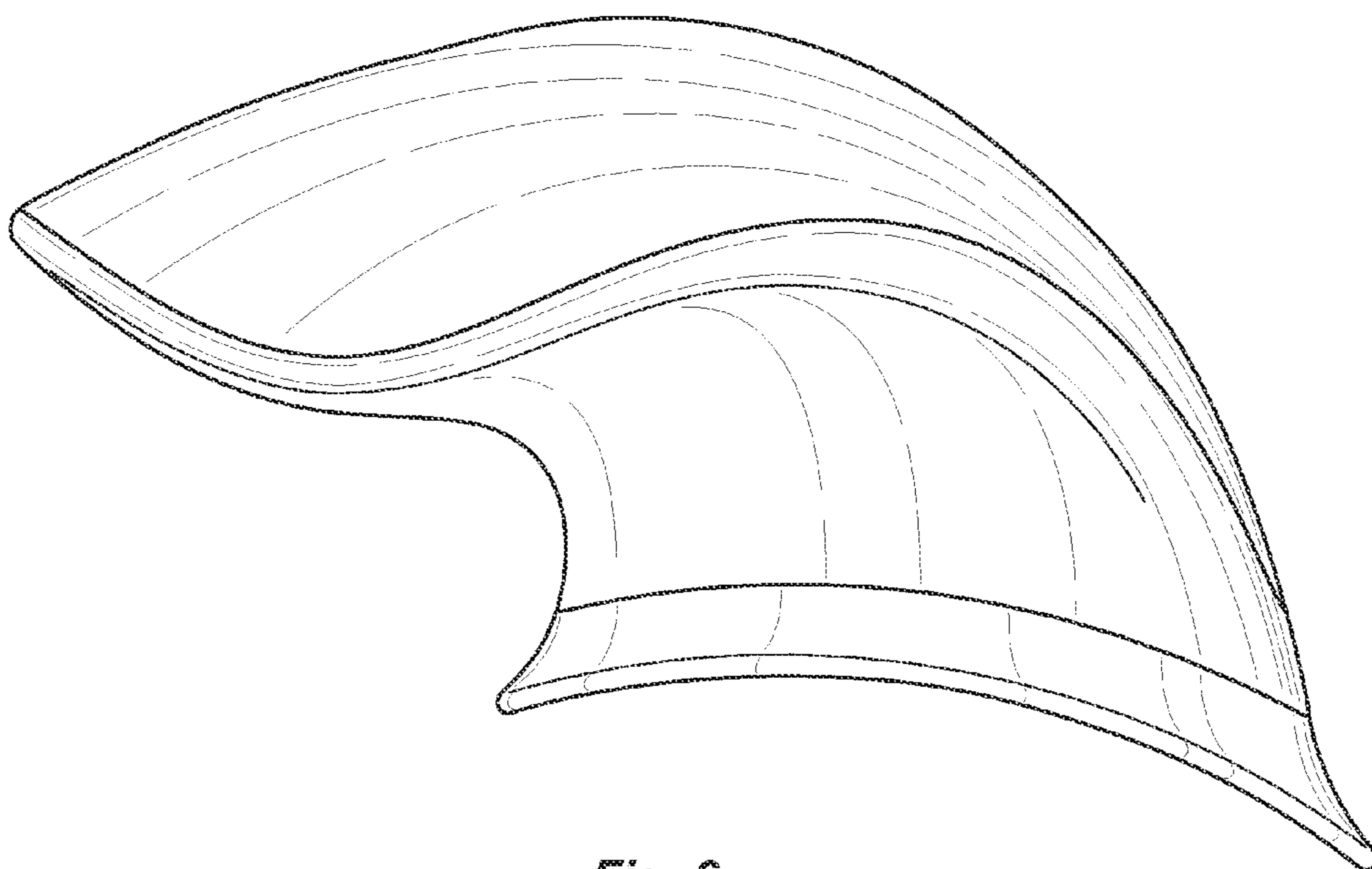

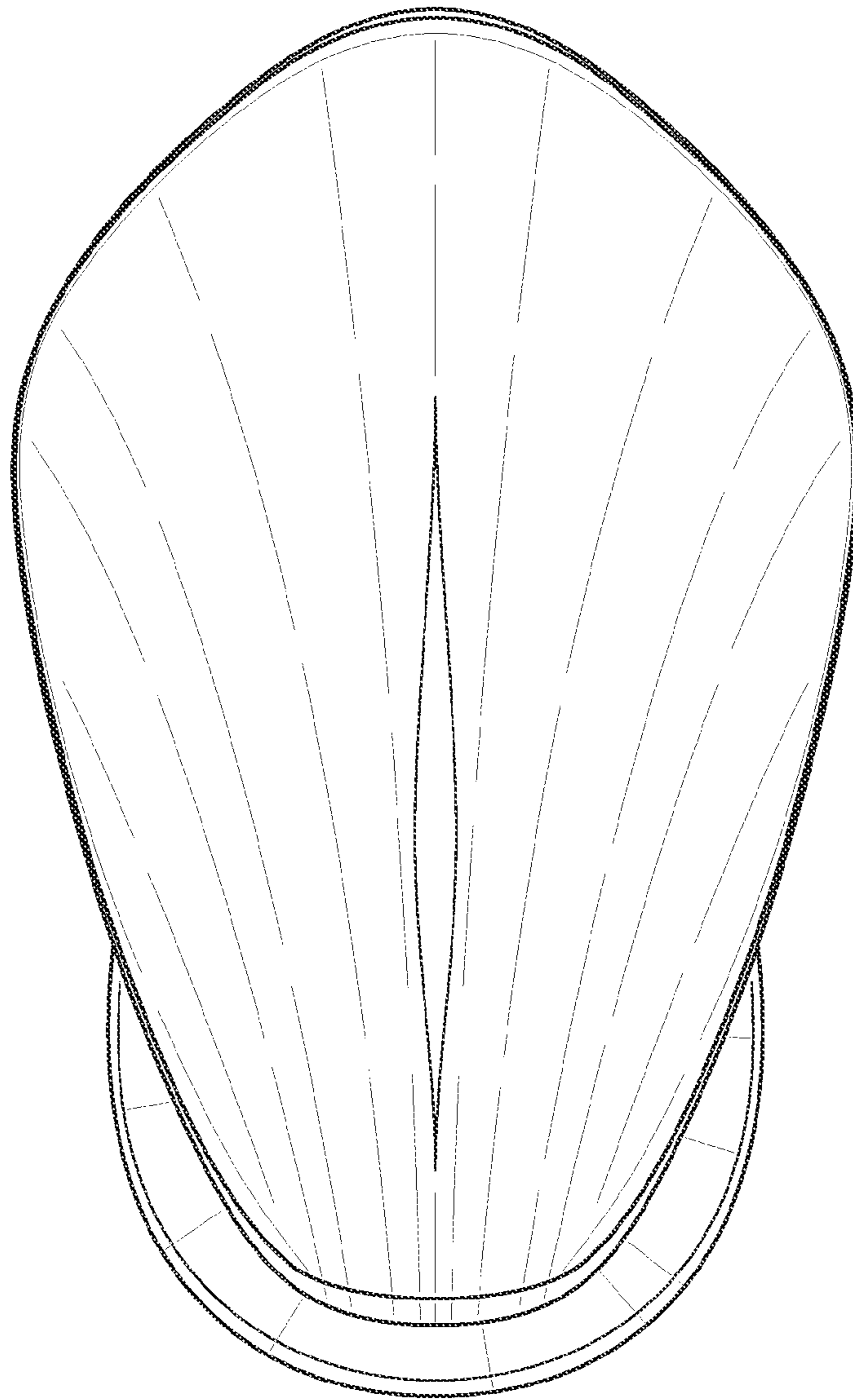

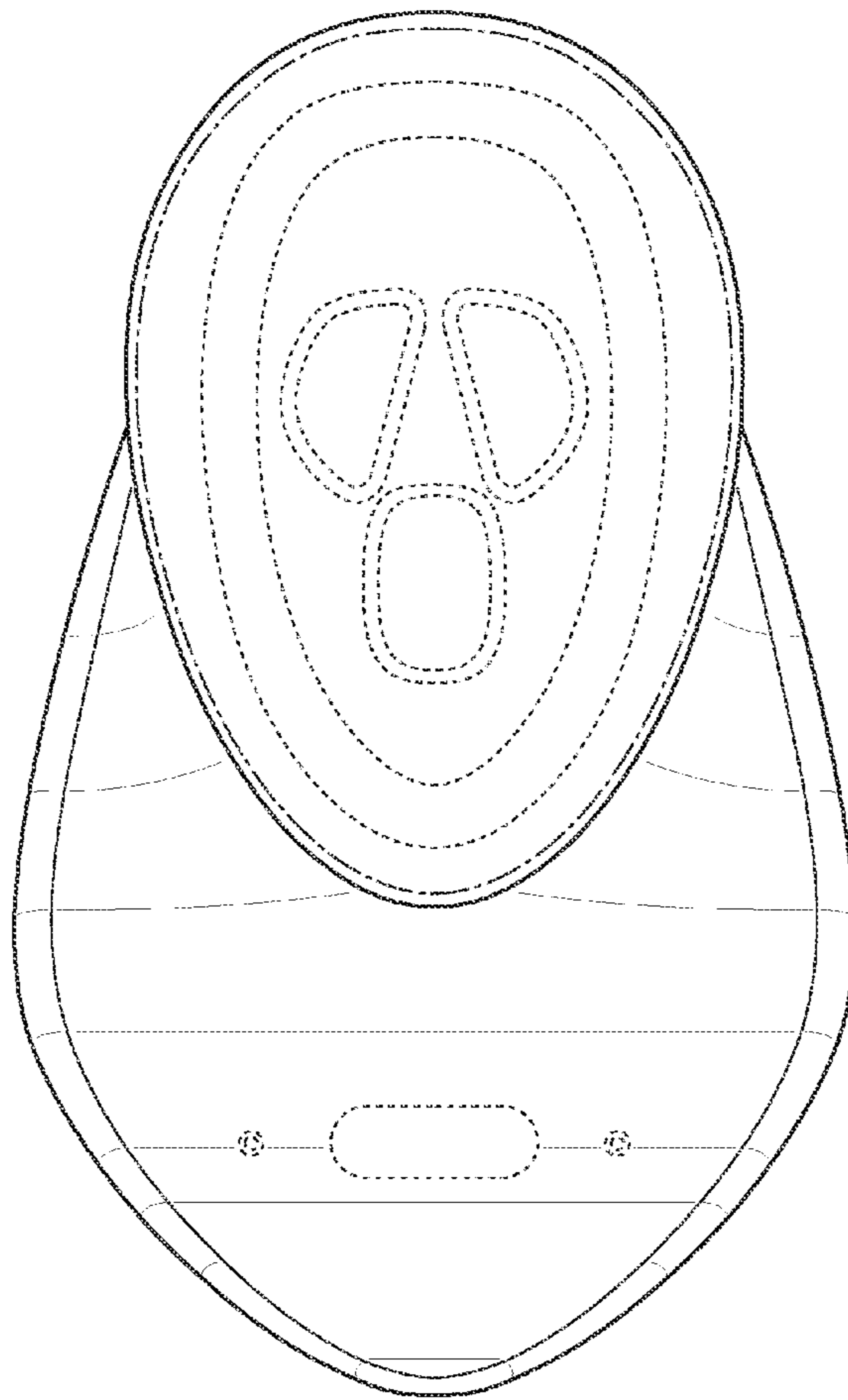

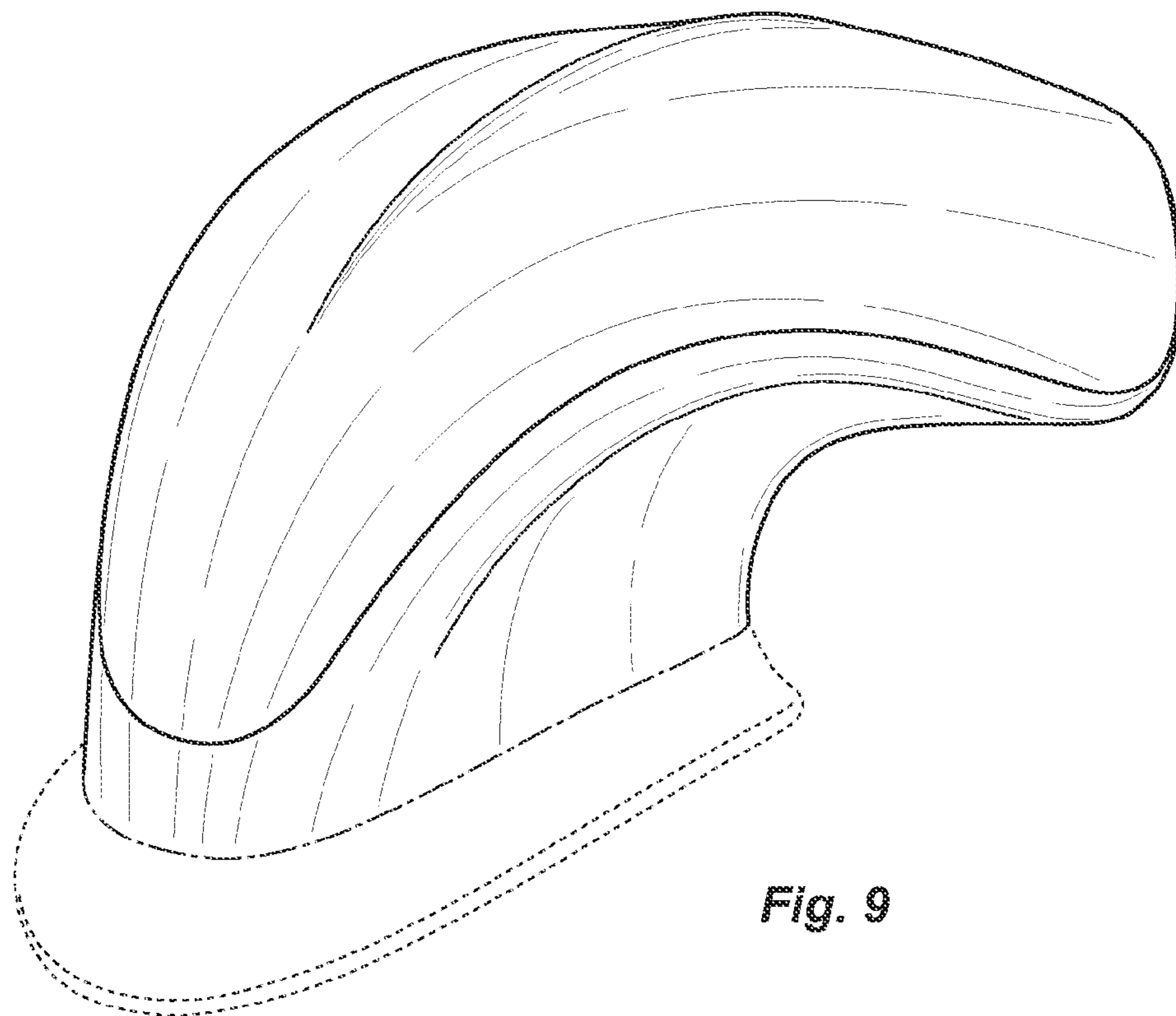

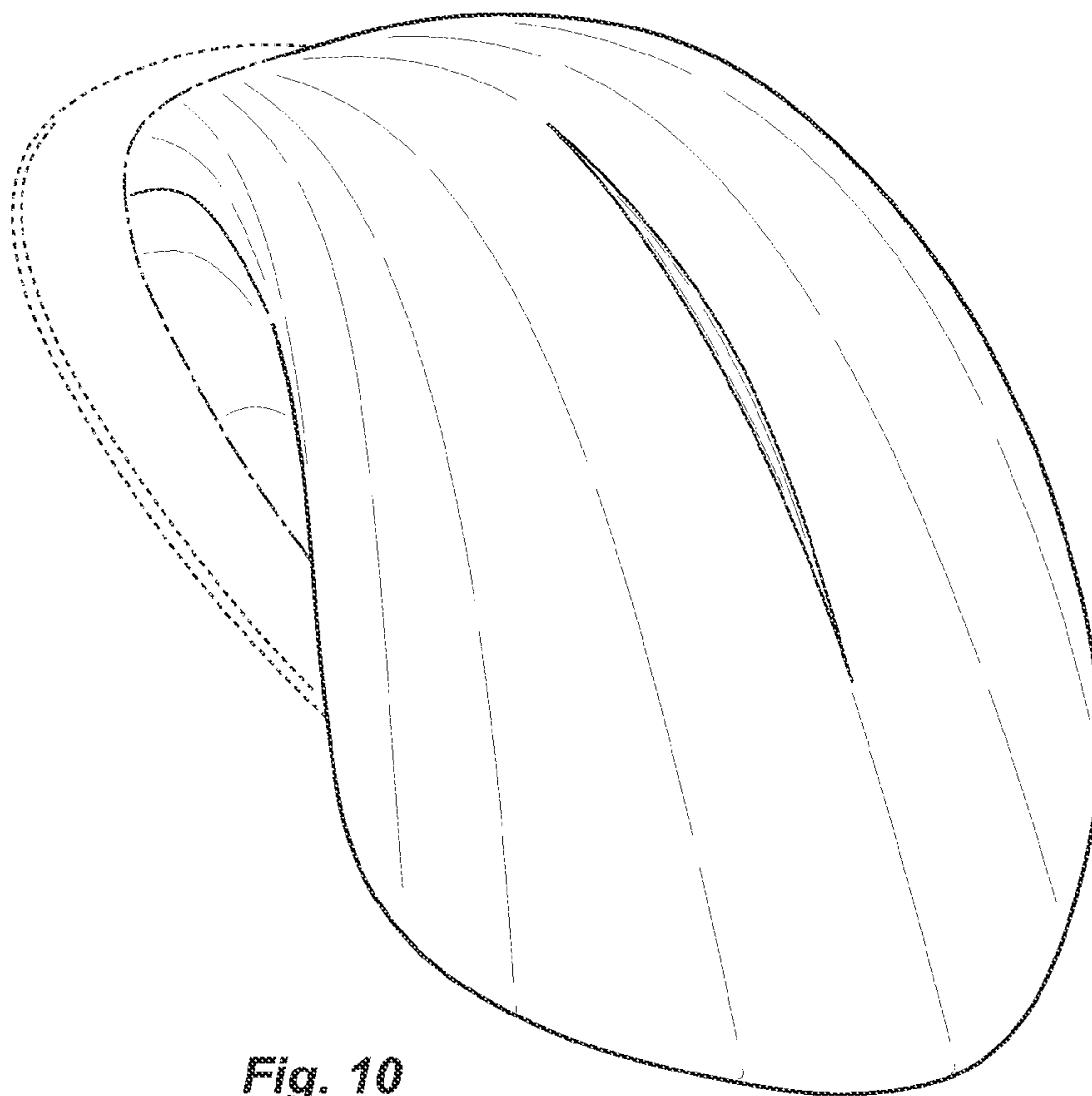

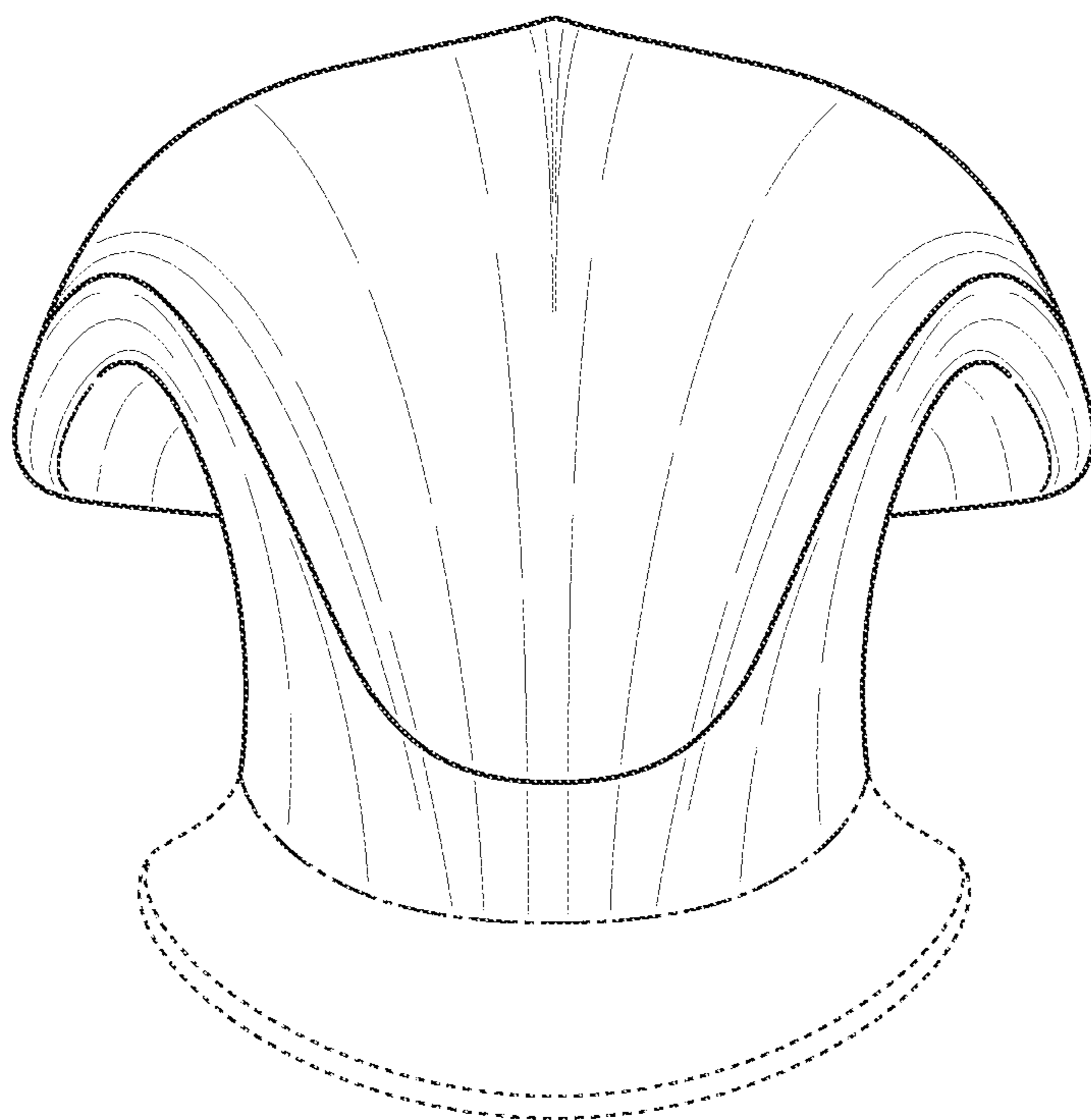

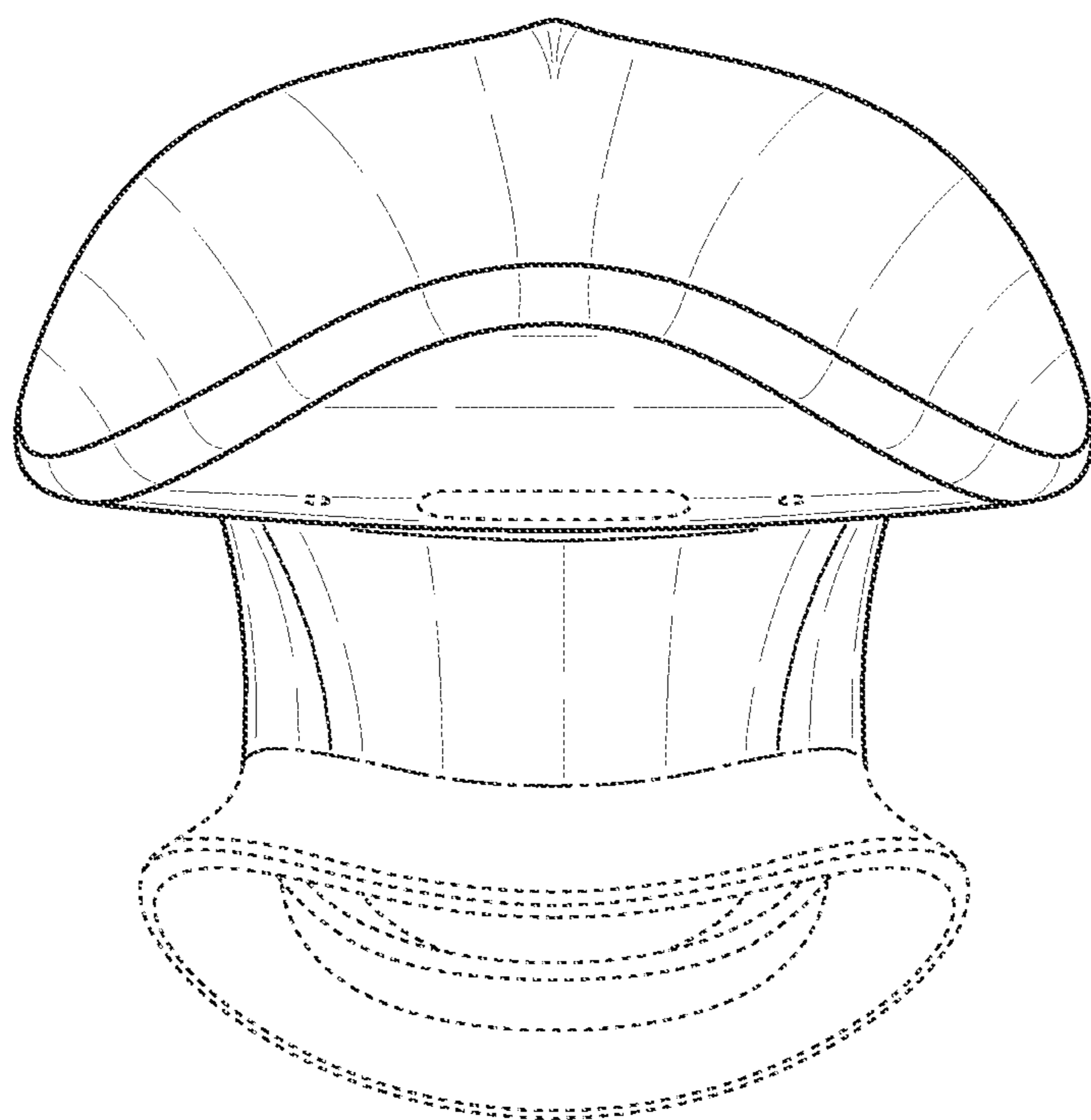

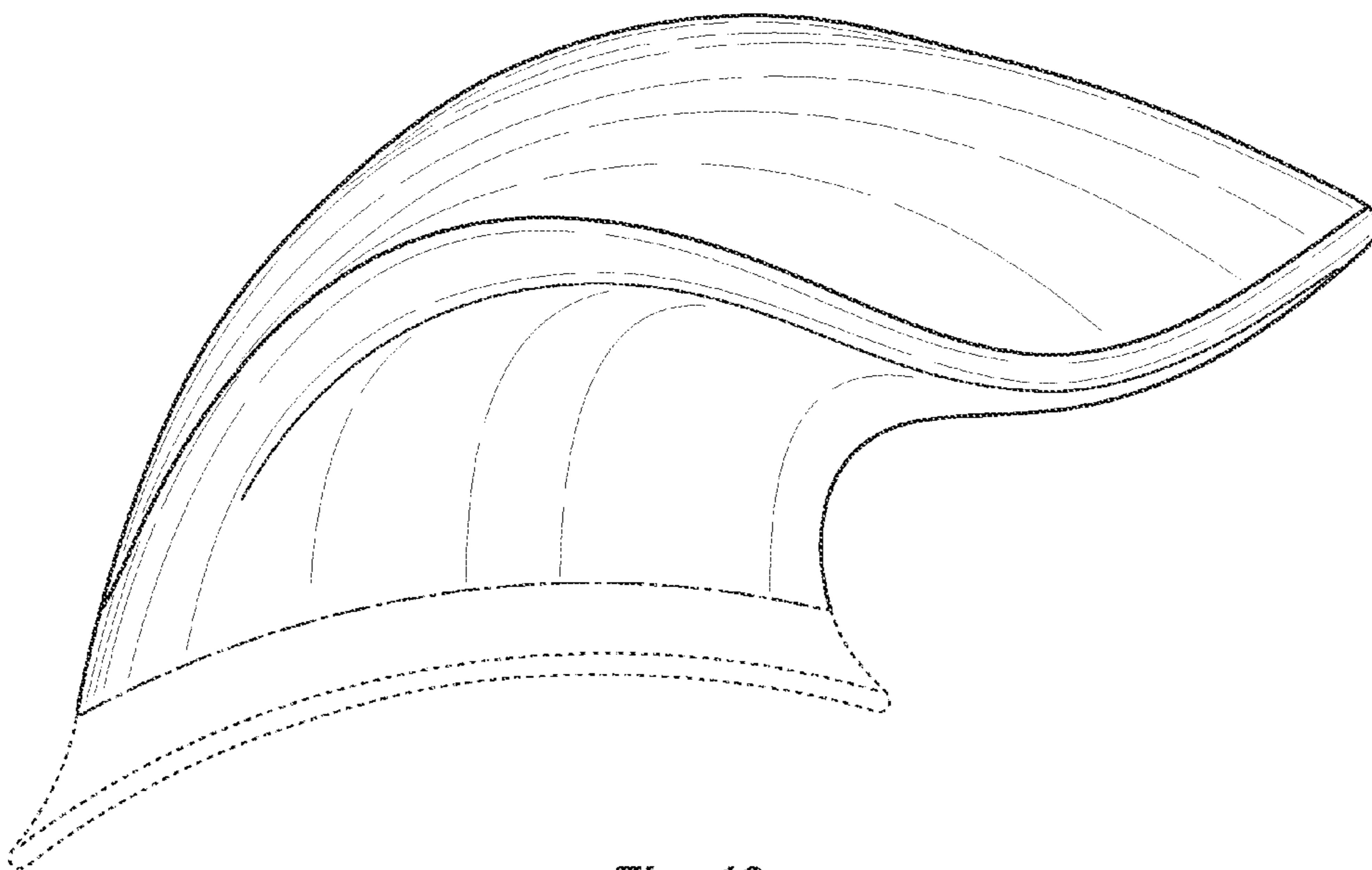

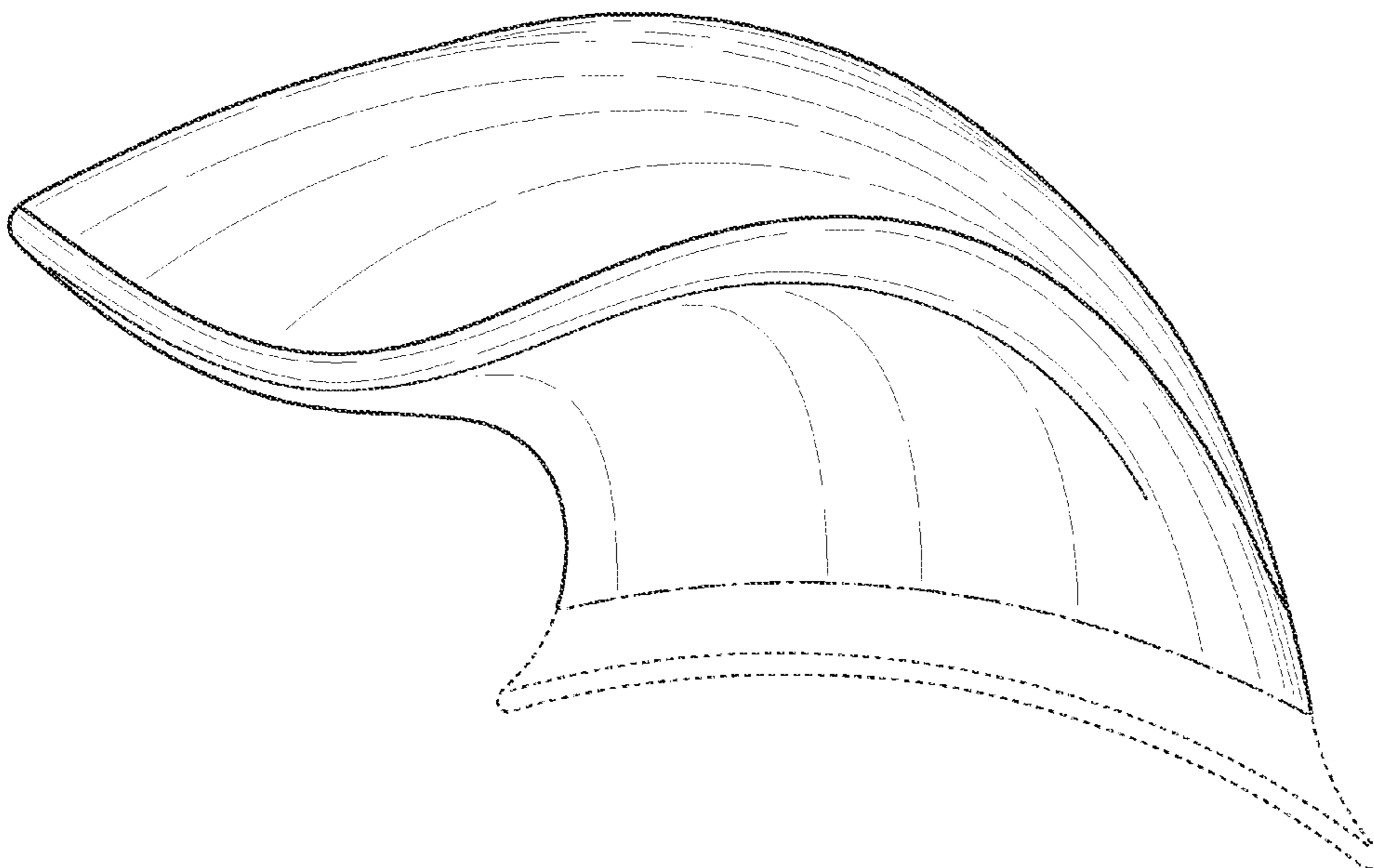

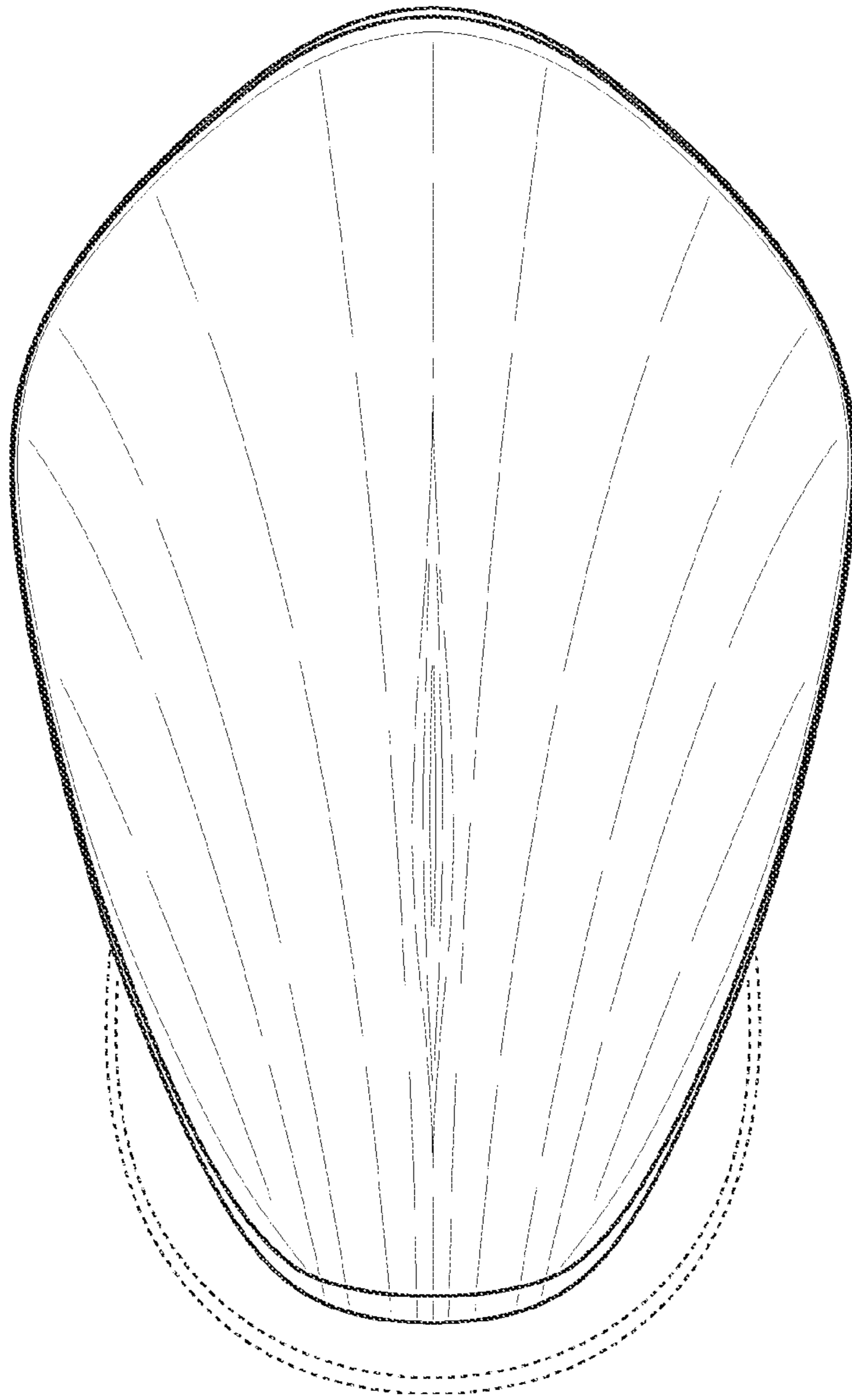

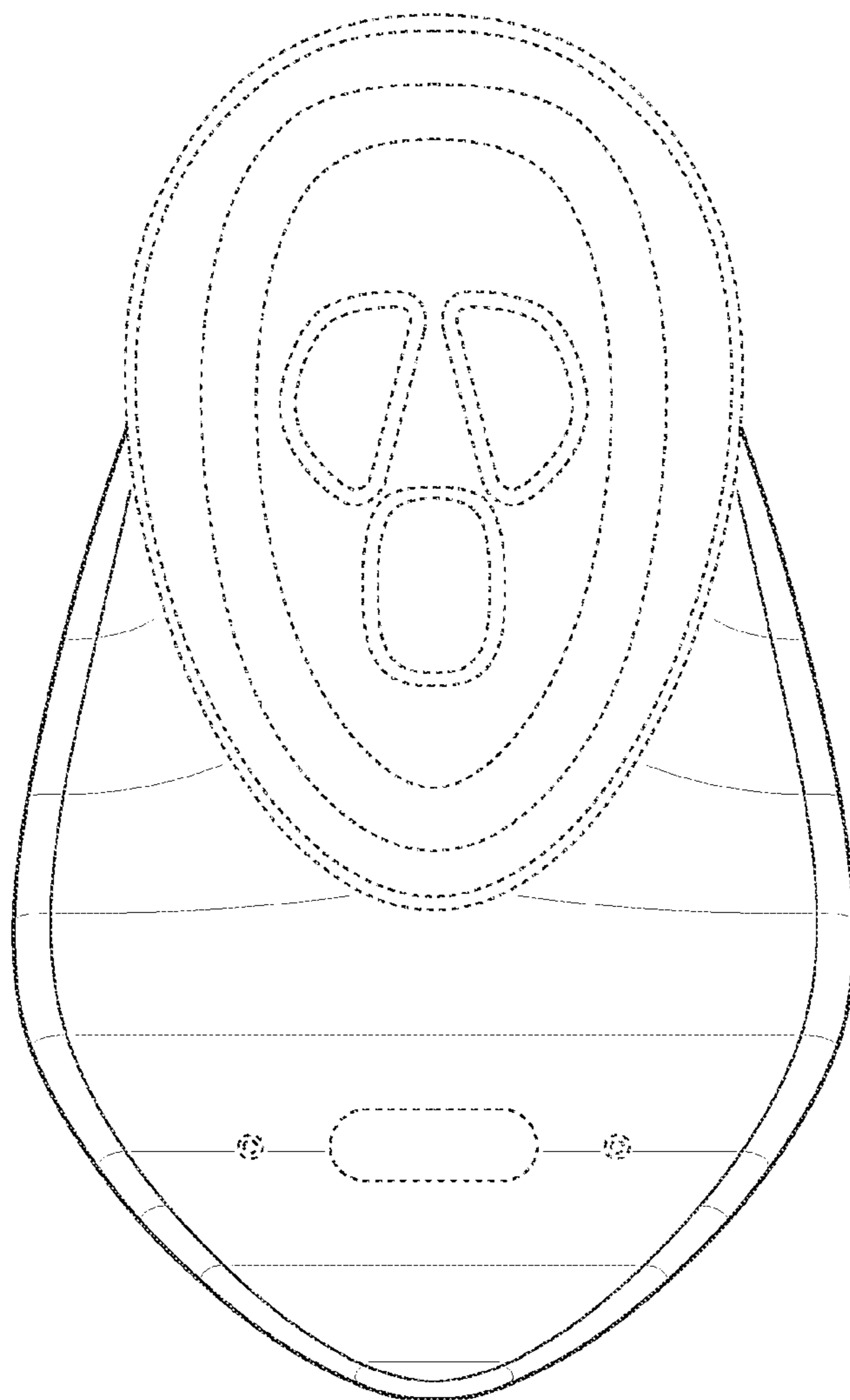
