**DESCRIPTION**

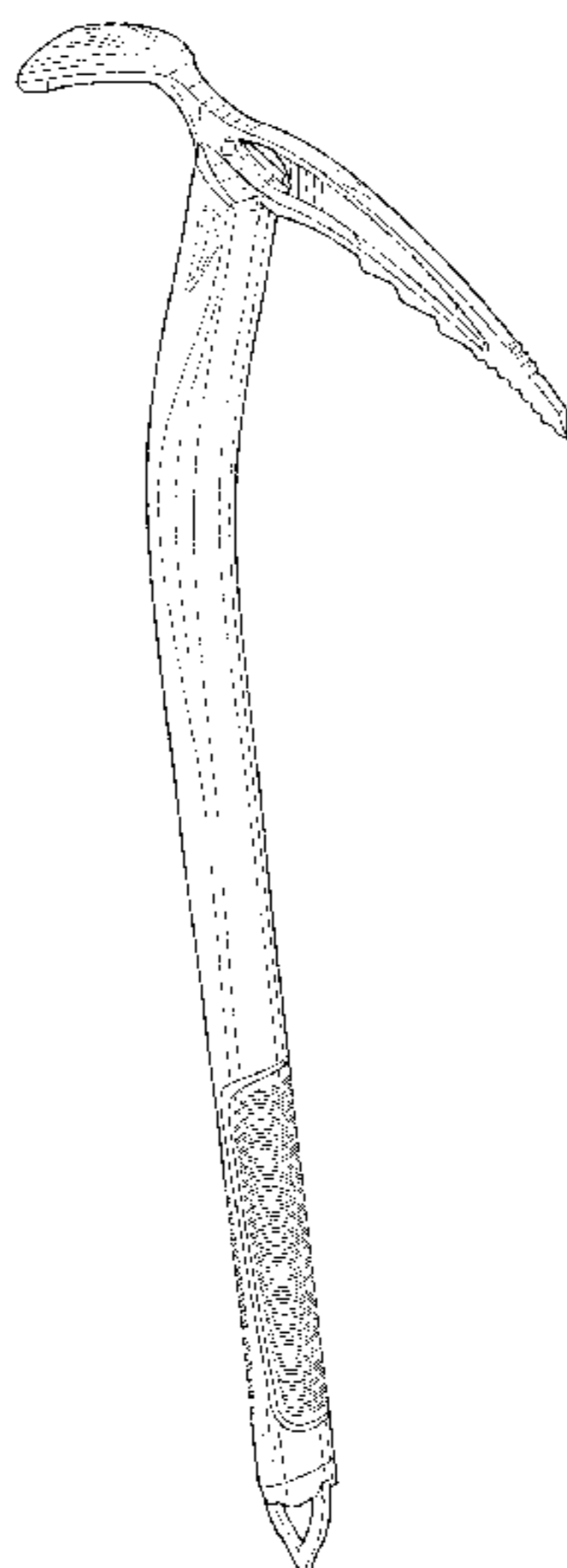
FIG. 1 is a front, left-side, top perspective view of the ice axe; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is an enlarged front, left-side, top perspective of a top portion of the ice axe as seen in FIG. 1. The broken line in FIG. 7 is a symbol showing the limit of claimed subject matter that is enlarged. It has no bearing on the claim and is used to facilitate illustration only.

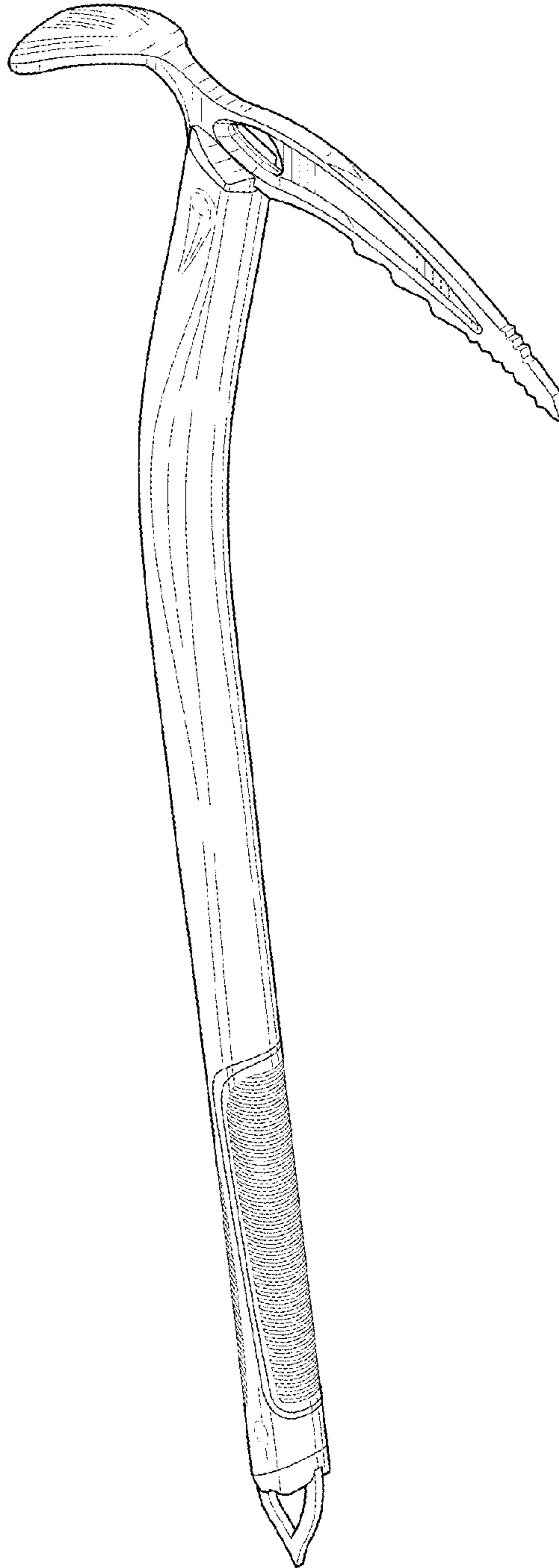

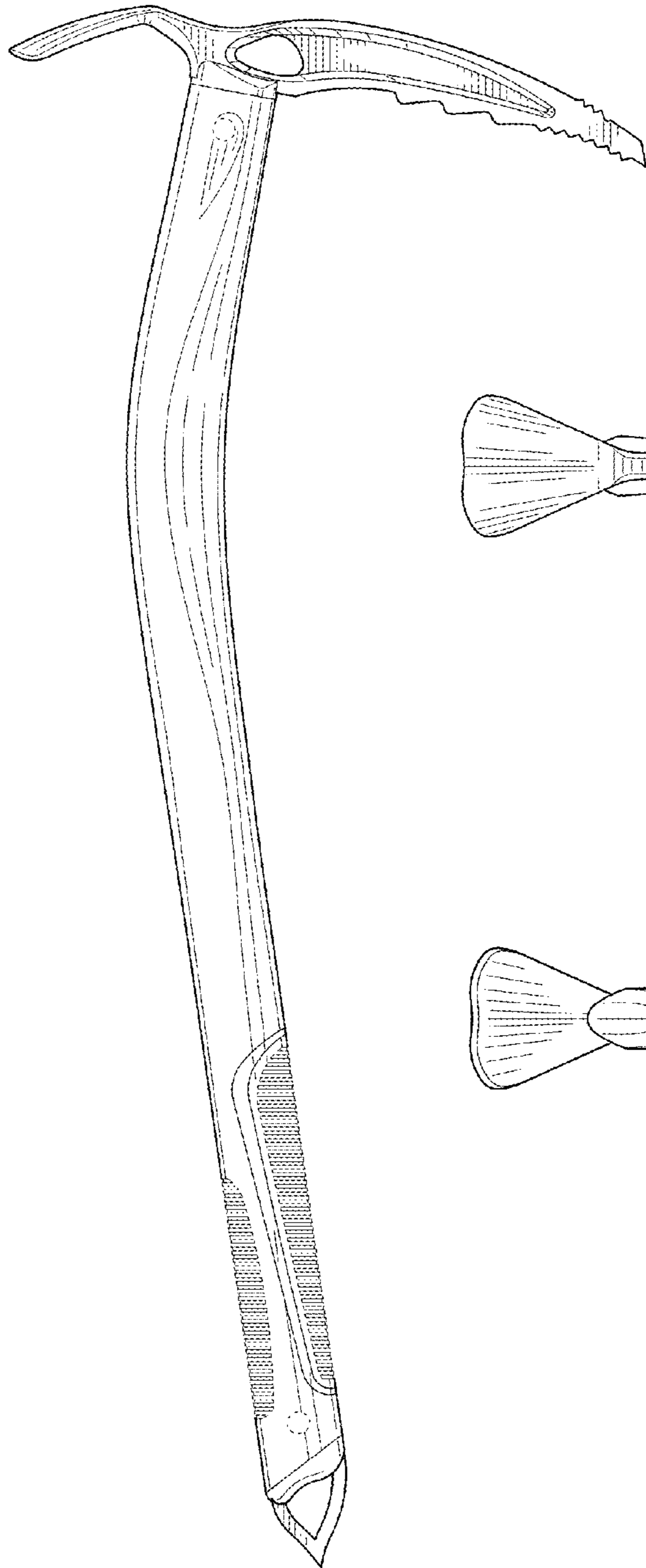

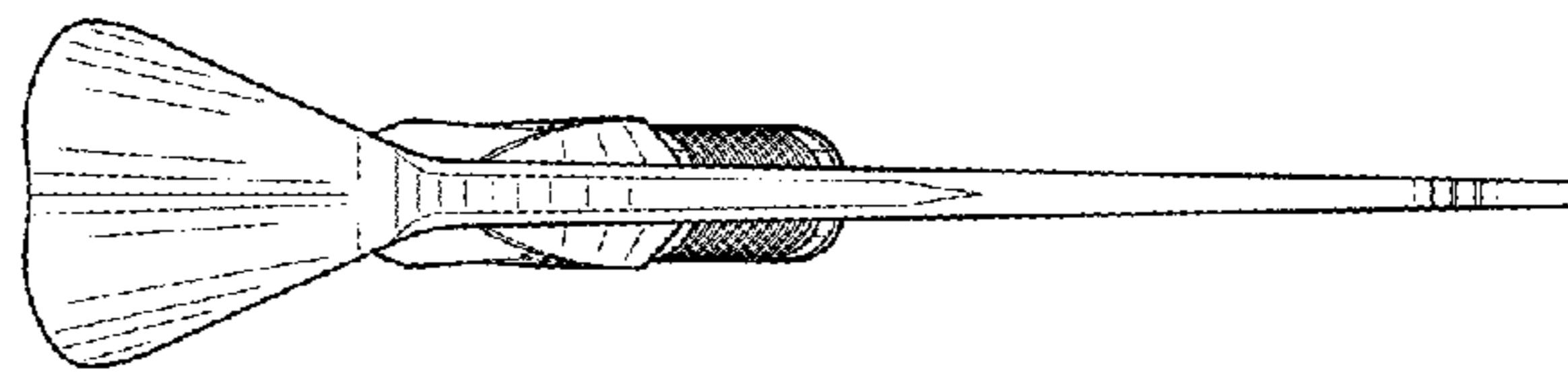

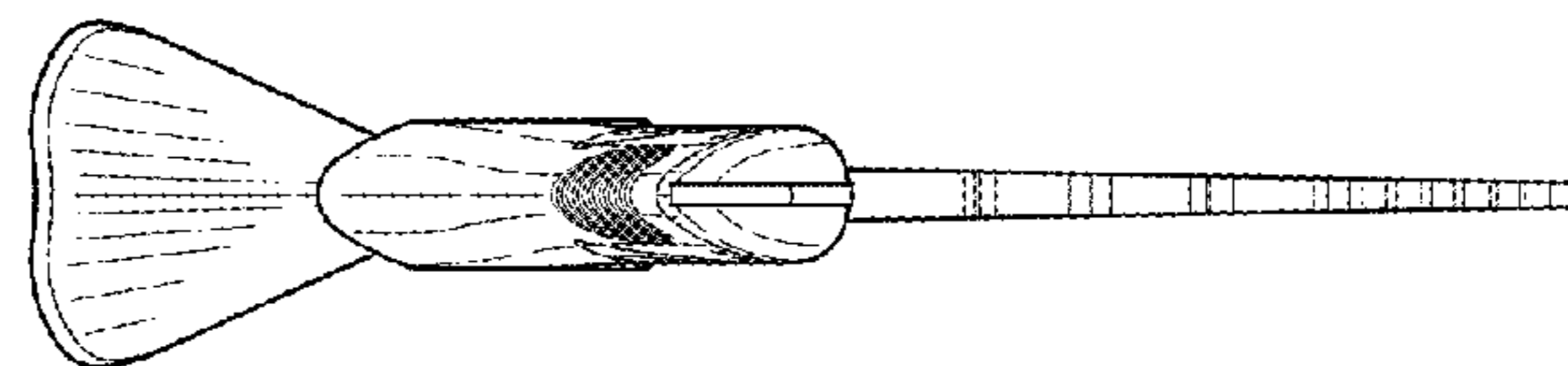

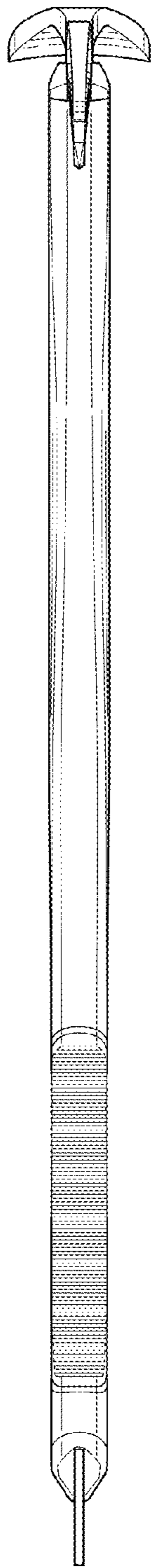

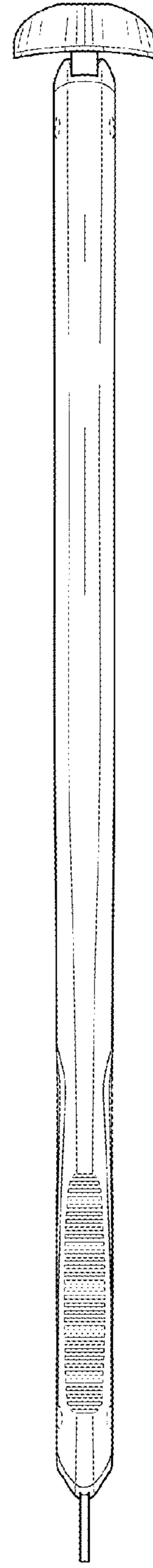

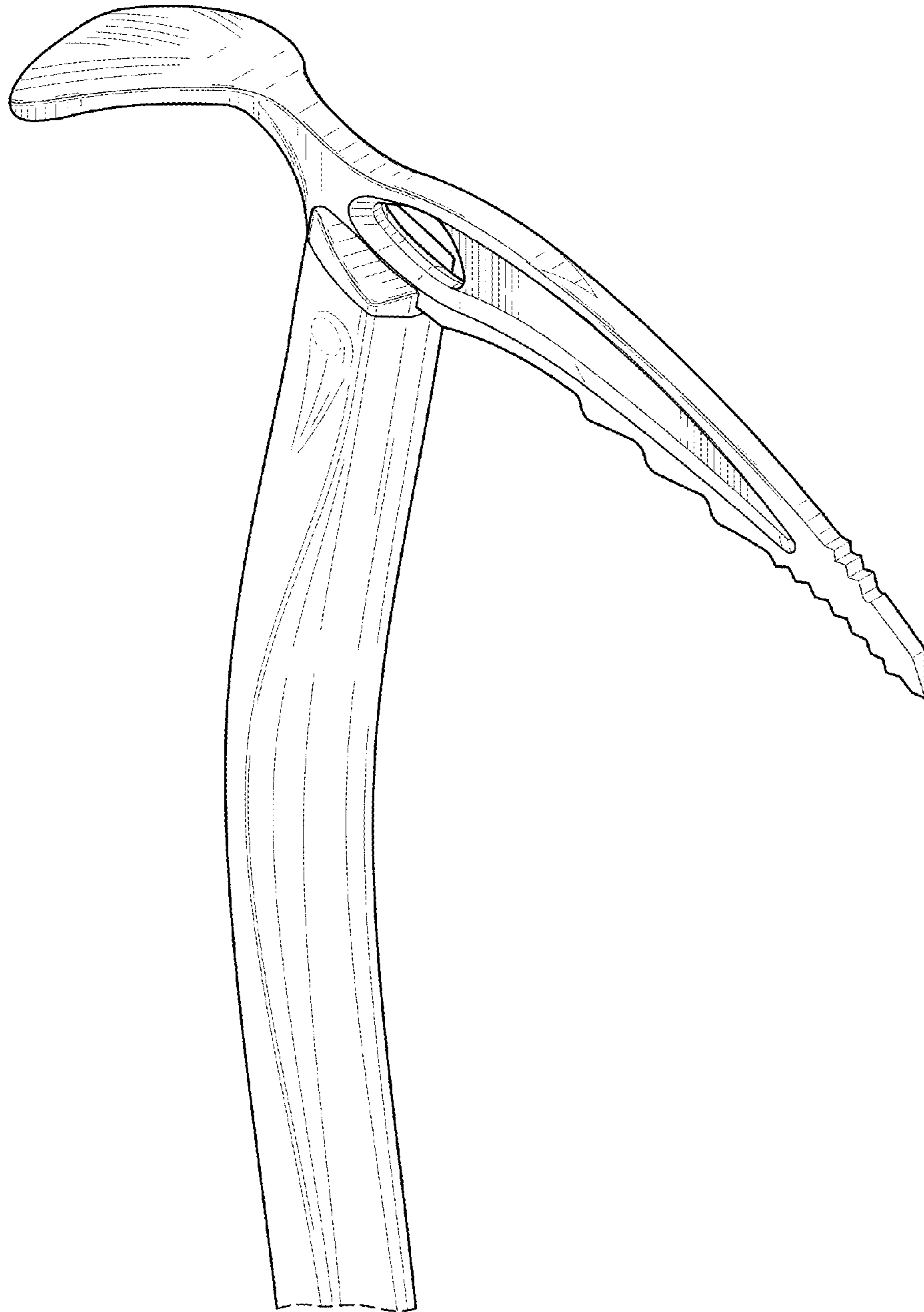
