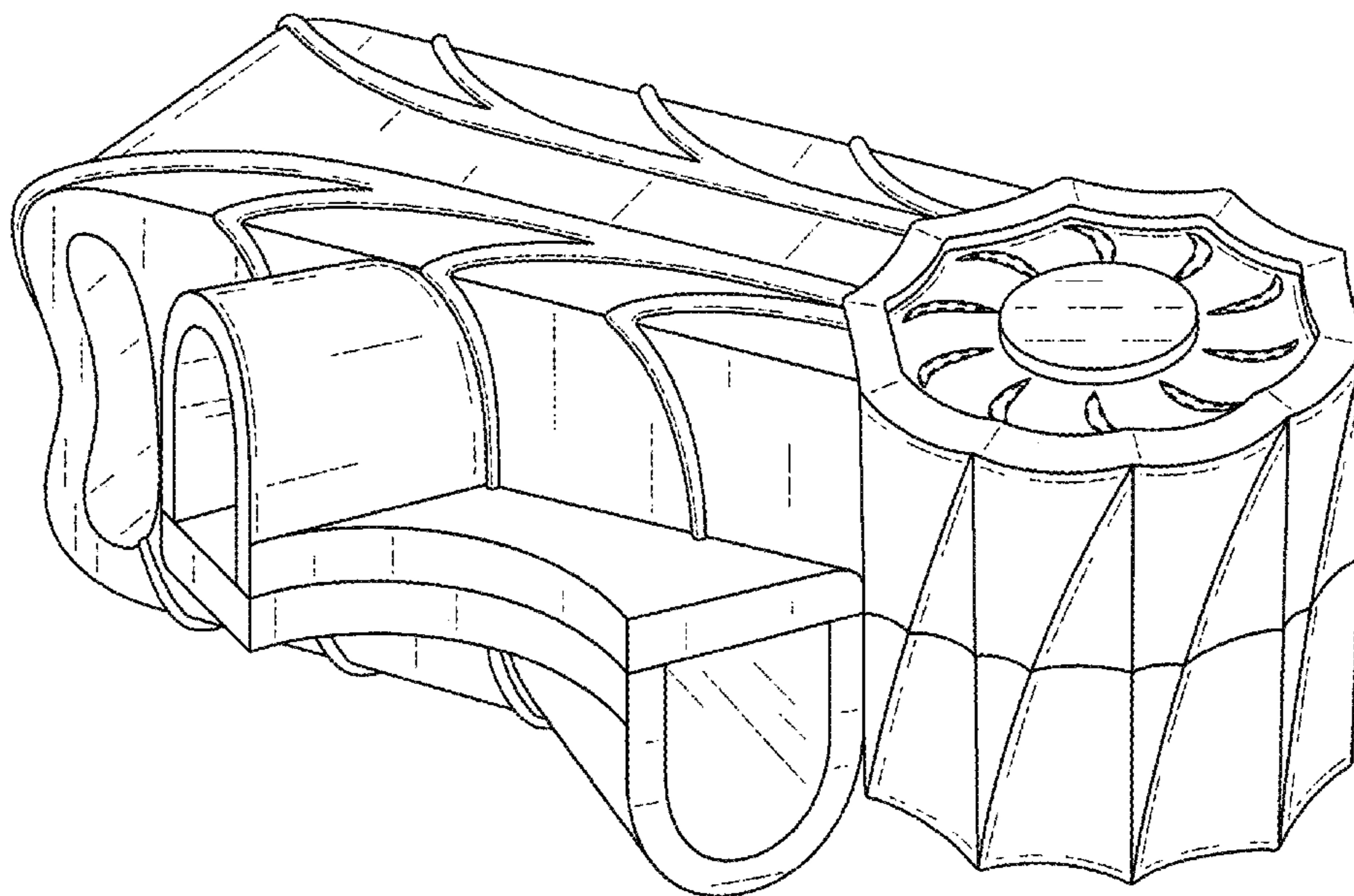
(57) **CLAIM**

The ornamental design for a fence-post clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a fence-post clip showing my new design;  
FIG. 2 is the rear elevational view thereof;  
FIG. 3 is the top plan view thereof;  
FIG. 4 is the bottom plan view thereof;  
FIG. 5 is the right side elevational view thereof;  
FIG. 6 is the left side elevational view thereof;  
FIG. 7 is the front elevational view of an alternate position thereof;  
FIG. 8 is the cross-sectional front elevational view of an alternate position thereof;  
FIG. 9 is the bottom plan view of the top half thereof;  
FIG. 10 is the top plan view of the bottom half thereof; and,  
FIG. 11 is a perspective view thereof.  
The broken lines in the figures represent portions of the fence-post clip that form no part of the claimed design.

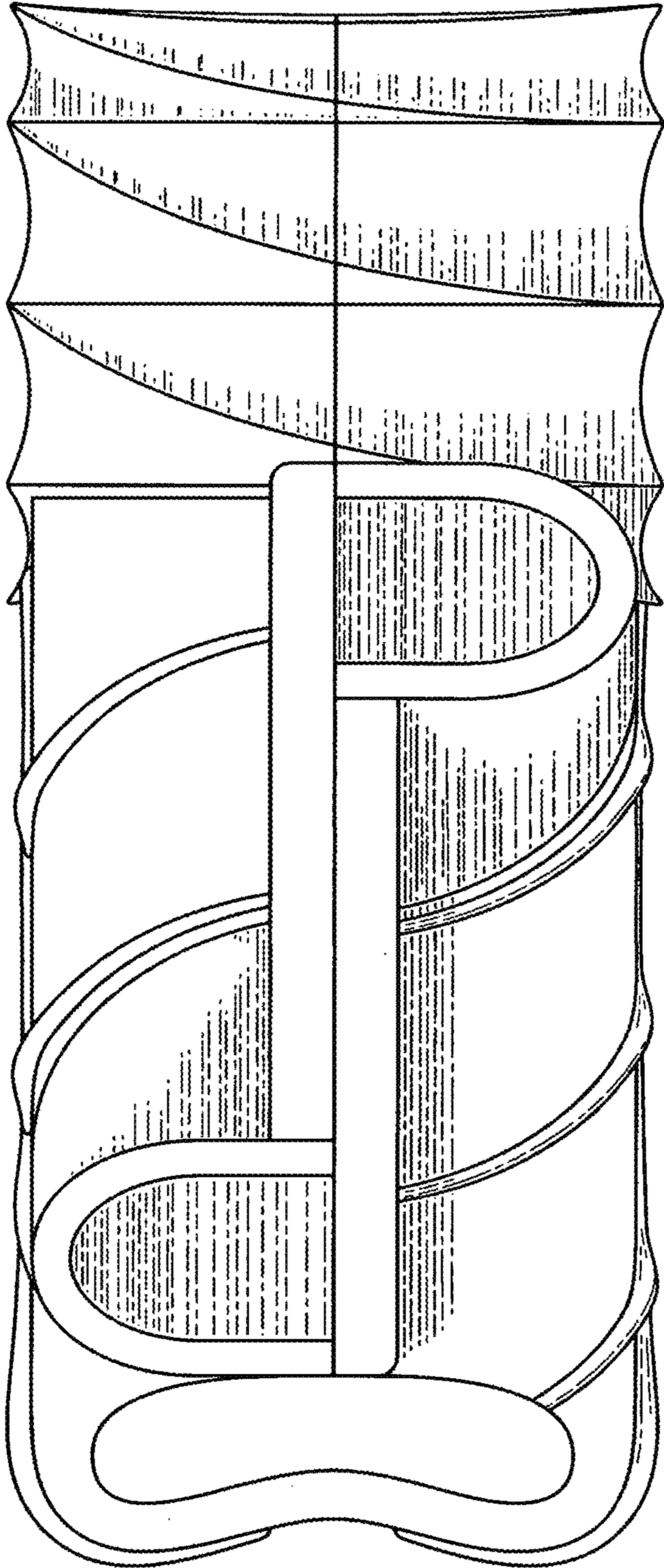

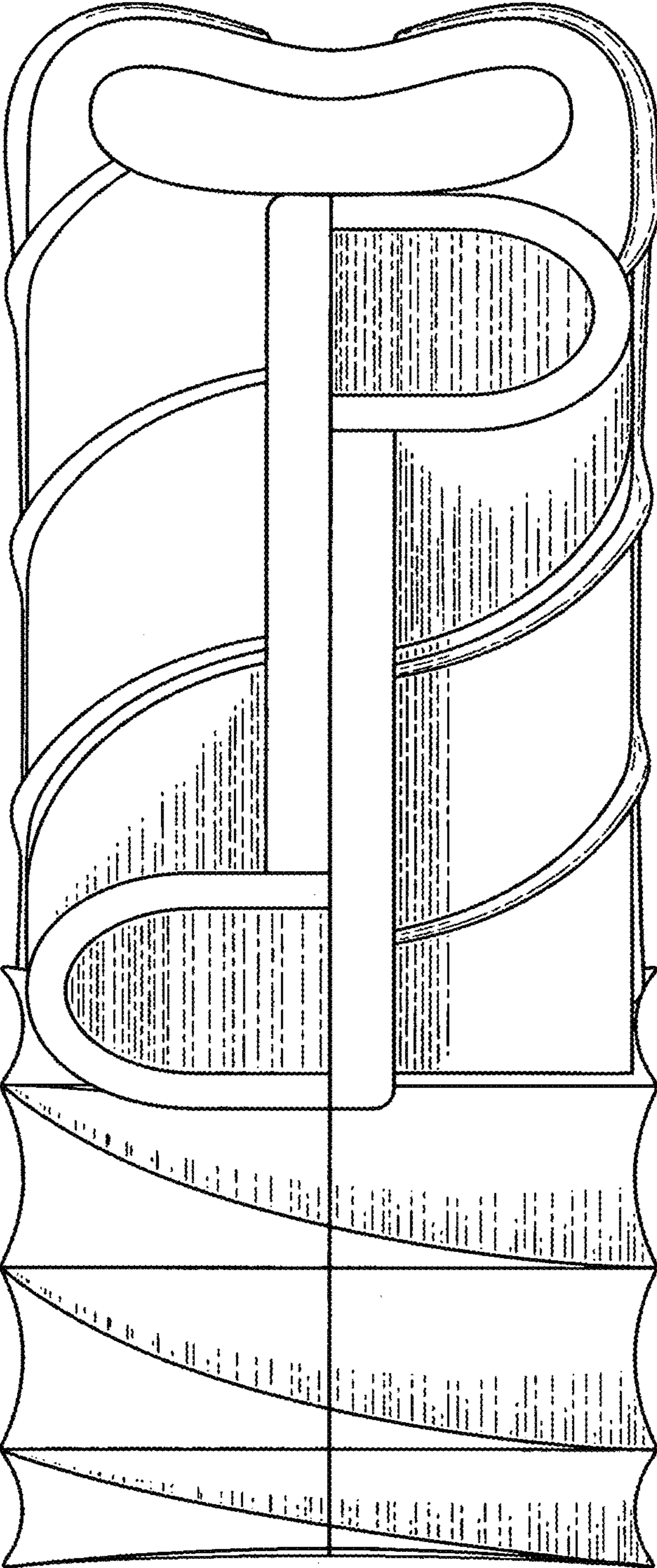
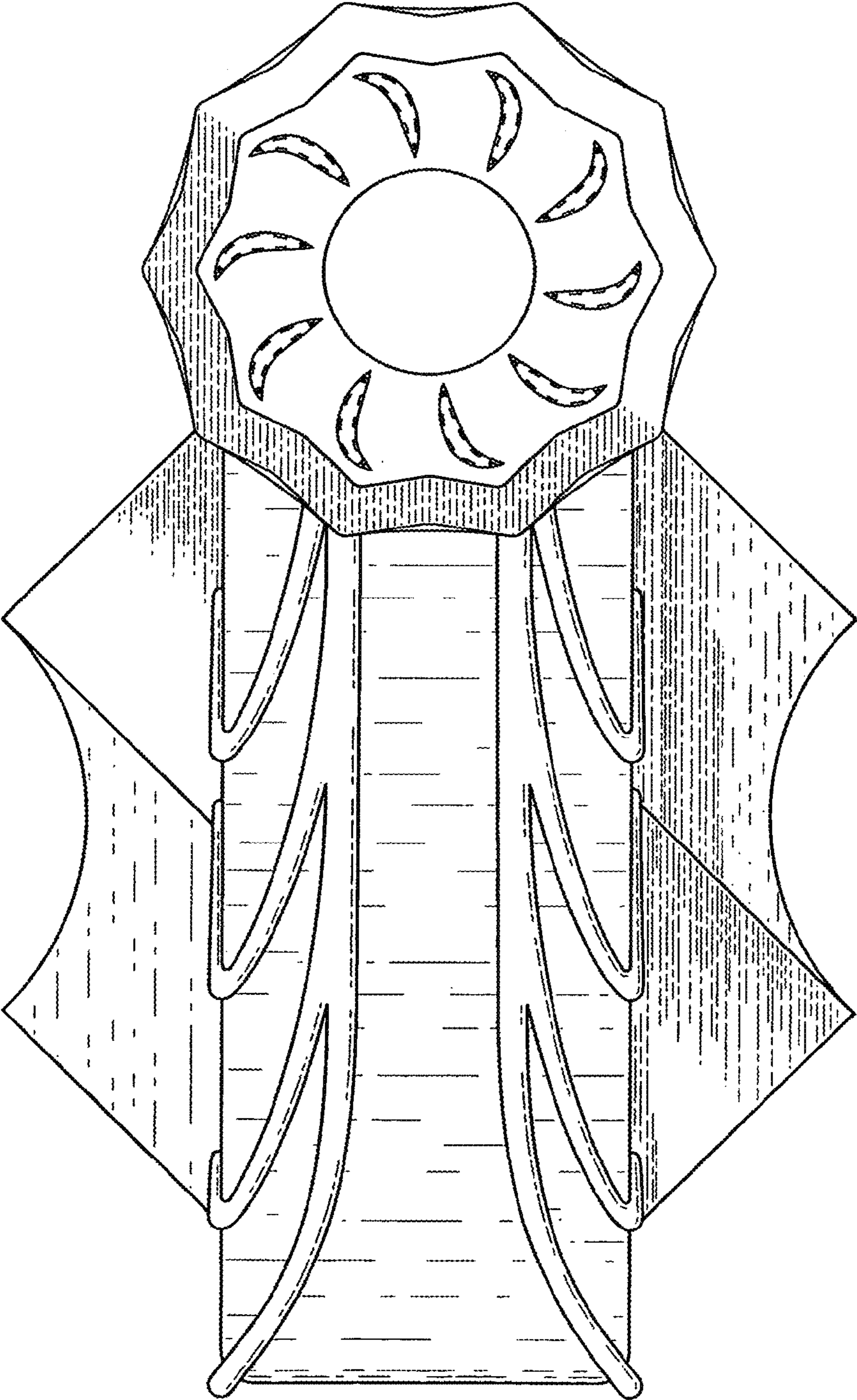

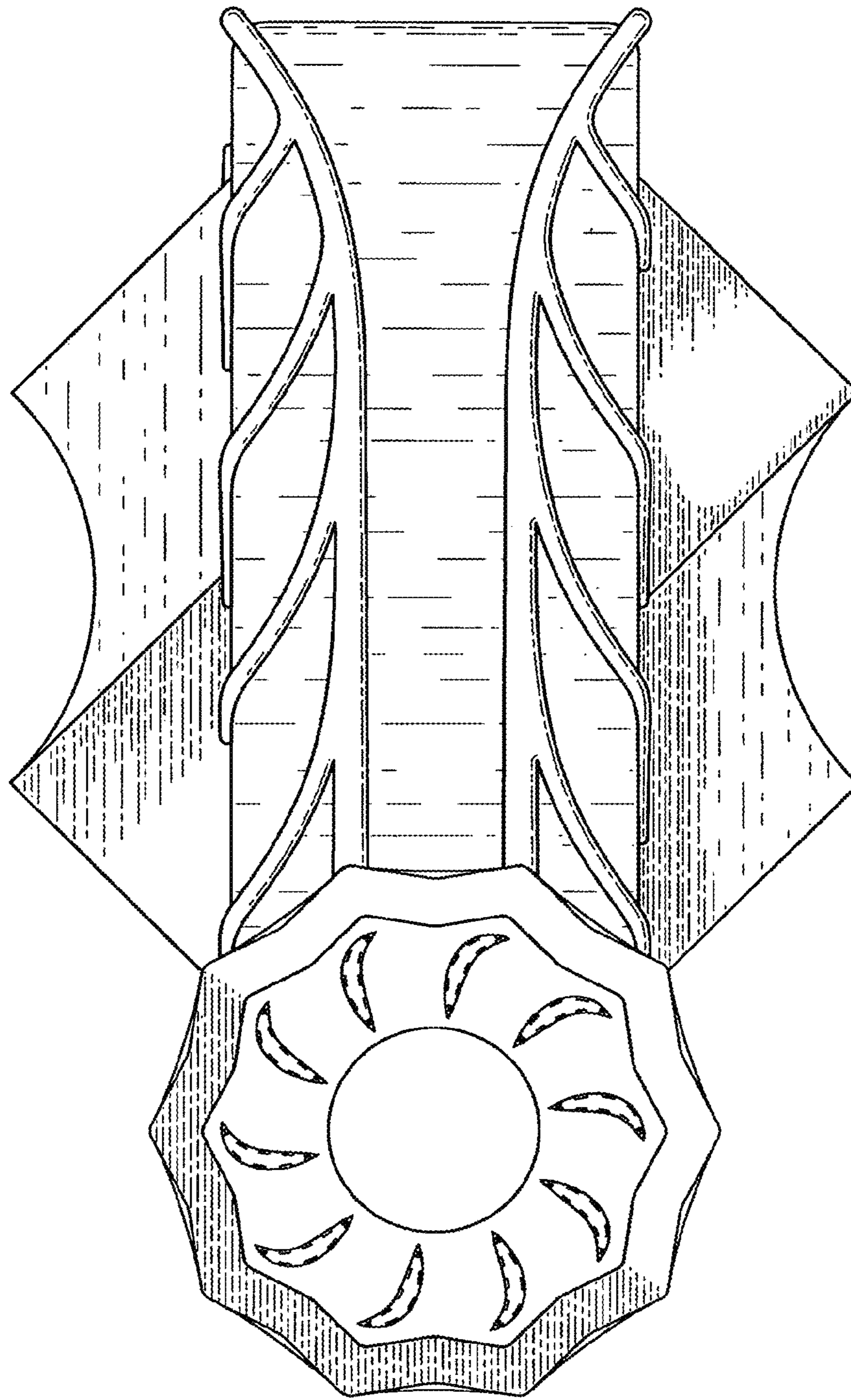
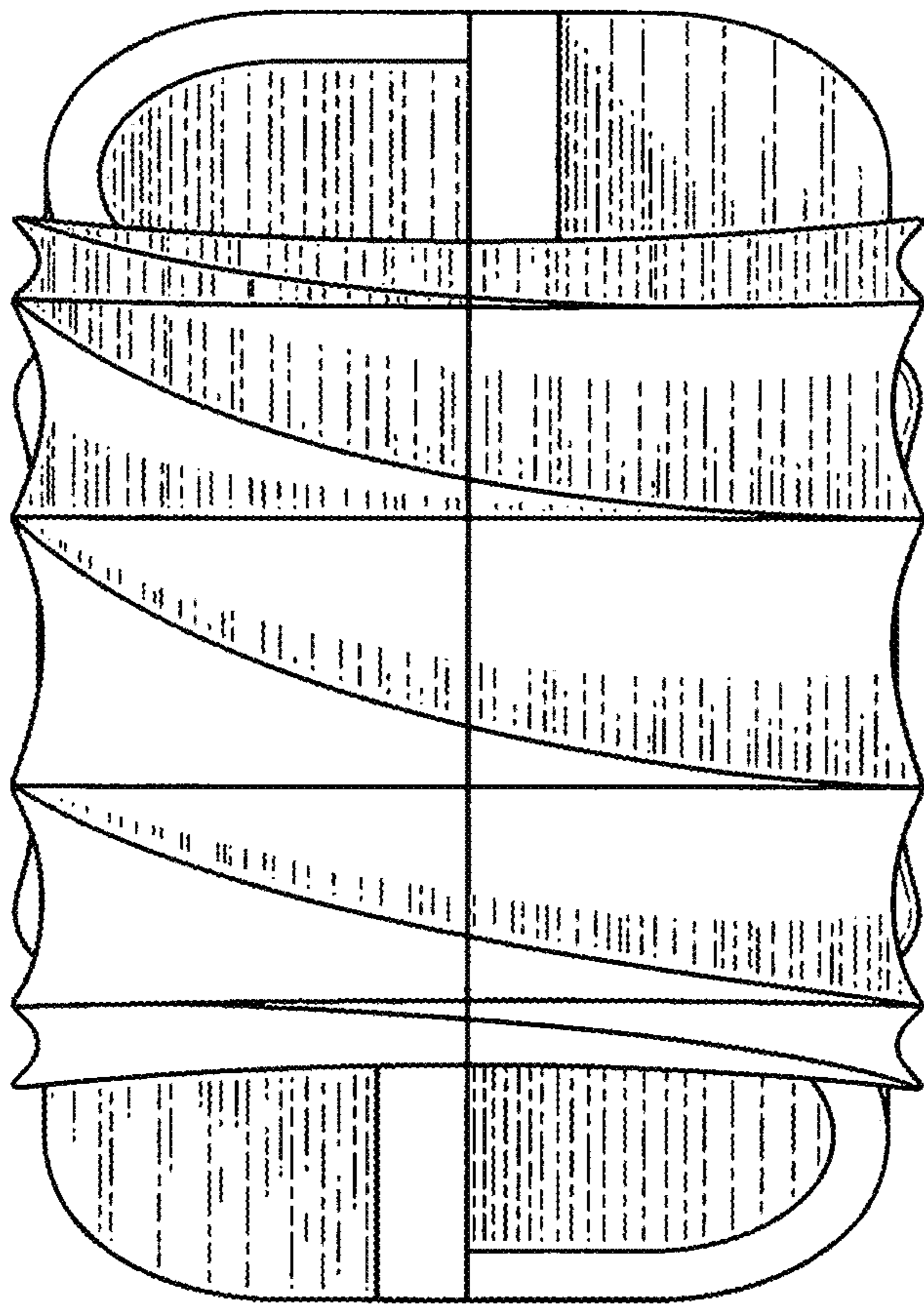
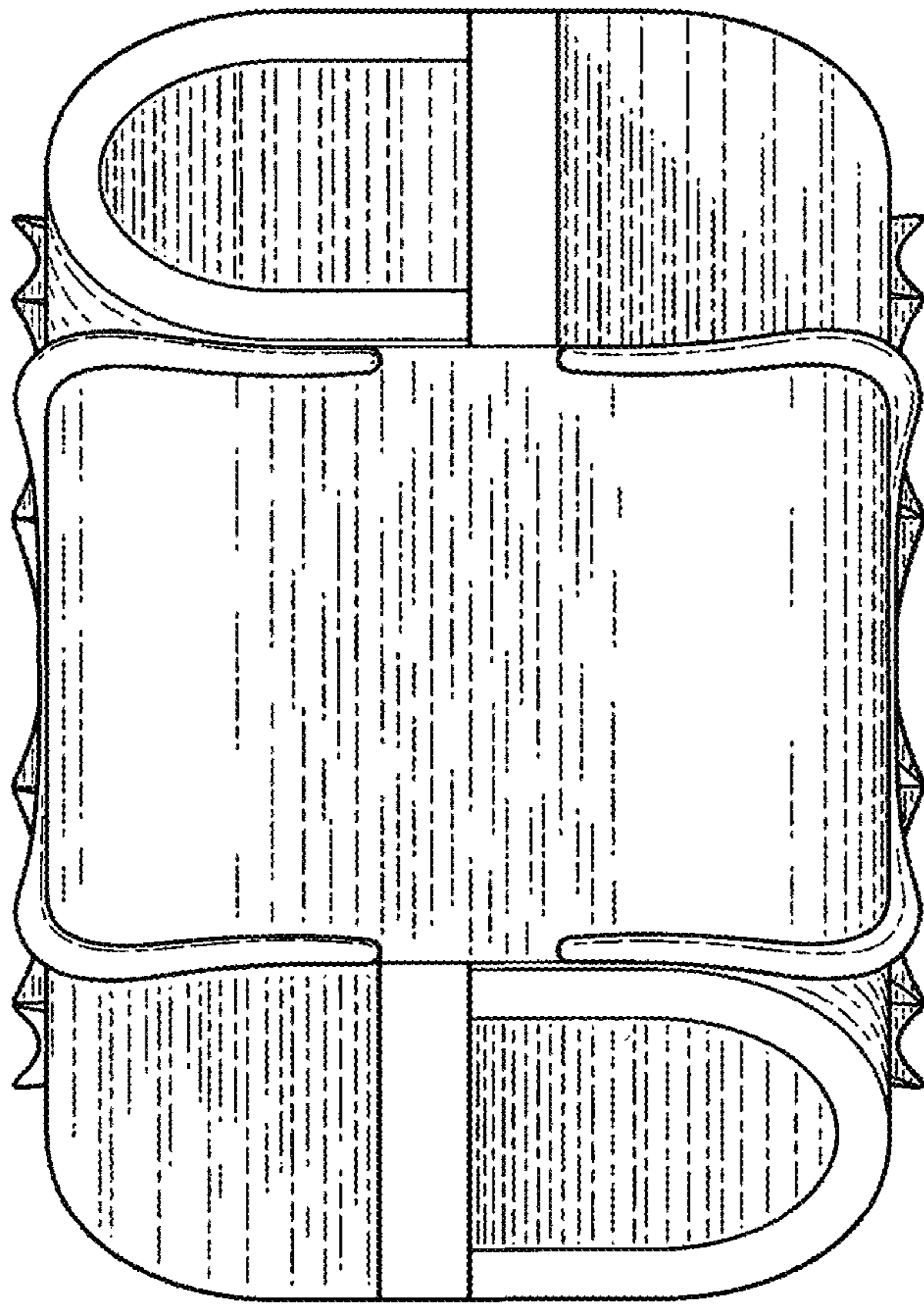

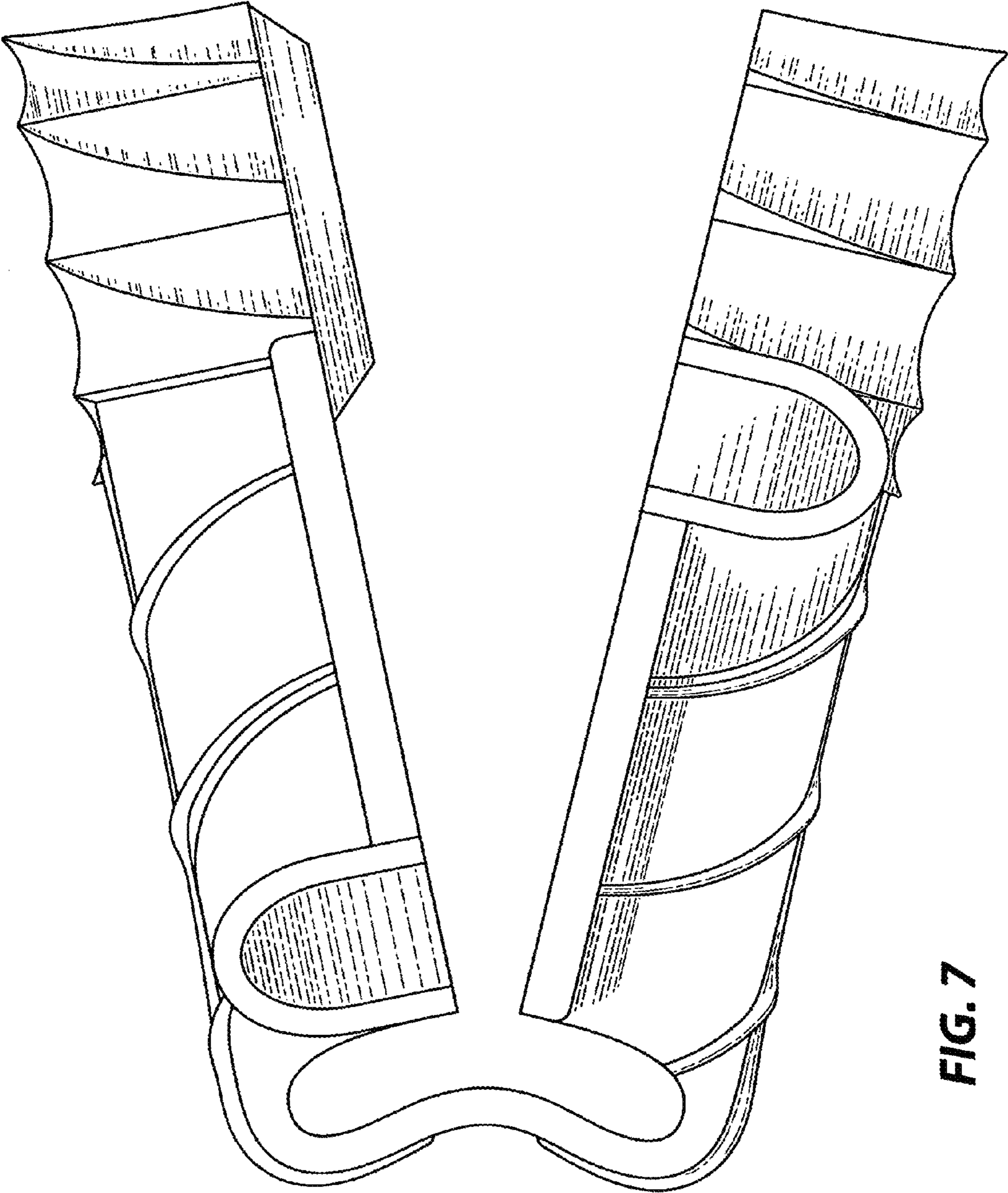

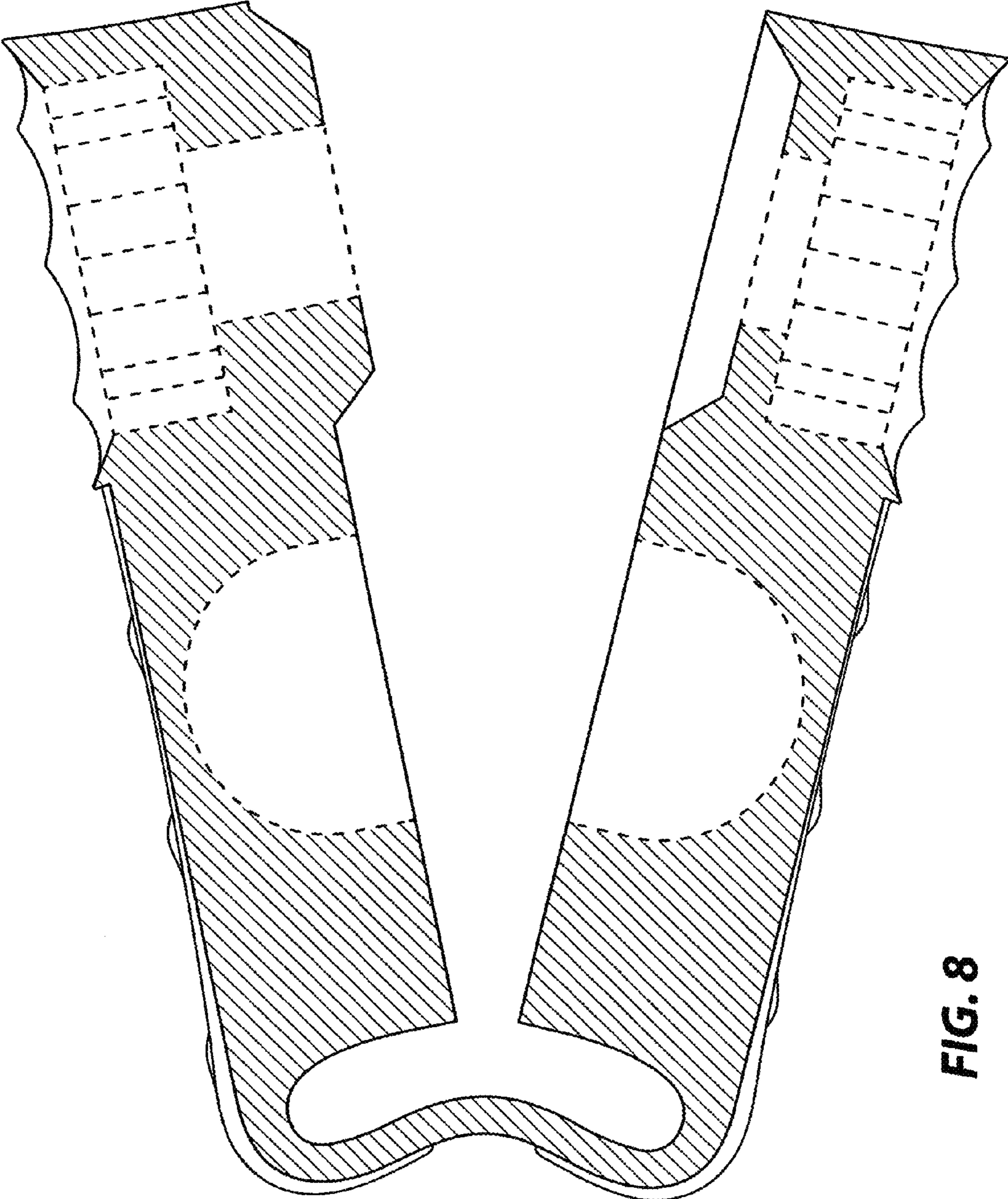
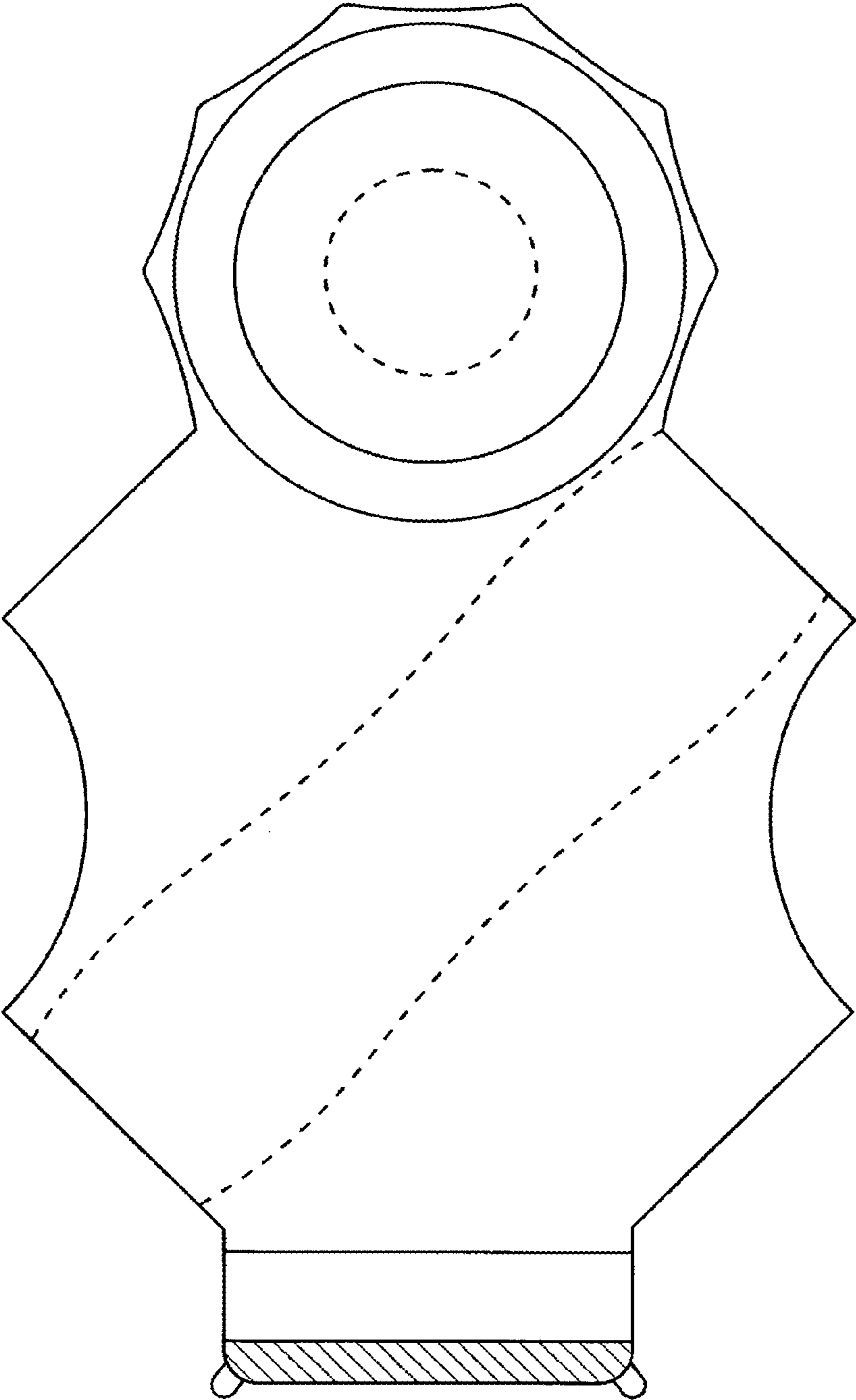
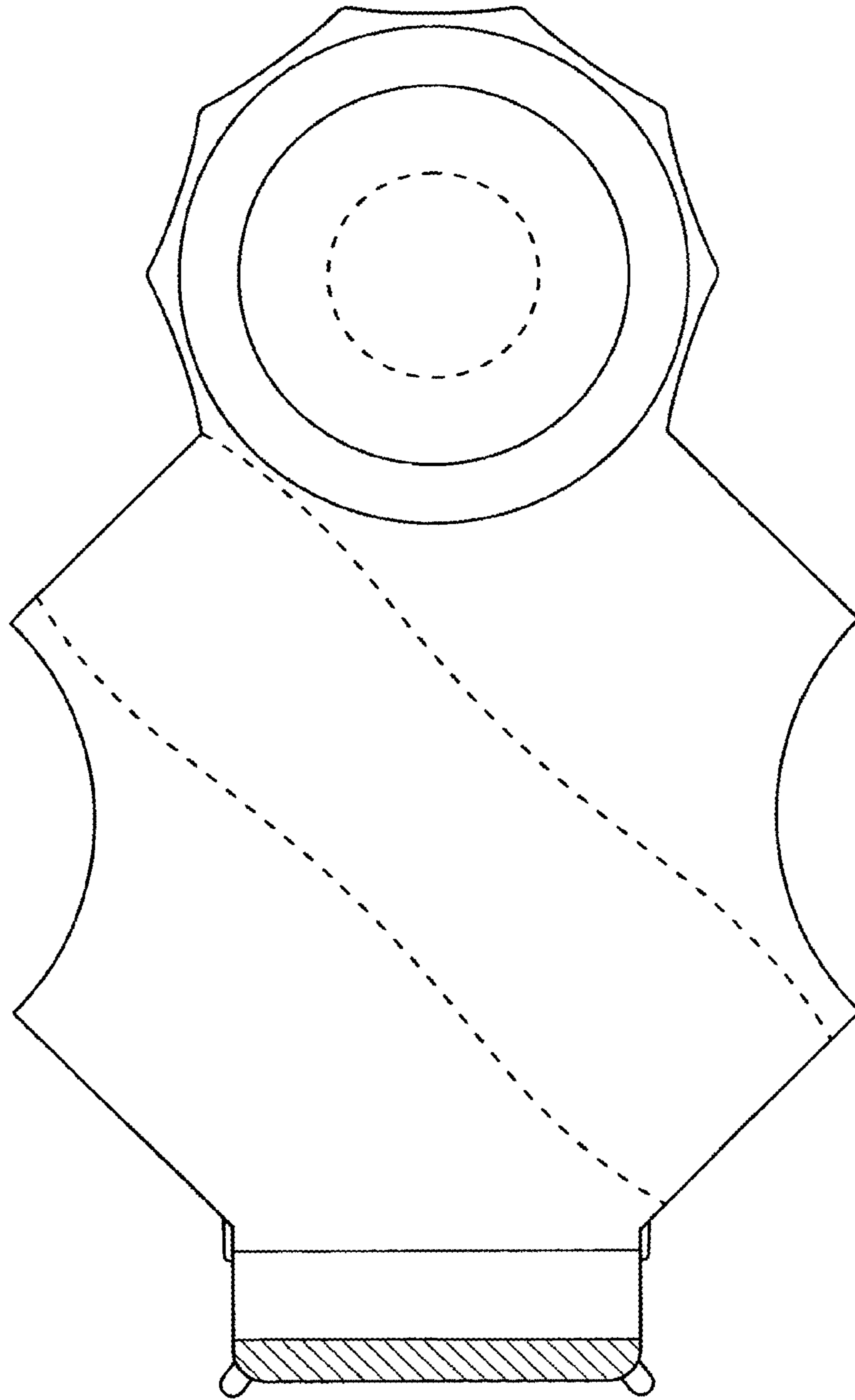


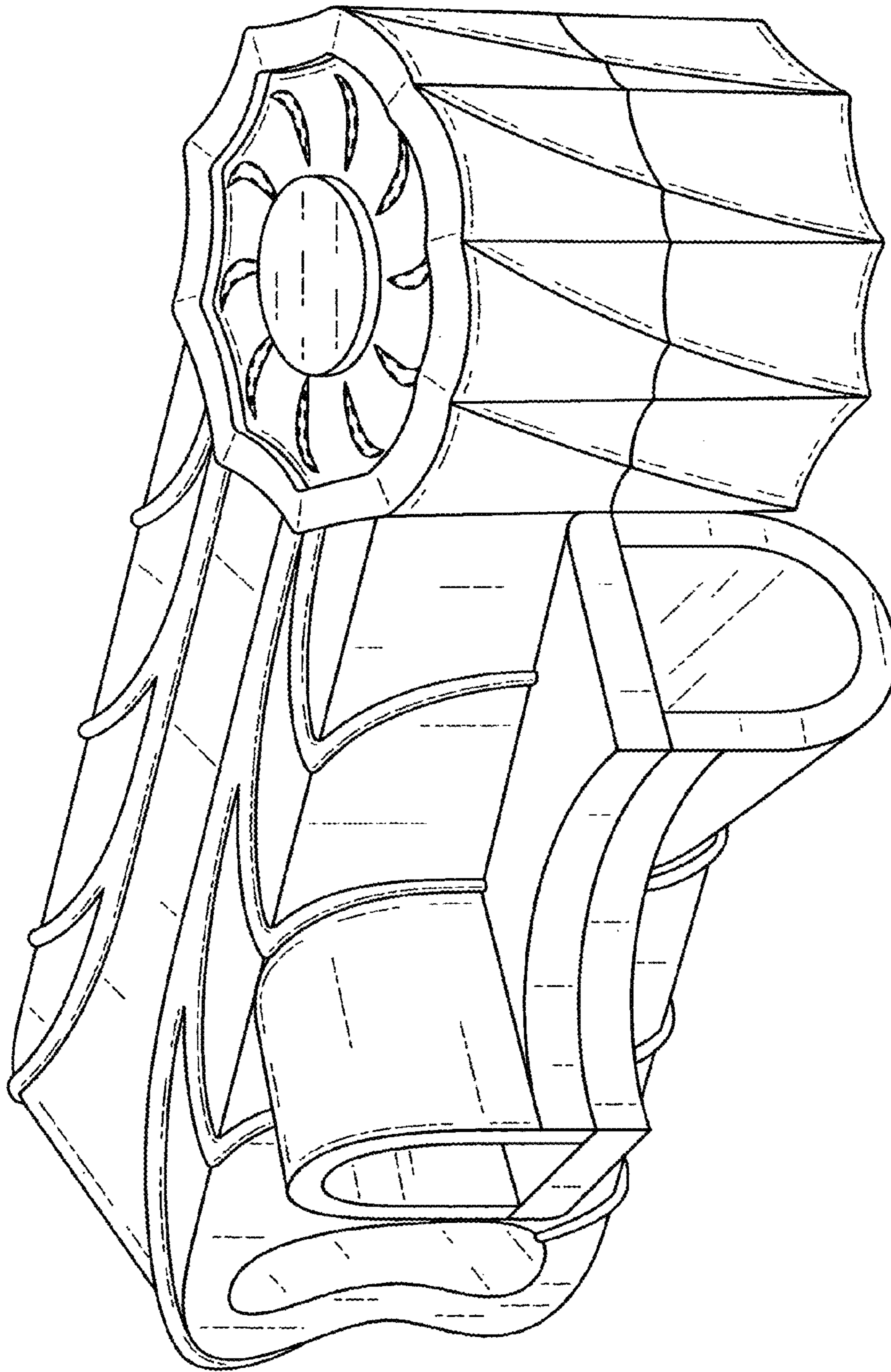
