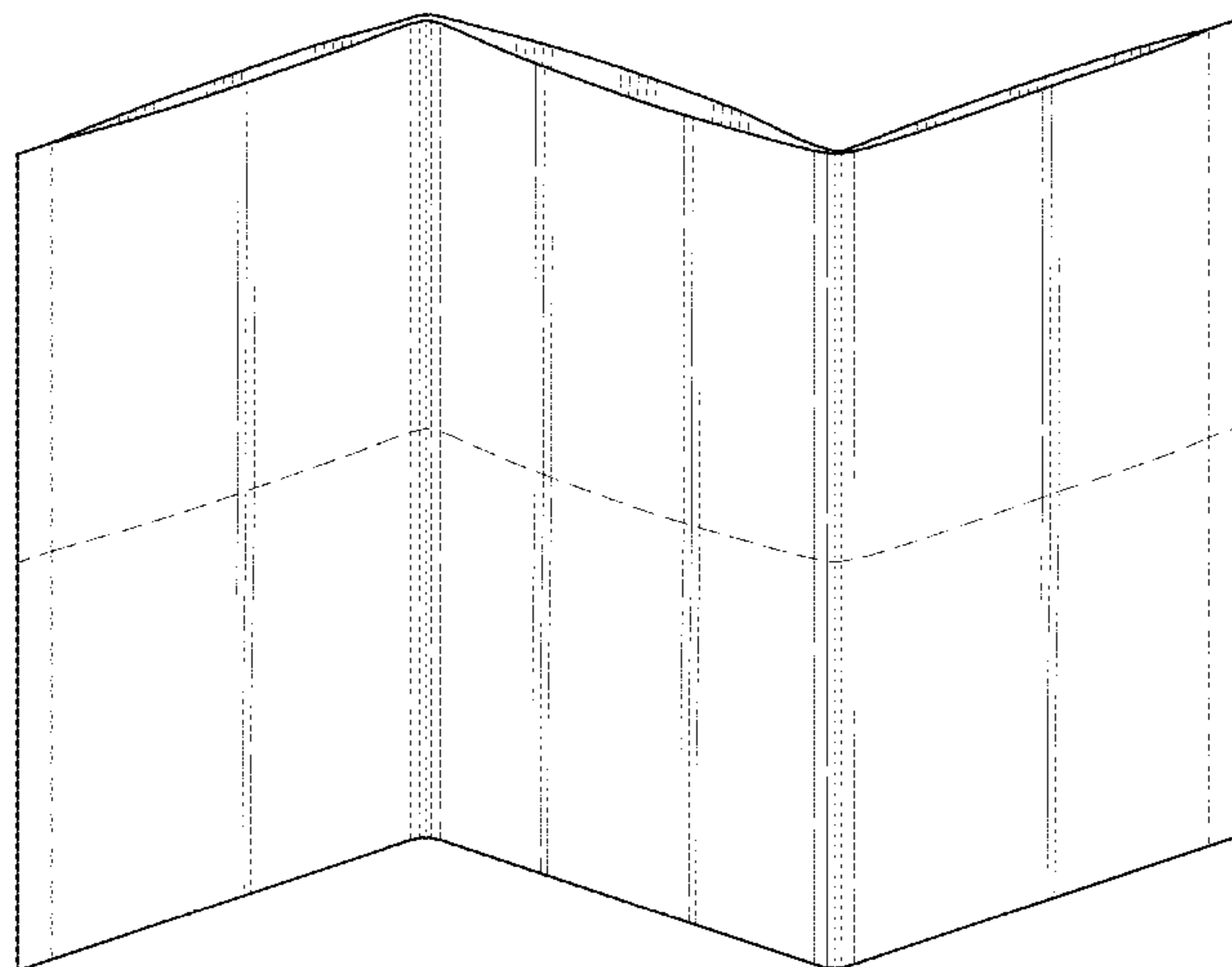
(57) **CLAIM**

The ornamental design for a Z-folded microwave foodstuff package, as shown and described.

DESCRIPTION

FIG. 1 is a bottom side perspective view of one embodiment of a Z-folded microwave foodstuff package of the claimed design;
FIG. 2 is a top side perspective view of the package of FIG. 1;
FIG. 3 is a front view of the package of FIG. 2;
FIG. 4 is a rear view of the package of FIG. 2;
FIG. 5 is a left side view of the package of FIG. 2;
FIG. 6 is a right side view of the package of FIG. 2;
FIG. 7 is a top view of the package of FIG. 2; and,
FIG. 8 is a bottom view of the package of FIG. 2.
The broken line showing of portions of the Z-folded microwave food-stuff package is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

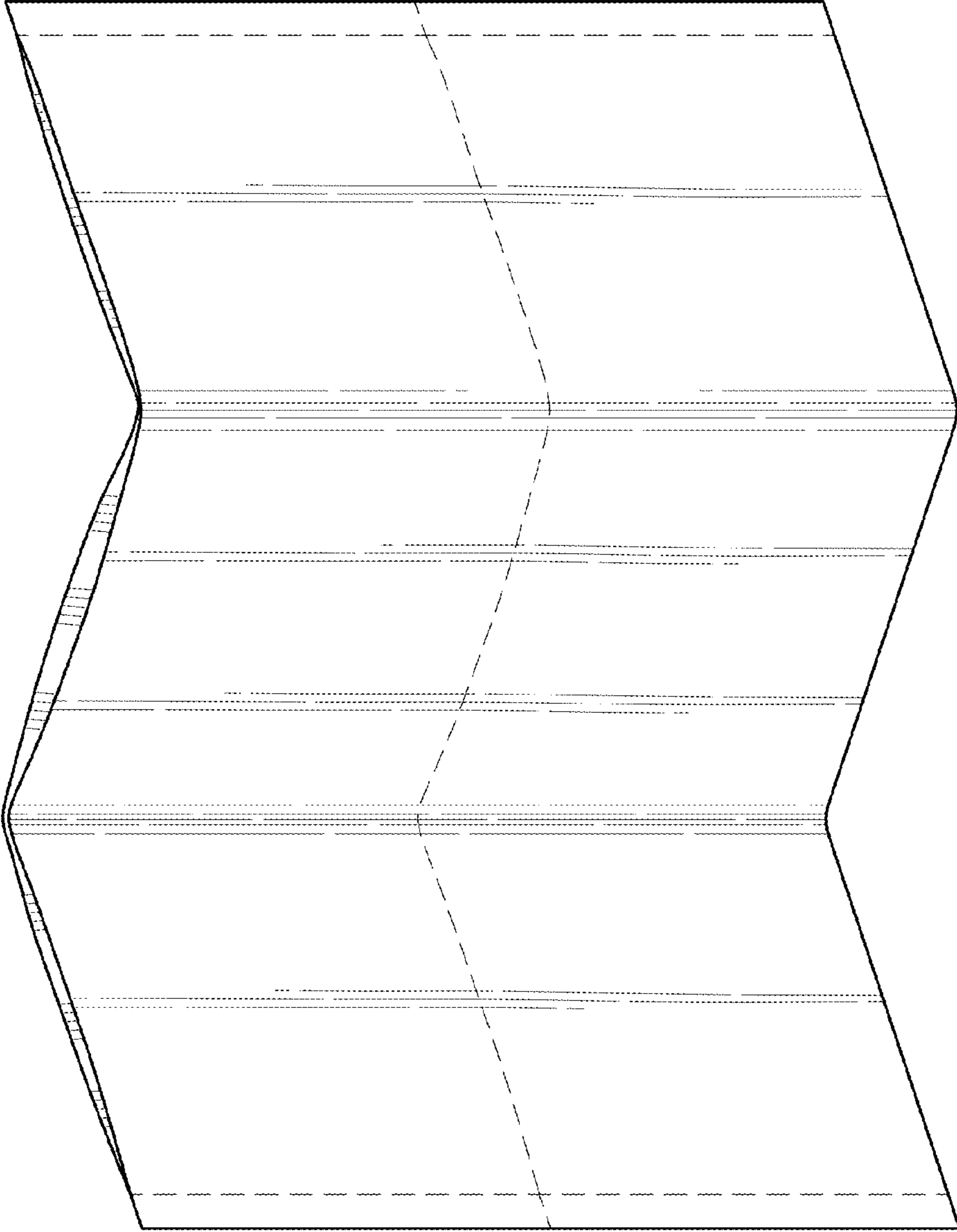

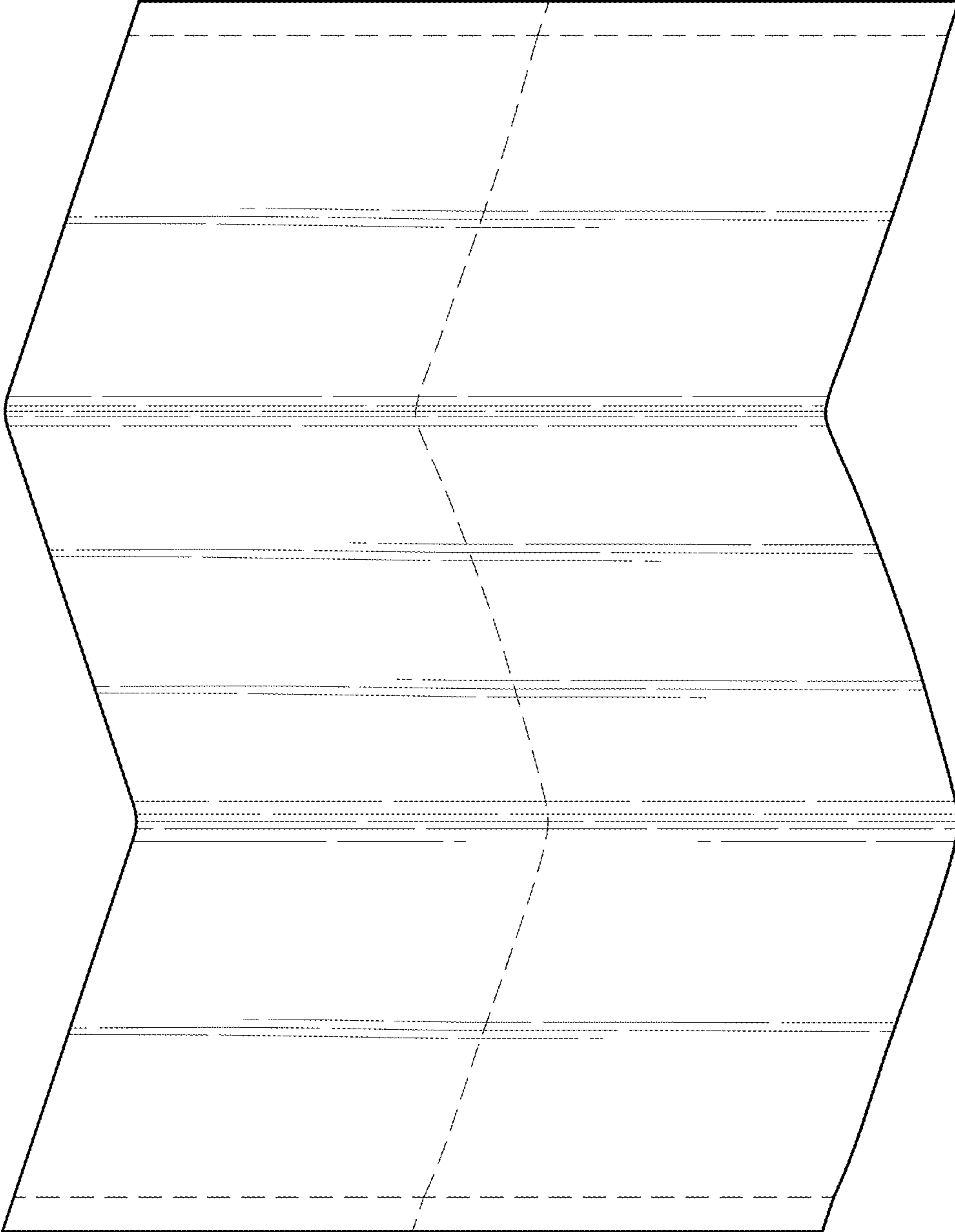

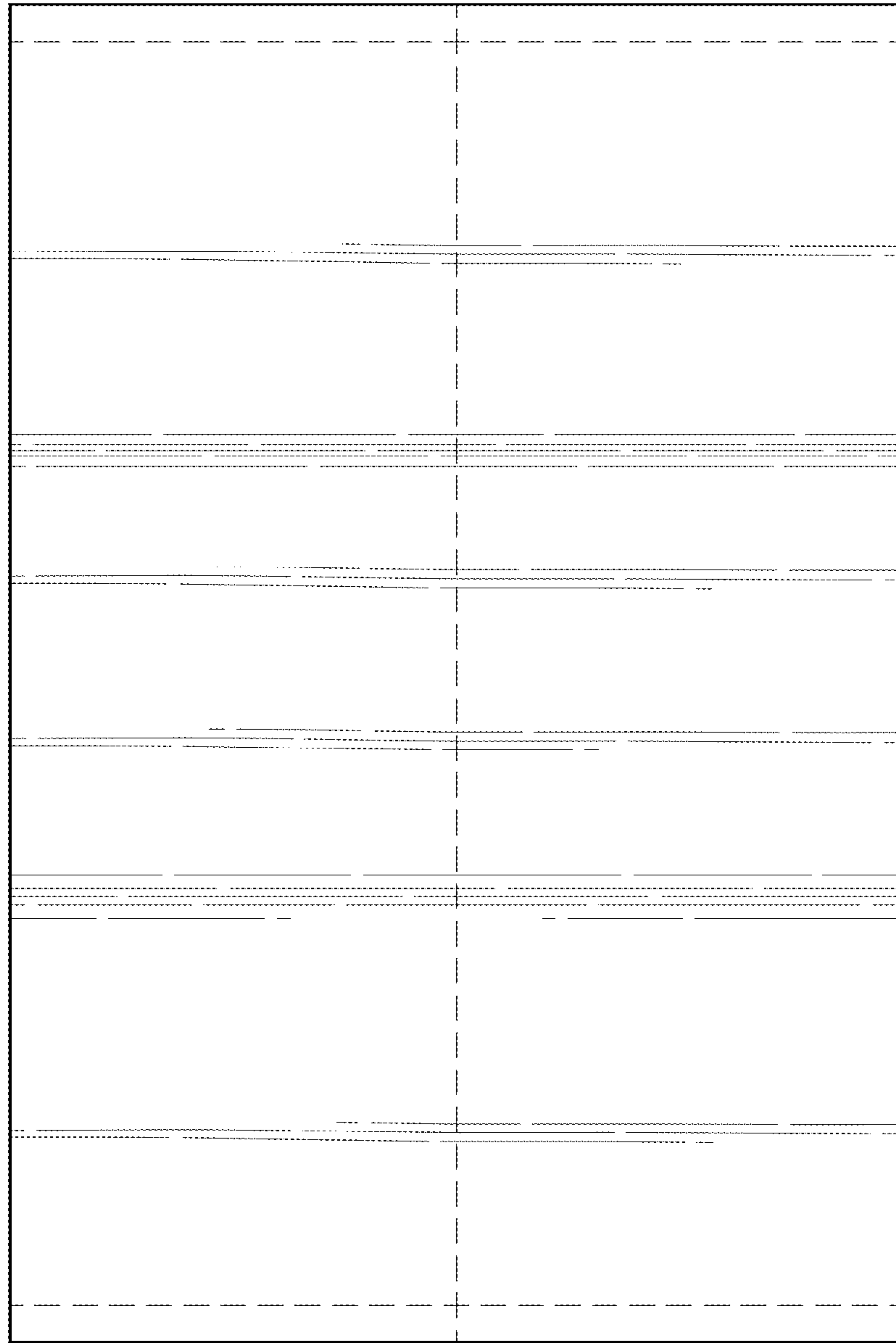

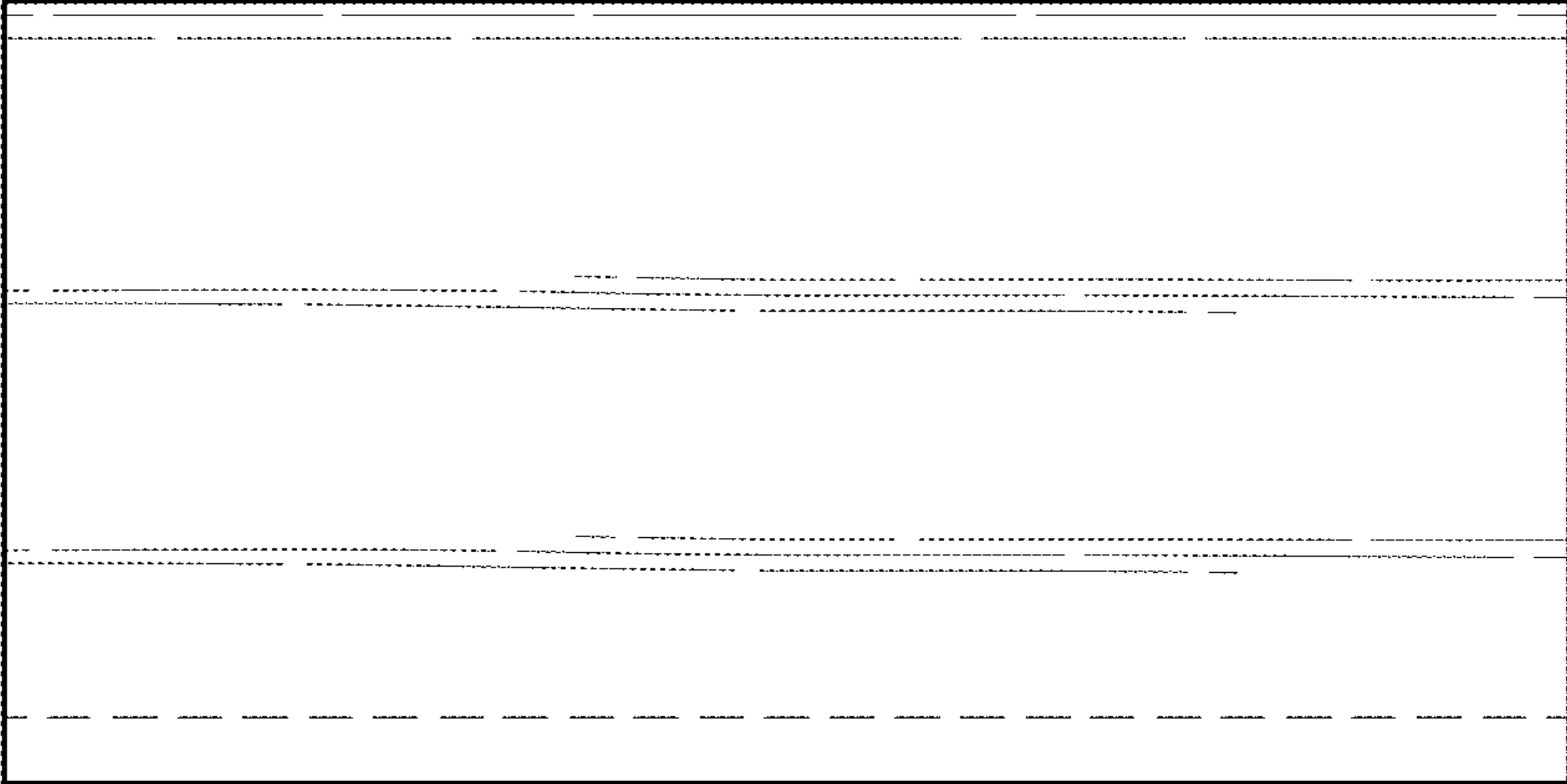
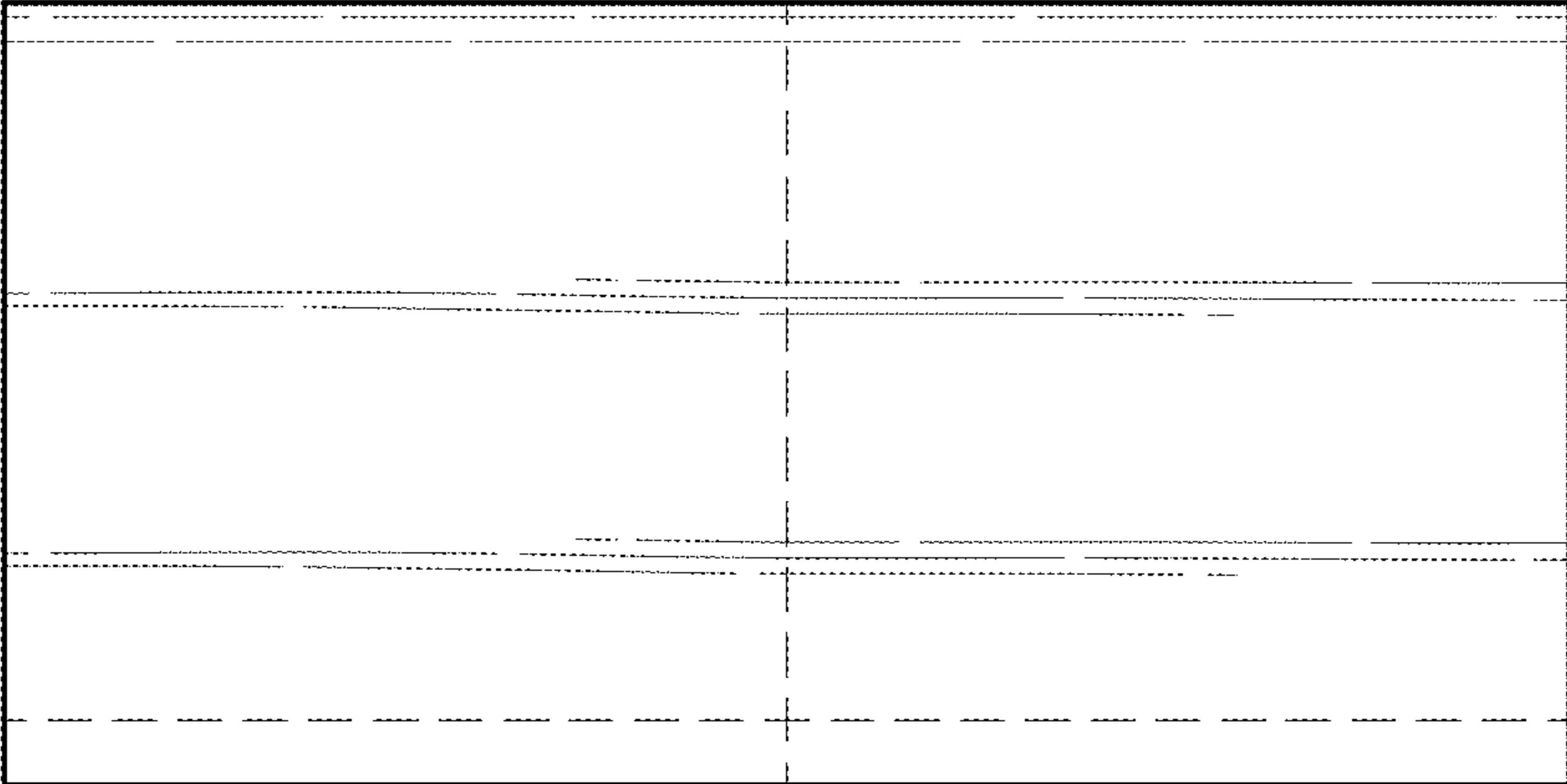

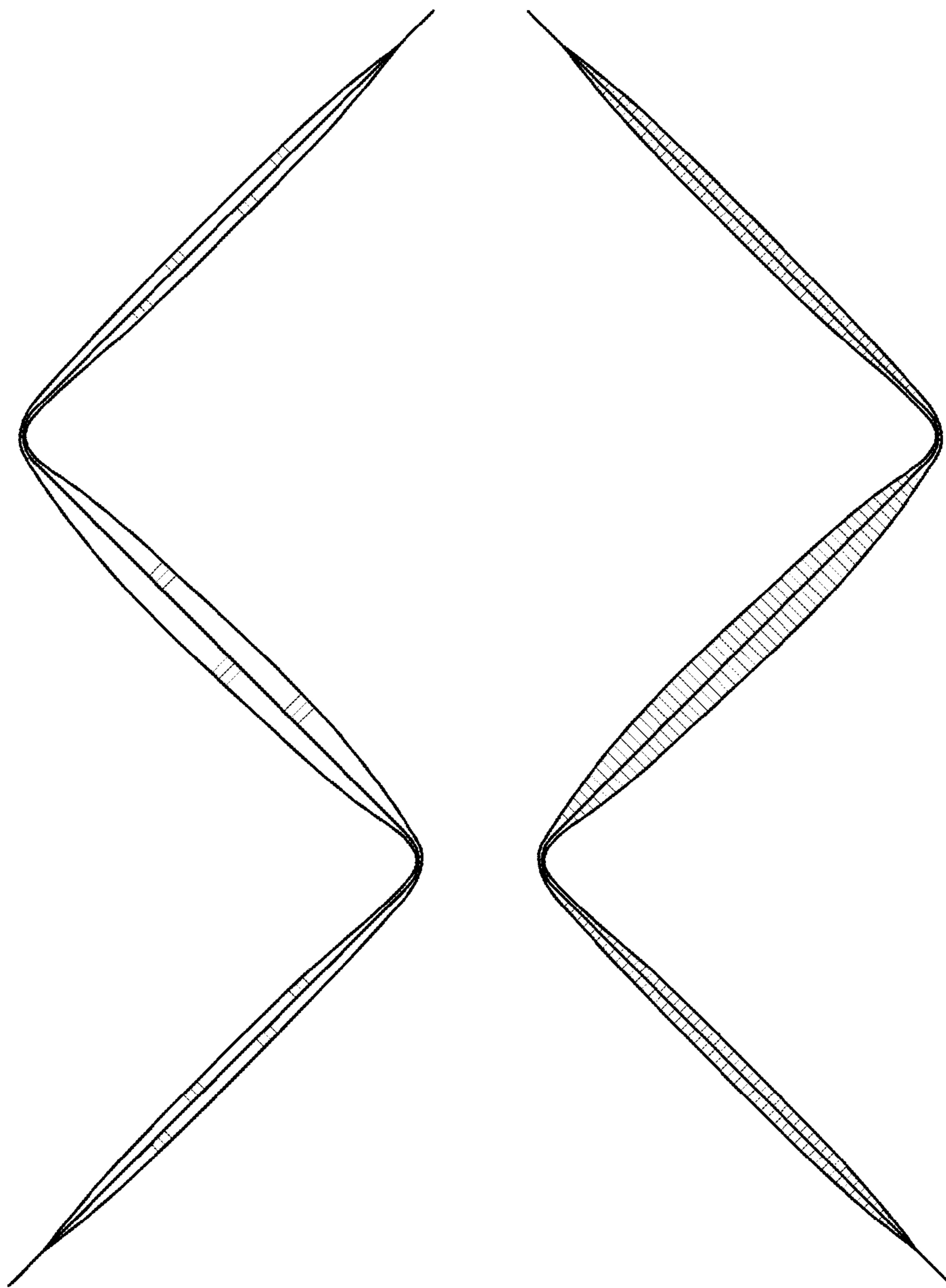
