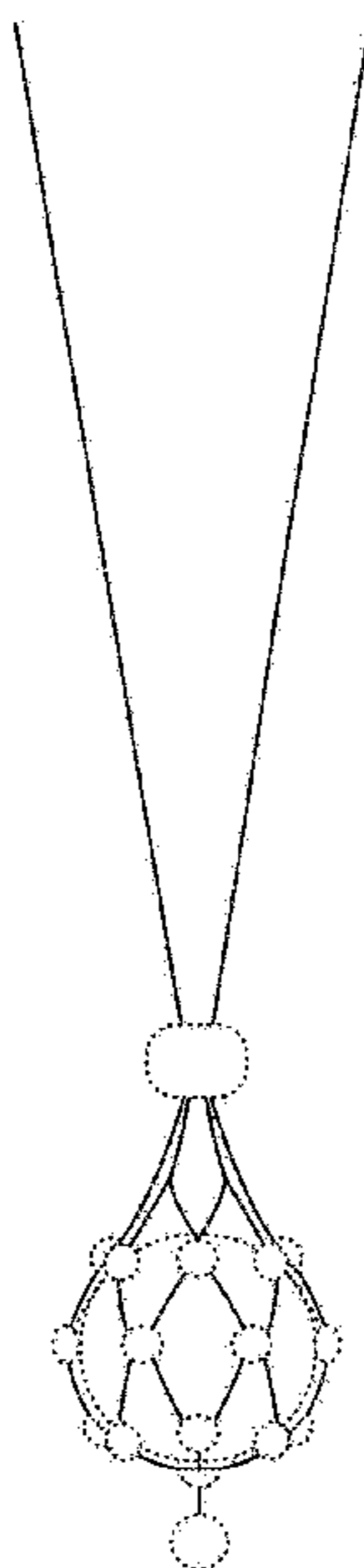

DESCRIPTION

FIG. 1 is a front view (rear view/and side view the same) of an article of adornment with a basket of the article in a closed configuration;
FIG. 2 is a front view (rear view the same) of the article of adornment with a basket of the article in an open configuration;
FIG. 3 is a bottom view of the article of adornment; and,
FIG. 4 is a top view of the article of adornment.

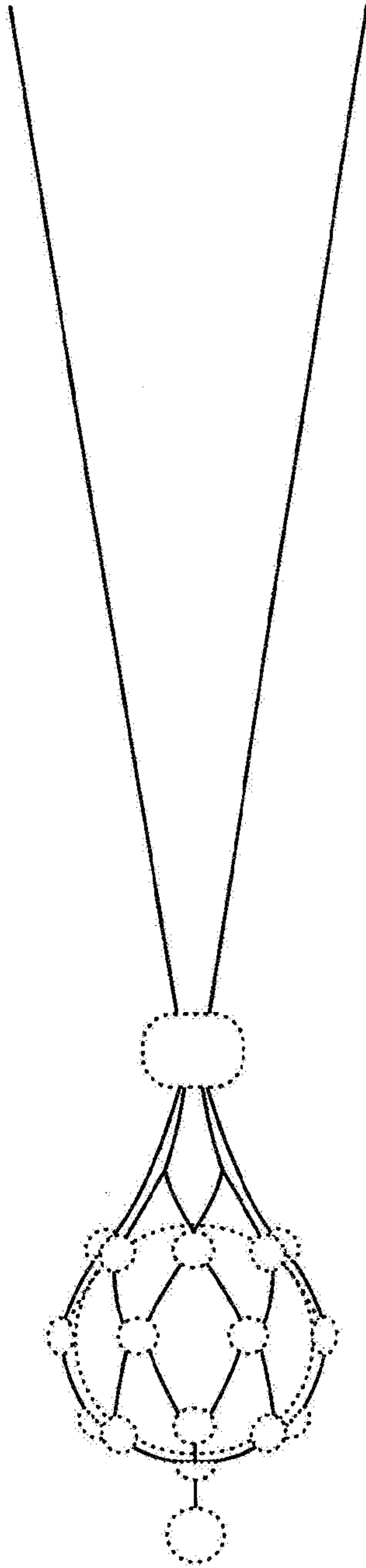

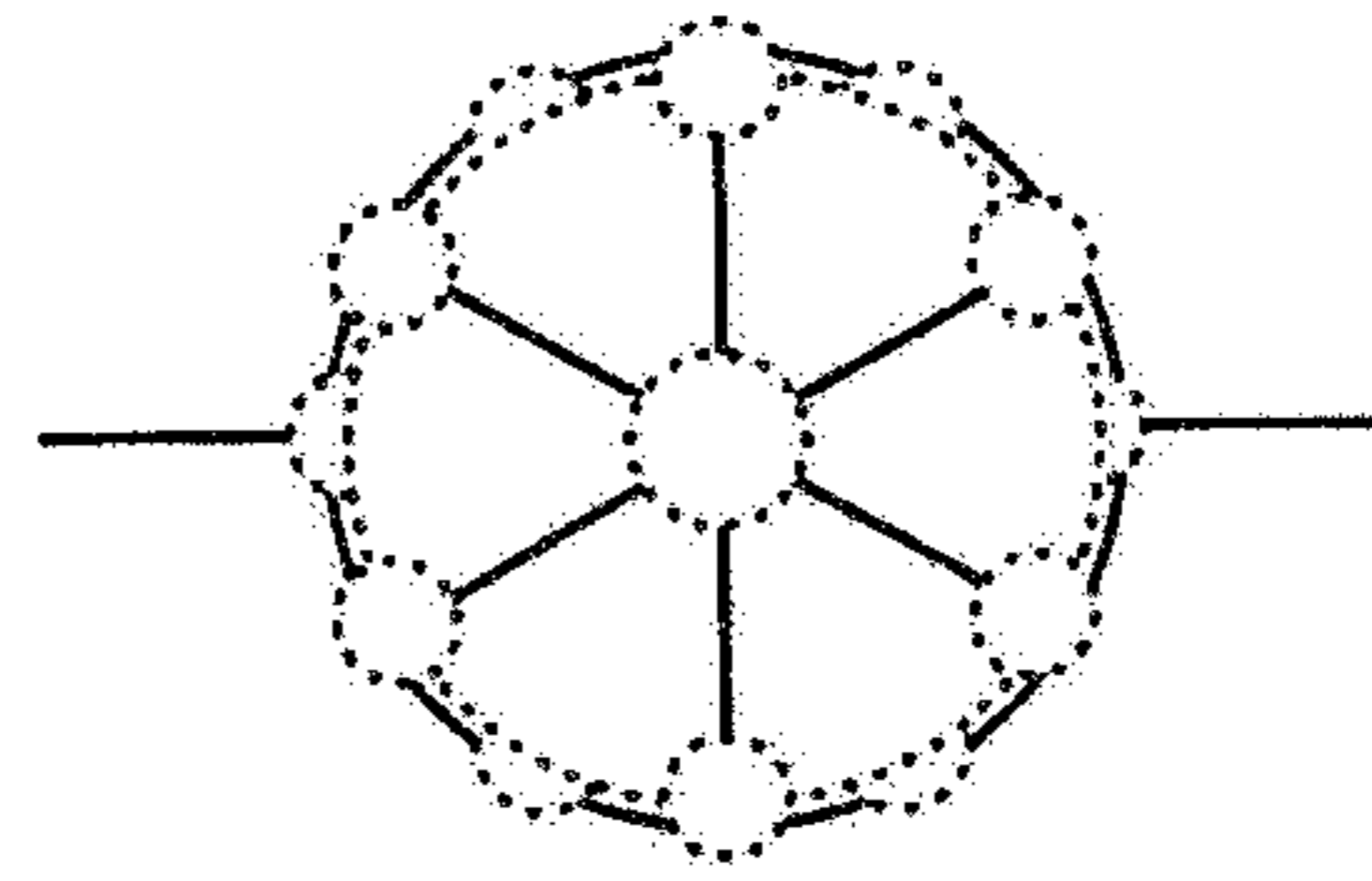

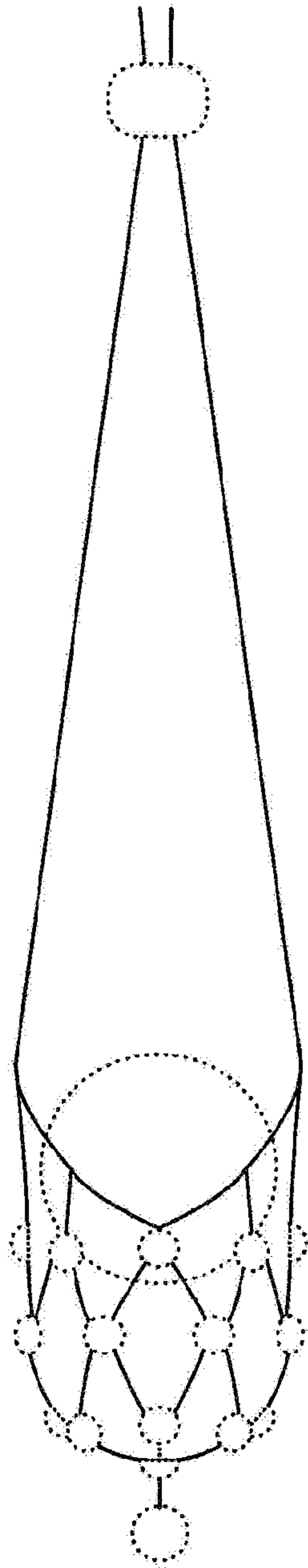

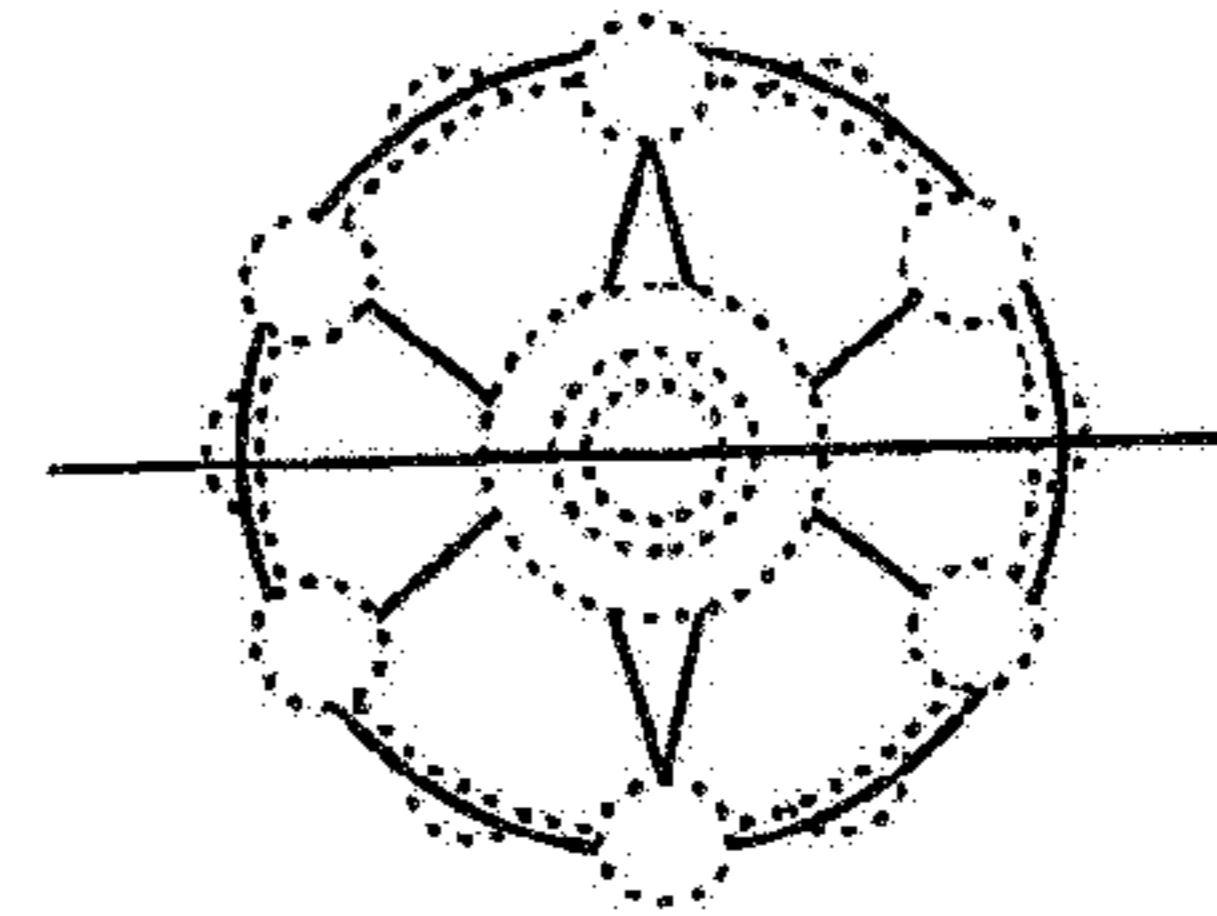
