DESCRIPTION

FIG. 11 is a left side view of thereof.

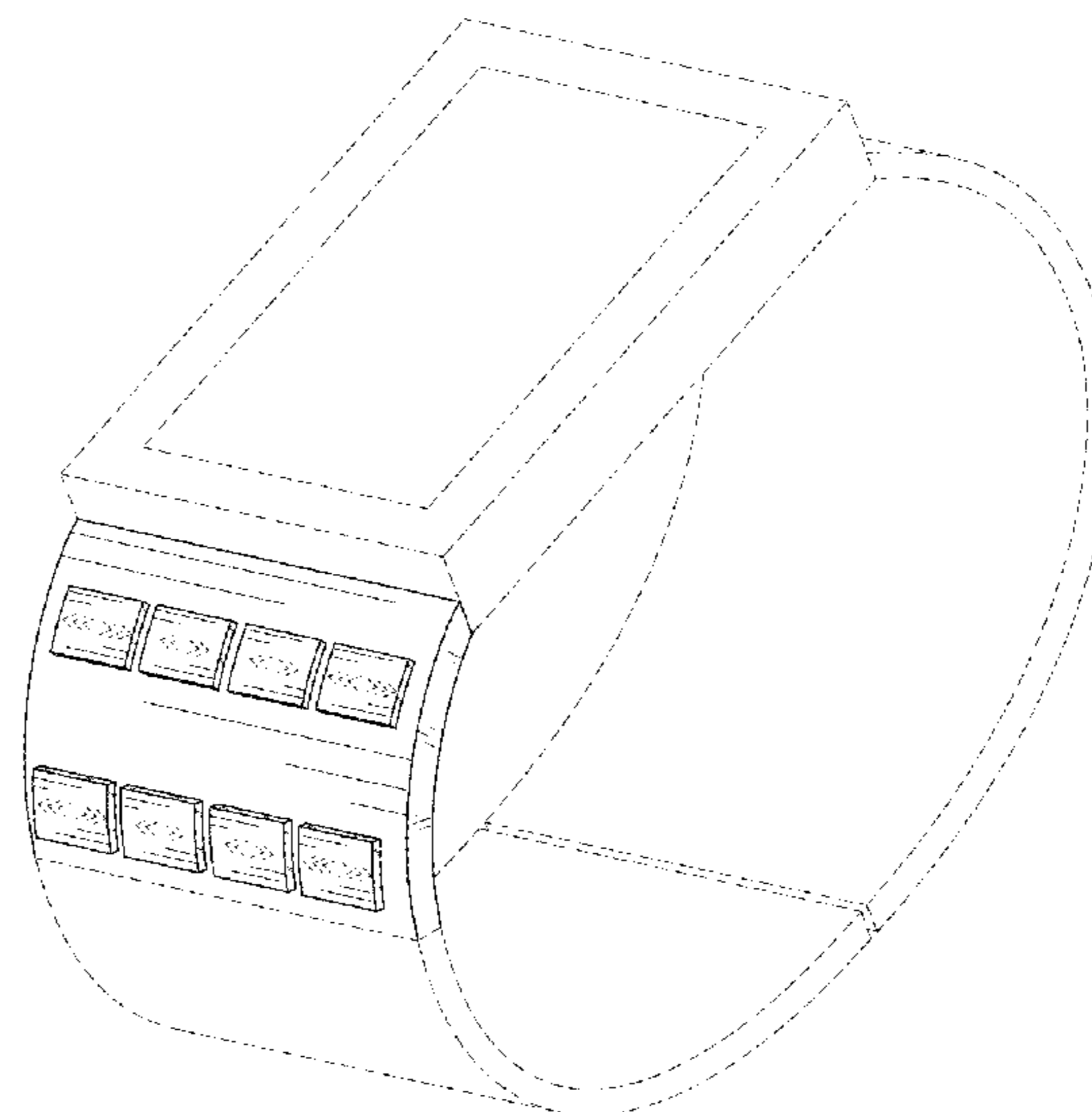
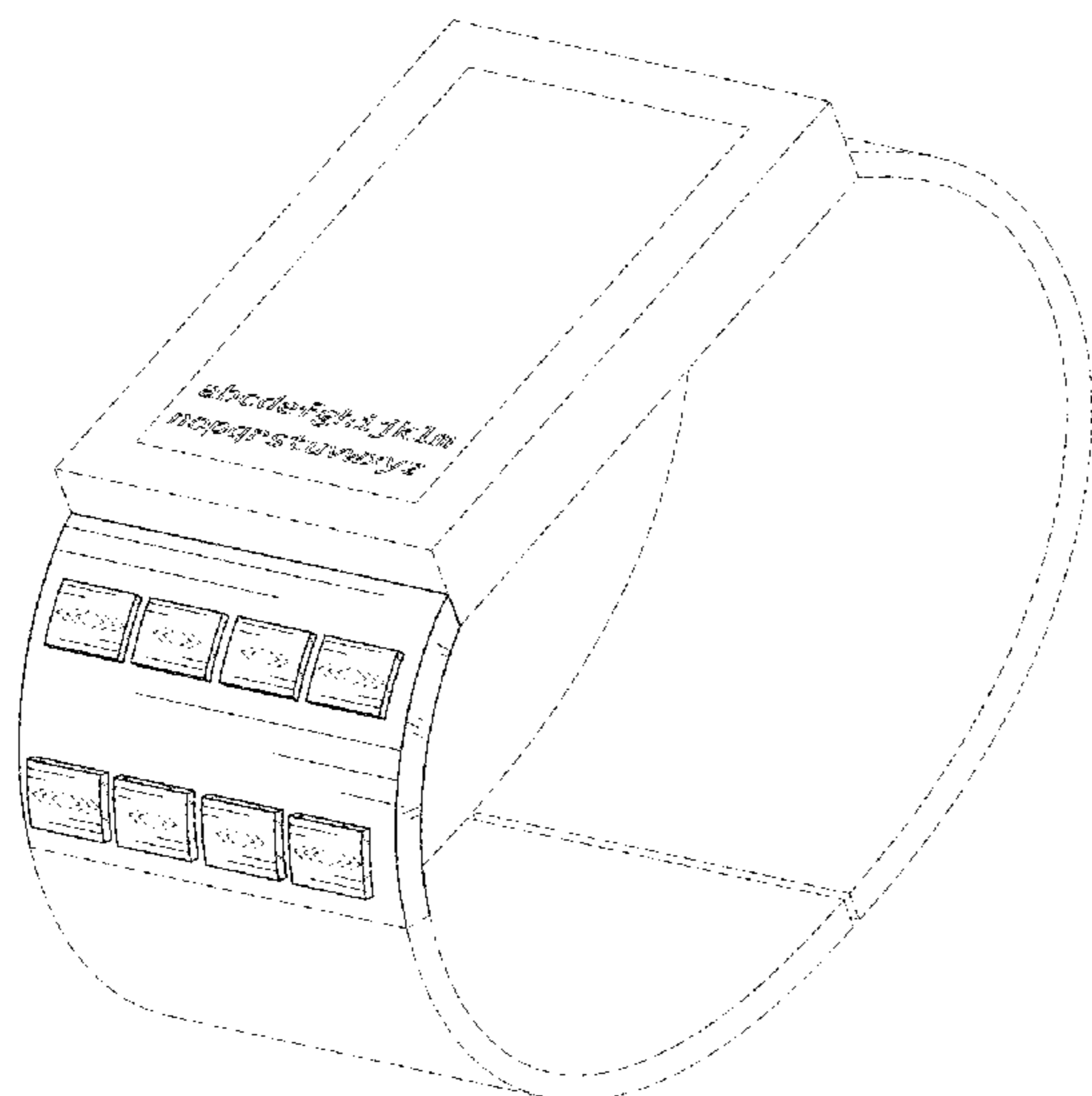
FIG. 12 is a right side view of thereof.

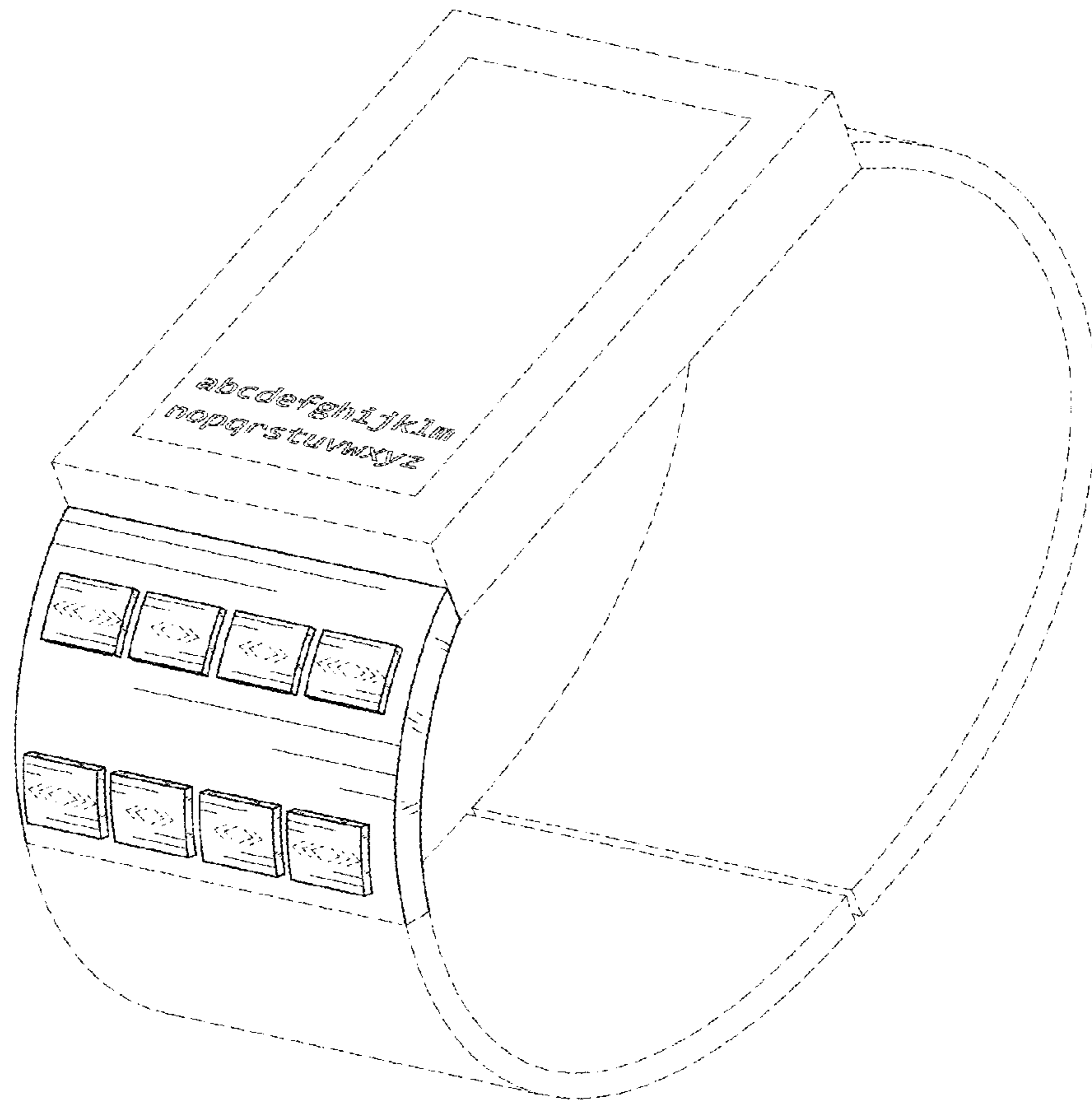

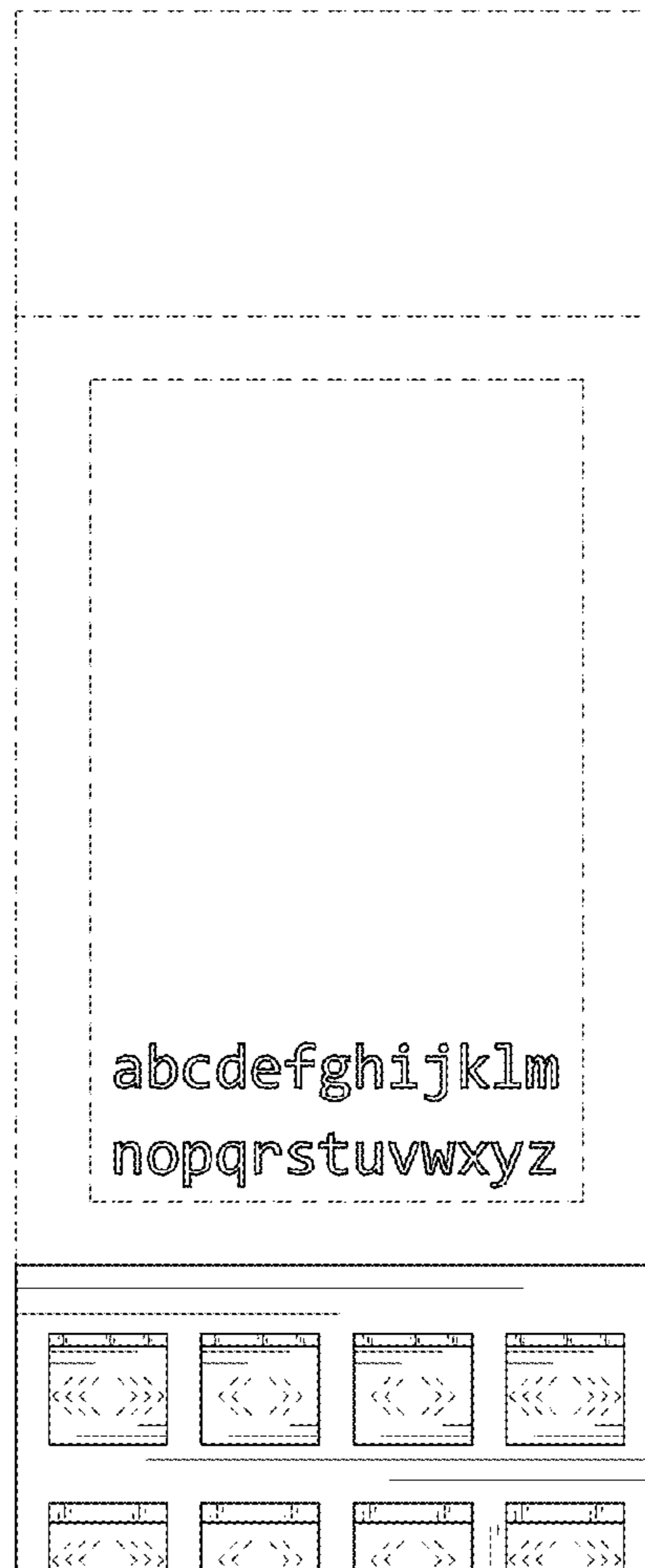

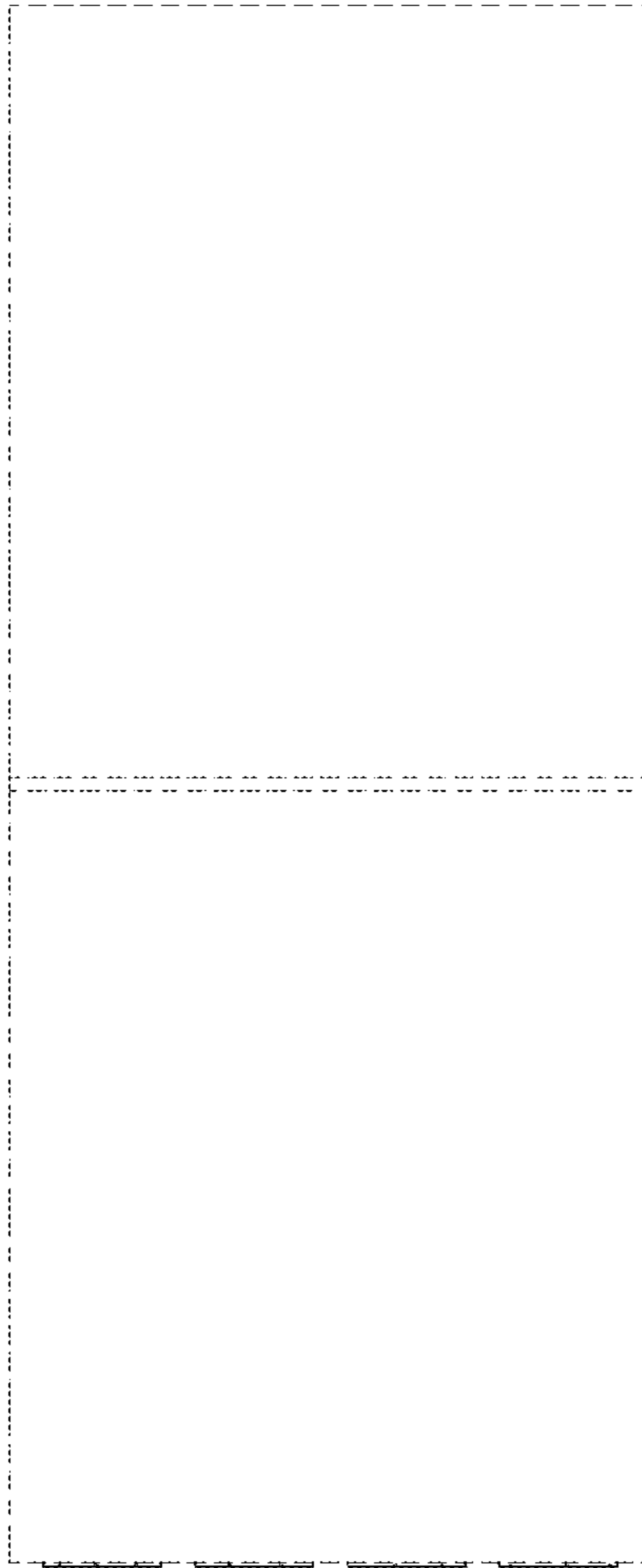

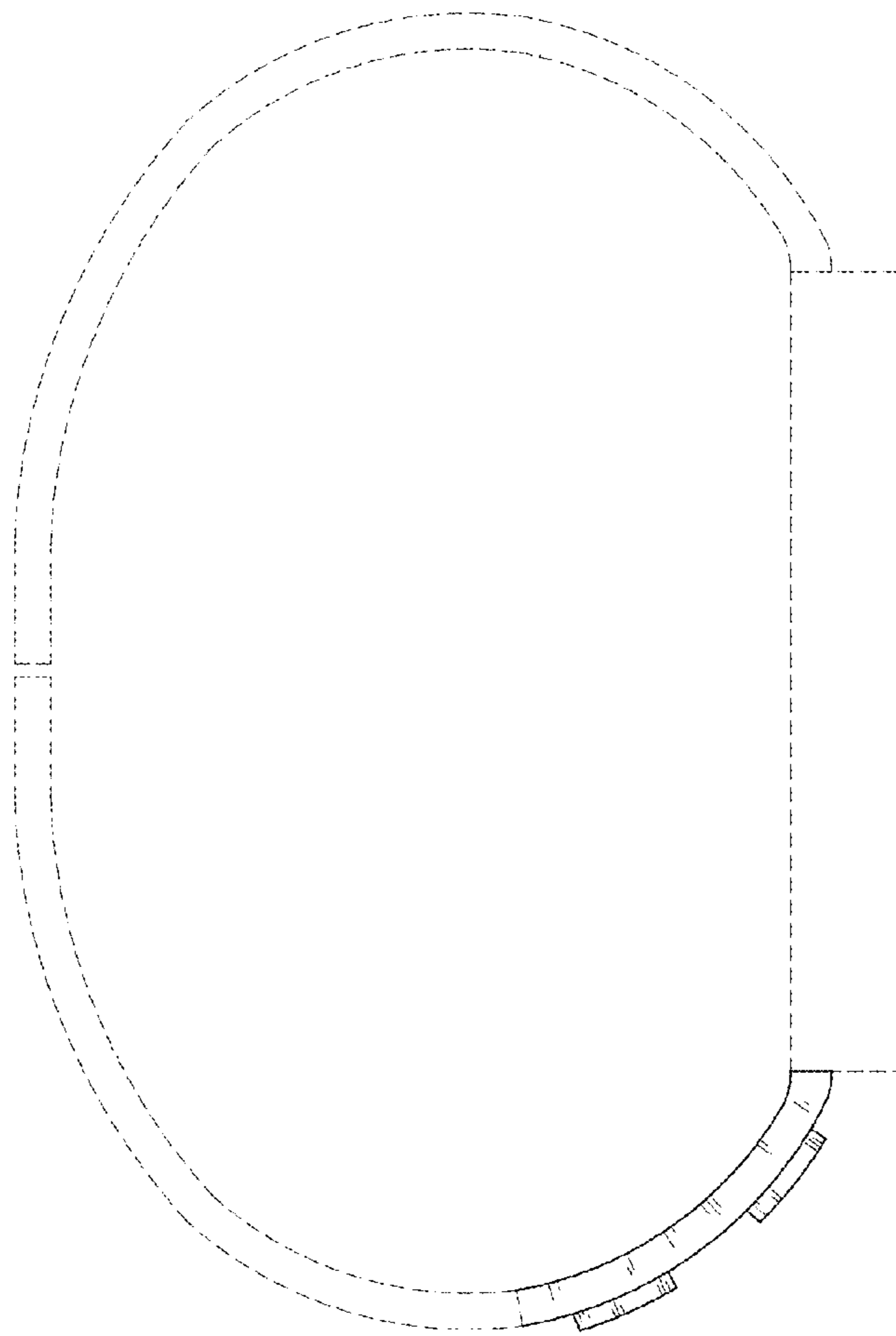

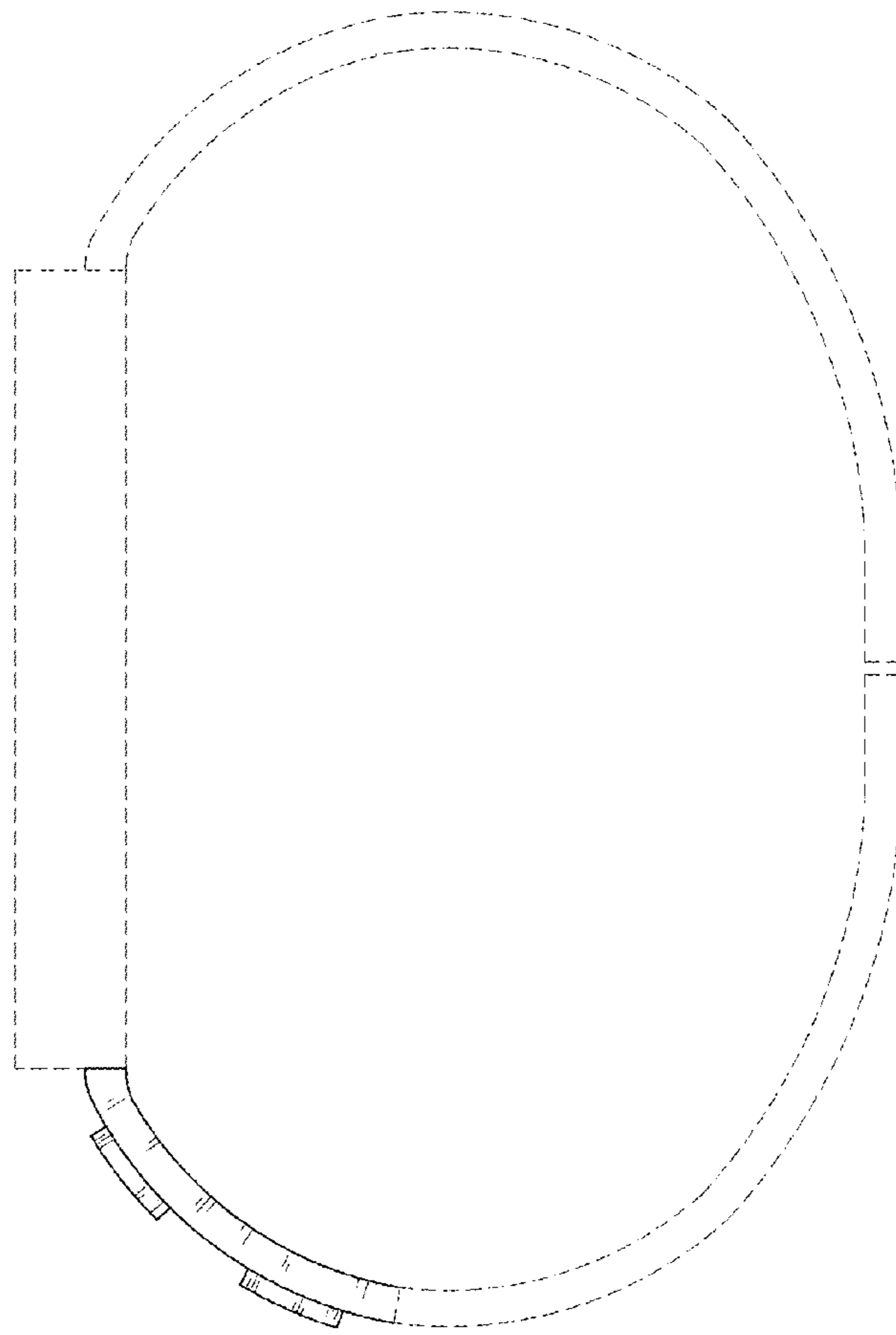

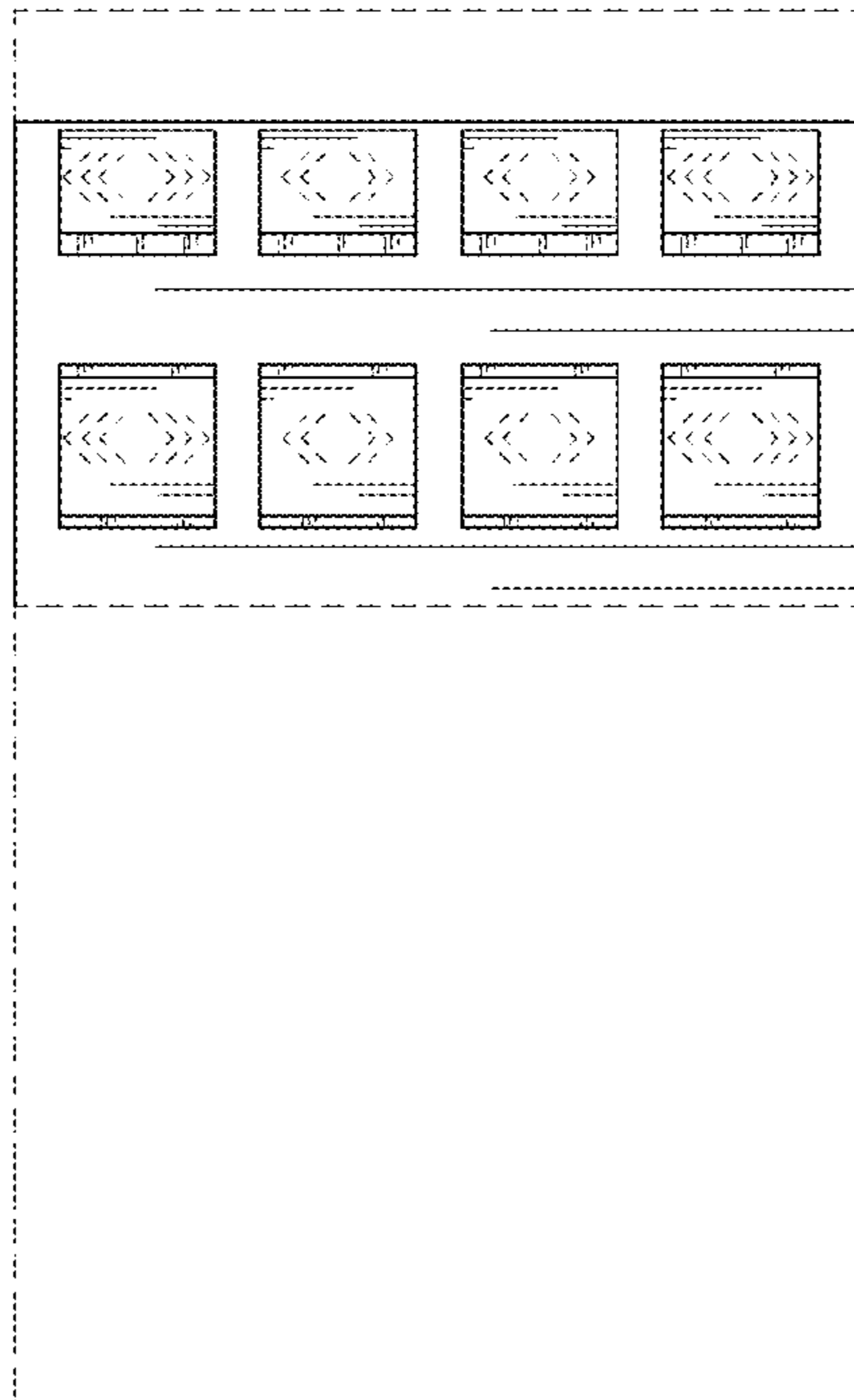

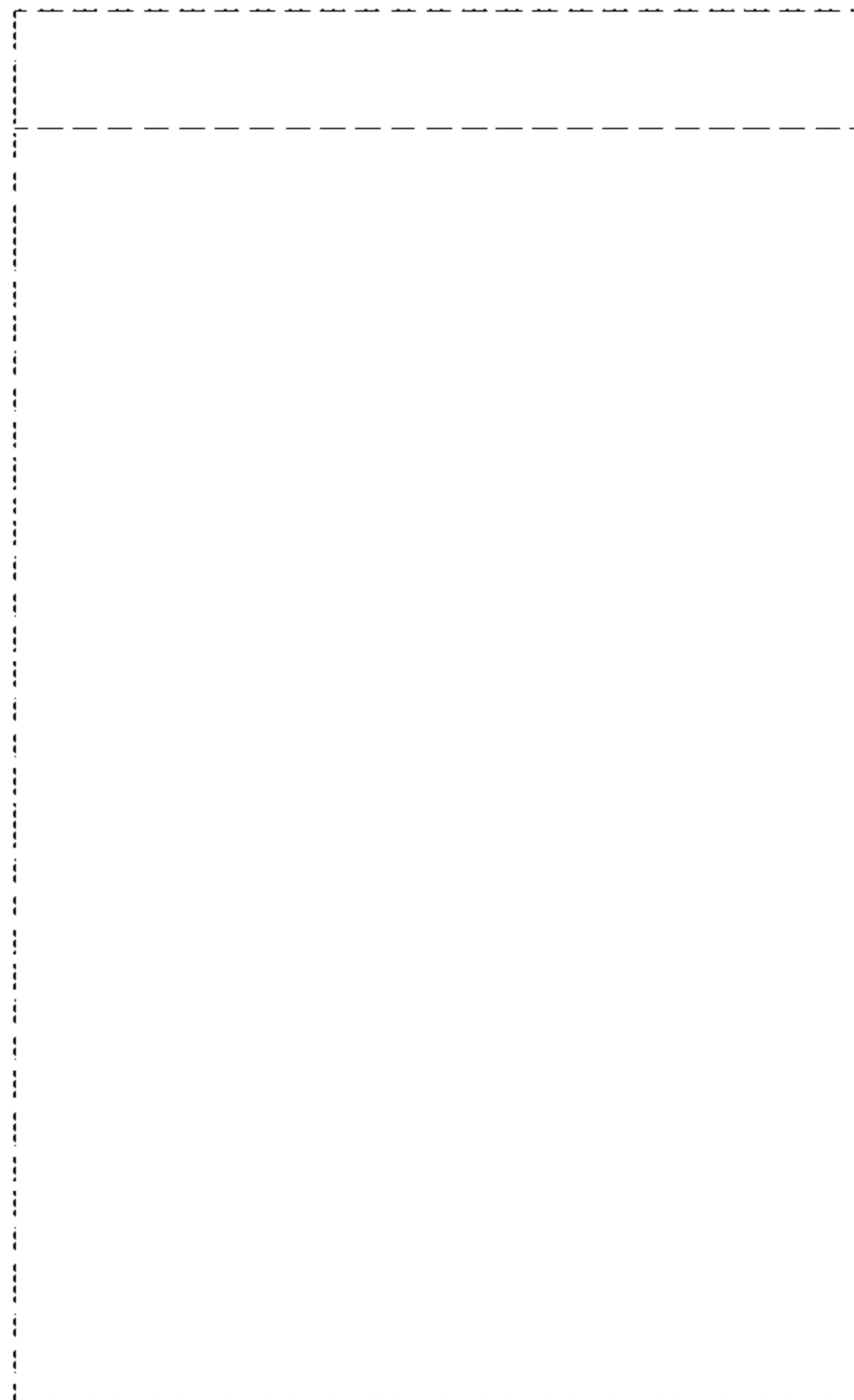

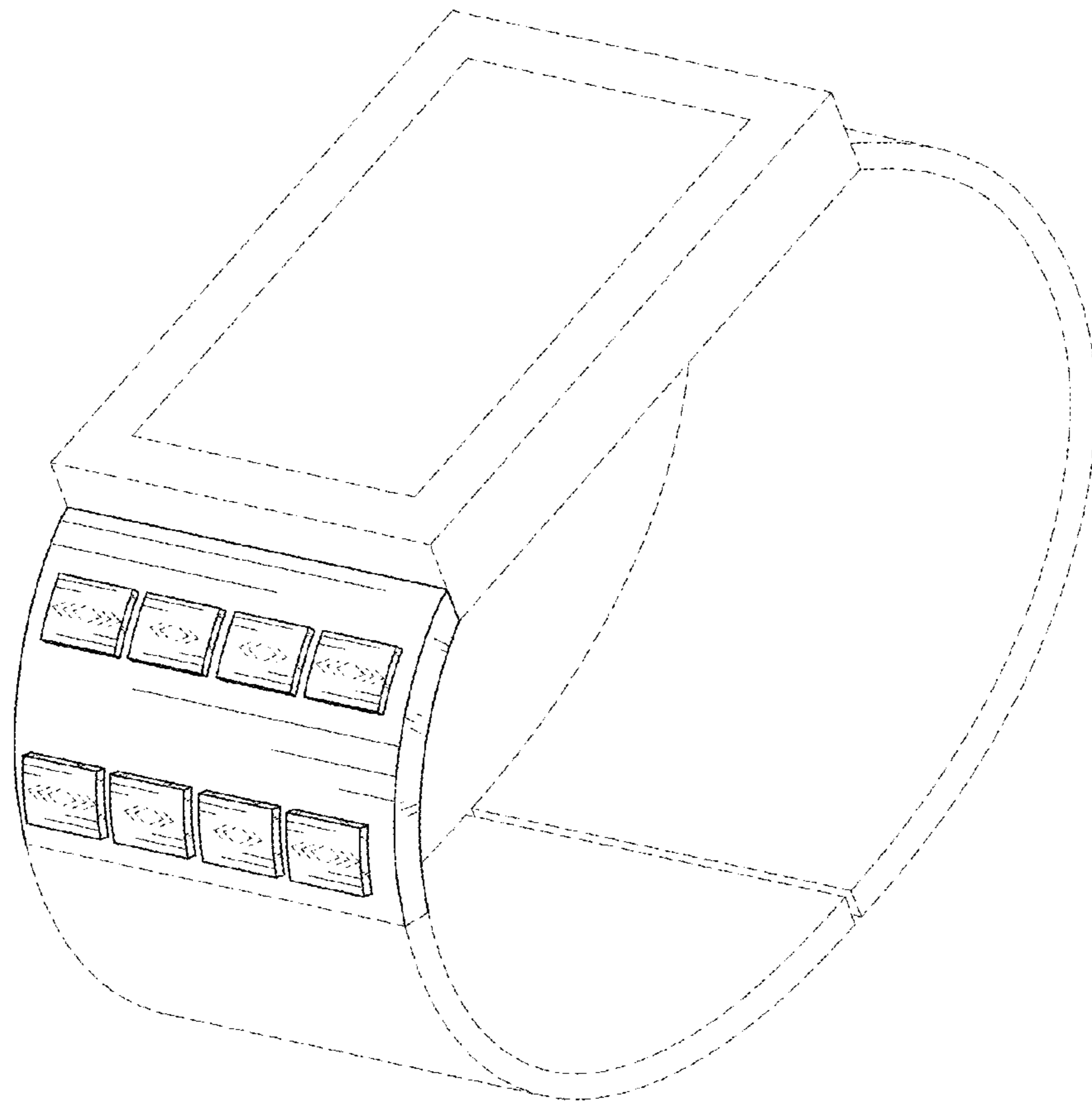

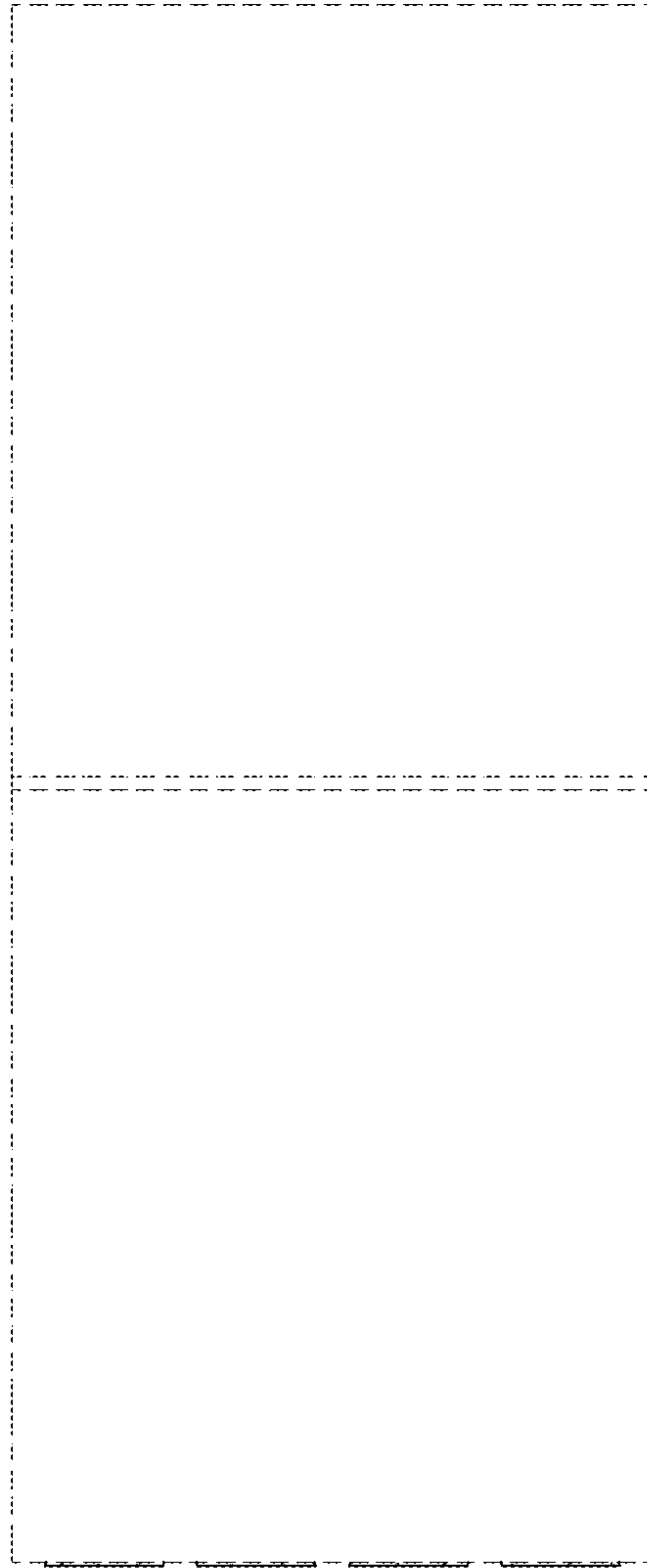

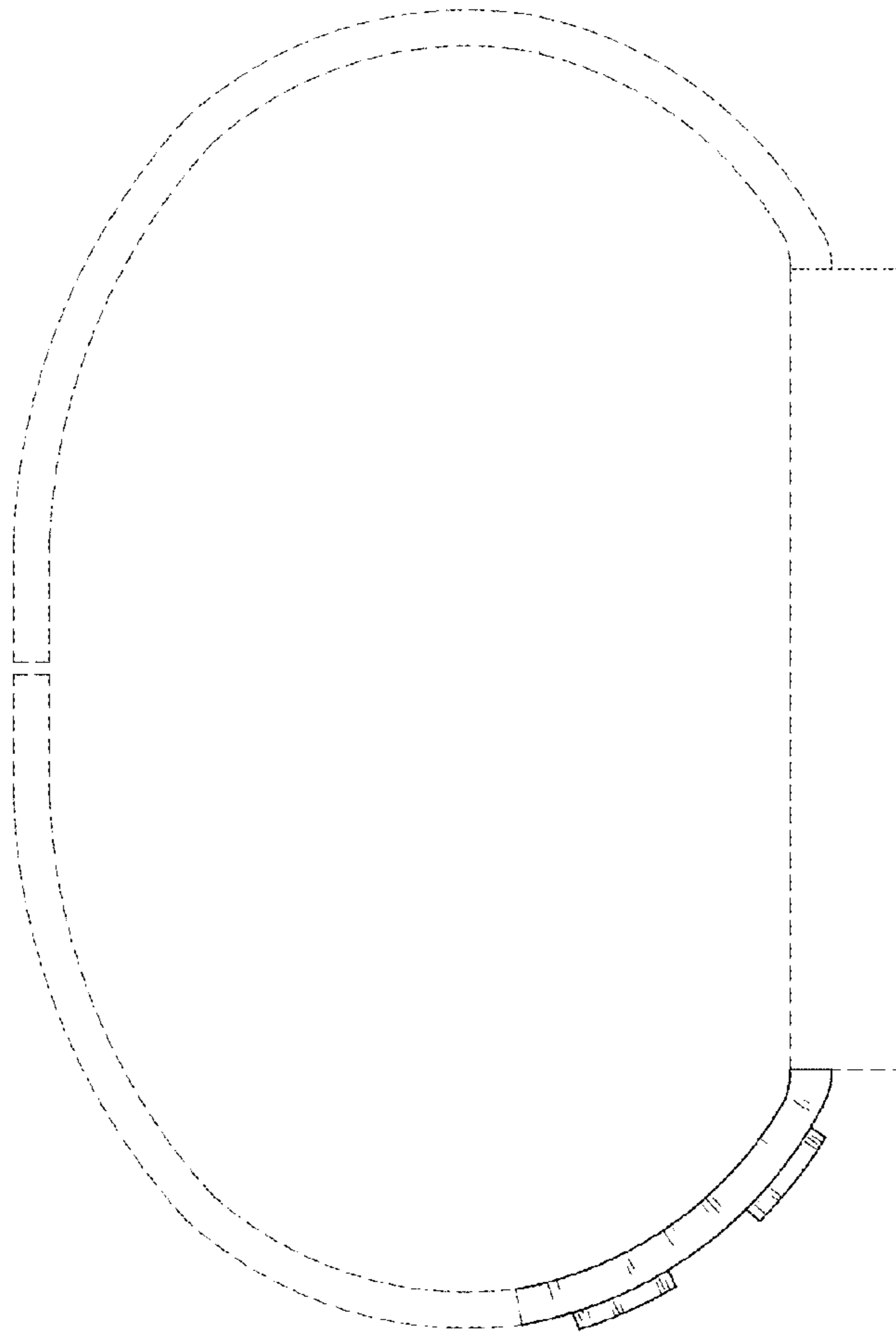

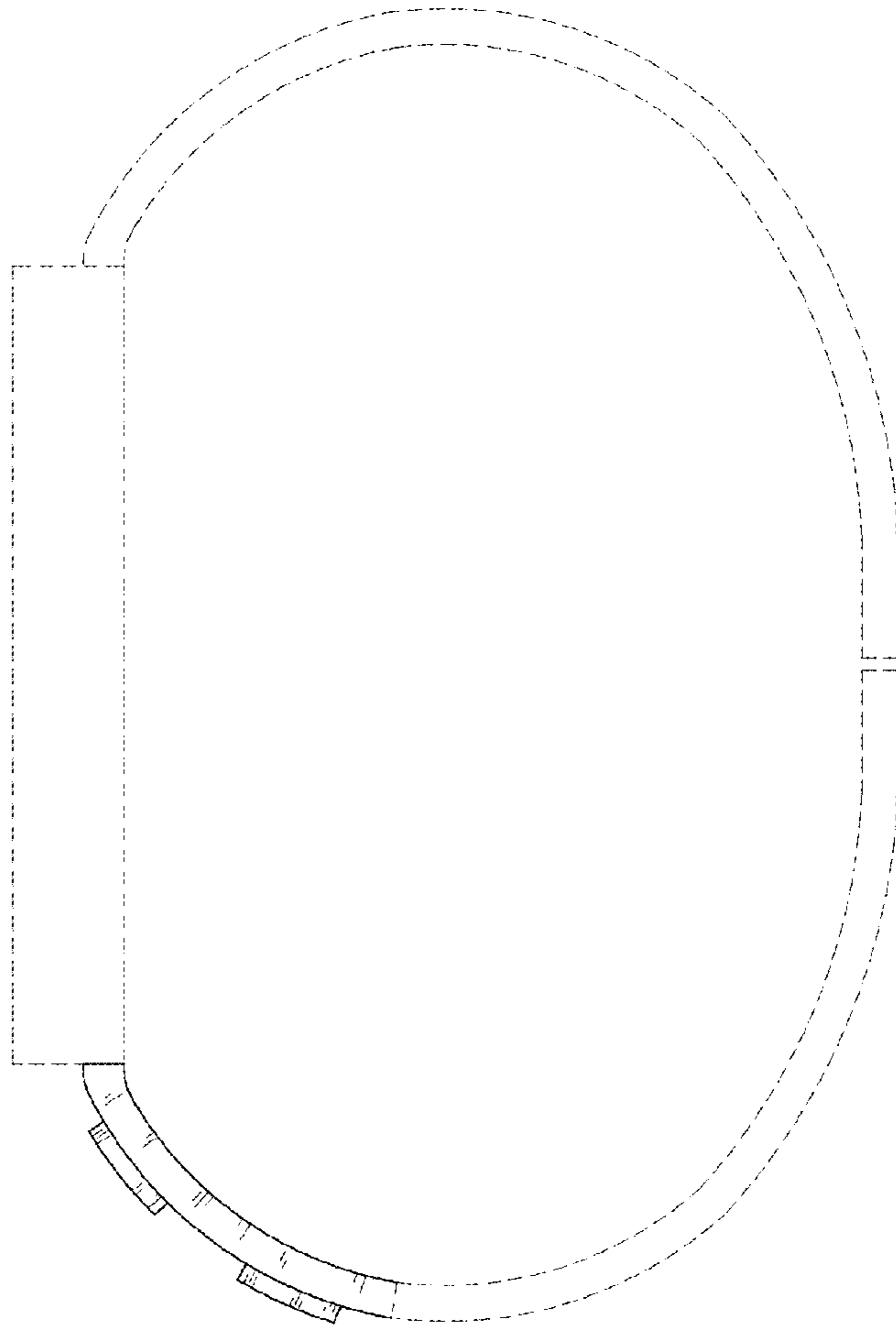

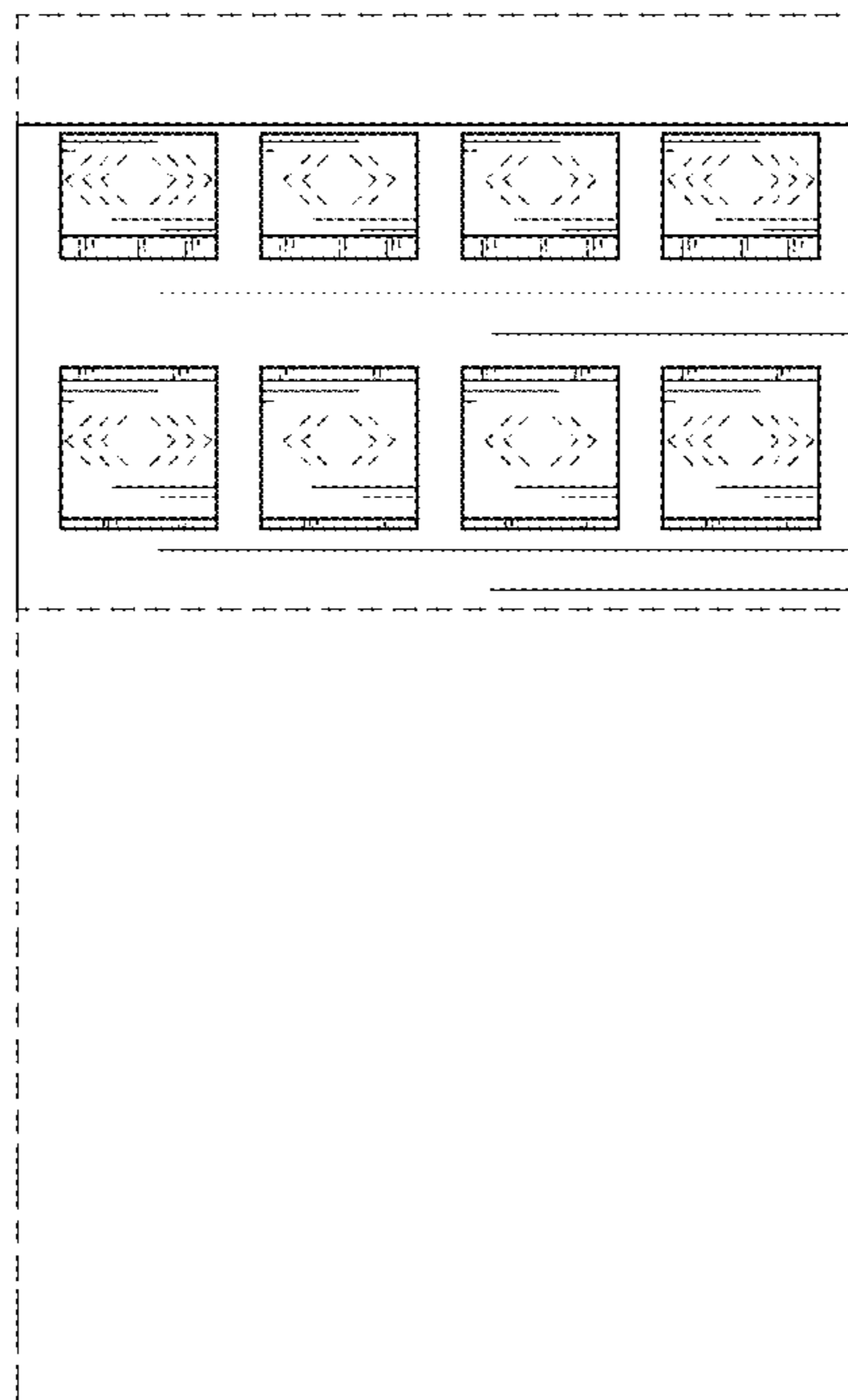

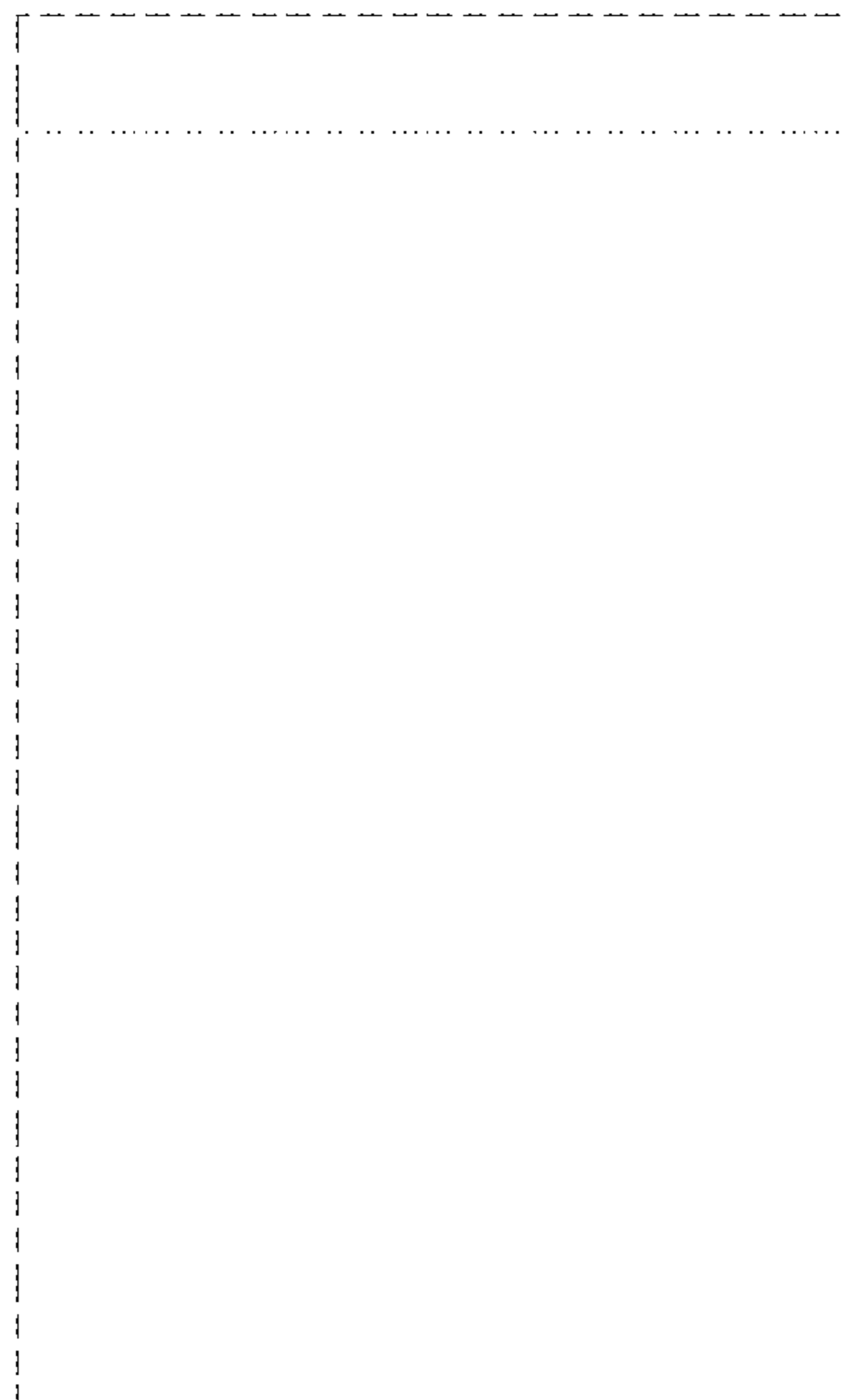
