FIG. 4 is a rear view of a vehicle;

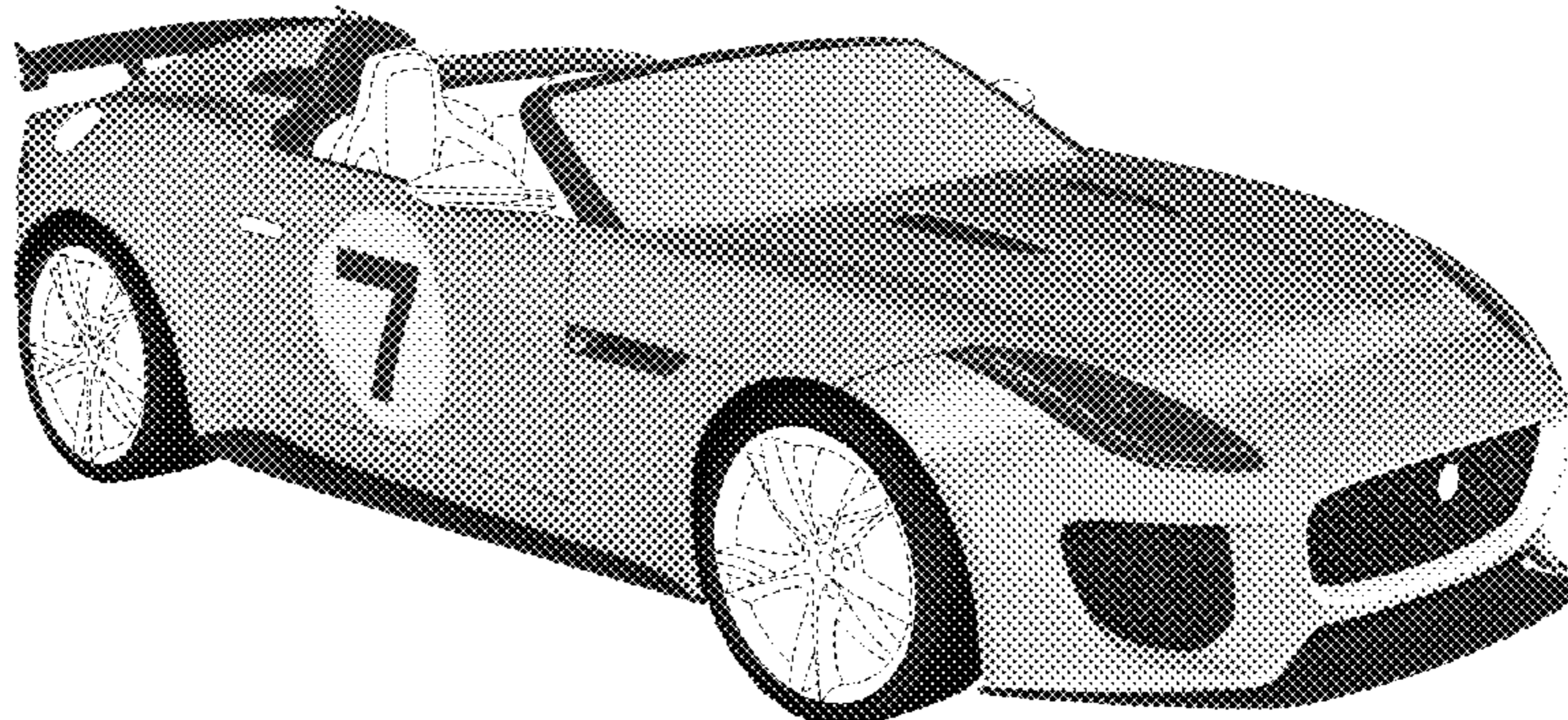
FIG. 5 is a left side view of a vehicle;

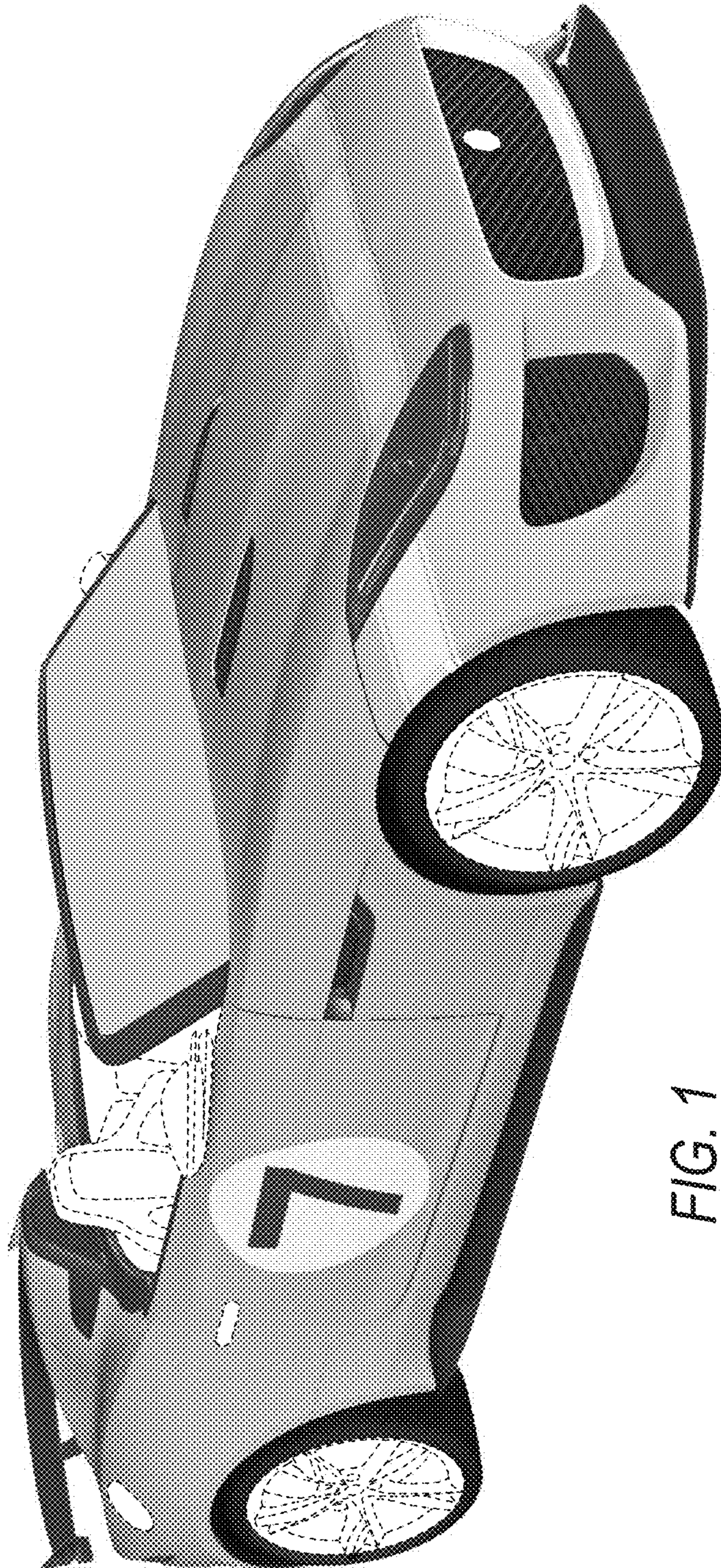

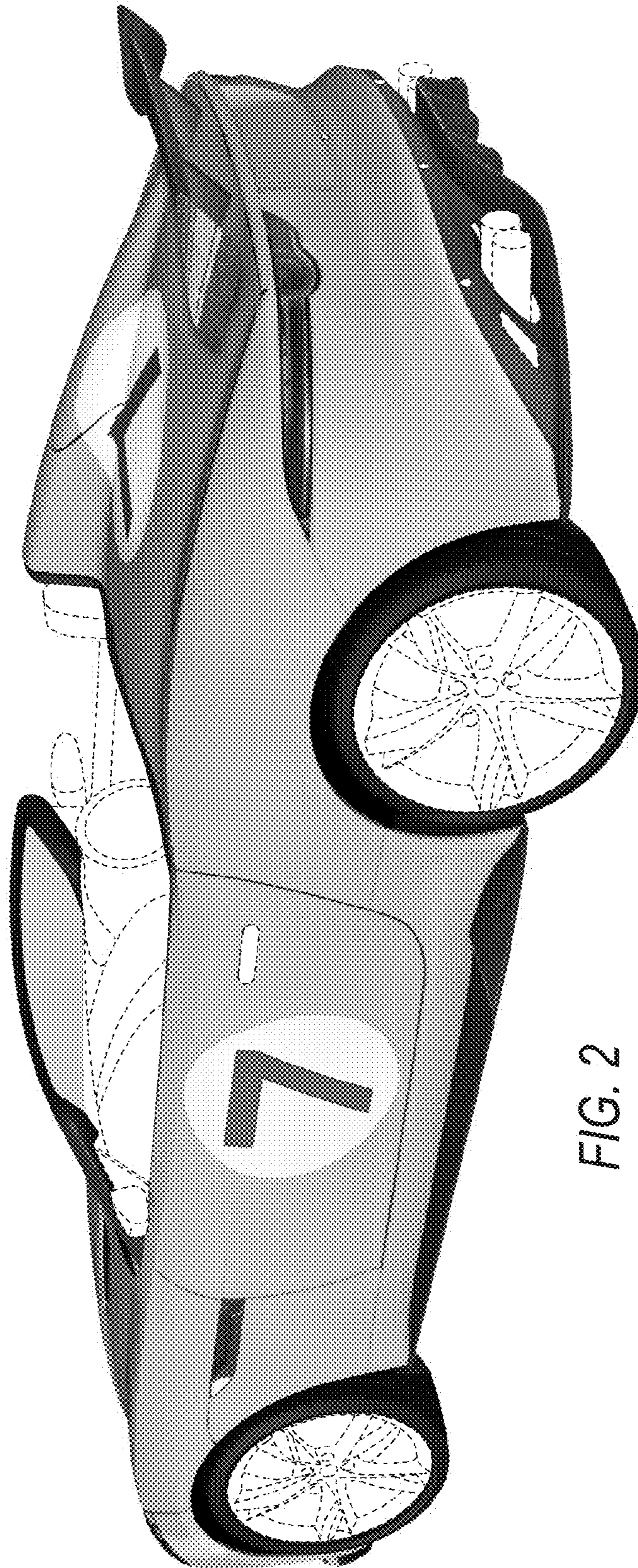

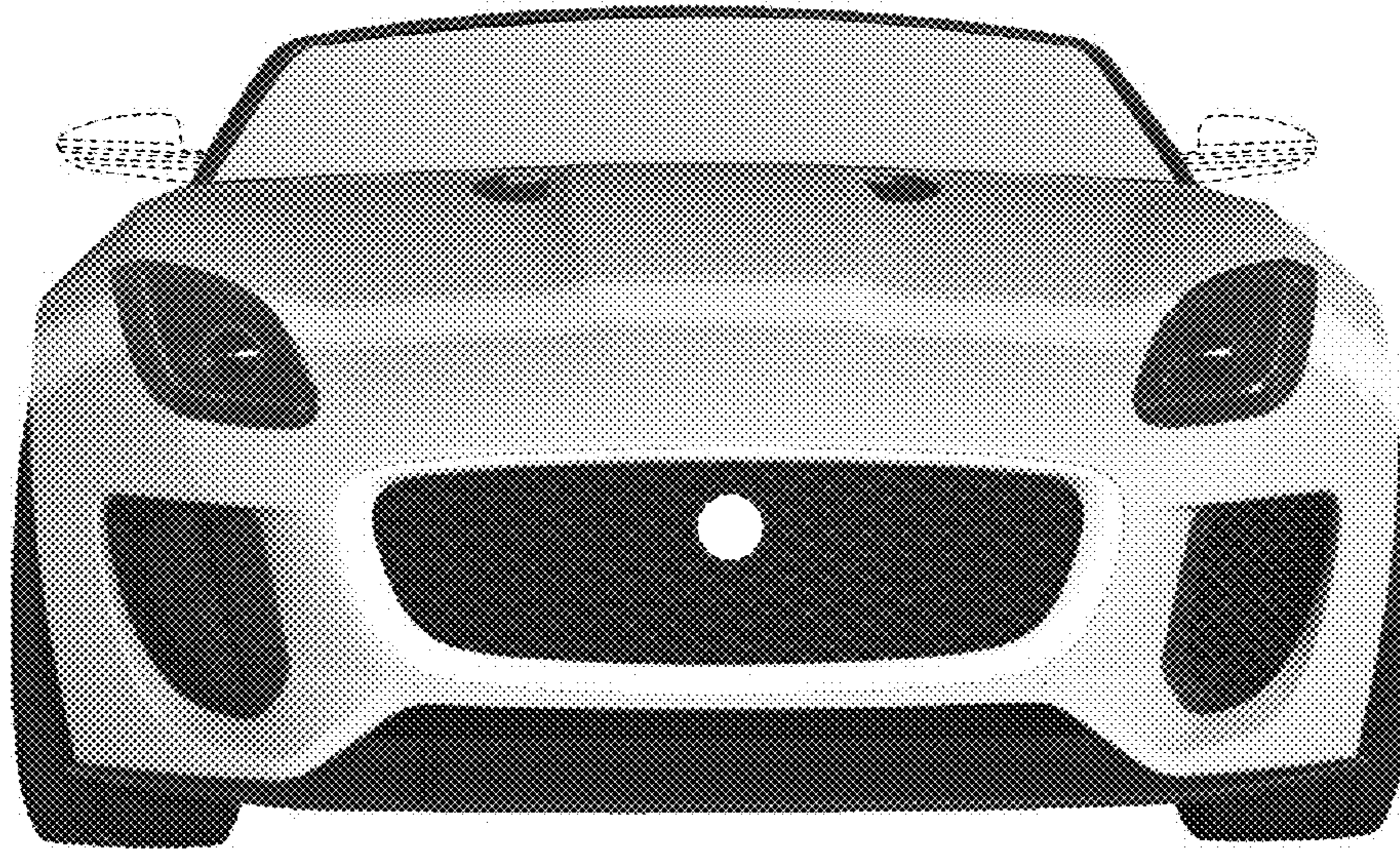

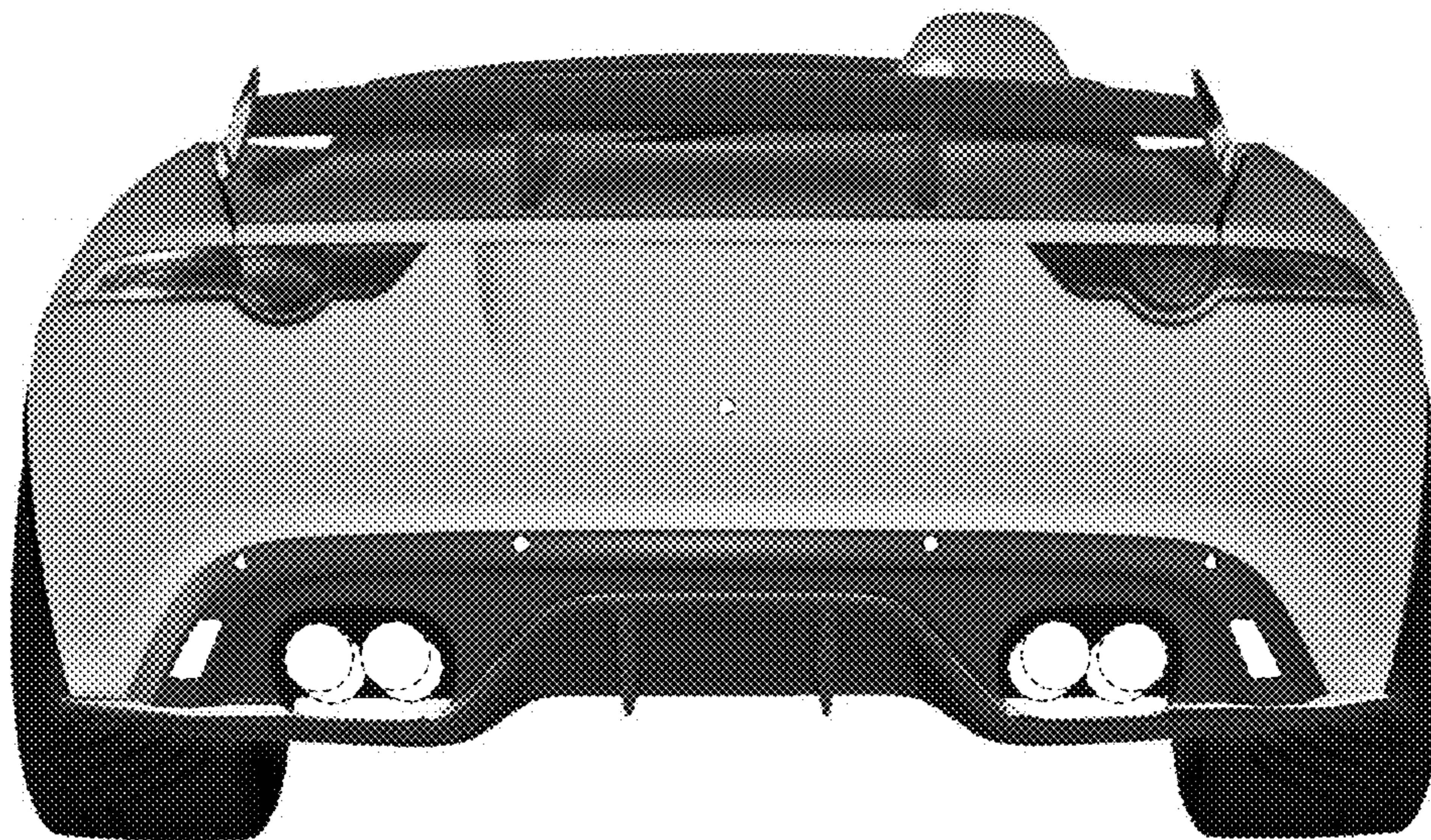

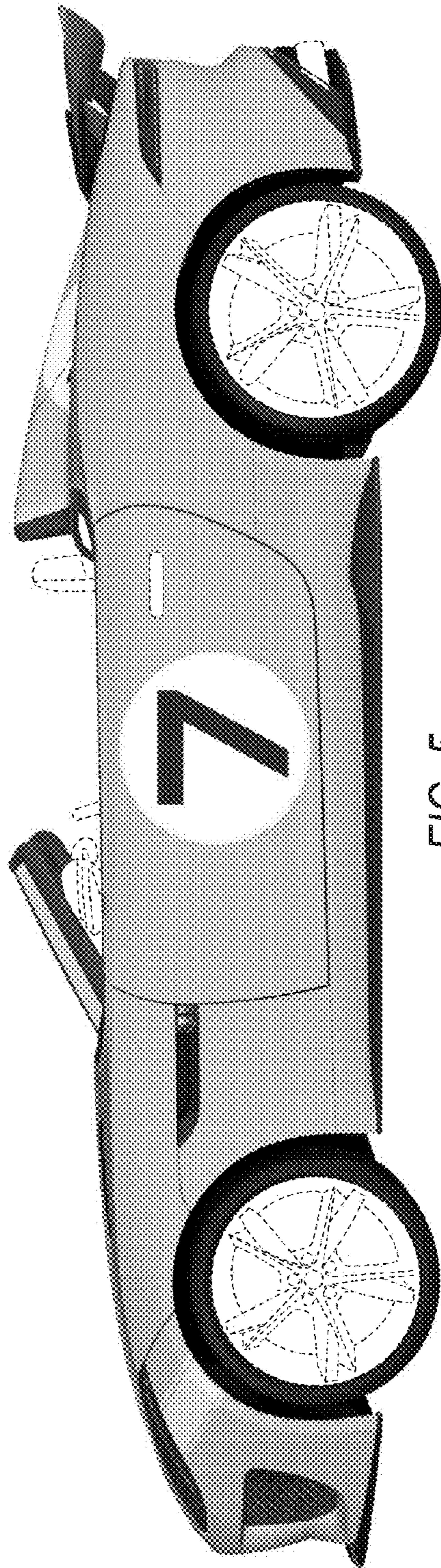

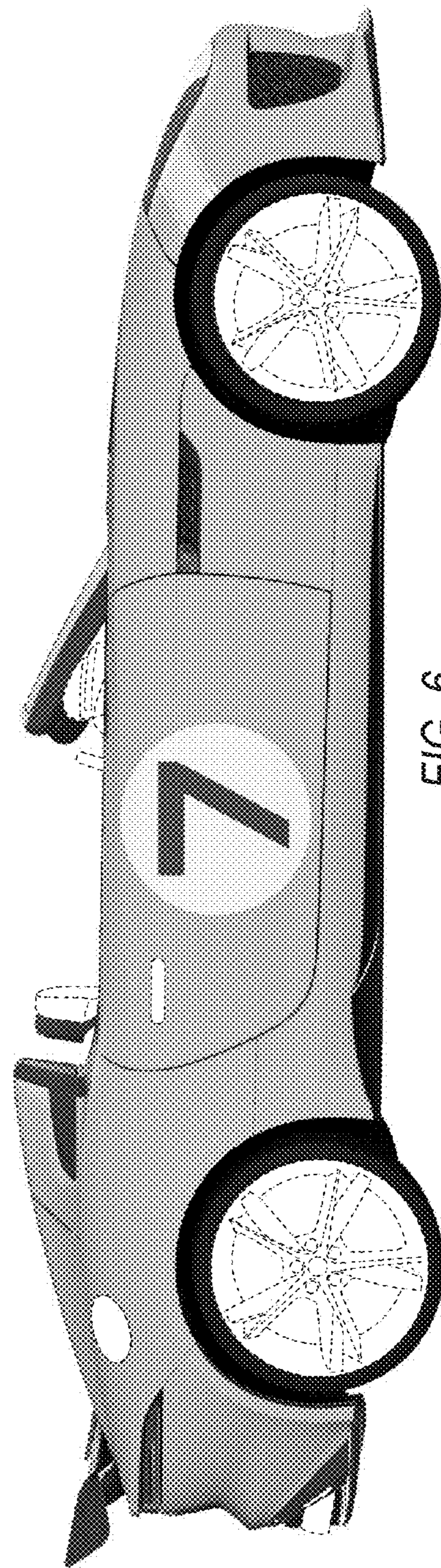

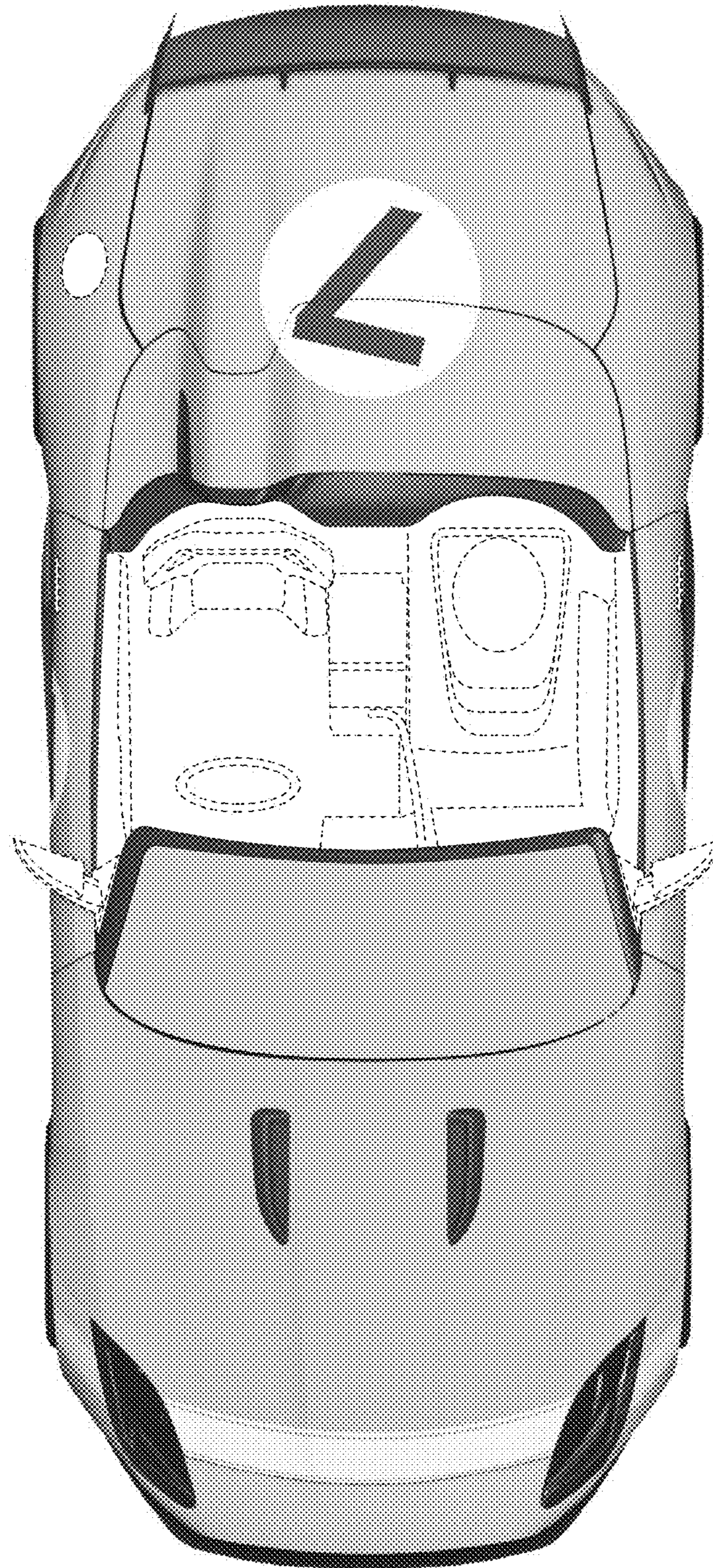
