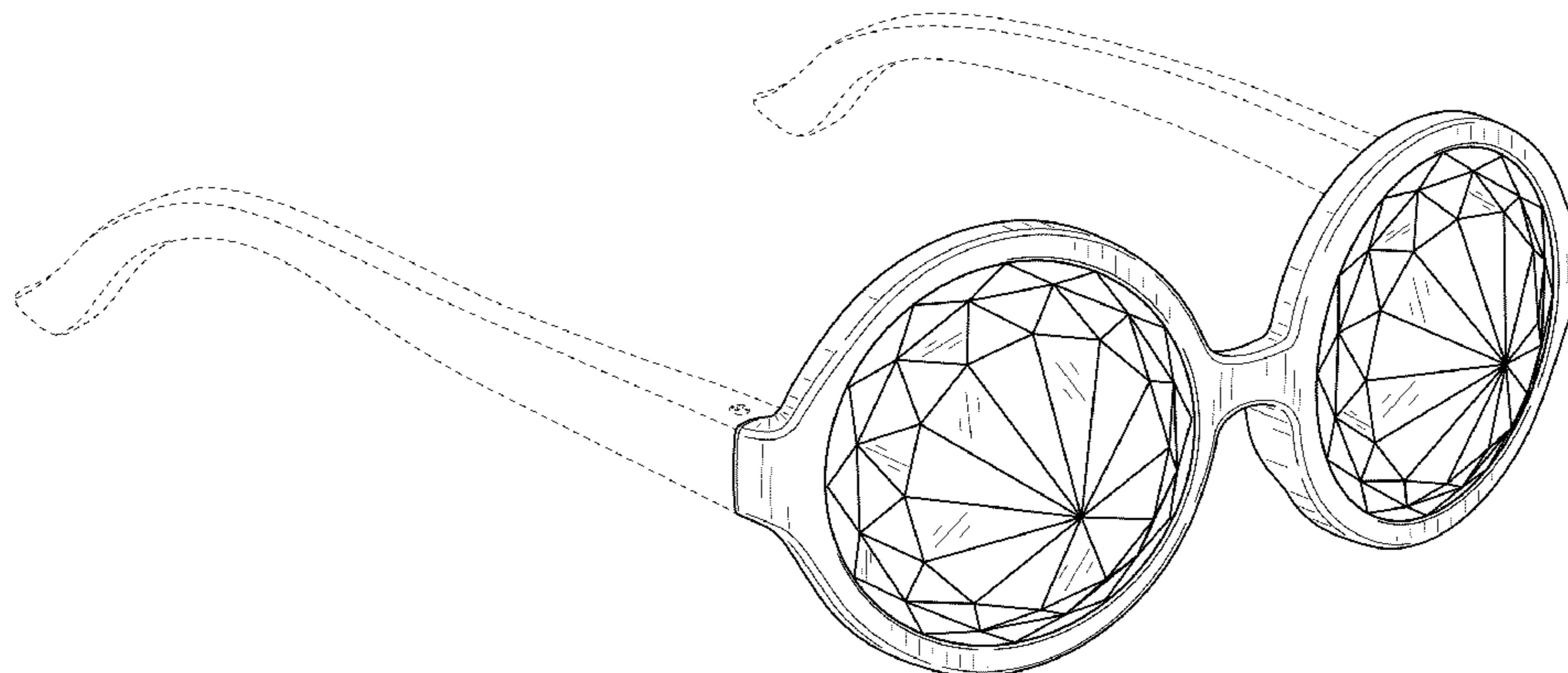
(57) **CLAIM**

The ornamental design for an eyewear with faceted lenses, substantially as shown and described.

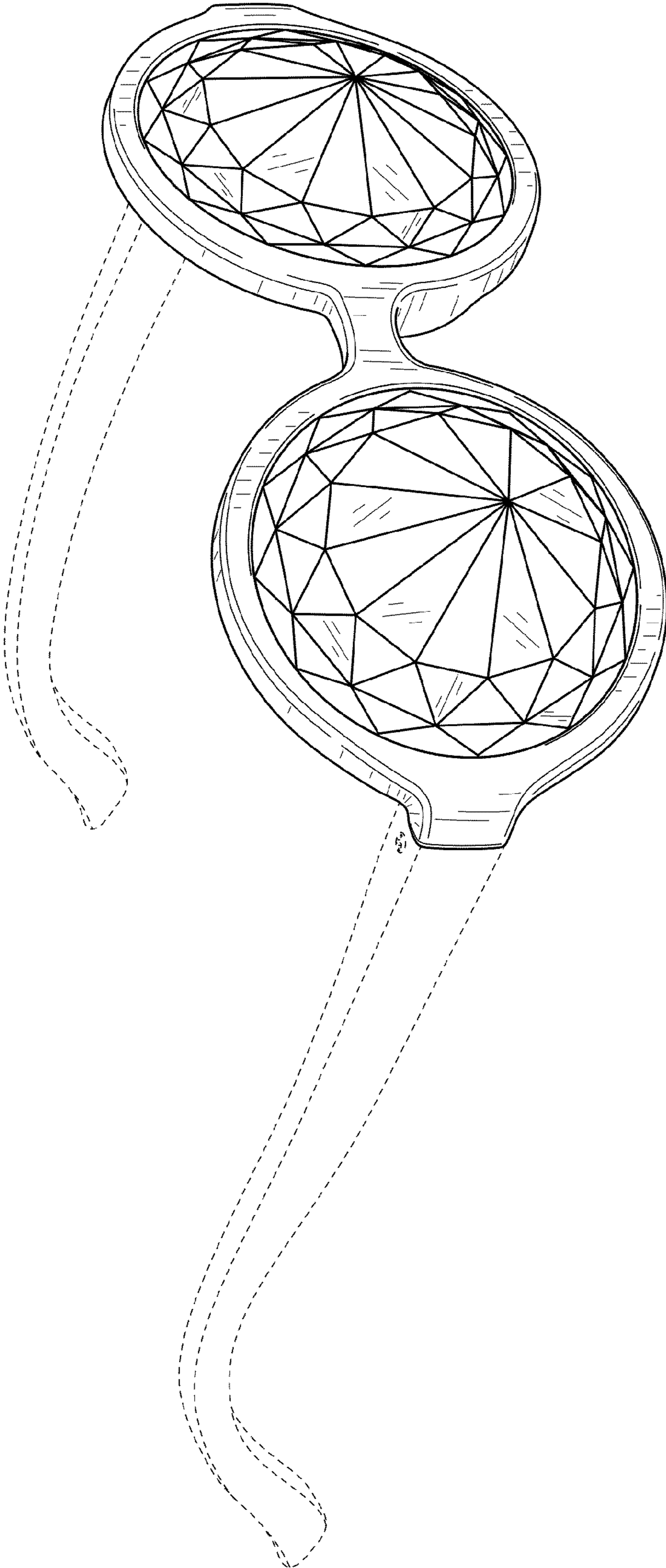

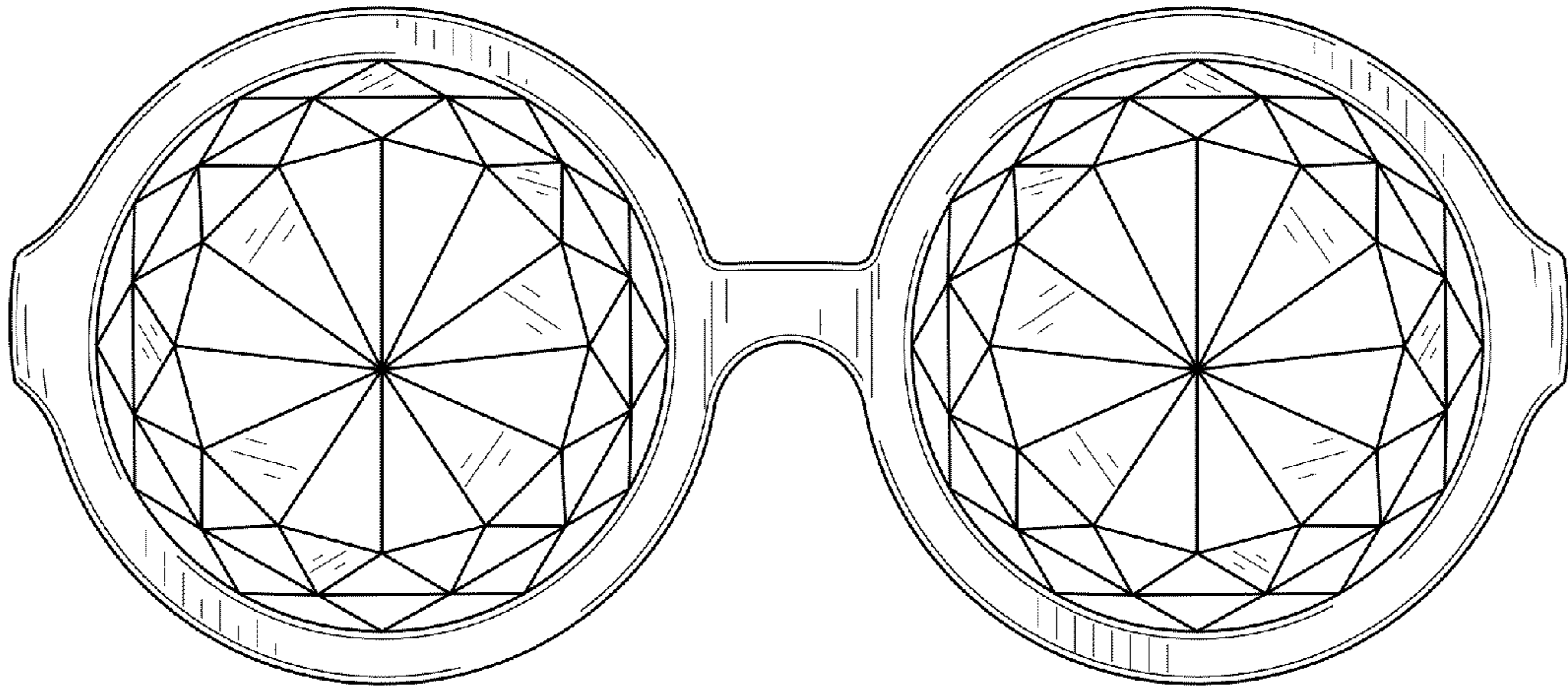

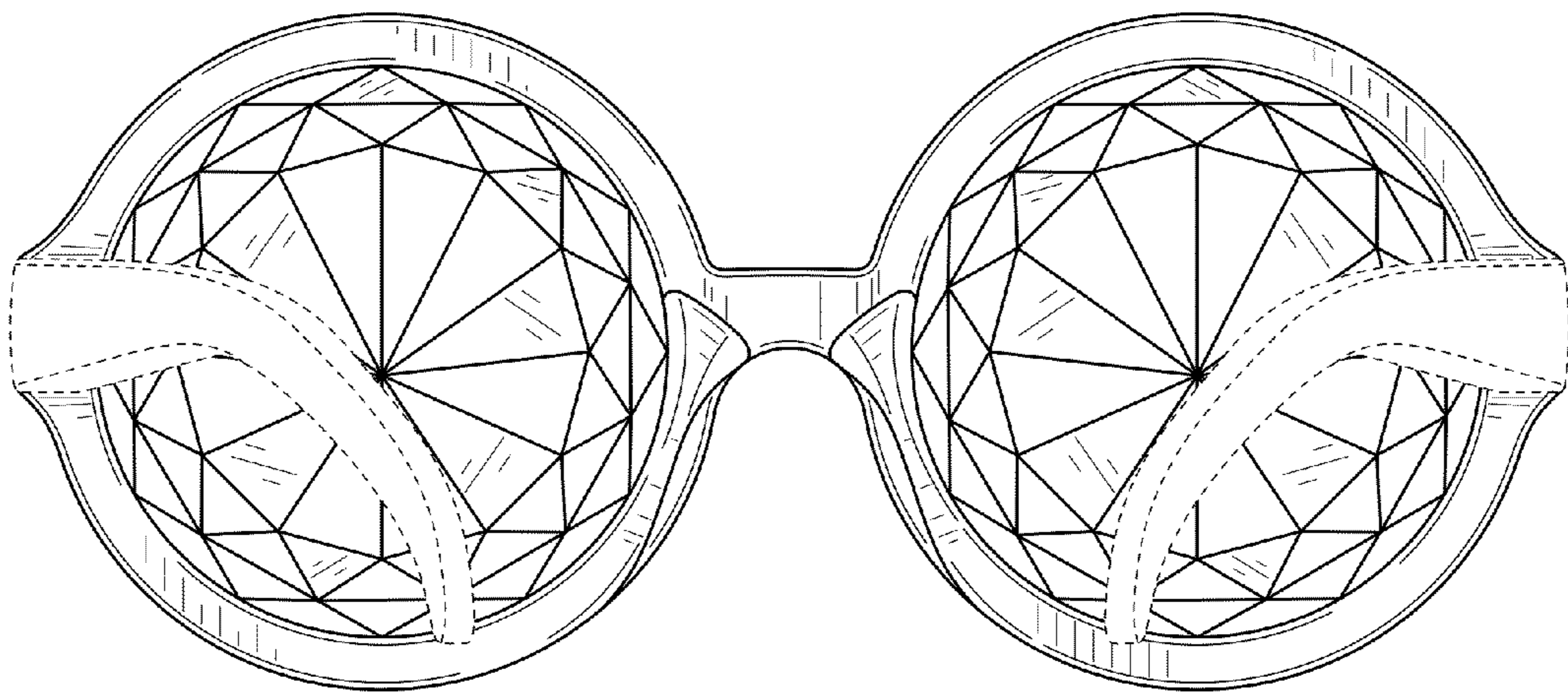

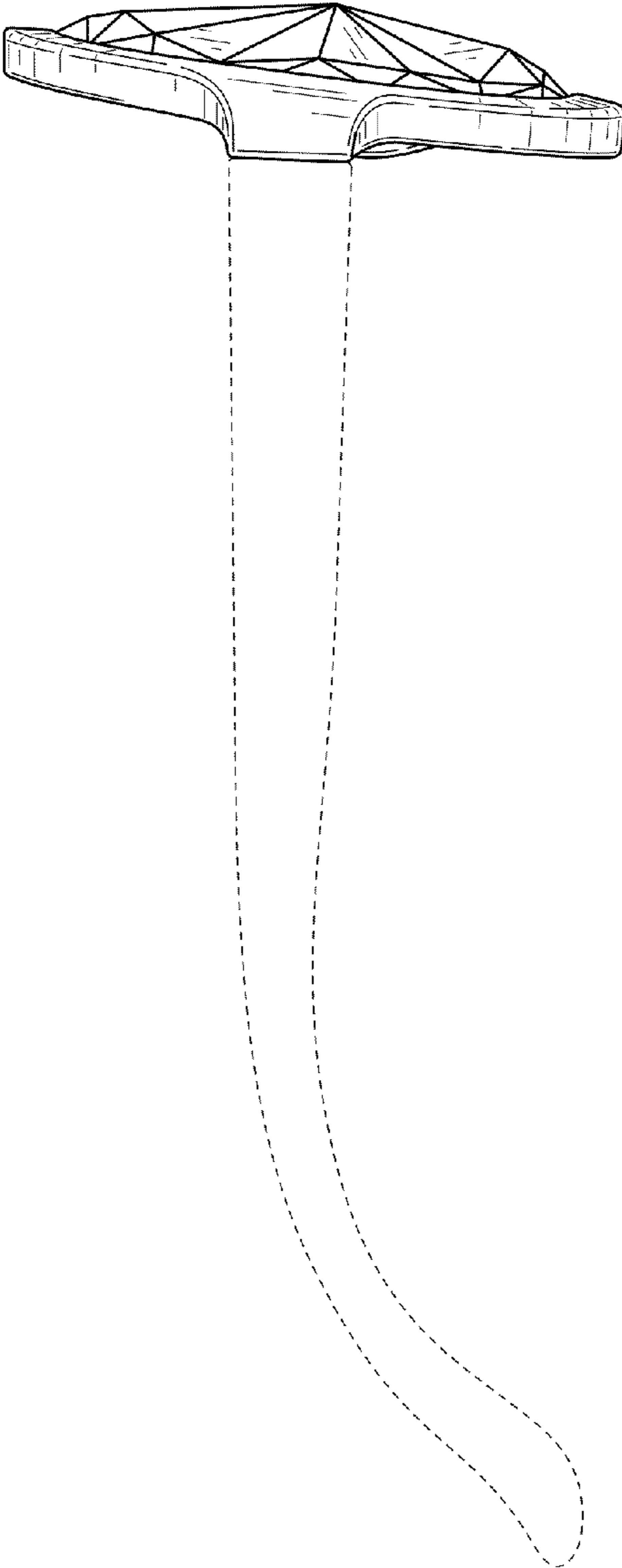

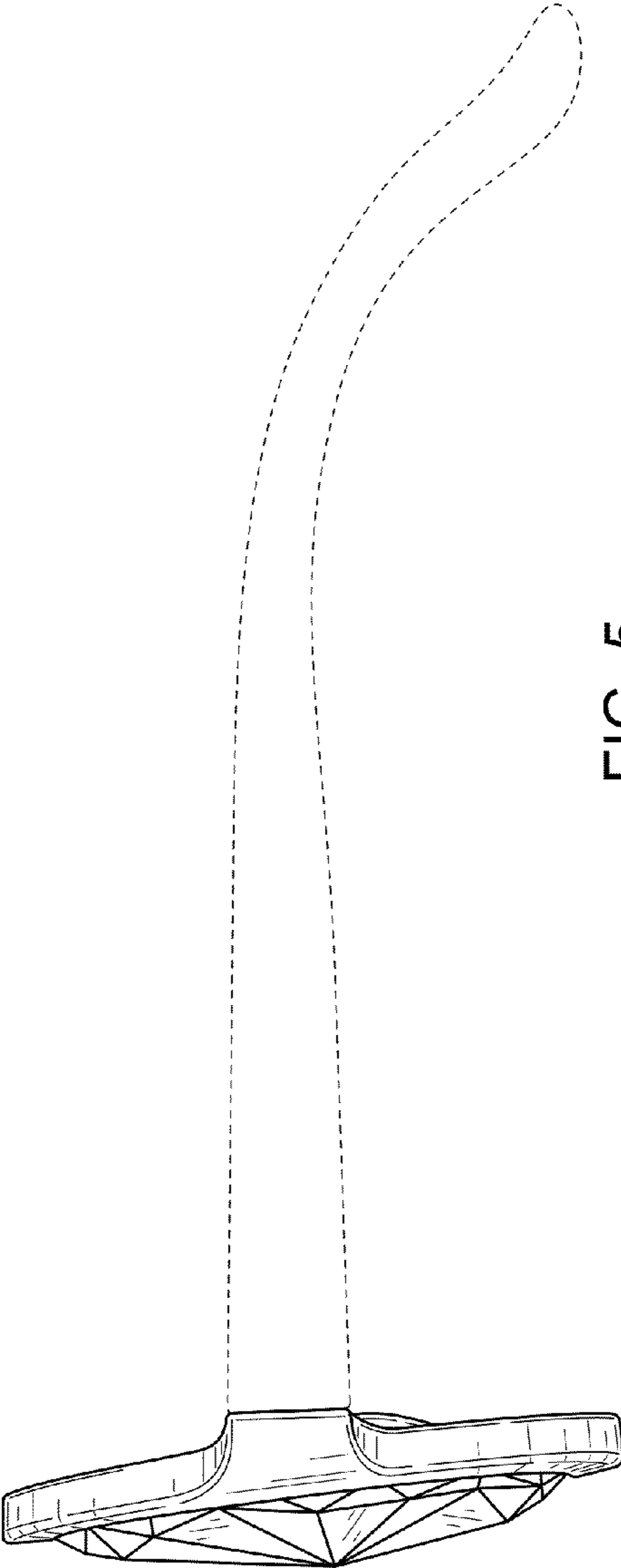

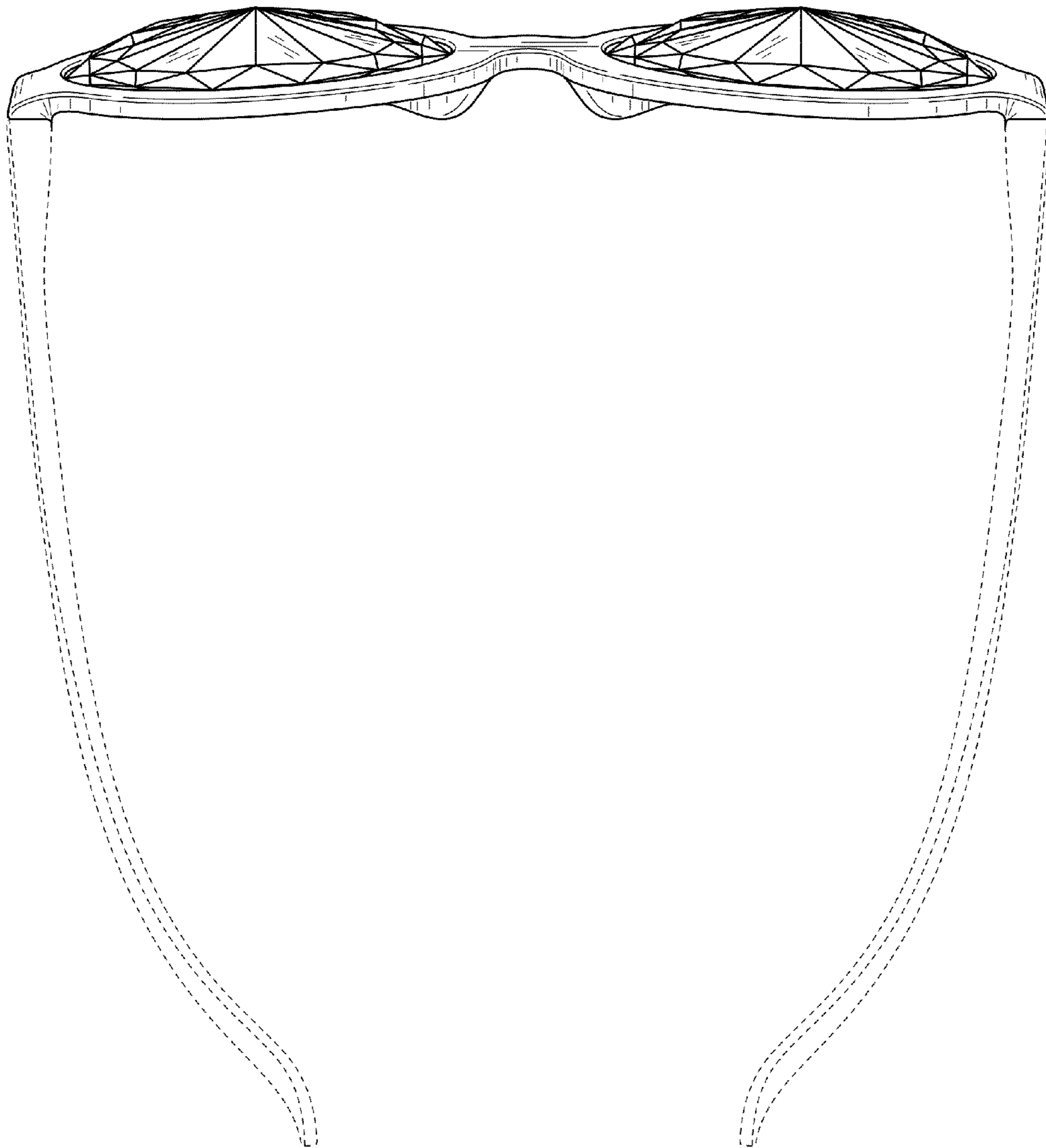
