The ornamental design for a directional sign, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the directional sign, where the reverse side is a mirror image;
FIG. 2 is a left side elevation view of the directional sign;
FIG. 3 is a top plan view of the directional sign;
FIG. 4 is a right side elevation view of the directional sign;
and,
FIG. 5 is a bottom plan view of the directional sign.

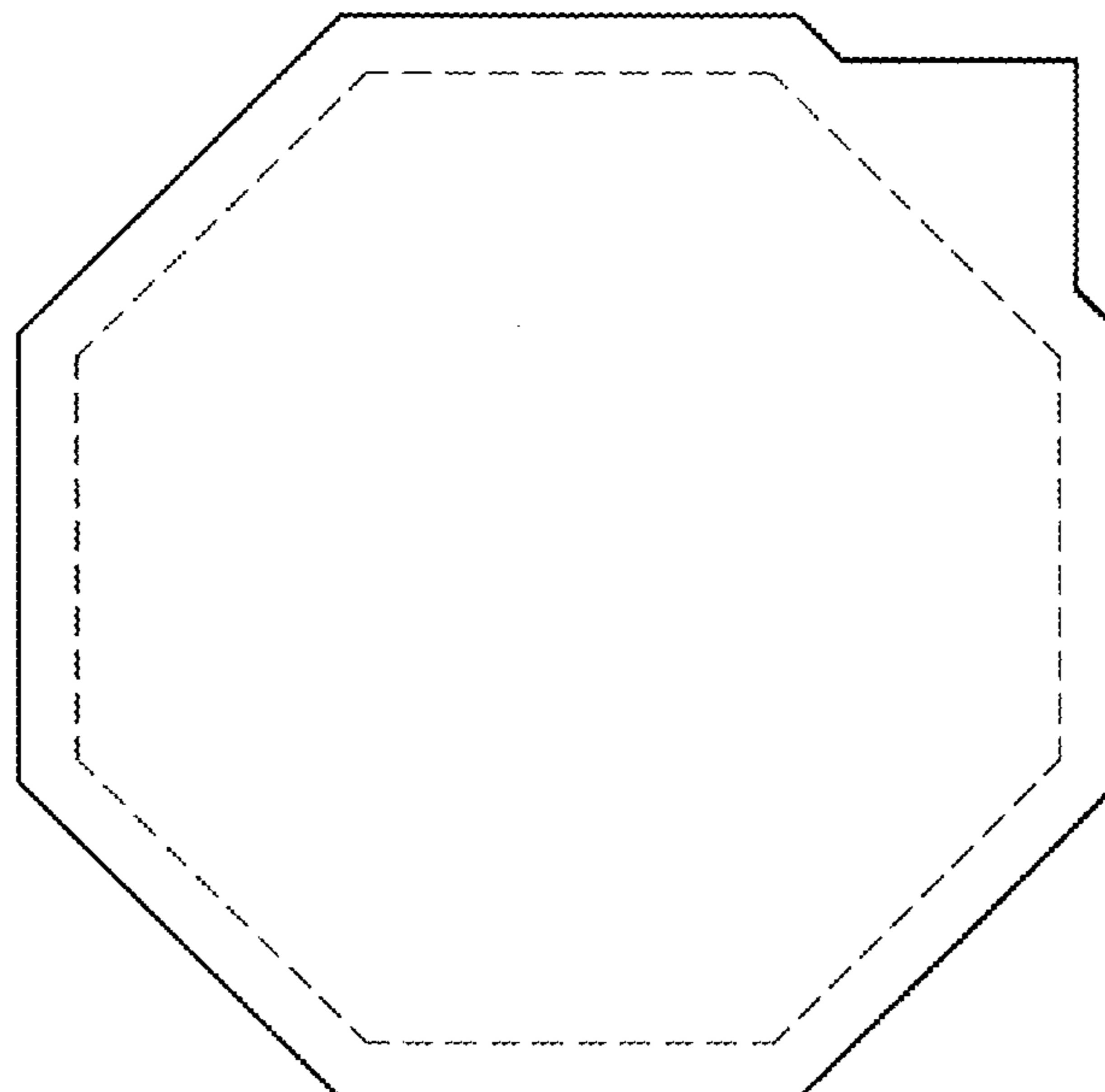

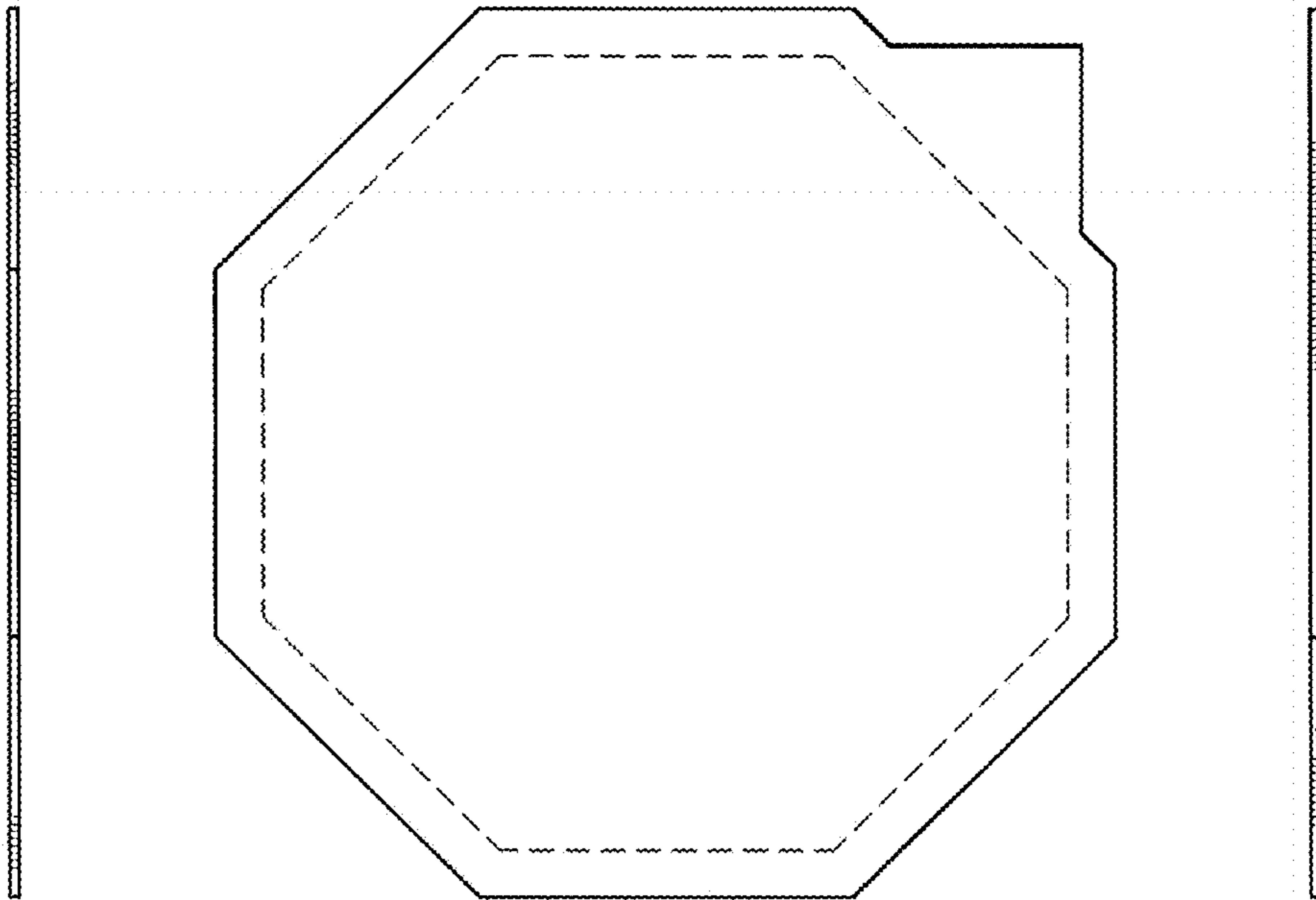
