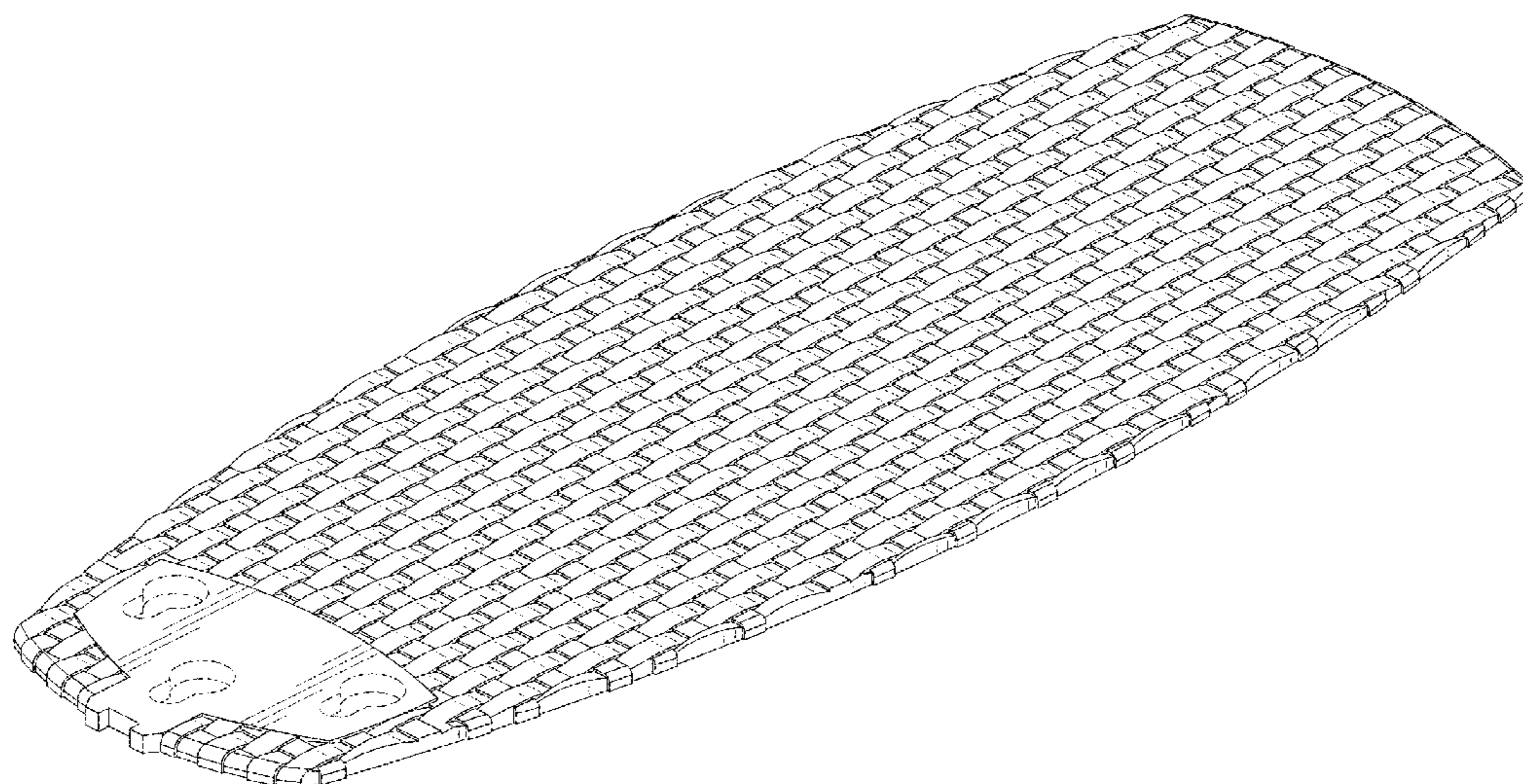
(57) **CLAIM**  
I claim the ornamental design for a ceiling fan blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a ceiling fan blade showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is another front perspective view.  
The broken lines in the drawings depict parts of the ceiling fan blade that form no part of the claimed design.

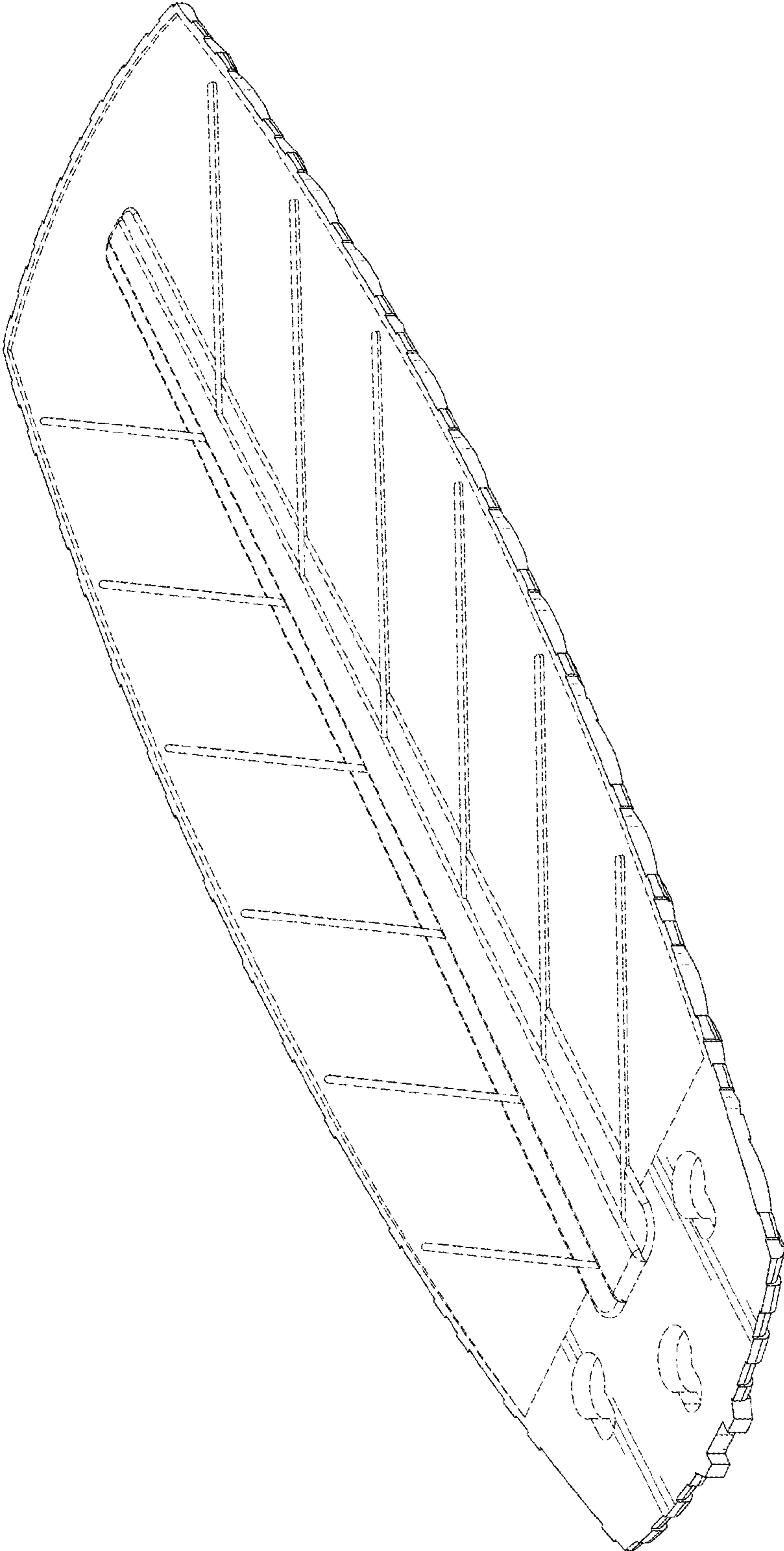

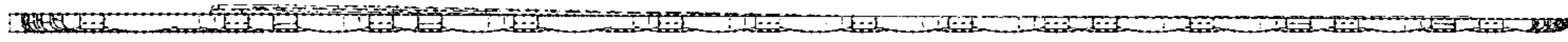

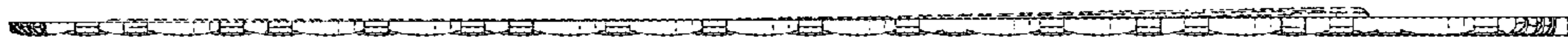

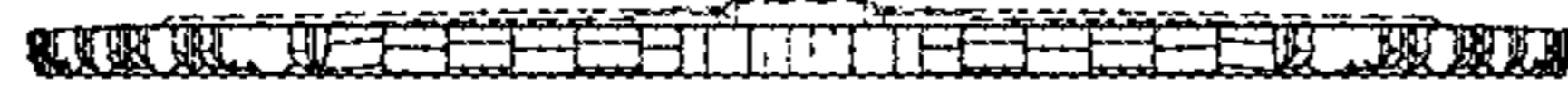

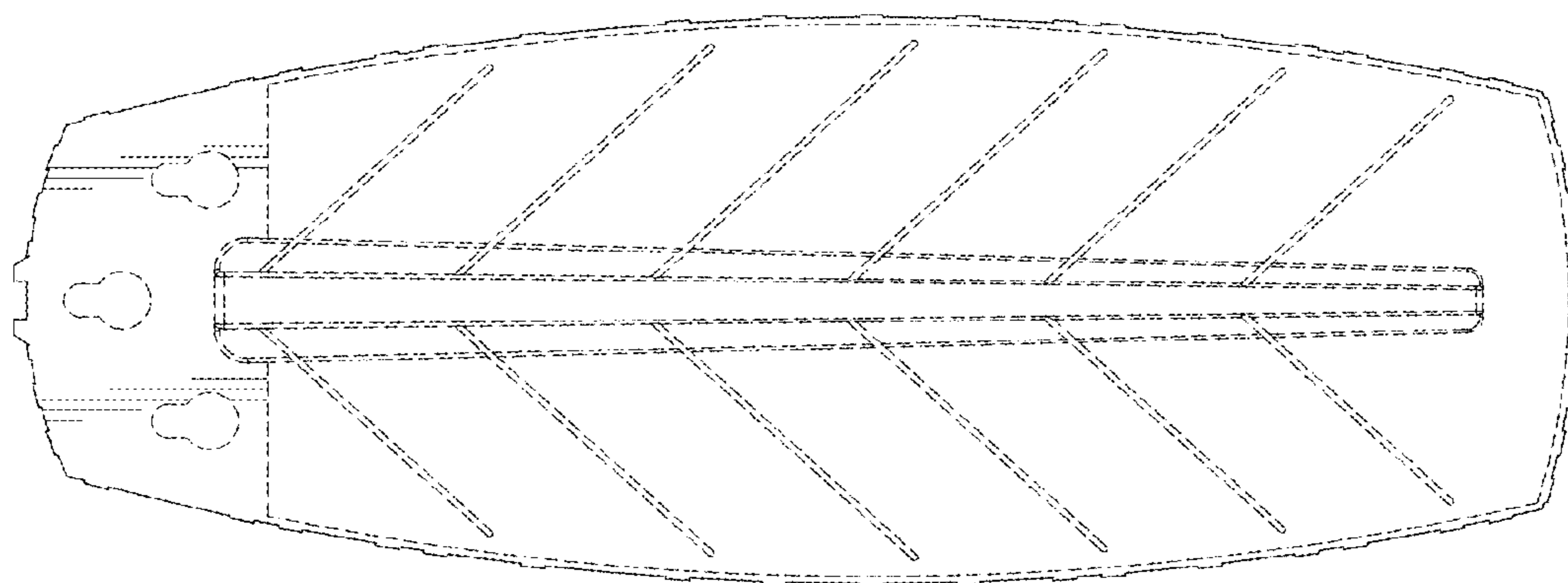

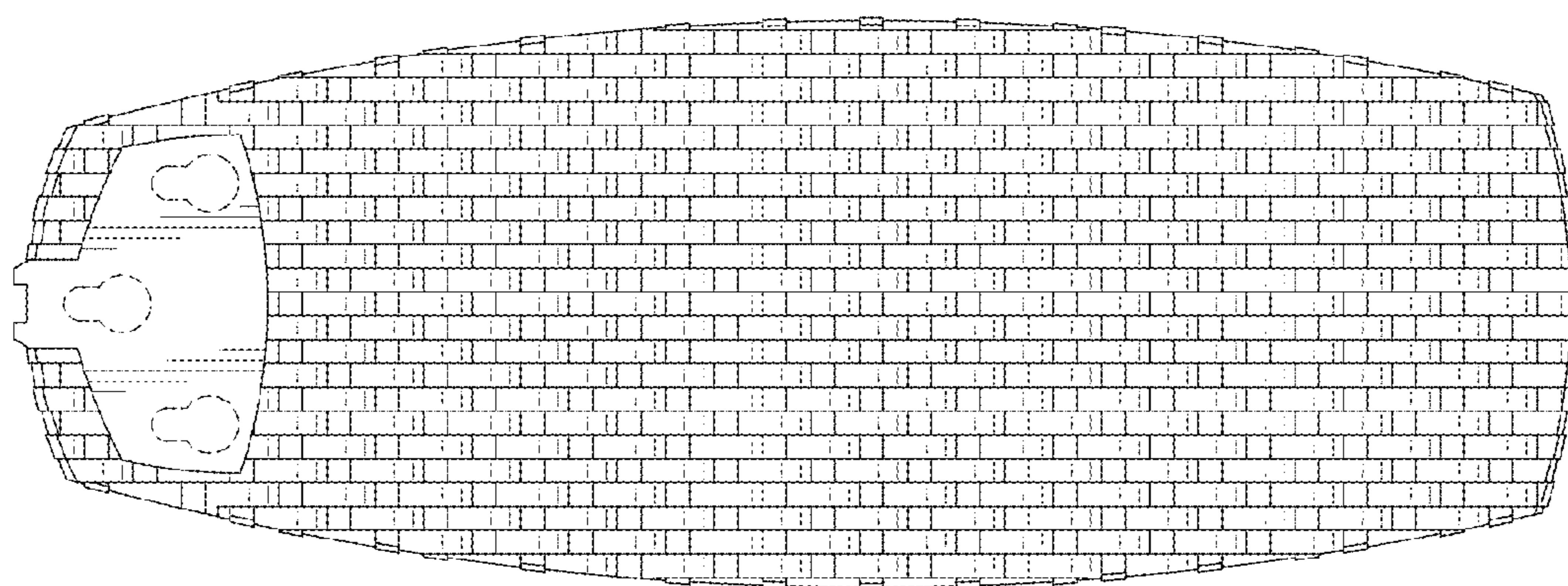

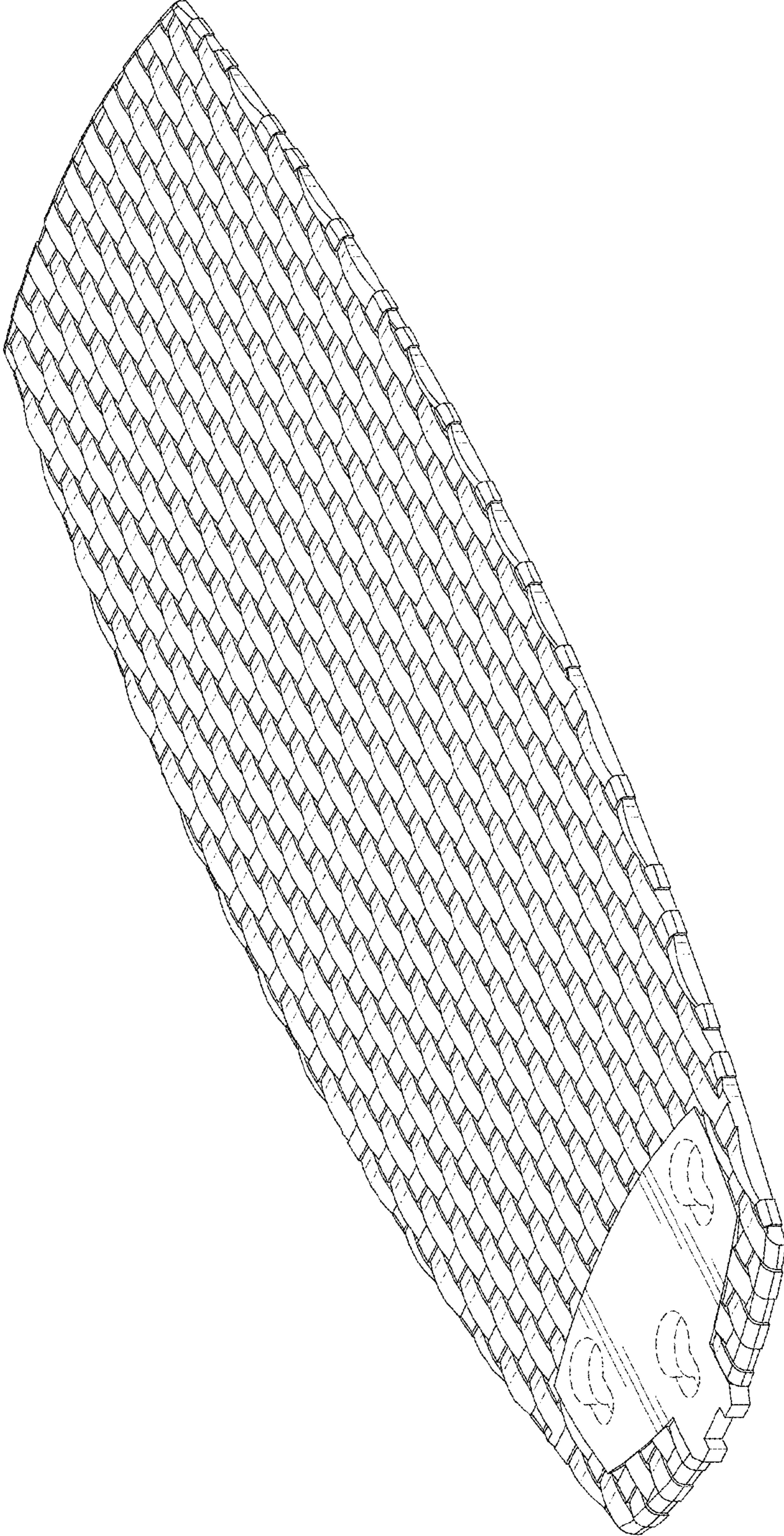
