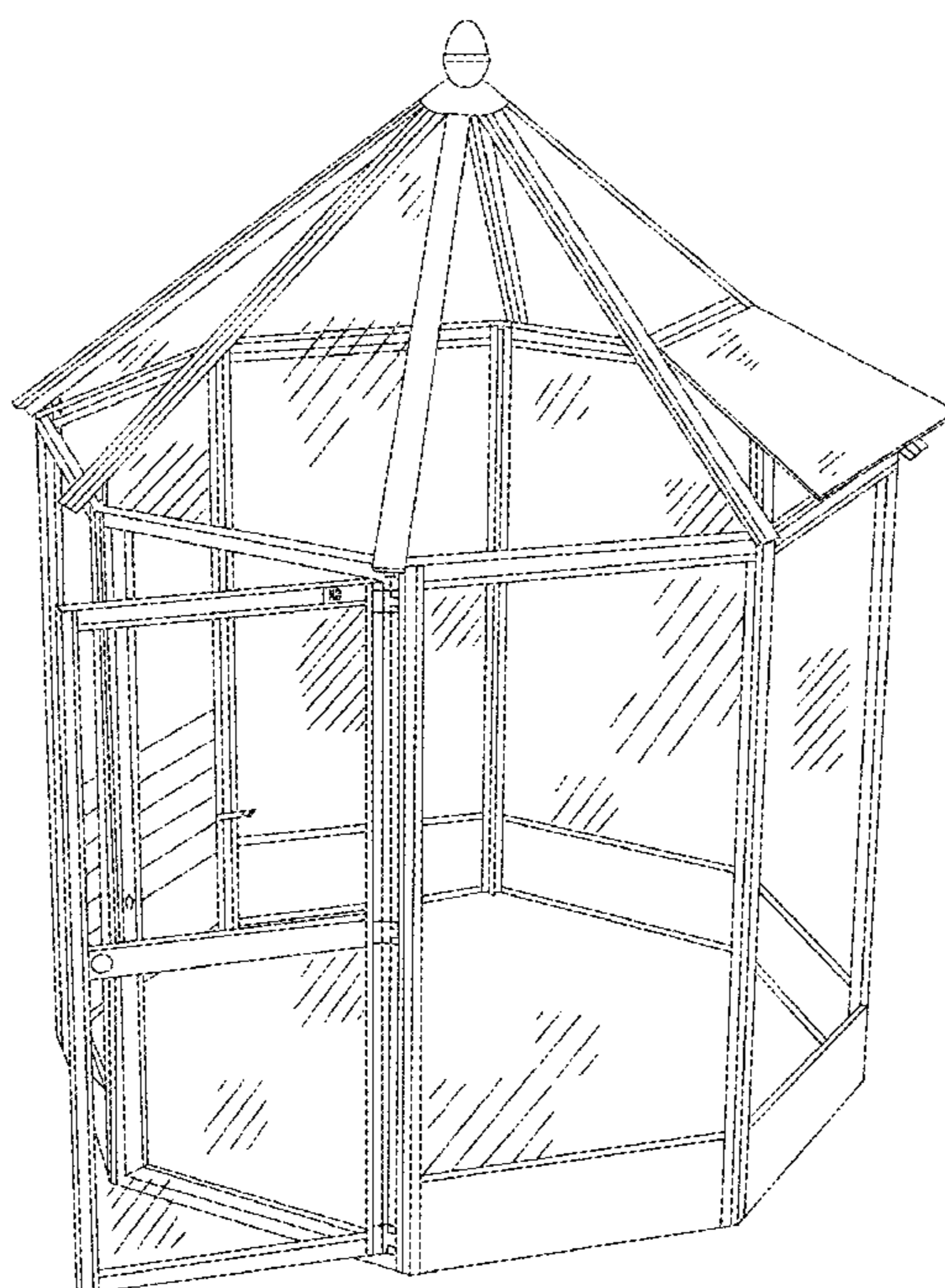
(57) **CLAIM**

The ornamental design for a glass house, as shown and described.

DESCRIPTION

FIG. 1 is a top, right side perspective view of a glass house illustrating a door and a top window in an open position.
FIG. 2 is a front view of the glass house of FIG. 1, illustrating the front door and a top window in an open position;
FIG. 3 is a front view of the glass house of FIG. 1, illustrating the front door in an open position;
FIG. 4 is a left side view of the glass house of FIG. 1, illustrating the front door in an open position;
FIG. 5 is a left side view of the glass house of FIG. 1, with the door and window in a closed position; and,
FIG. 6 is top view of the glass house of FIG. 1, illustrating the front door and a top window on the right side in the open position.

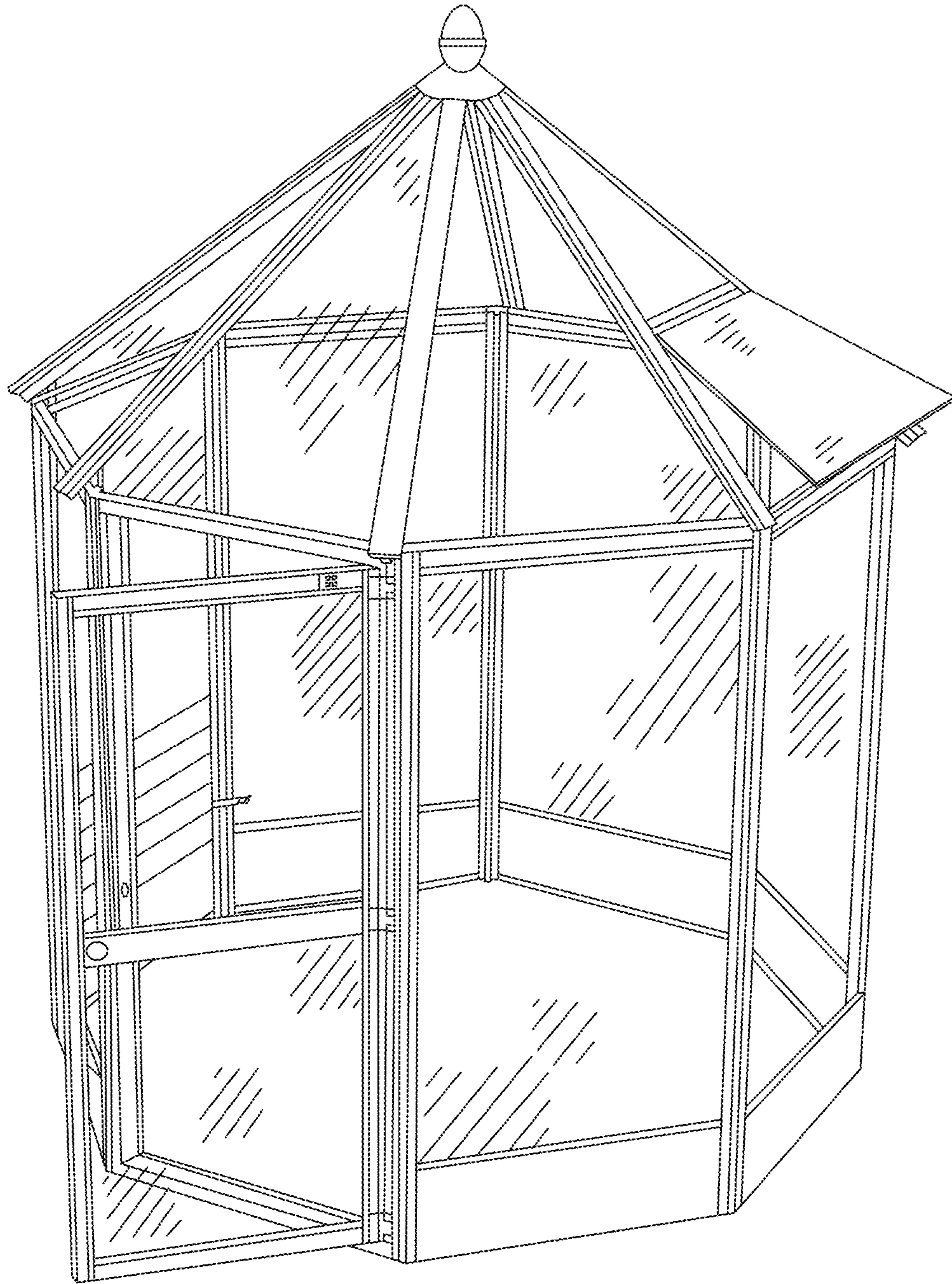

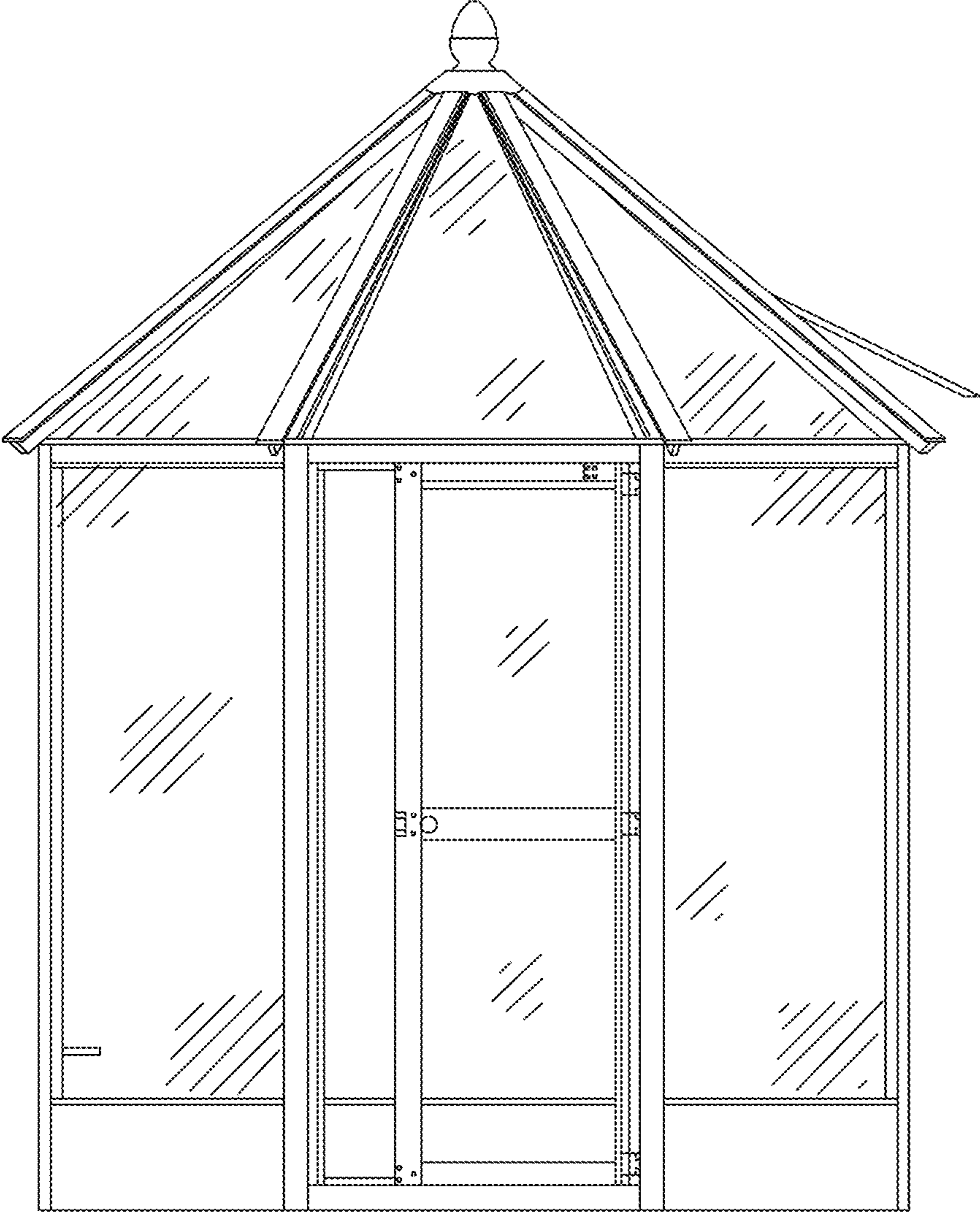

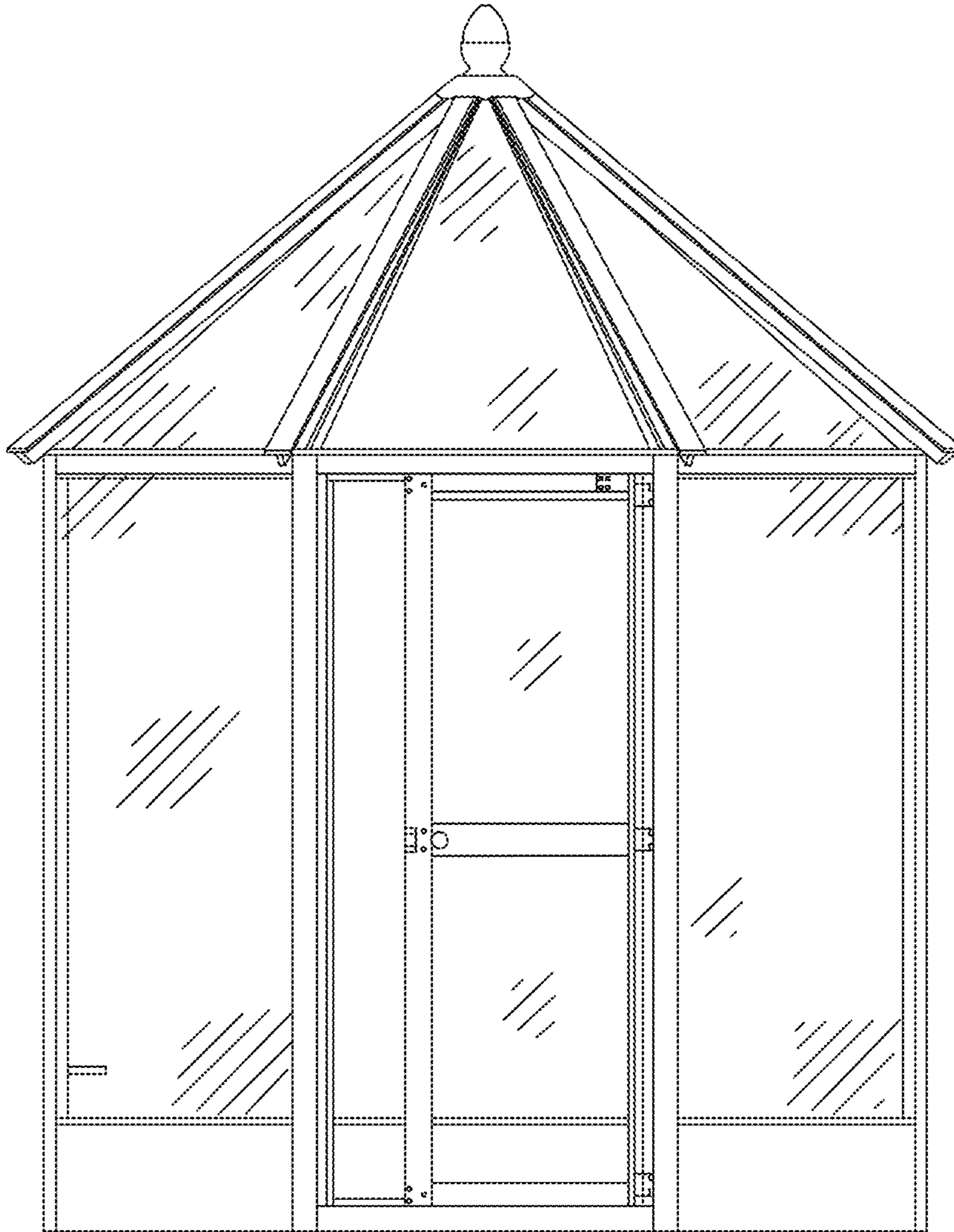

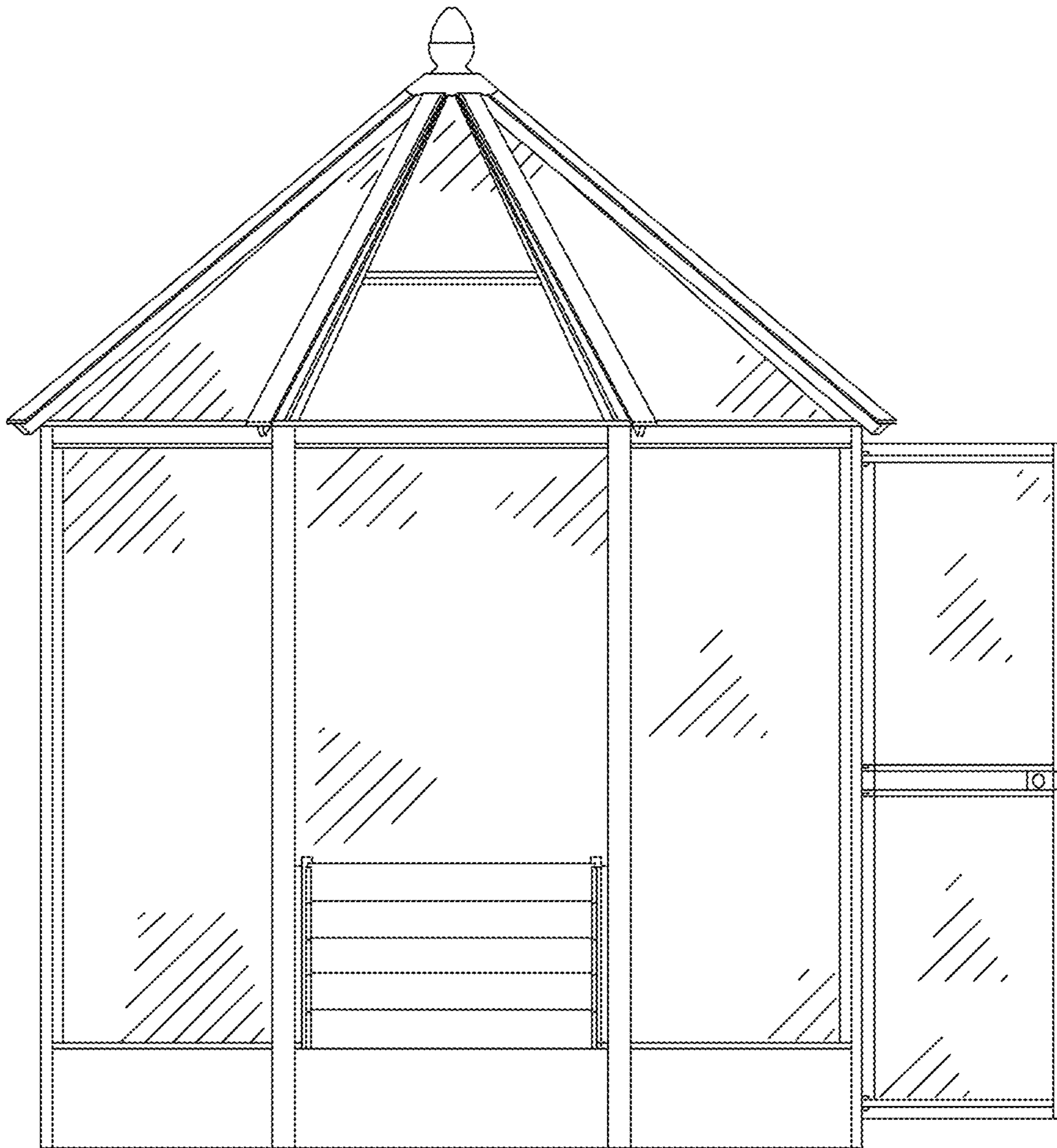

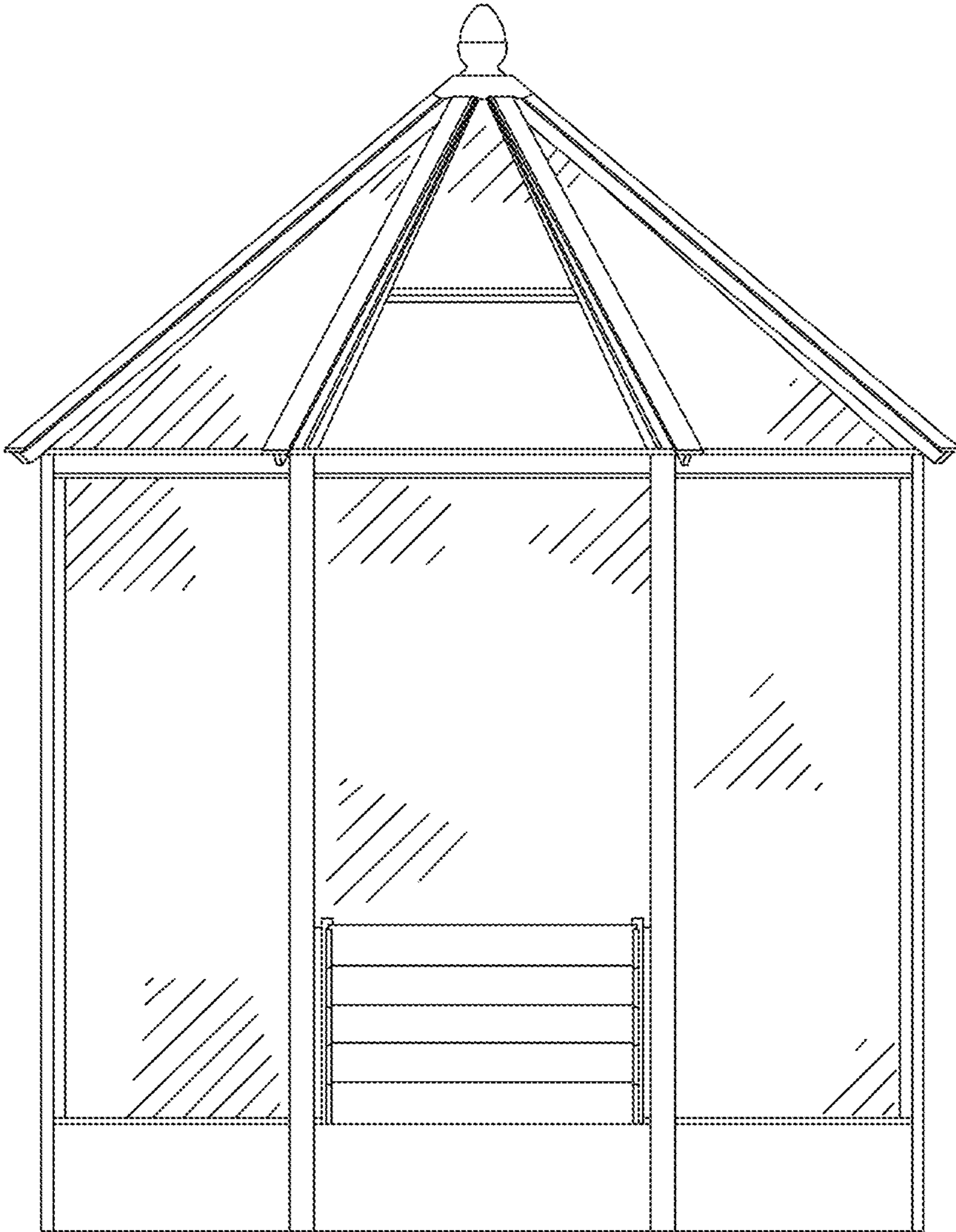

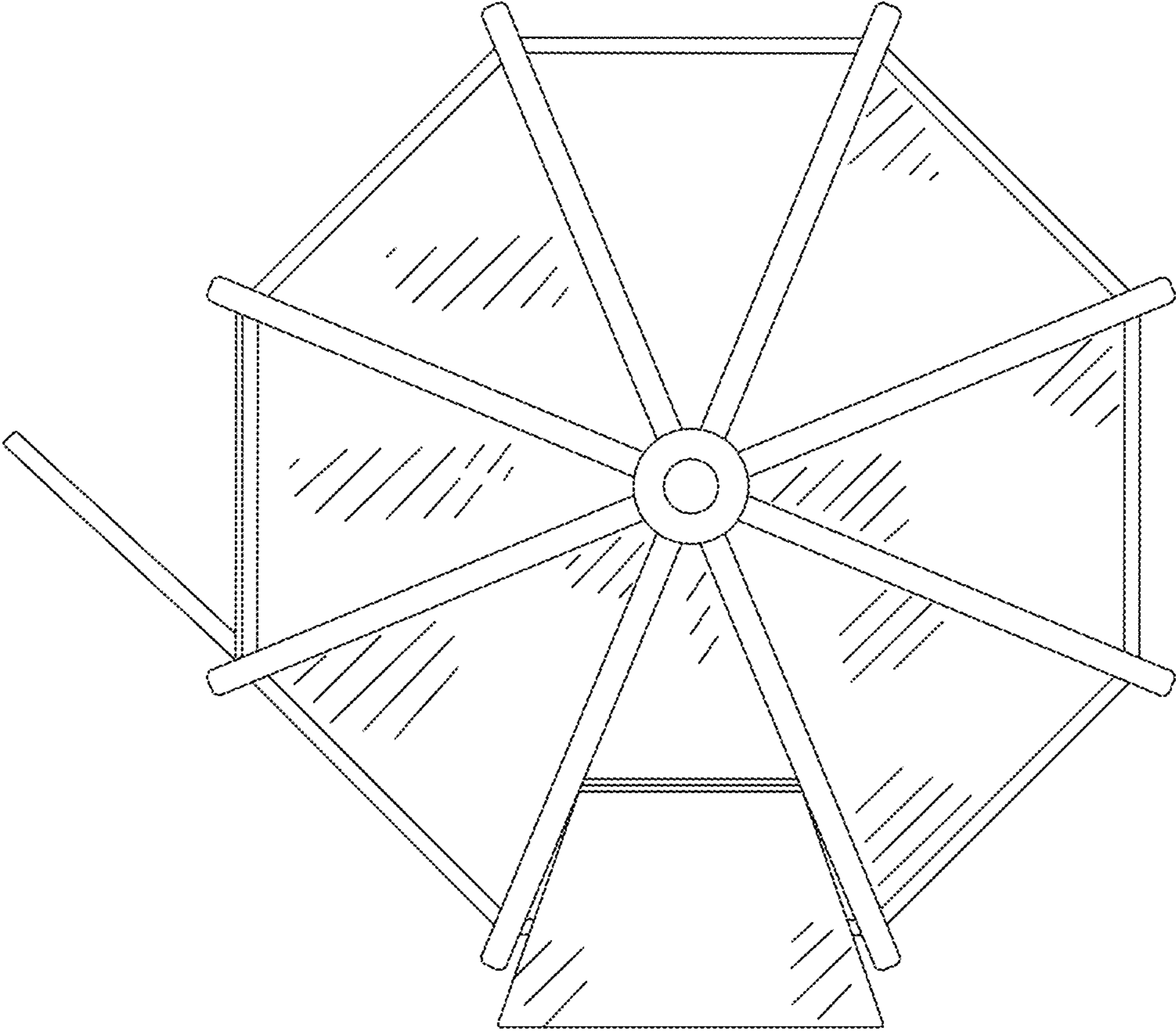
