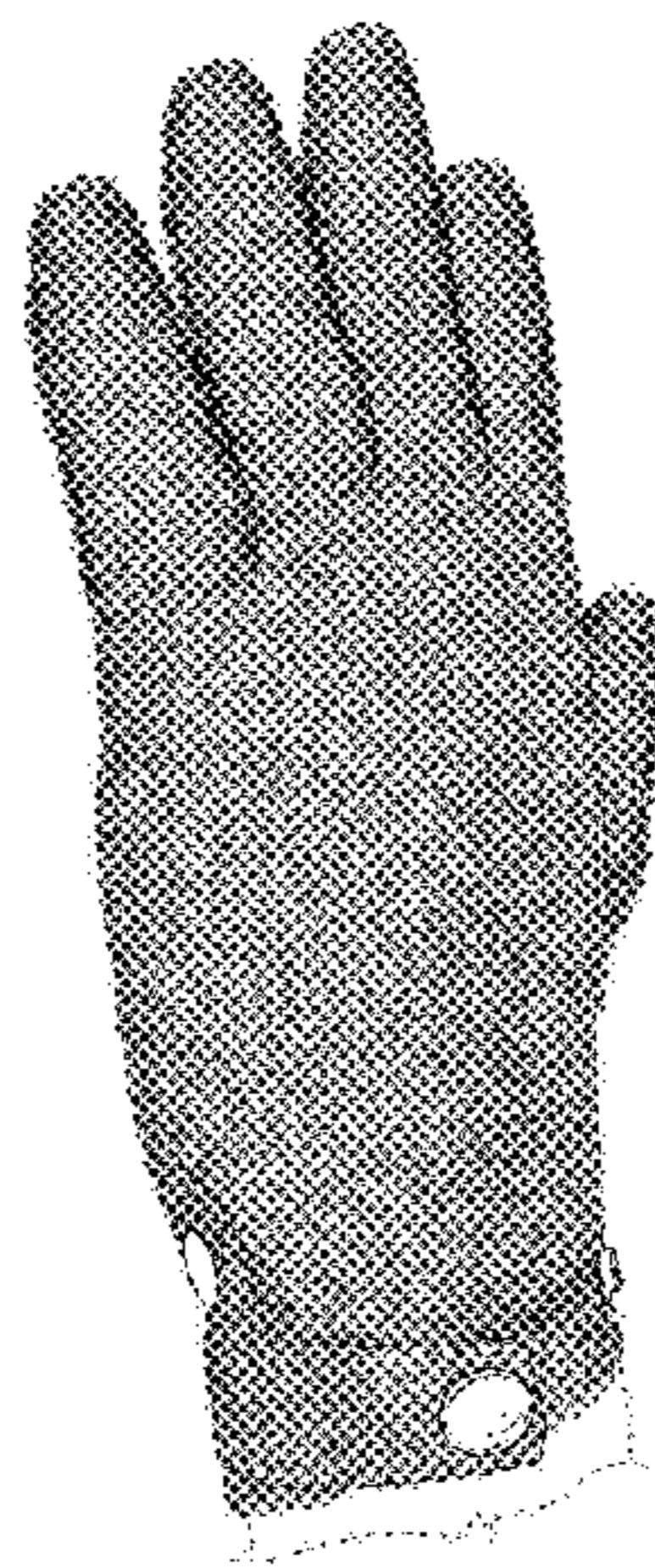

(57) **CLAIM**  
I claim the ornamental design for a mesh glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a mesh glove, in accordance with the present design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a front perspective view thereof, with the clasp in the opened position; and,  
FIG. 9 is a left perspective view thereof, with the clasp in the opened position.  
The broken lines shown are included for the purpose of illustrating environment that forms no part of the claimed design.

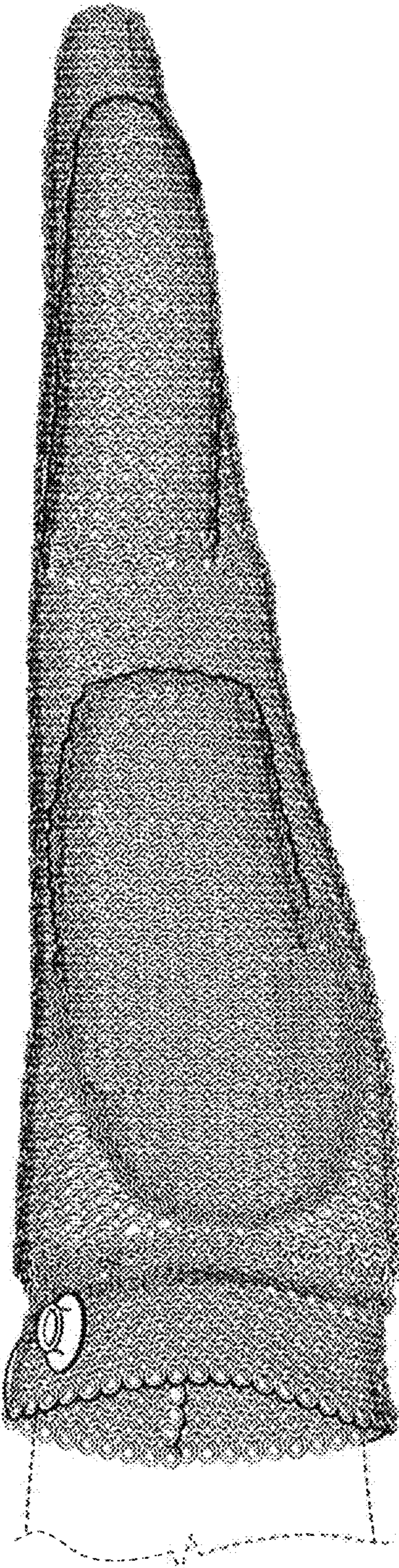
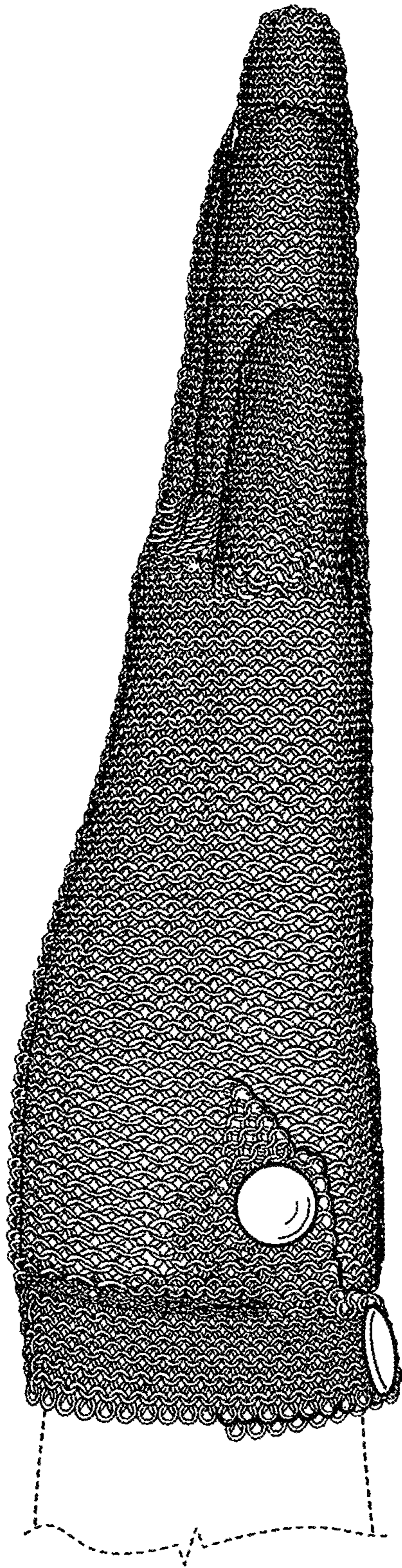

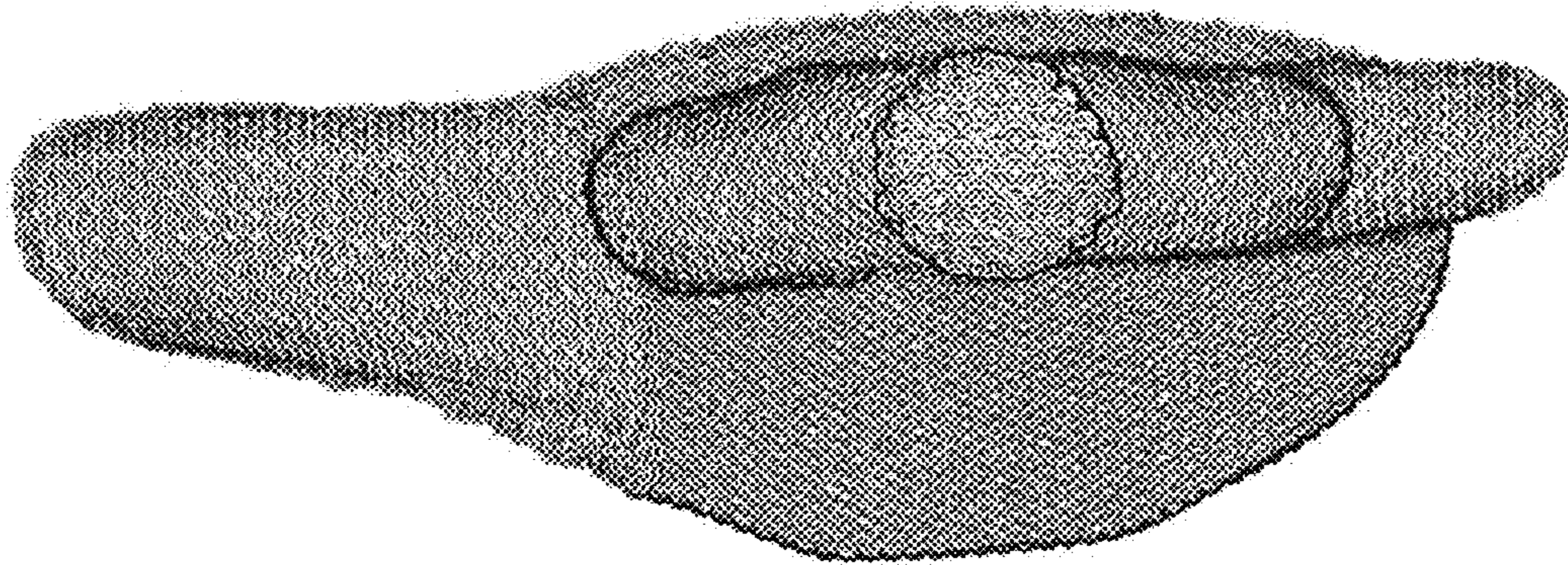

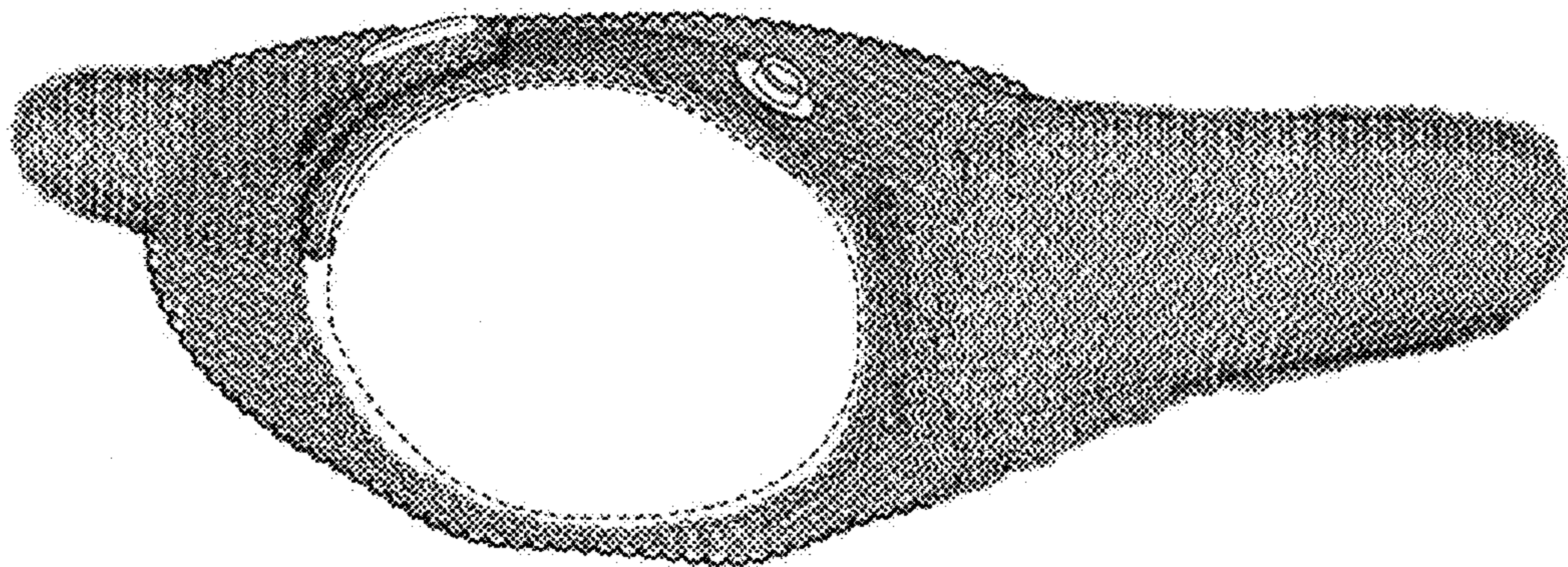

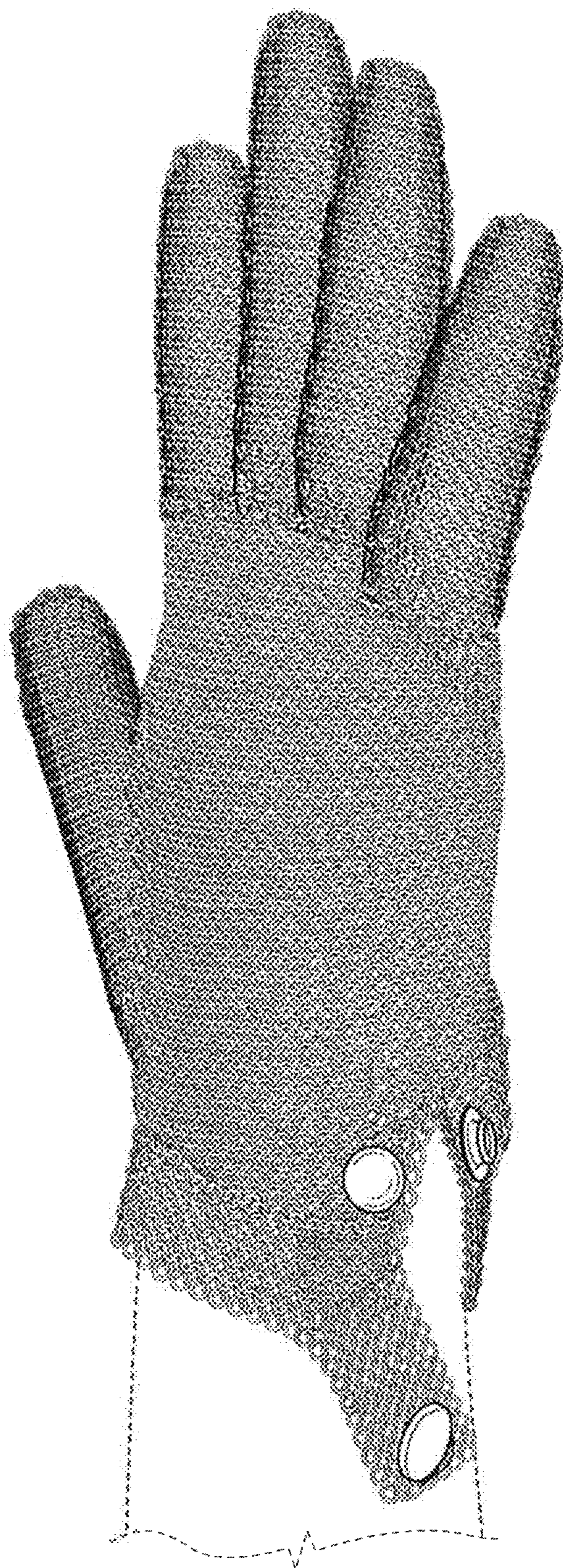

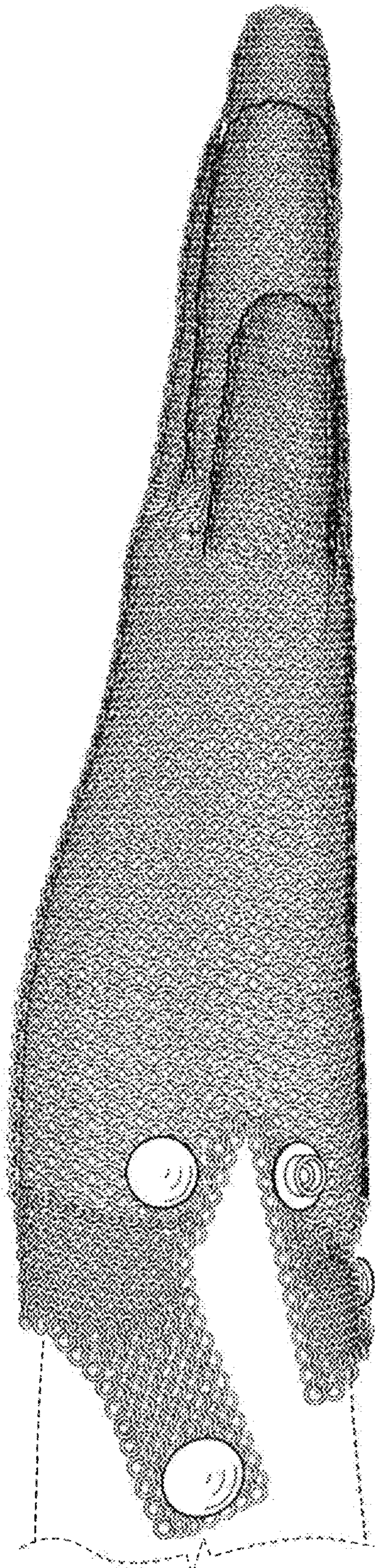
