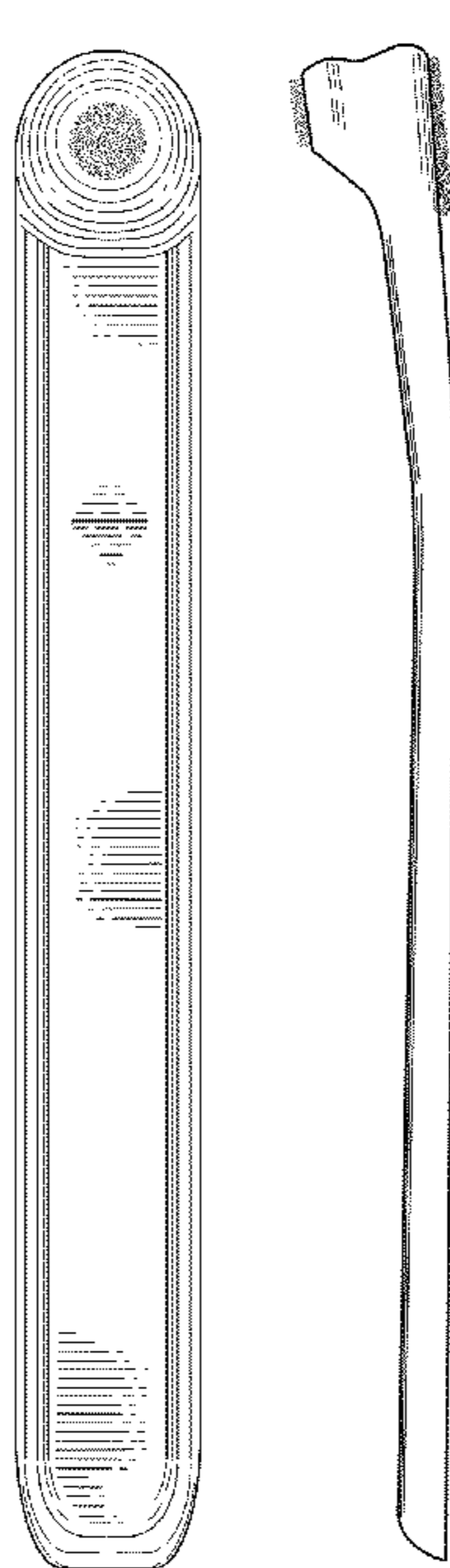
(57) **CLAIM**

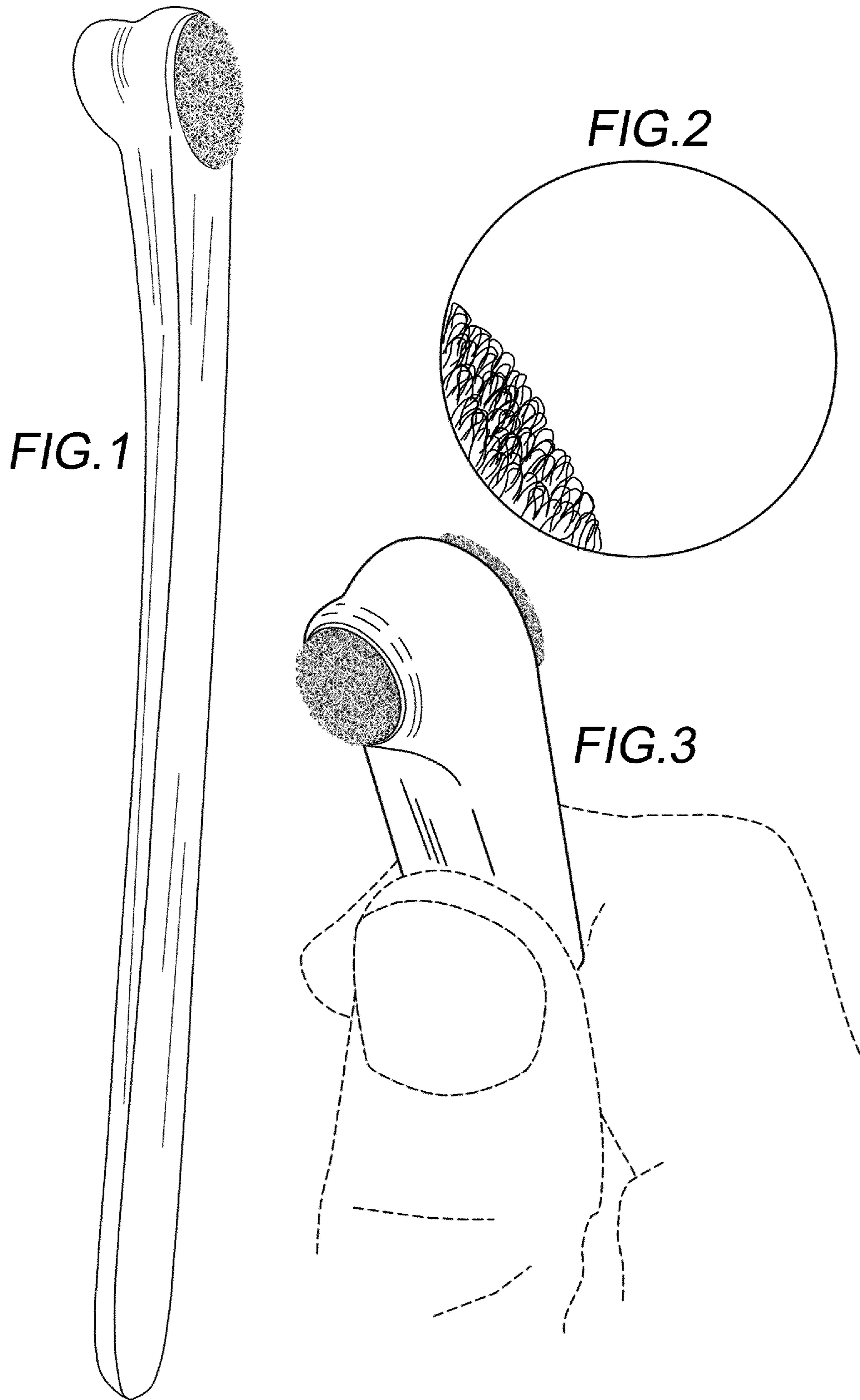
The ornamental design for the eye cleaning implement, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my eye cleaning implement;
FIG. 2 is a greatly enlarged detail view thereof showing the looped texture of the cleaning pad;
FIG. 3 is an enlarged, partial, rear perspective view thereof shown in an Environmental setting;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a cross-sectional view taken along lines 6-6 of (FIG. 4);
FIG. 7 is a side elevation view thereof; and,
FIG. 8 is the opposite side elevation view thereof.
The dashed lines showing a human hand in FIG. 3 and a flat surface in FIGS. 7 and 8 are for illustrative purposes only and form no part of the claimed design.

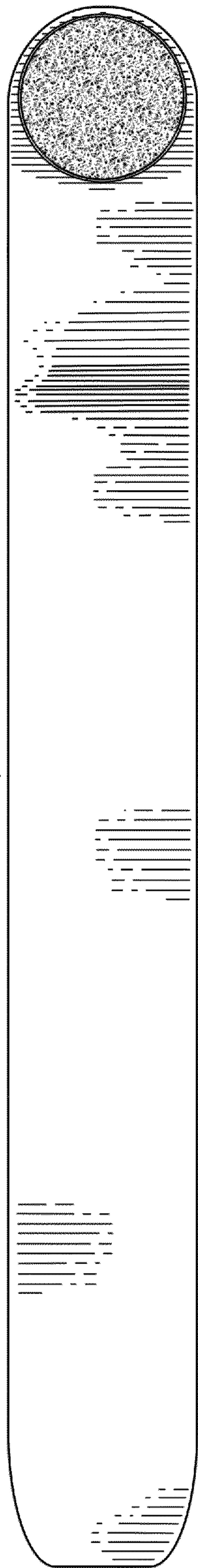

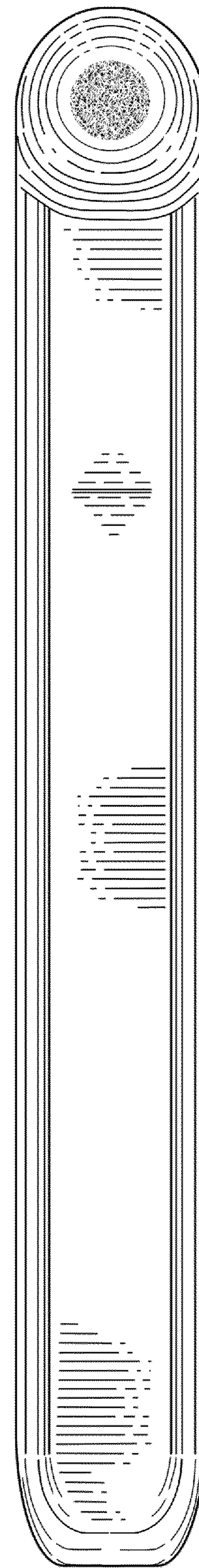

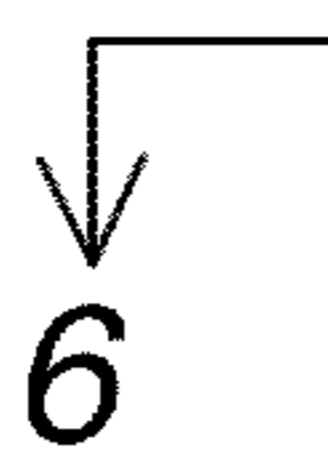

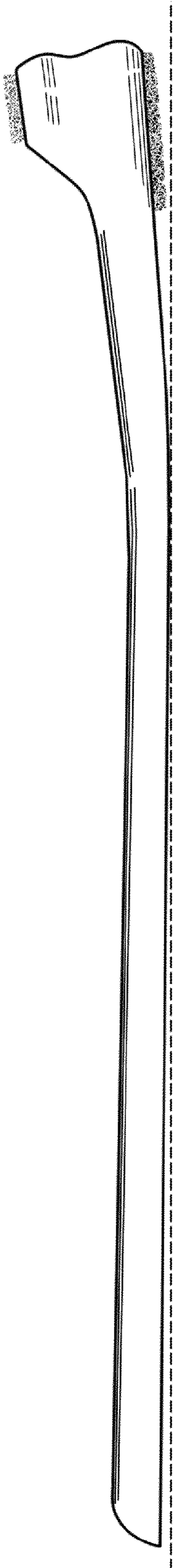
