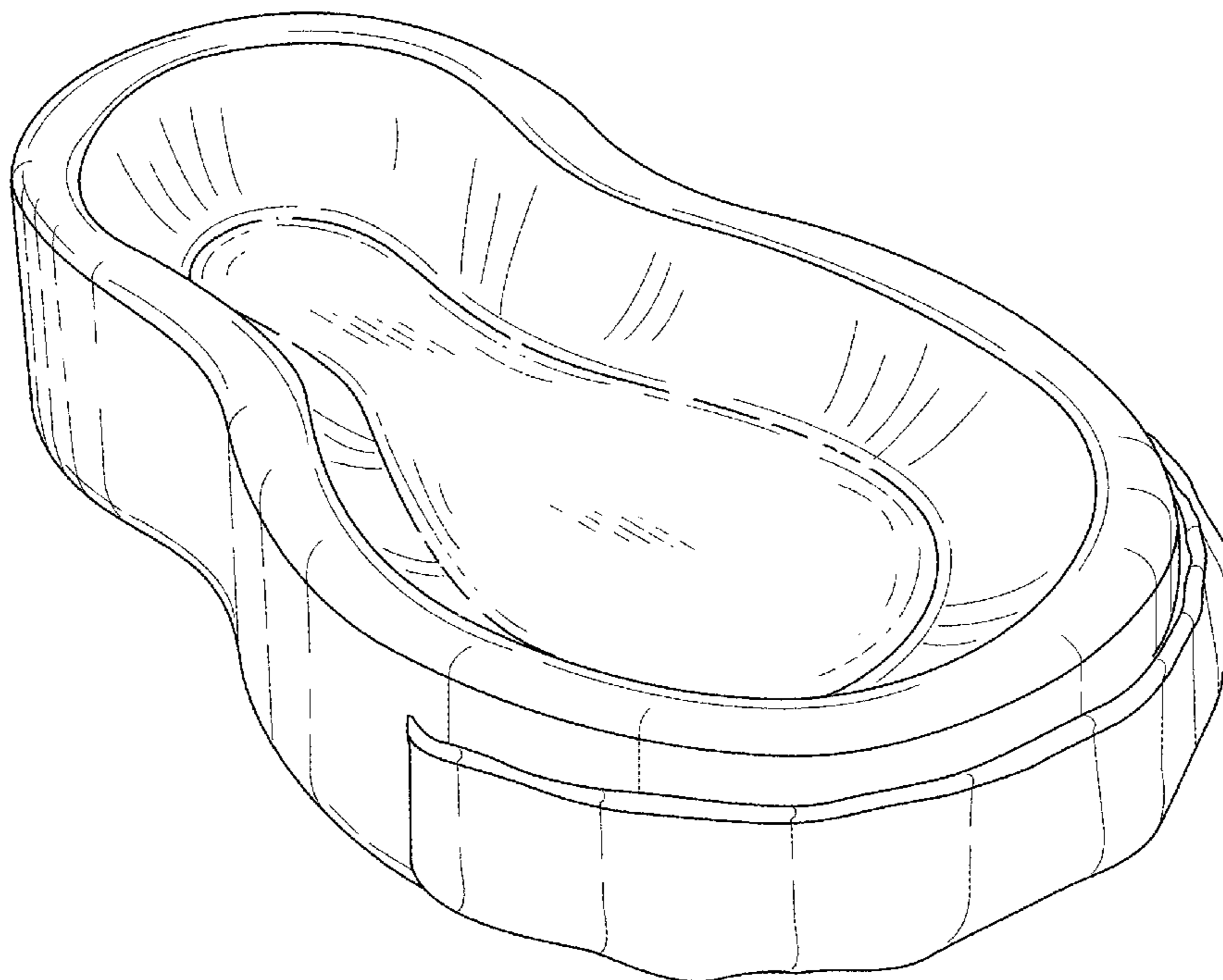
(57) **CLAIM**

The ornamental design for a baby cushion, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a baby cushion;
FIG. 2 is a left side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a perspective view thereof;
FIG. 8 is a rear perspective view thereof, showing a strap; and,

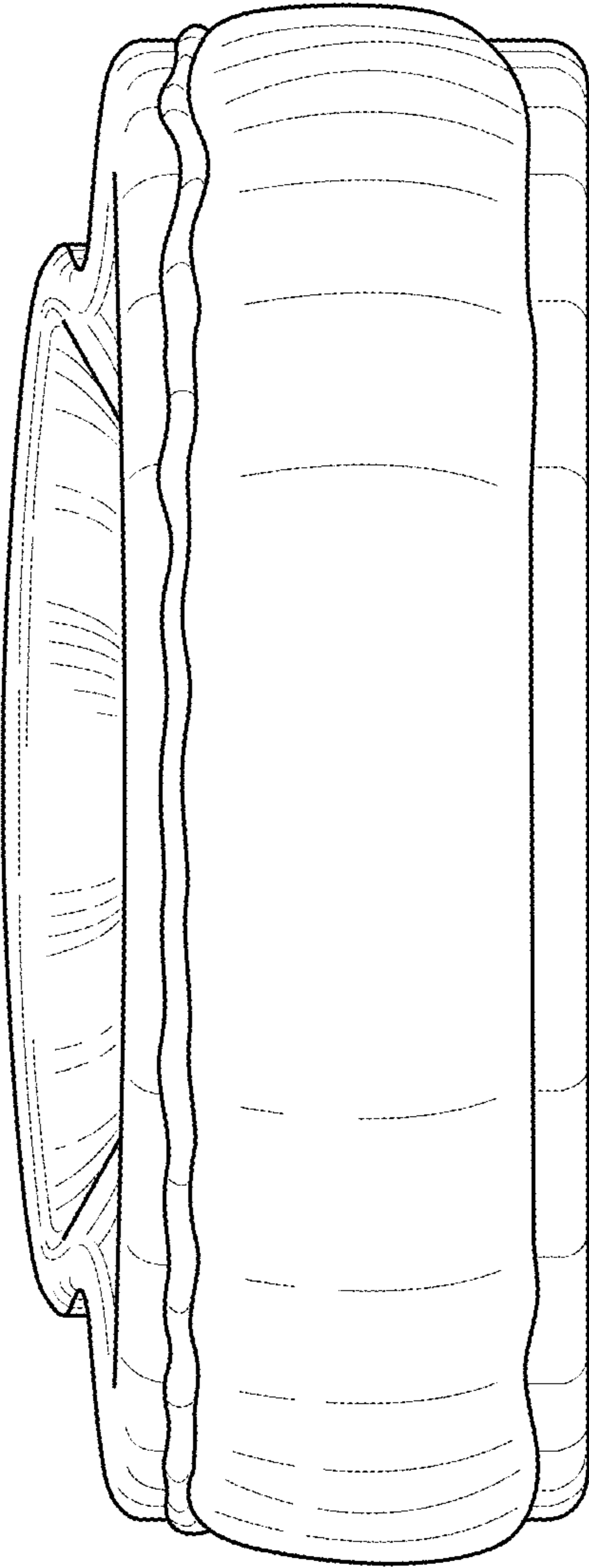

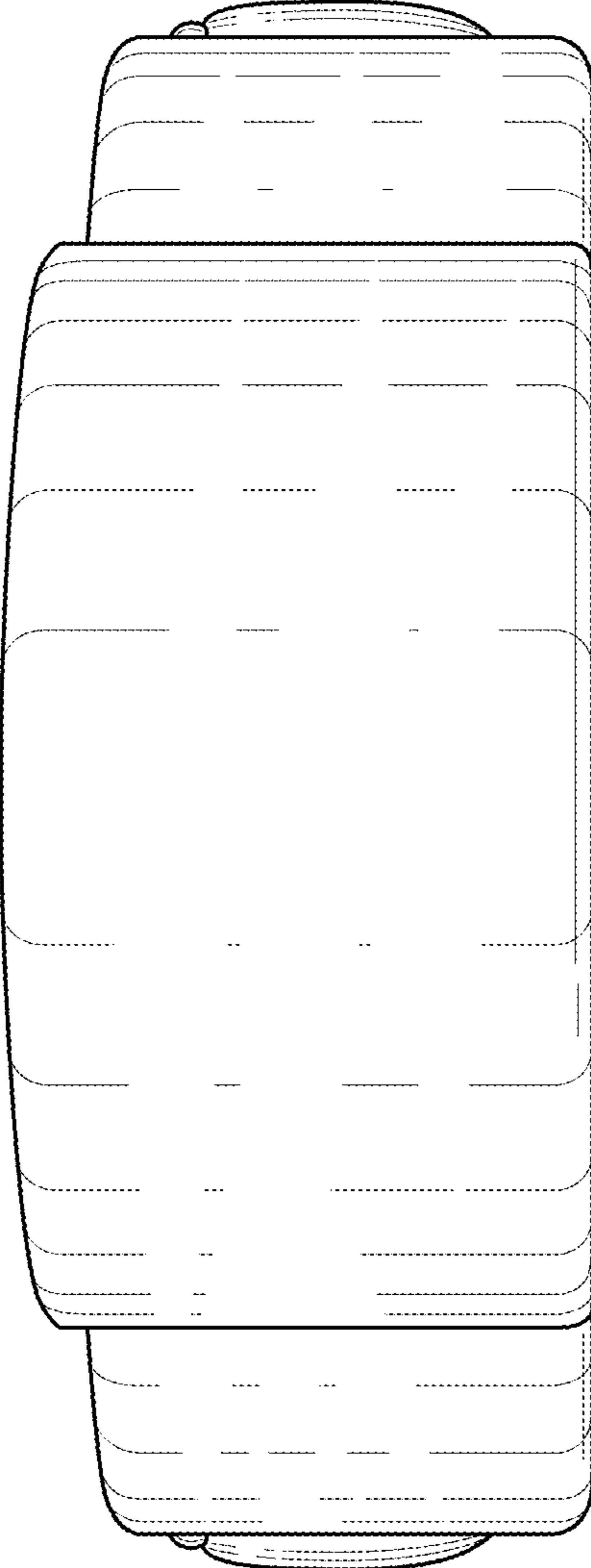

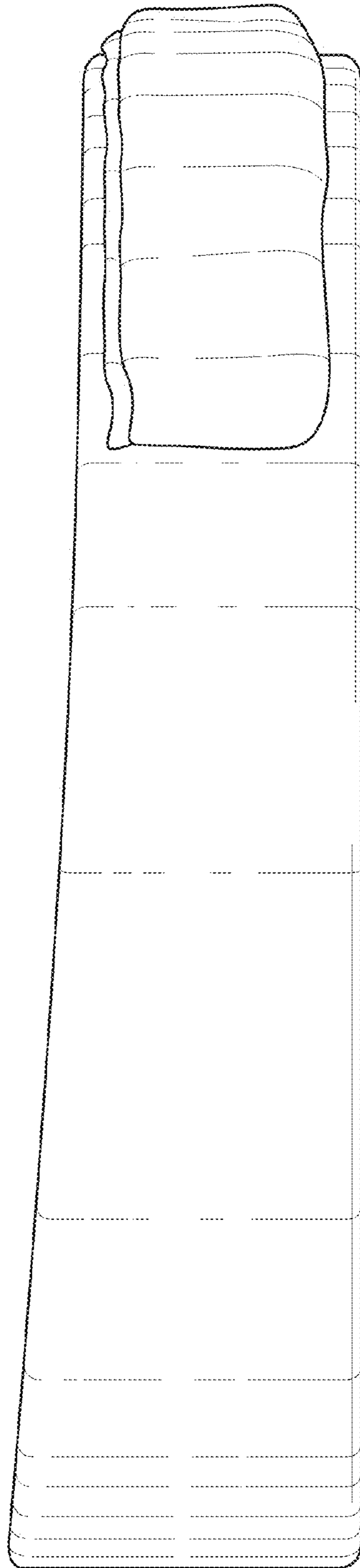

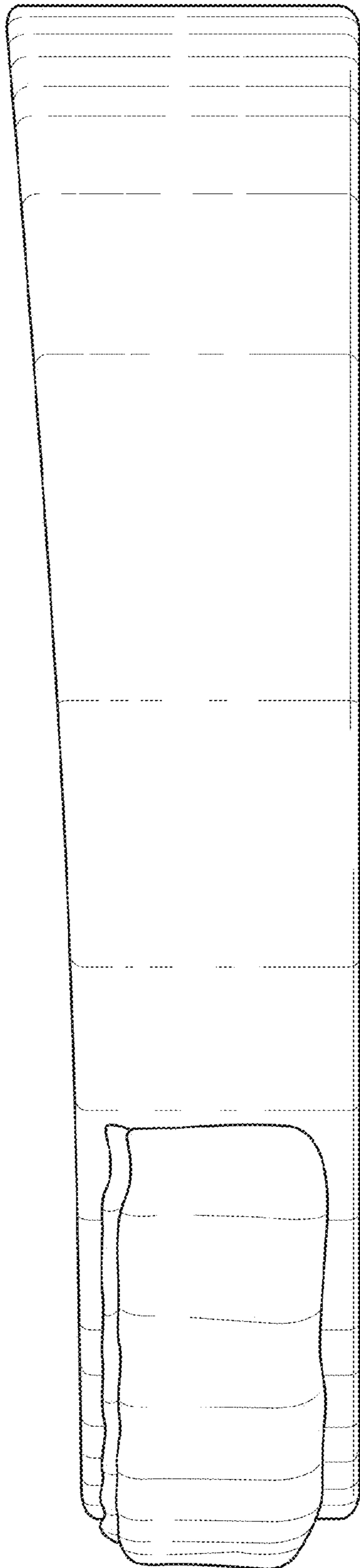

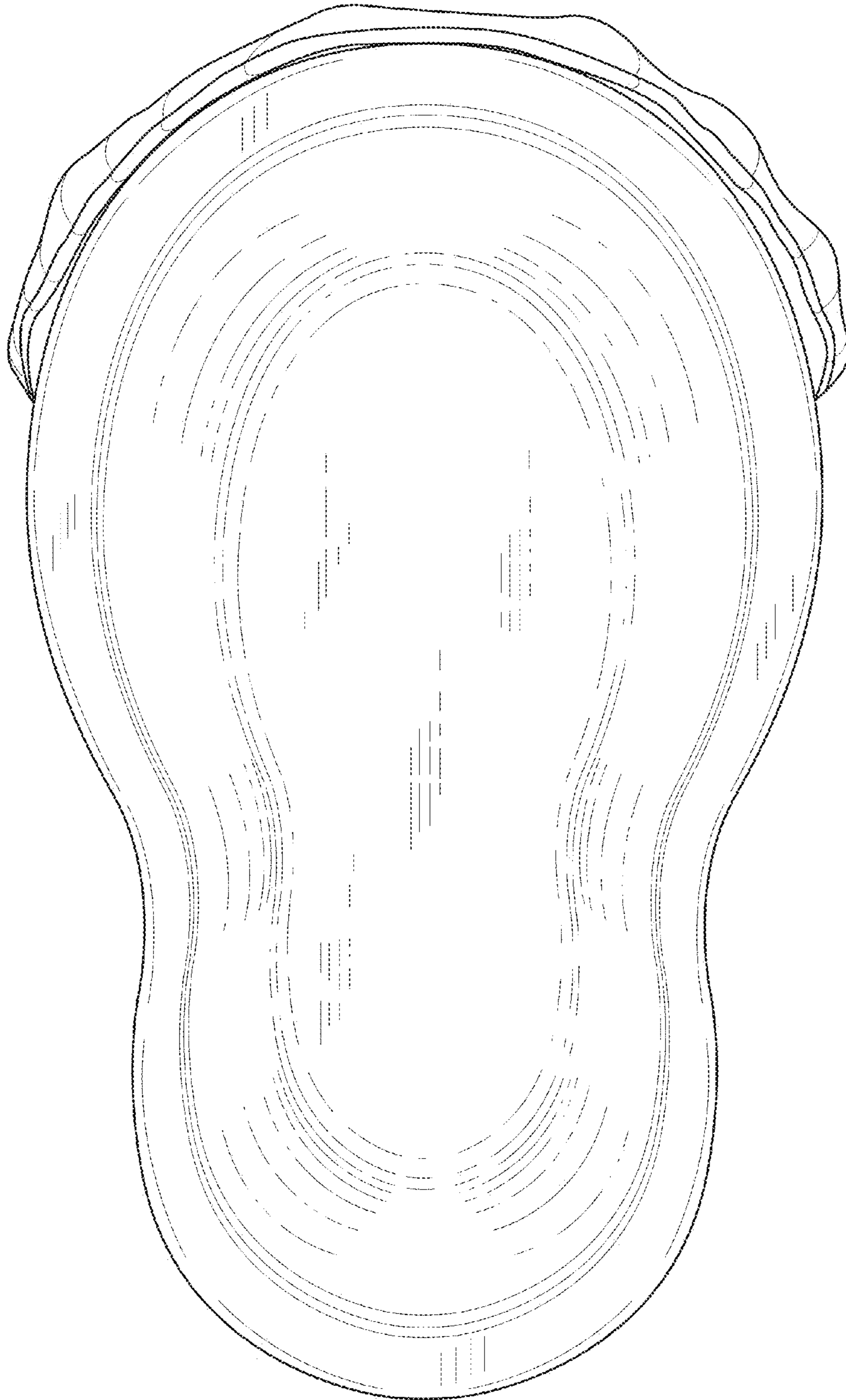

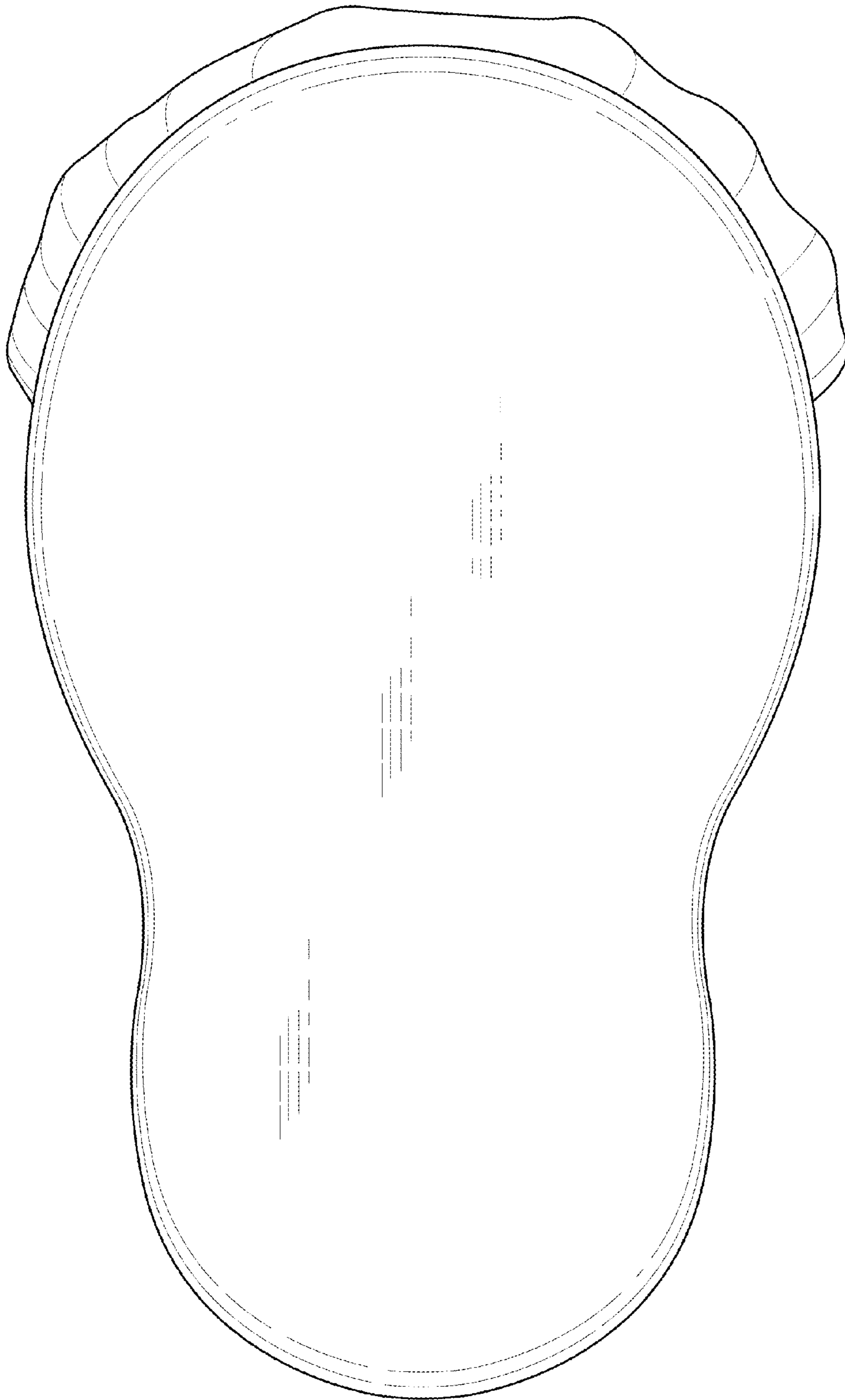

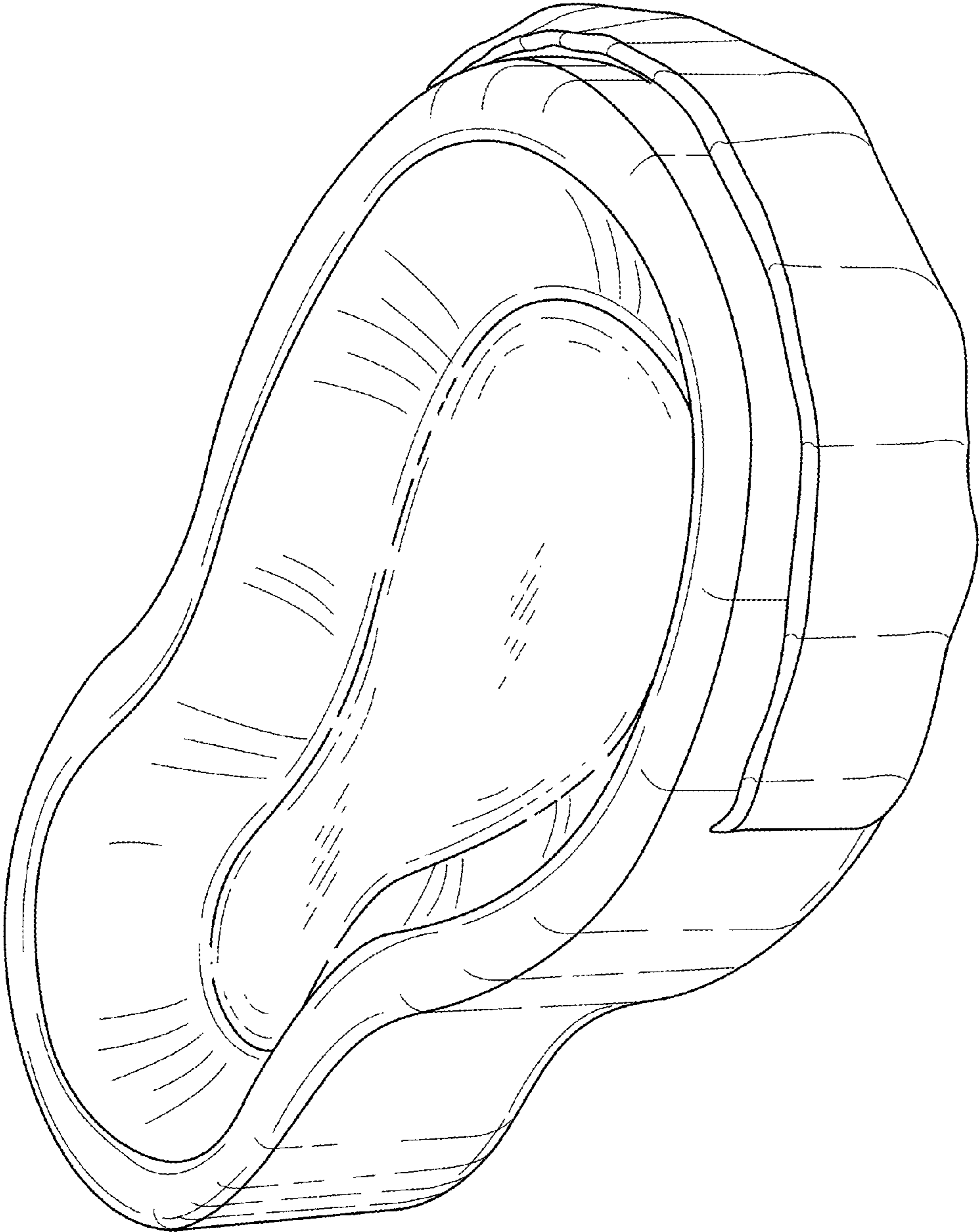

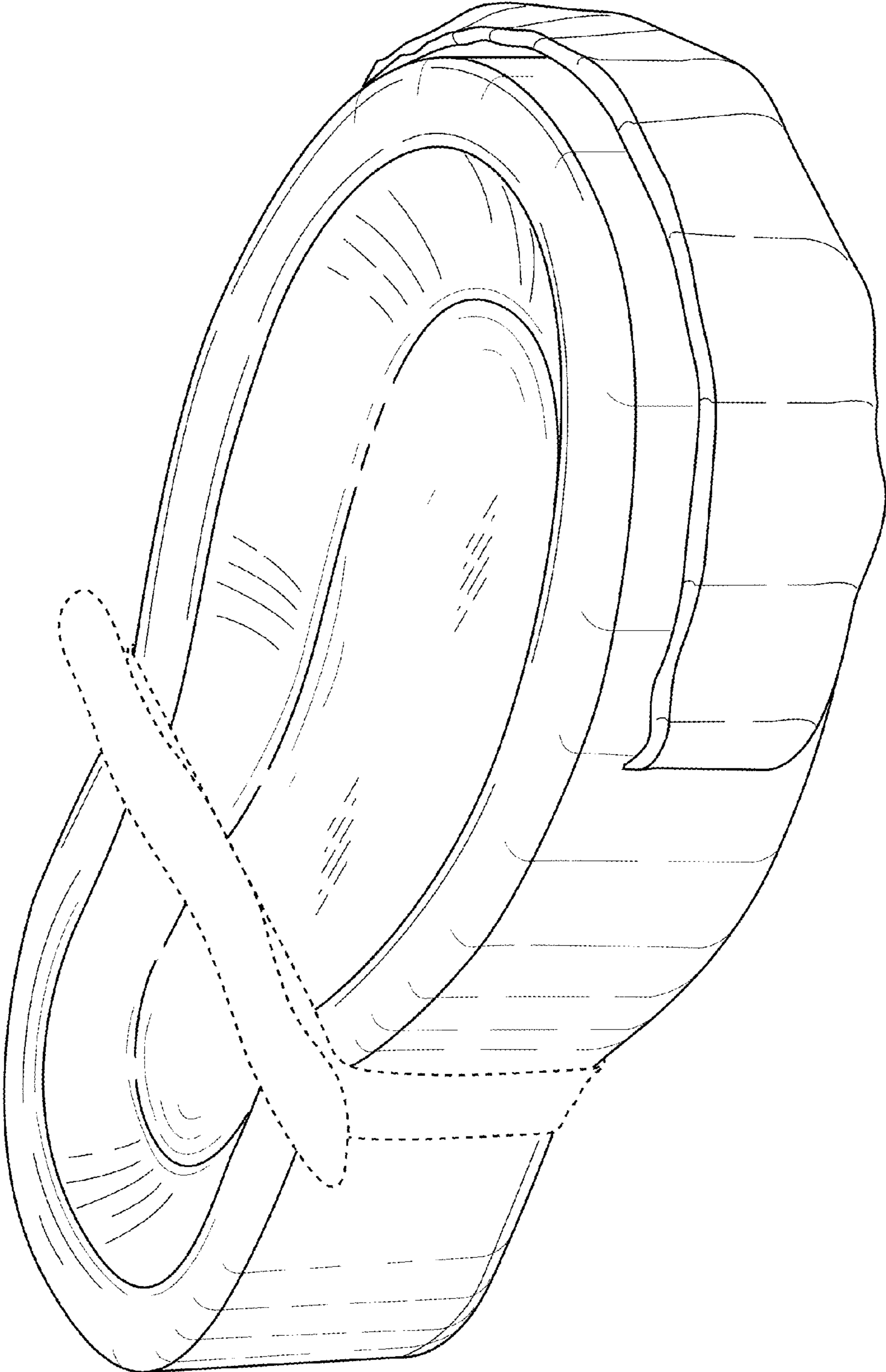

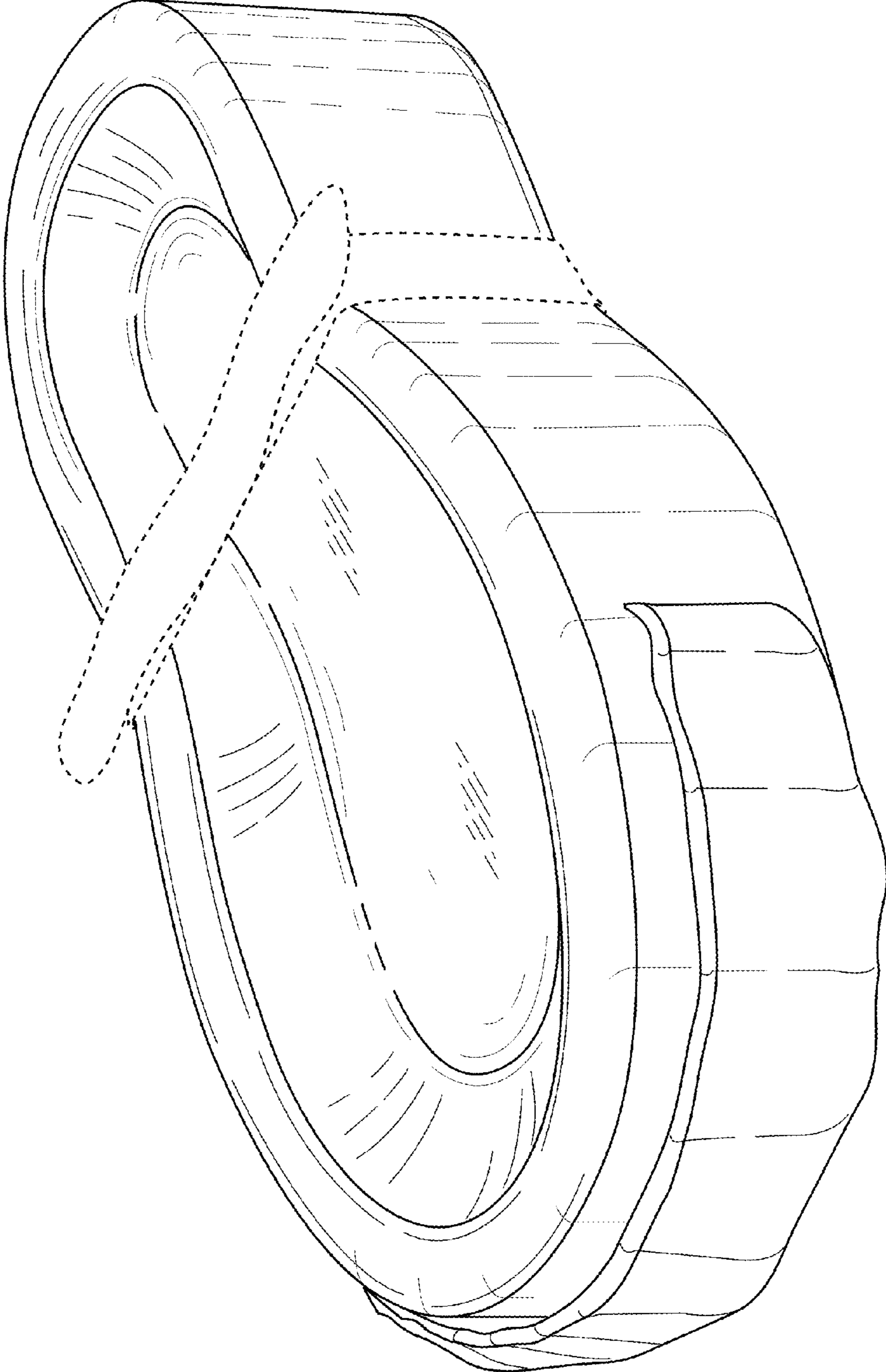
