(57) **CLAIM**

The ornamental design for a kitchen appliance with a blending attachment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the kitchen appliance with a blending attachment, showing my new design;

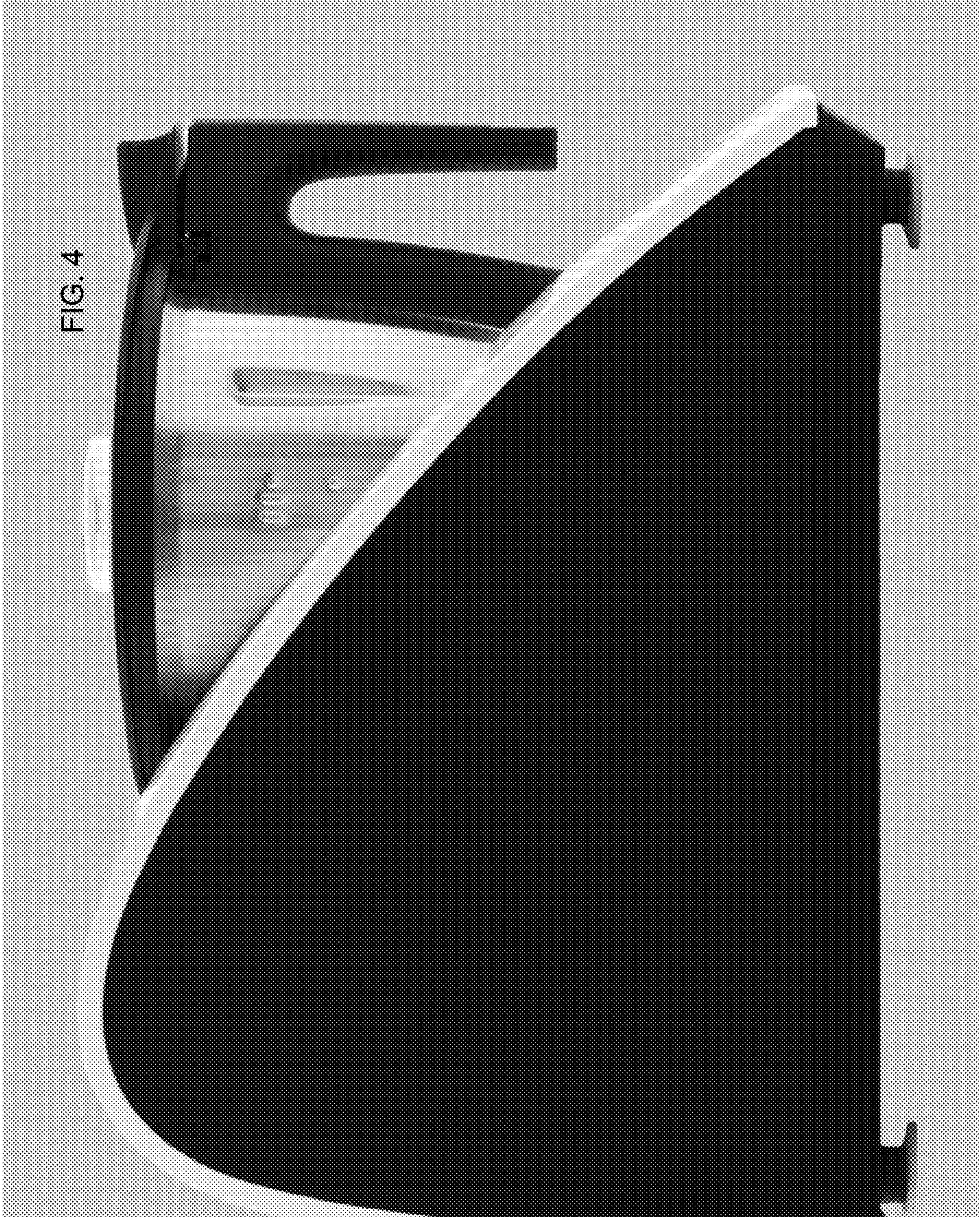

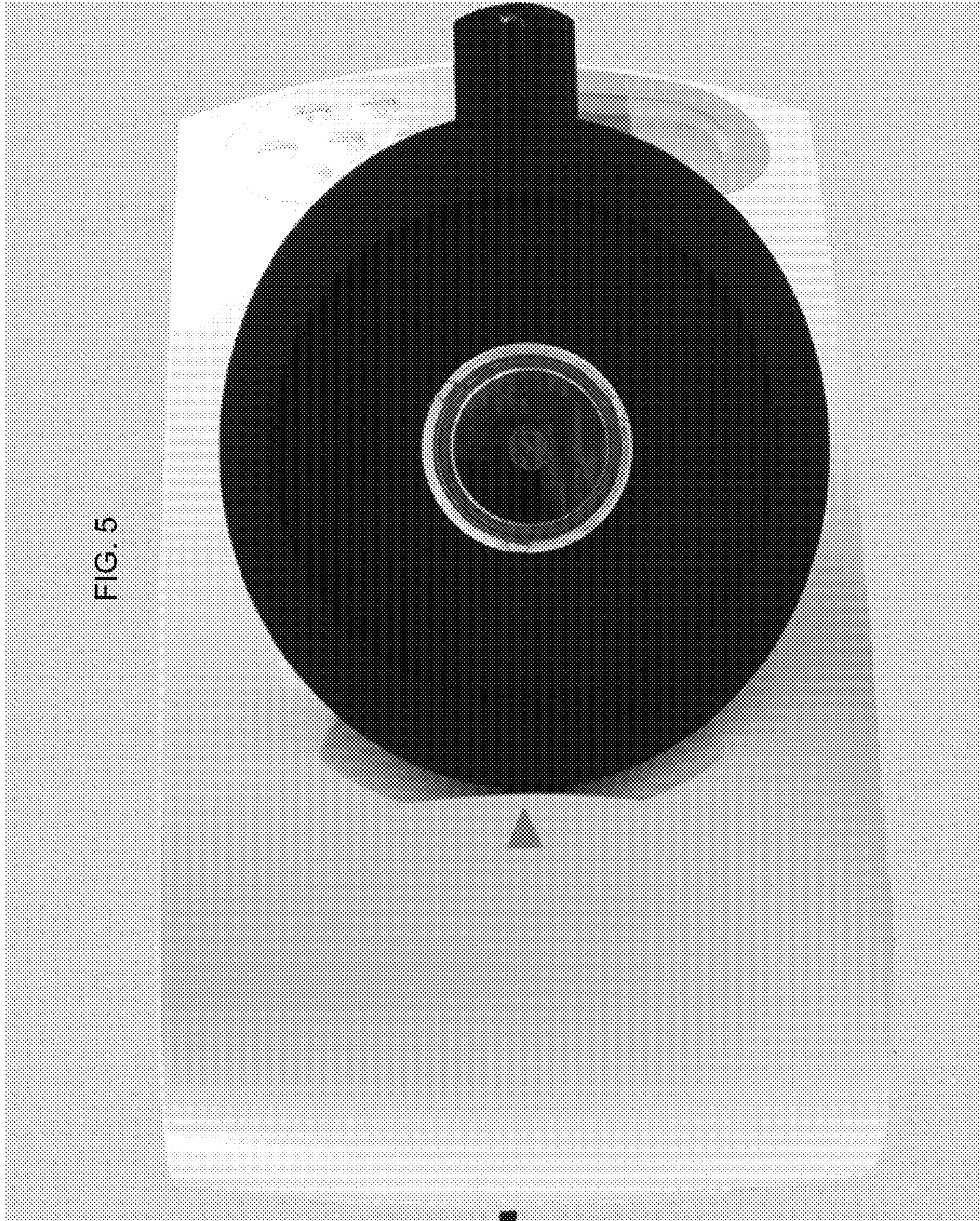

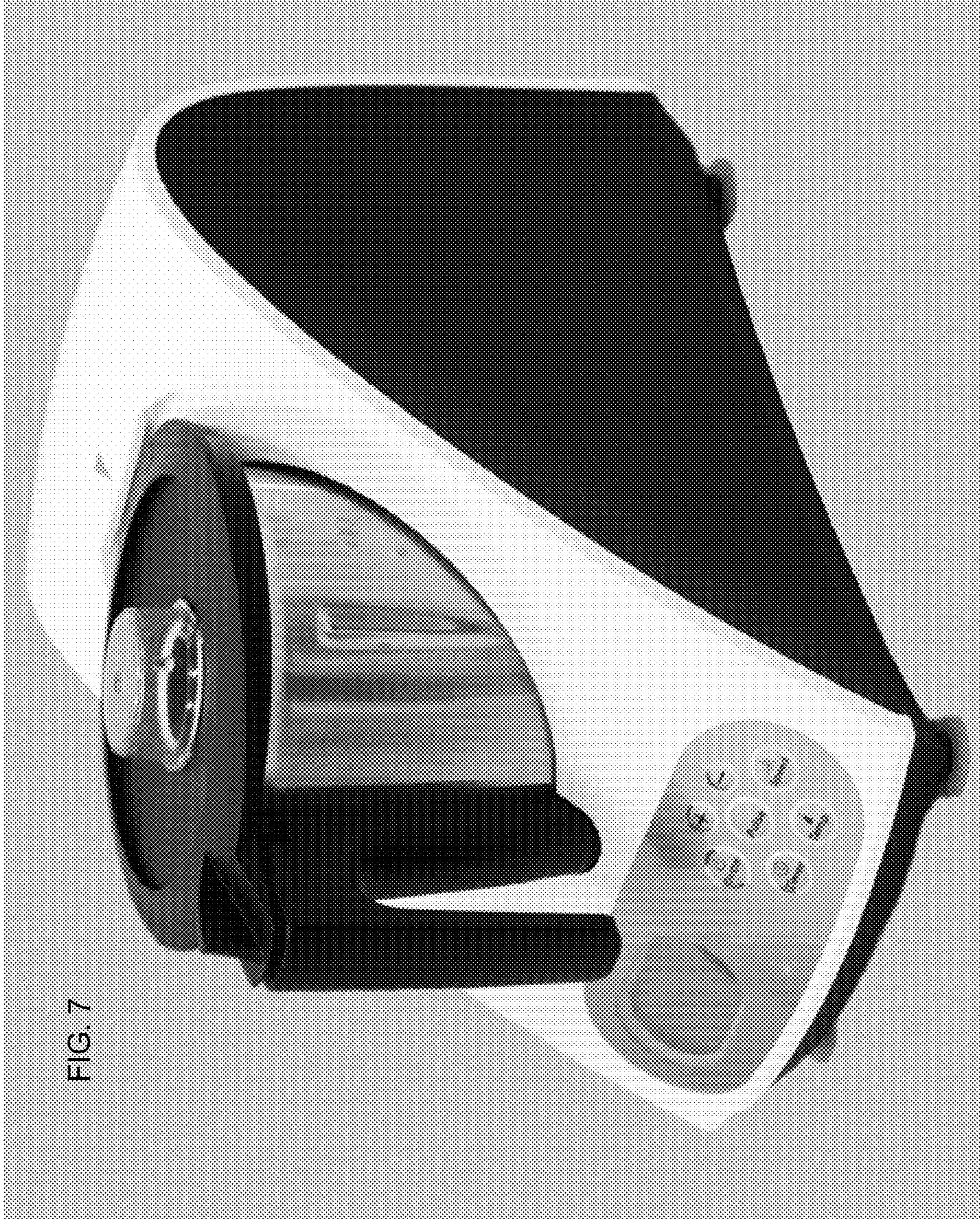
