I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a bottle according to the claimed design;

FIG. 5 is a left-side view of the bottle of FIG. 1;

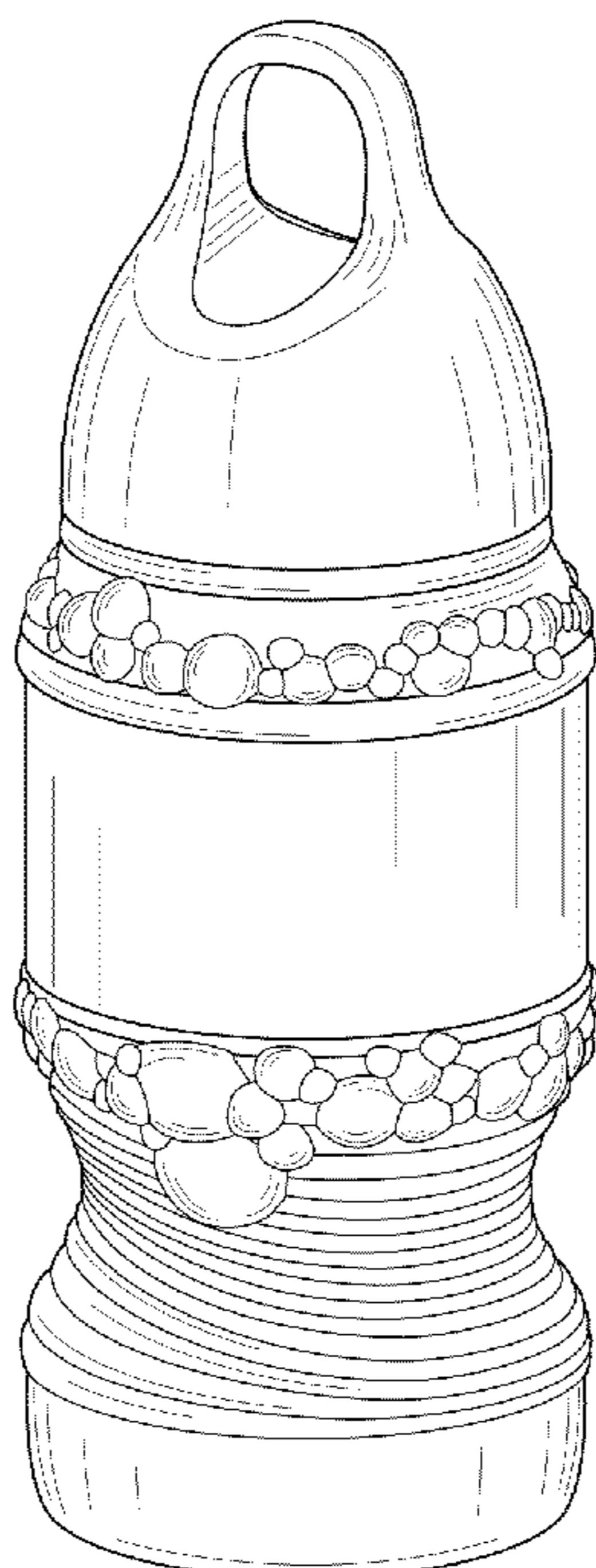
FIG. 6 is a right-side view of the bottle of FIG. 1;

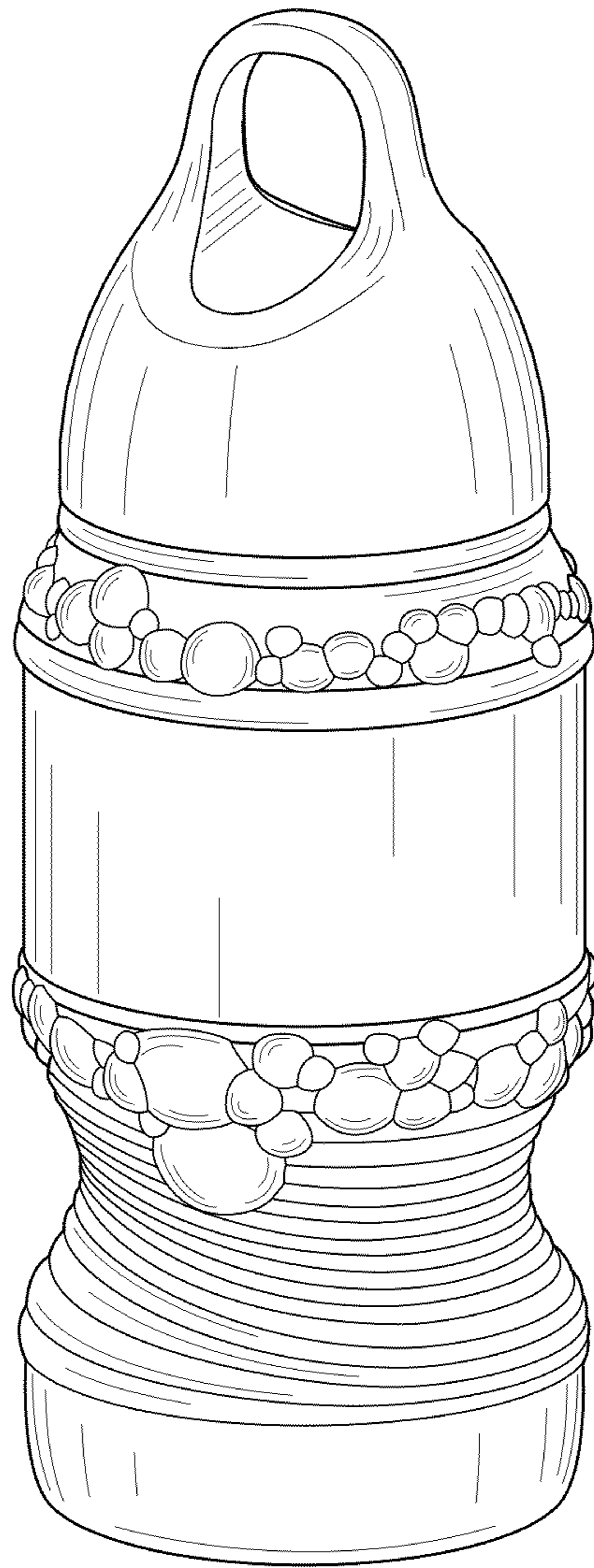

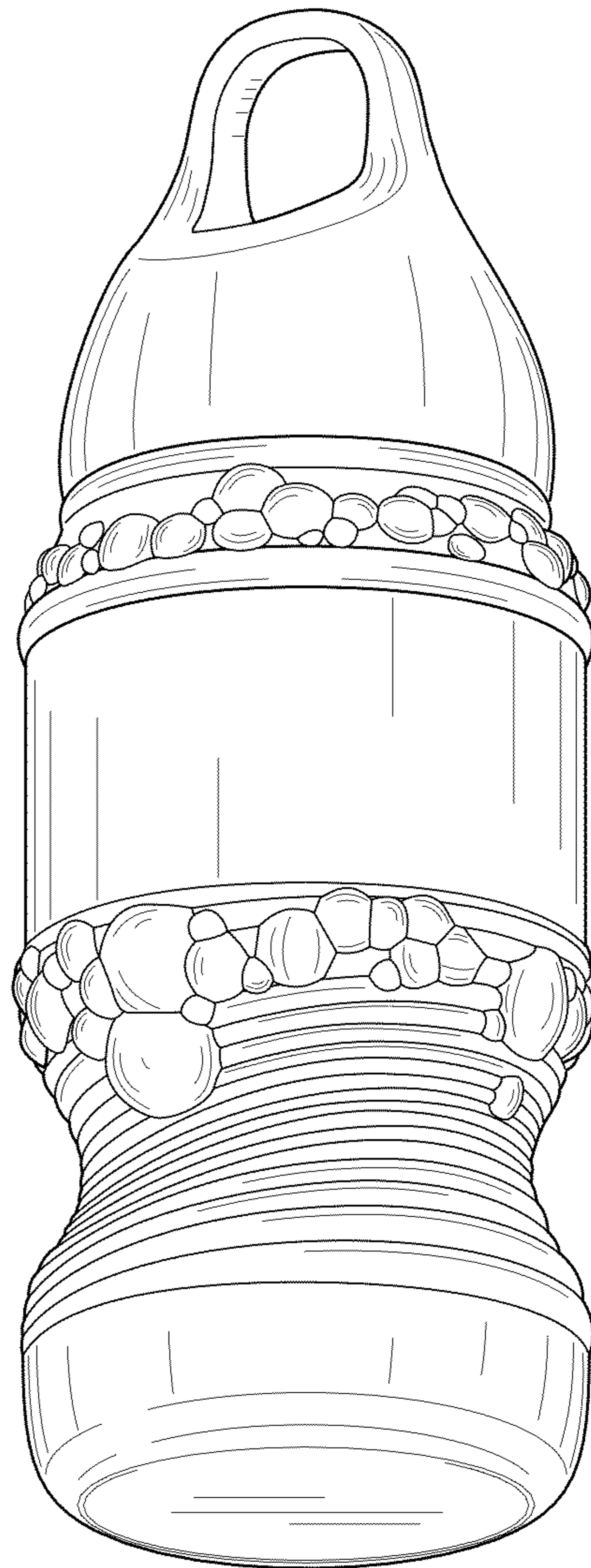

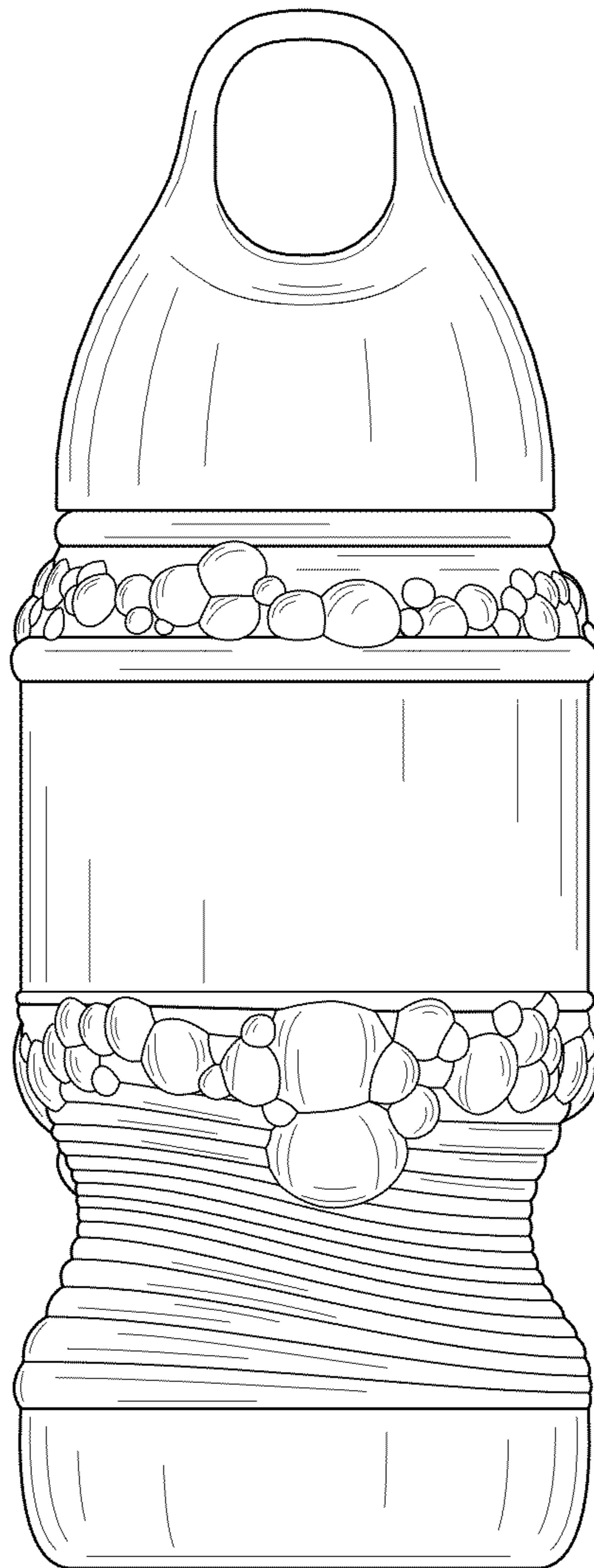

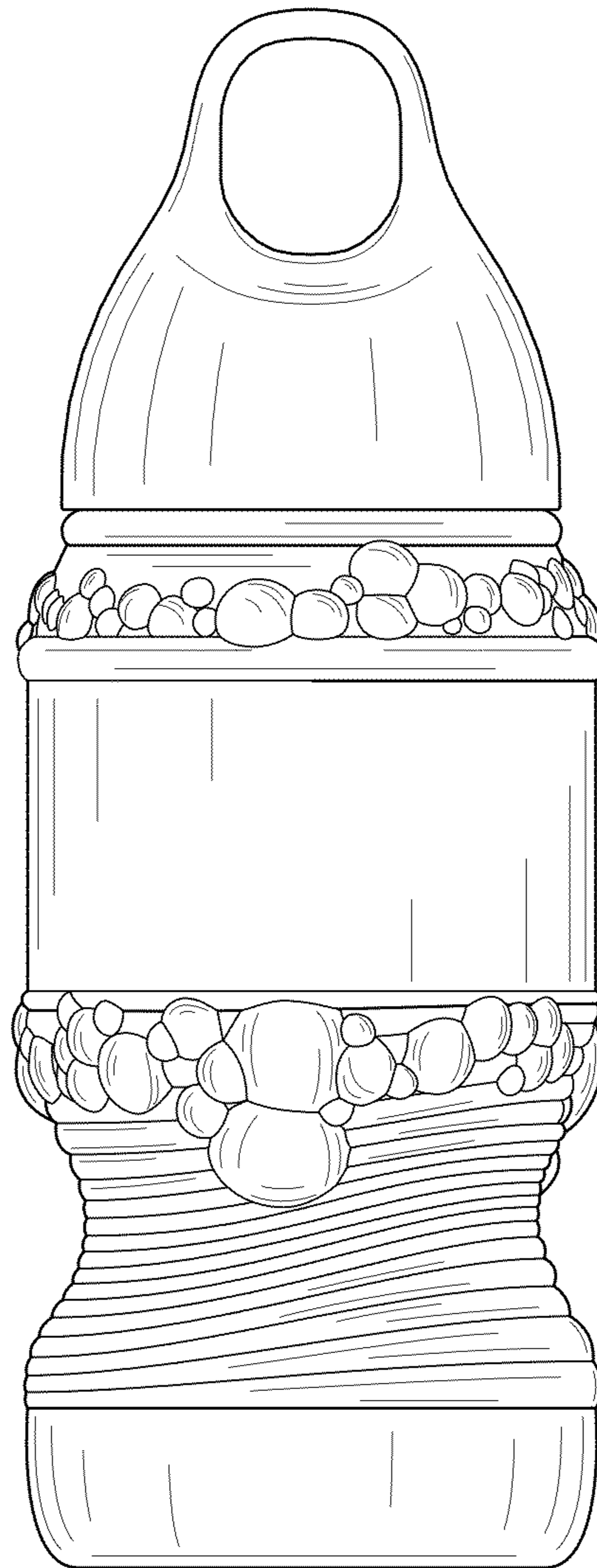

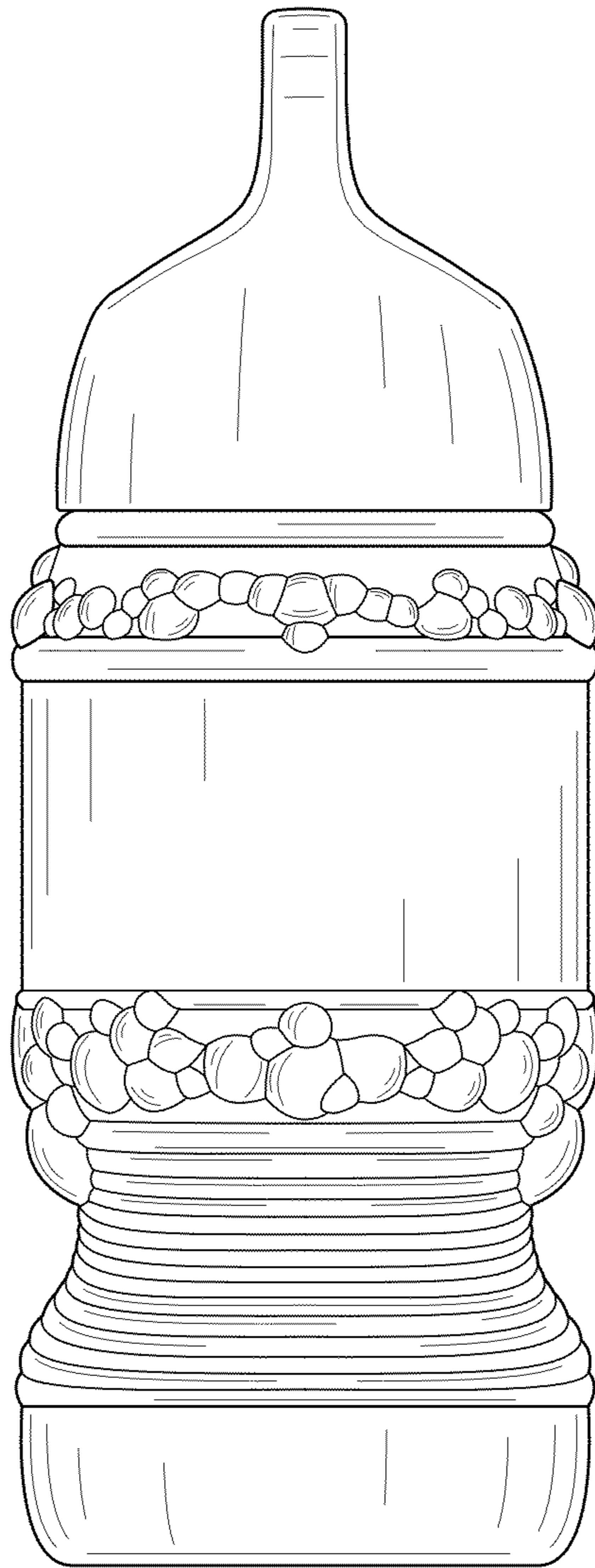

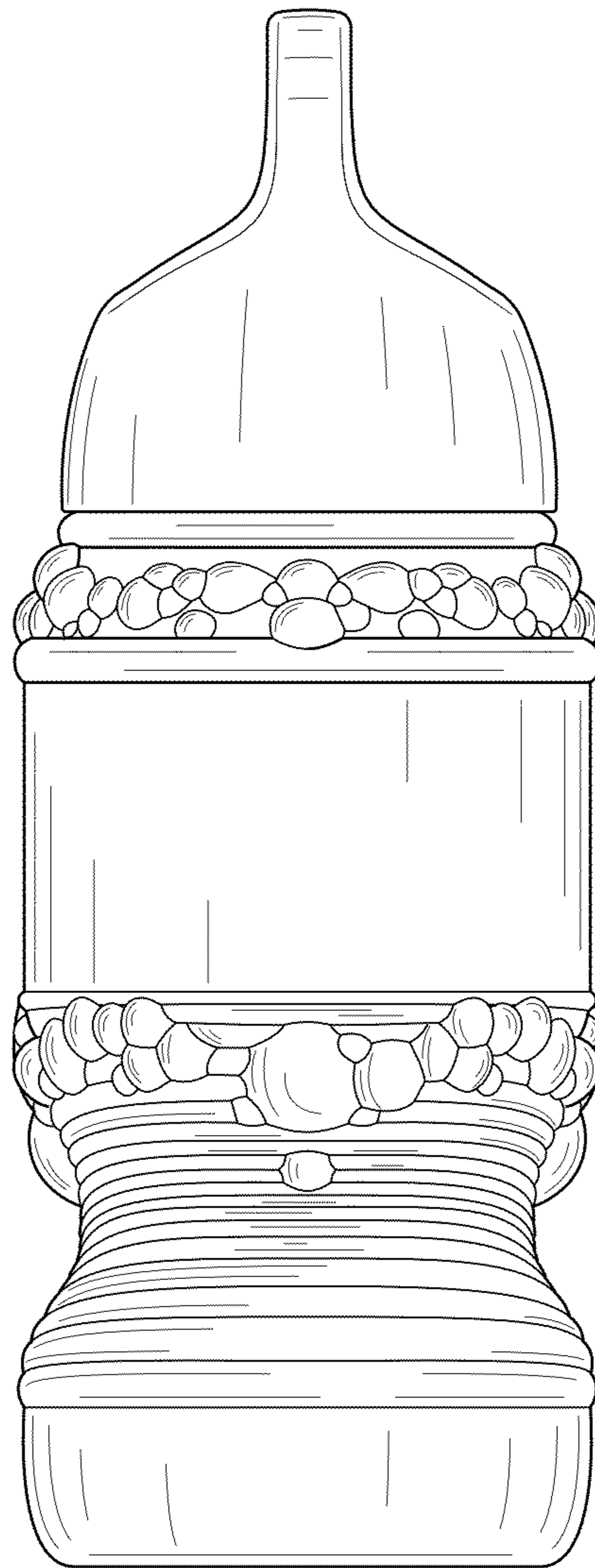

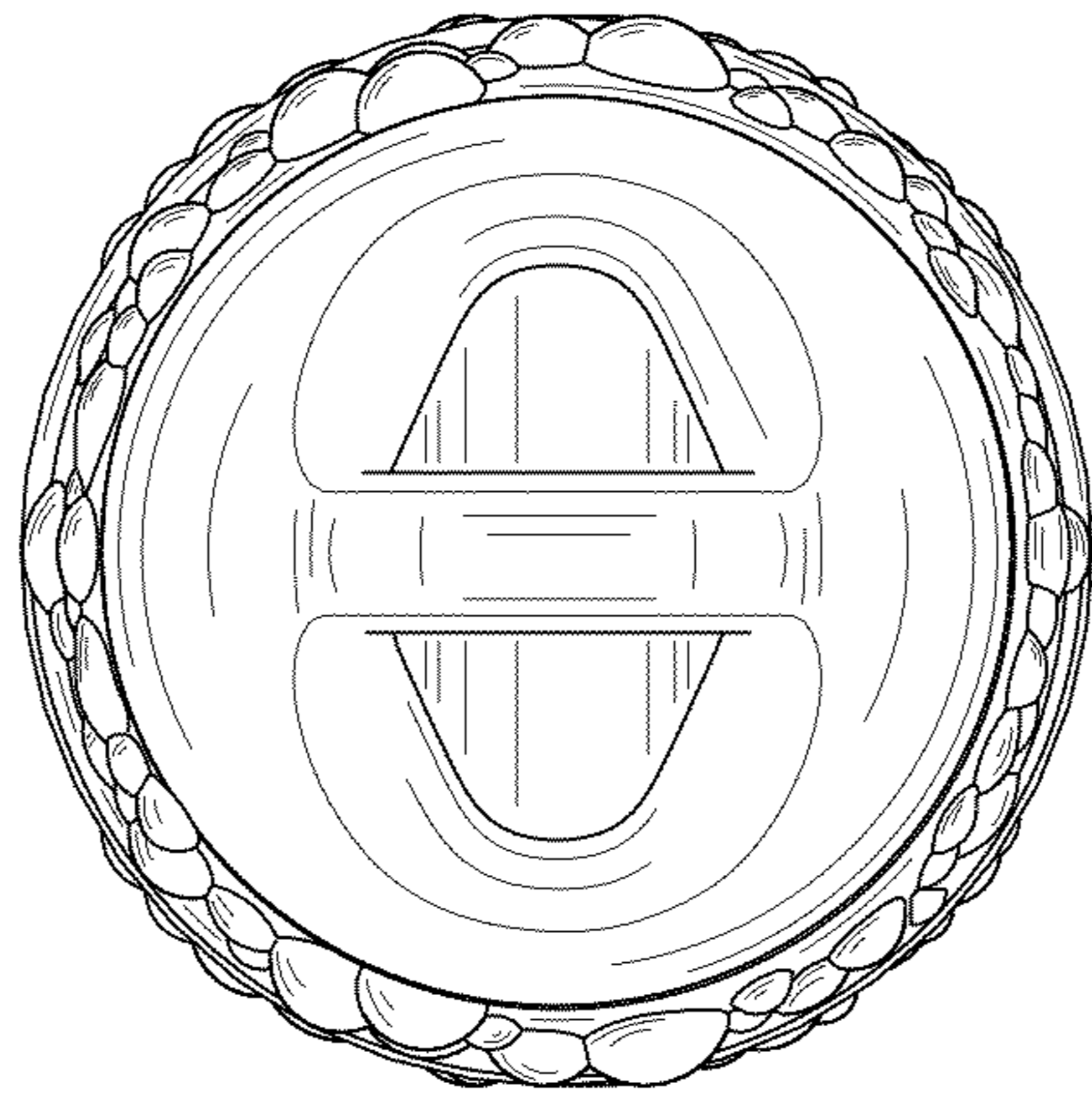

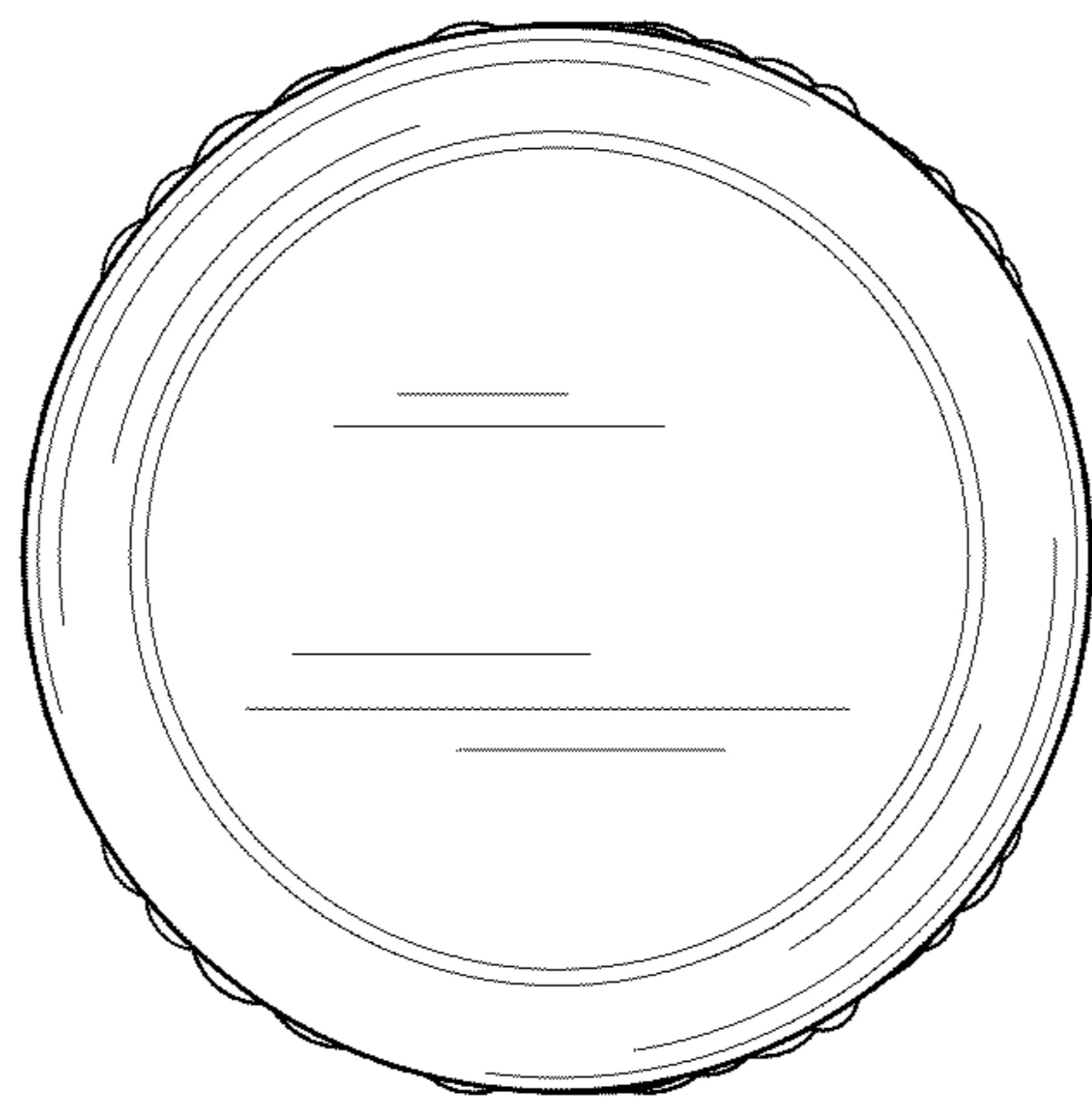
