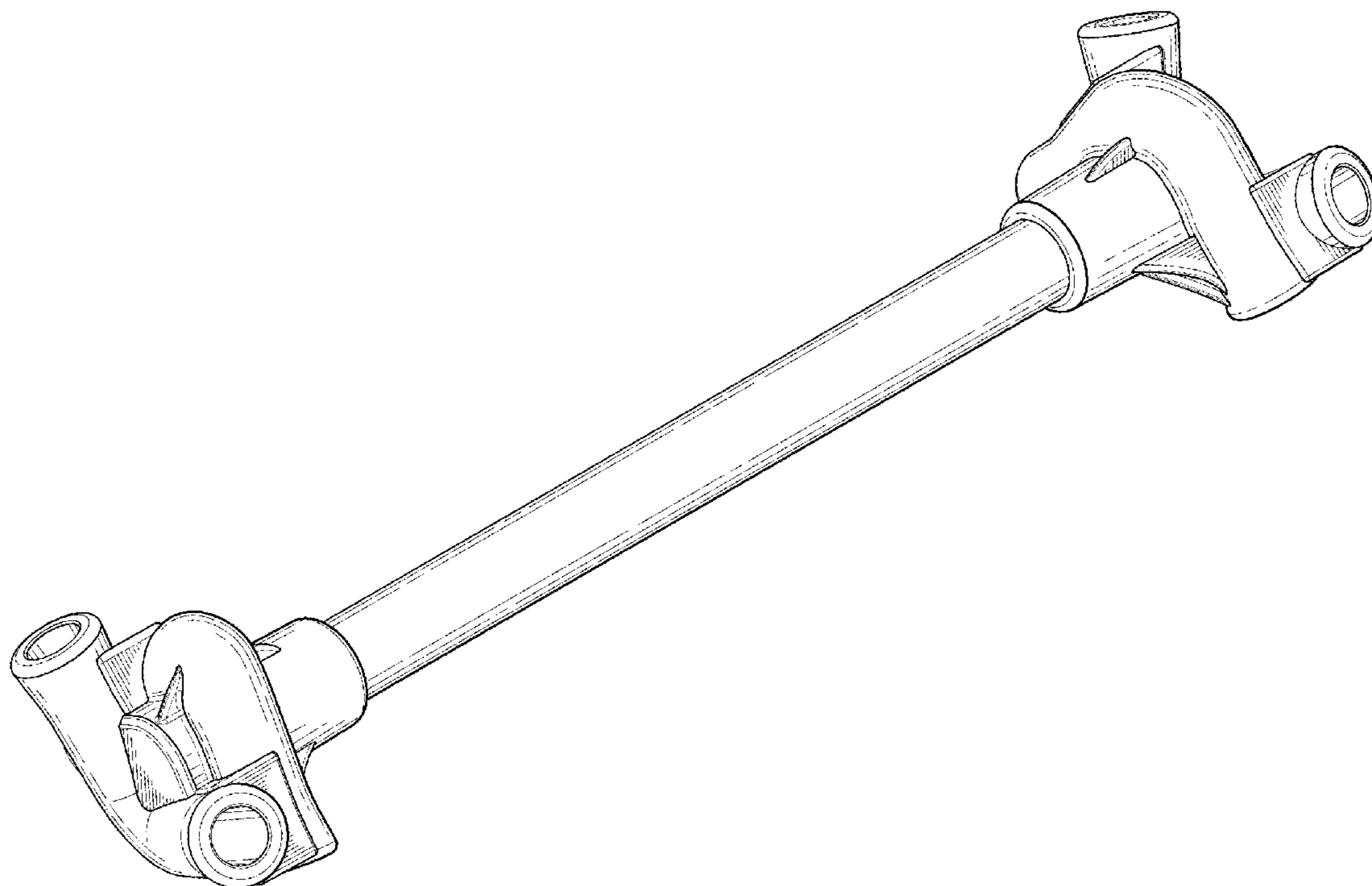
(57) **CLAIM**

The ornamental design of a crossbar assembly for a camp chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective of a crossbar assembly for a camp chair in accordance with the present design;
FIG. 2 is a plan view of the crossbar assembly for a camp chair shown in FIG. 1;
FIG. 3 is a bottom view of the crossbar assembly for a camp chair shown in FIG. 1;
FIG. 4 is a front view of the crossbar assembly for a camp chair shown in FIG. 1;
FIG. 5 is a rear view of the crossbar assembly for a camp chair shown in FIG. 1;

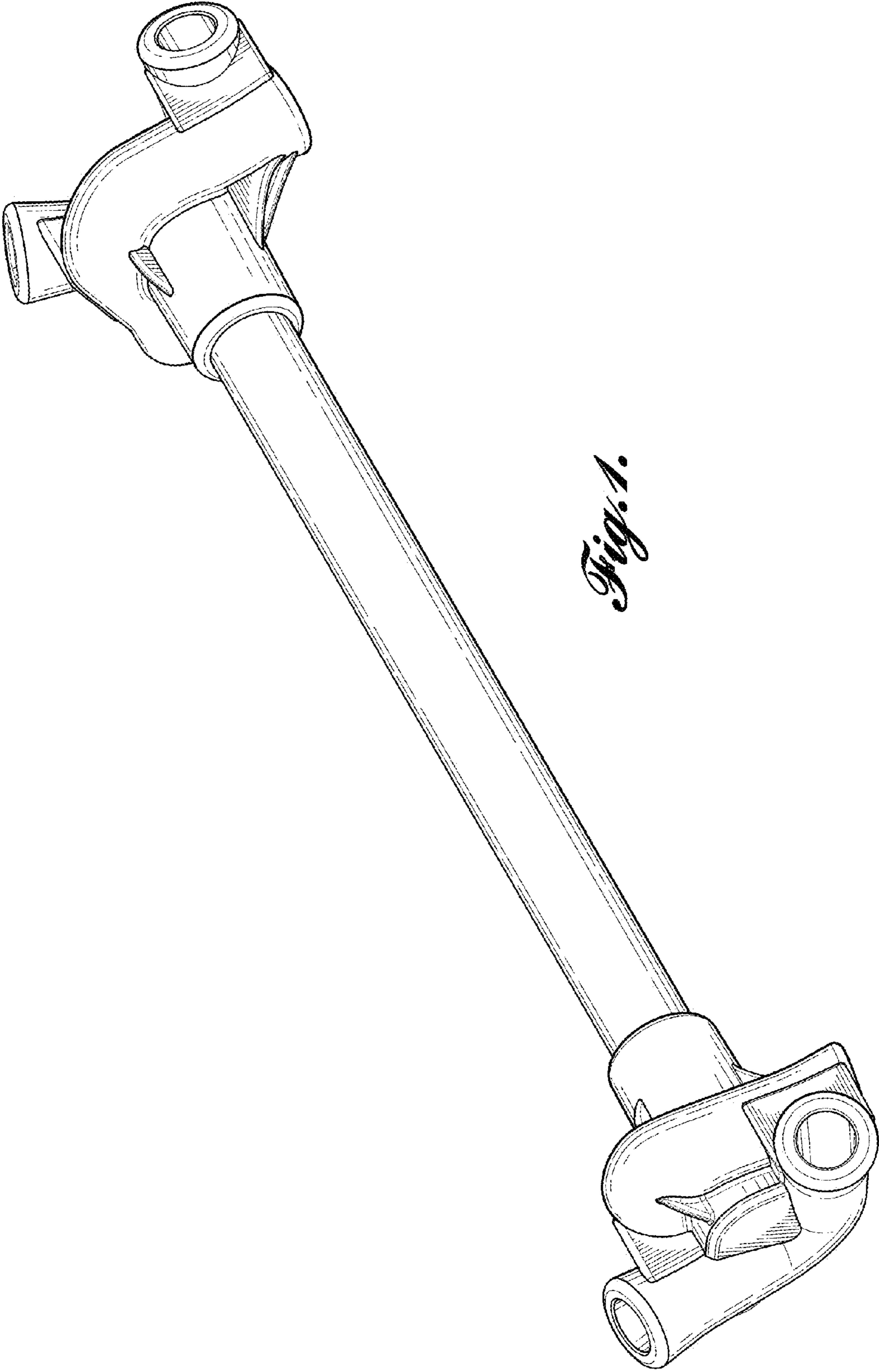

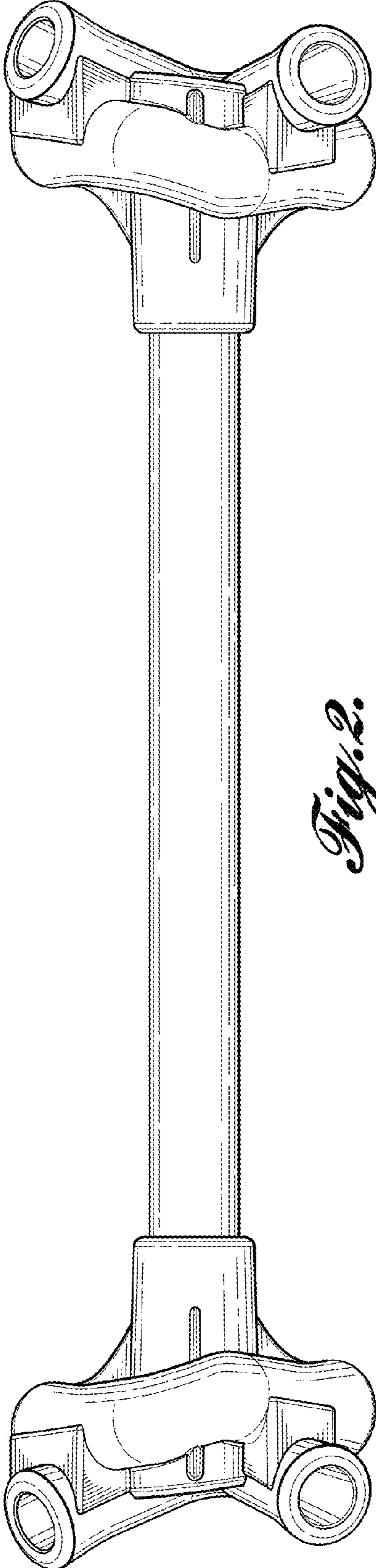

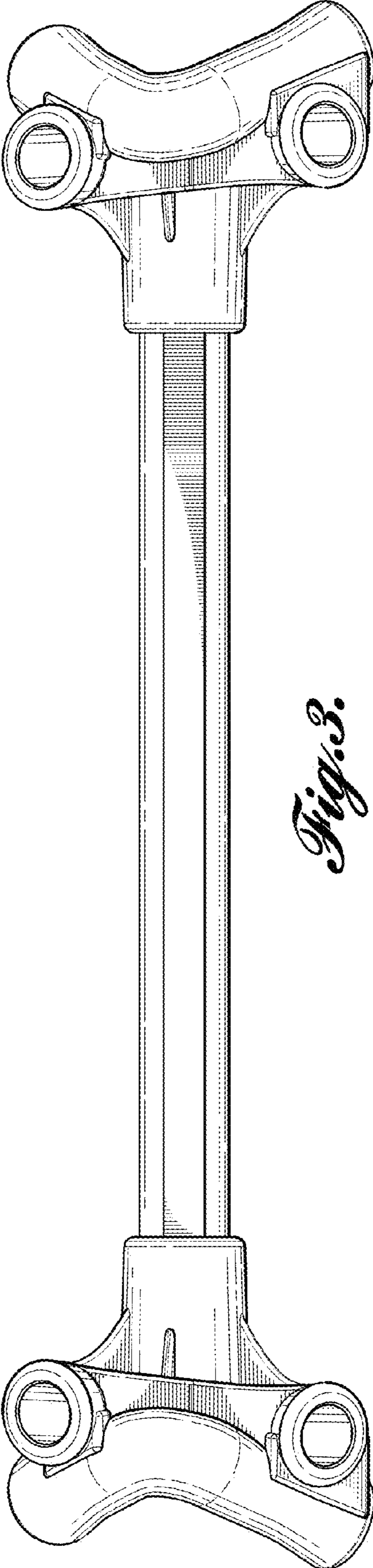

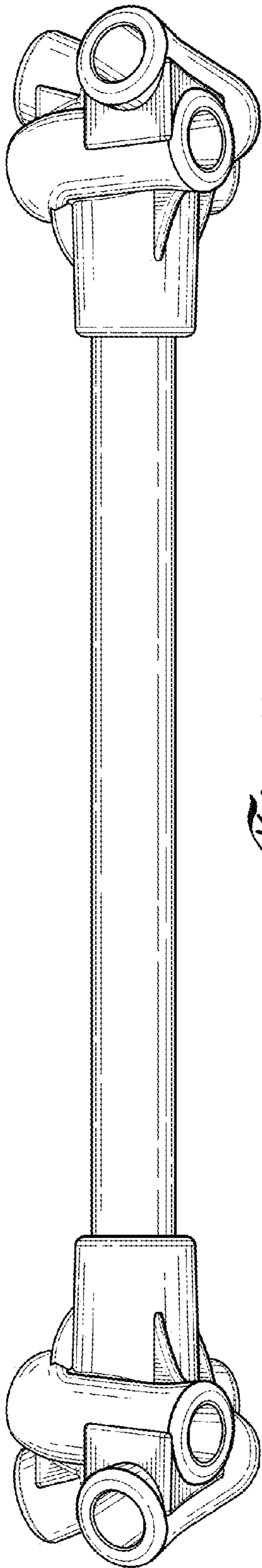

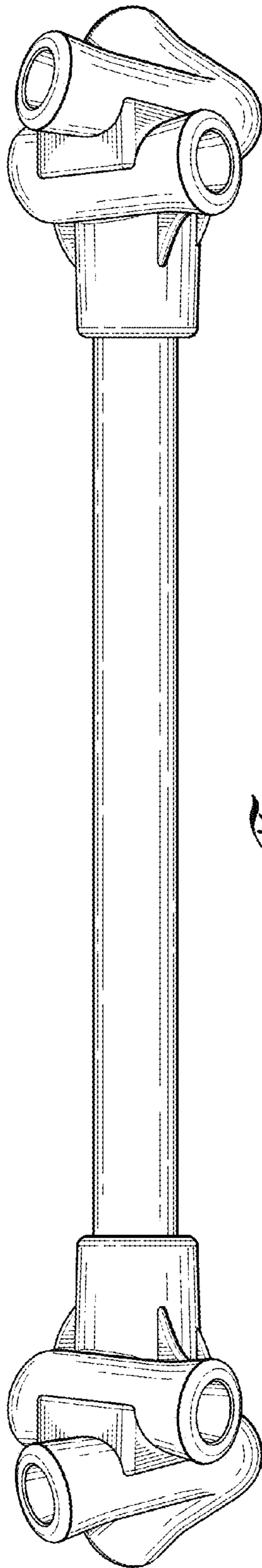
