(57) **CLAIM**

The ornamental design for a nail polish bottle carton, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the nail polish bottle carton; FIG. 2 is a front view of the nail polish bottle carton of FIG. 1; FIG. 3 is a rear view of the nail polish bottle carton of FIG. 1; FIG. 4 is a side view of the nail polish bottle carton of FIG. 1; FIG. 5 is the other side view of the nail polish bottle carton of FIG. 1; FIG. 6 is a top view of the nail polish bottle carton of FIG. 1; and, FIG. 7 is a bottom view of the nail polish bottle carton of FIG. 1.

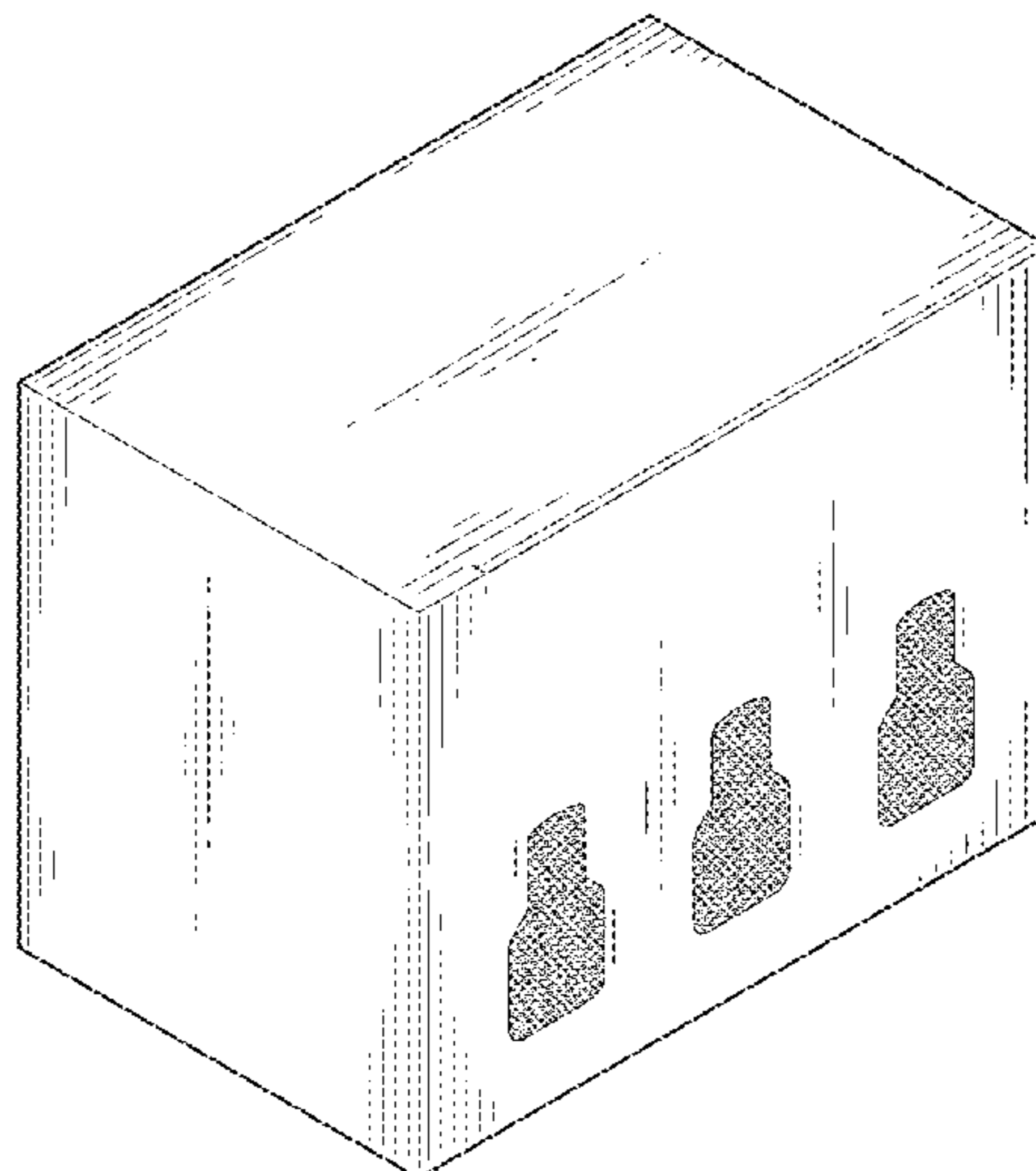

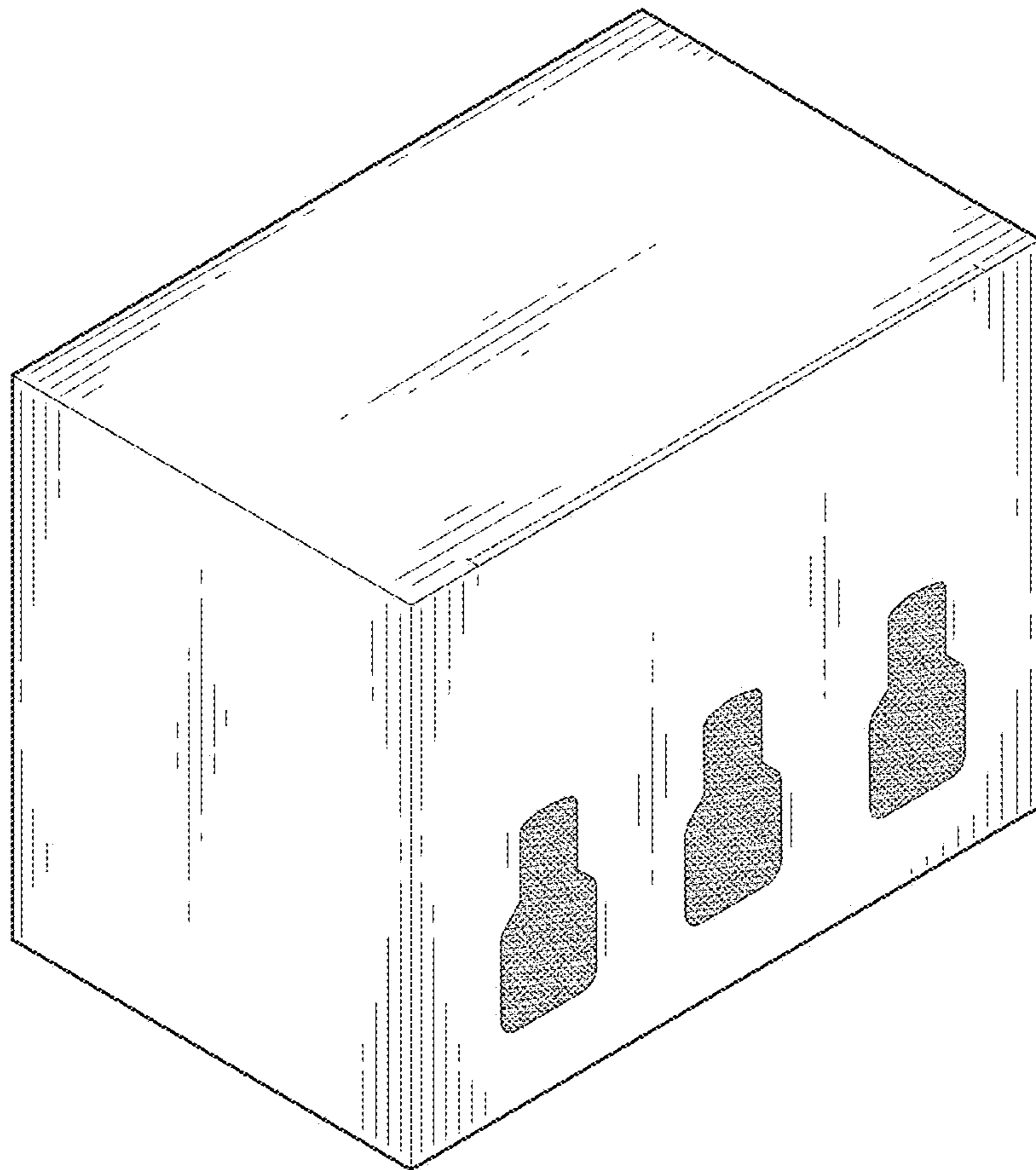

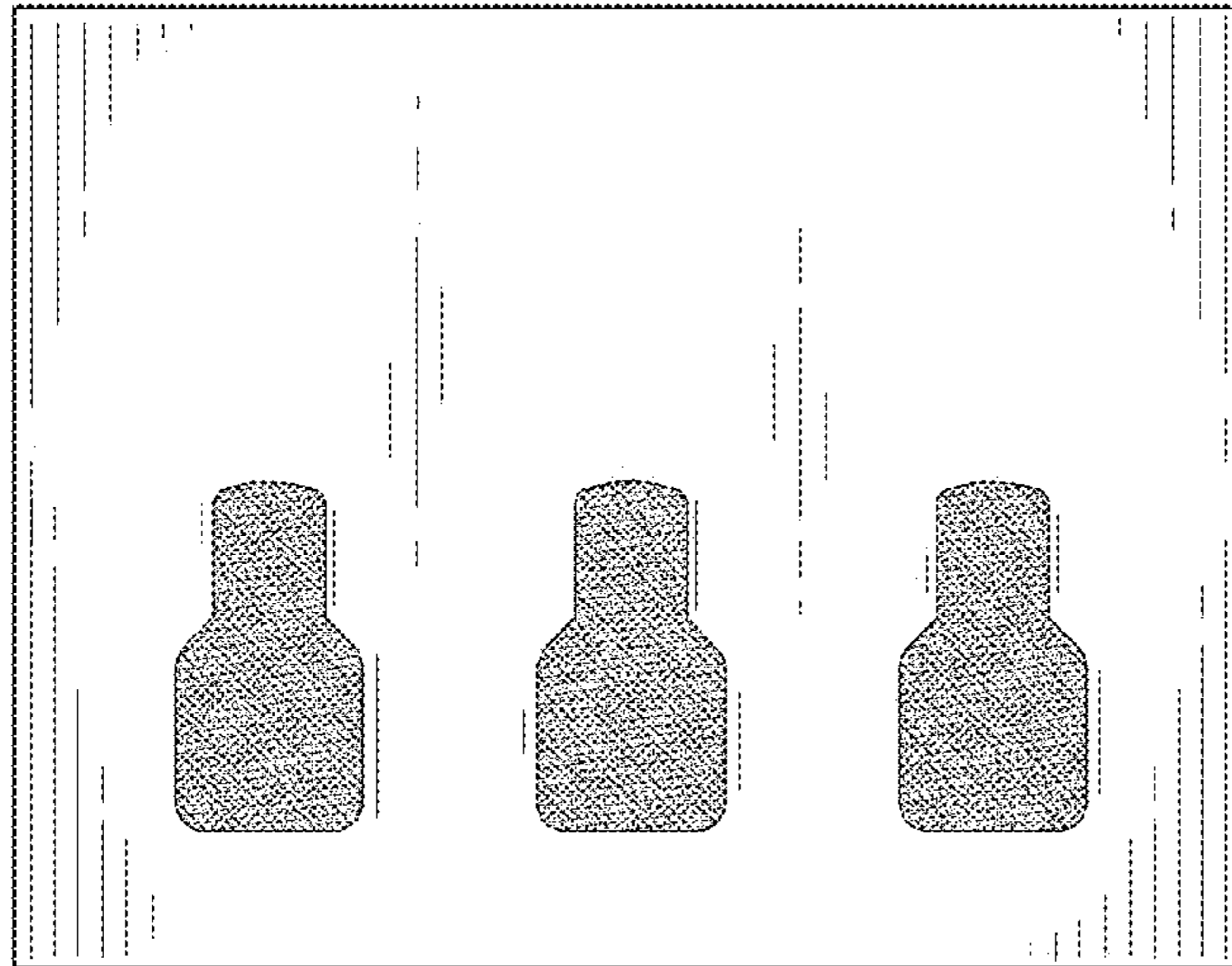

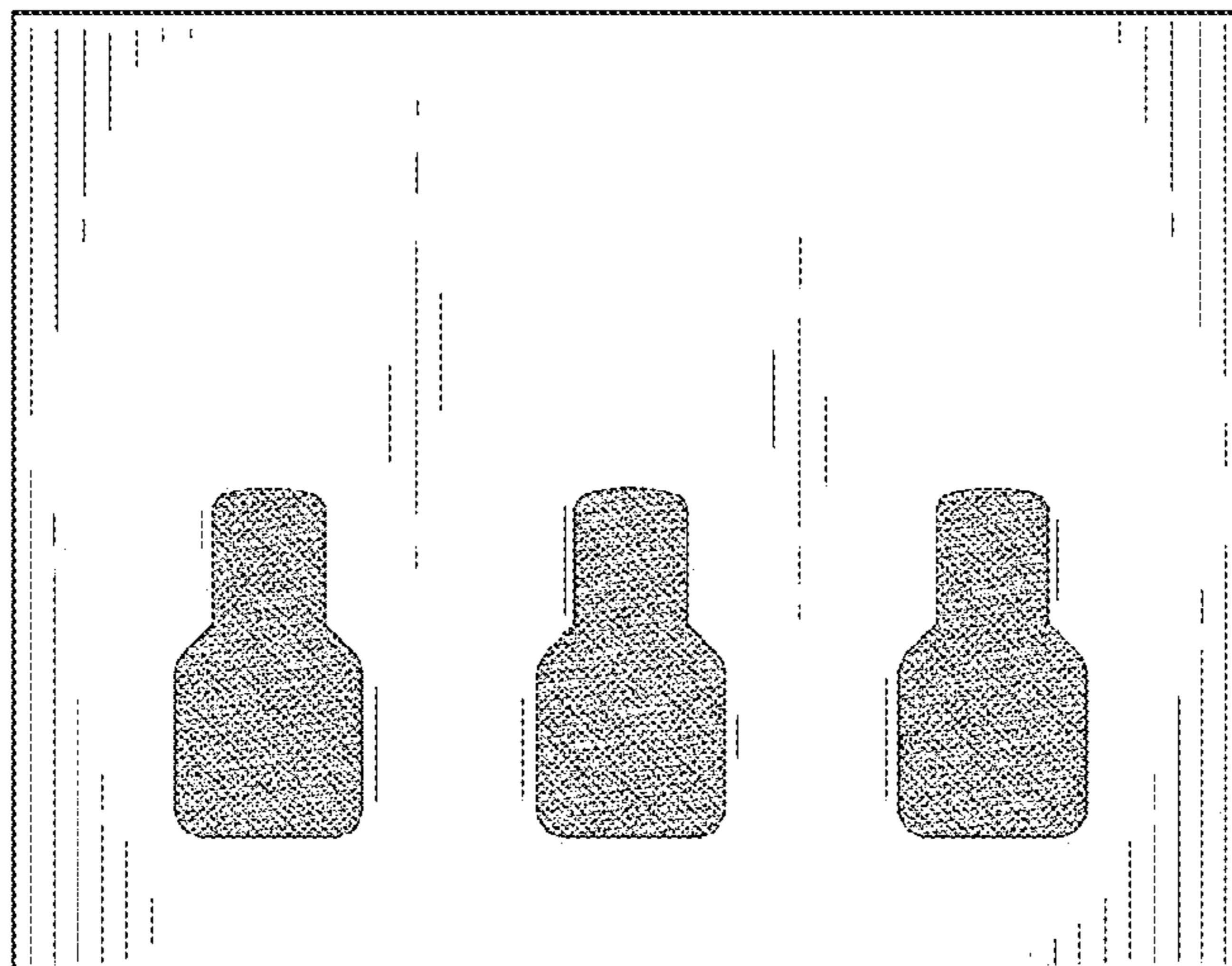

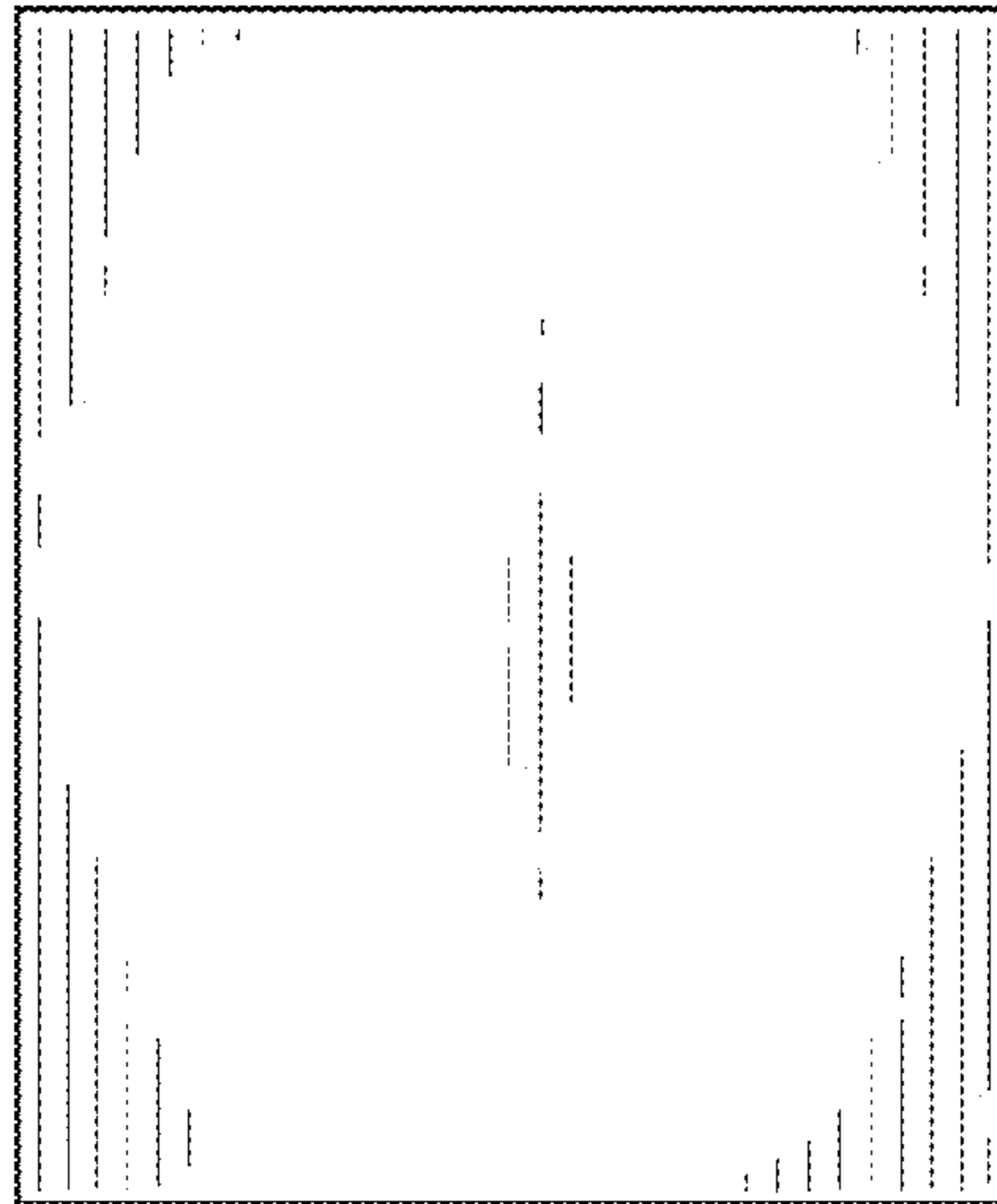

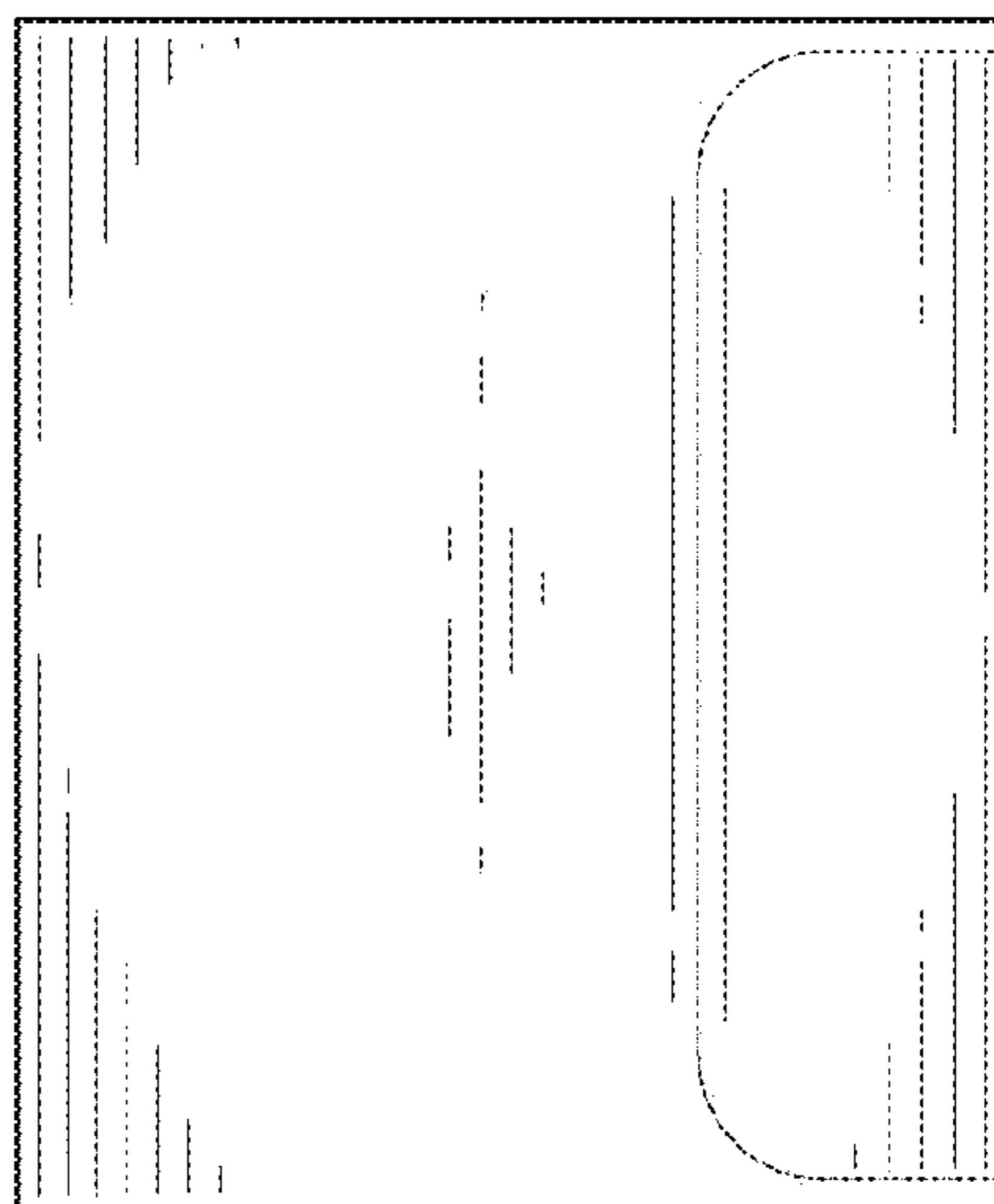

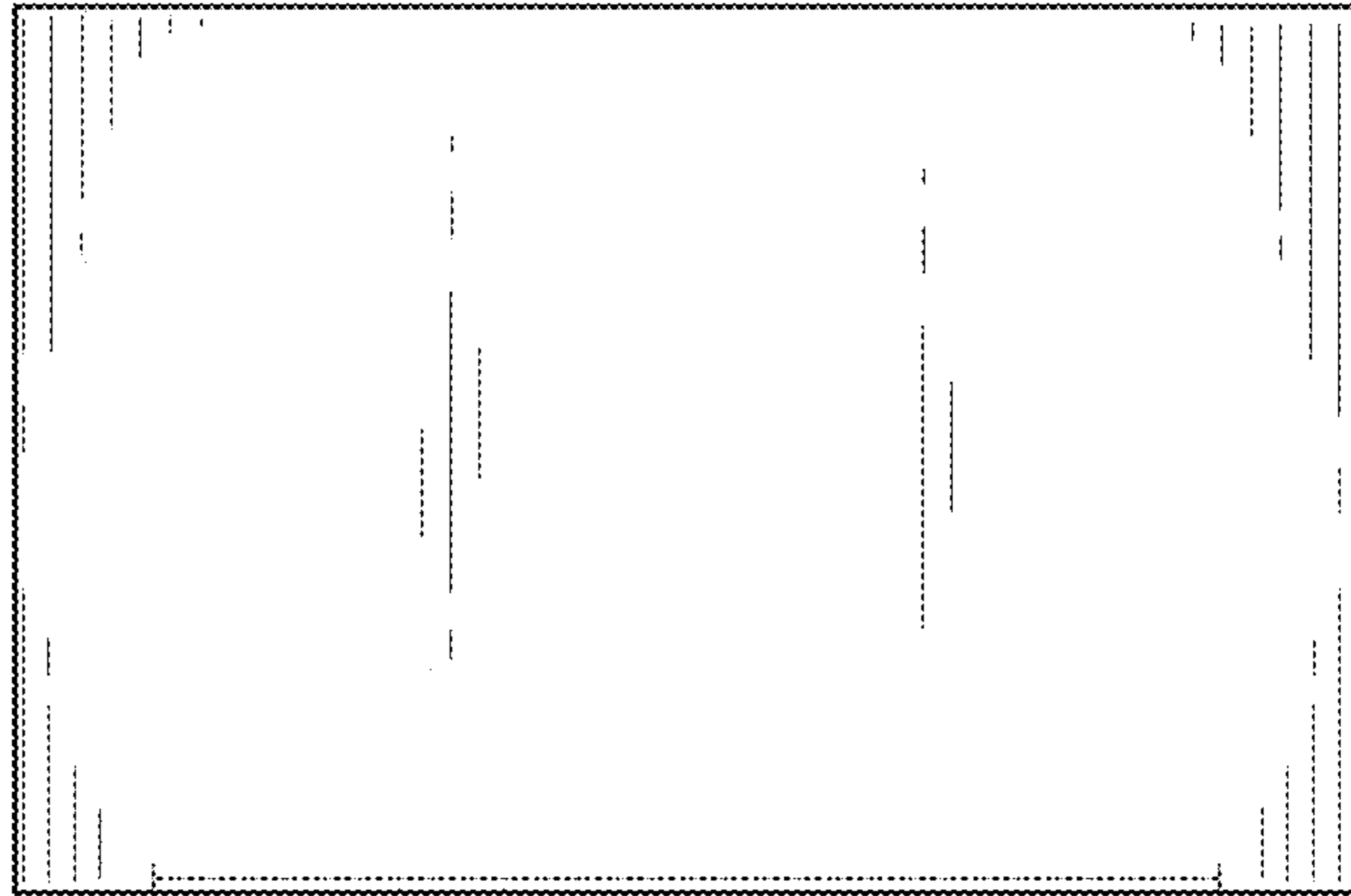

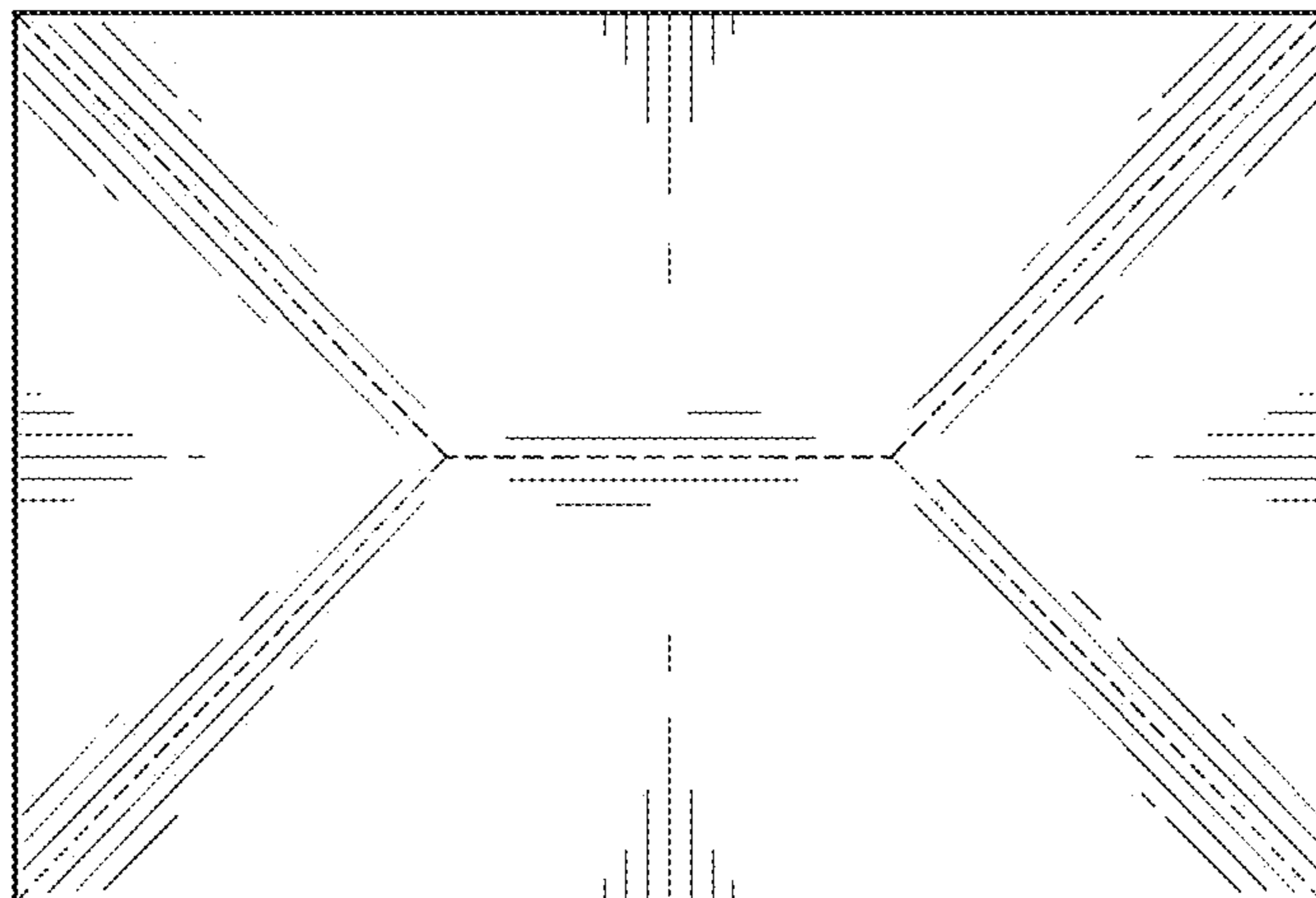
