FIG. 4 is a rear view of the bottle shown in FIG. 1.

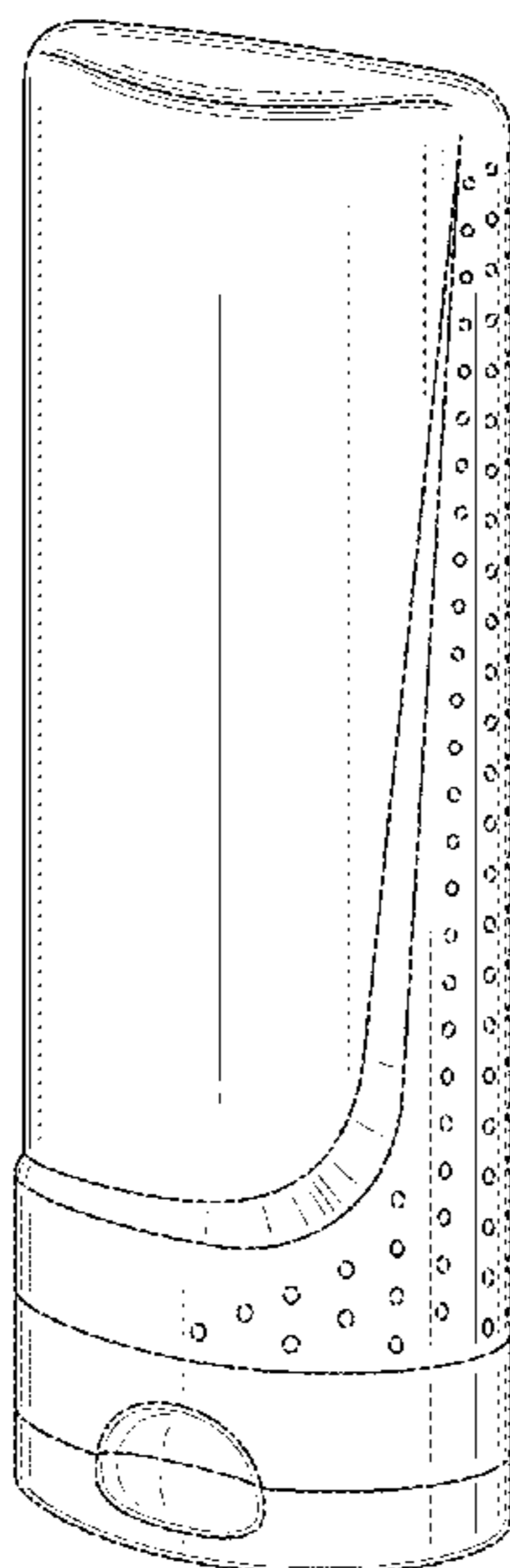
FIG. 5 is a left side view of the bottle shown in FIG. 1.

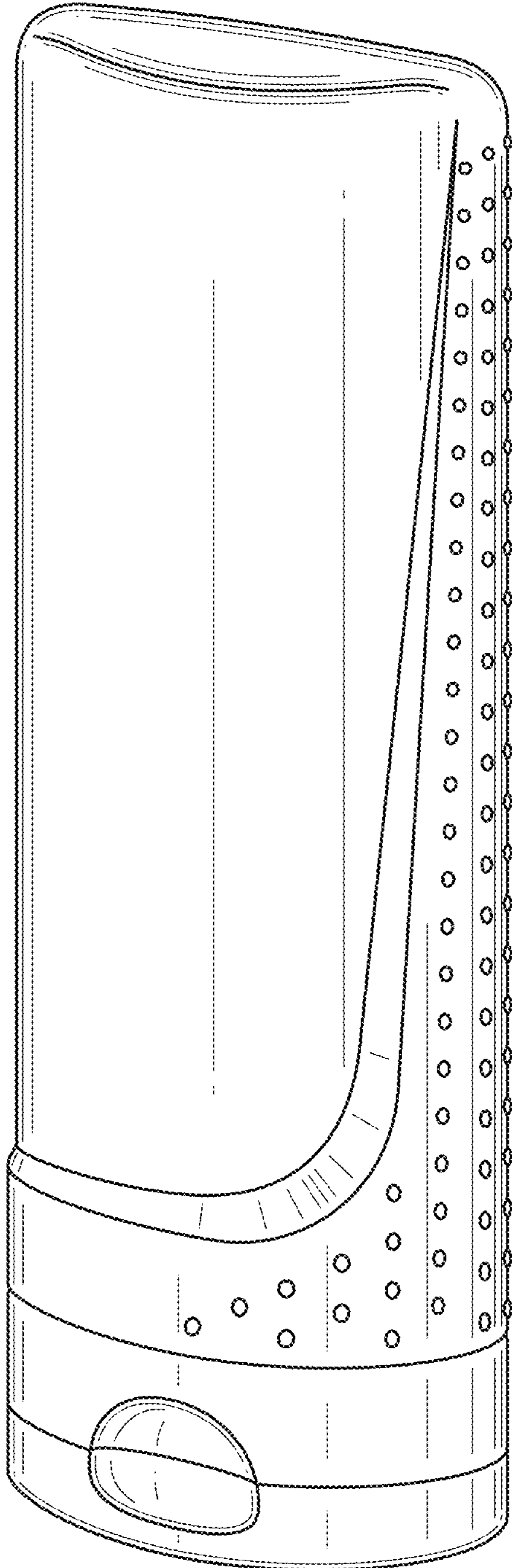

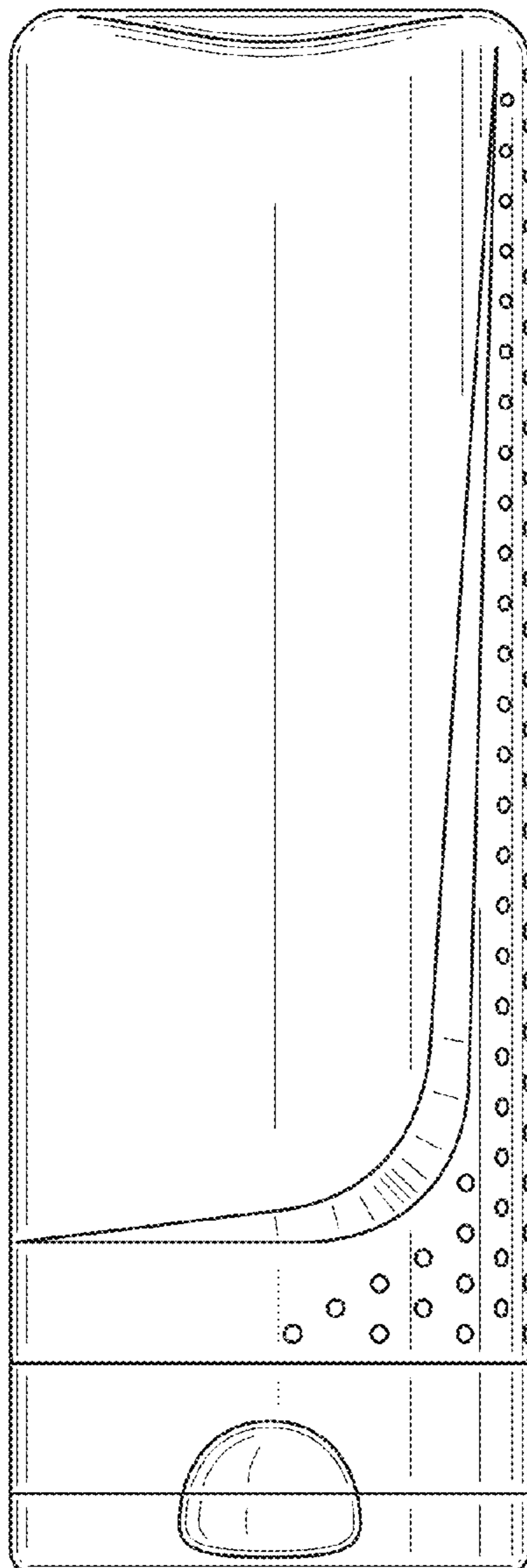

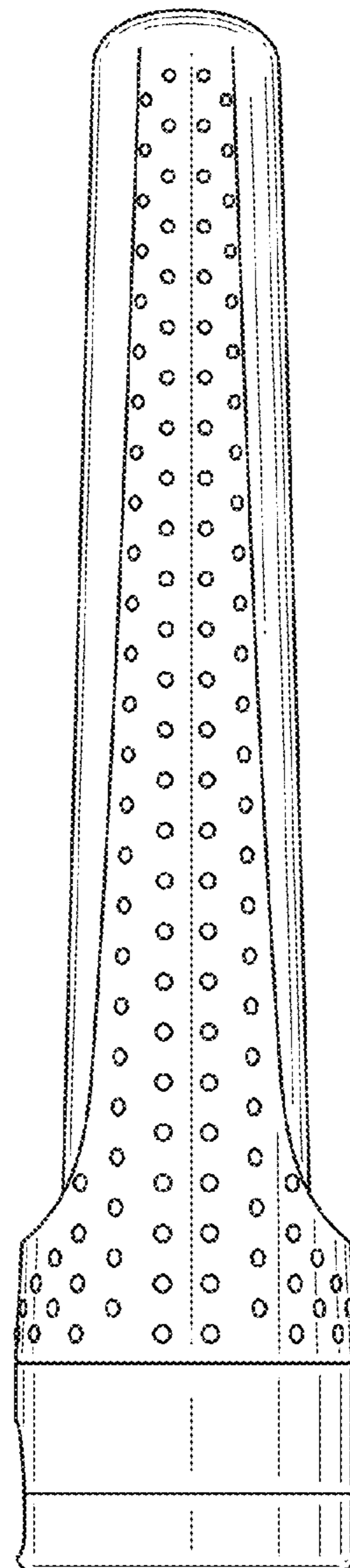

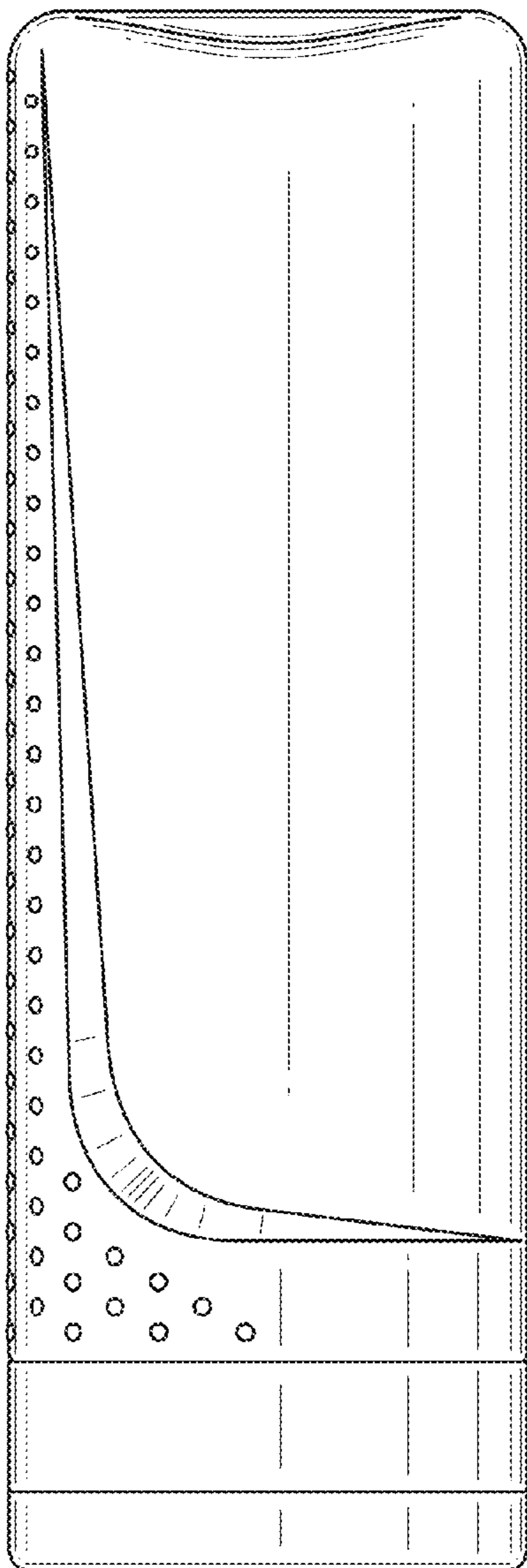

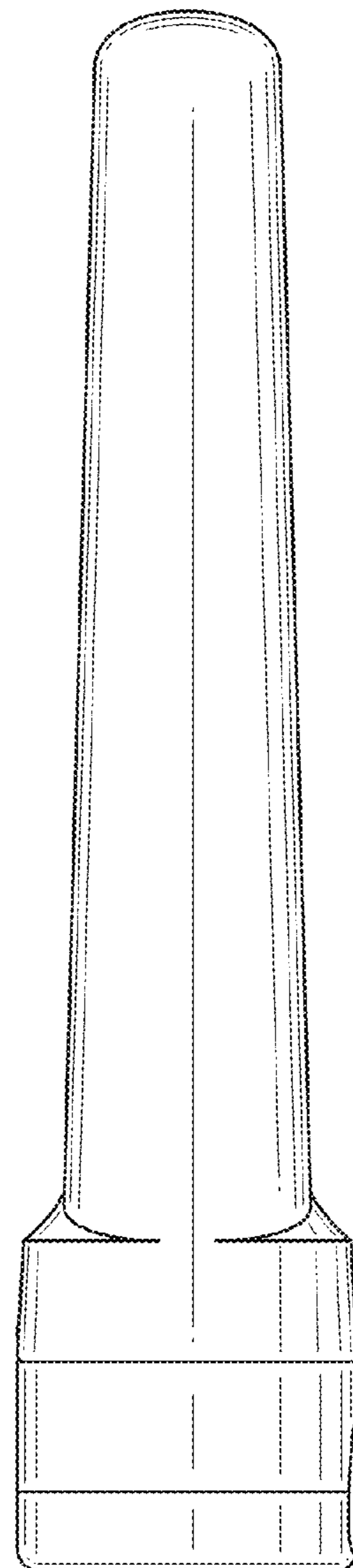

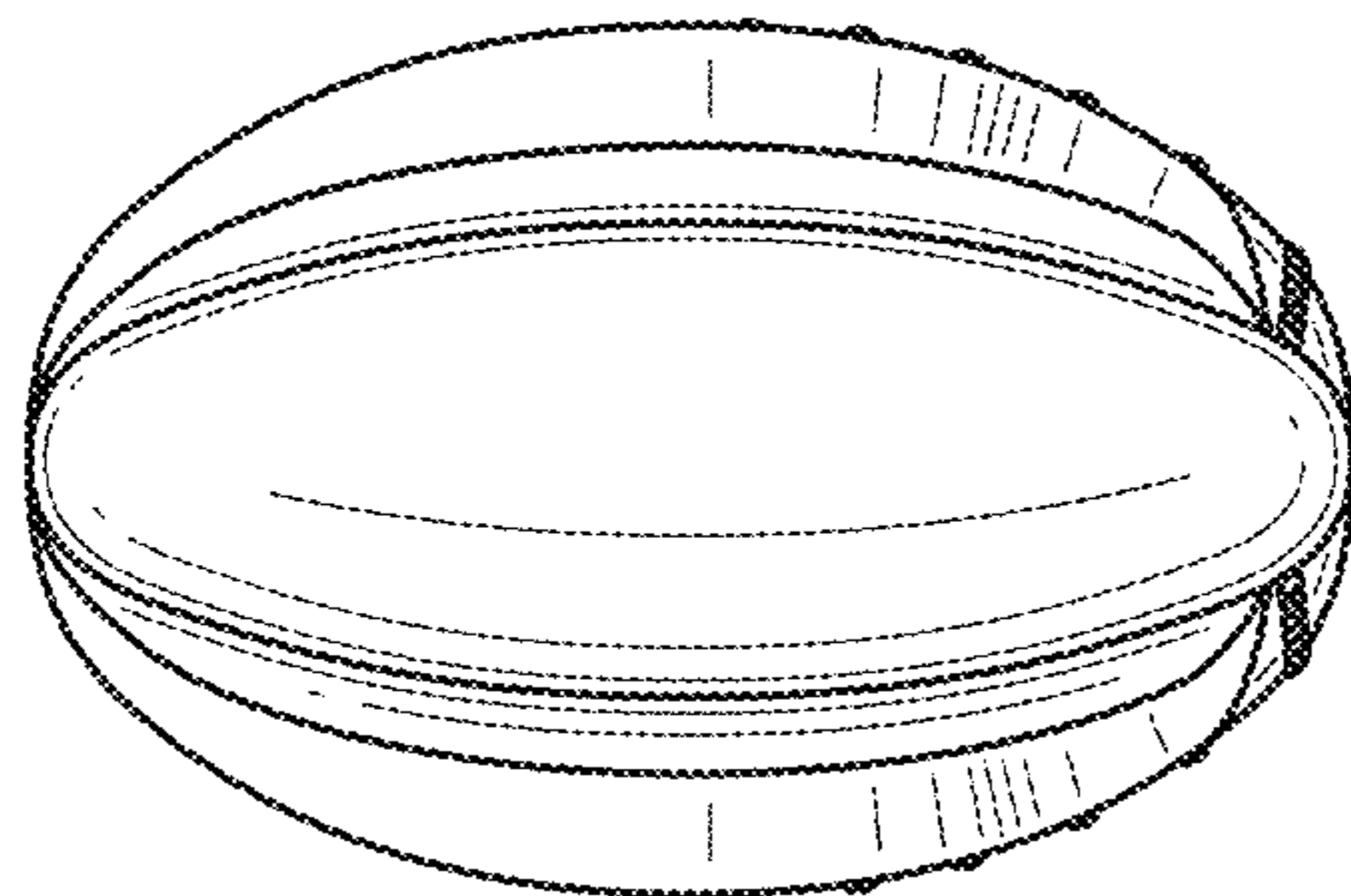
