**DESCRIPTION**

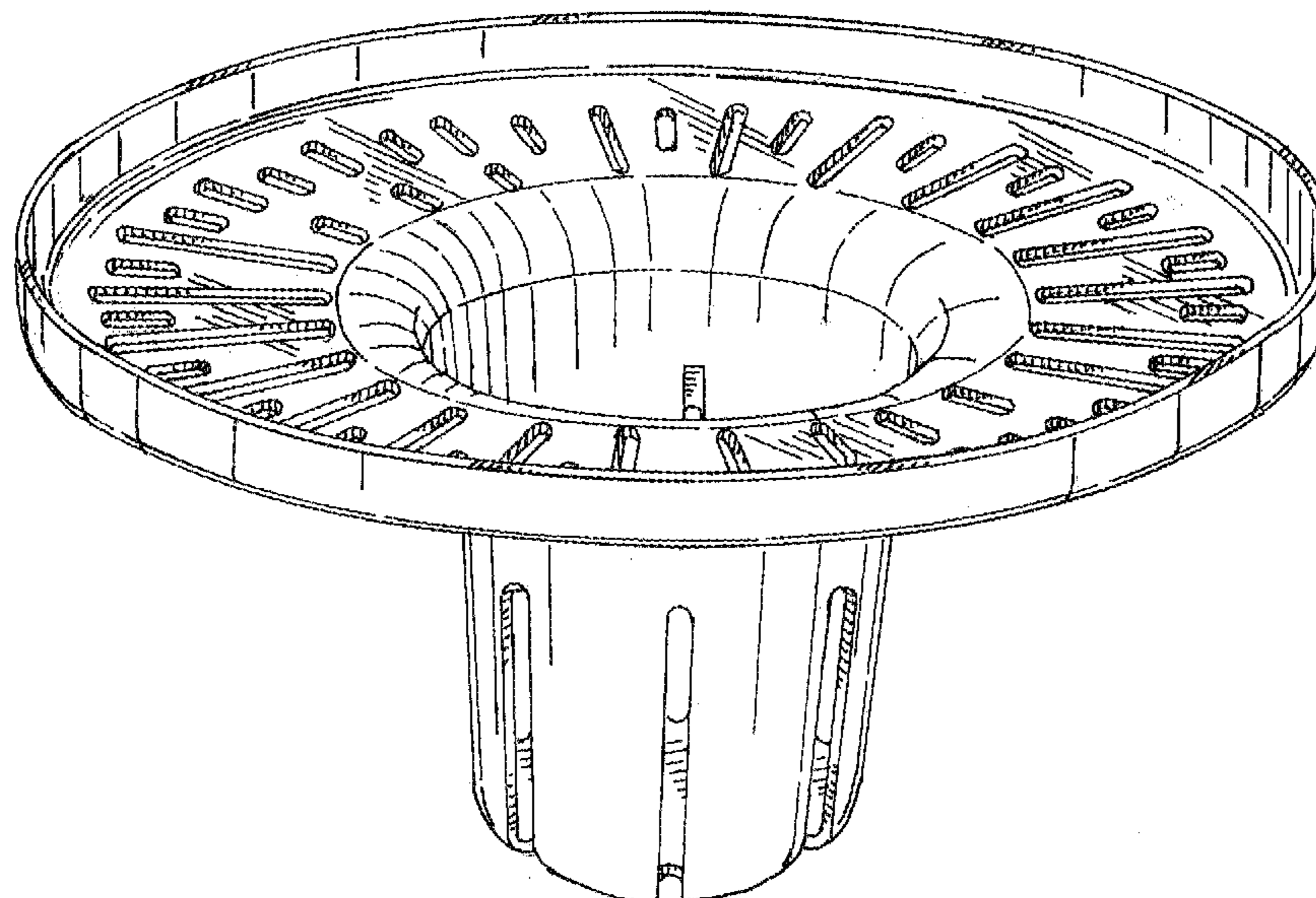
FIG. 1 is a perspective view of a soil support and irrigation platform for a planter showing my design;

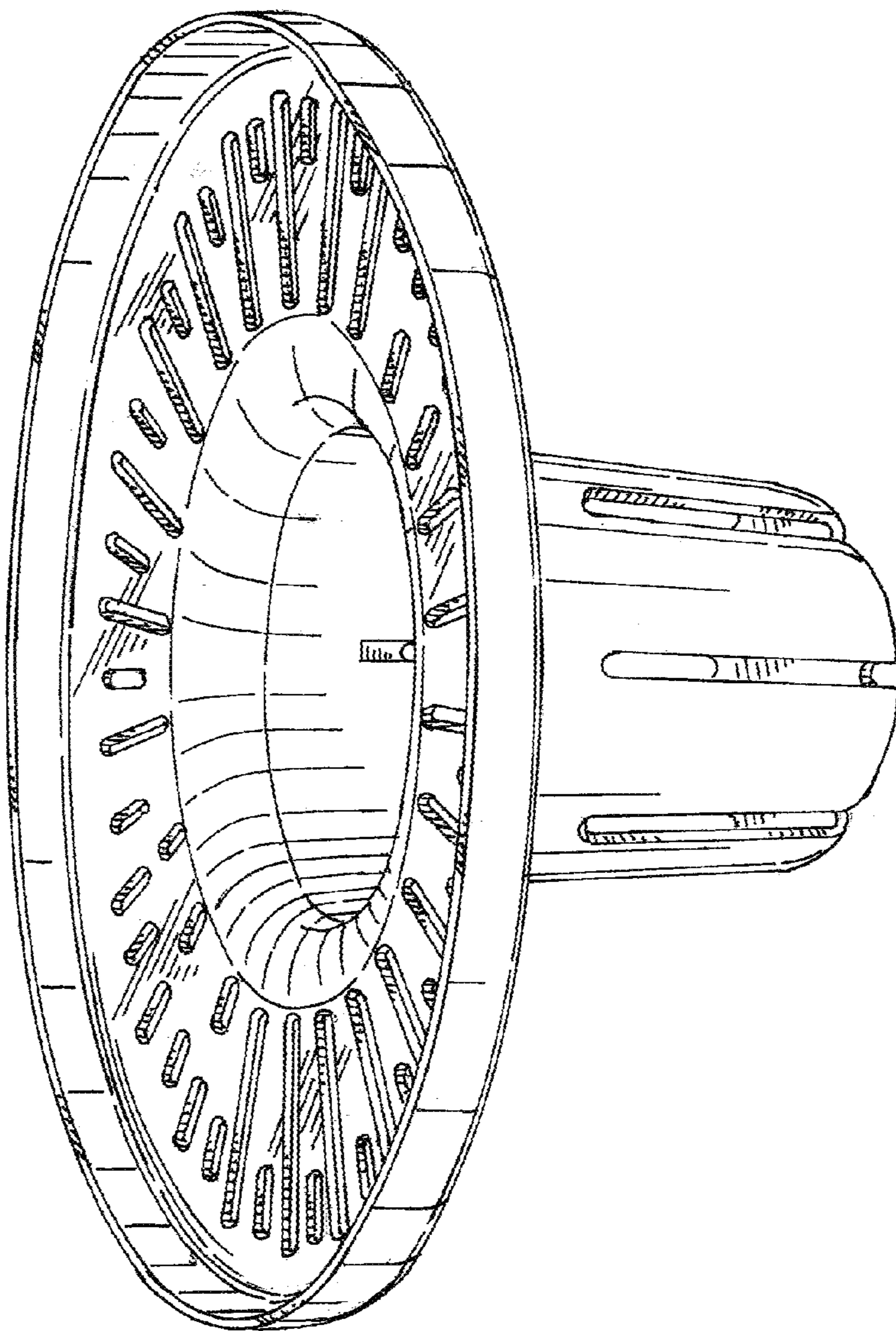
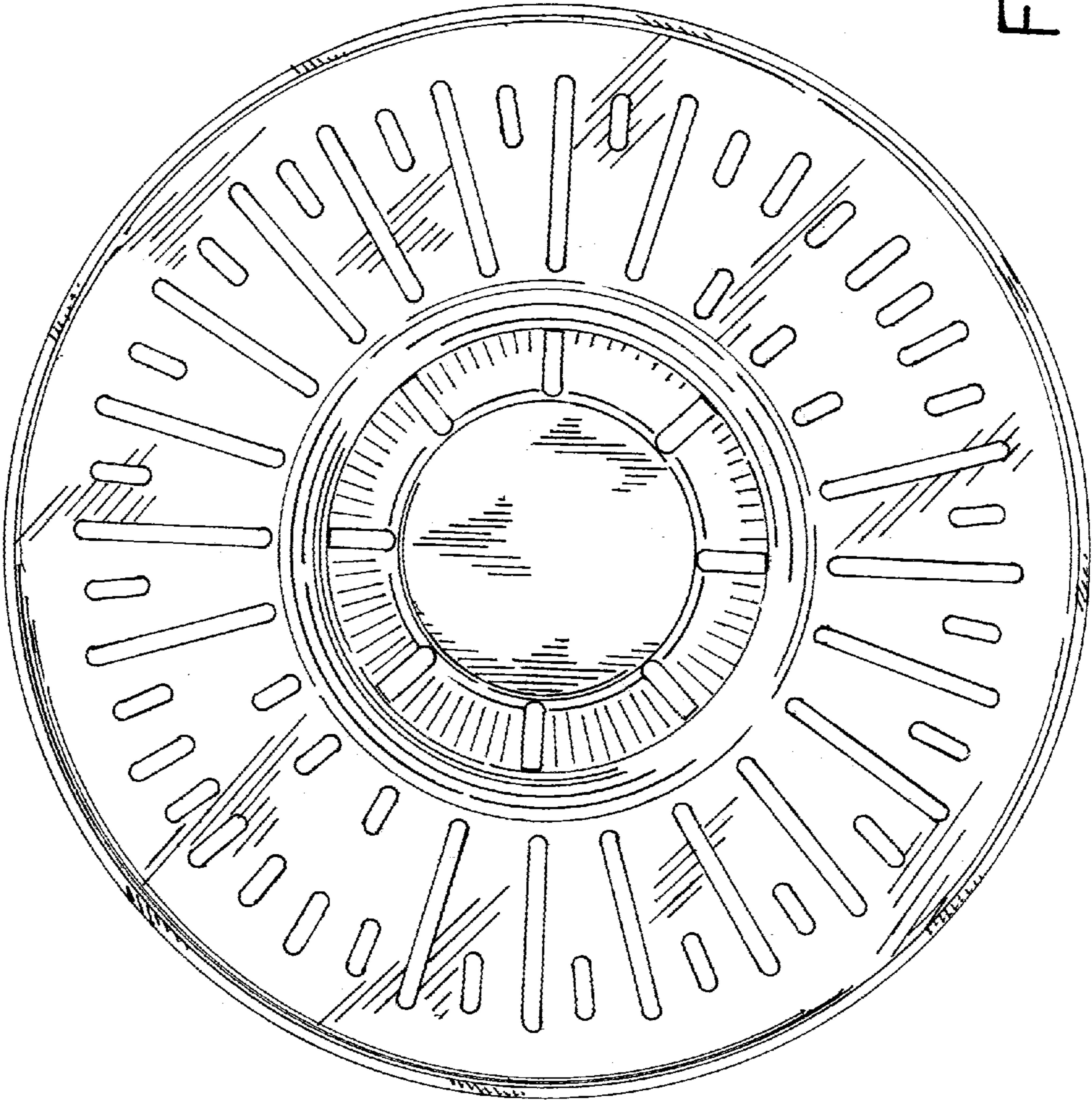

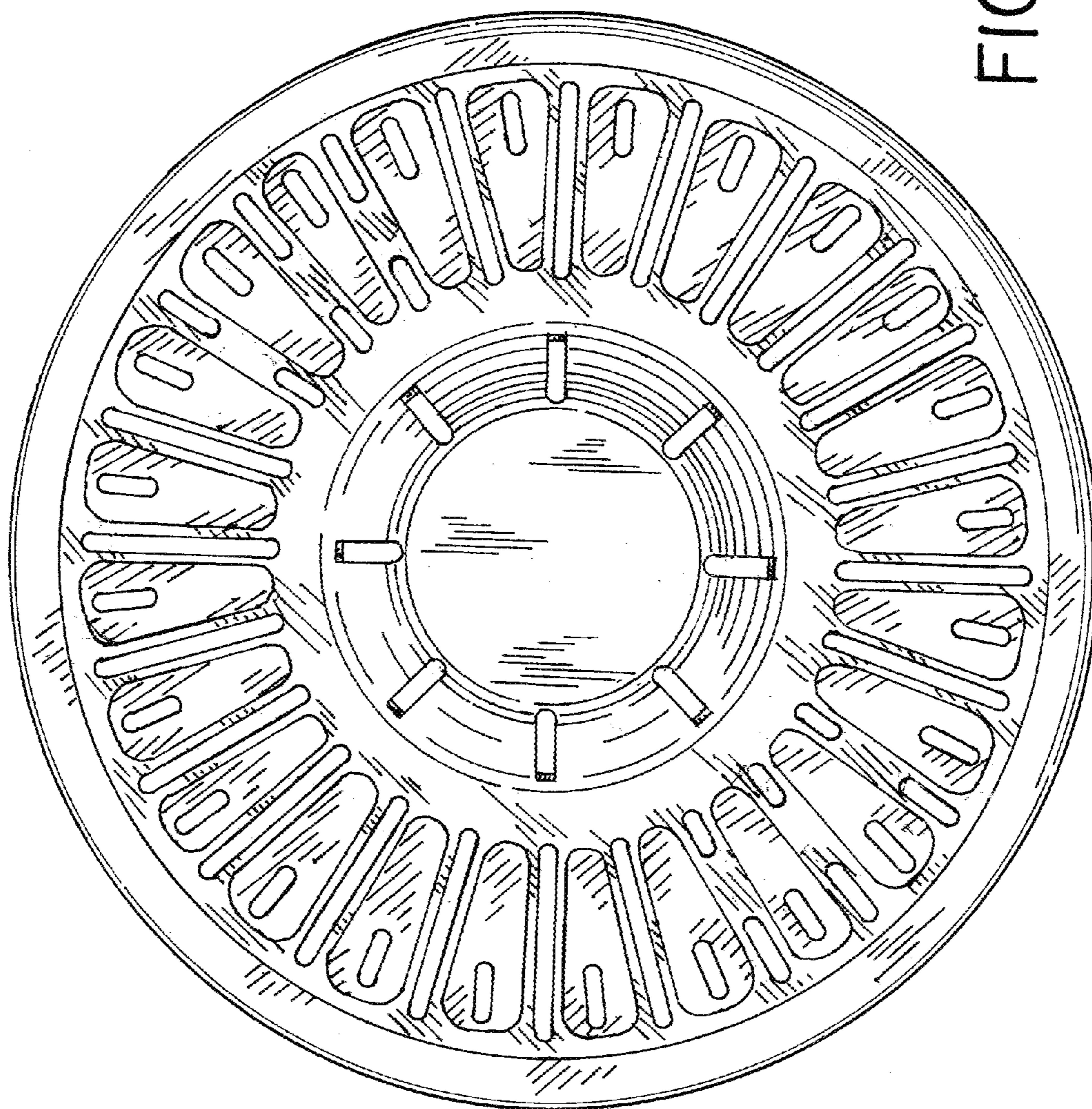

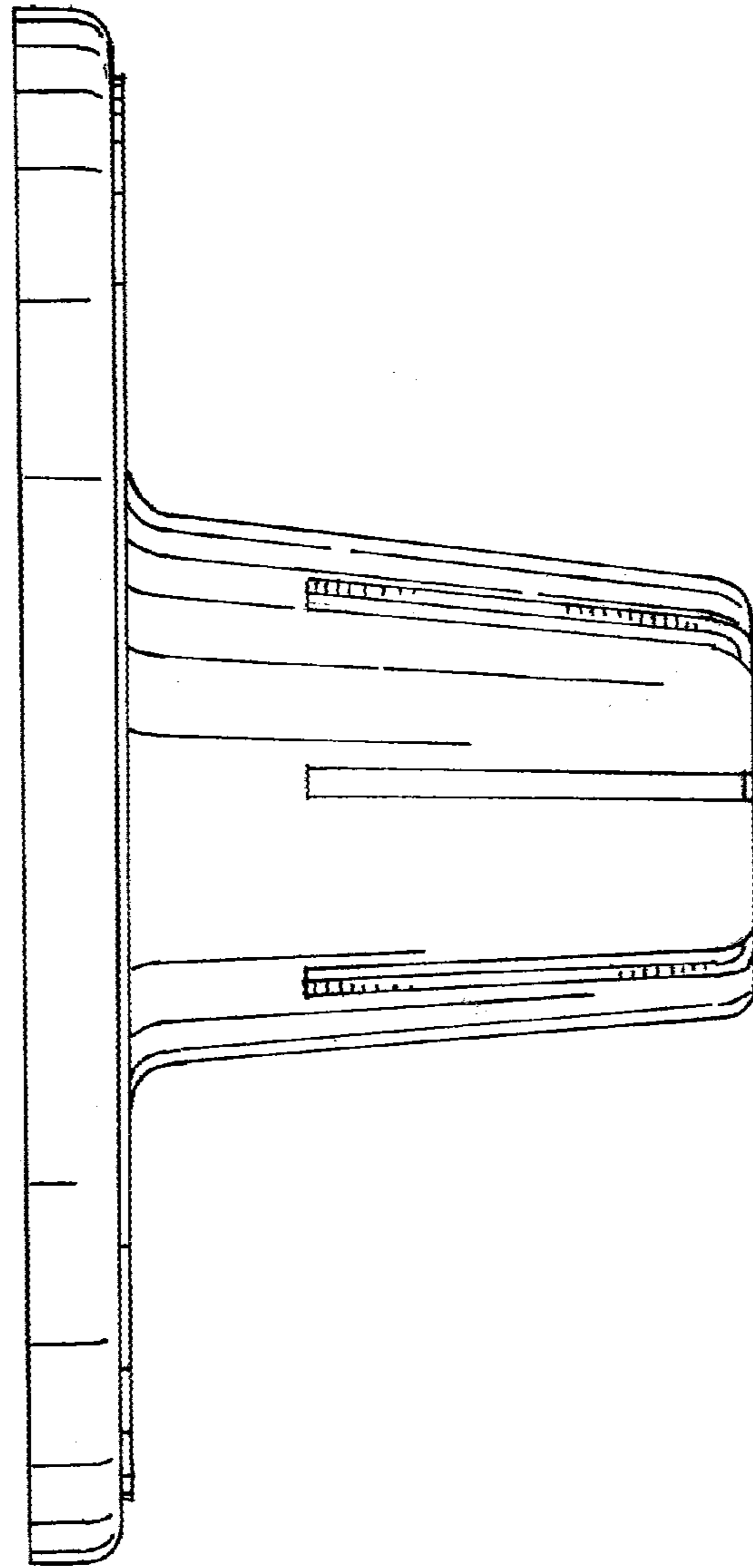
