(57) **CLAIM**

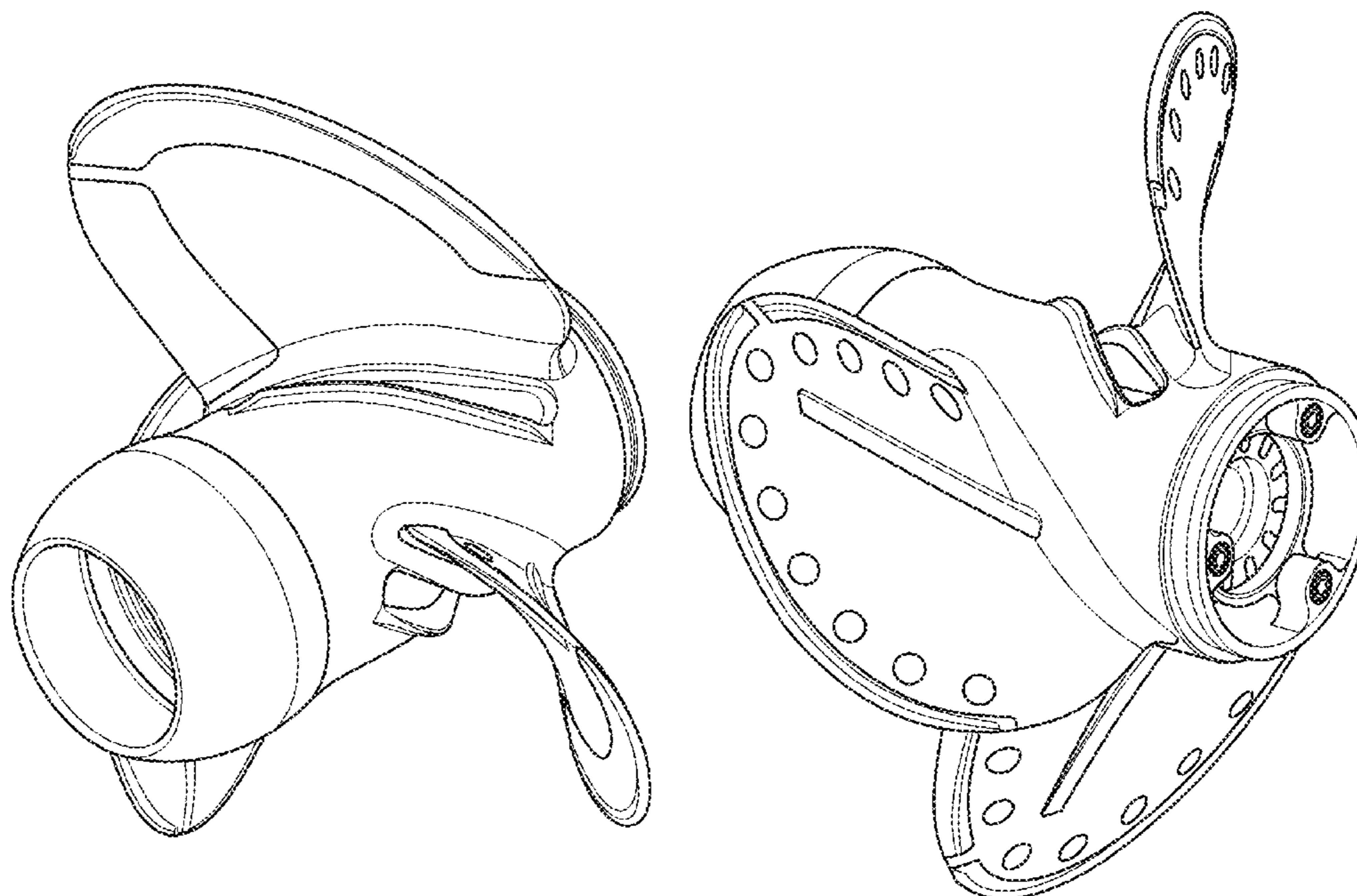
The ornamental design for propeller, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a propeller showing my new design;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a bottom view thereof; and,

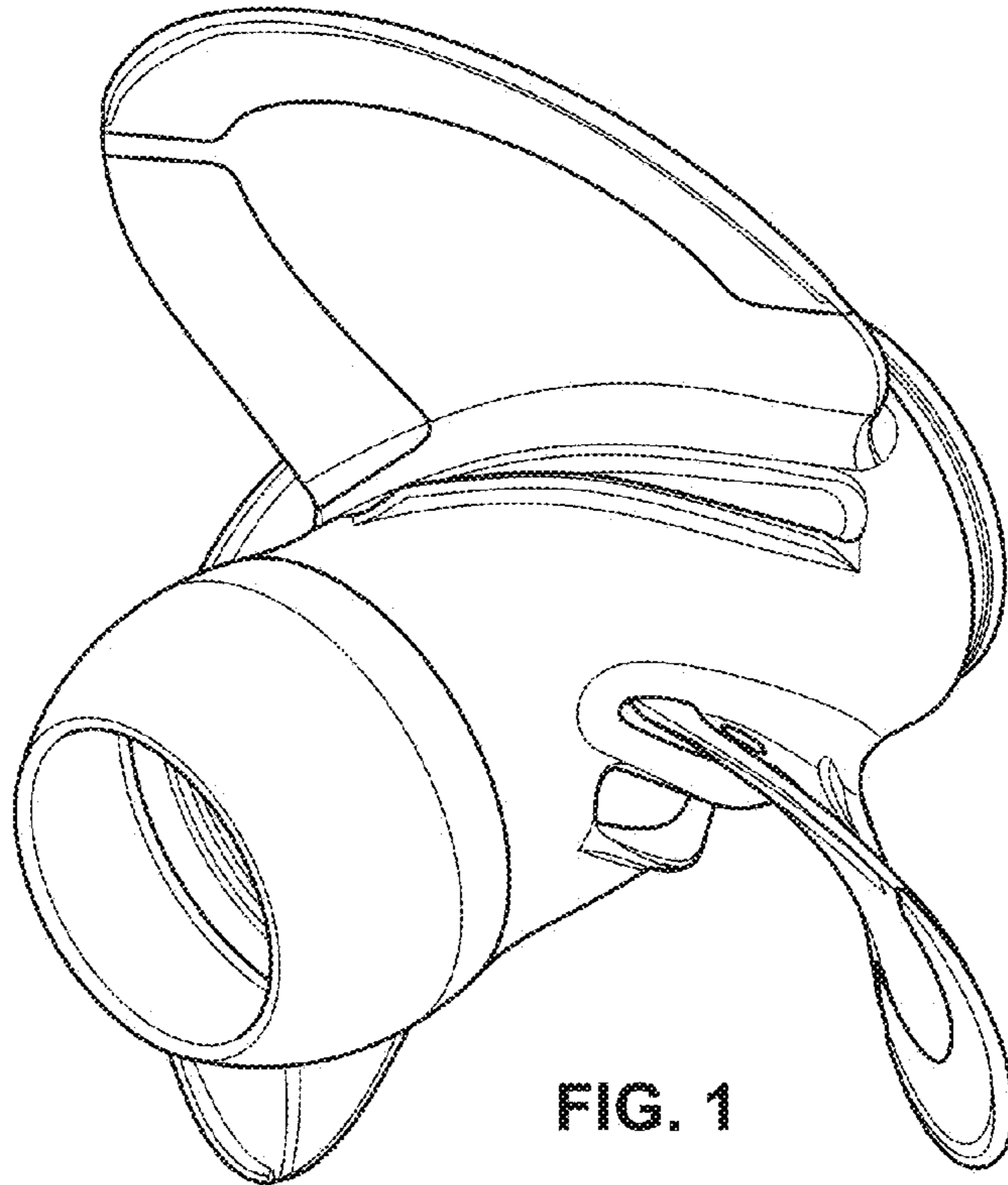

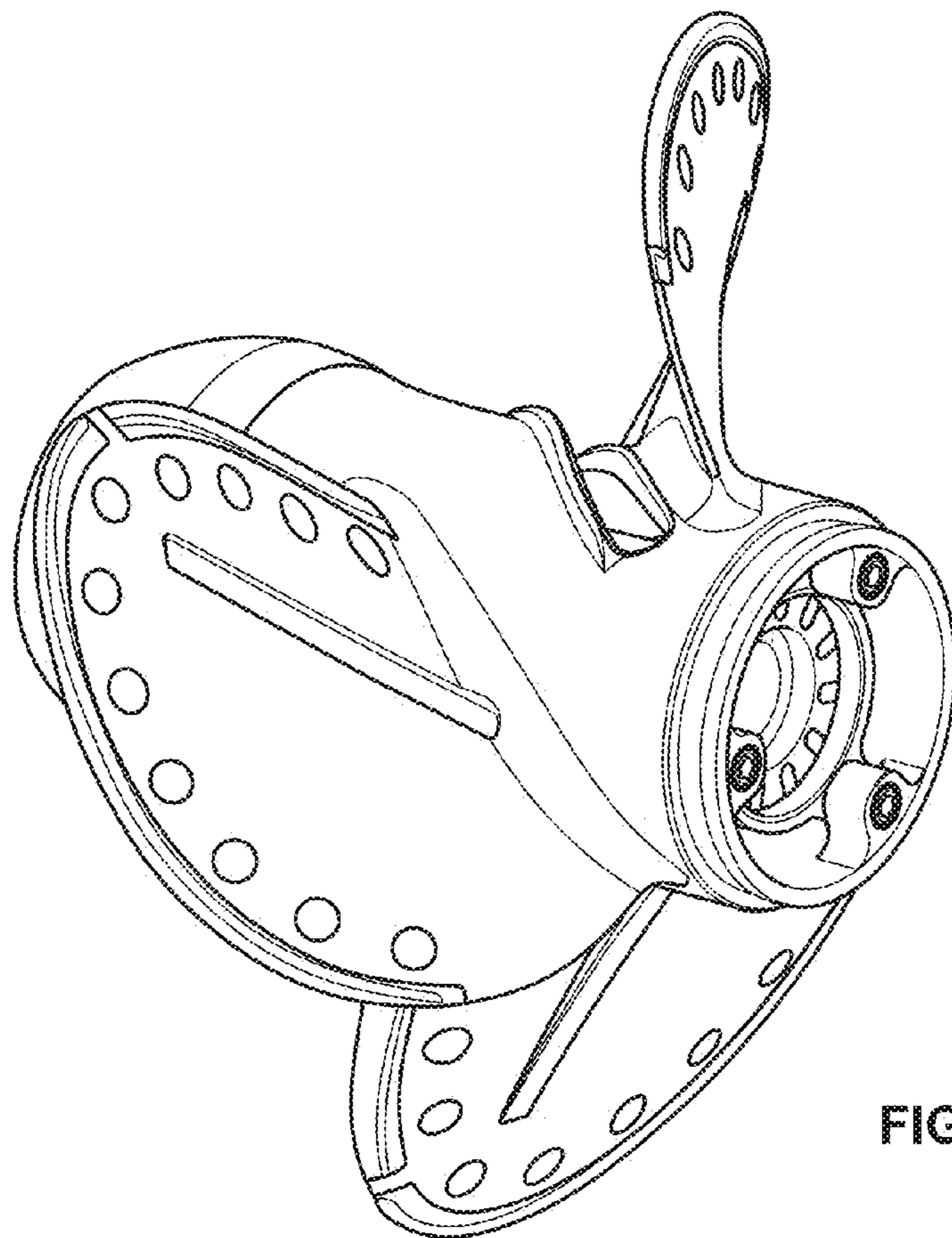

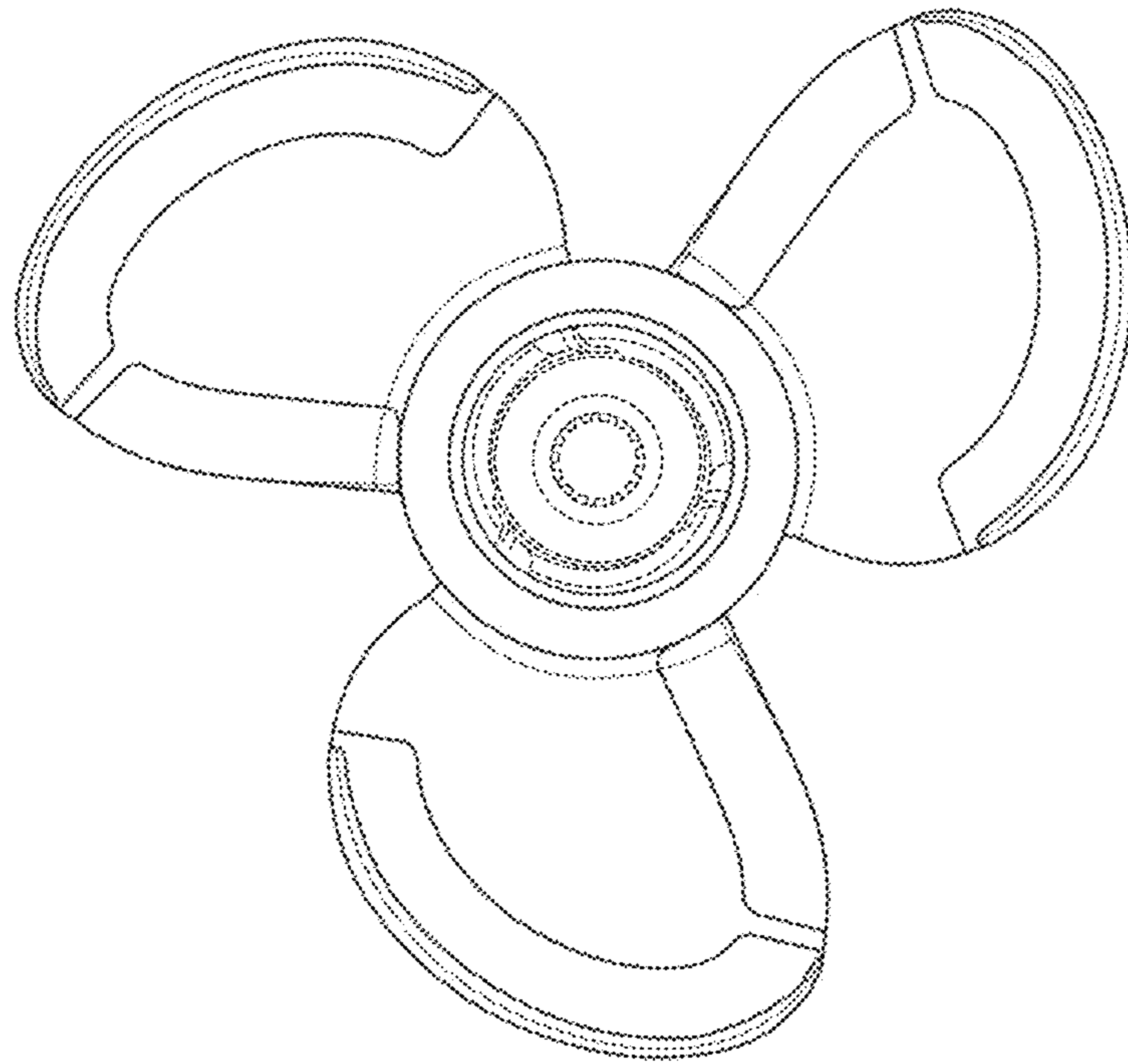

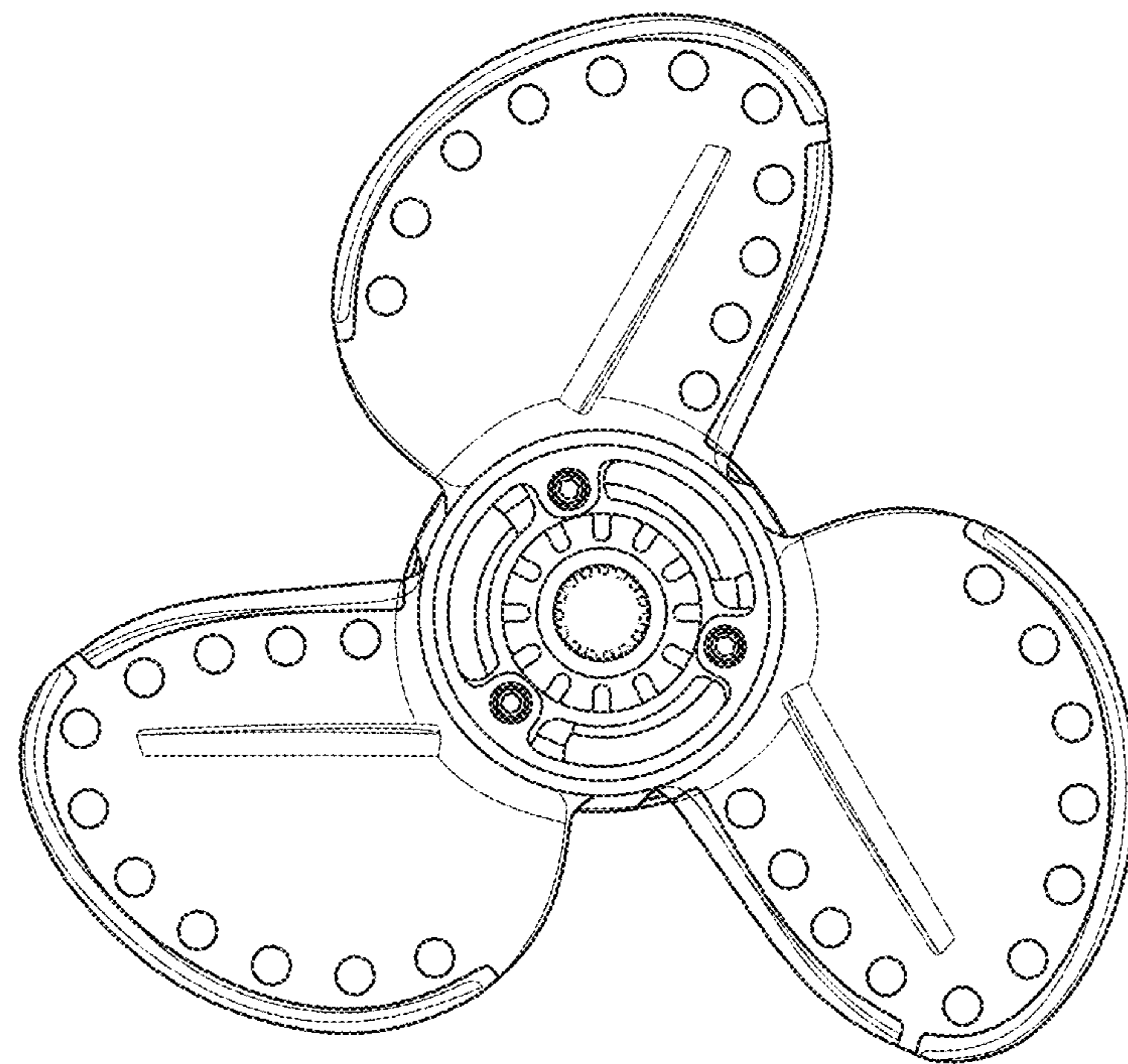

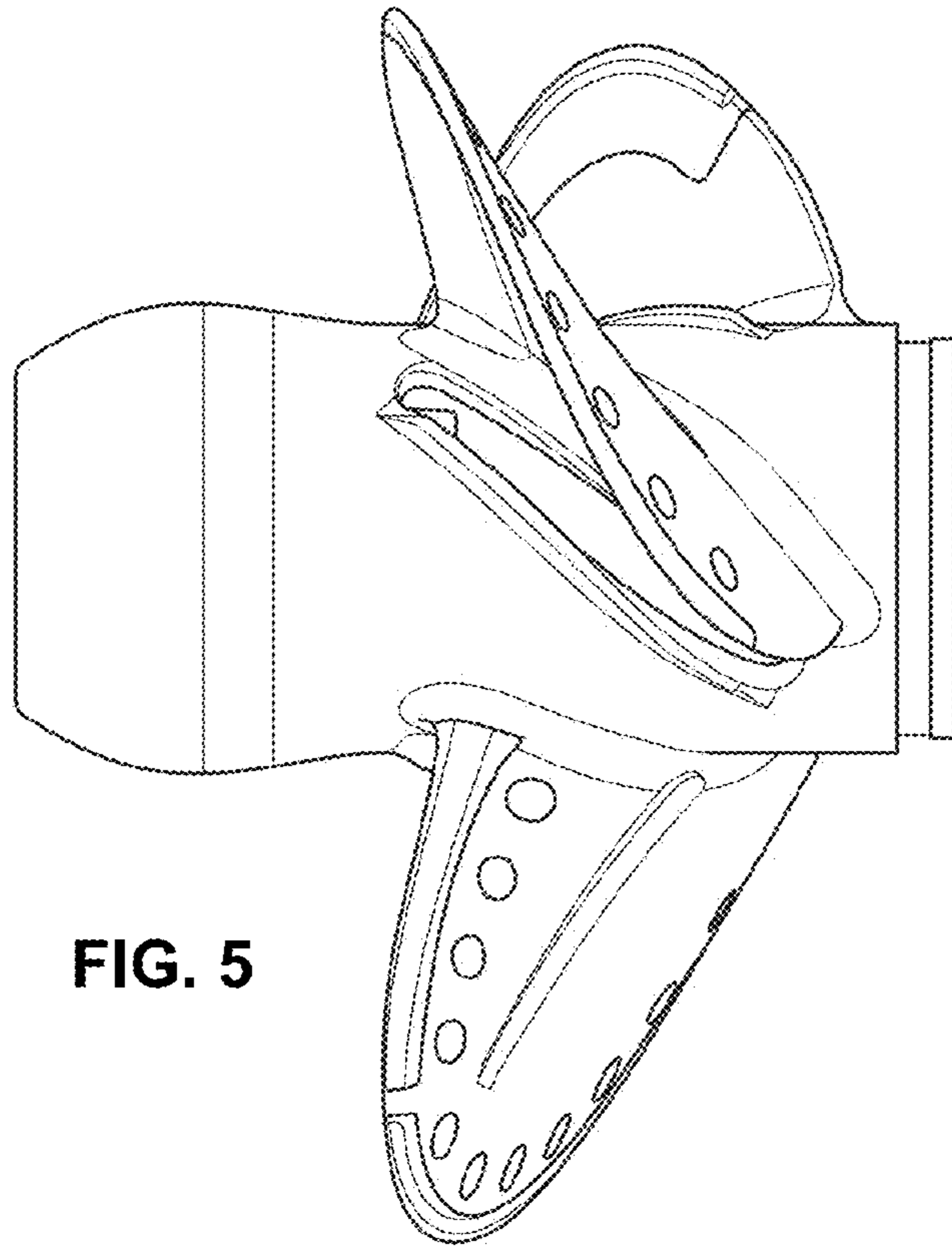

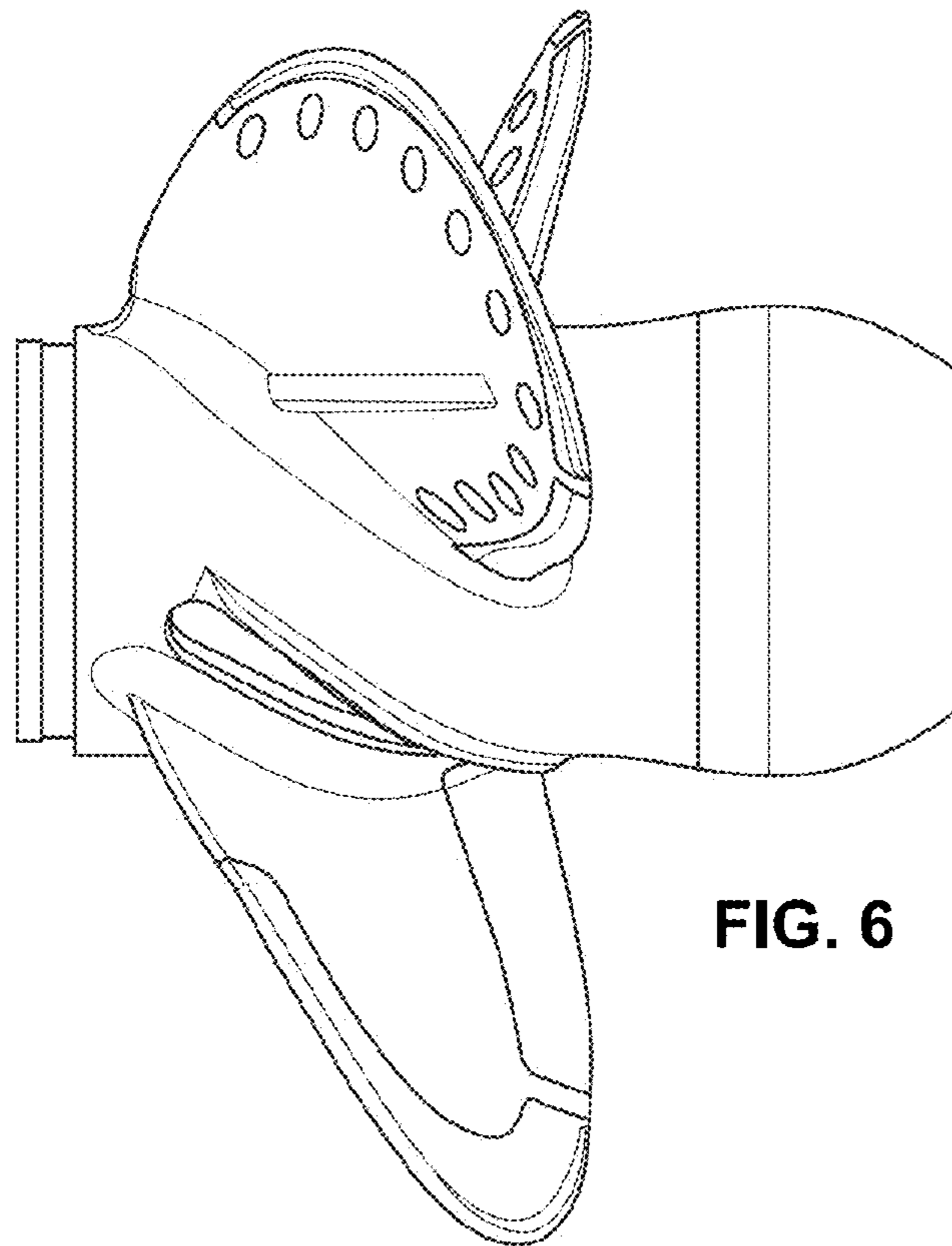

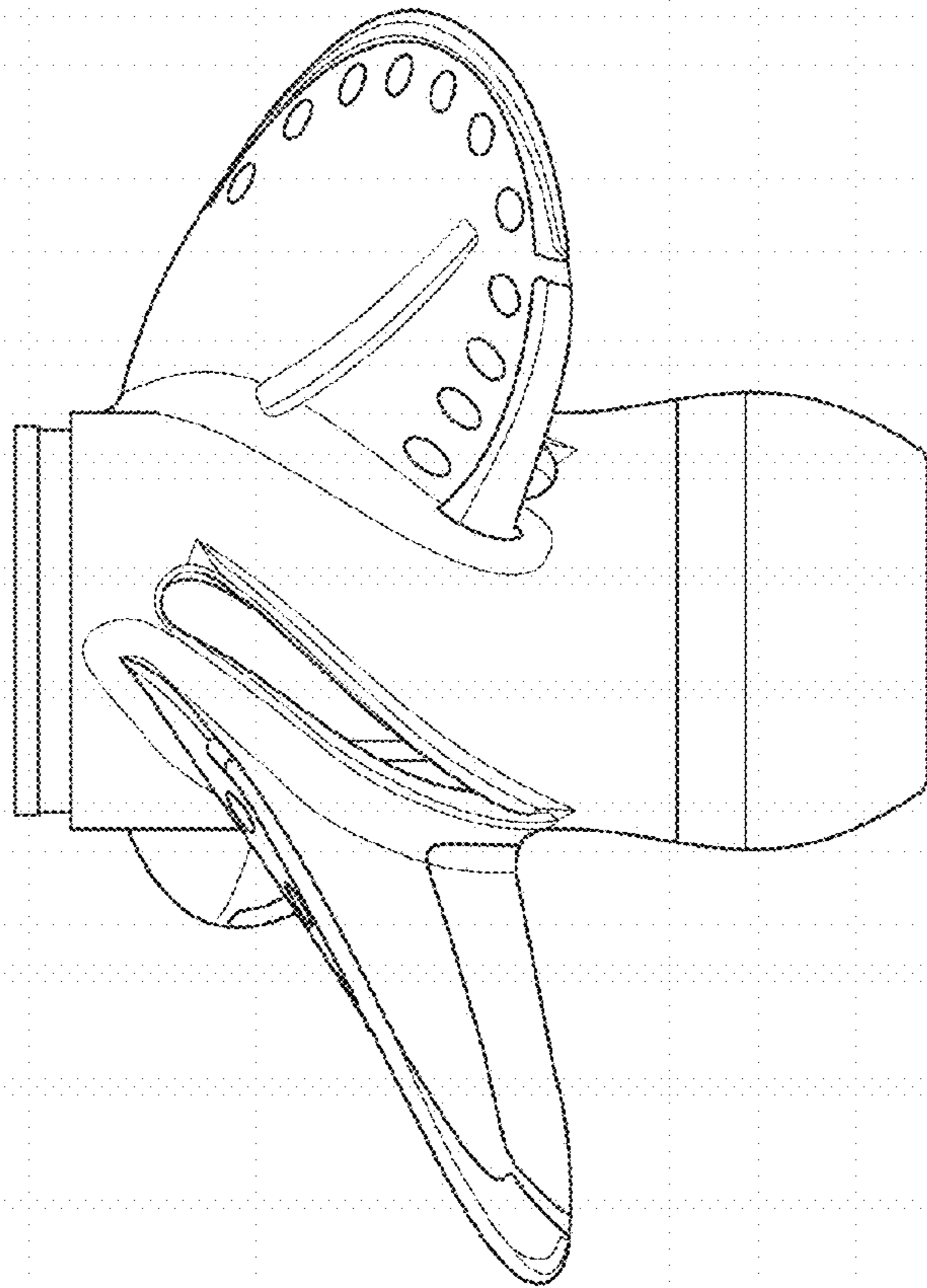

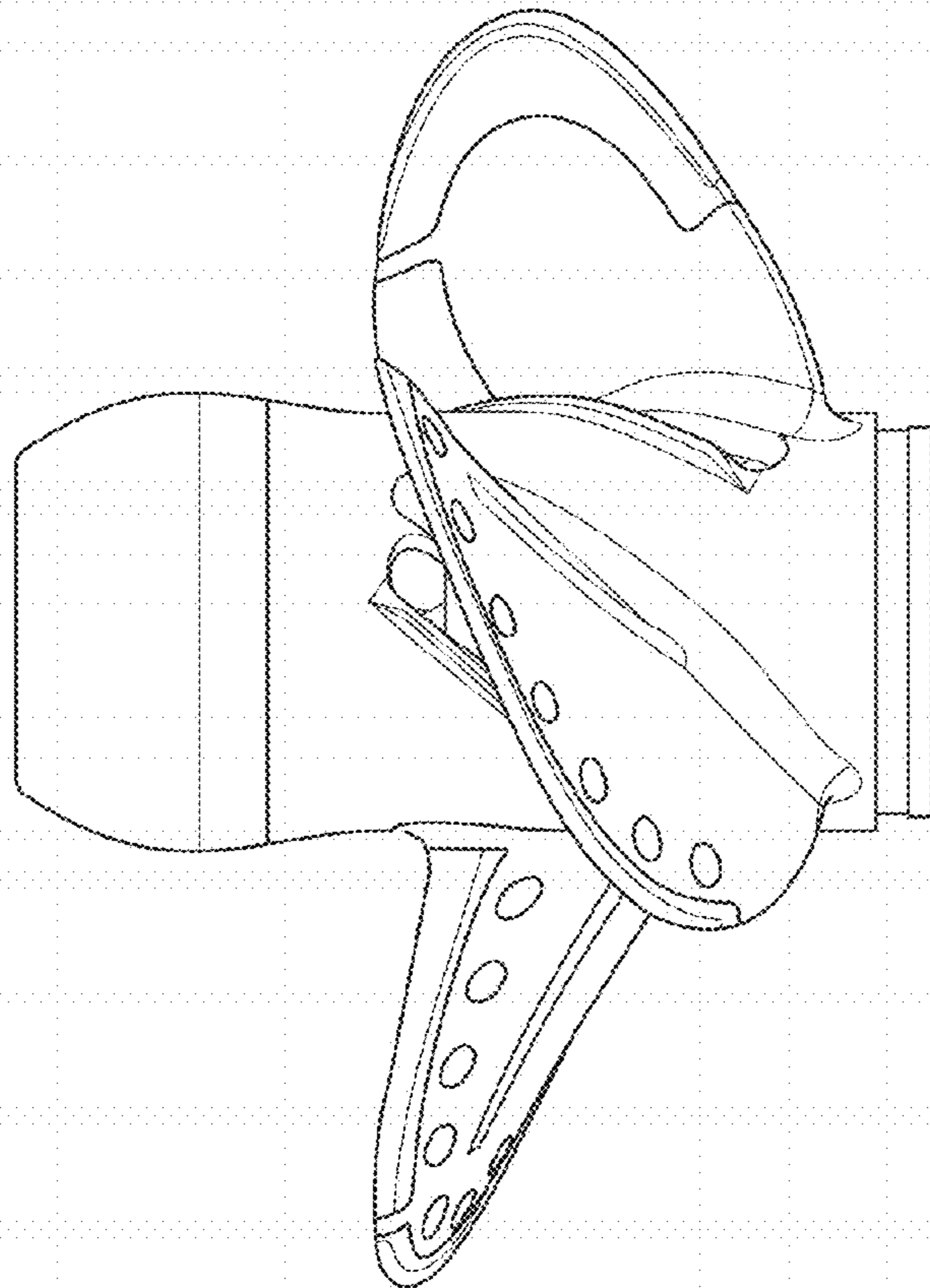
