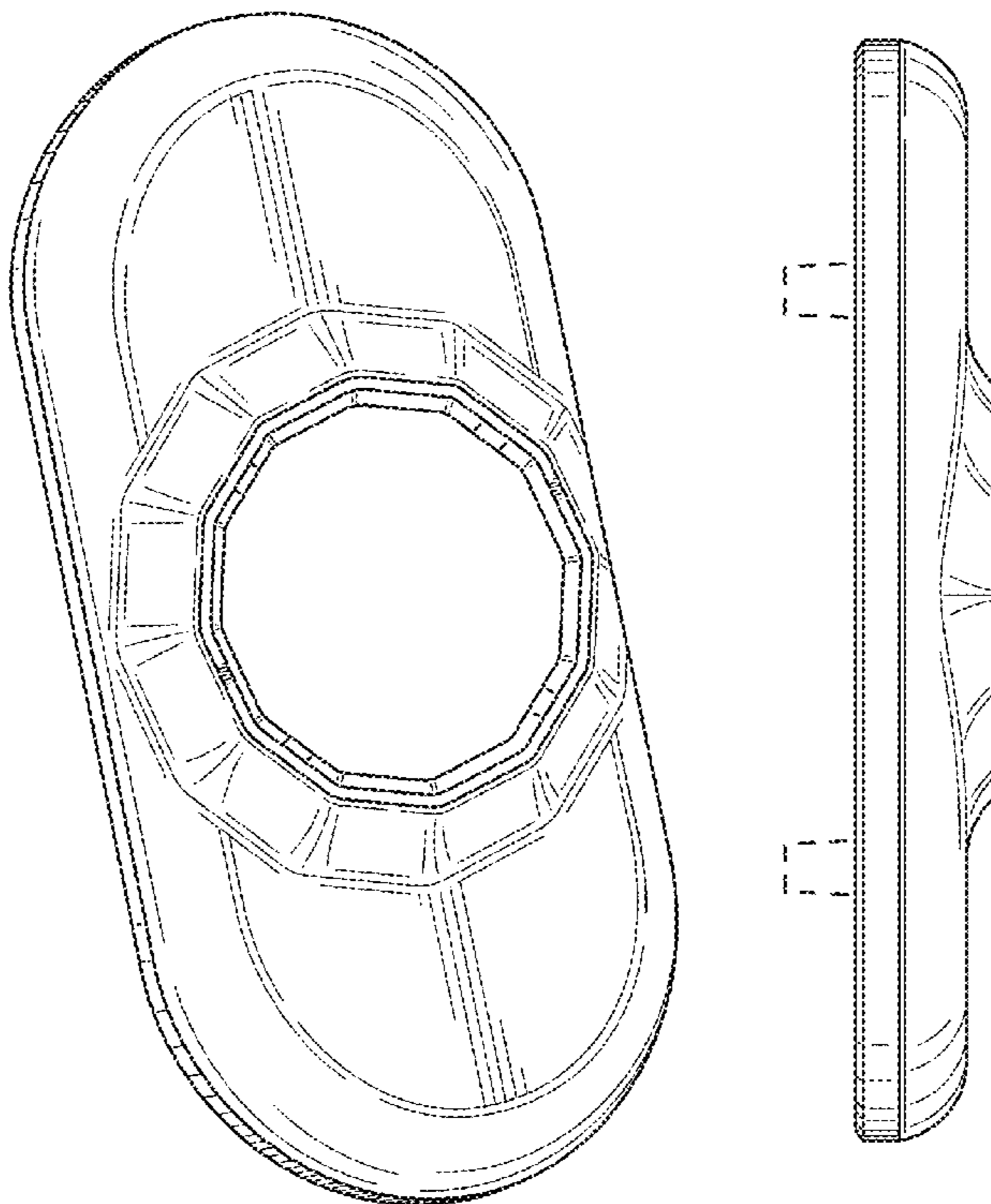
(57) **CLAIM**

What is claimed is the ornamental design for a cover plate for an electrical device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover plate for an electrical device showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a rear side elevational view thereof; and,

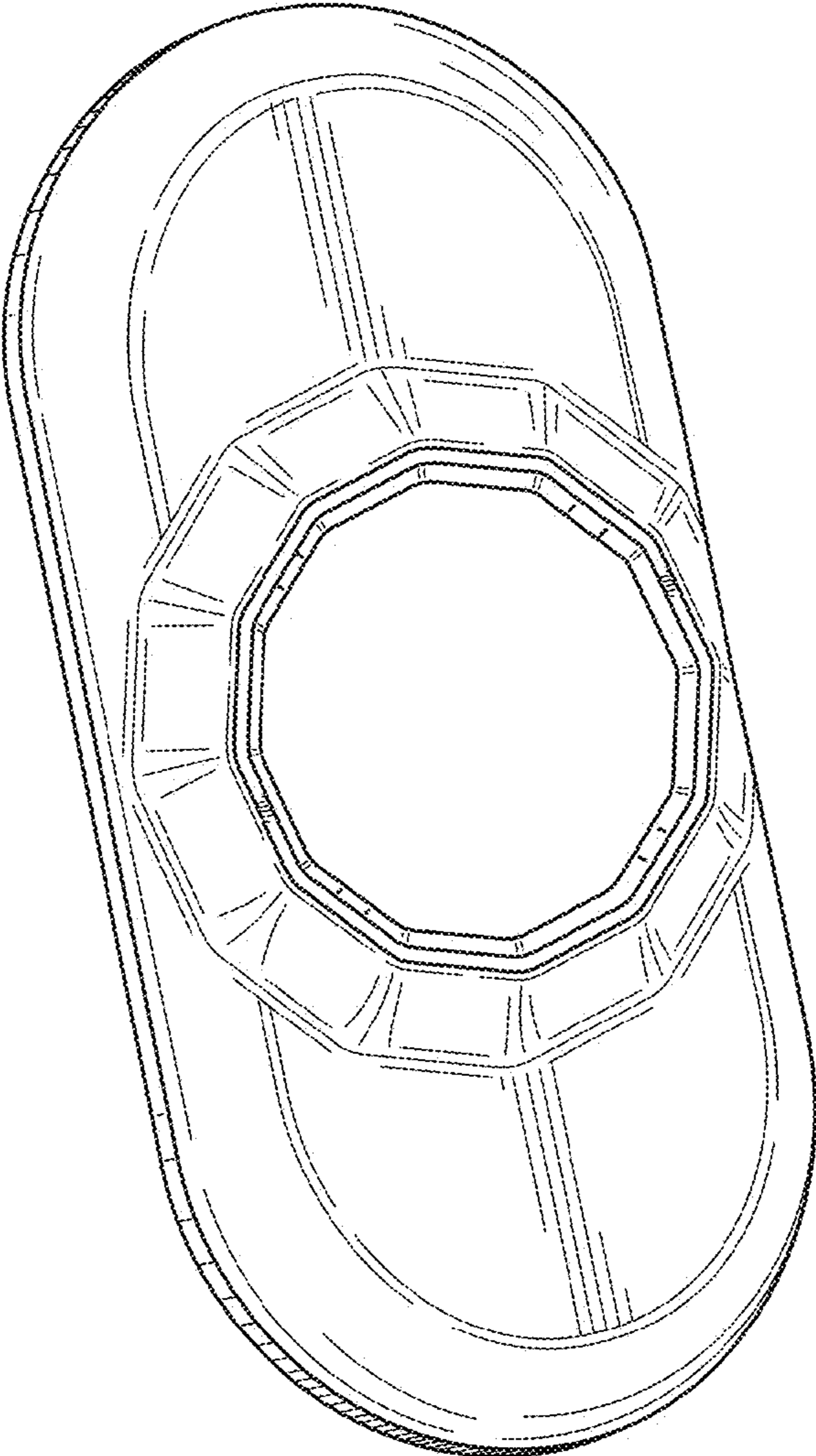

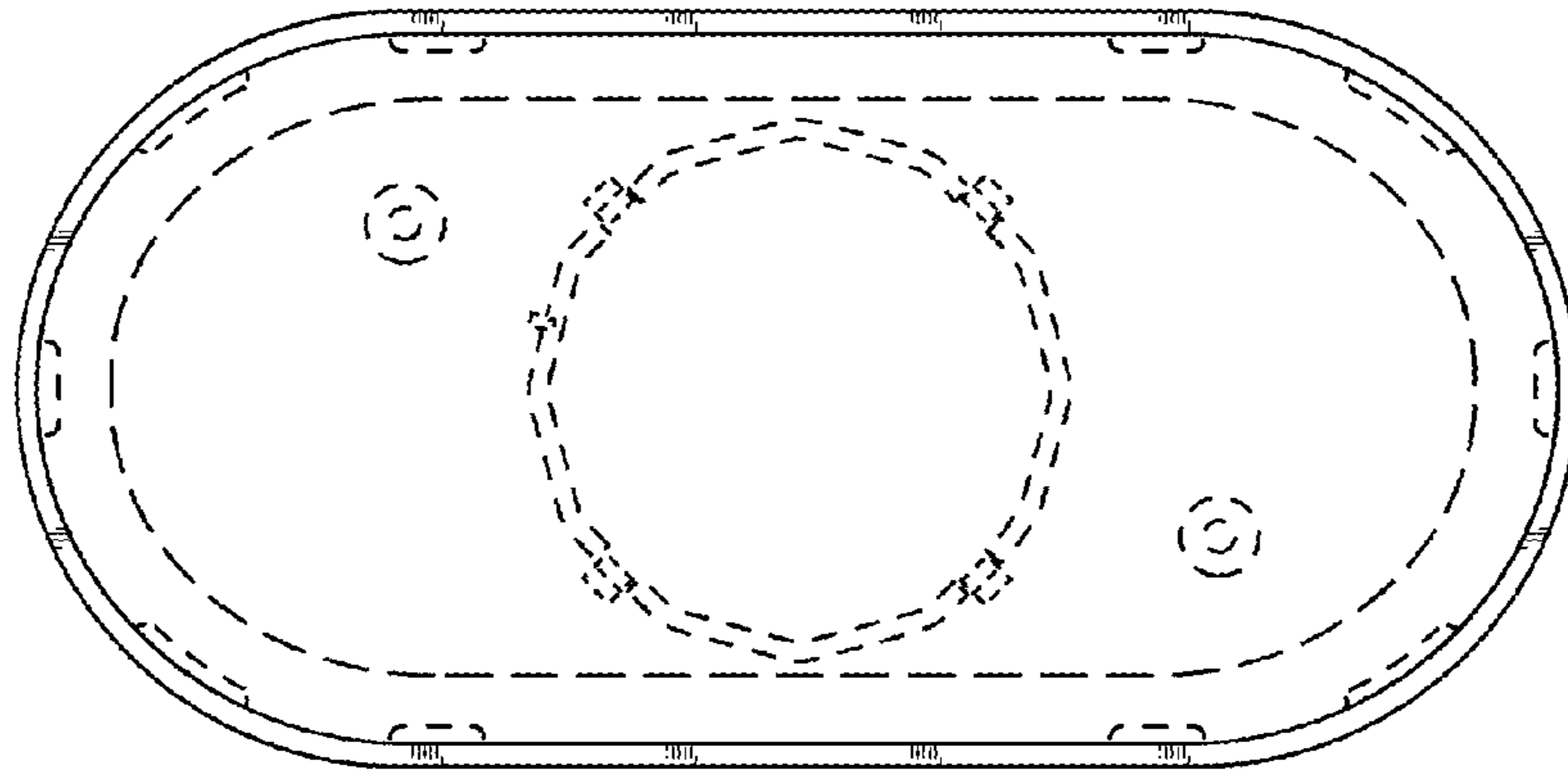

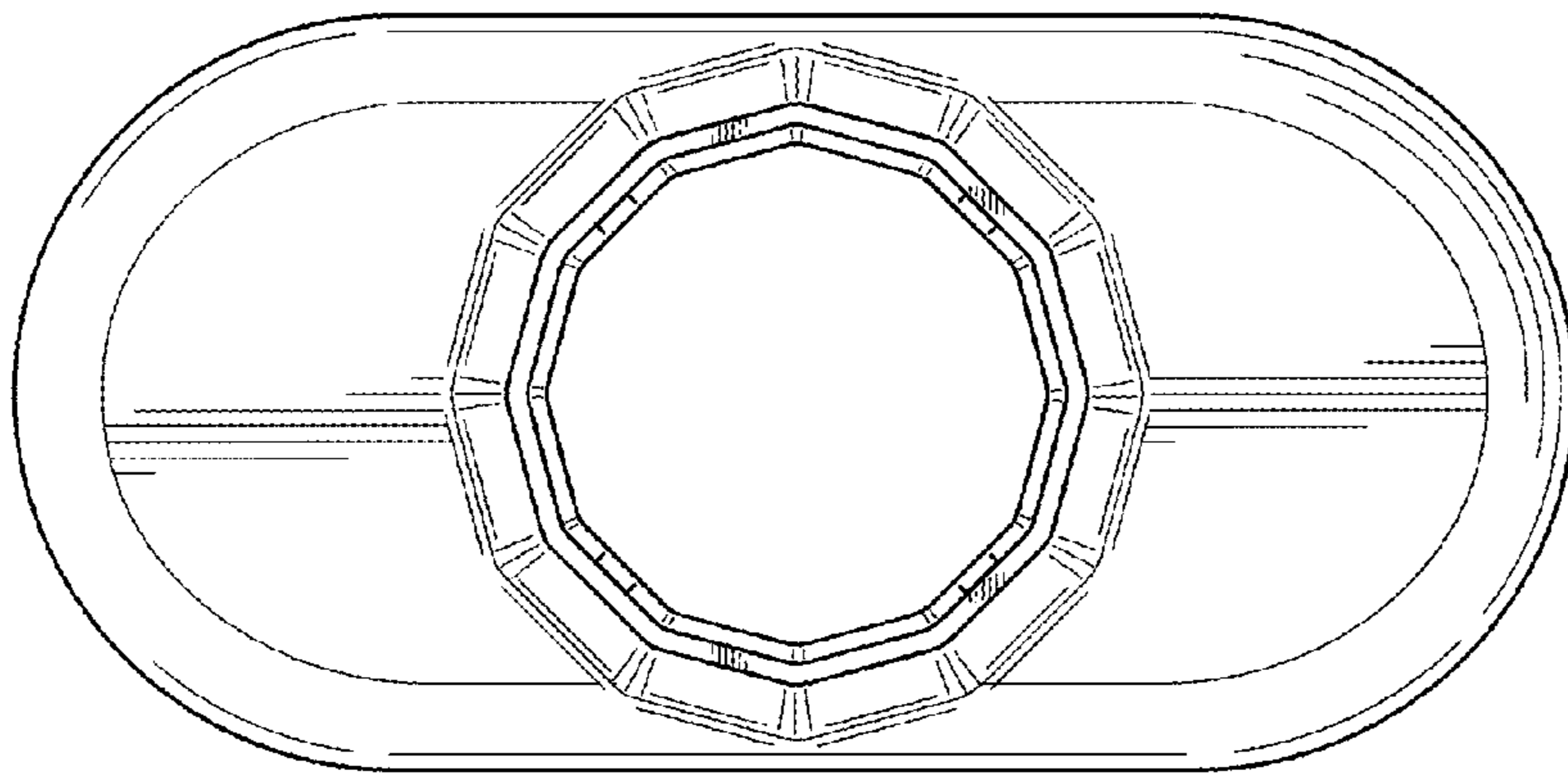

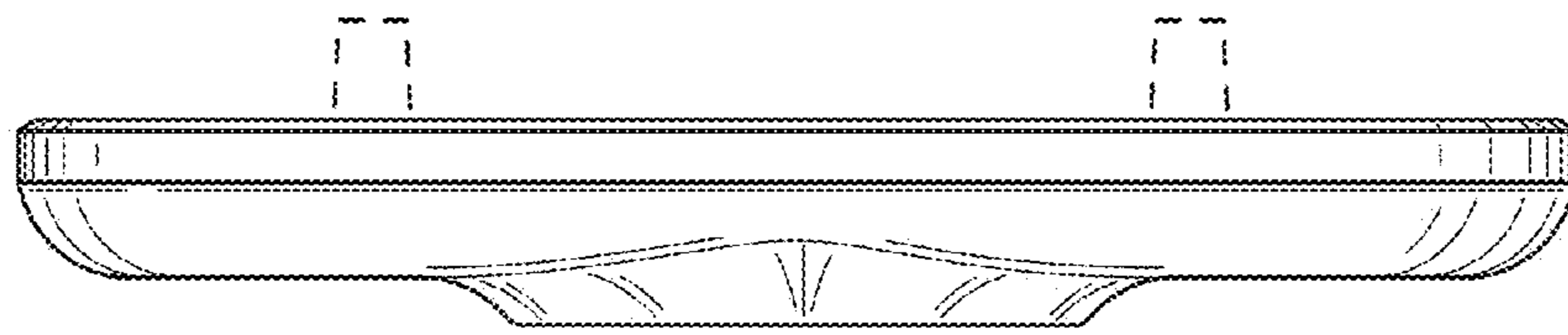

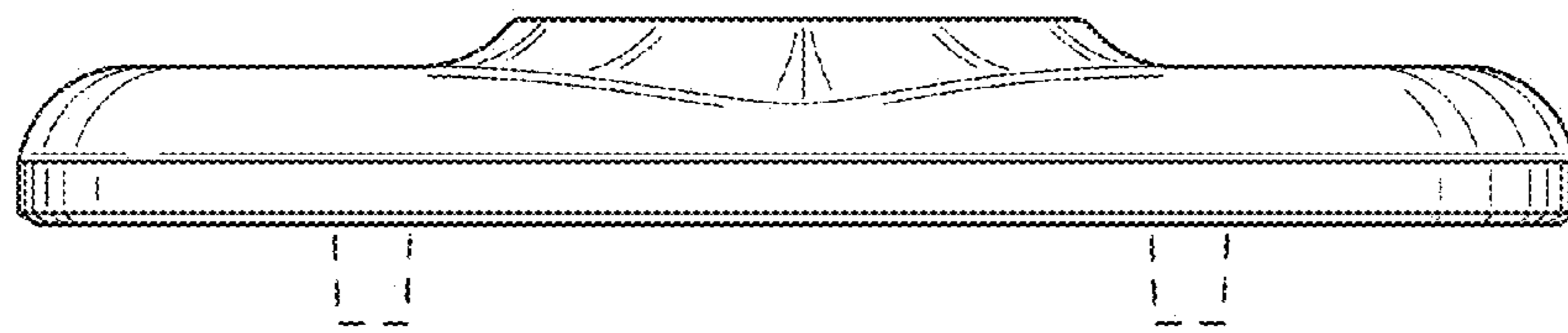

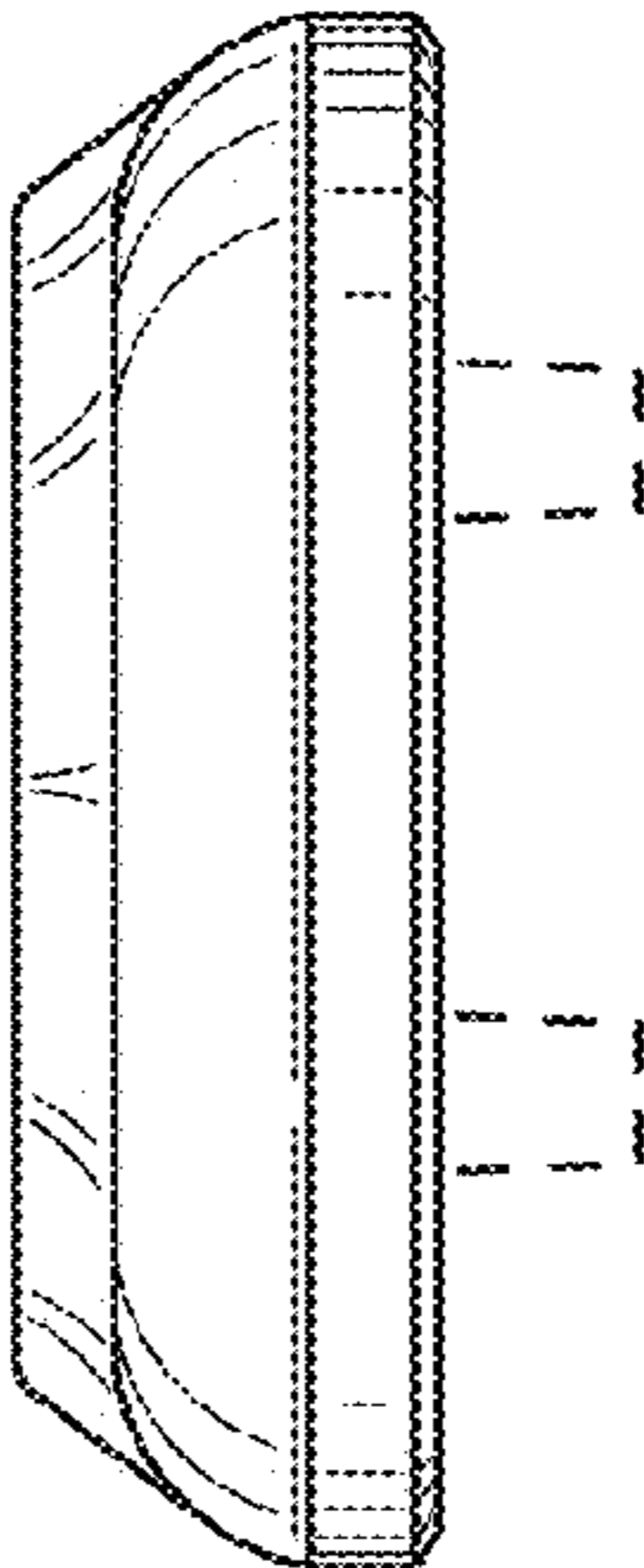

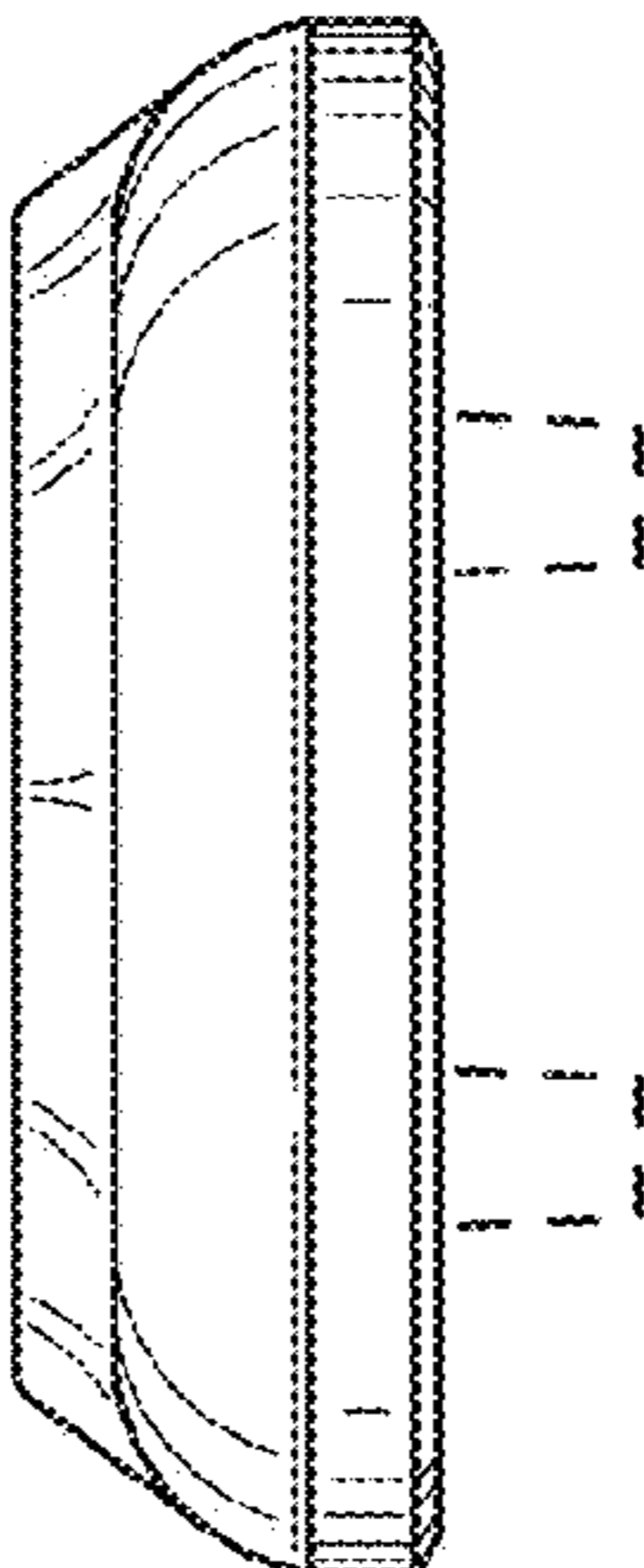
