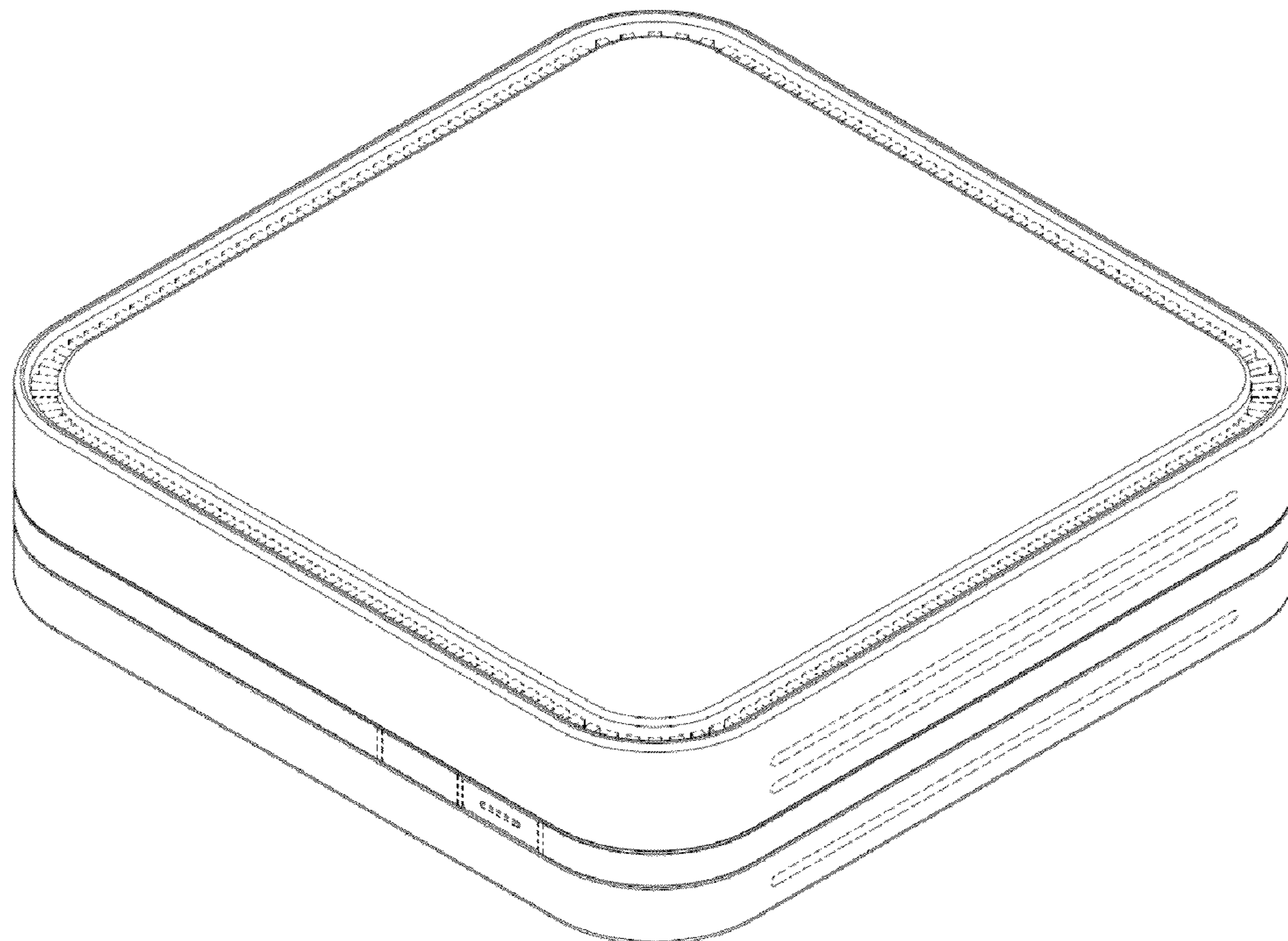
(57) **CLAIM**

The ornamental design for a set-top enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the set-top enclosure.
FIG. 2 is a front elevation view of the set-top enclosure.
FIG. 3 is a right side elevation view of the set-top enclosure.
The left side elevation view of the set-top enclosure is a mirror image of the right side elevation view of the set-top enclosure; and,
FIG. 4 is a rear elevation view of the set-top enclosure.
The broken lines depict portions of the set-top enclosure that form no part of the claimed design.

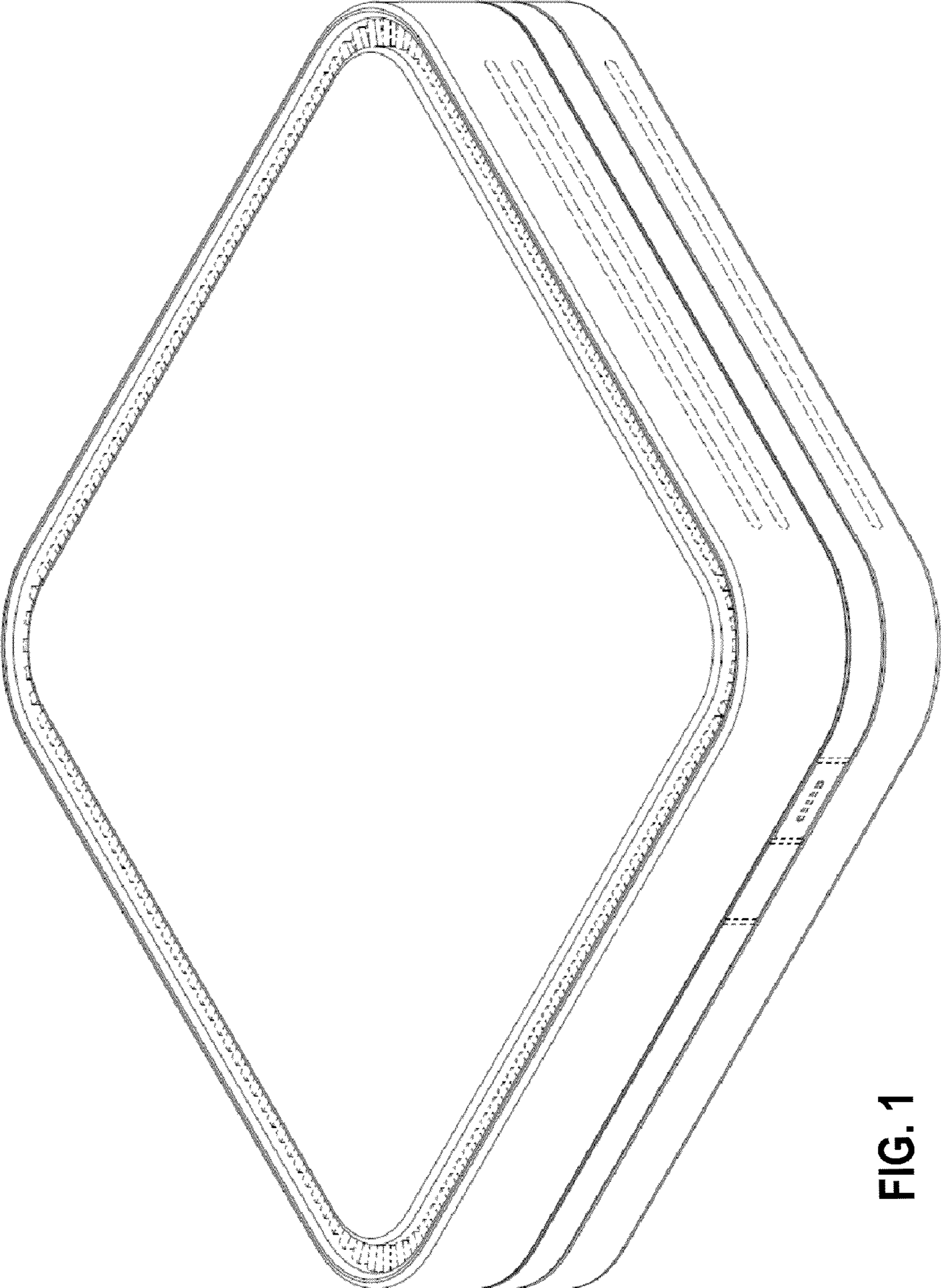

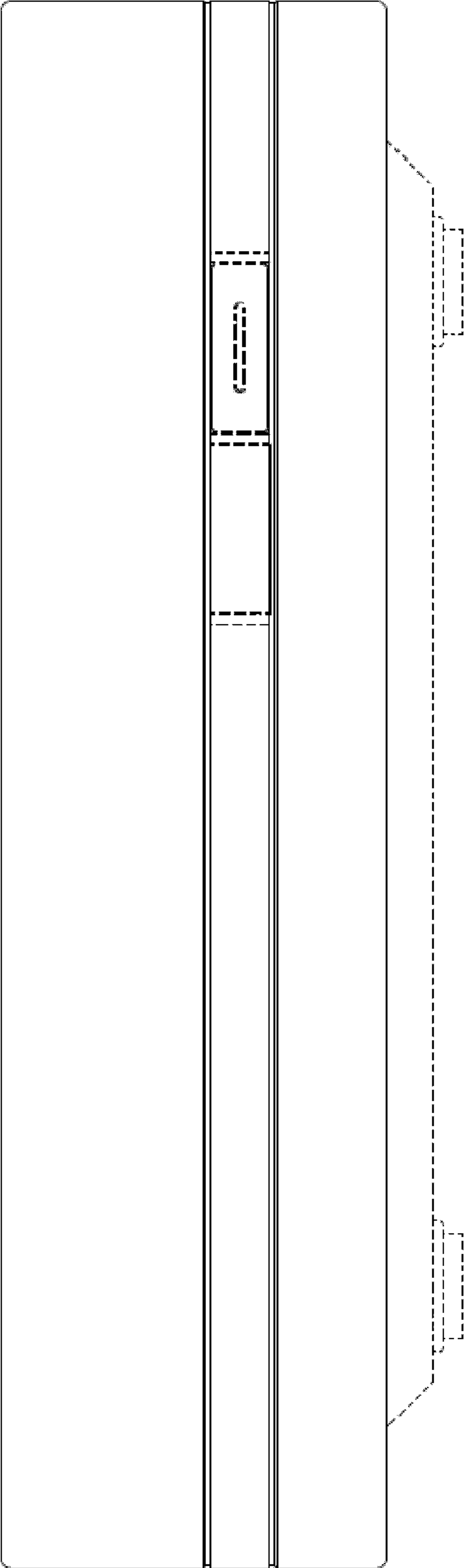

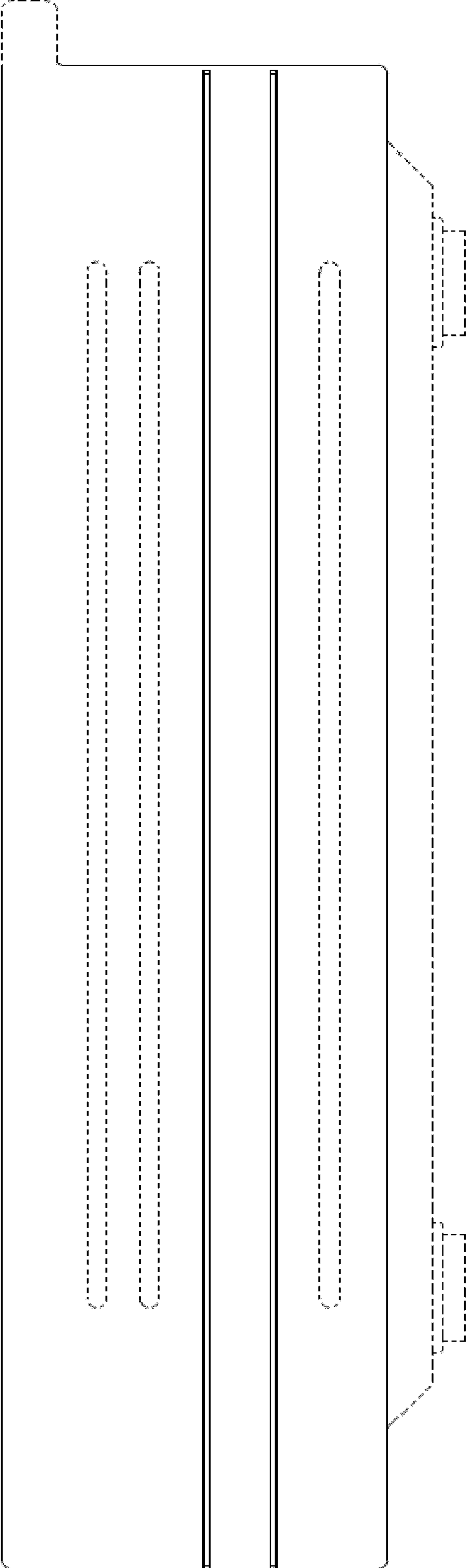

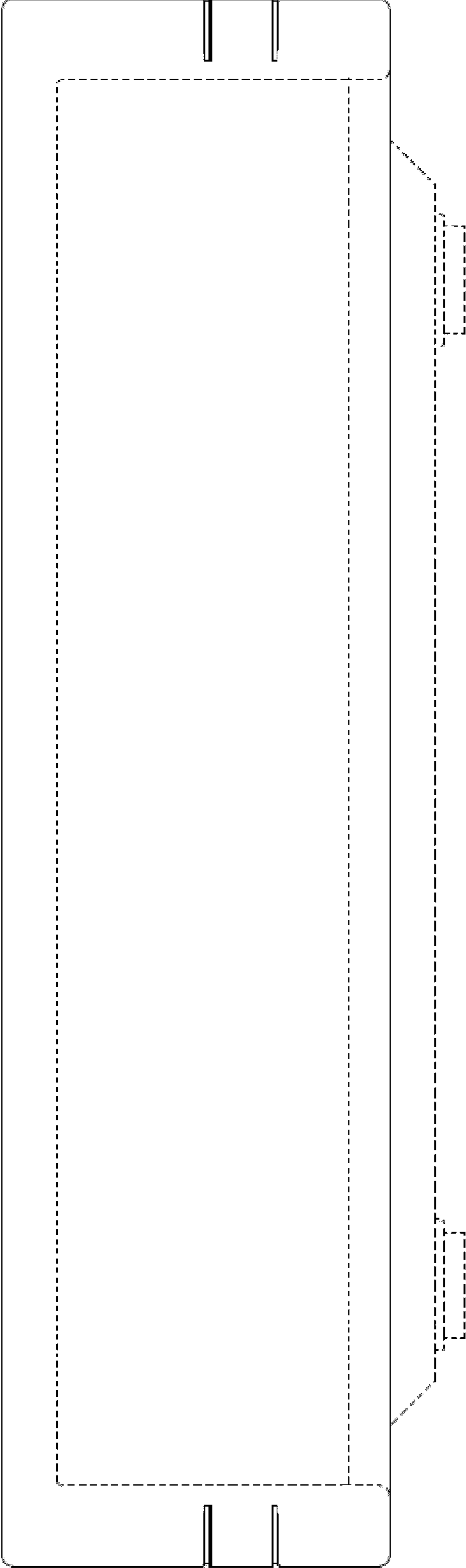
