(57) **CLAIM**

We claim, the ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a television receiver showing our new design;
FIG. 2 is a front elevation view of thereof;
FIG. 3 is a rear elevation view of thereof;
FIG. 4 is a side elevation view of thereof;
FIG. 5 is another side elevation view of thereof;
FIG. 6 is a top plan view of thereof;
FIG. 7 is a bottom plan view of thereof; and,
FIG. 8 is a rear perspective view thereof.
The broken lines illustrating portions of the television receiver are for environmental purpose only and form no part of the claimed design.
The shade lines in the figures show contour and not surface ornamentation.

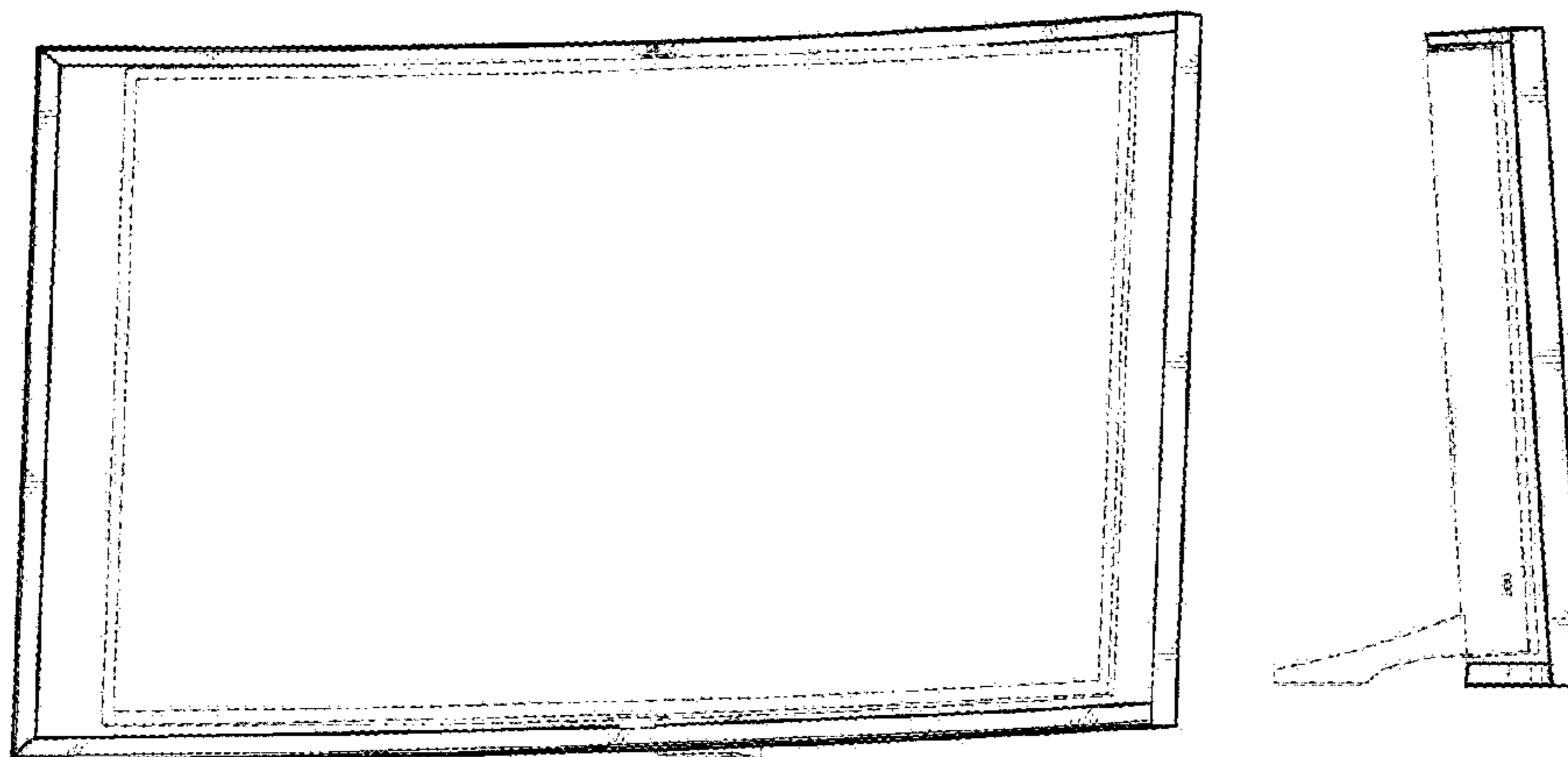

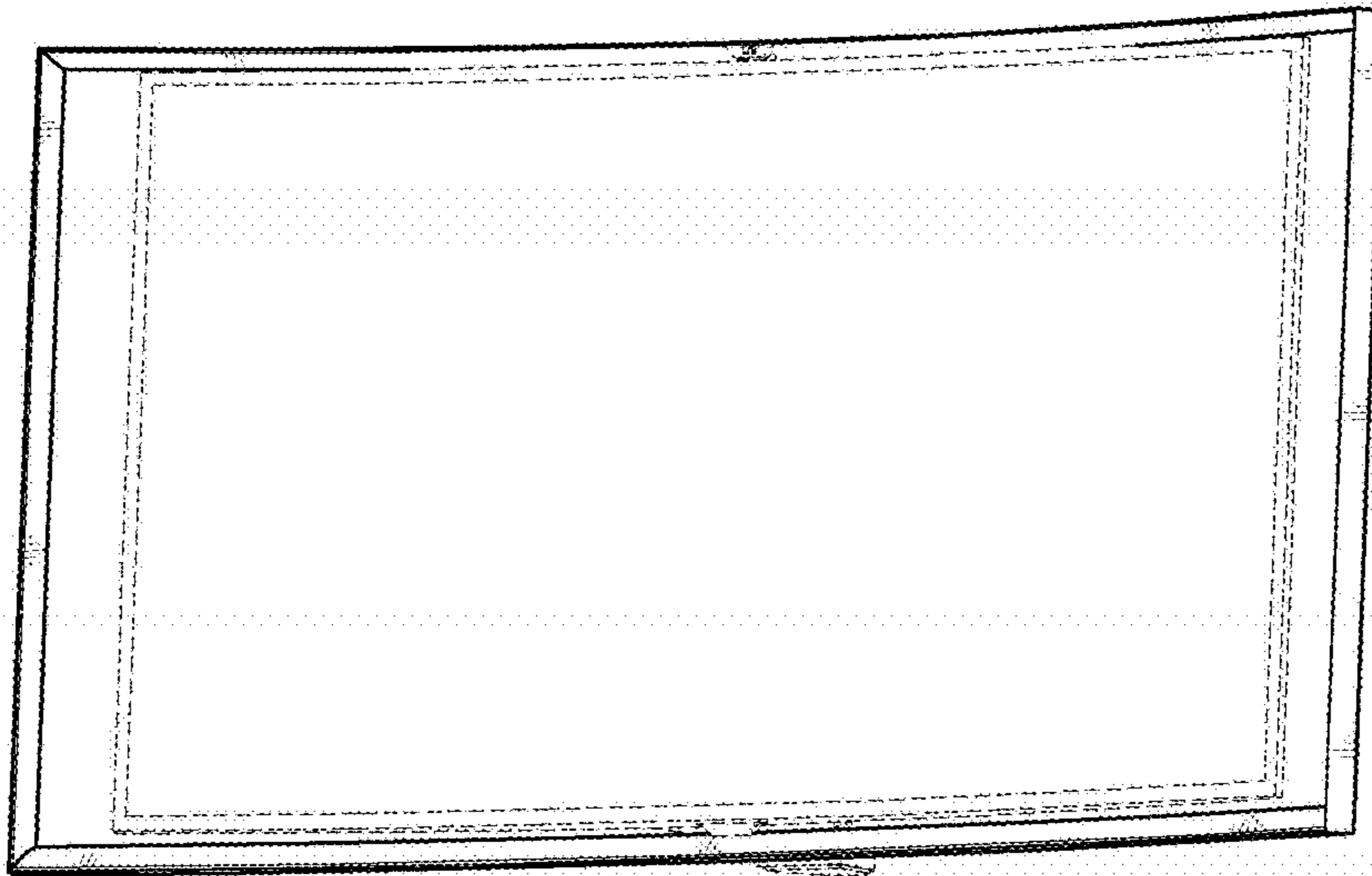

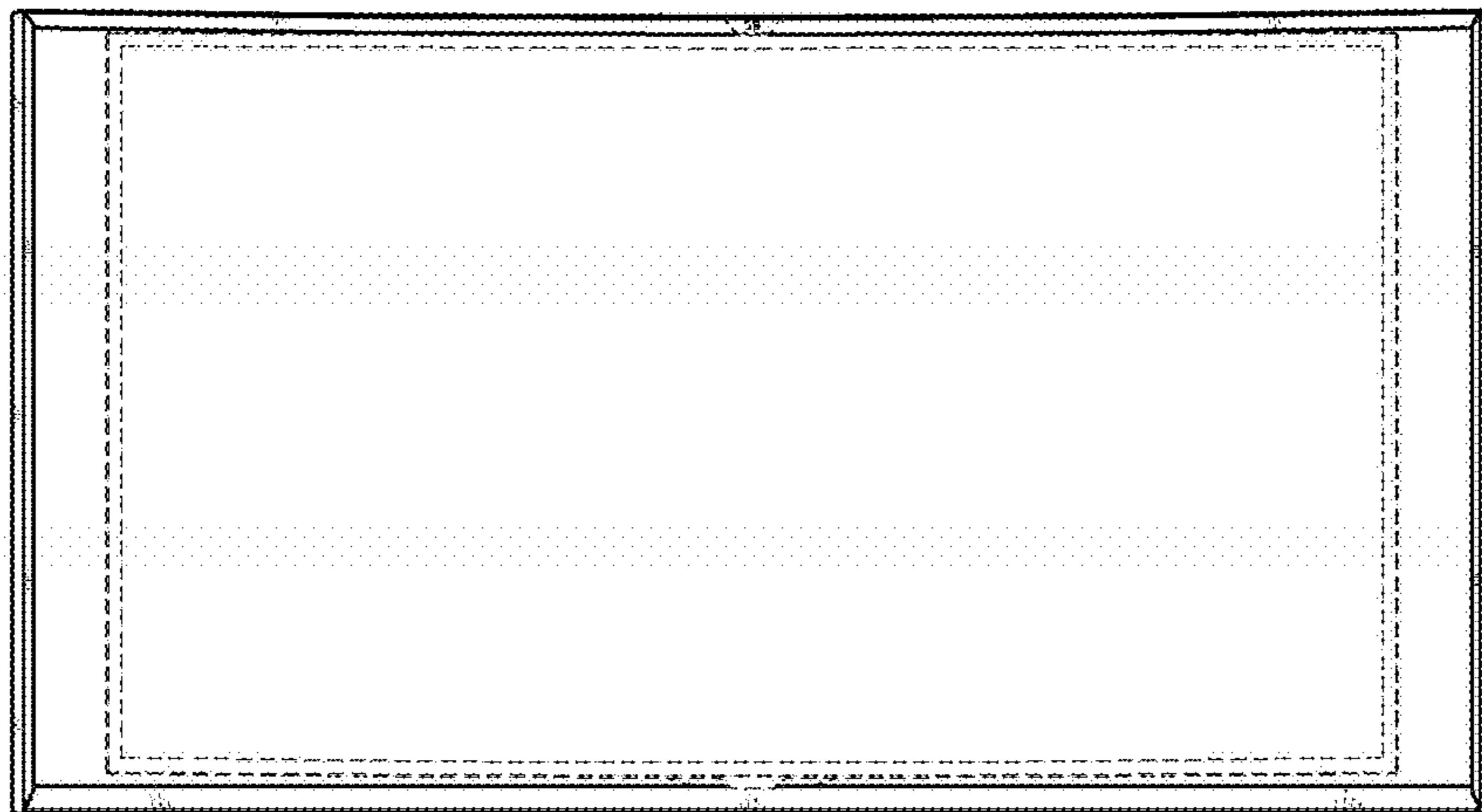

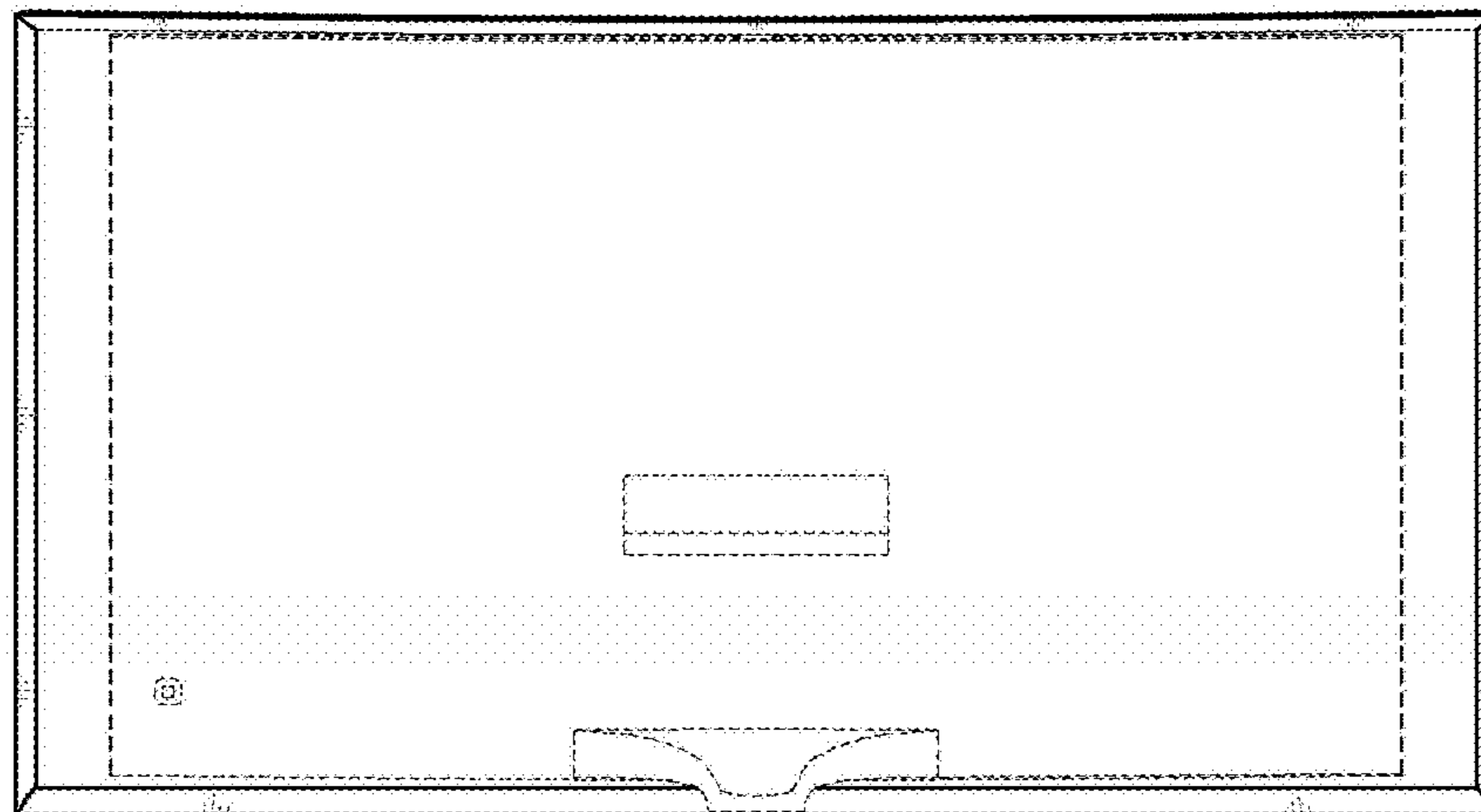

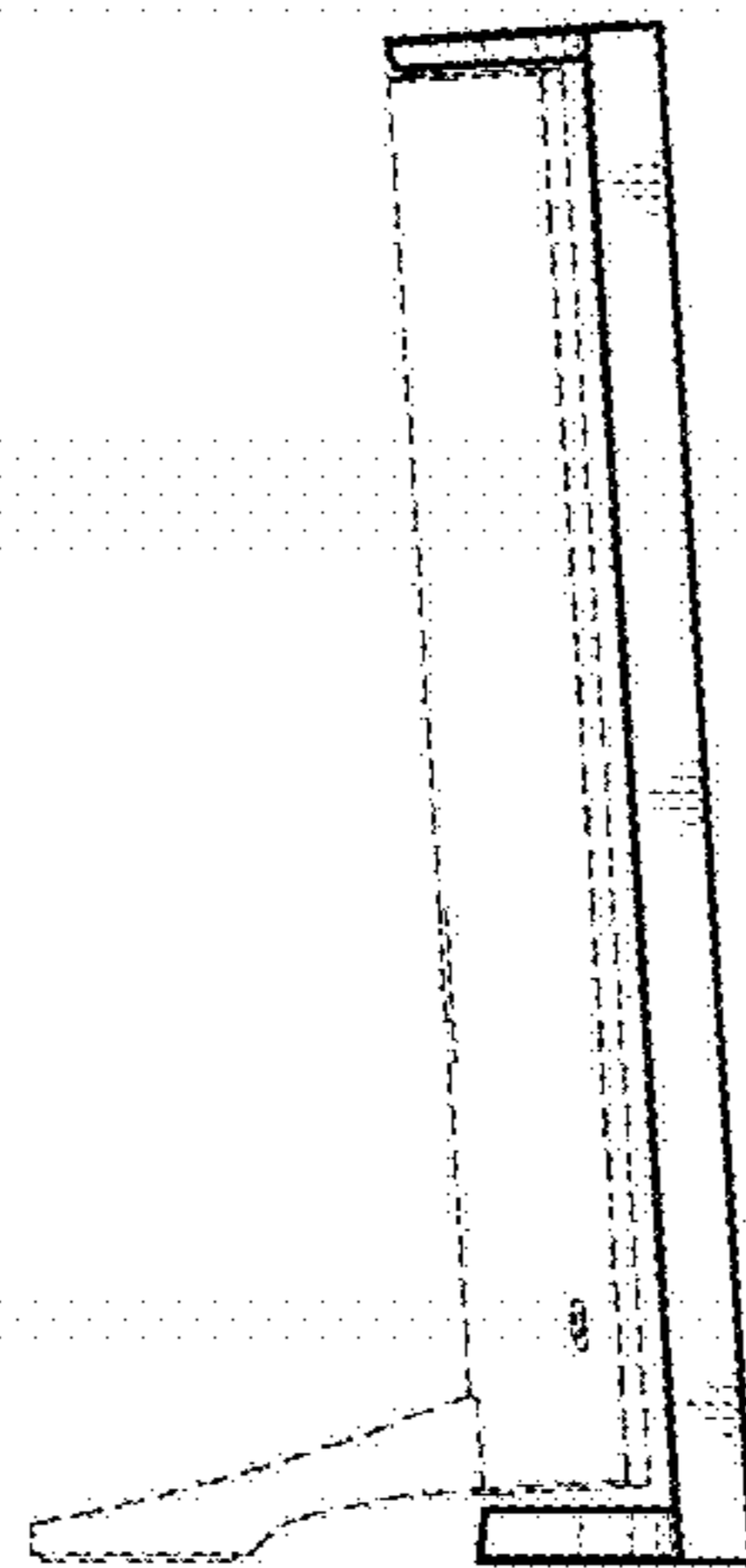

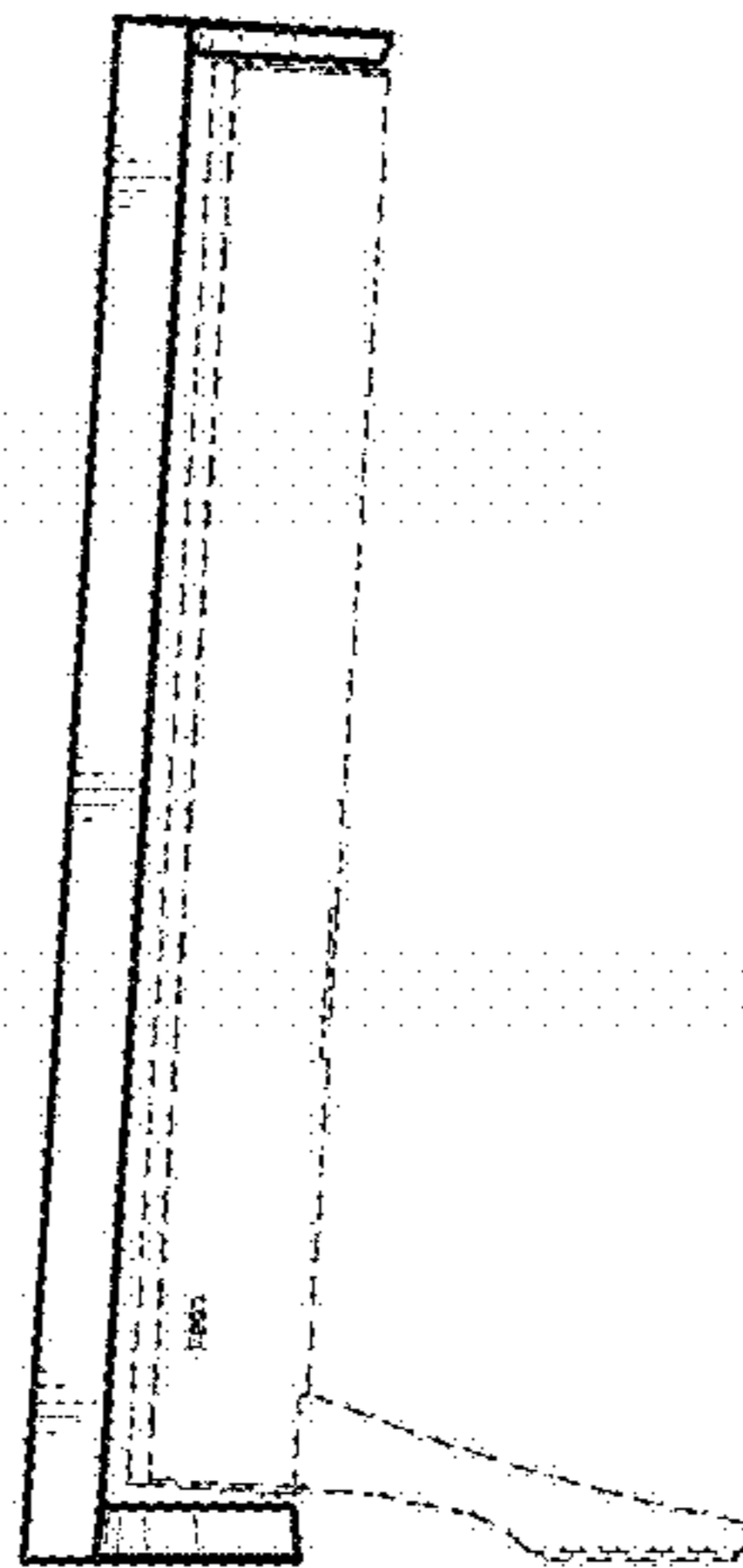

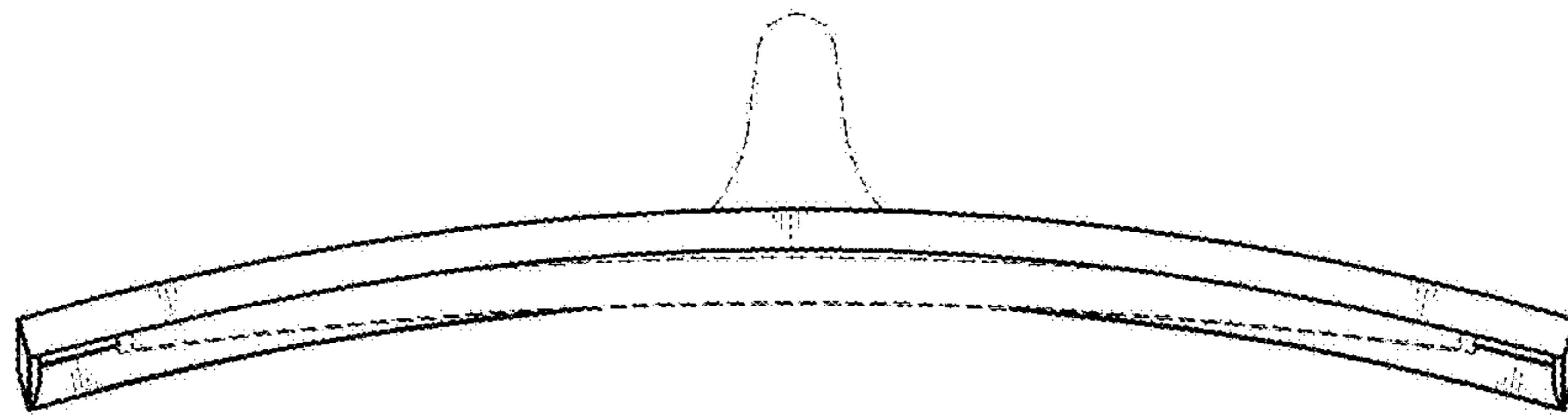

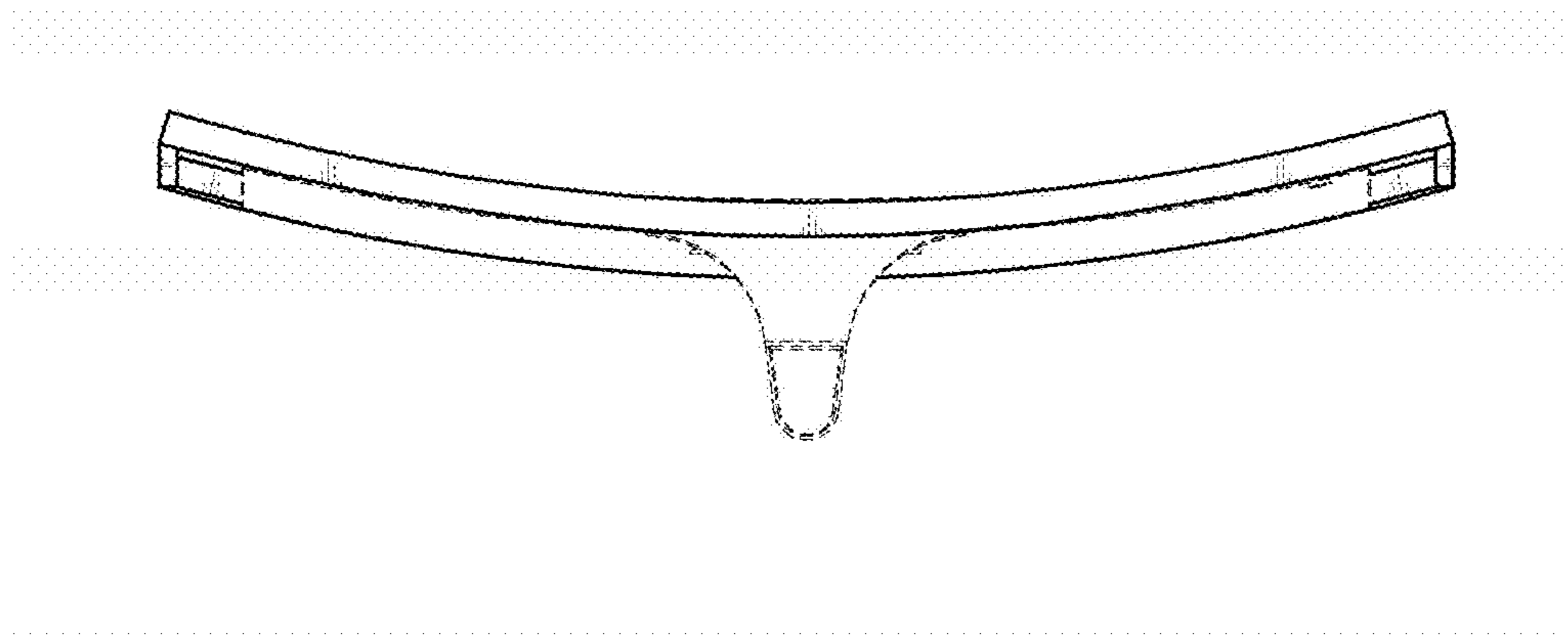
