The ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electronic device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view of the portion A encircled in FIG. 7; and,
FIG. 9 is a cross-sectional view taken through line B-B of FIG. 8.

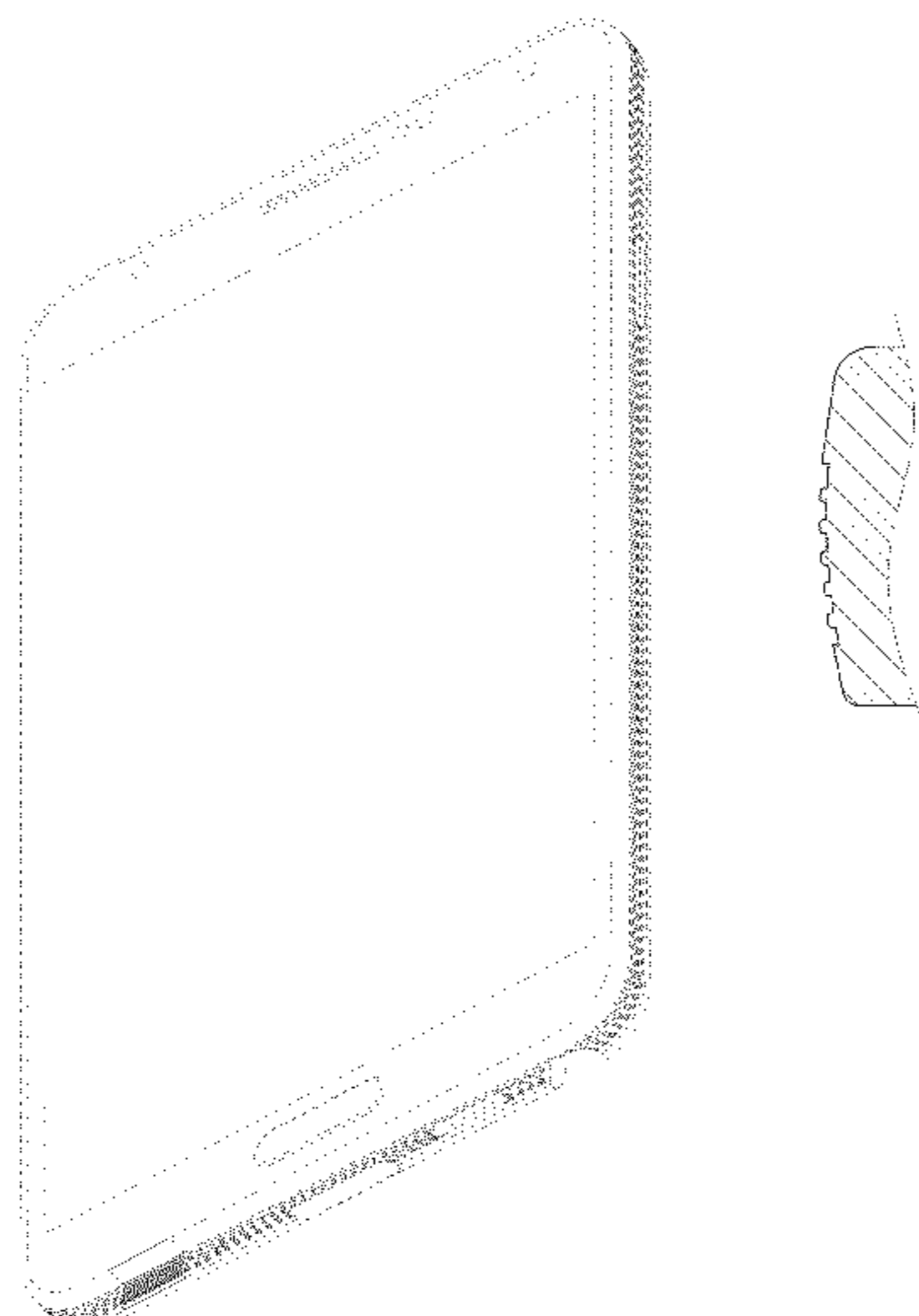

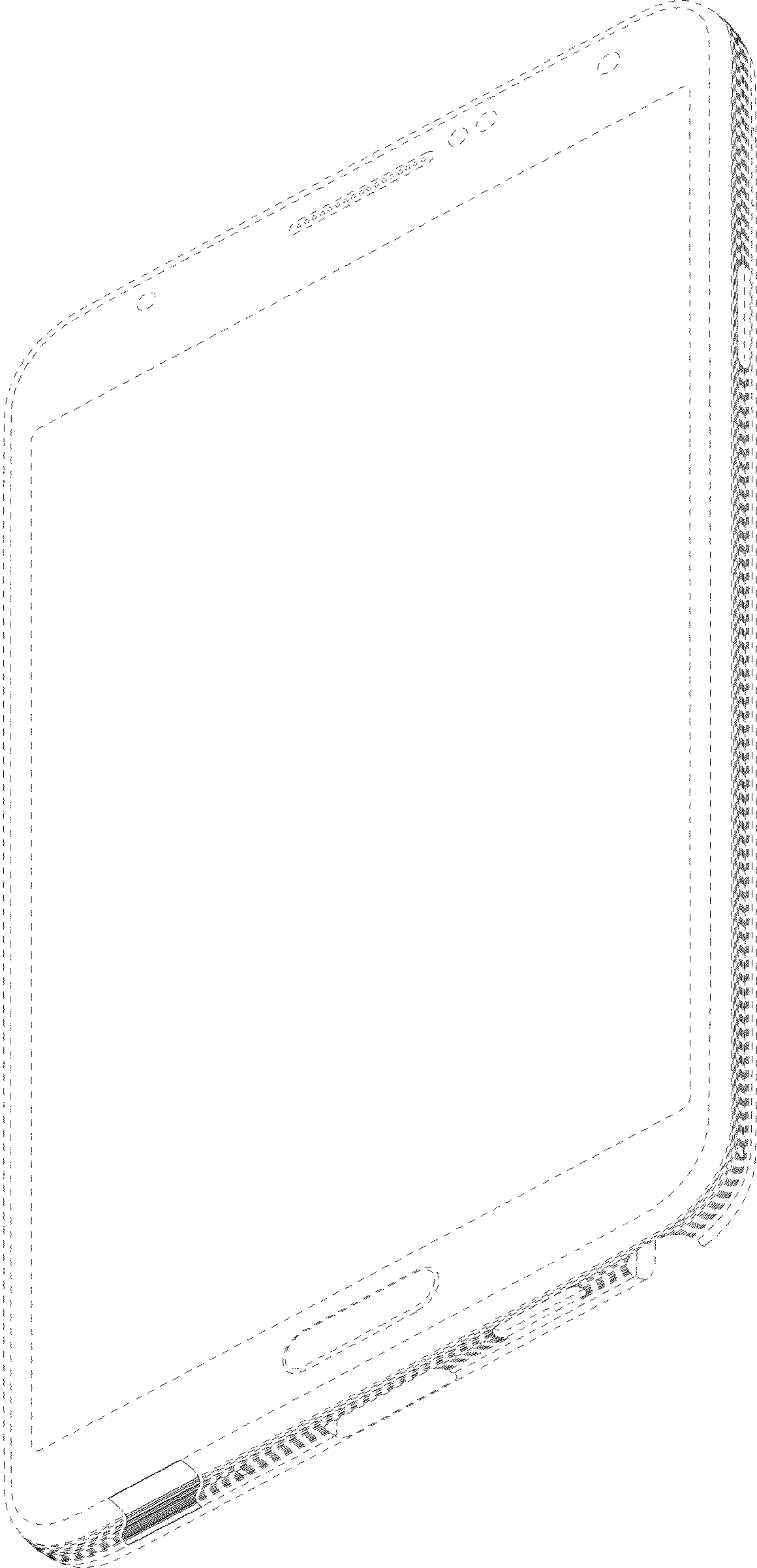

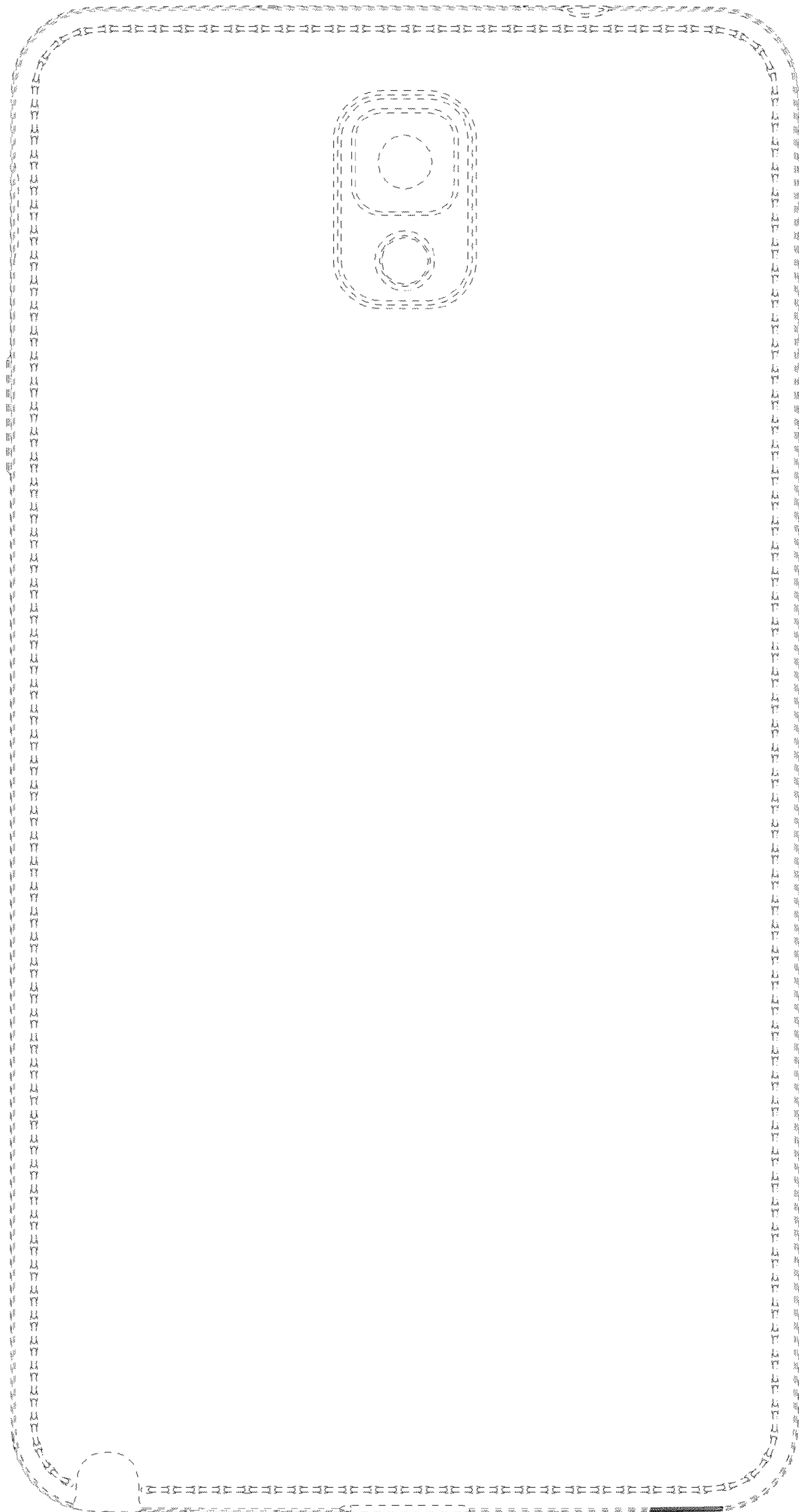

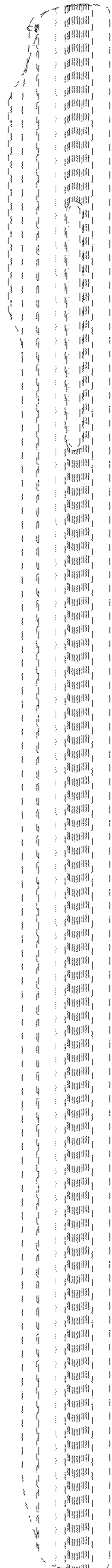

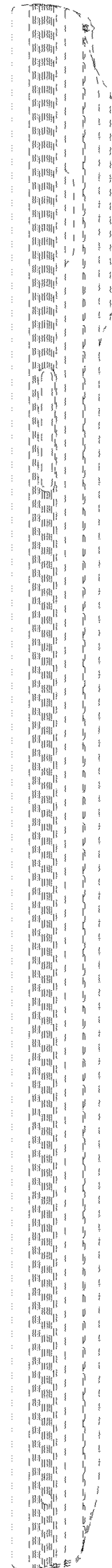

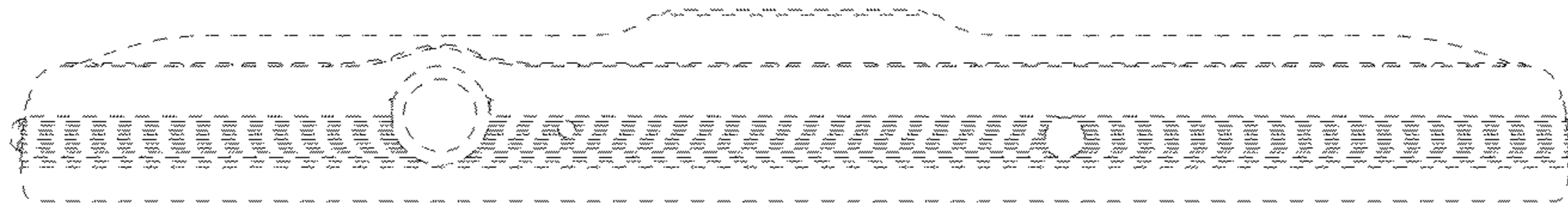

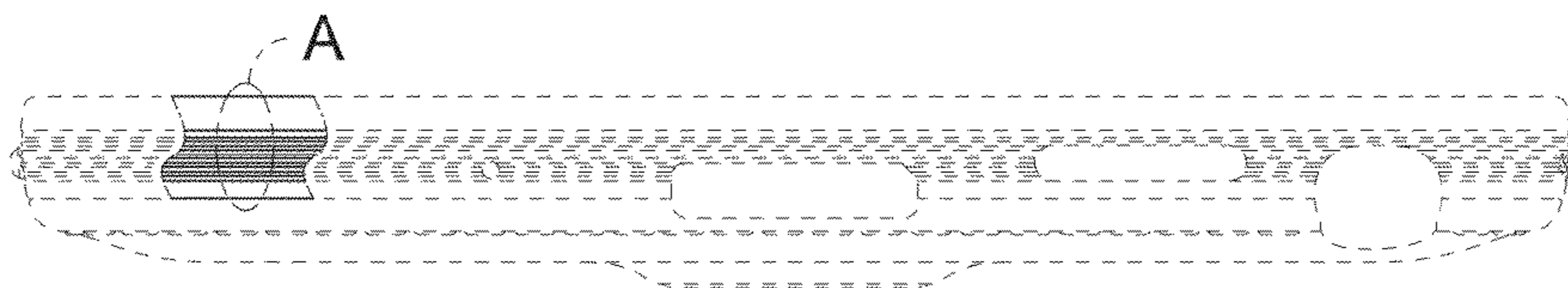

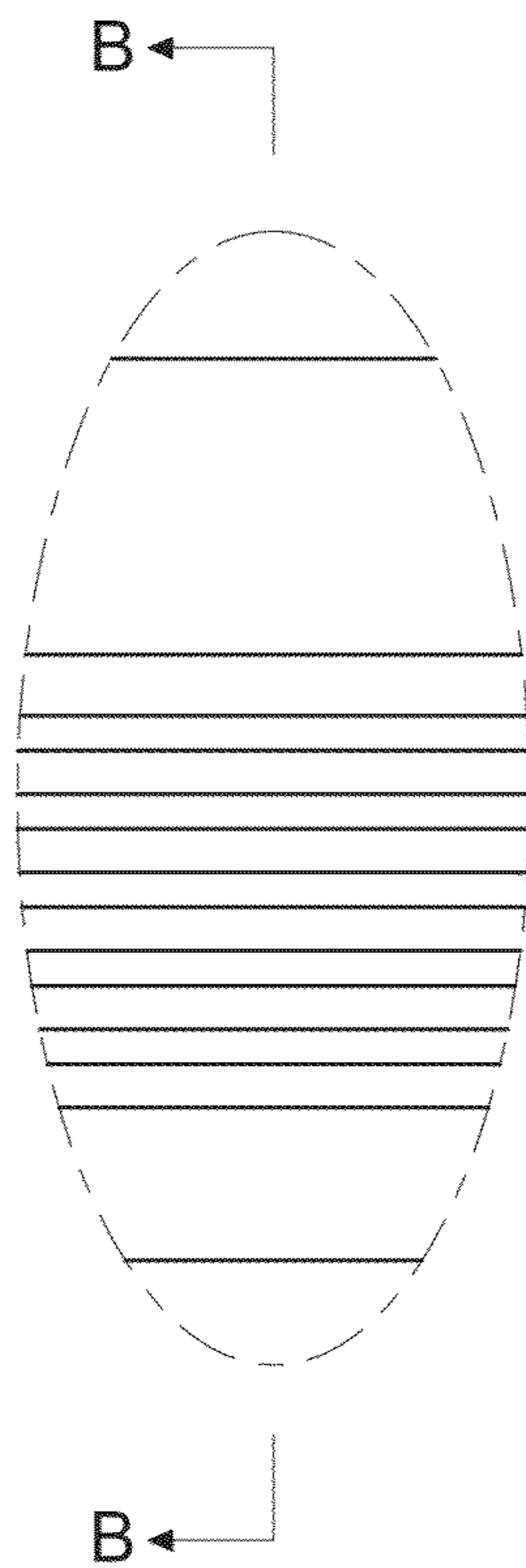
