FIG. 10 is a right side elevation view thereof.

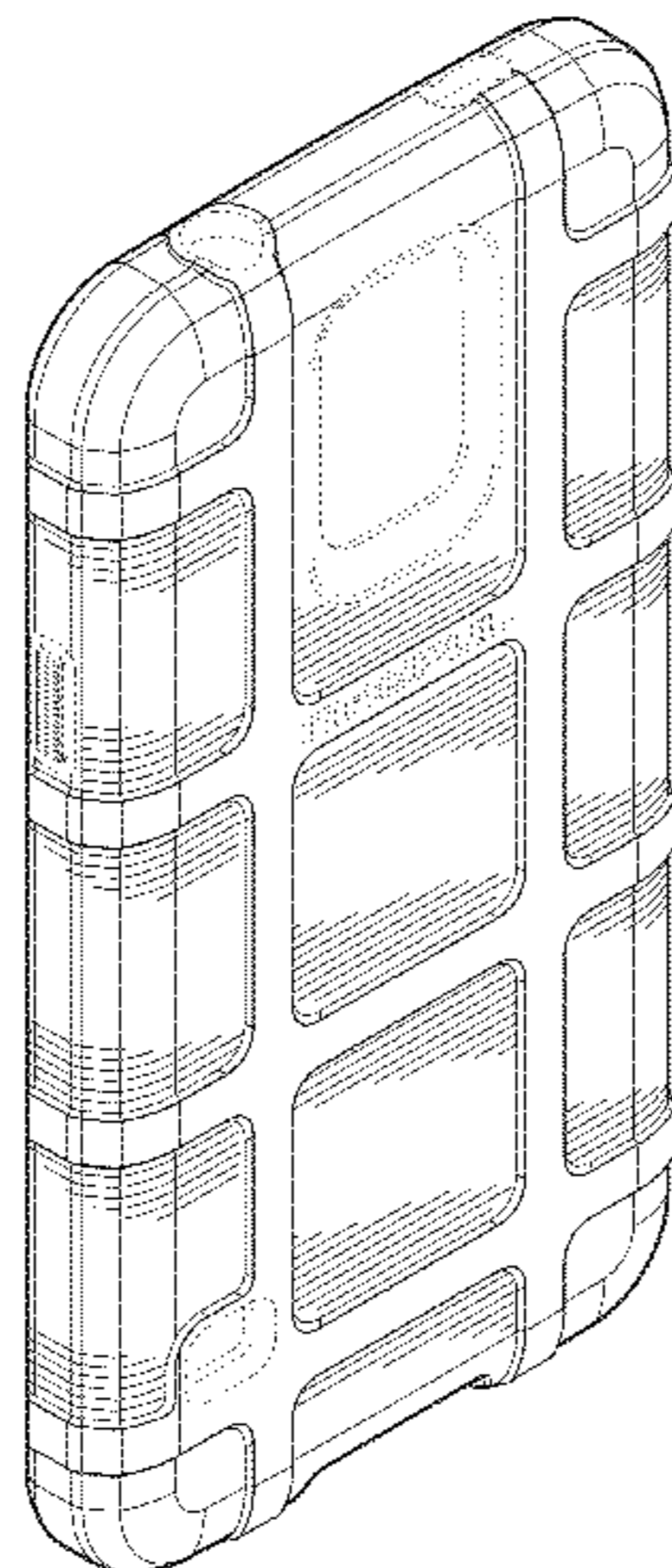
The broken lines immediately adjacent the claimed surfaces

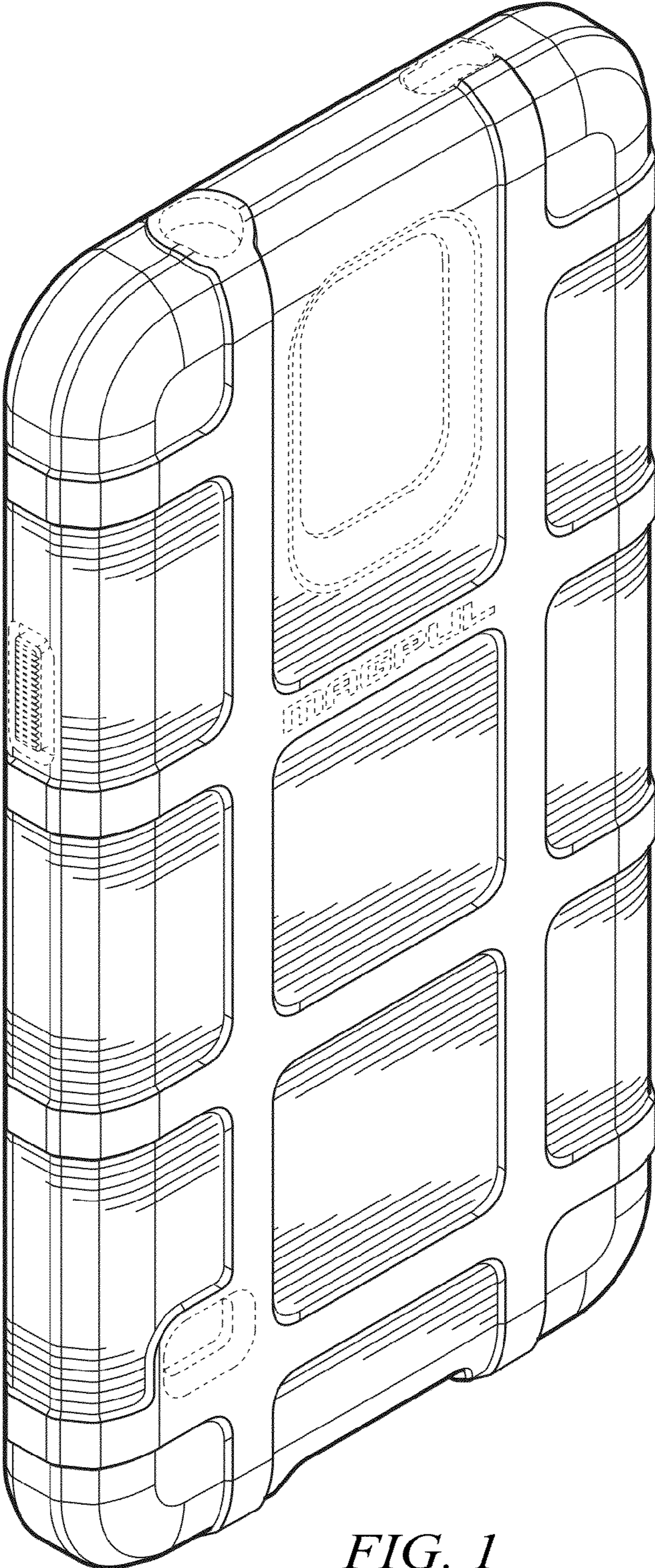

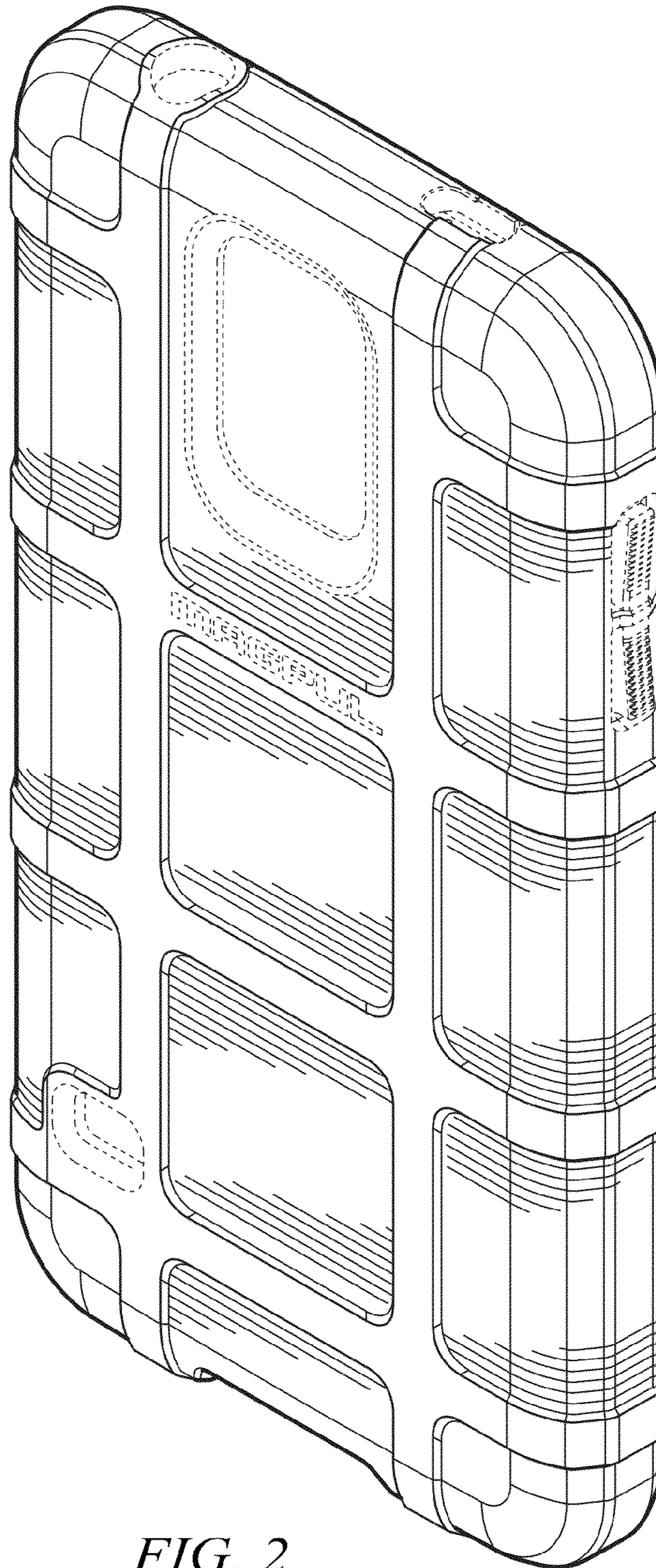
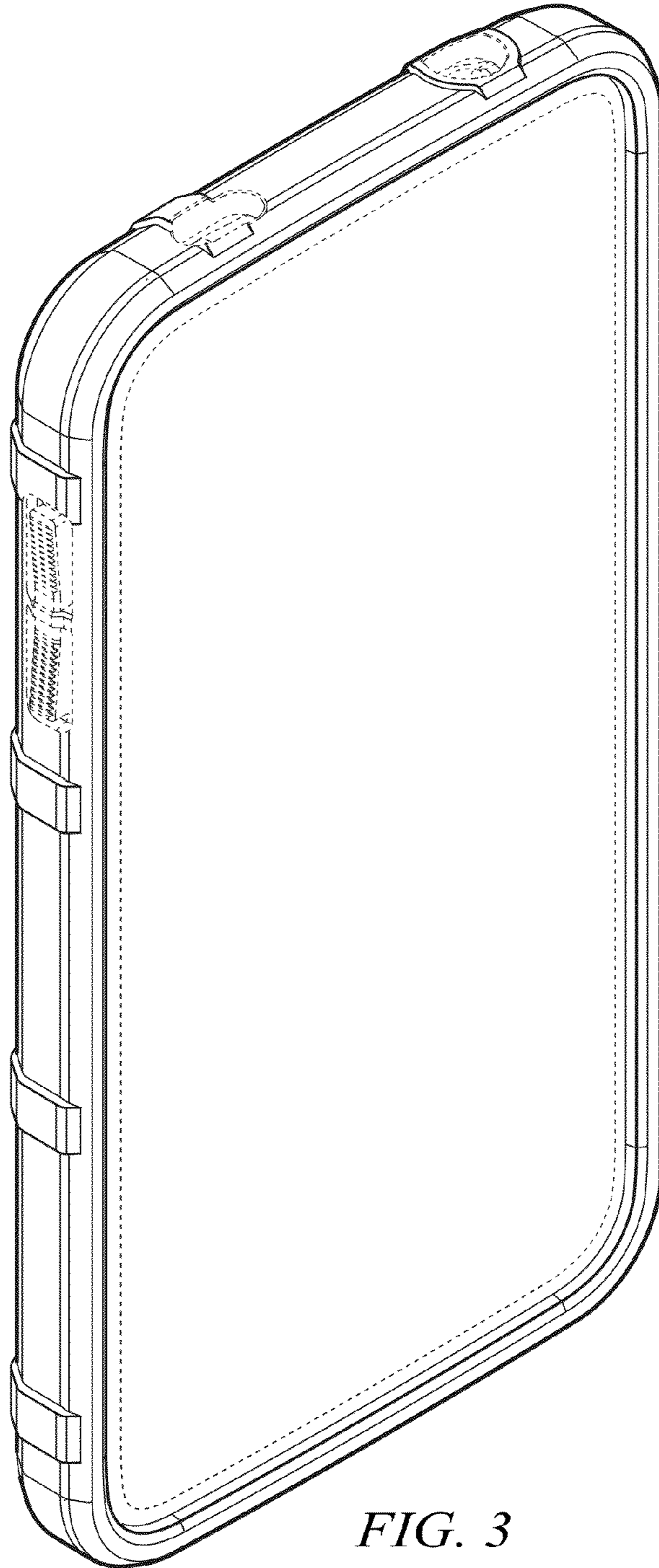

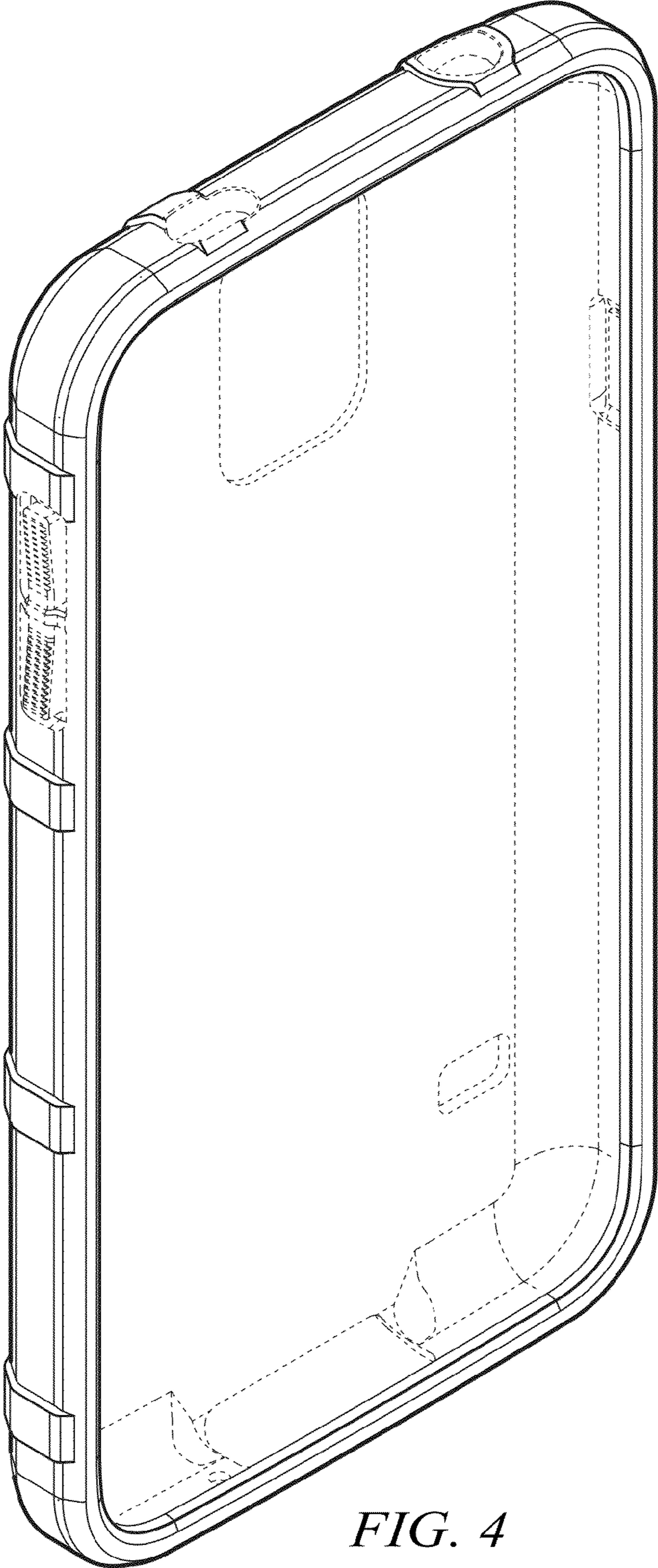

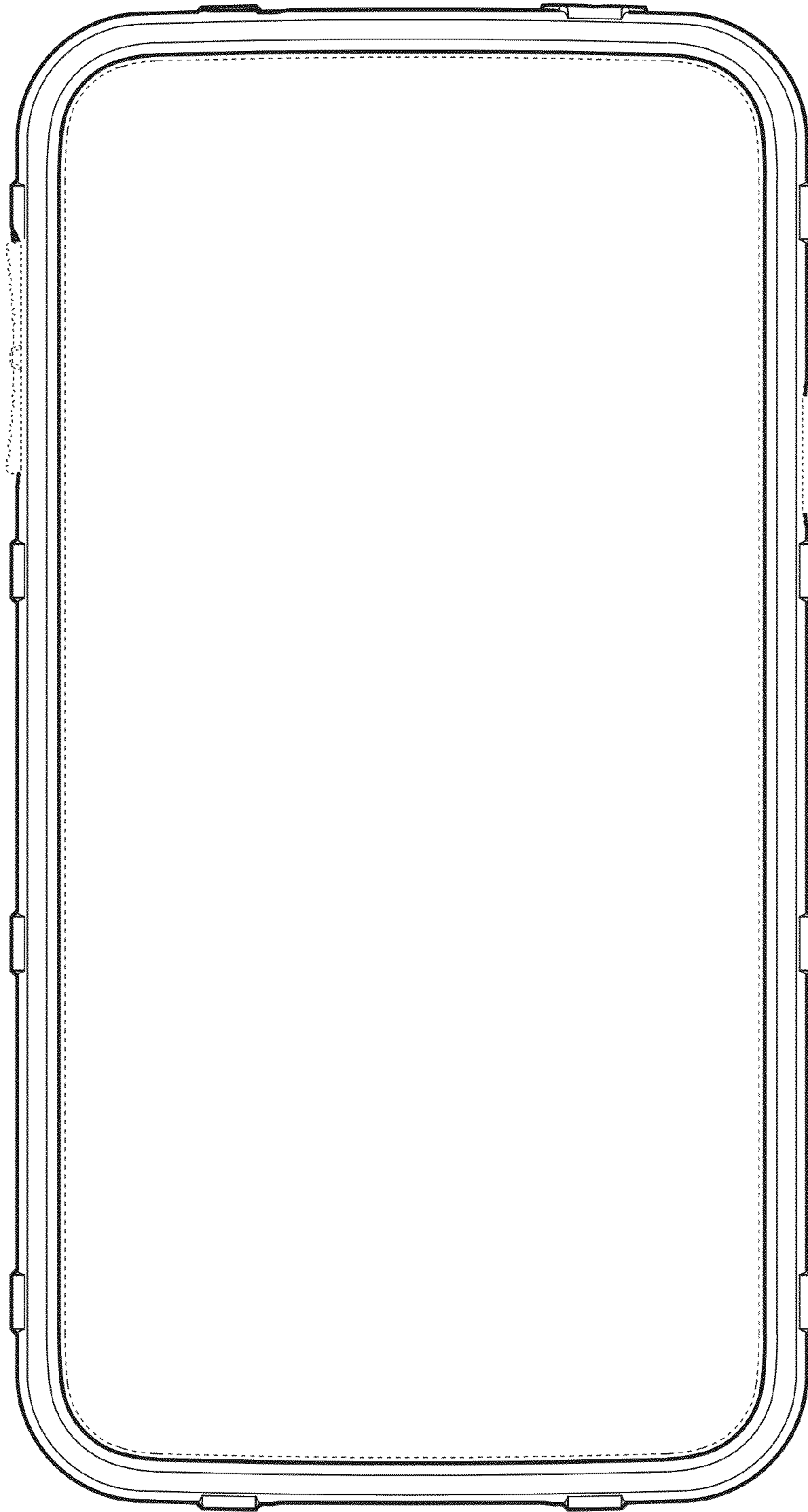

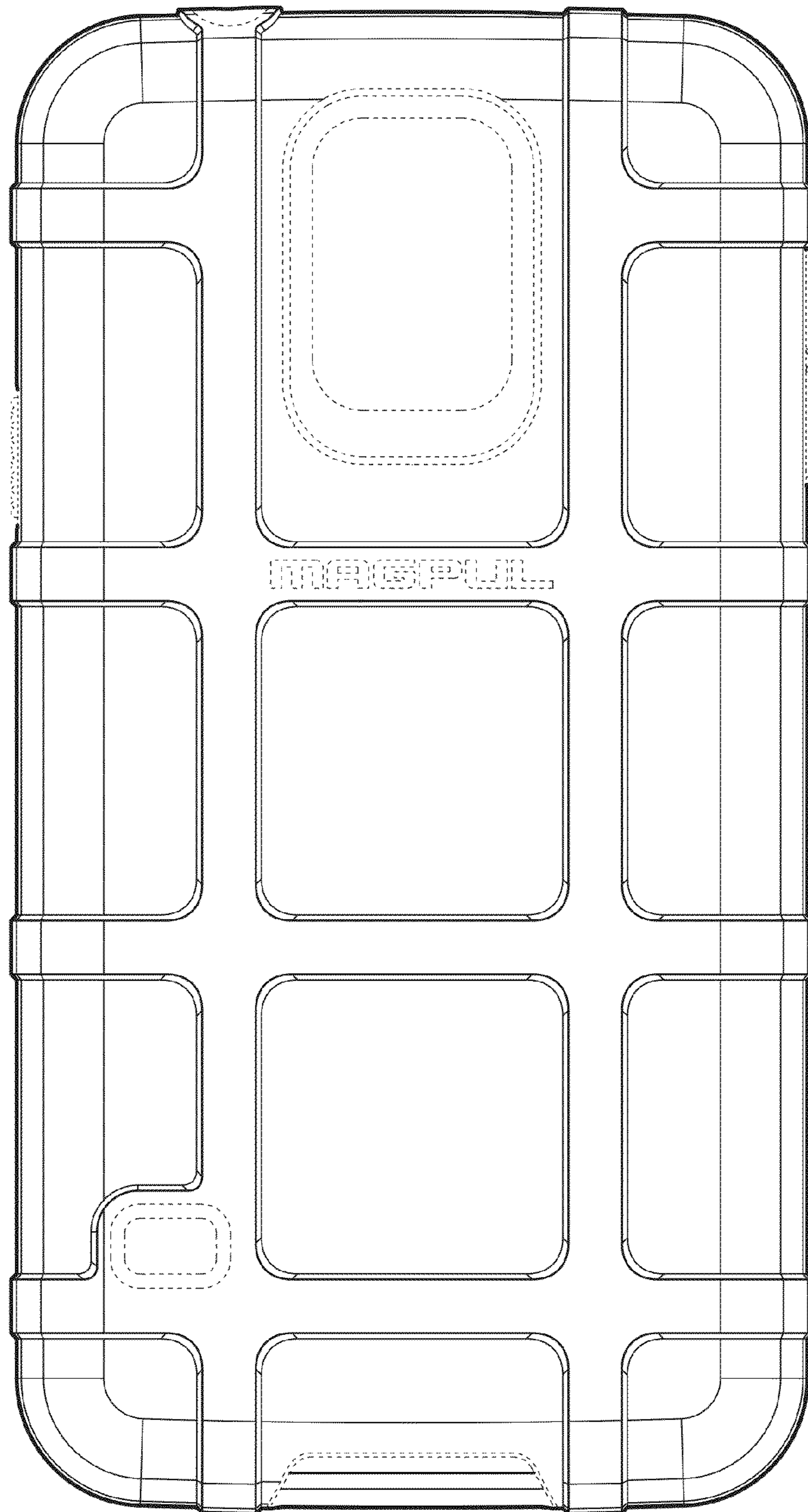

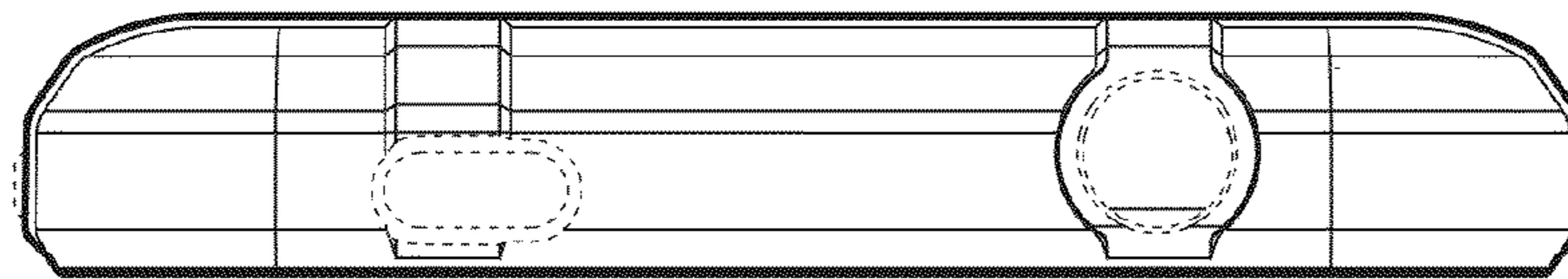

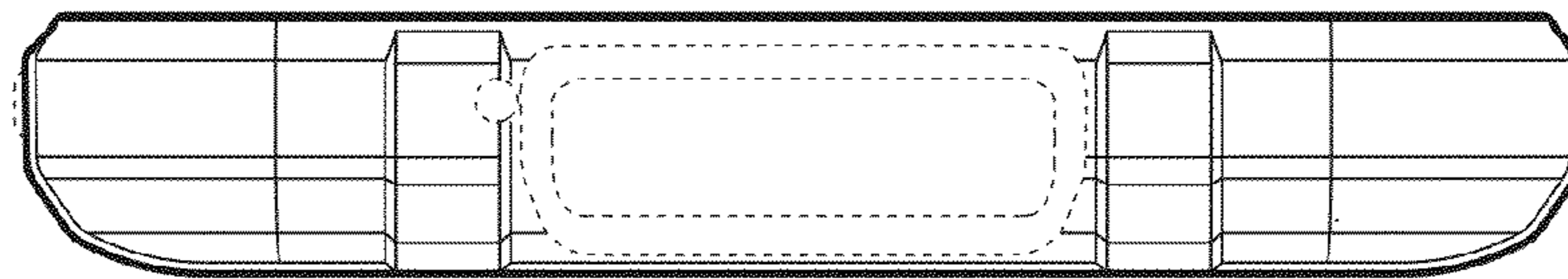

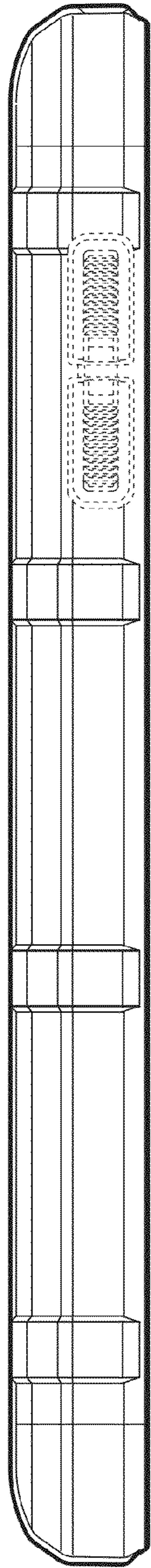

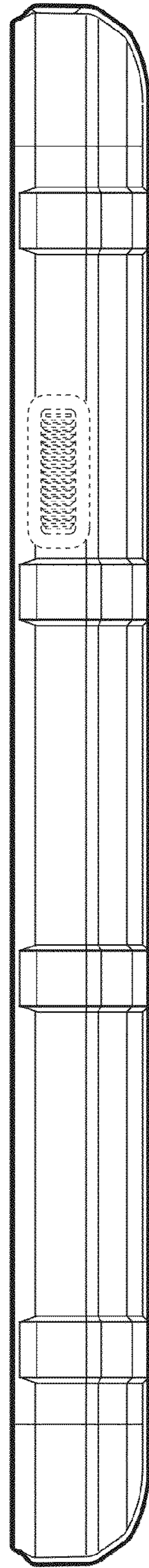
