(57) **CLAIM**

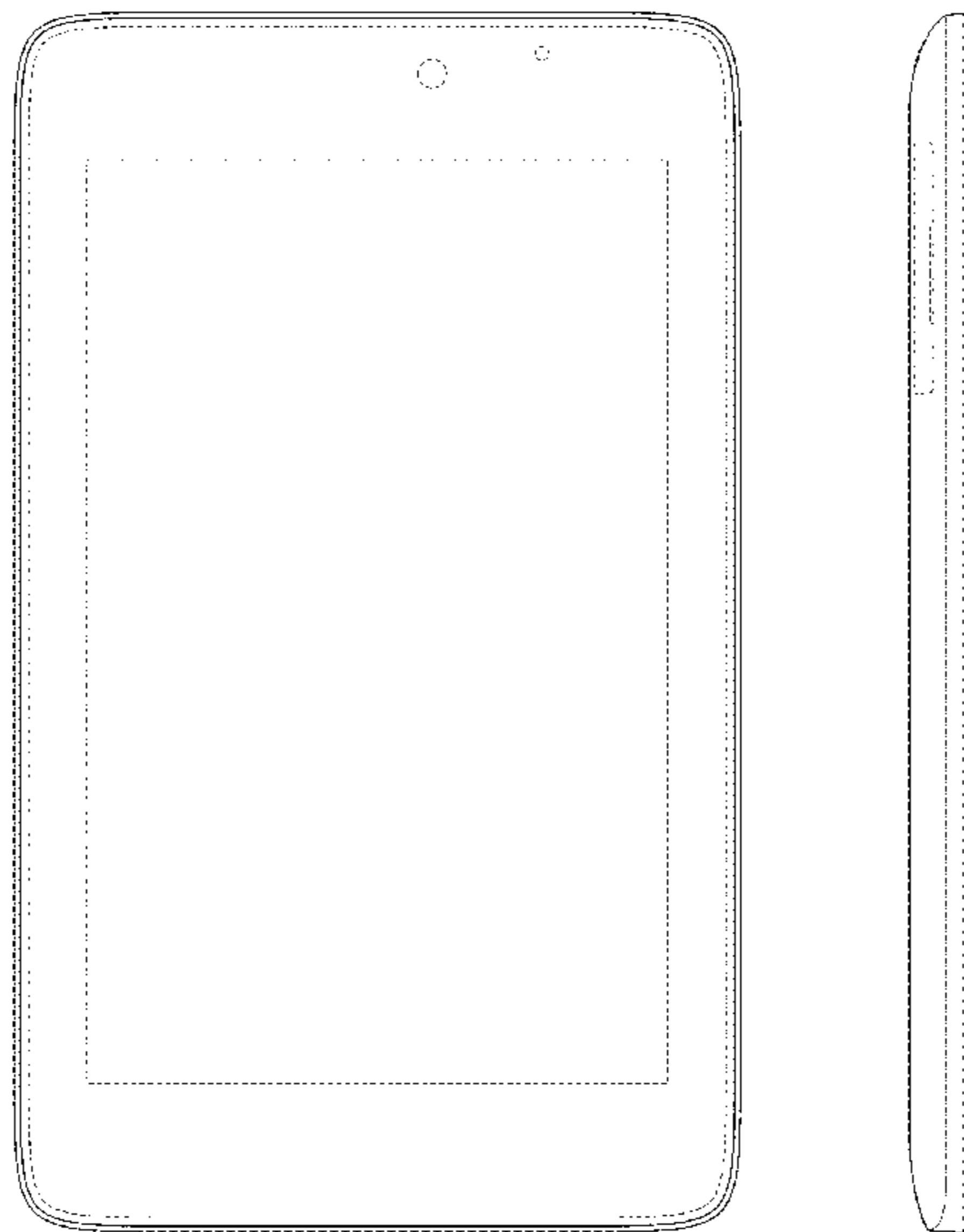
We claim the ornamental design for a tablet computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a tablet computer showing the new design;

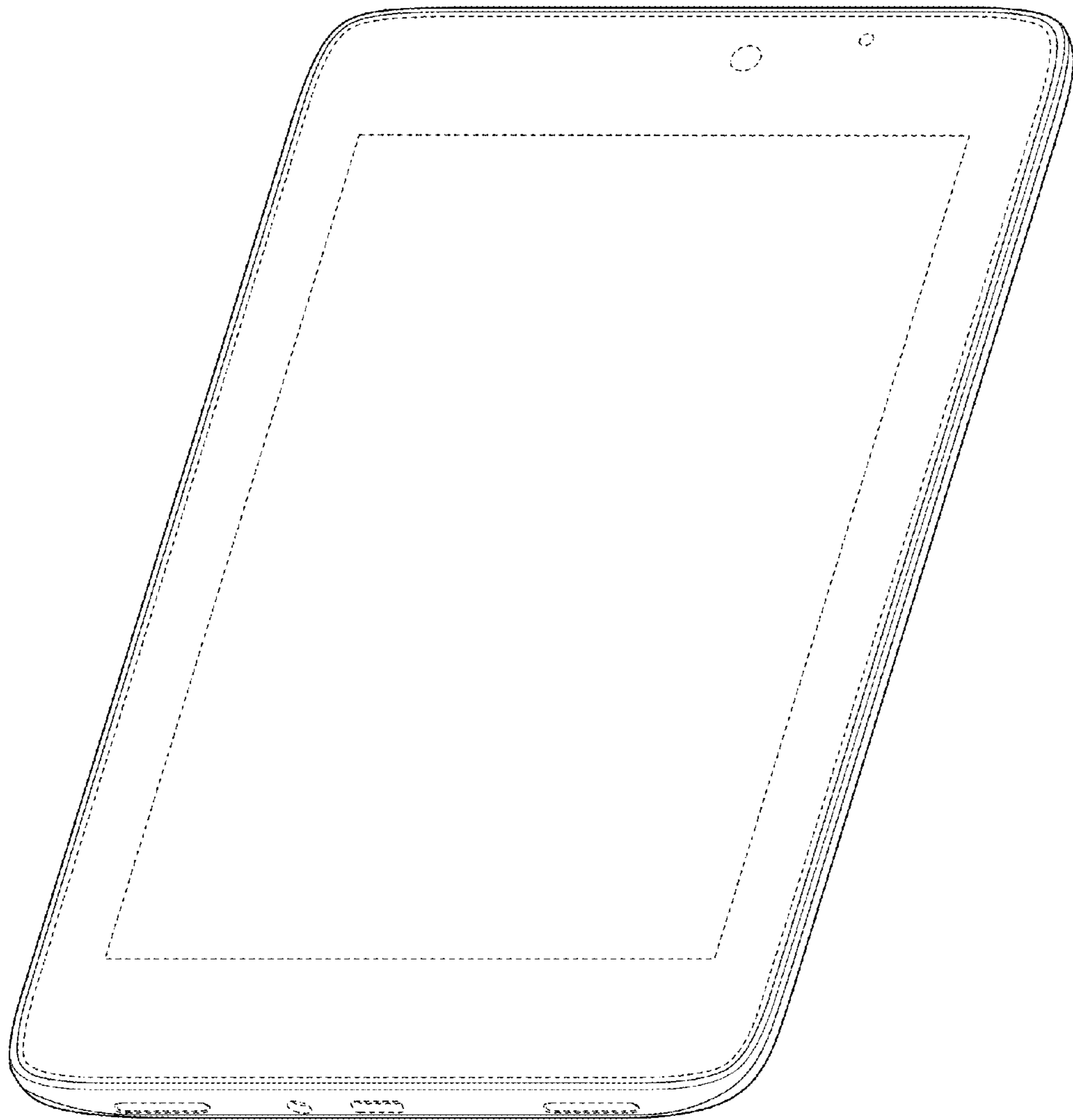

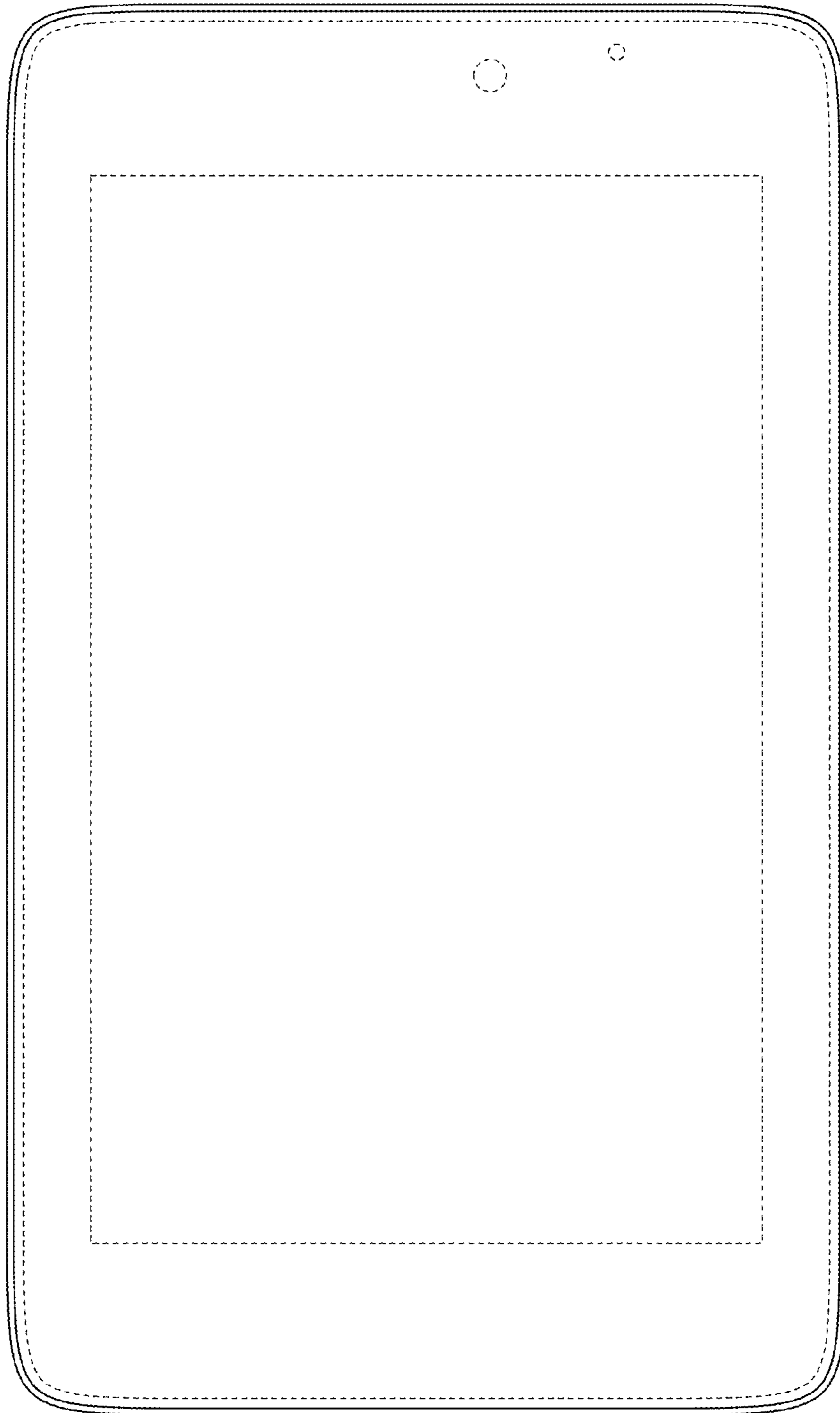
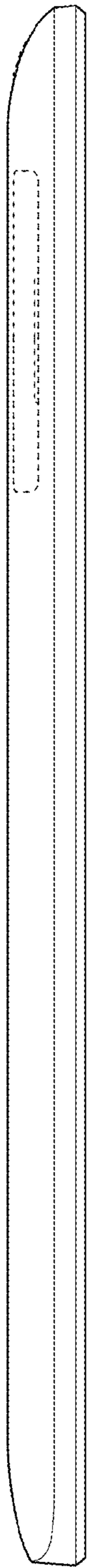
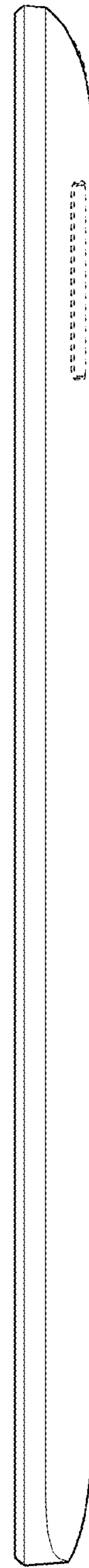


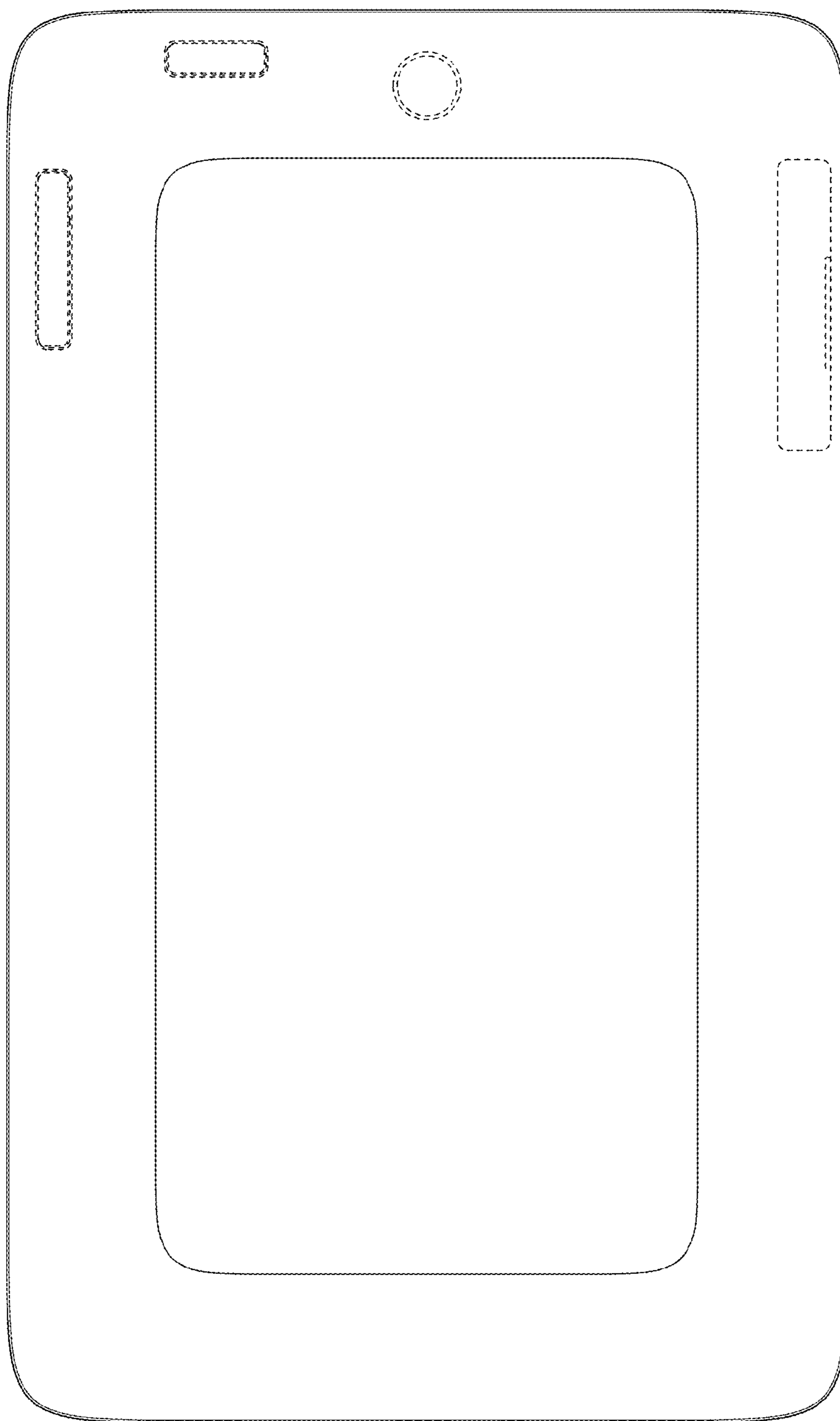

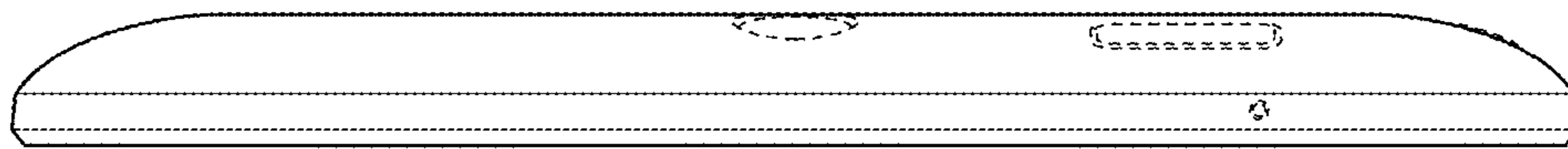

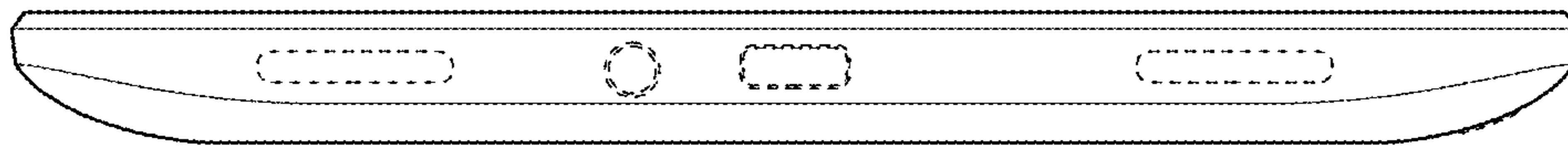
