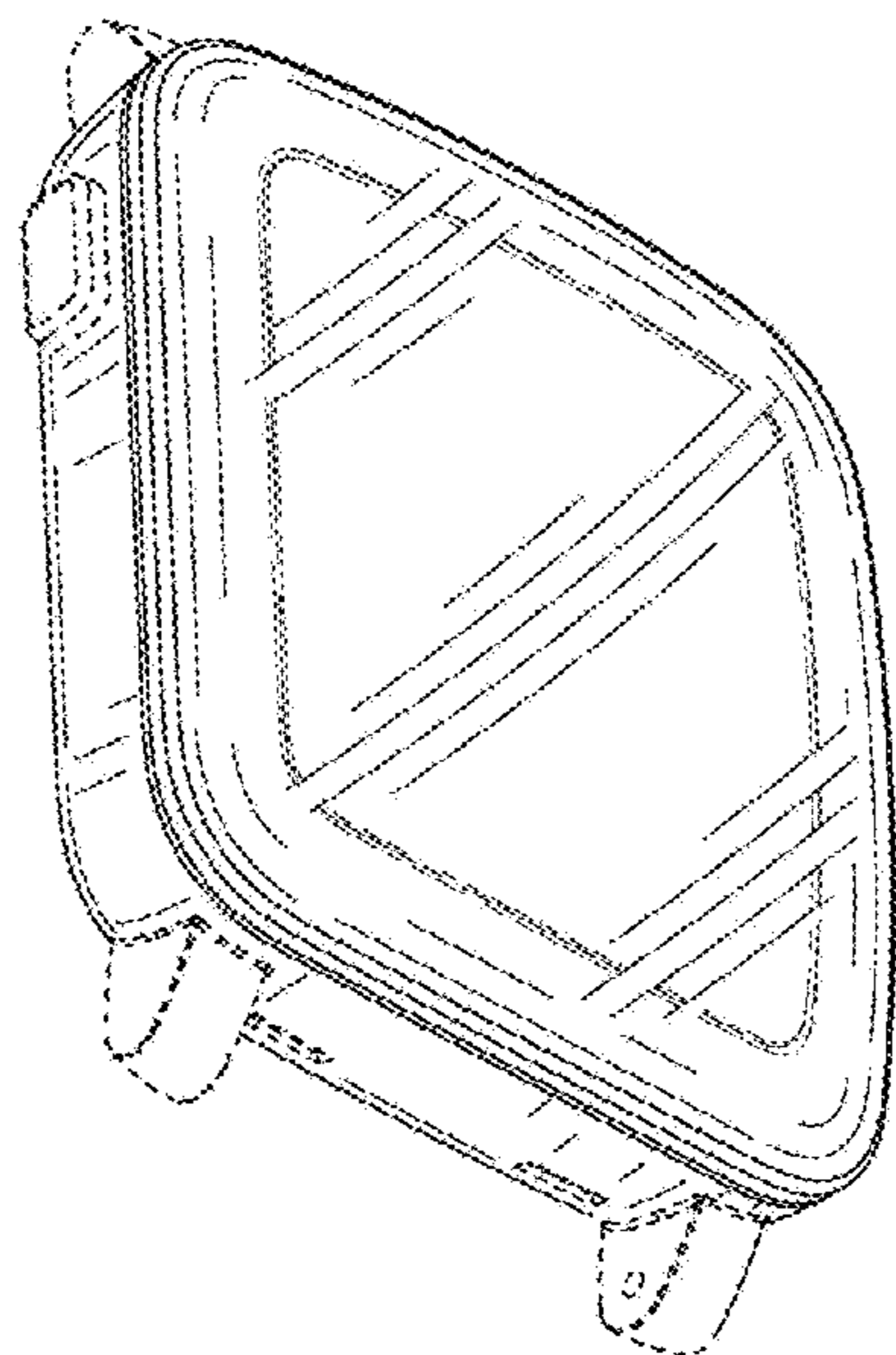
(57) **CLAIM**

The ornamental design for a watch body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing a front, a bottom, and a right side of a watch body according to our new design; FIG. 2 is a perspective view showing the front, the bottom, and a left side of the watch body; FIG. 3 is an elevational view of the front of the watch body; FIG. 4 is an elevational view of a back of the watch body; FIG. 5 is a perspective view showing the back, the bottom, and the left side of the watch body; FIG. 6 is a perspective view showing the back, the bottom, and the right side of the watch body; FIG. 7 is an elevational view of the right side of the watch body; FIG. 8 is an elevational view of the left side of the watch body; FIG. 9 is a plan view of the top of the watch body; FIG. 10 is a plan view of the bottom of the watch body; FIG. 11 is a perspective view showing the front, the bottom, and the right side of the watch body with a band; and, FIG. 12 is a perspective view showing the back, the bottom, and the left side of the watch body with the band. The broken line showing of portions of the watch body form no part of the claimed design. The broken line showing of the band in FIGS. 11, 12 represents environment that forms no part of the claimed design.

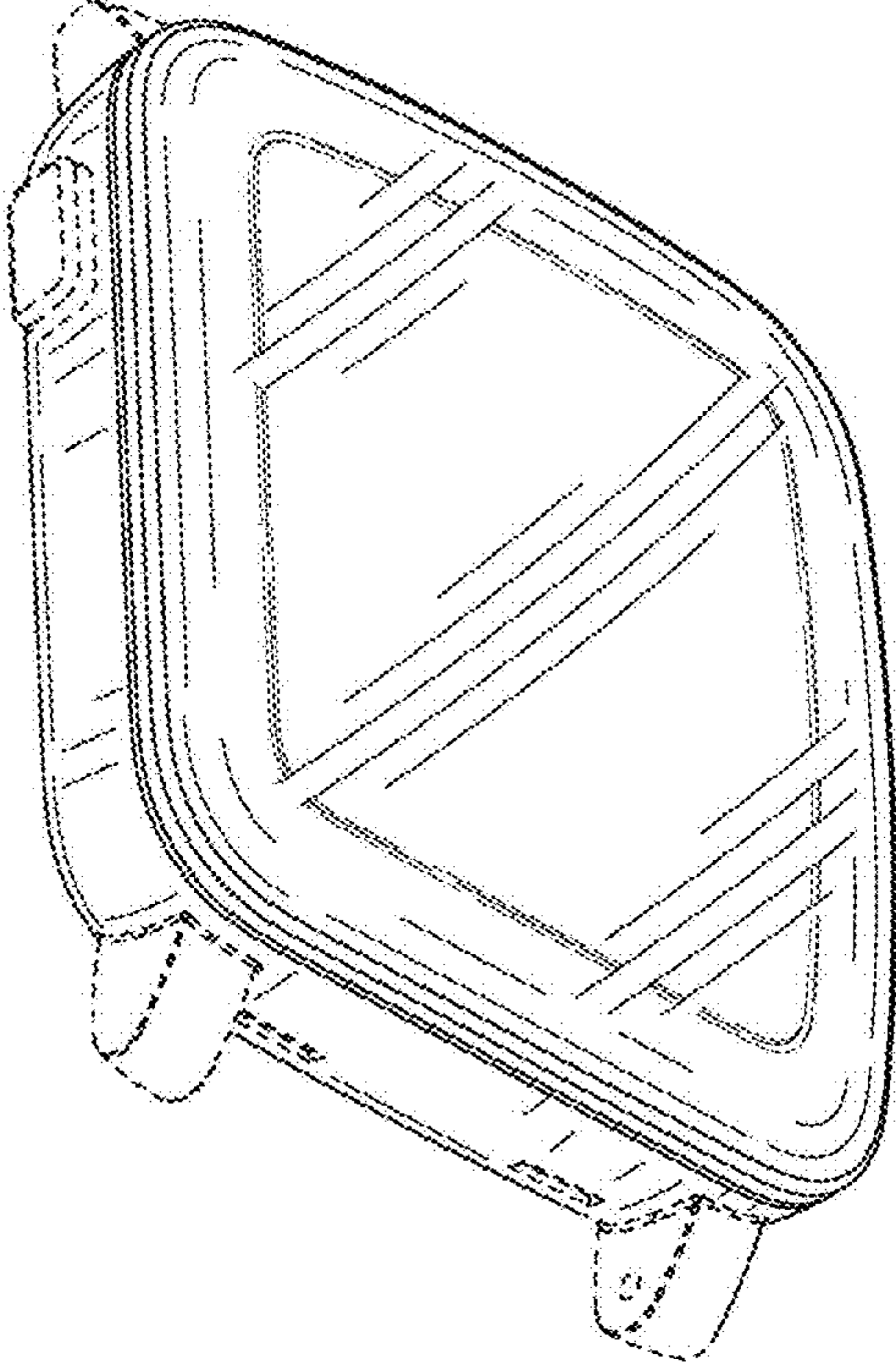

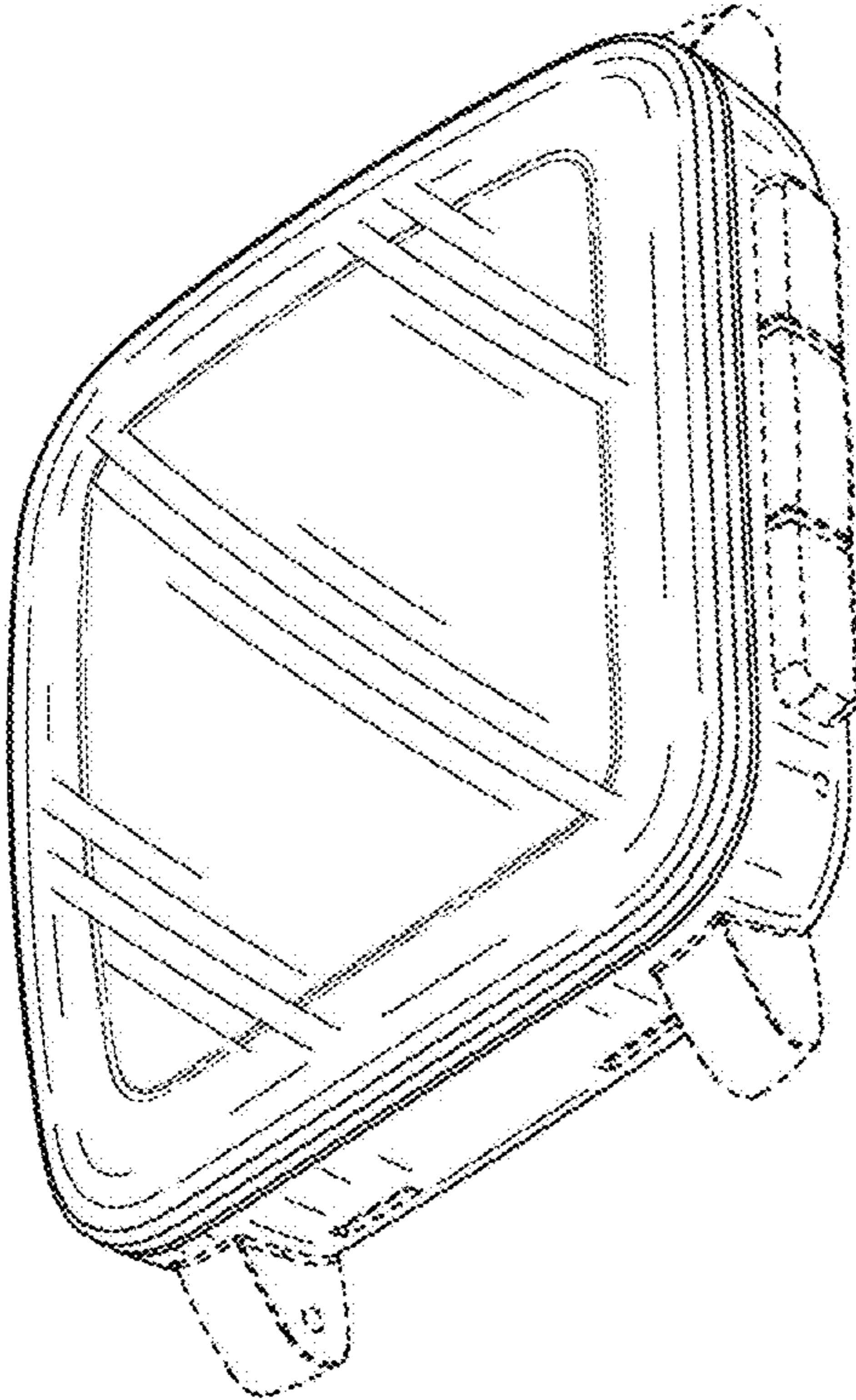

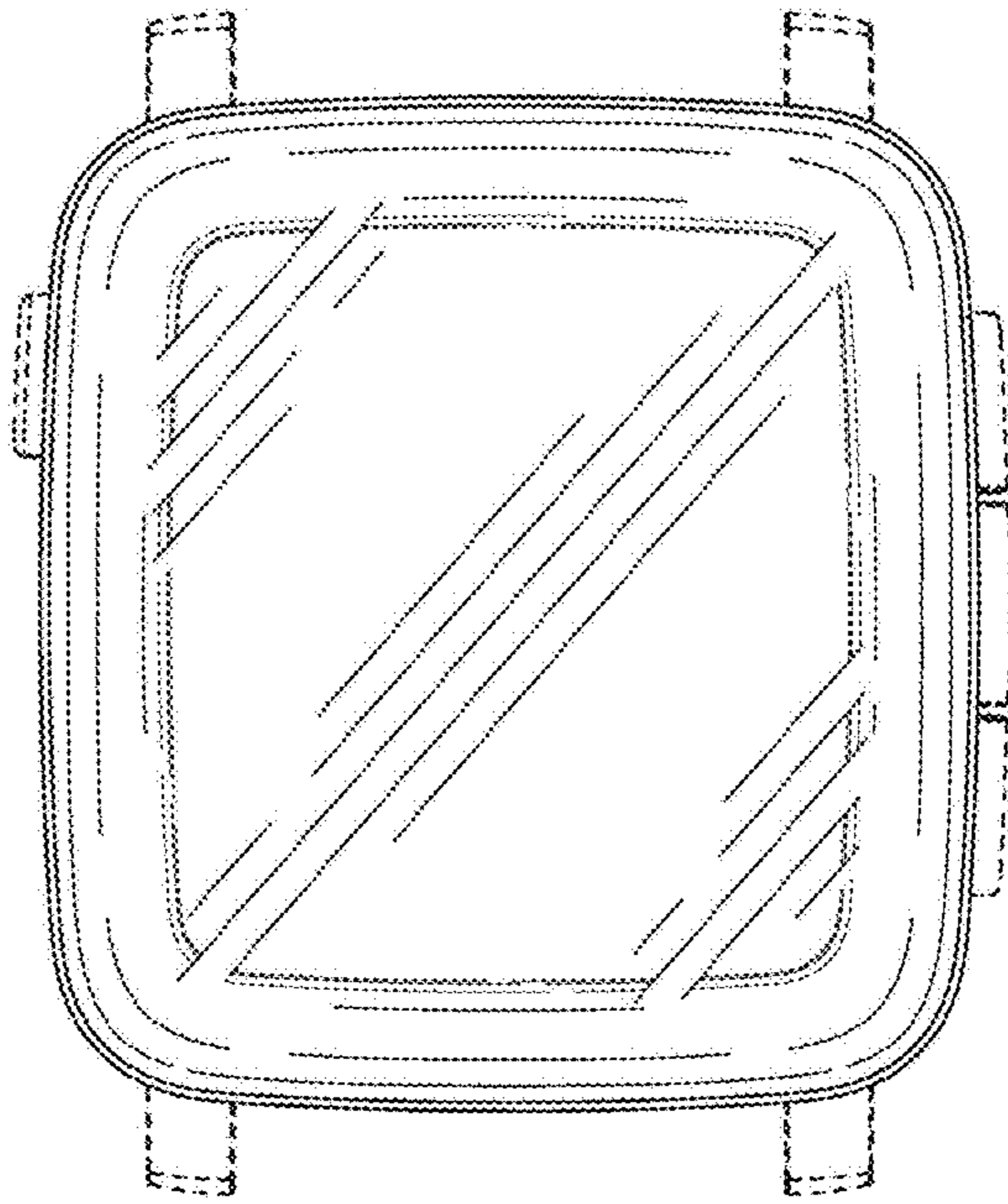

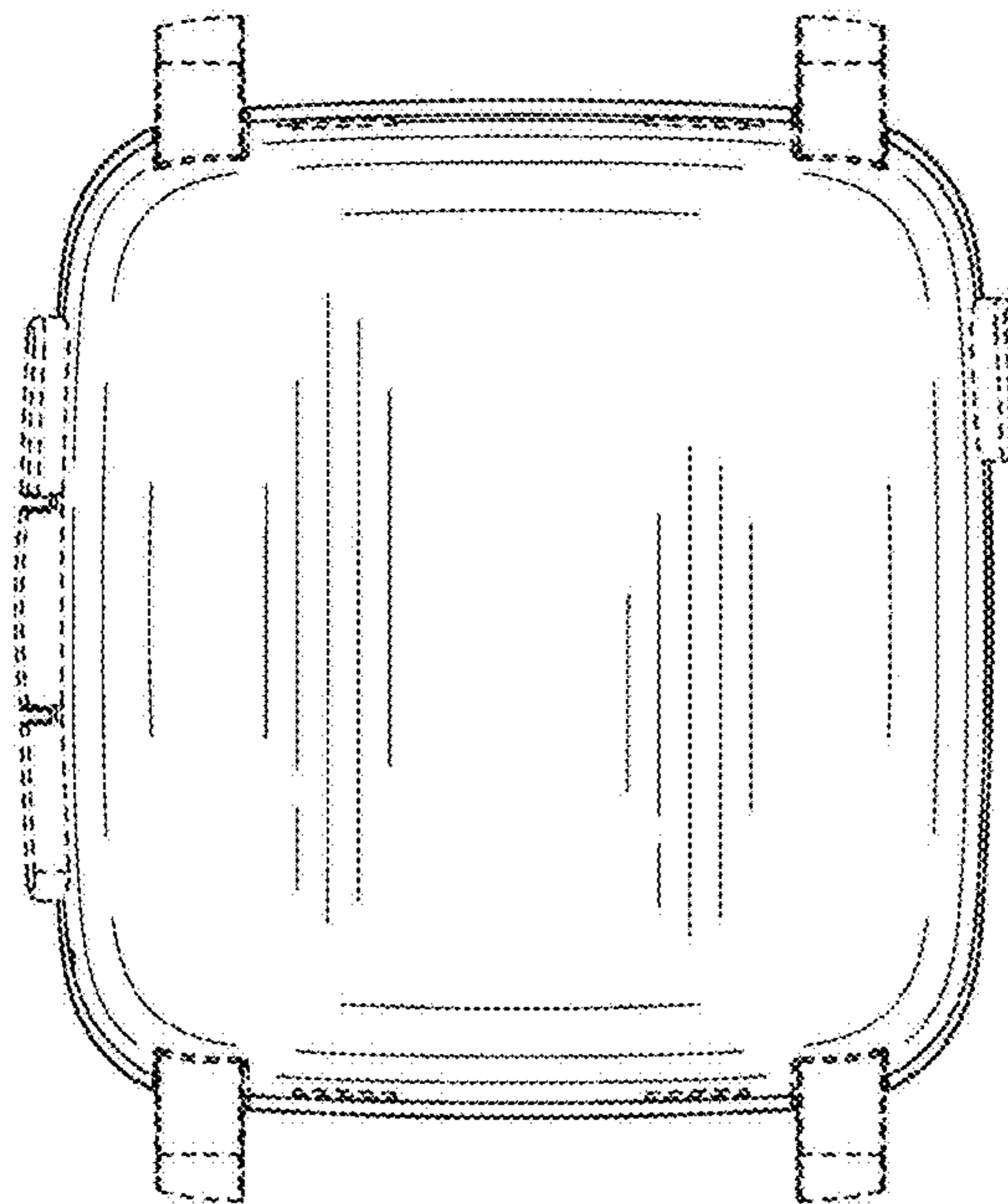

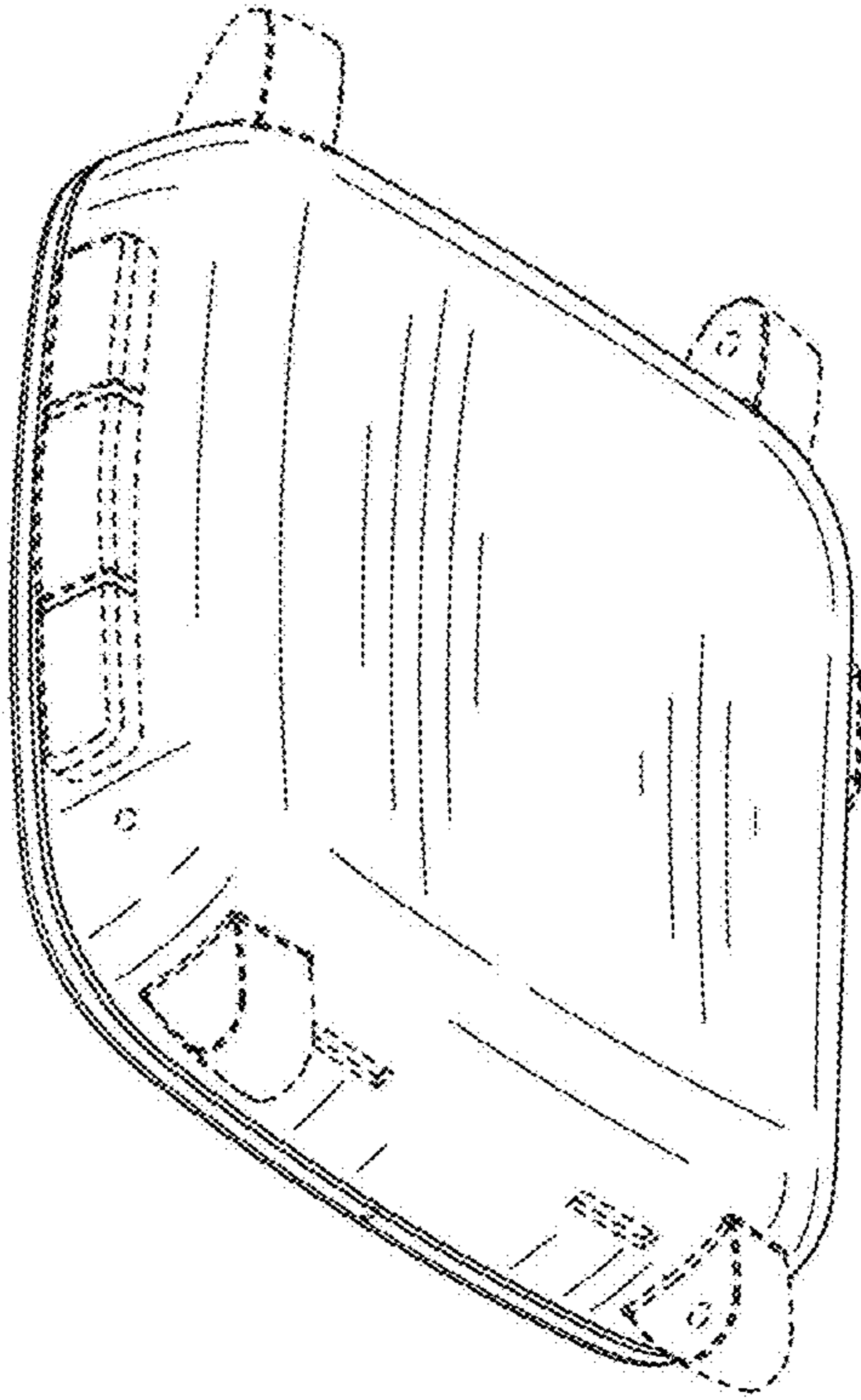

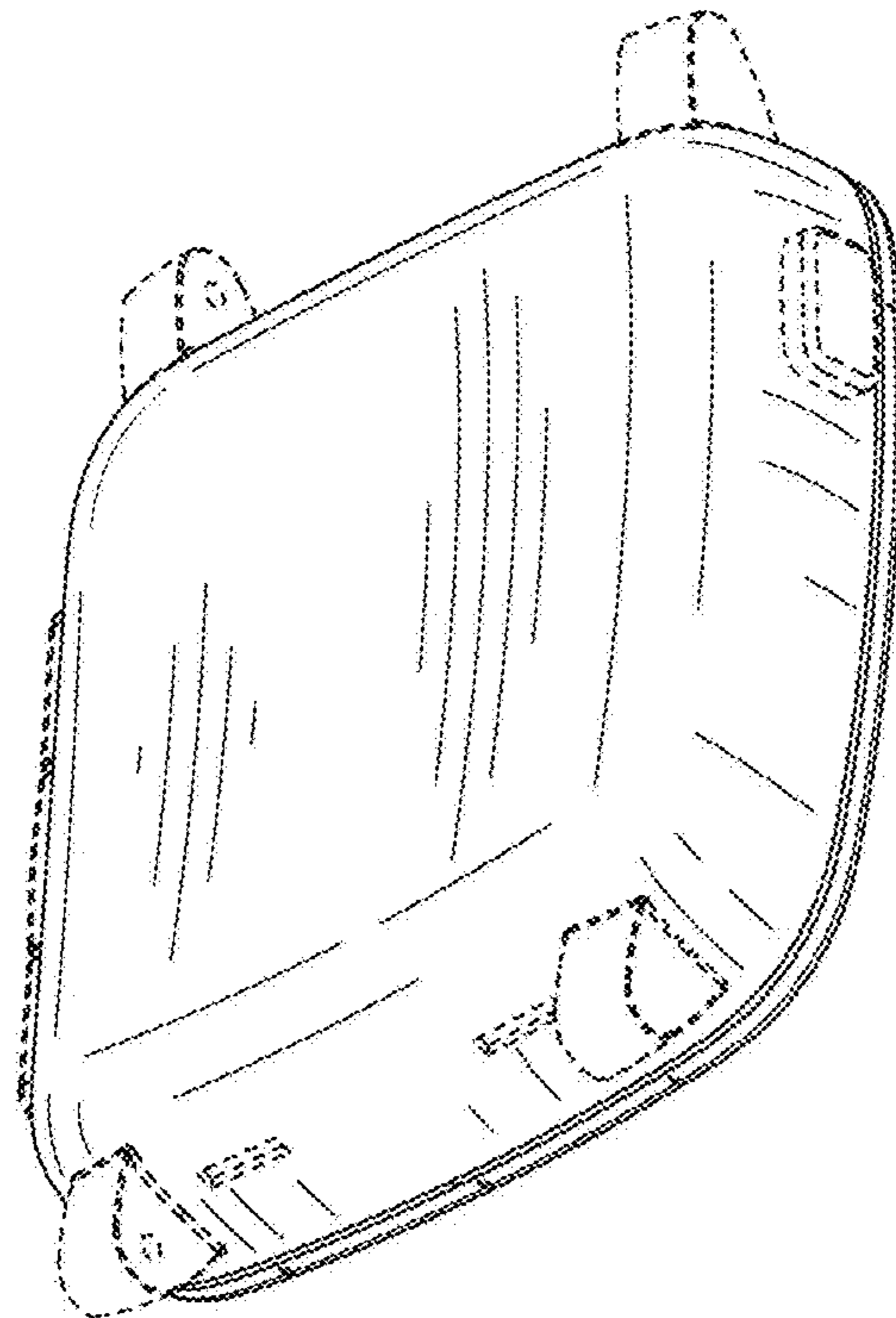

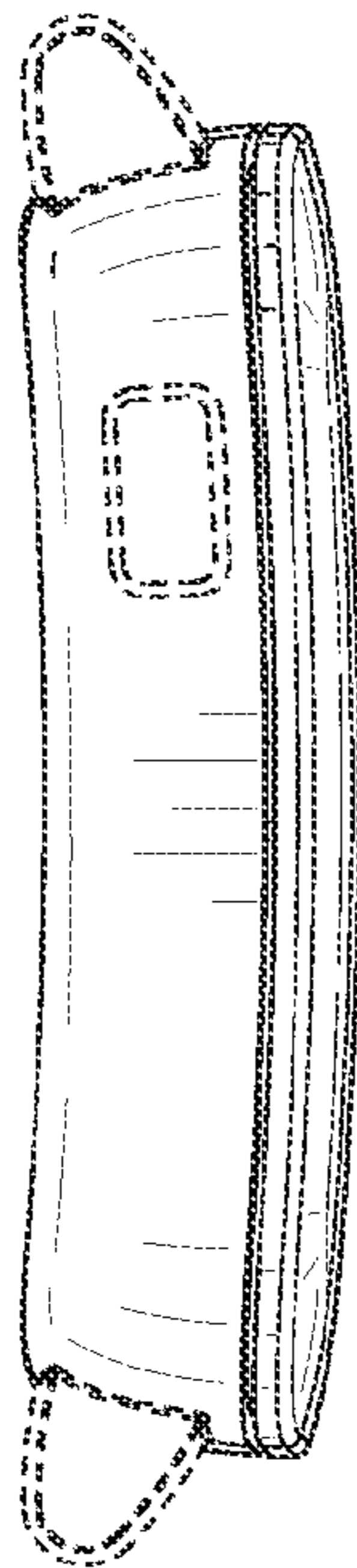

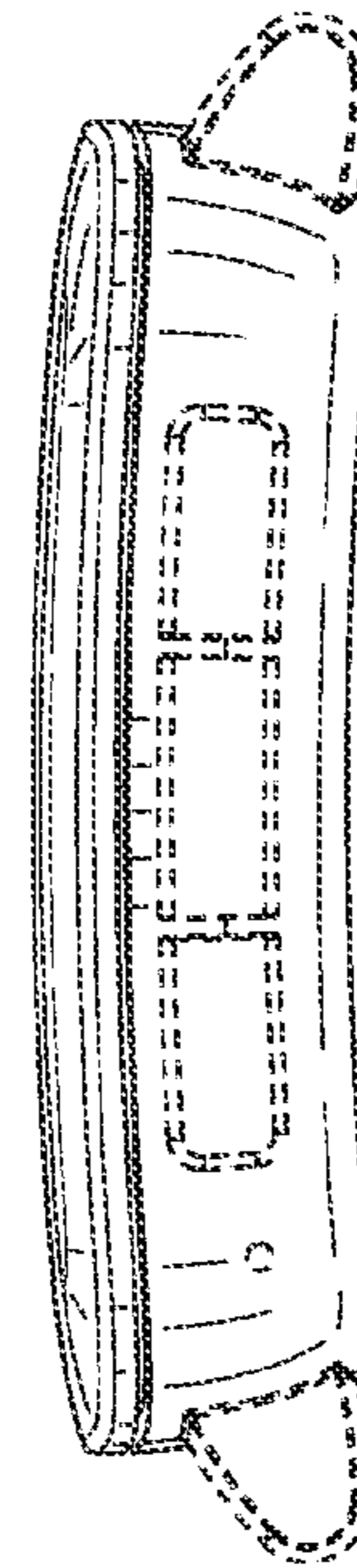

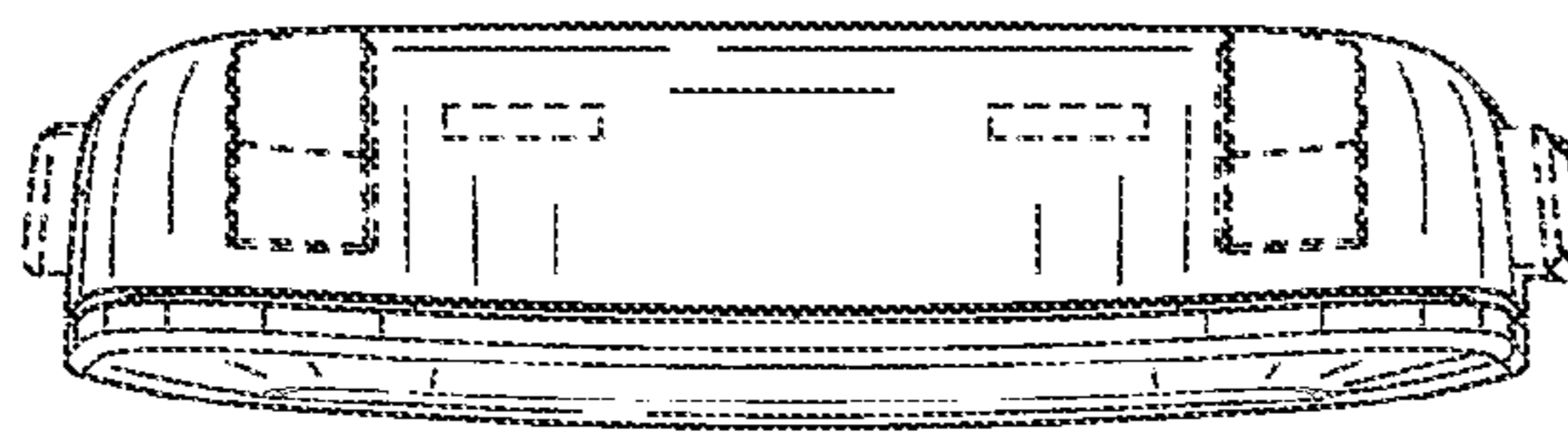

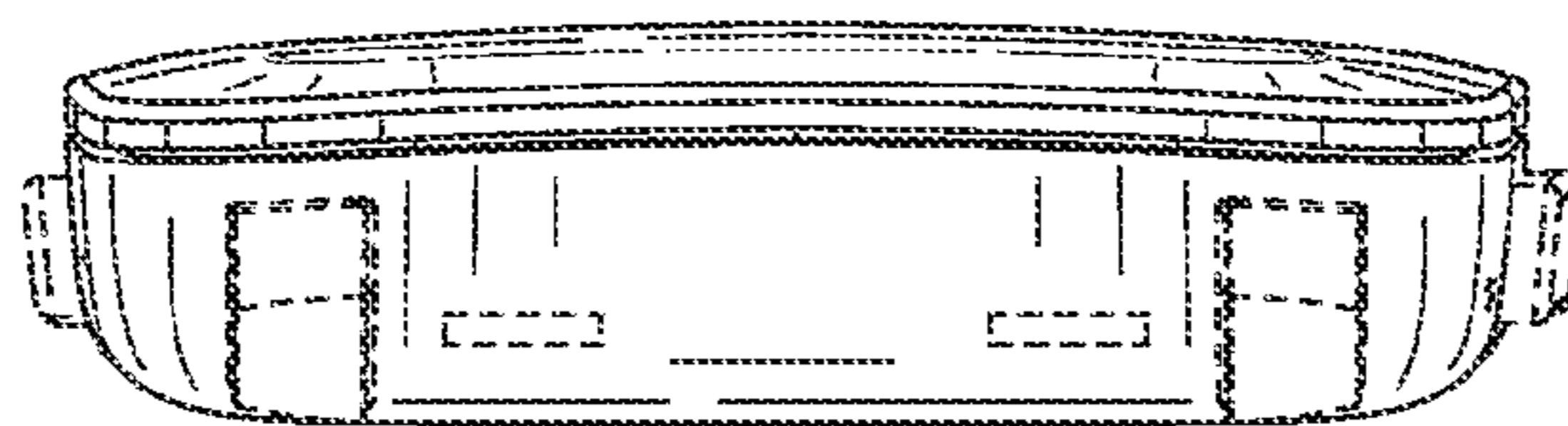

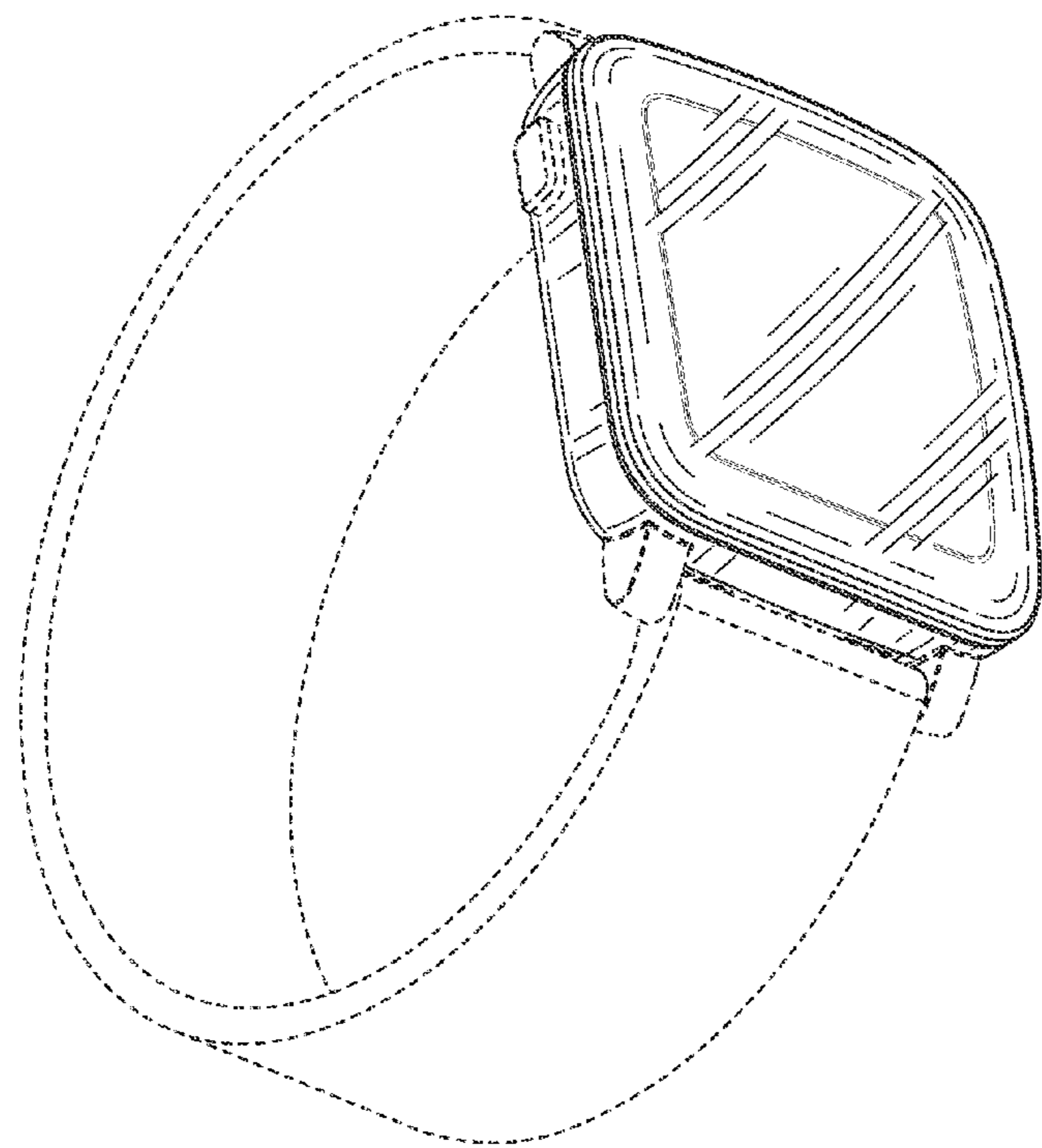

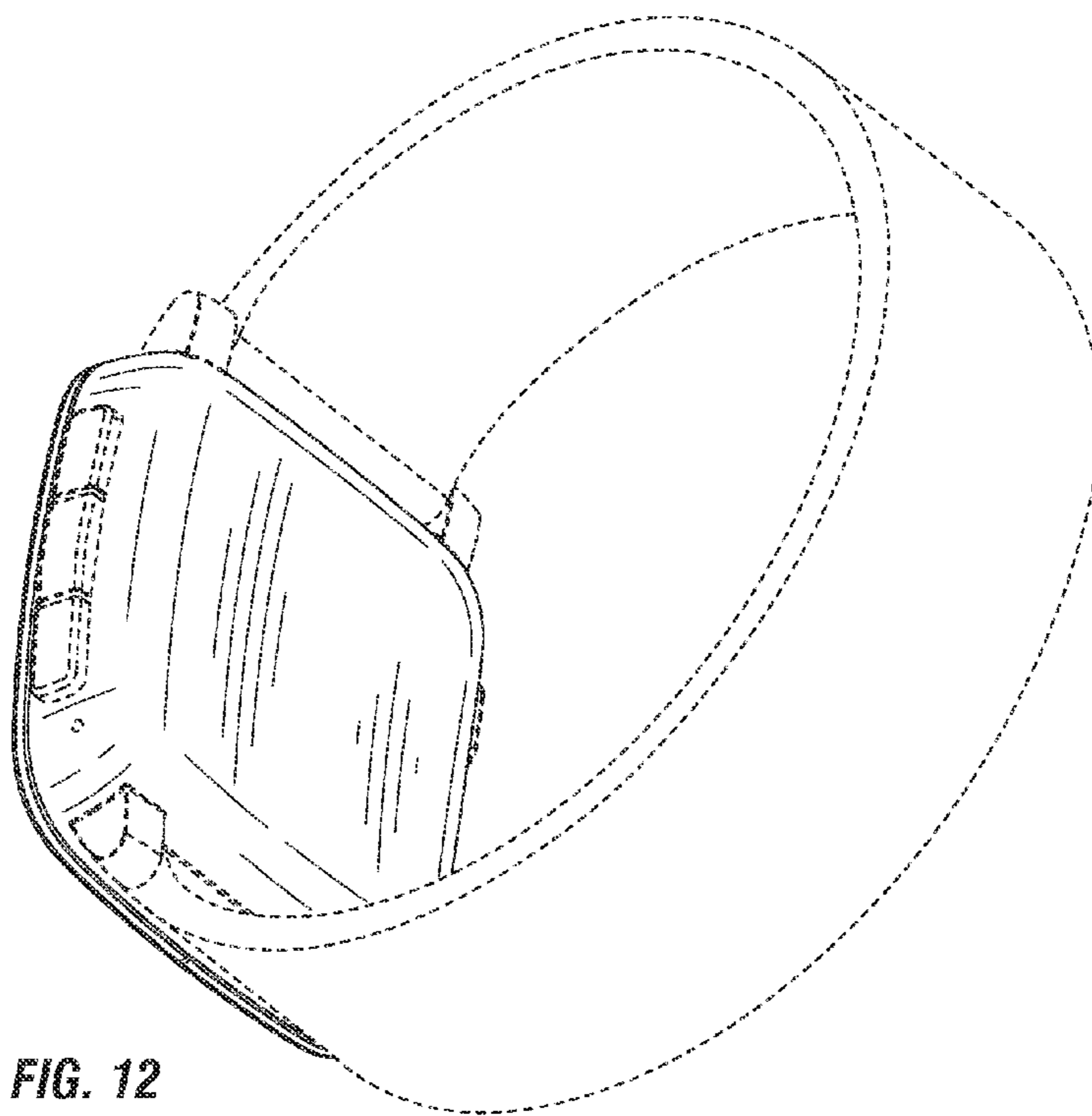
