(57) **CLAIM**

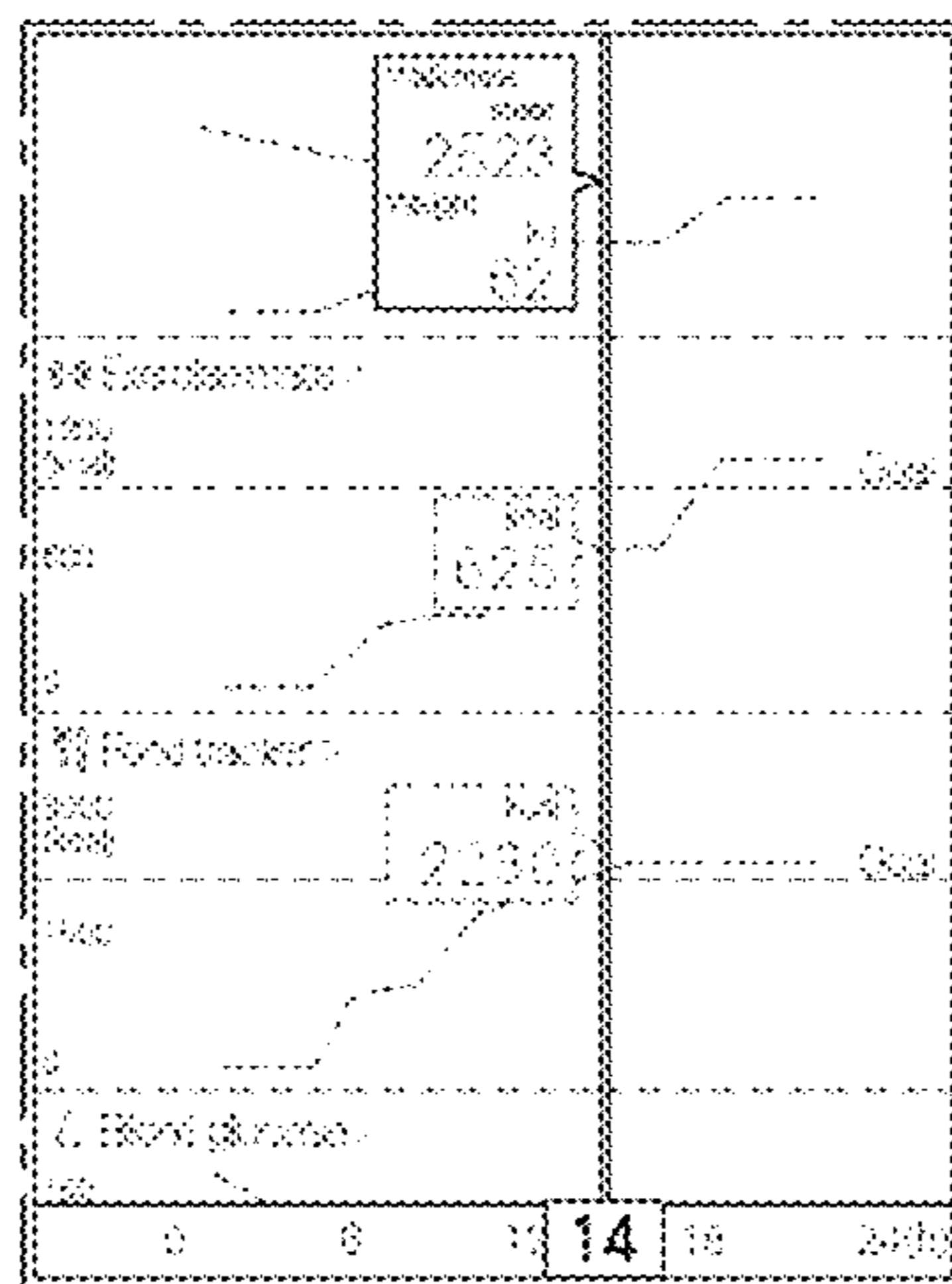
We claim, the ornamental design for a graphic user interface for a display screen or a portion thereof, as shown and described.

**DESCRIPTION**
