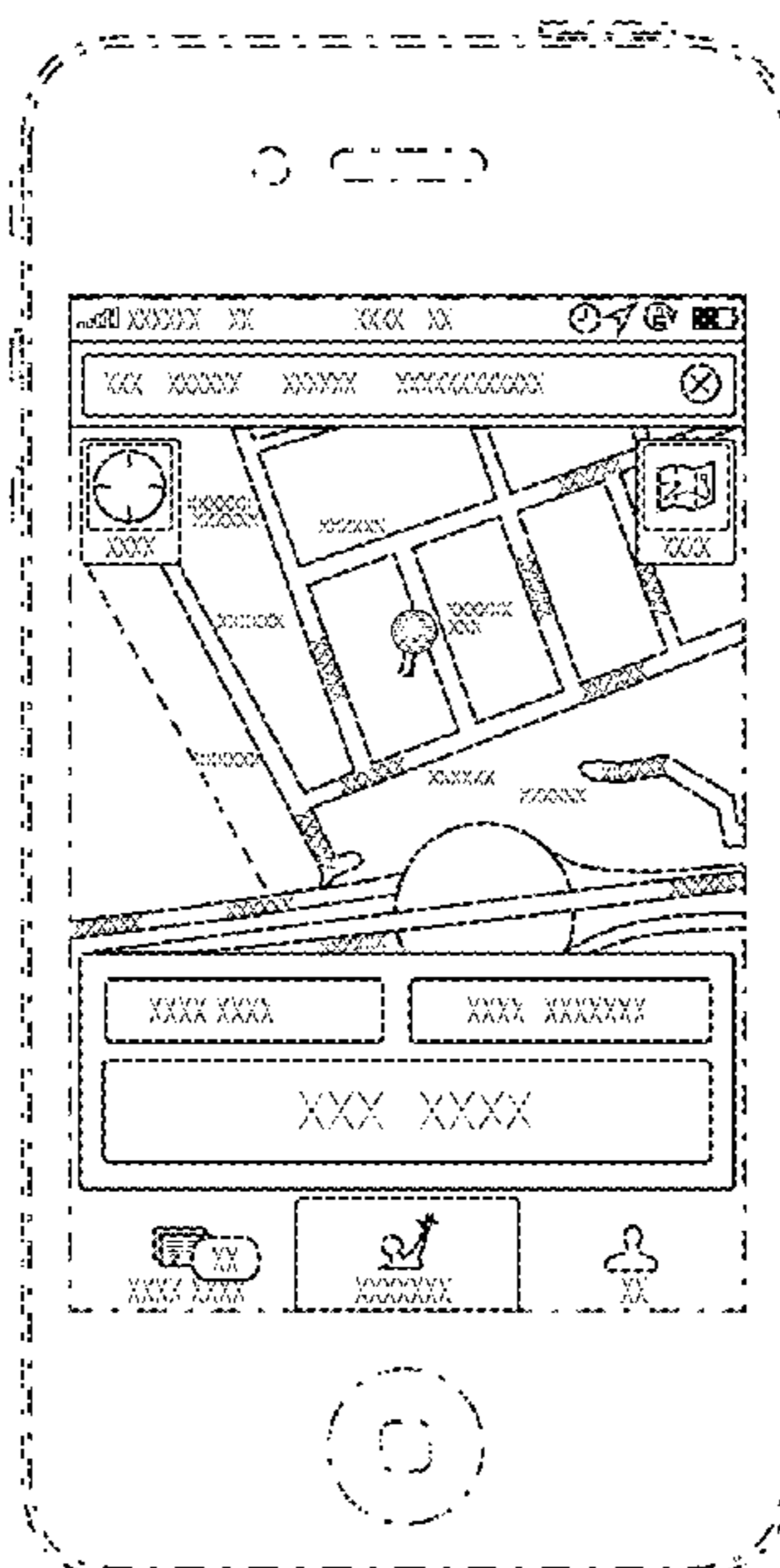
The ornamental design for a graphical user interface for a display screen or portion thereof, as shown and described.

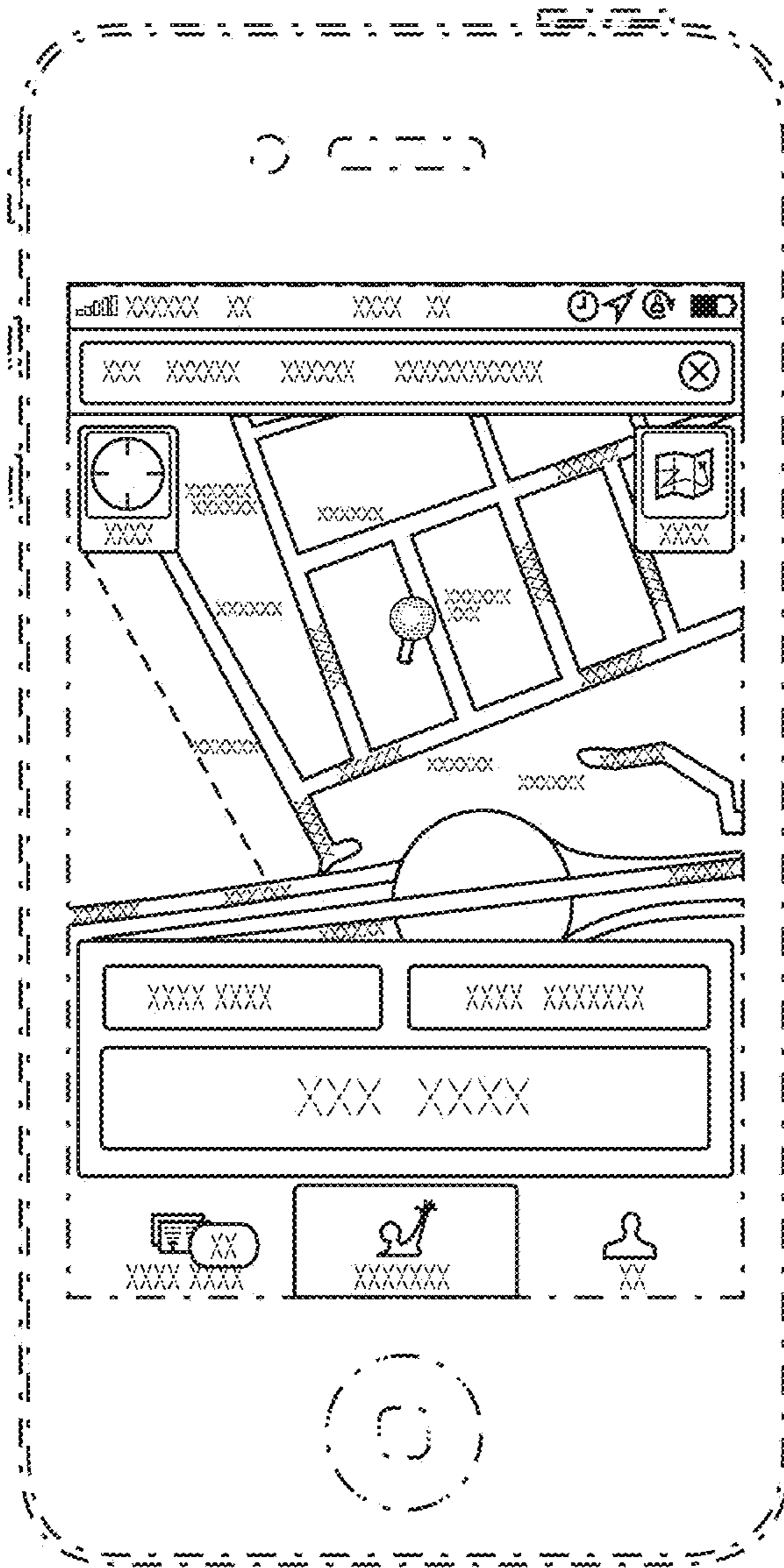
DESCRIPTION
