FIG. 8 is a front view of FIG. 3, showing the display screen in an exemplary environment;

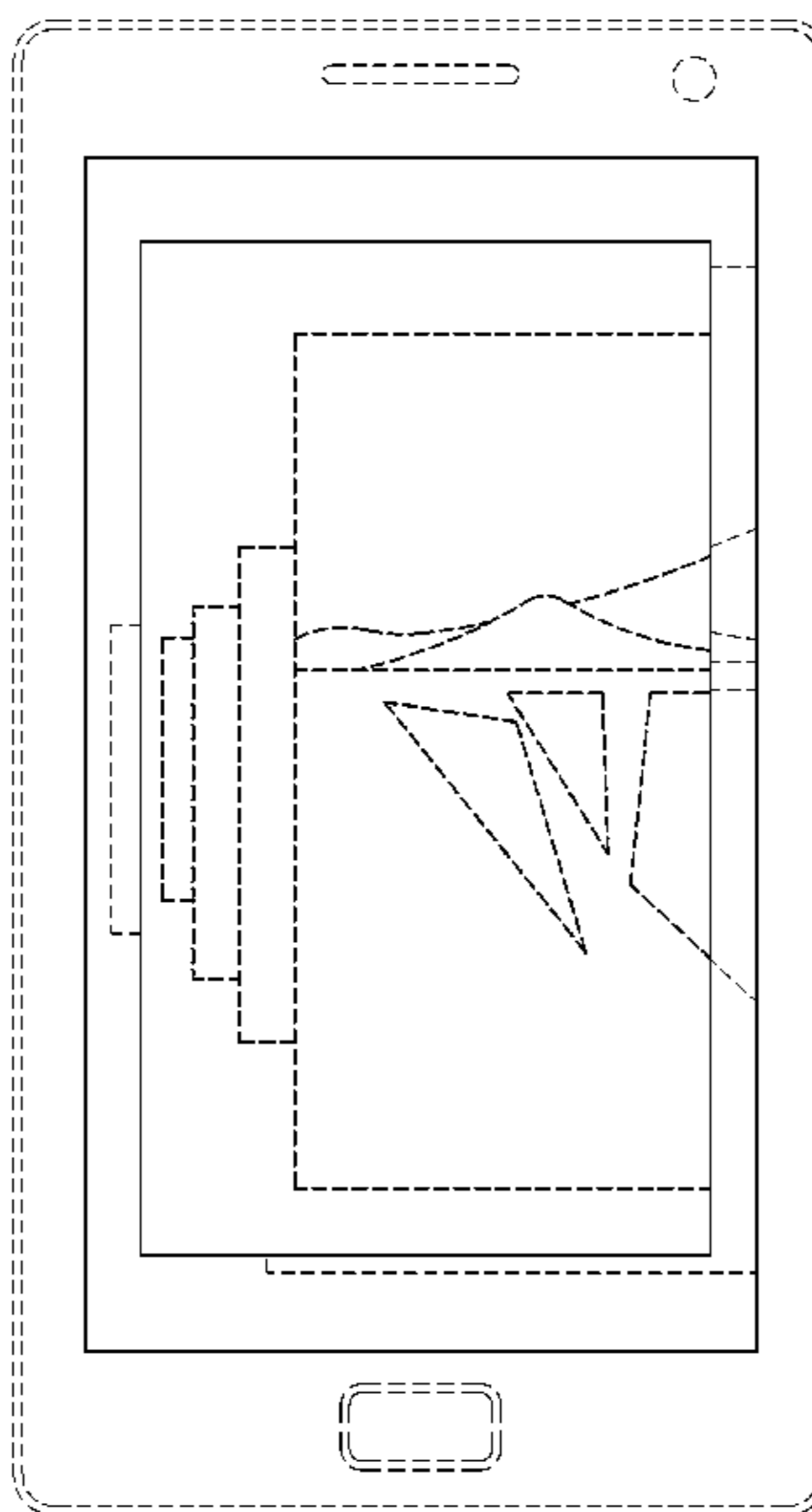
FIG. 9 is a front view of FIG. 4, showing the display screen in an exemplary environment; and,

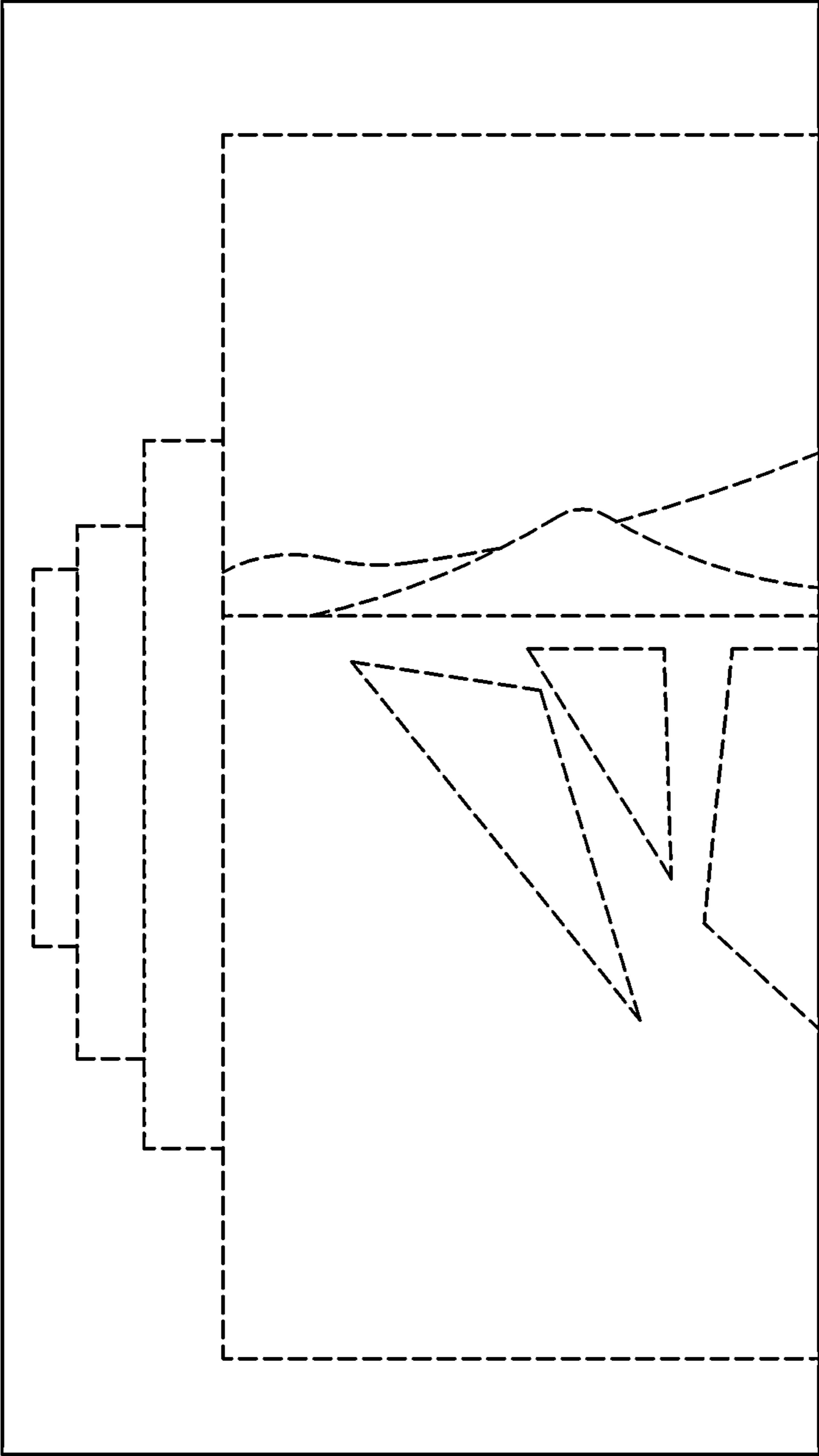

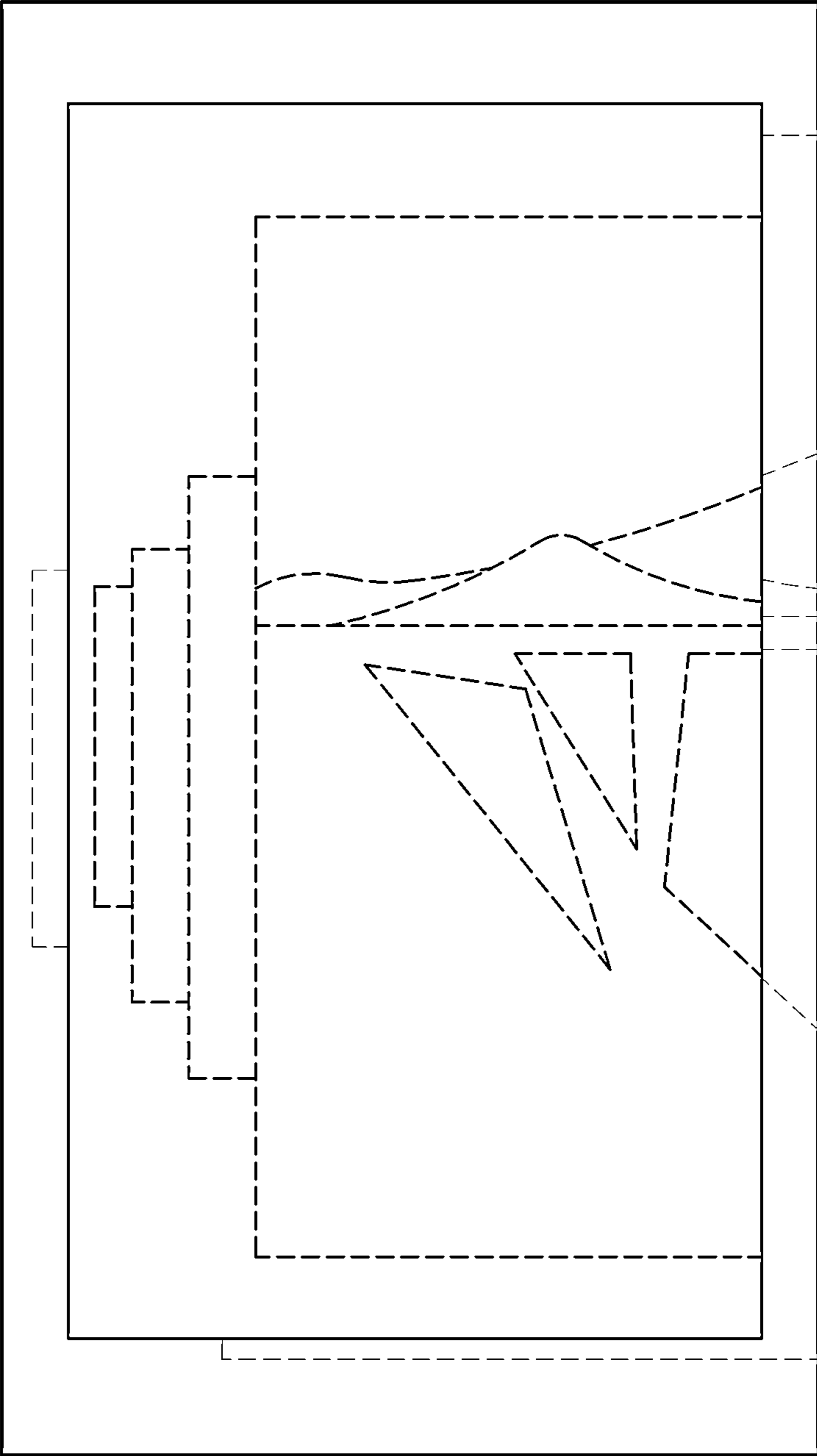

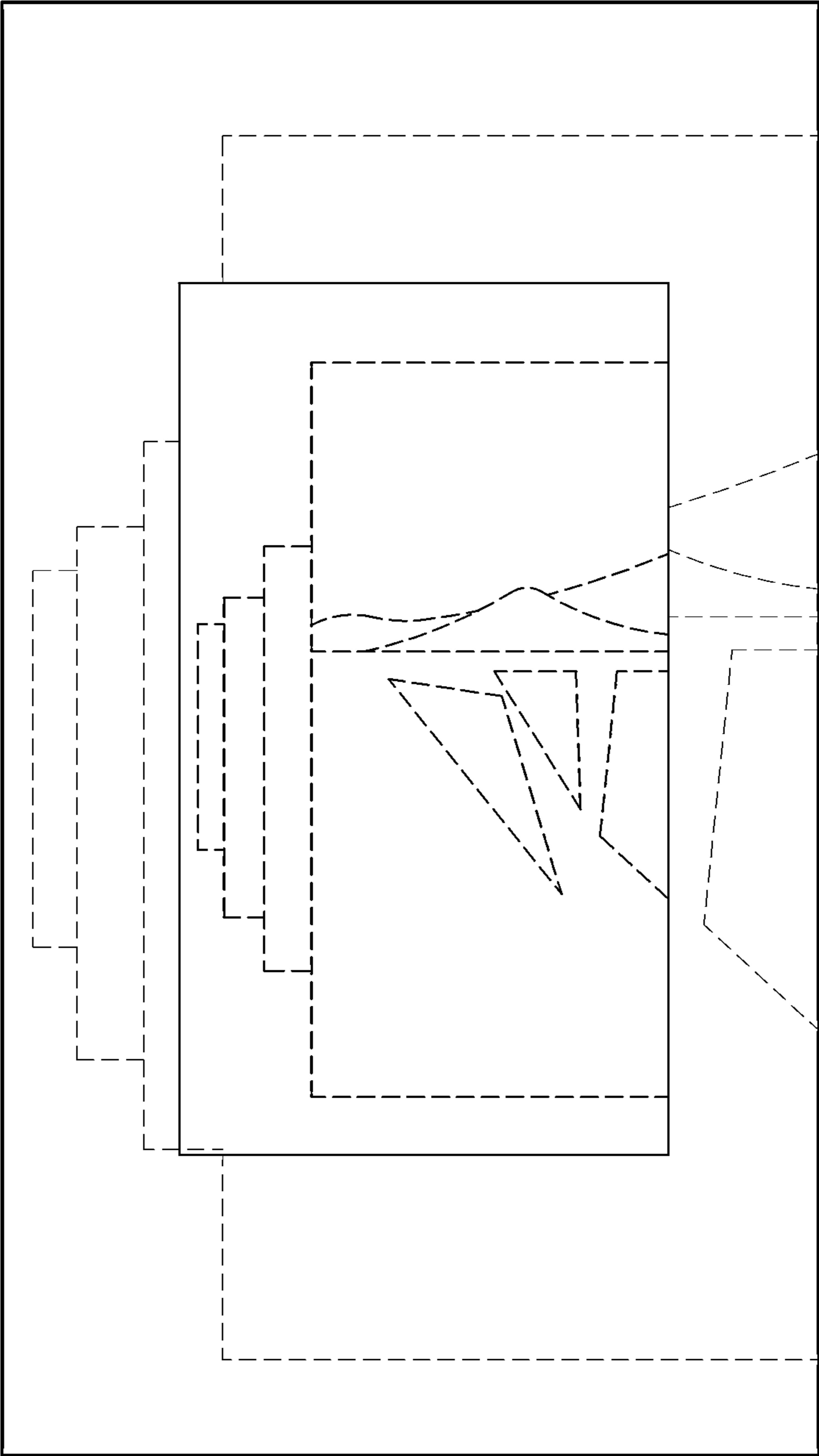

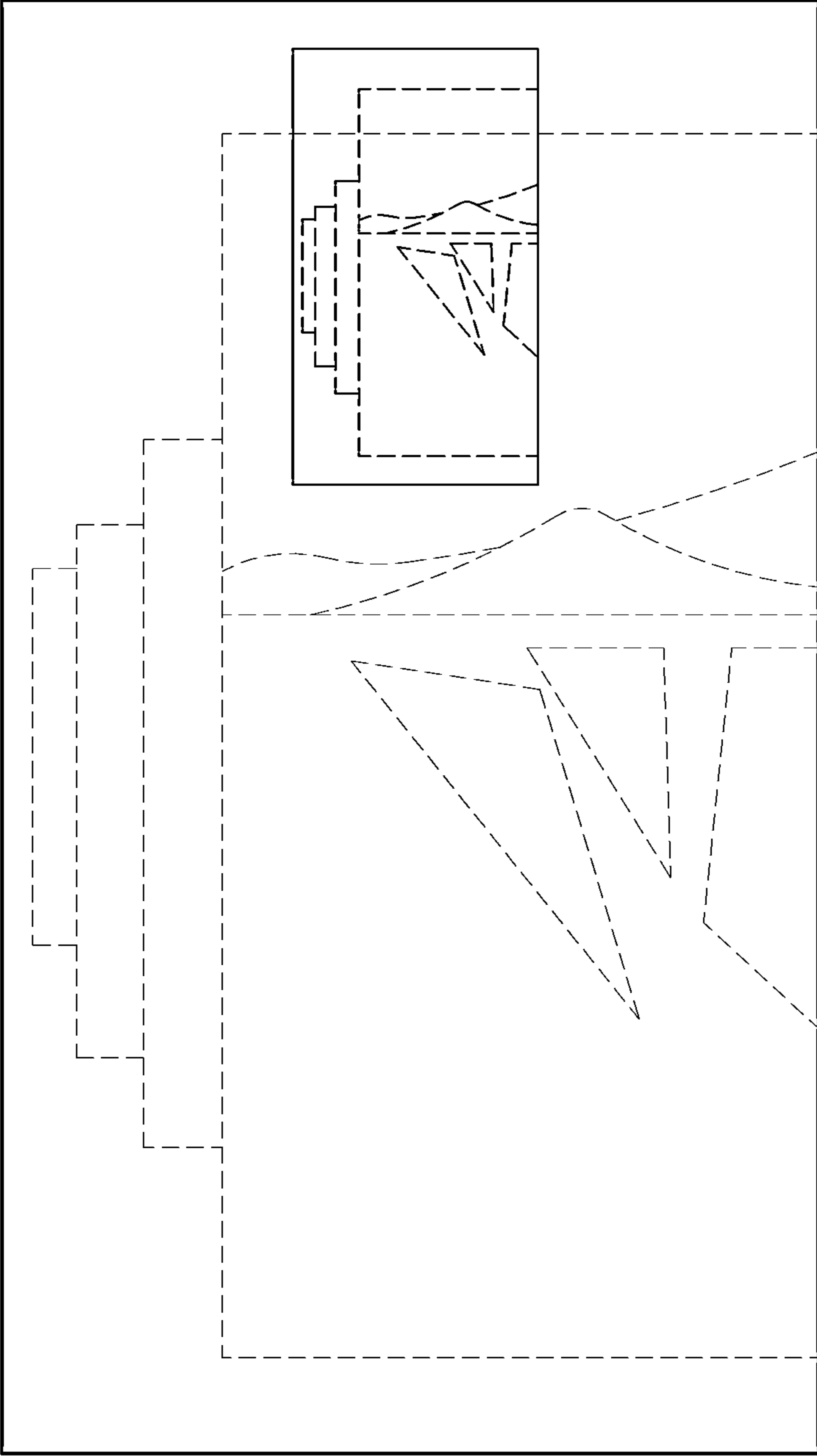

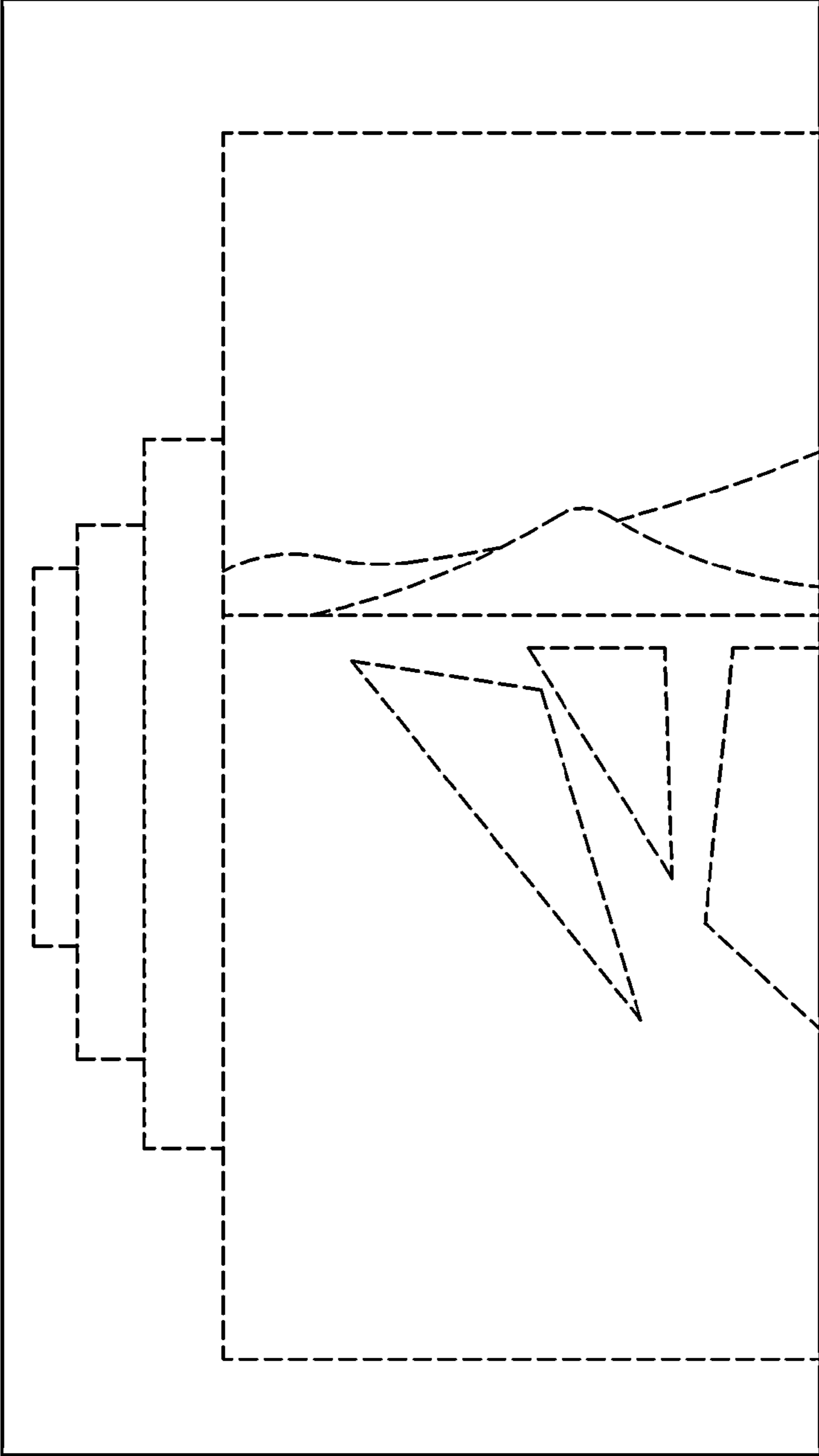

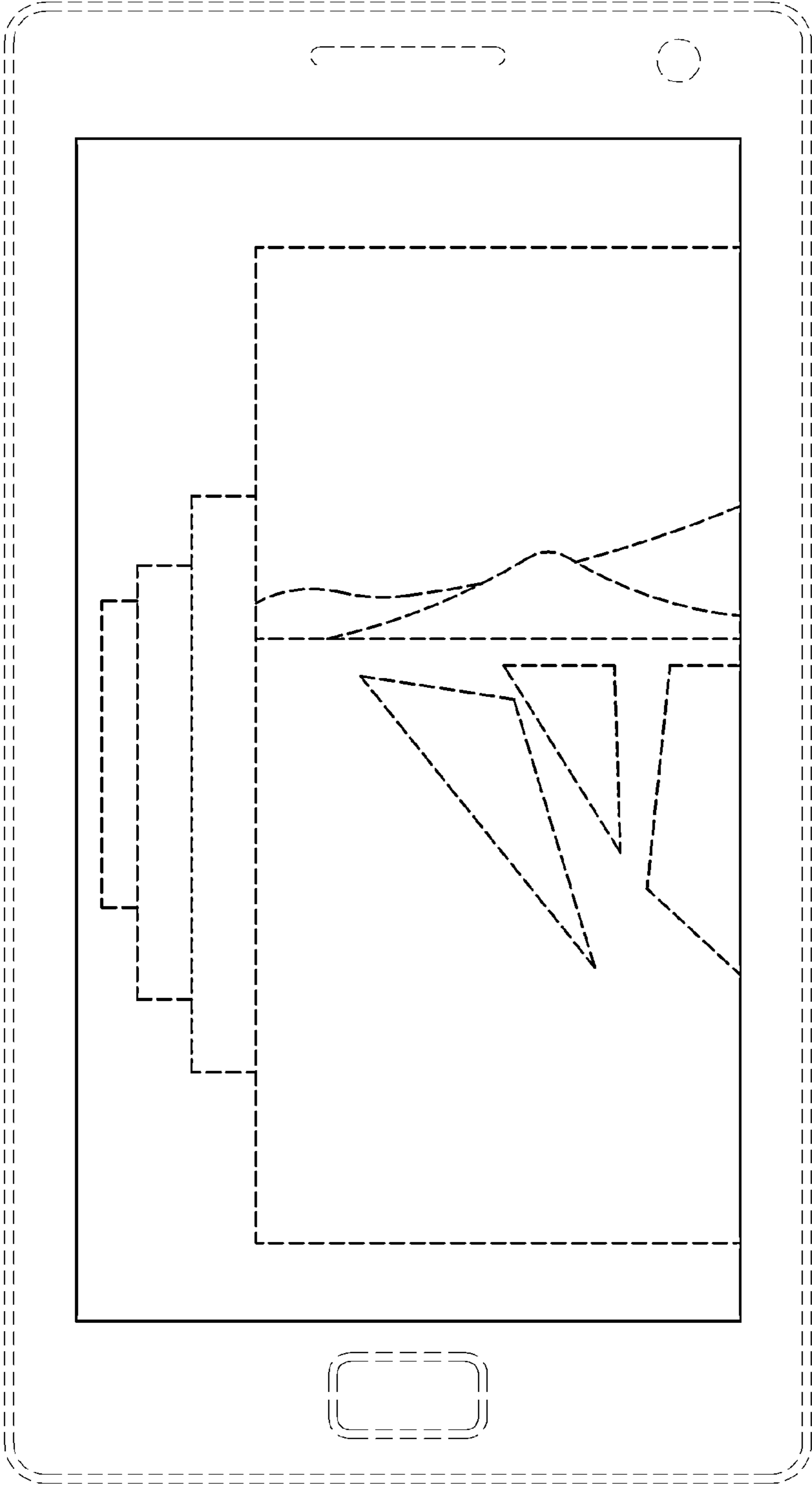

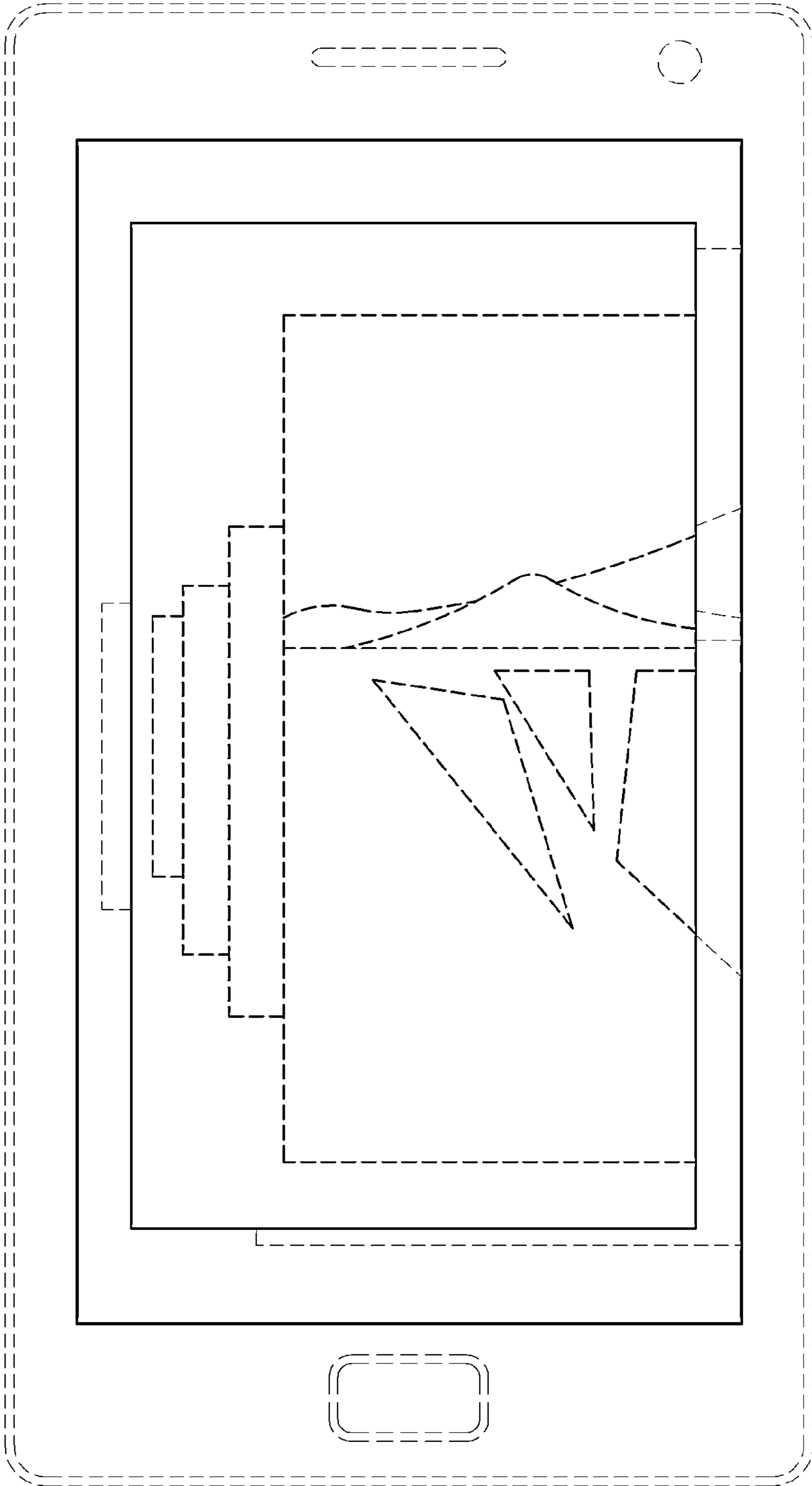

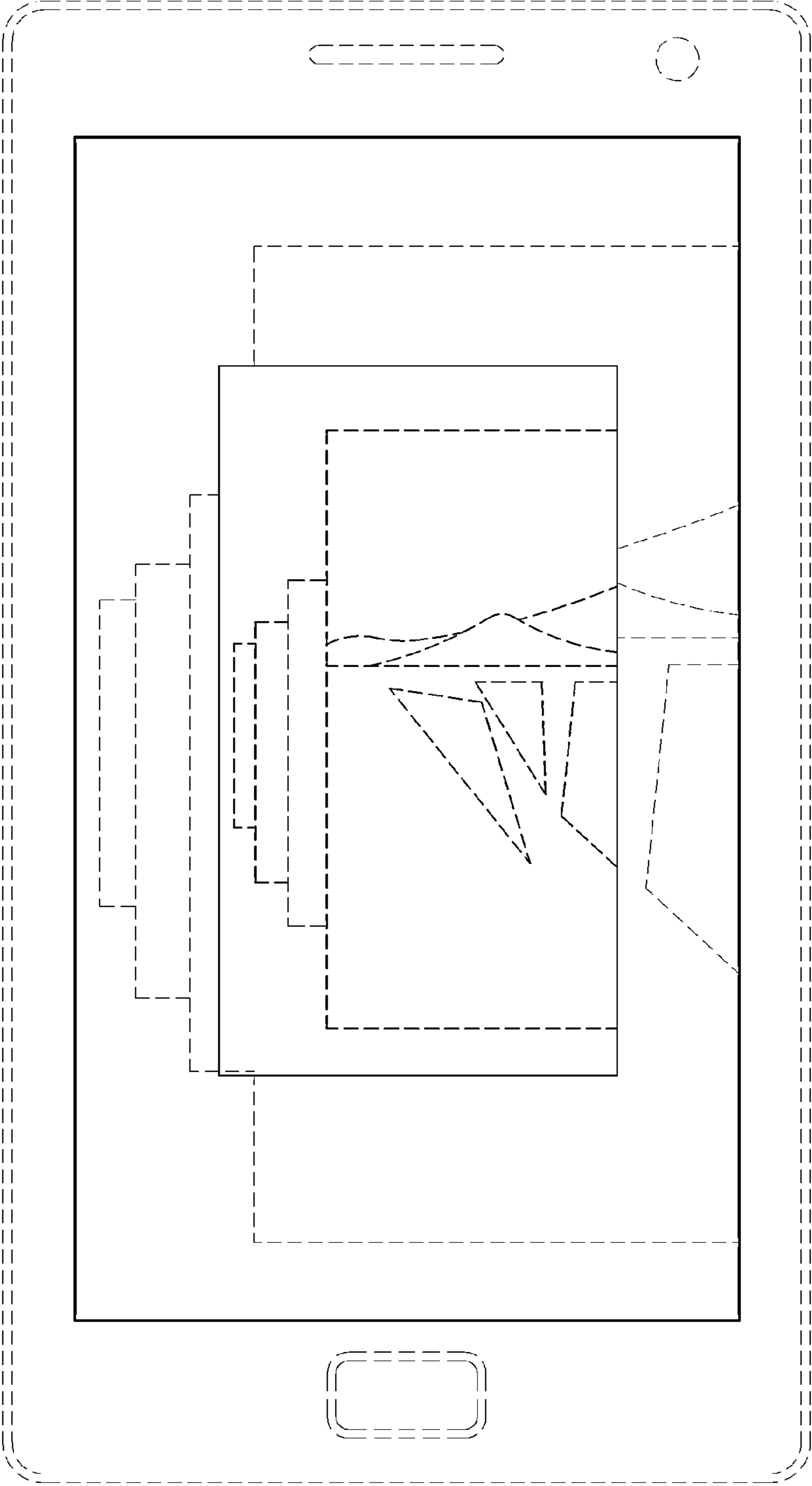

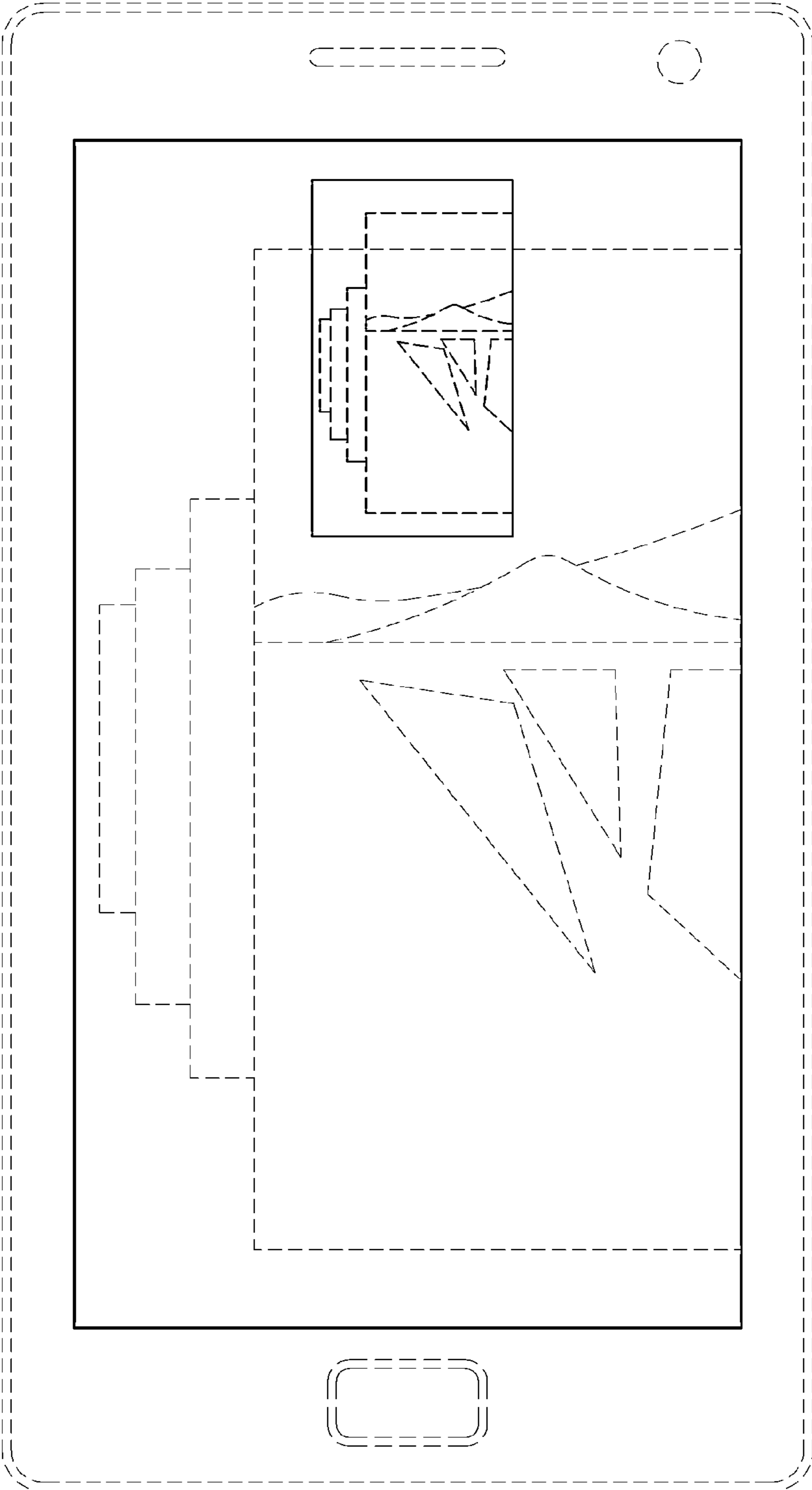
