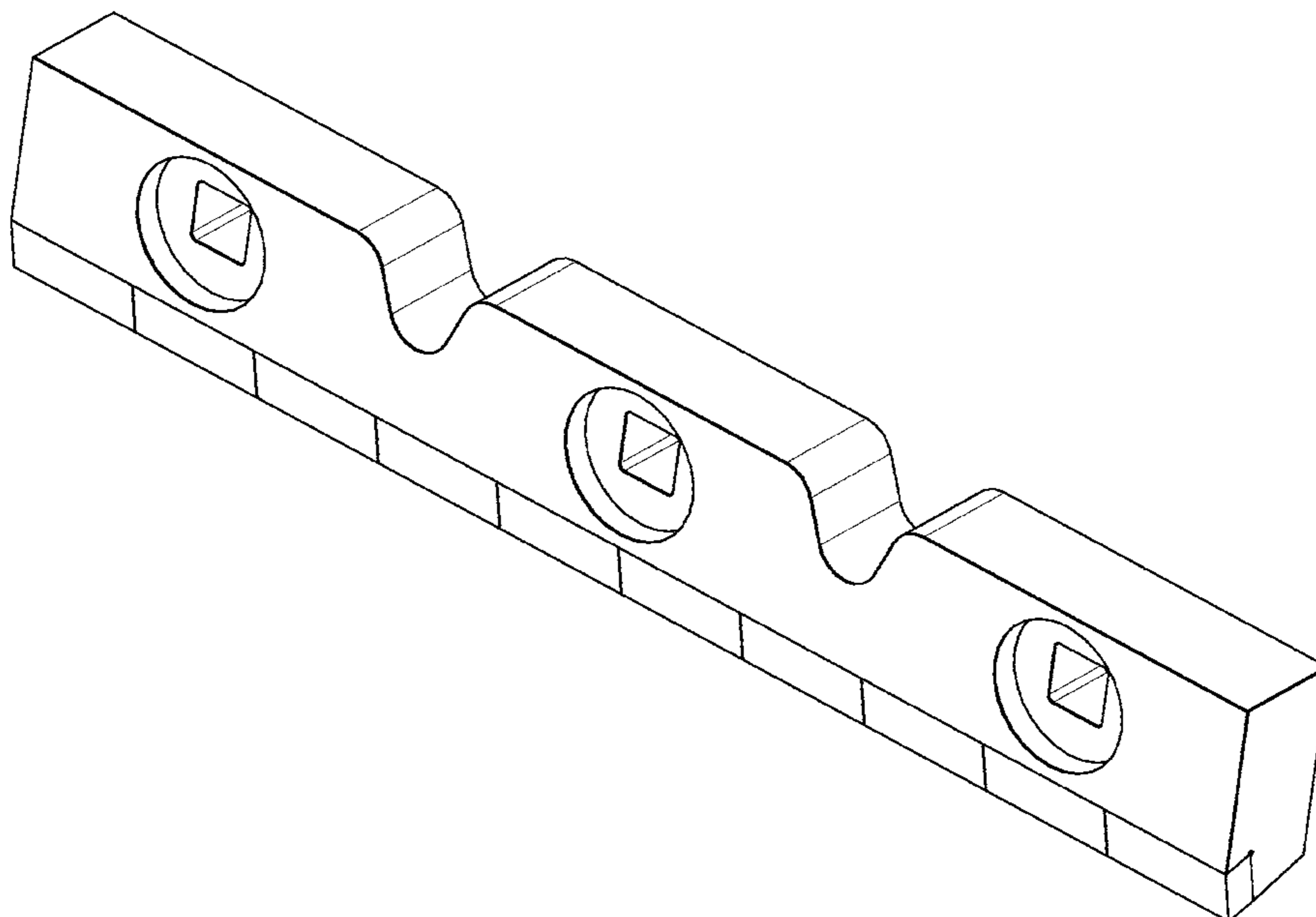
(57) **CLAIM**

The ornamental design for a scraper bar for a milling machine, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of our new scraper bar for a milling machine design;

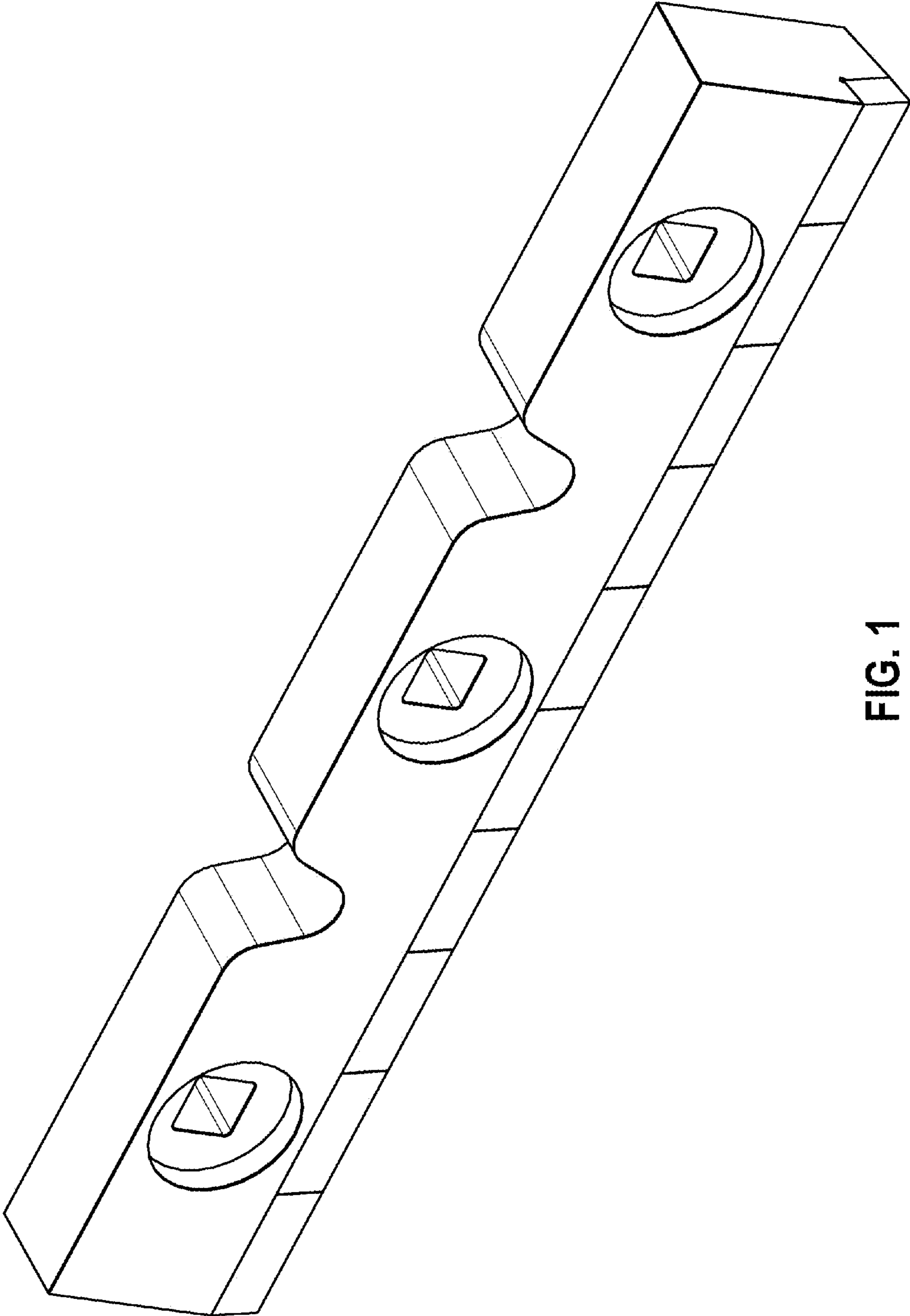

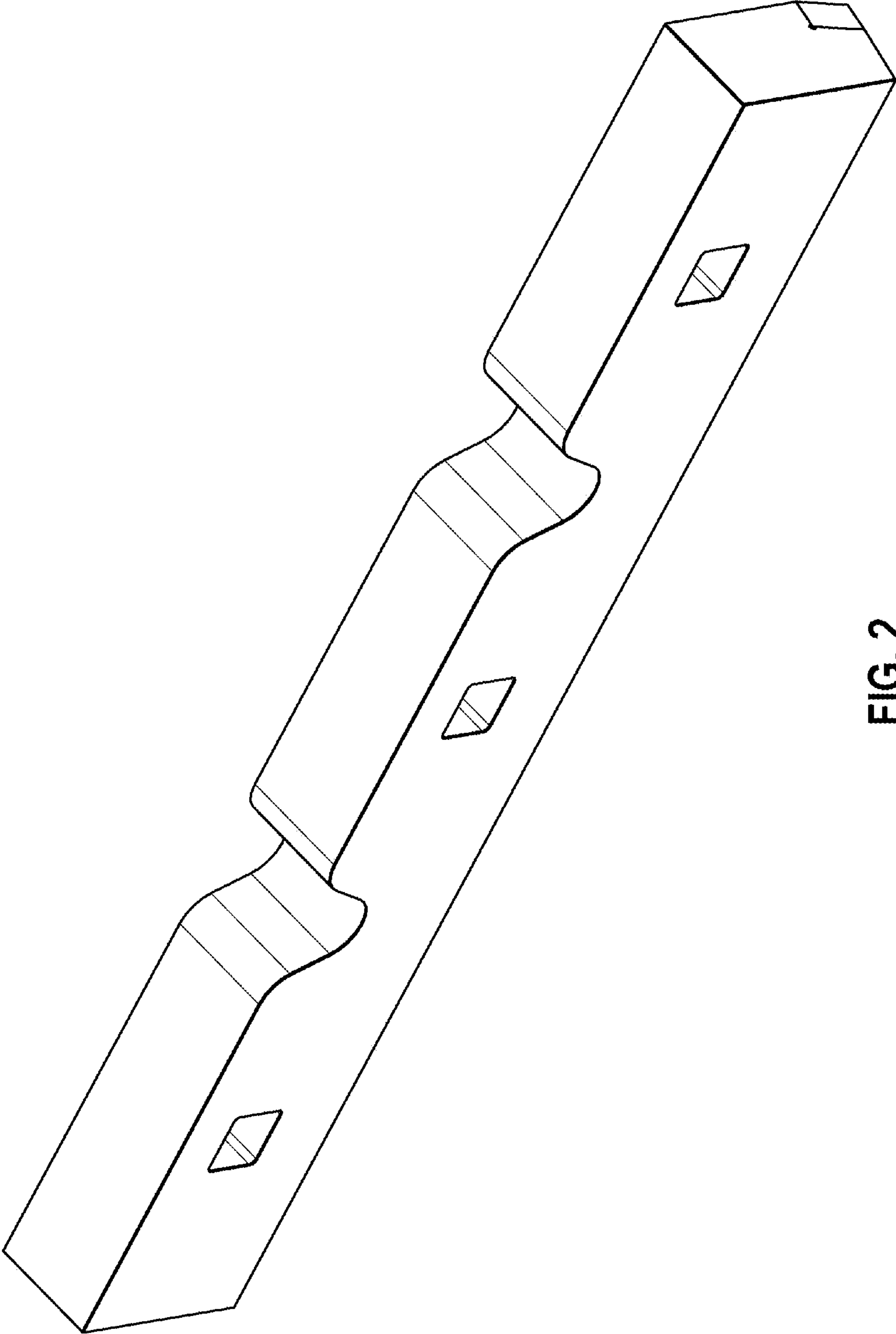

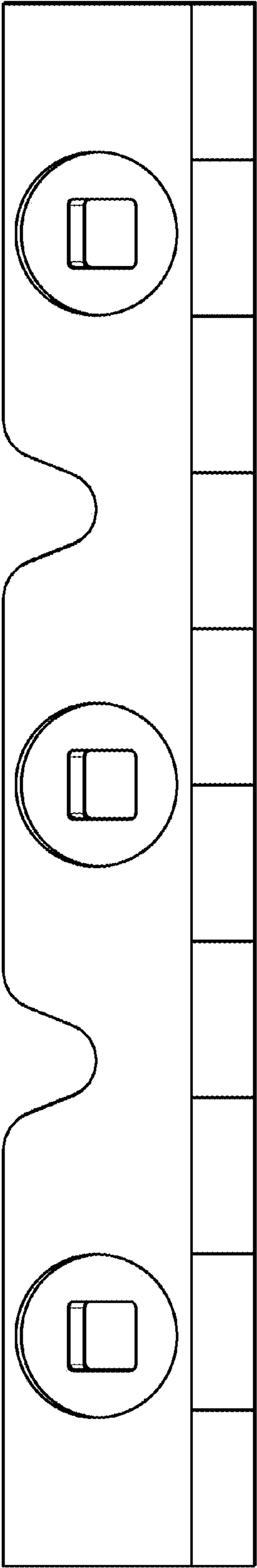

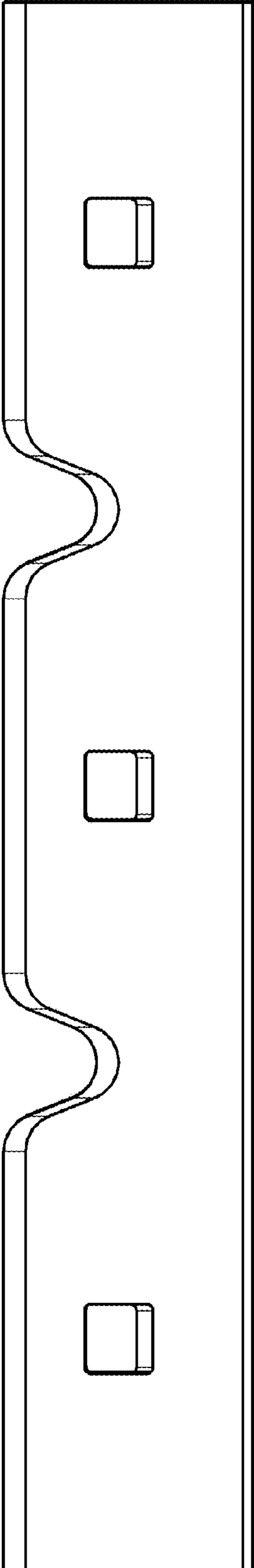

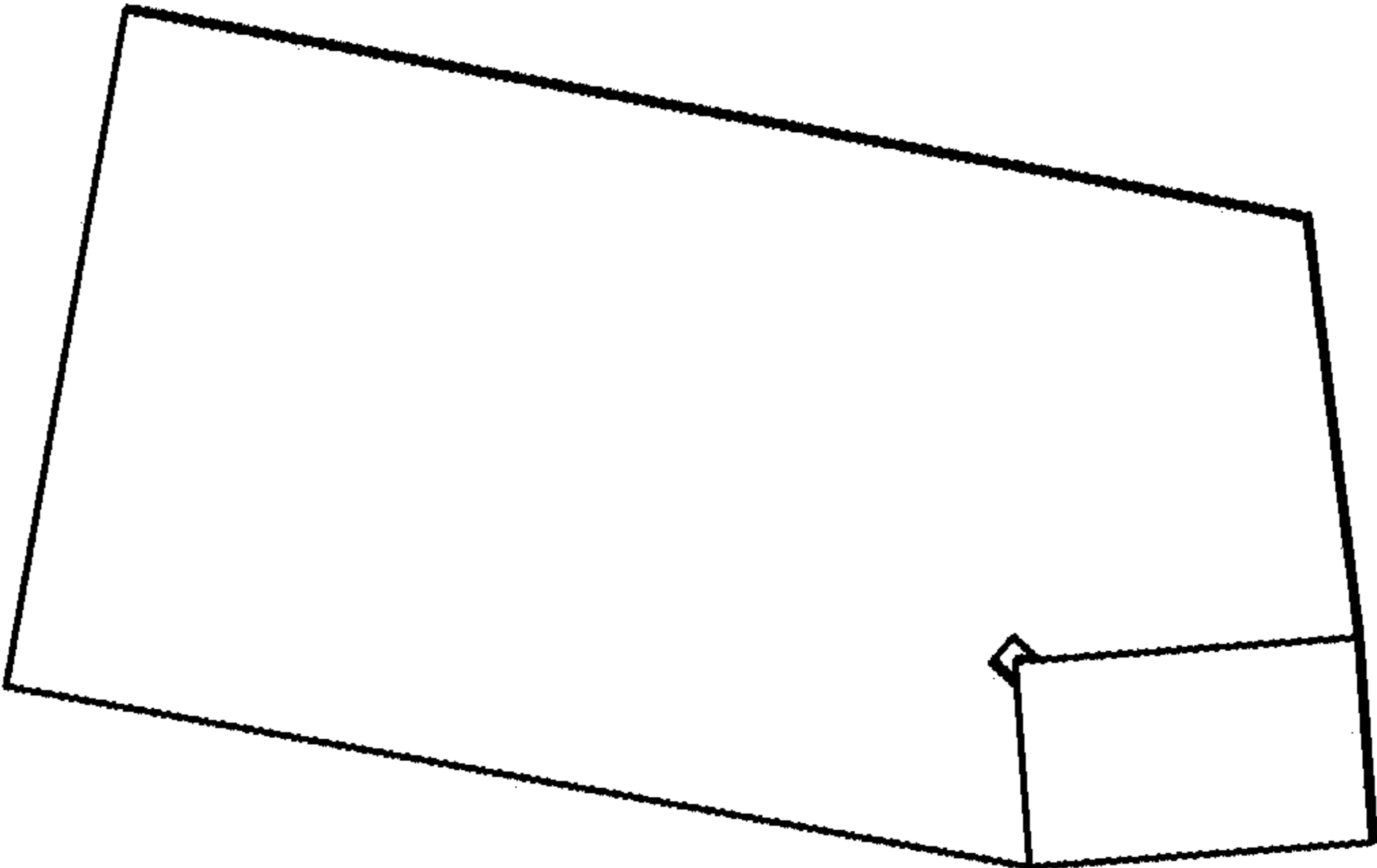

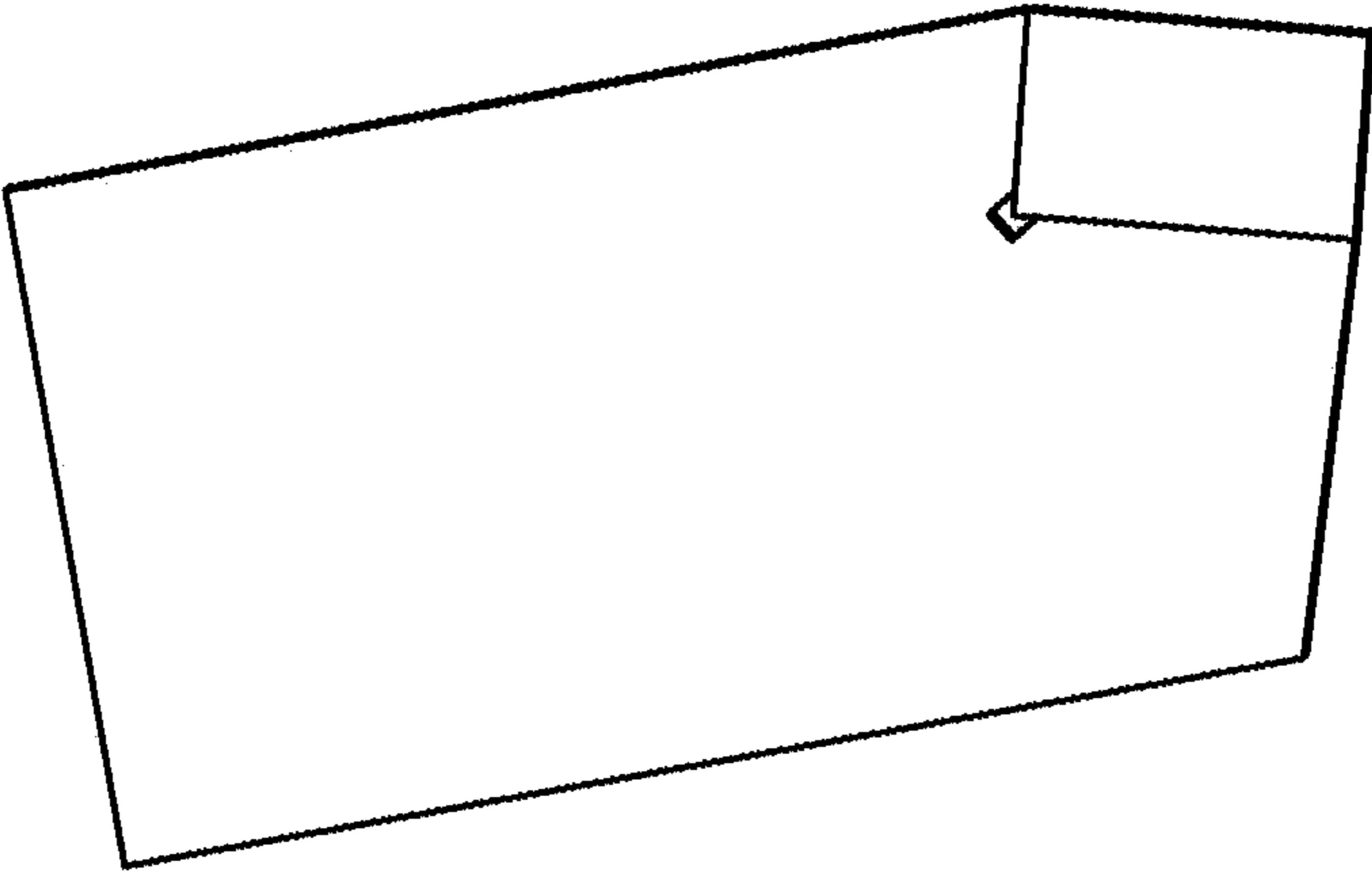

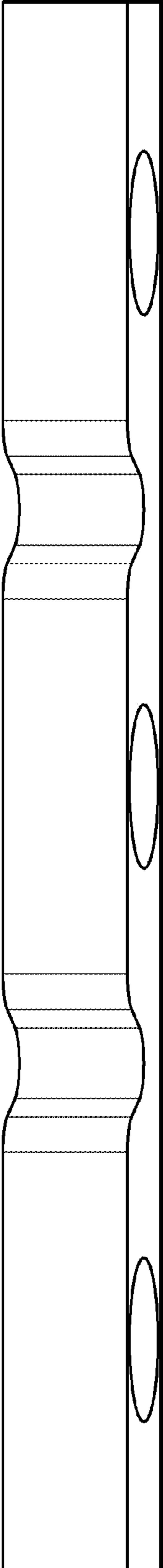

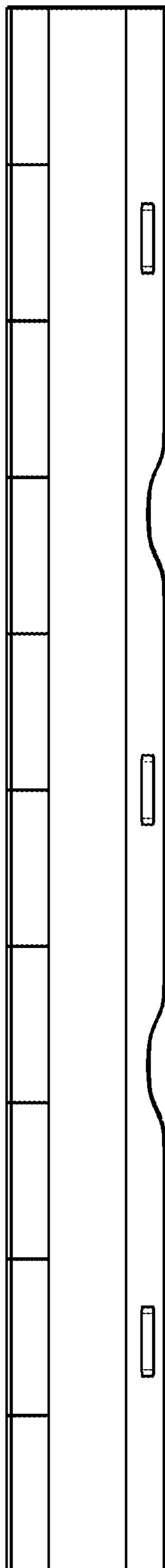
