DESCRIPTION

FIG. 1 is a front perspective view of a lens for camera showing my new design;
FIG. 2 is front elevational view thereof;
FIG. 3 is rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,

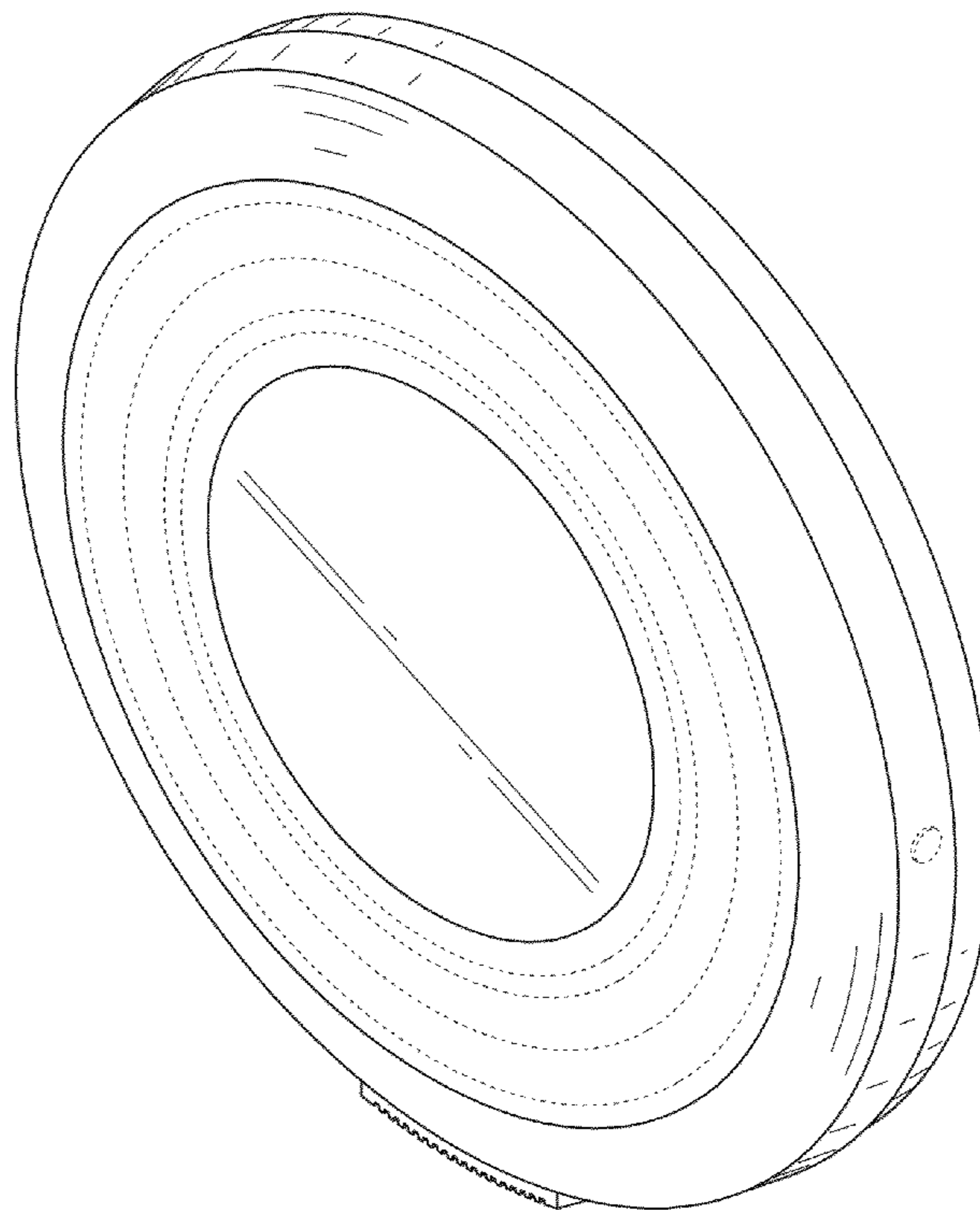

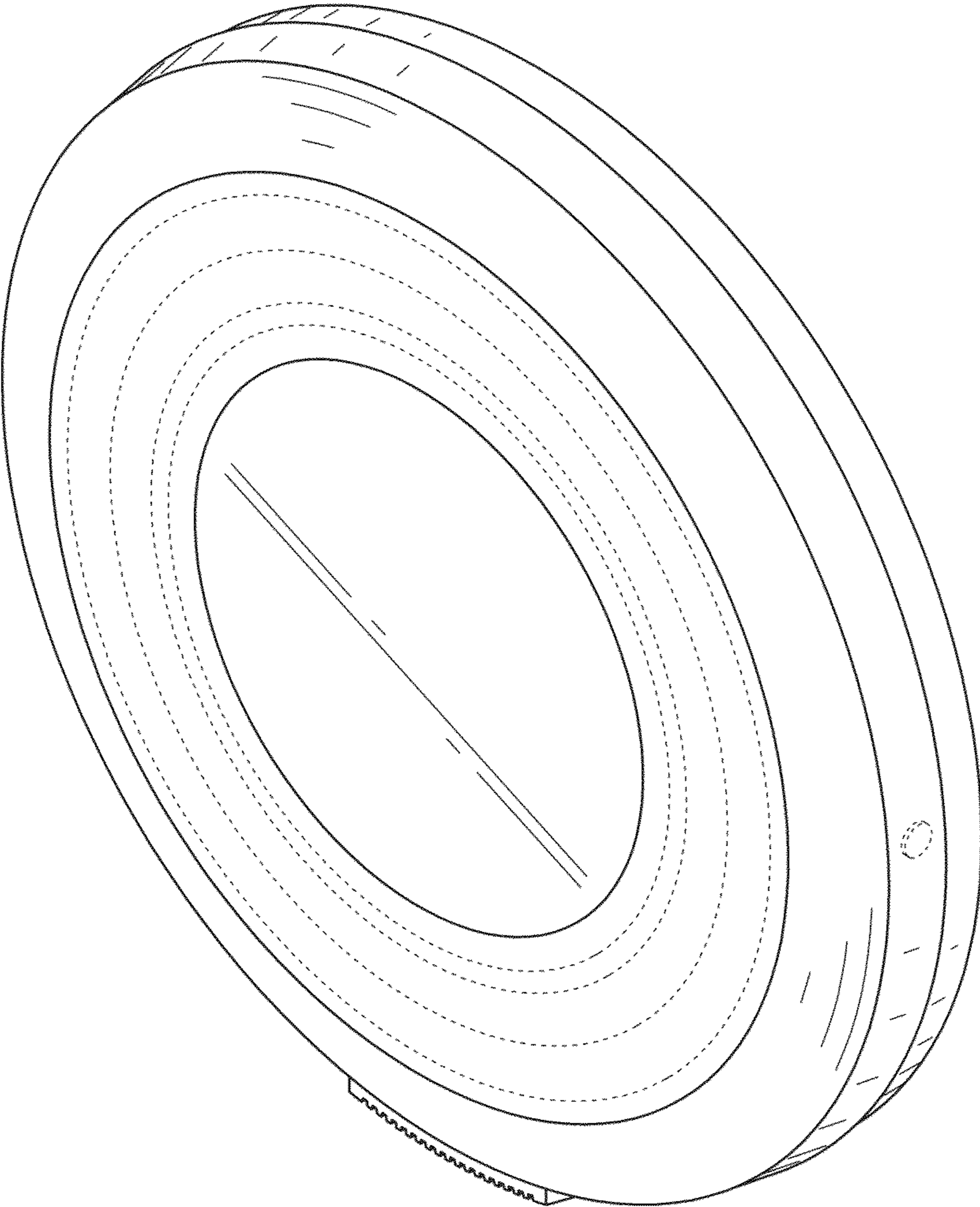

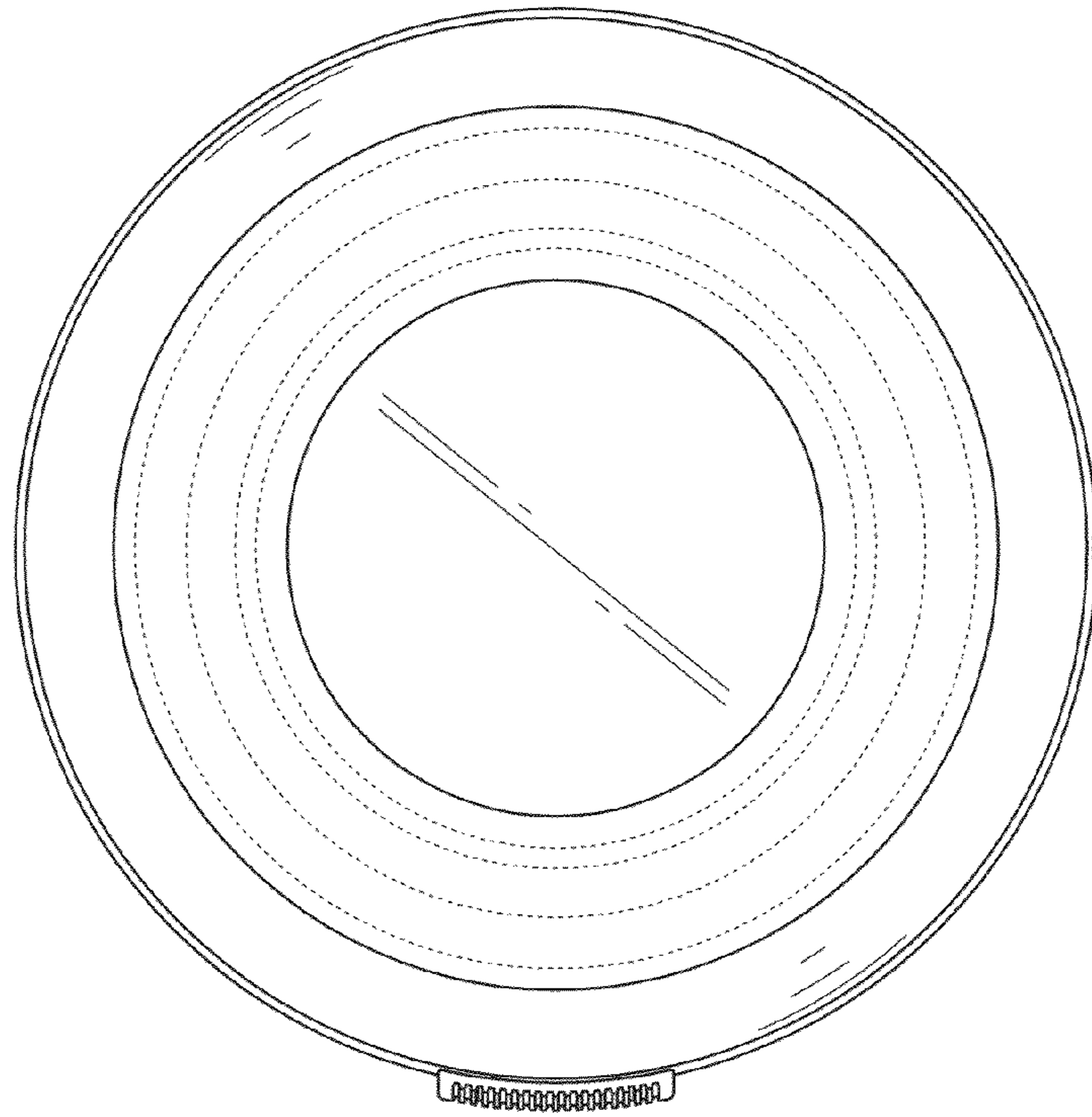

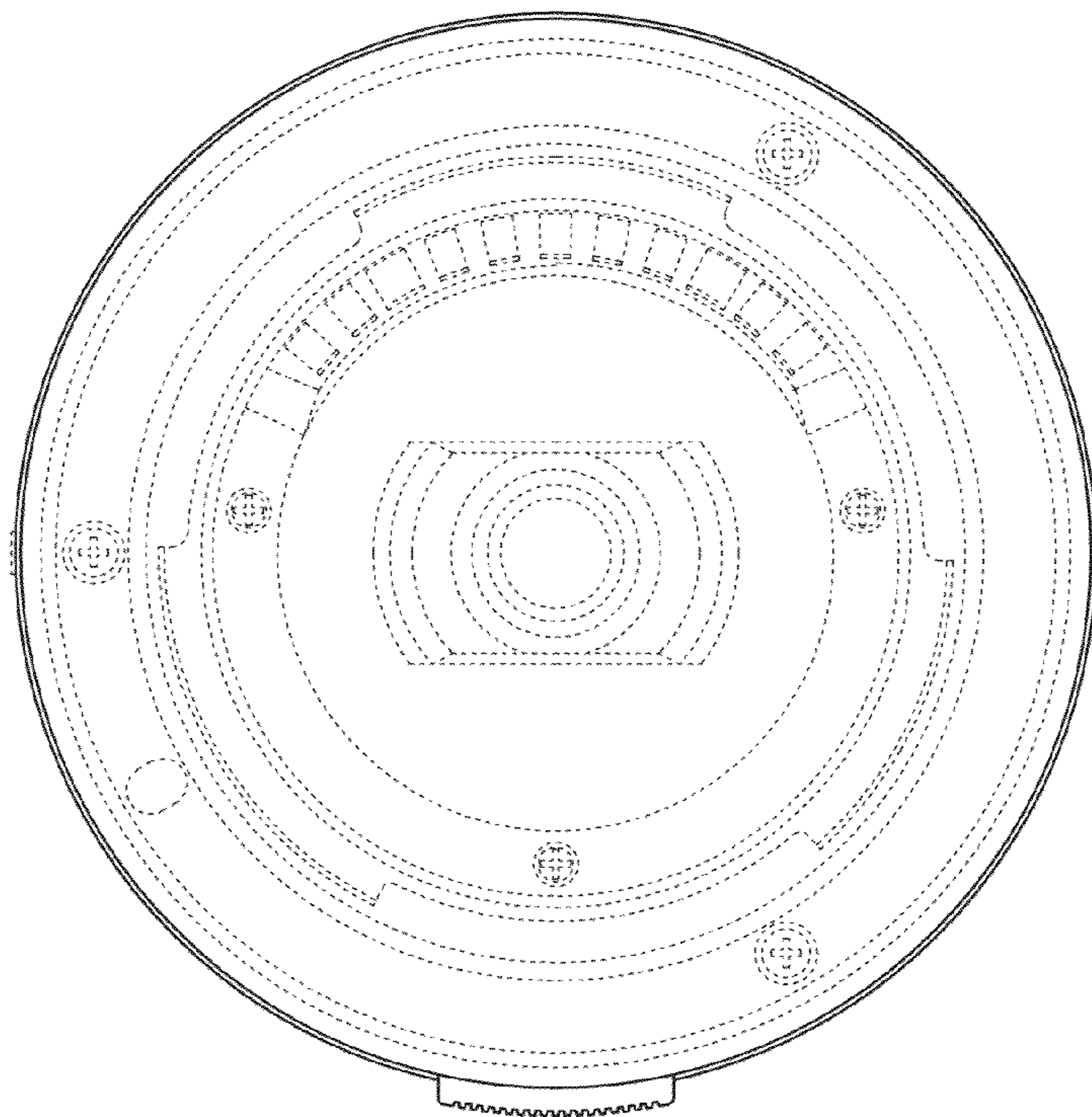

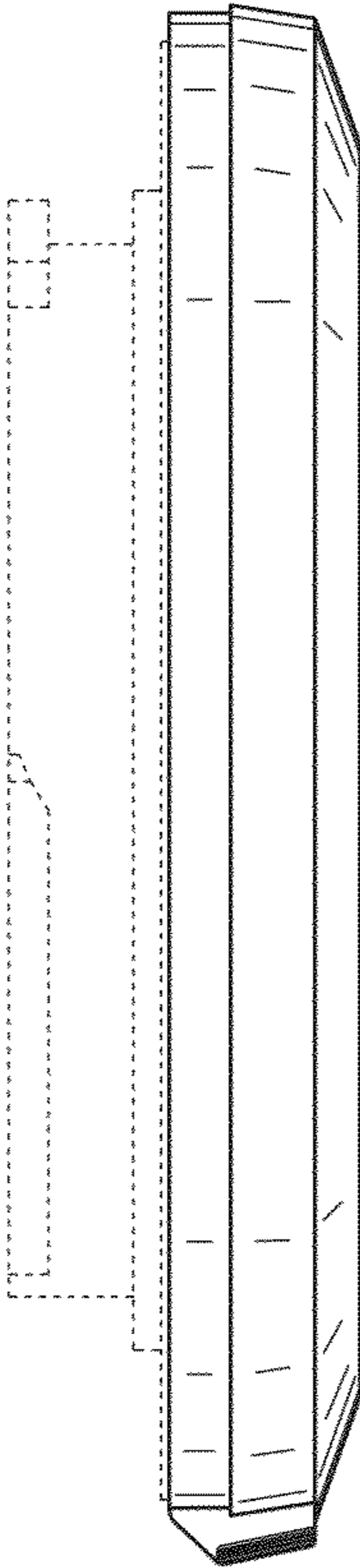

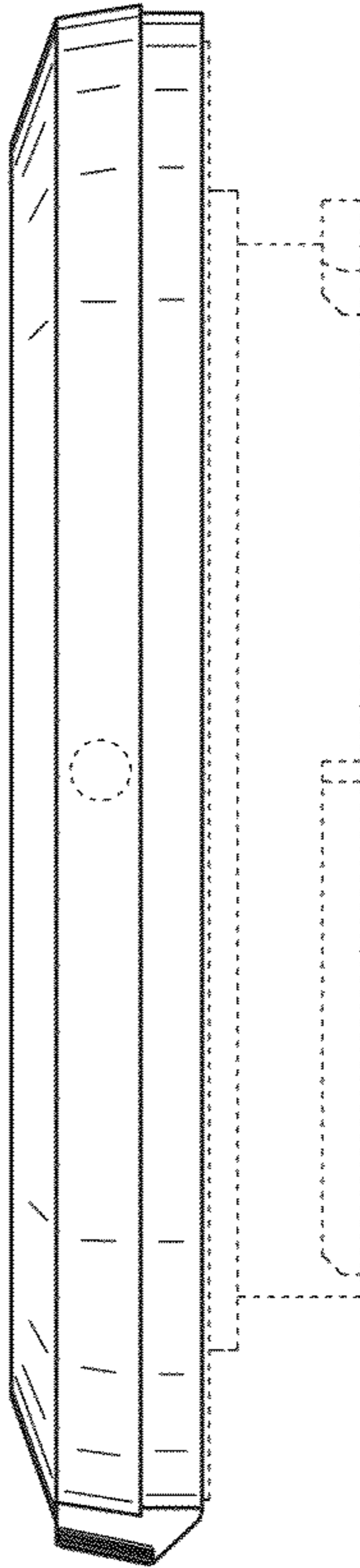

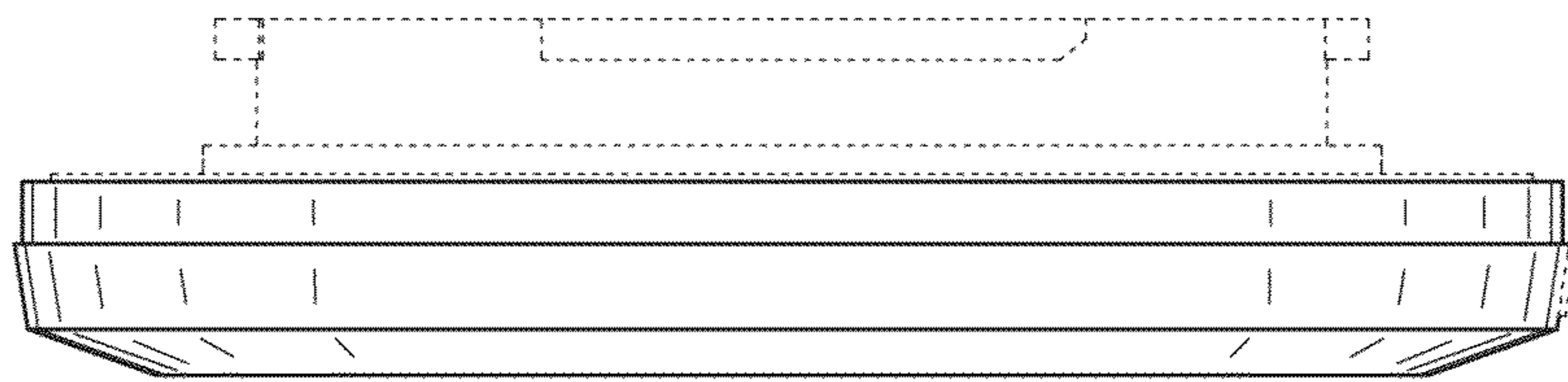
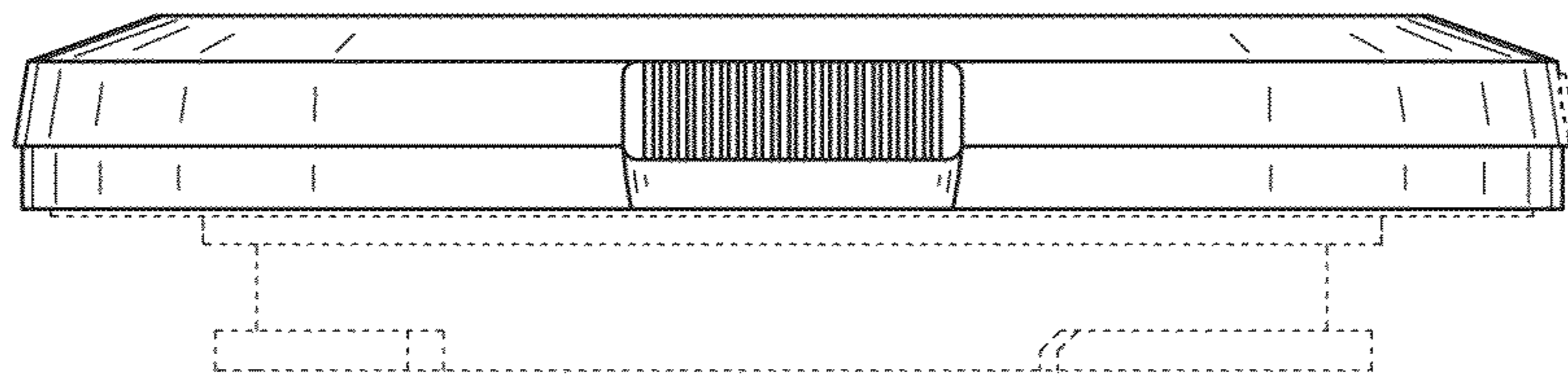
