(57) **CLAIM**

I claim the ornamental design for a prosthetic knee, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing a new design for a prosthetic knee;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear side view thereof;

FIG. 5 is a left side view thereof;

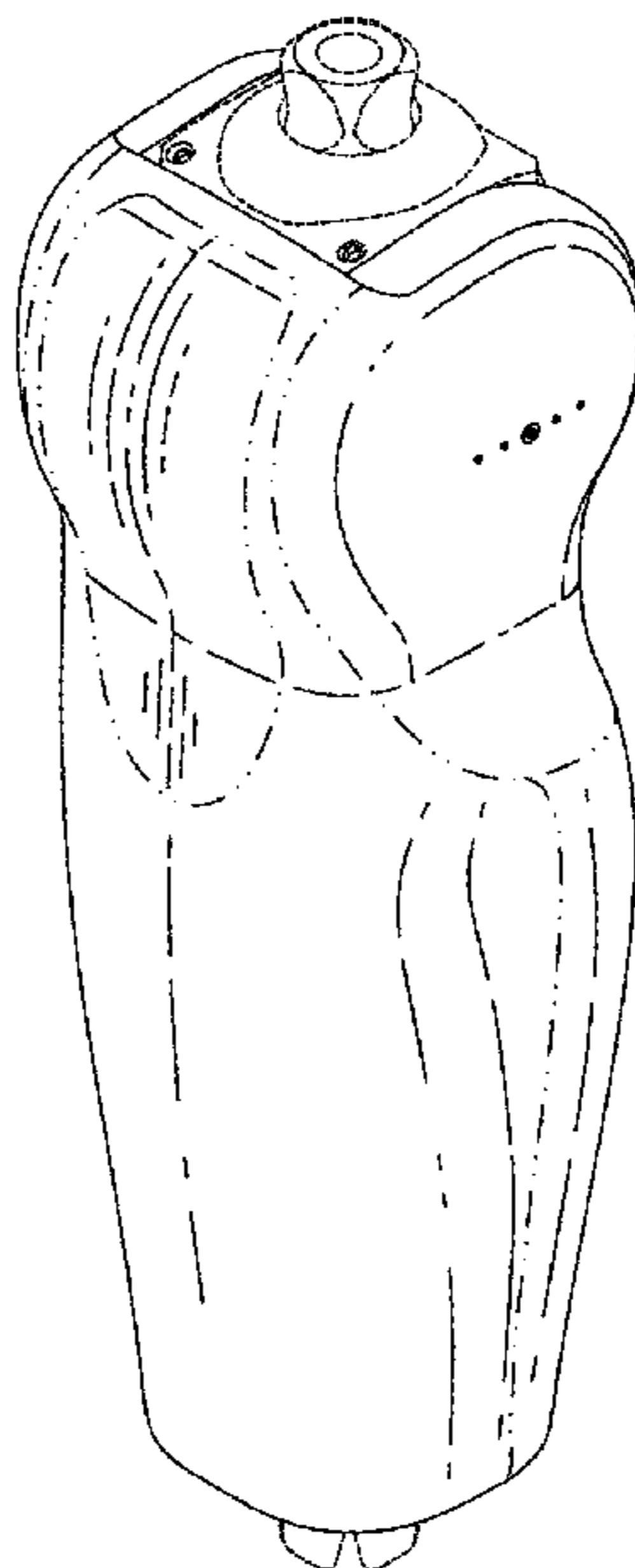
FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof; and,

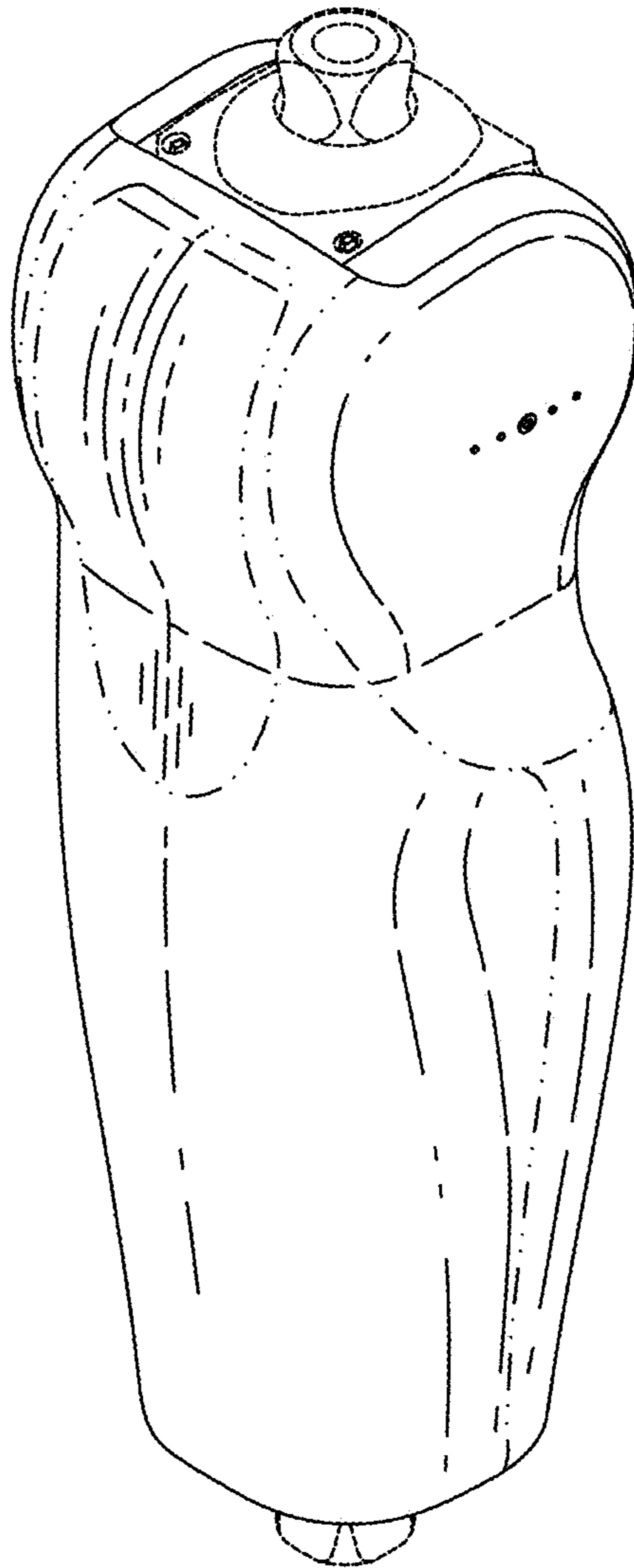

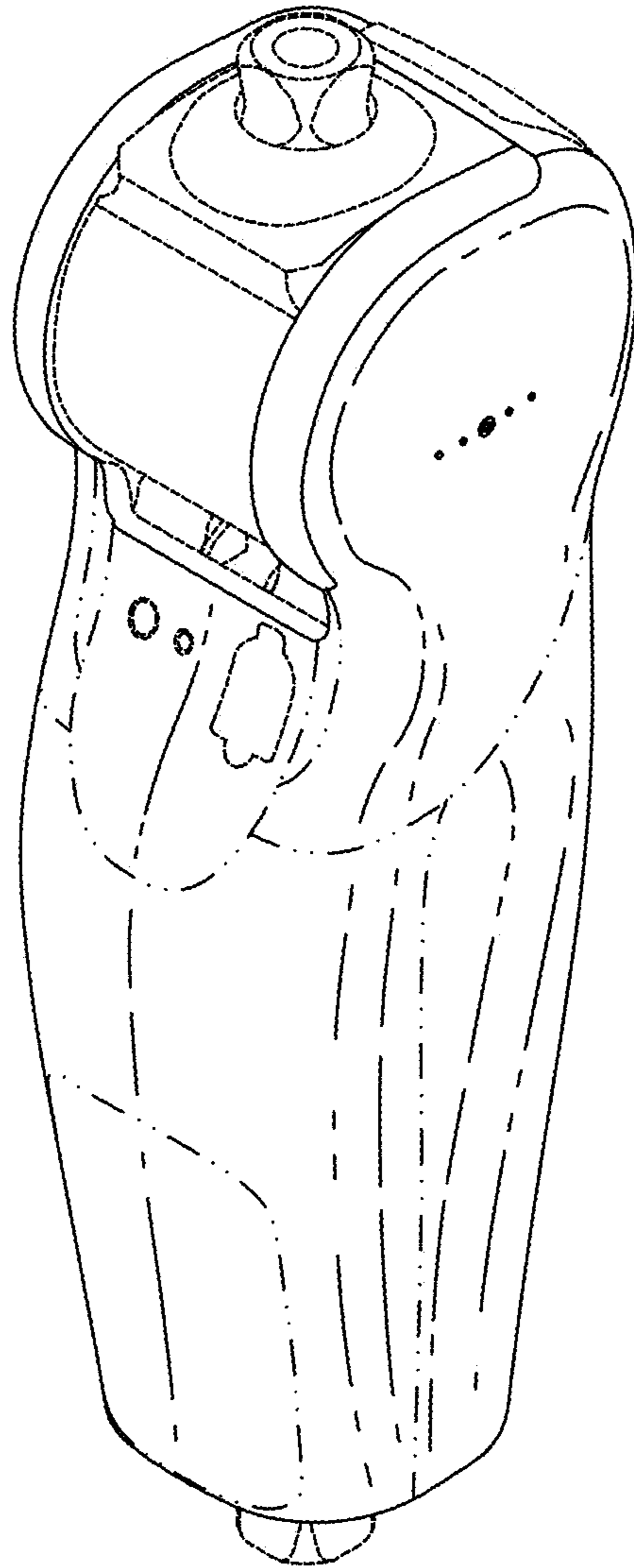

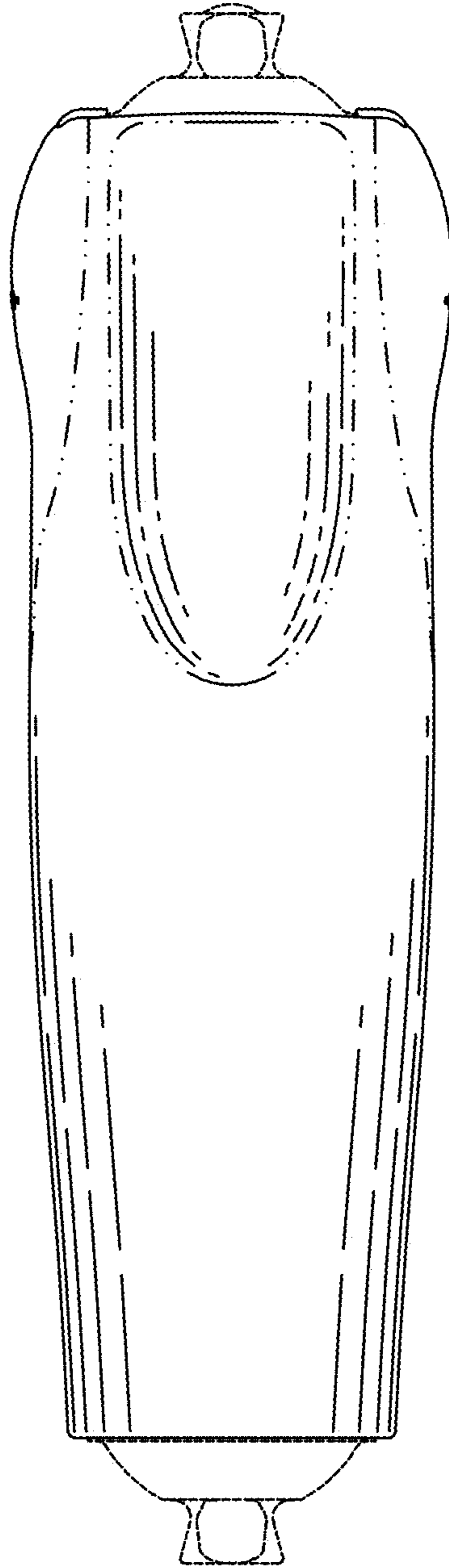

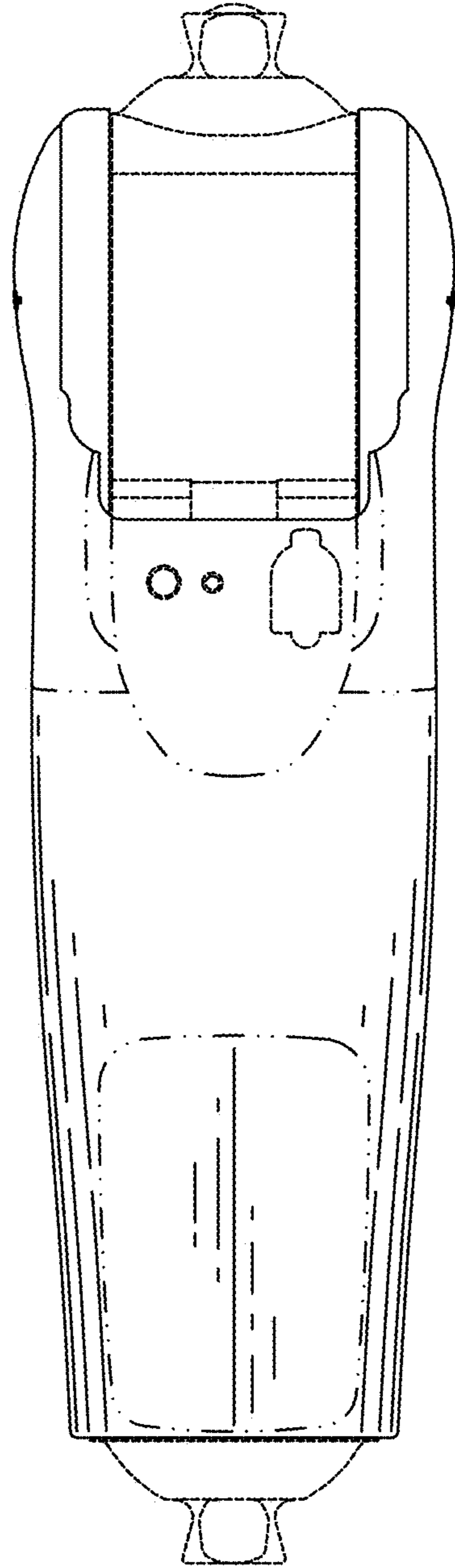

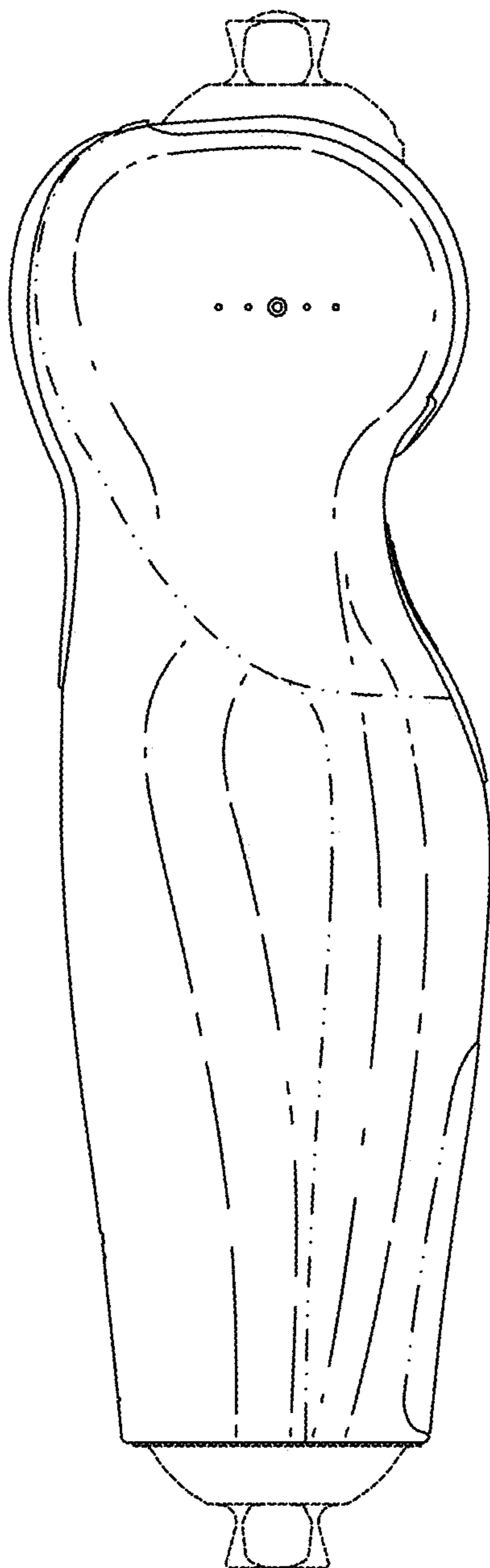

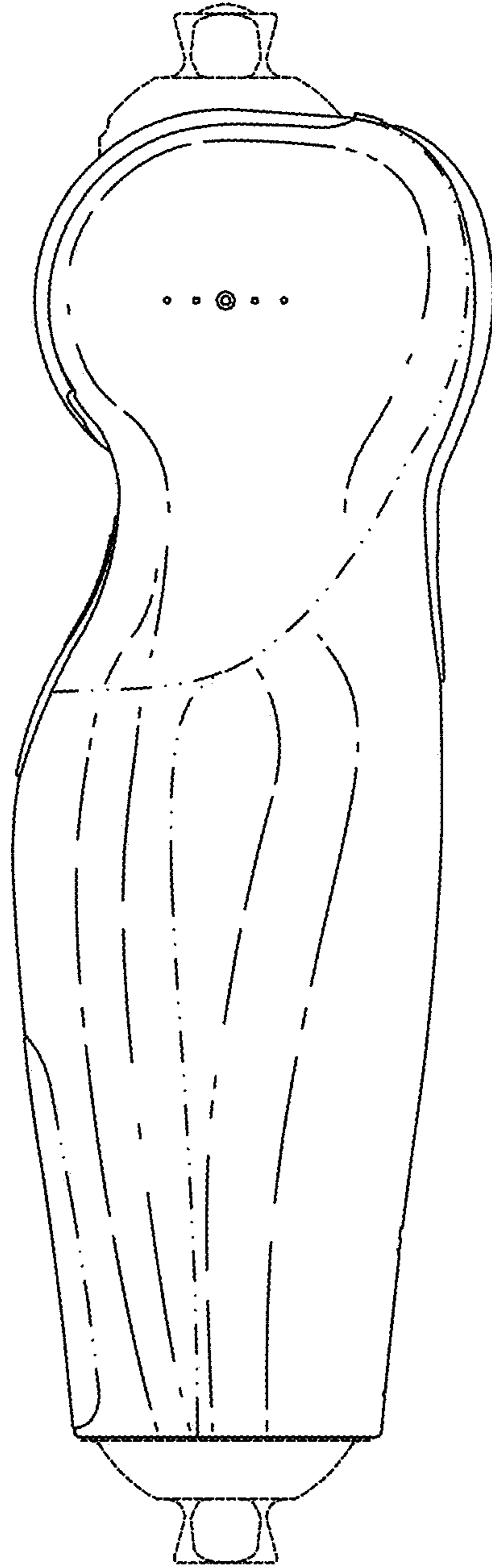

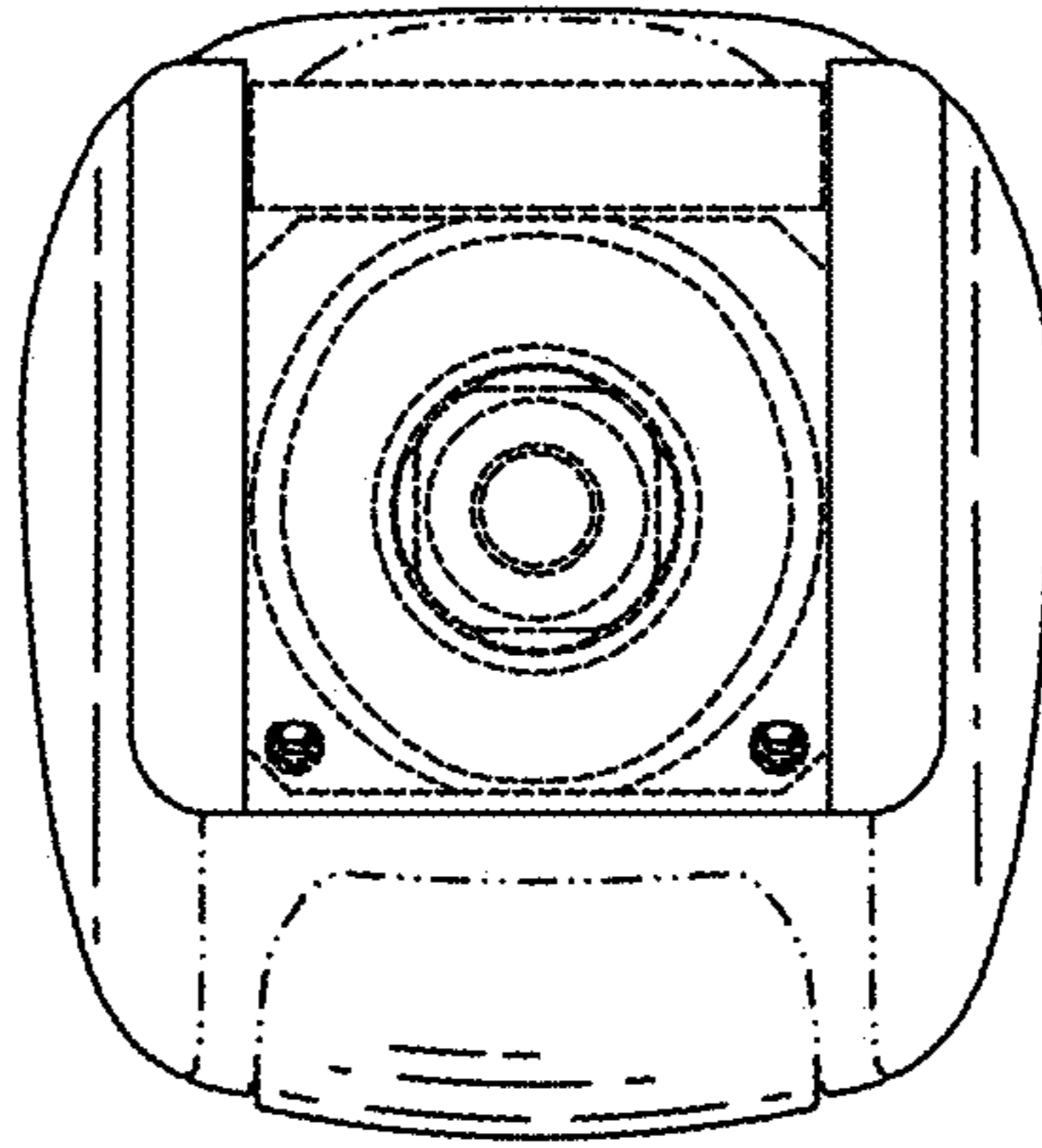

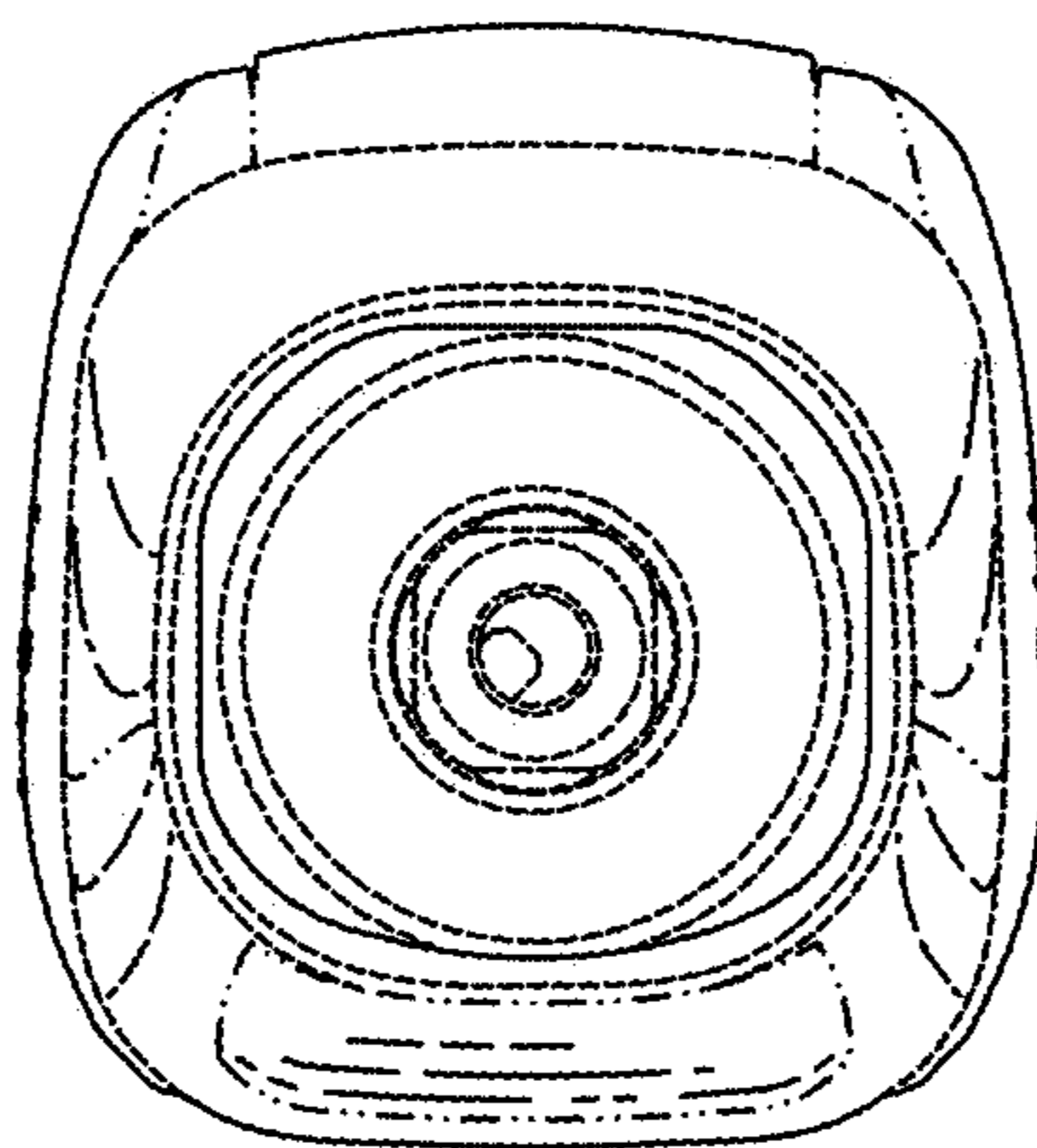
