DESCRIPTION

FIG. 1 is a front perspective view of a back support showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof, the left side view being a mirror image of FIG. 3;

FIG. 4 is a bottom view thereof;

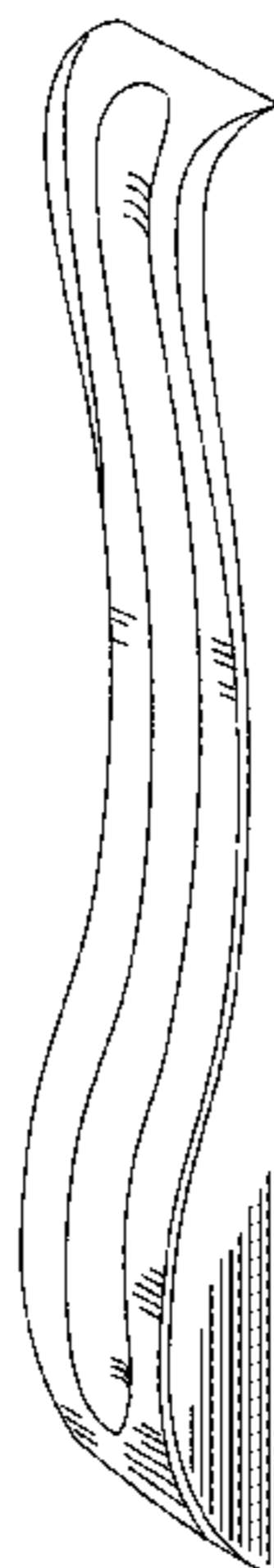
FIG. 5 is a top view thereof;

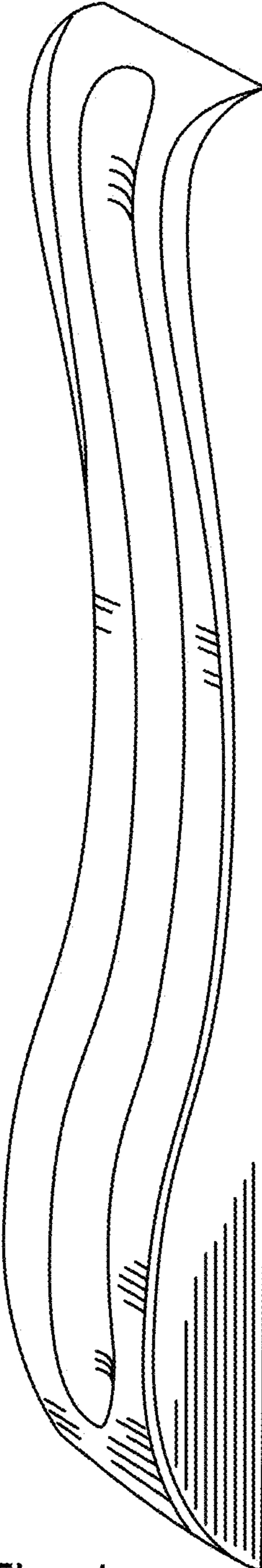

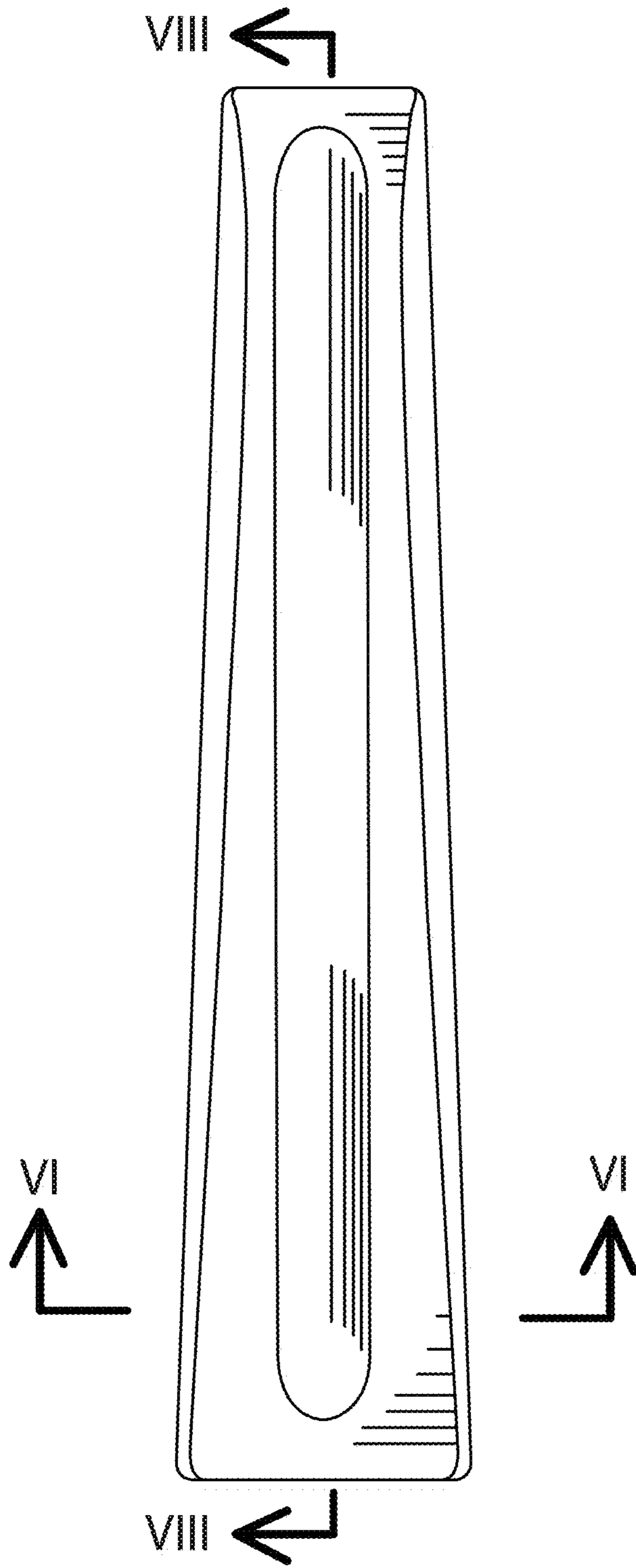

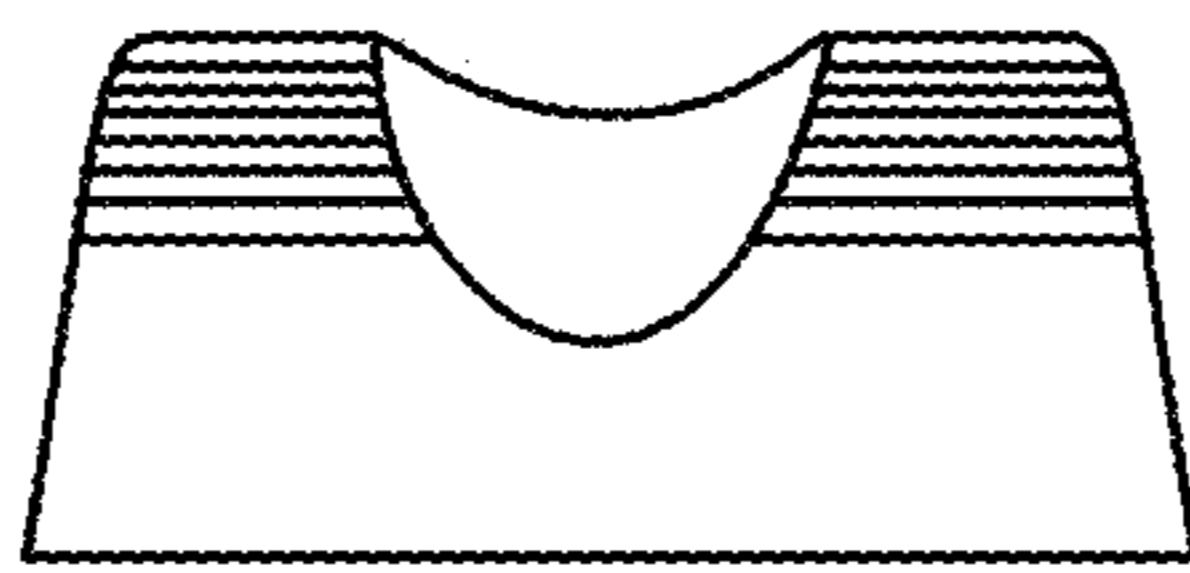

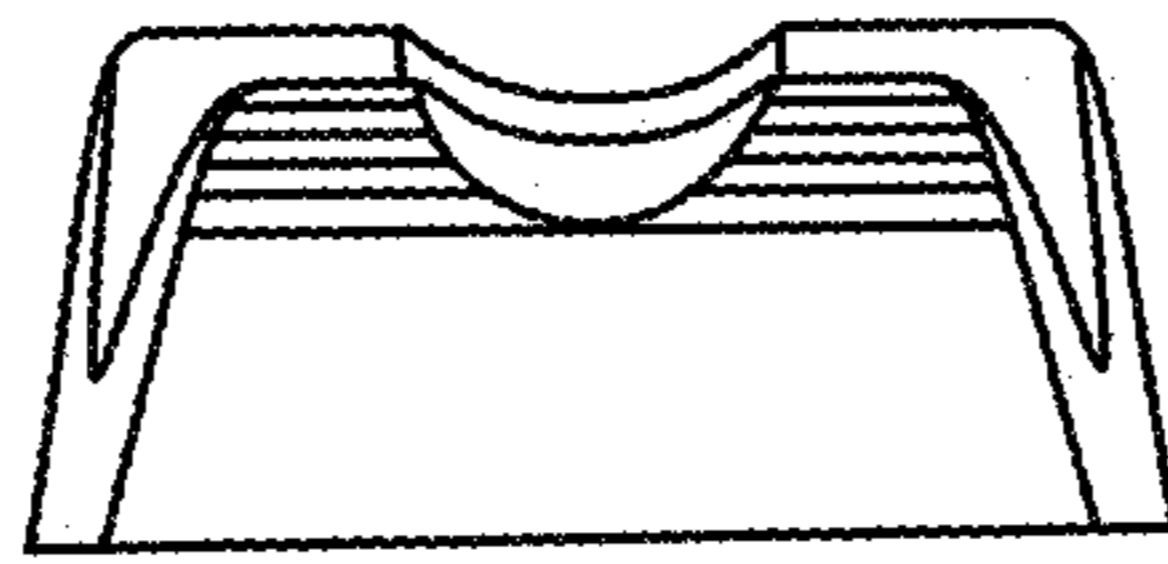

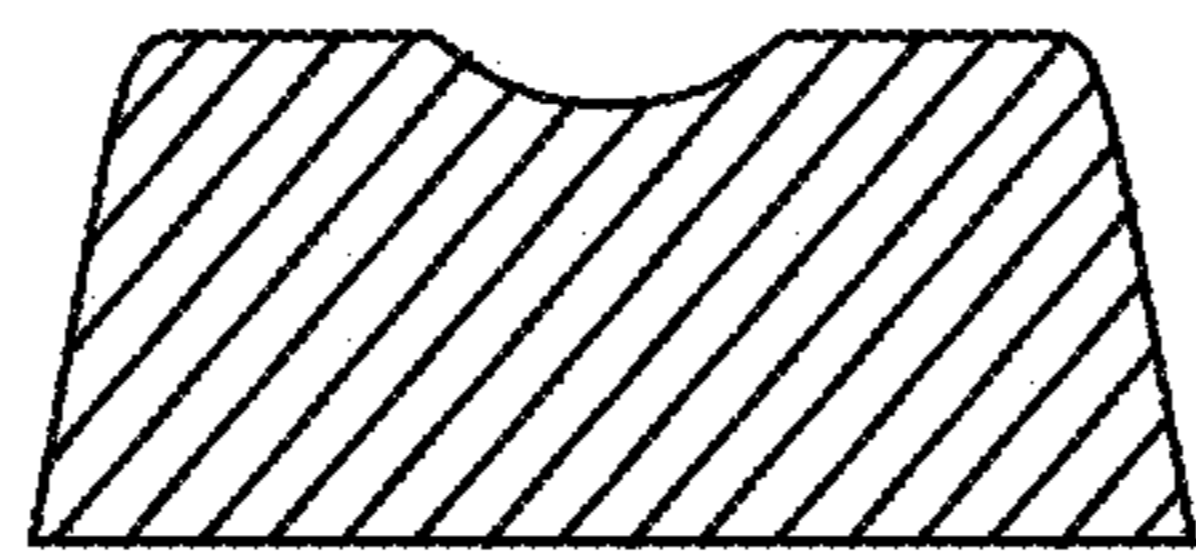

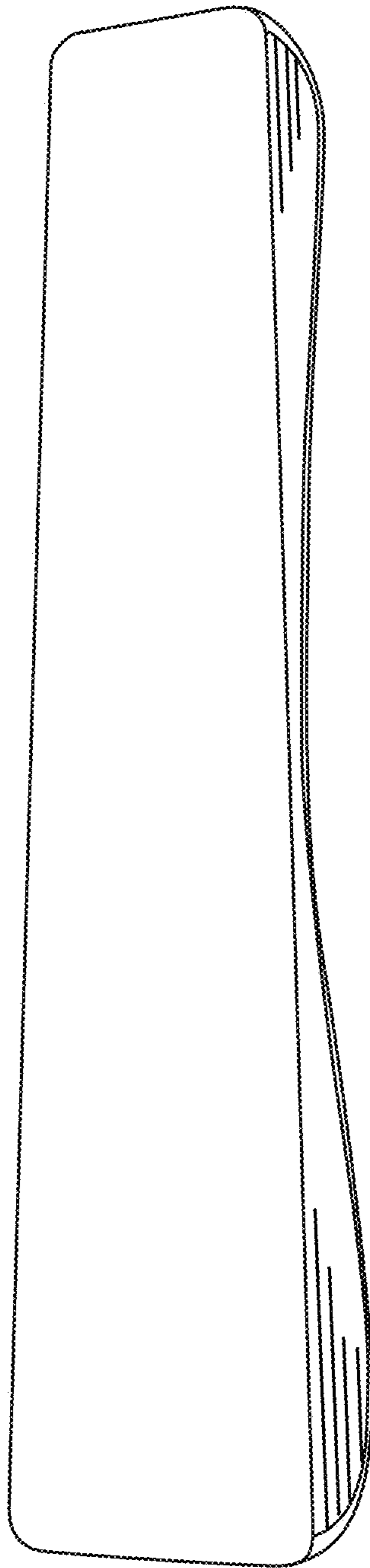

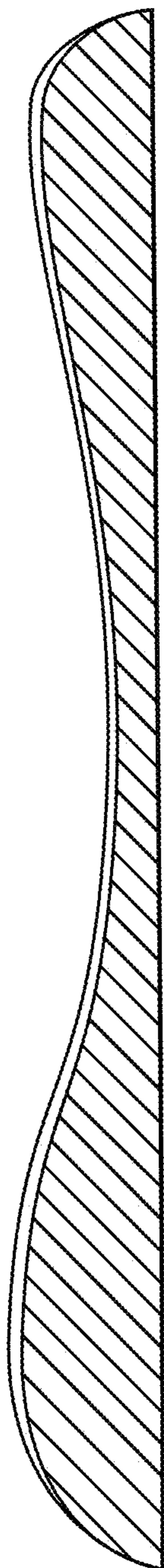
