(57) **CLAIM**

The ornamental design for a pacifier holder, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right perspective view of a pacifier holder showing my new design;

FIG. 4 is a left side view thereof;

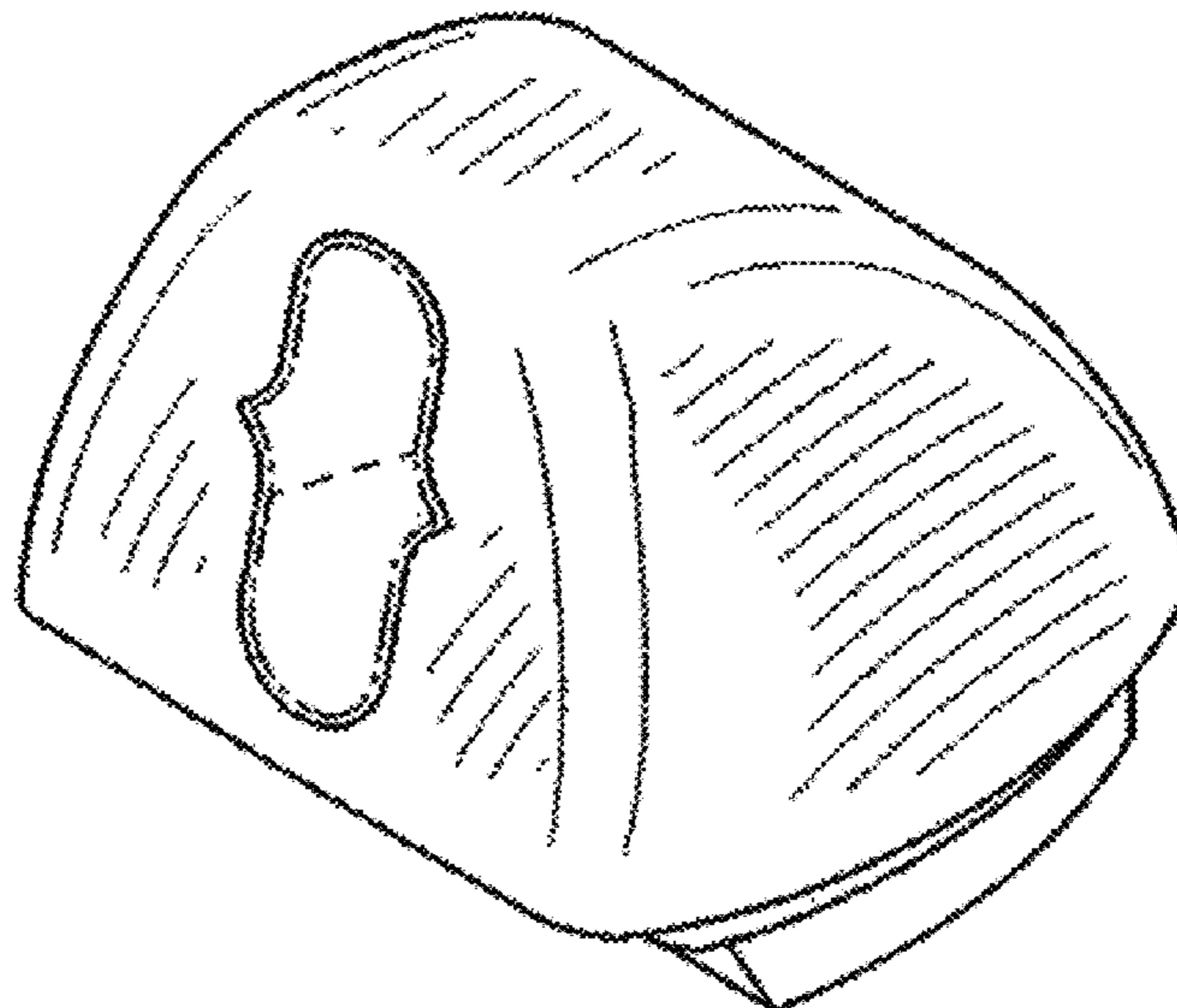
FIG. 5 is a right side view thereof;

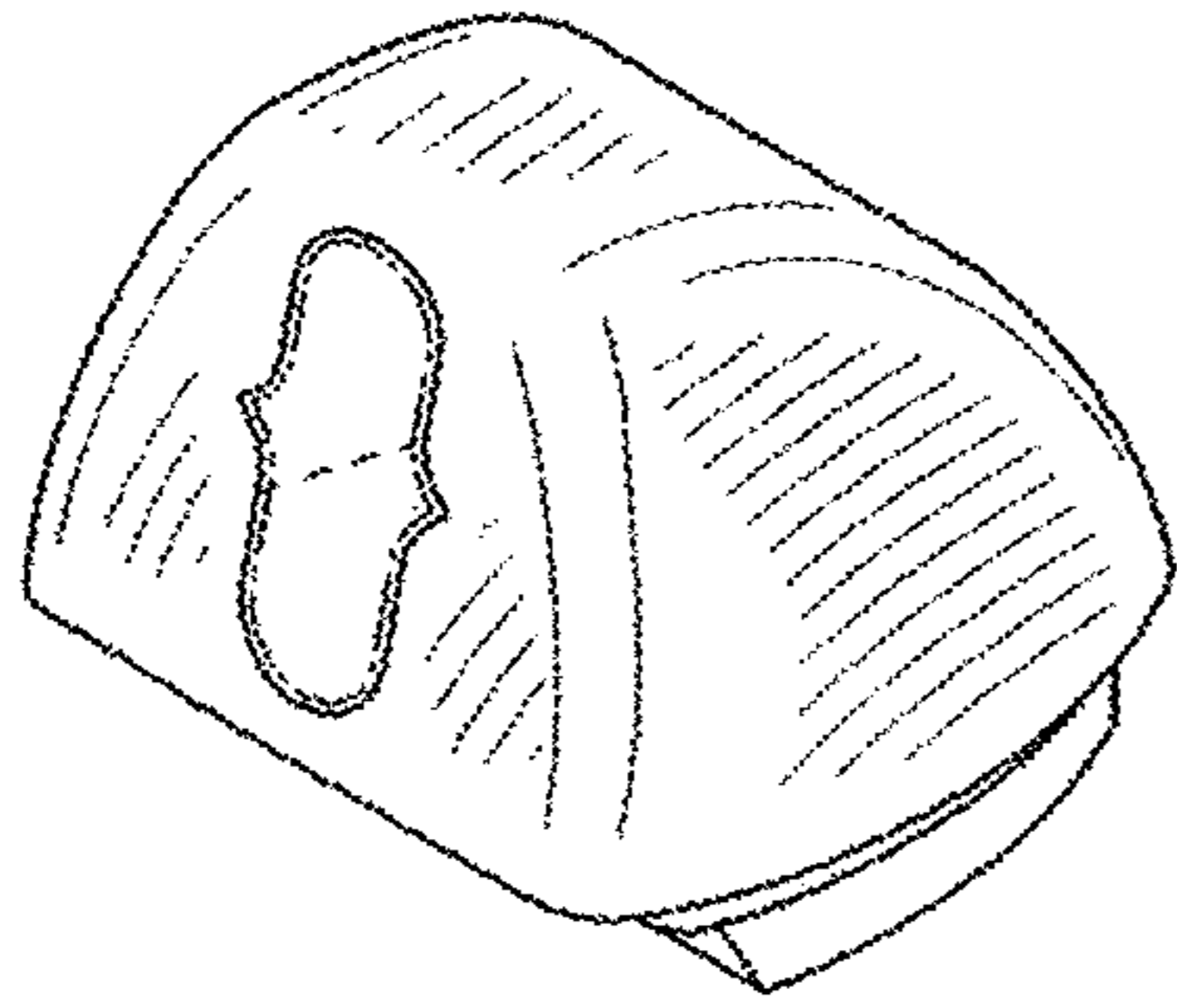

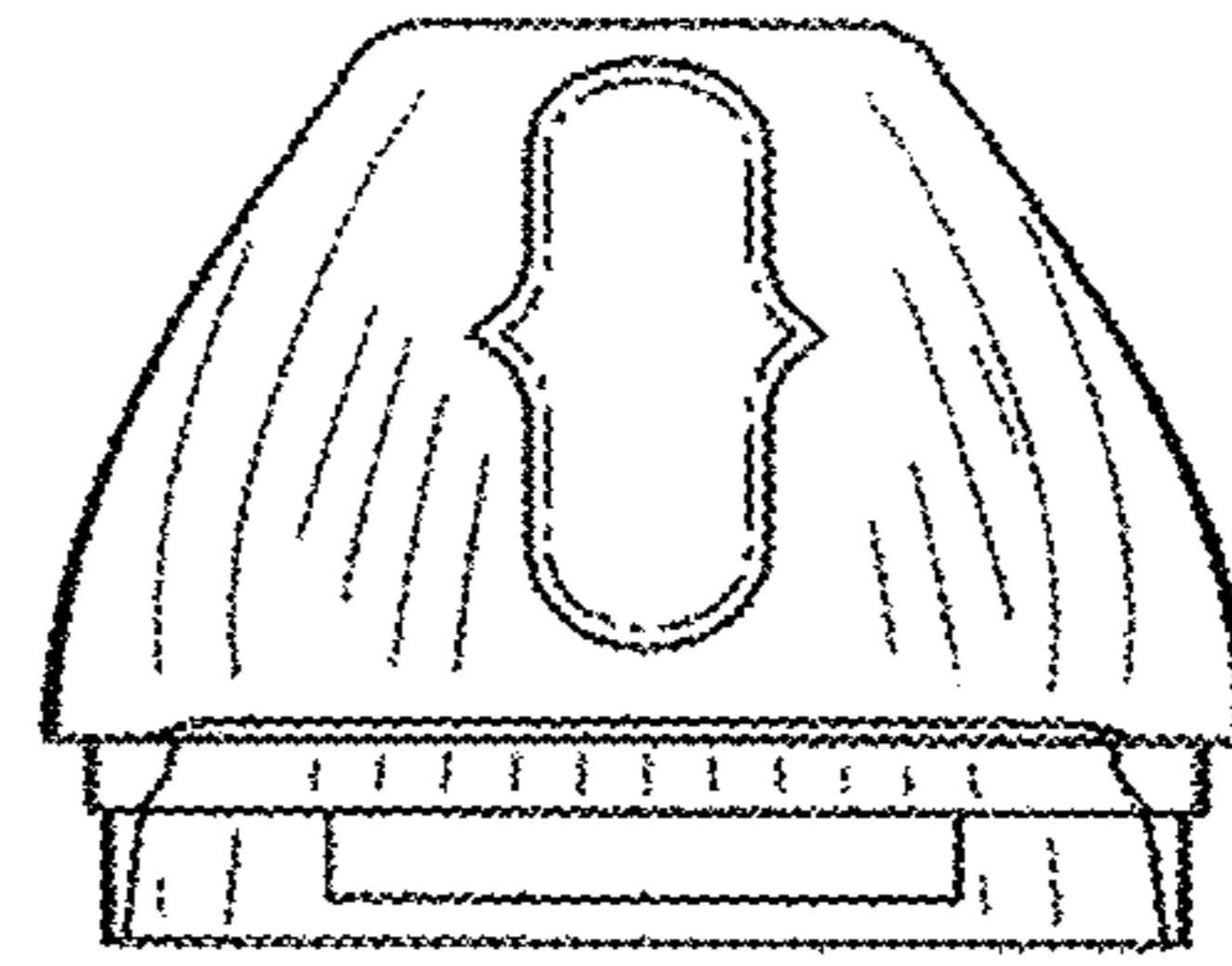

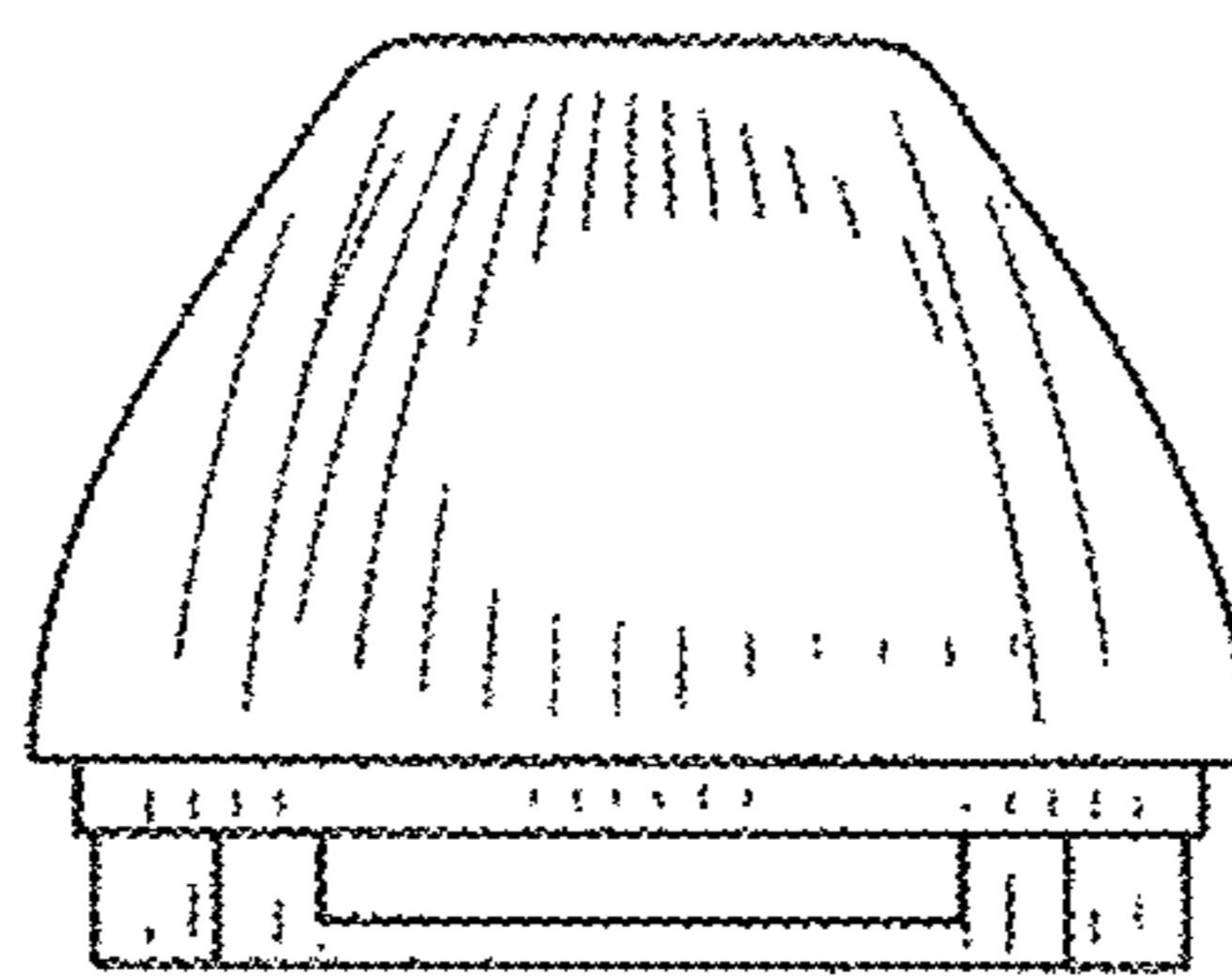

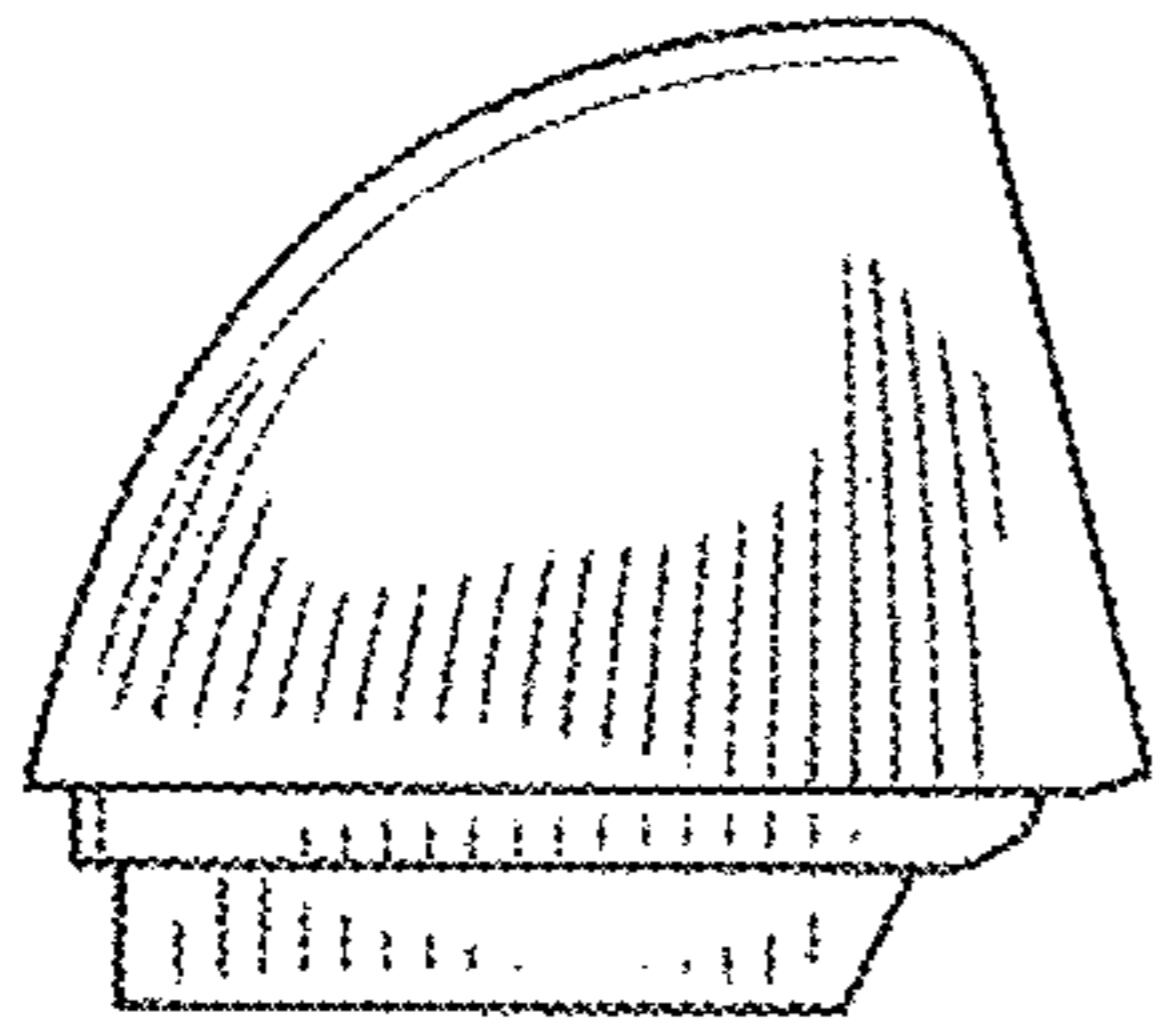

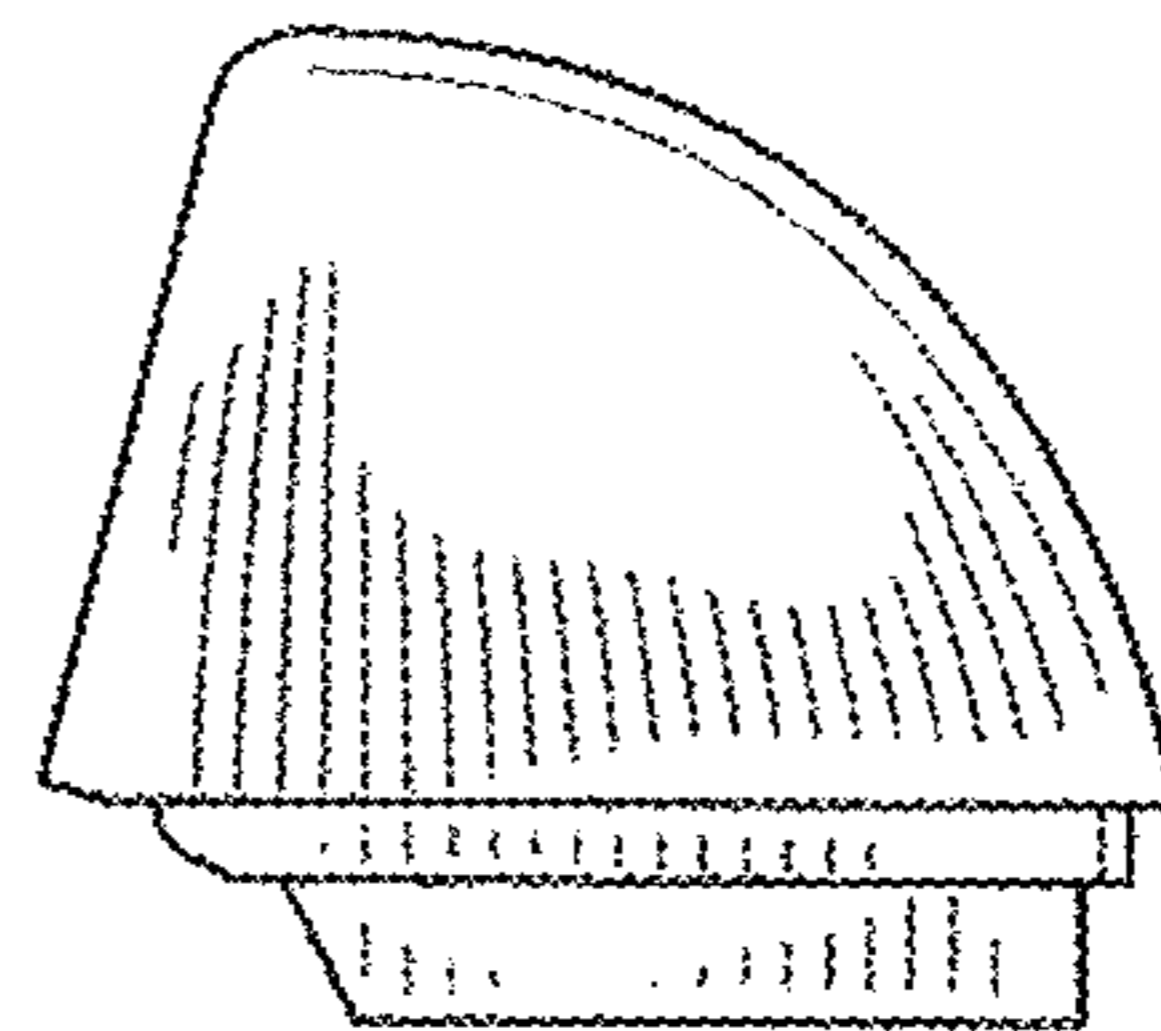

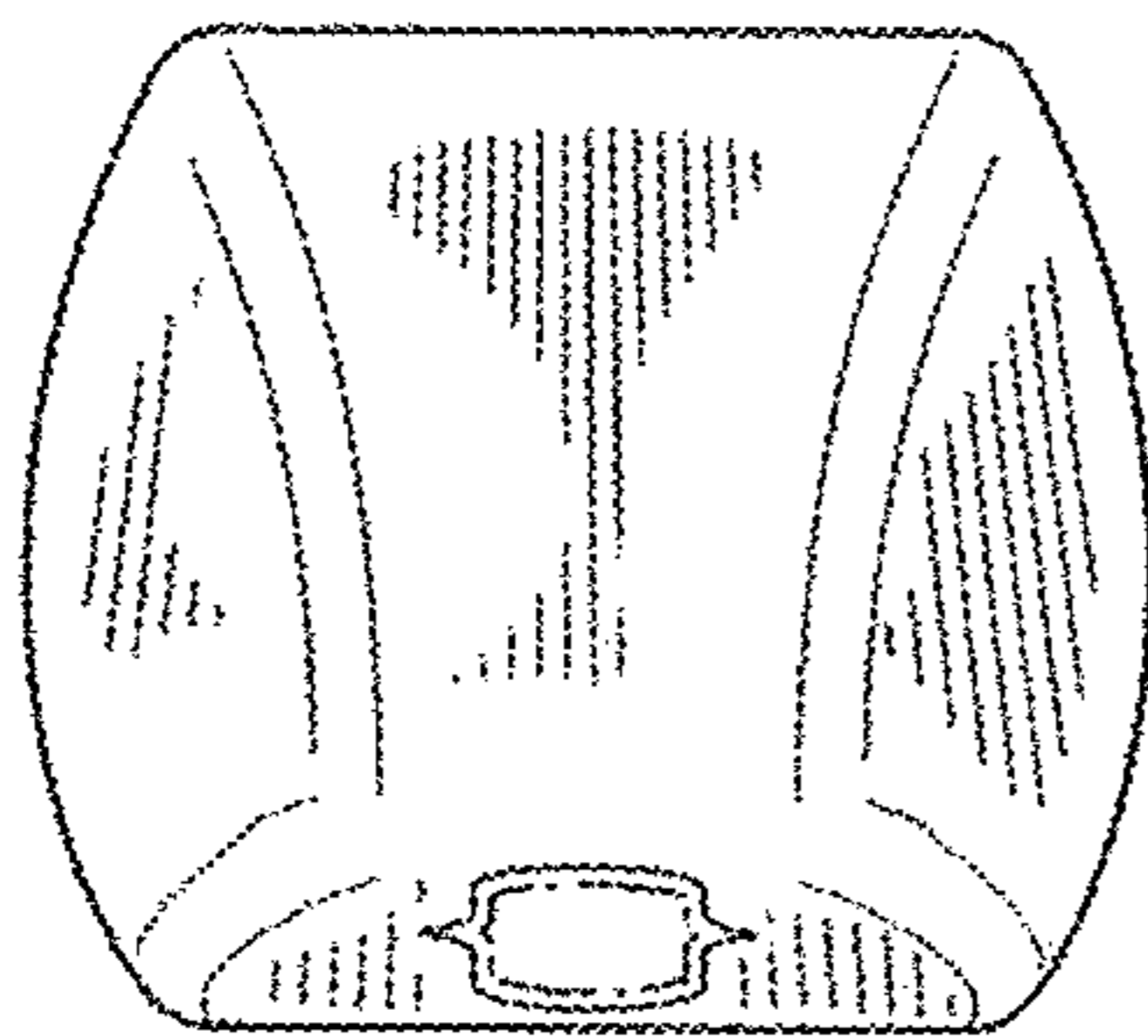

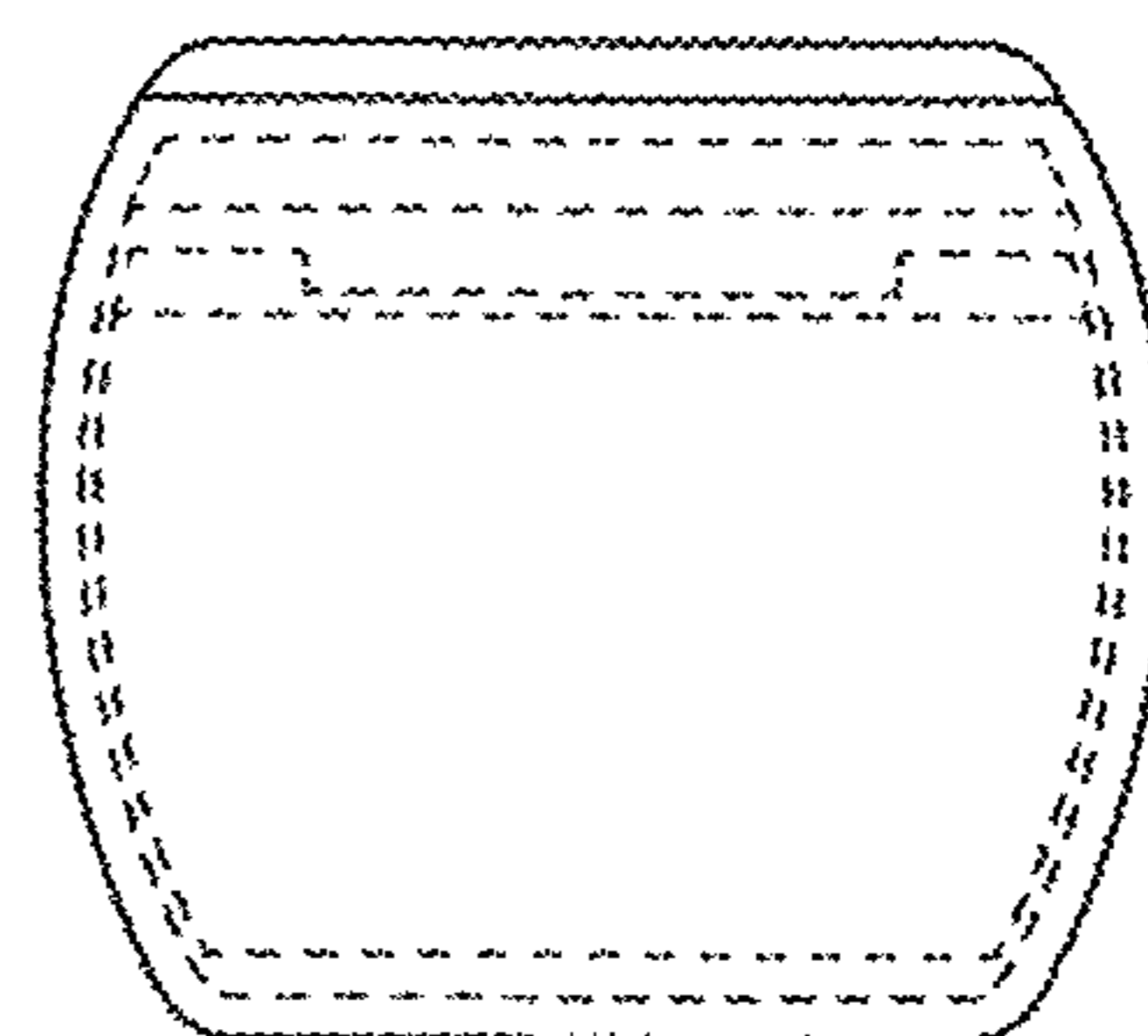
