DESCRIPTION

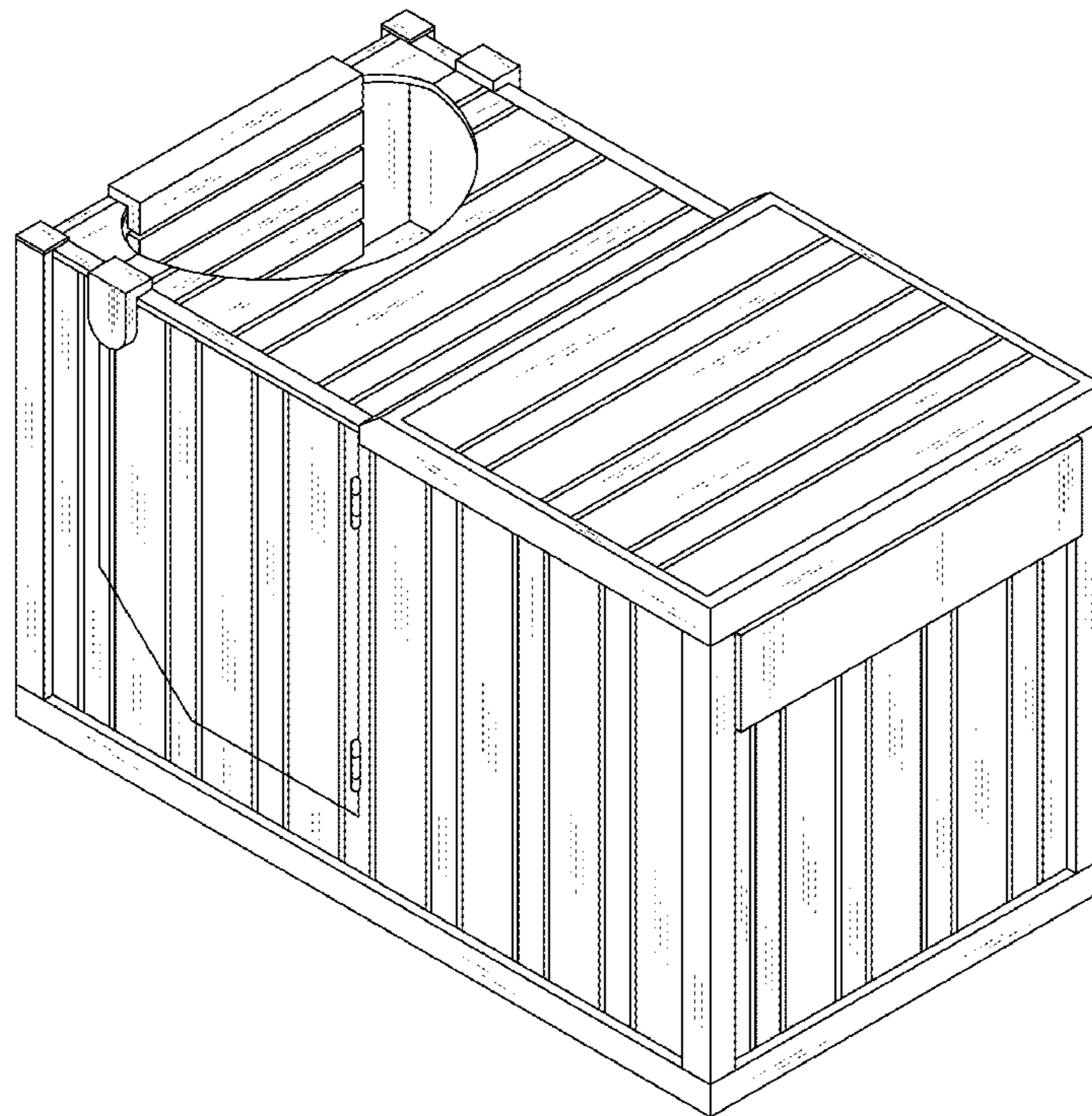
FIG. 1 is a bottom view of a sauna apparatus for half-bath showing our new design;

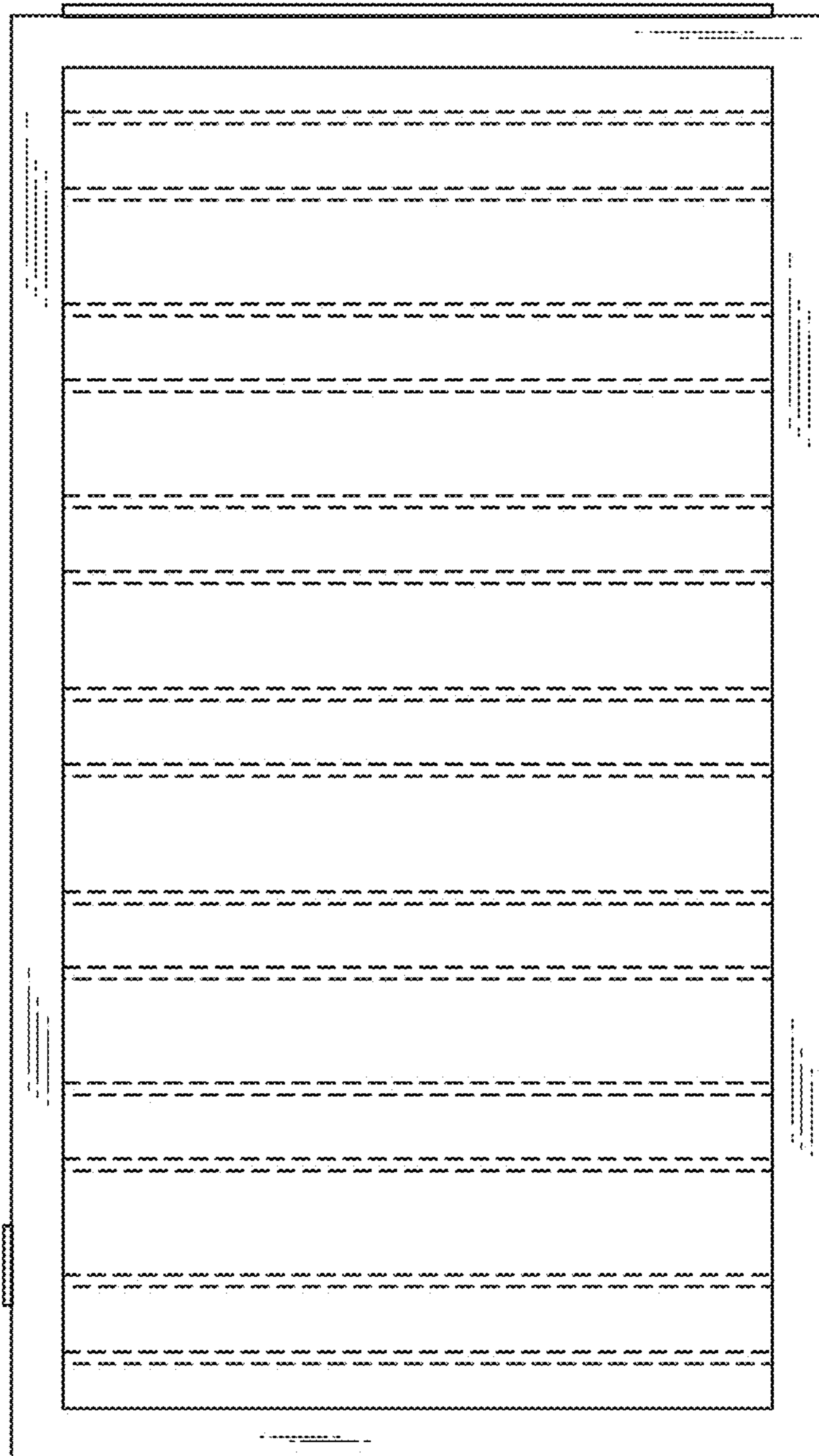

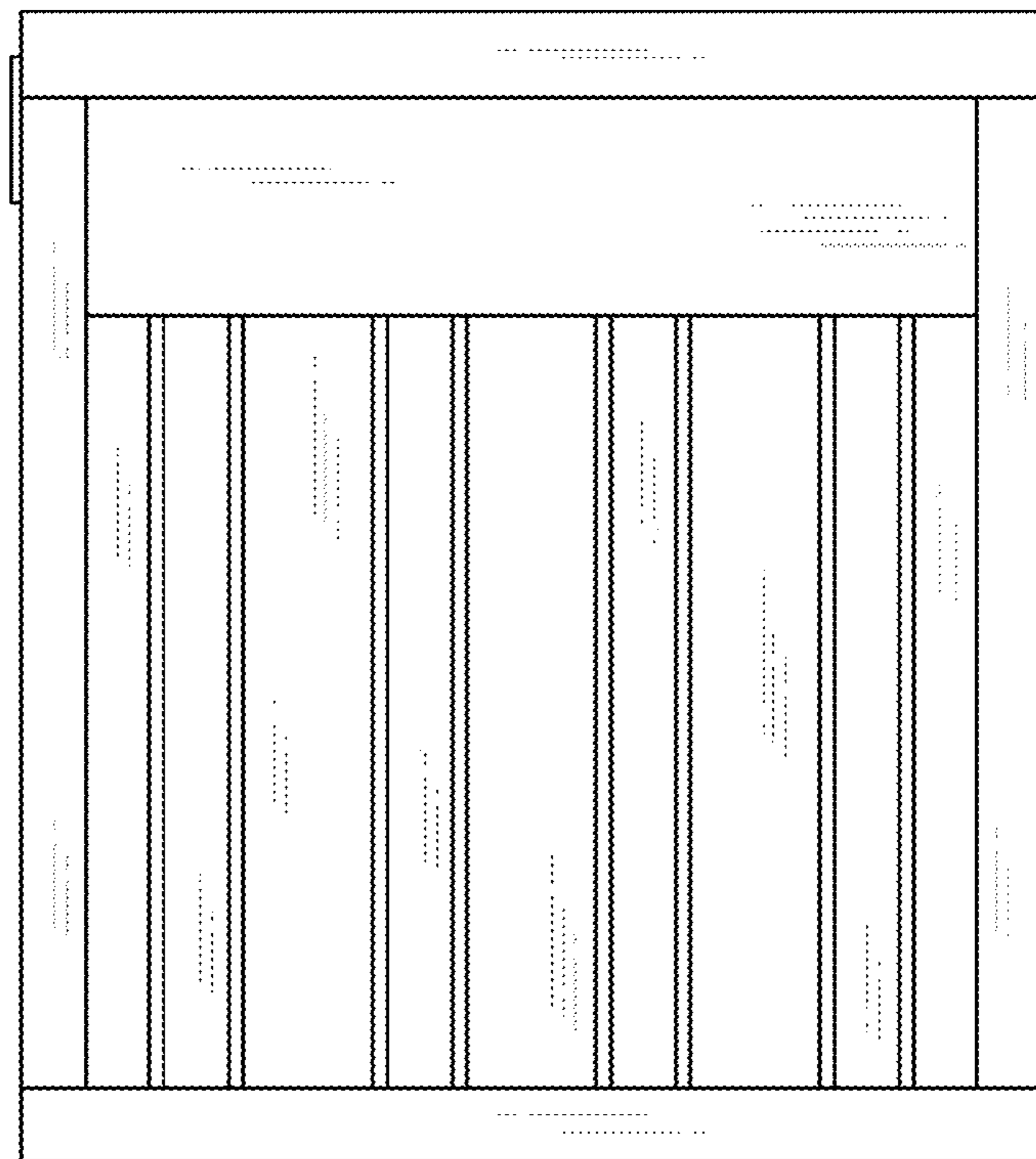

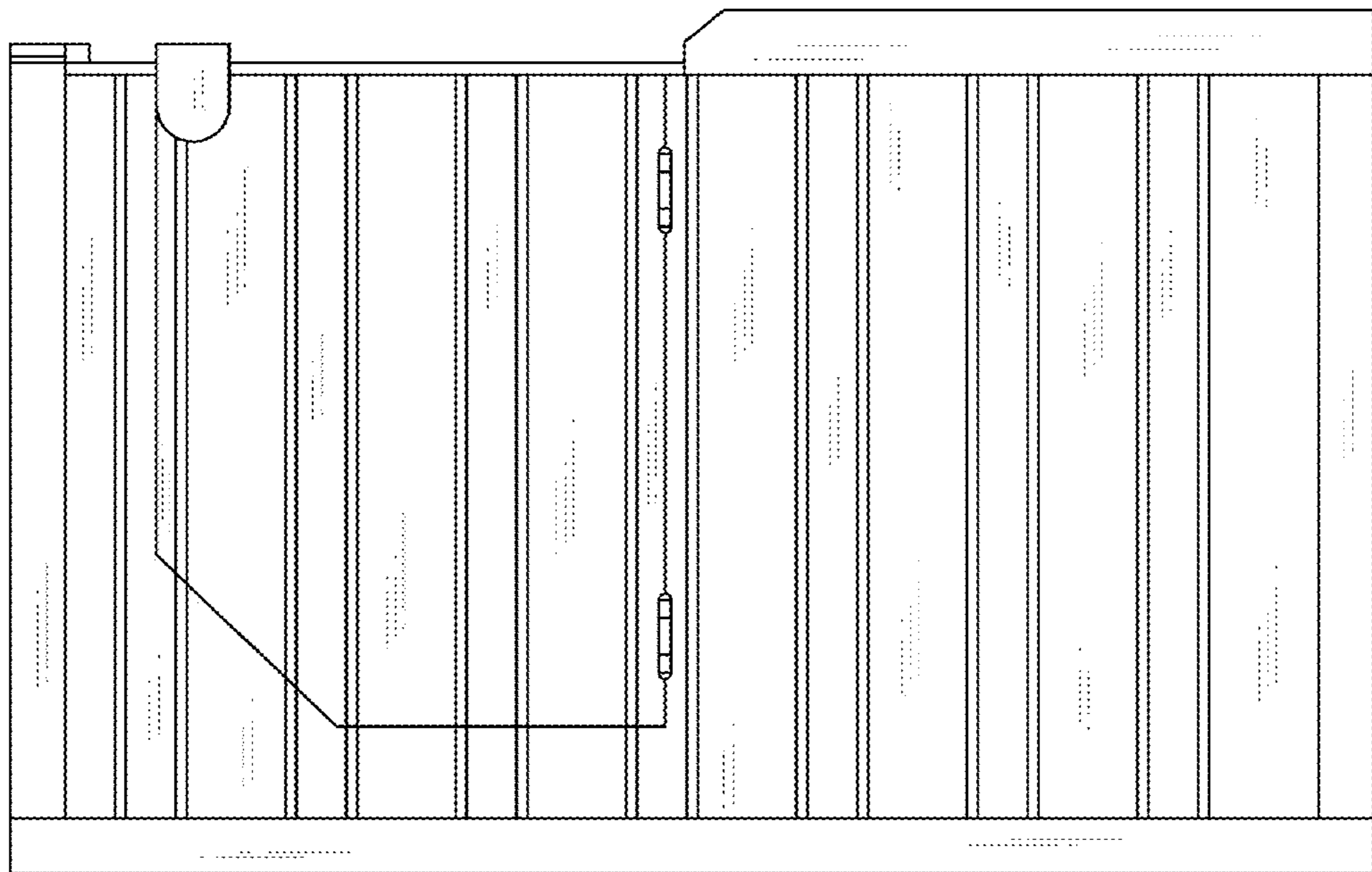

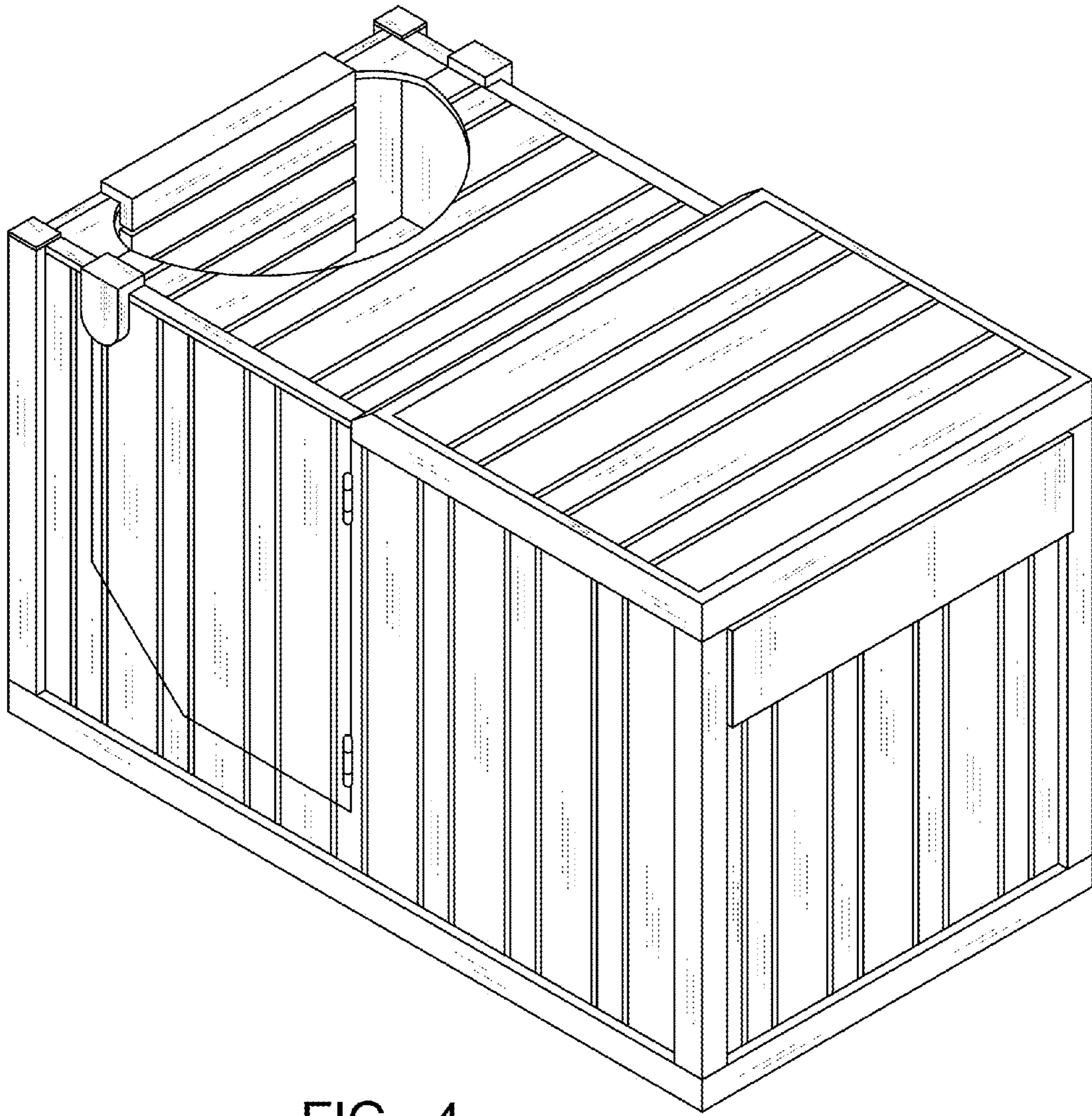

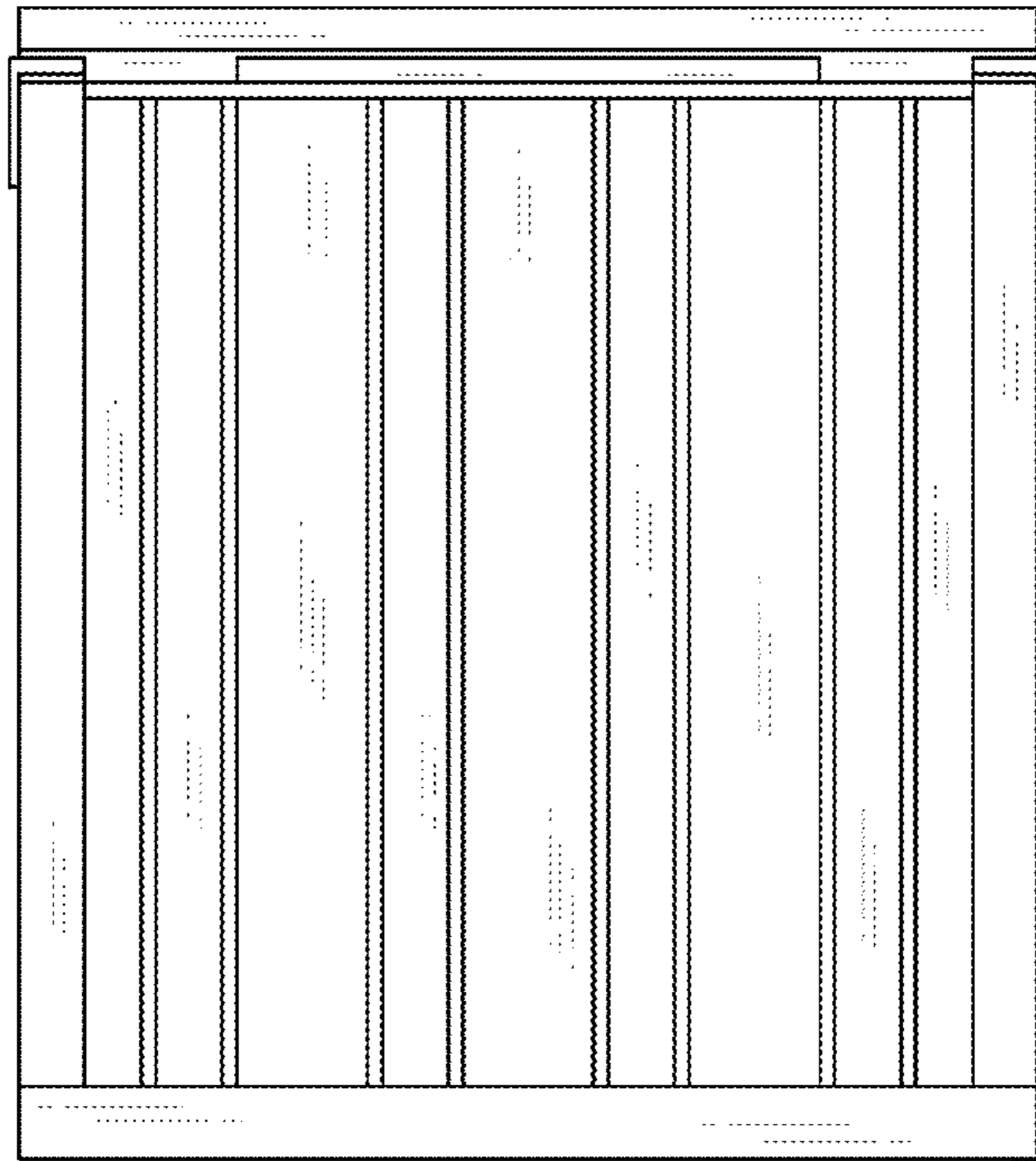

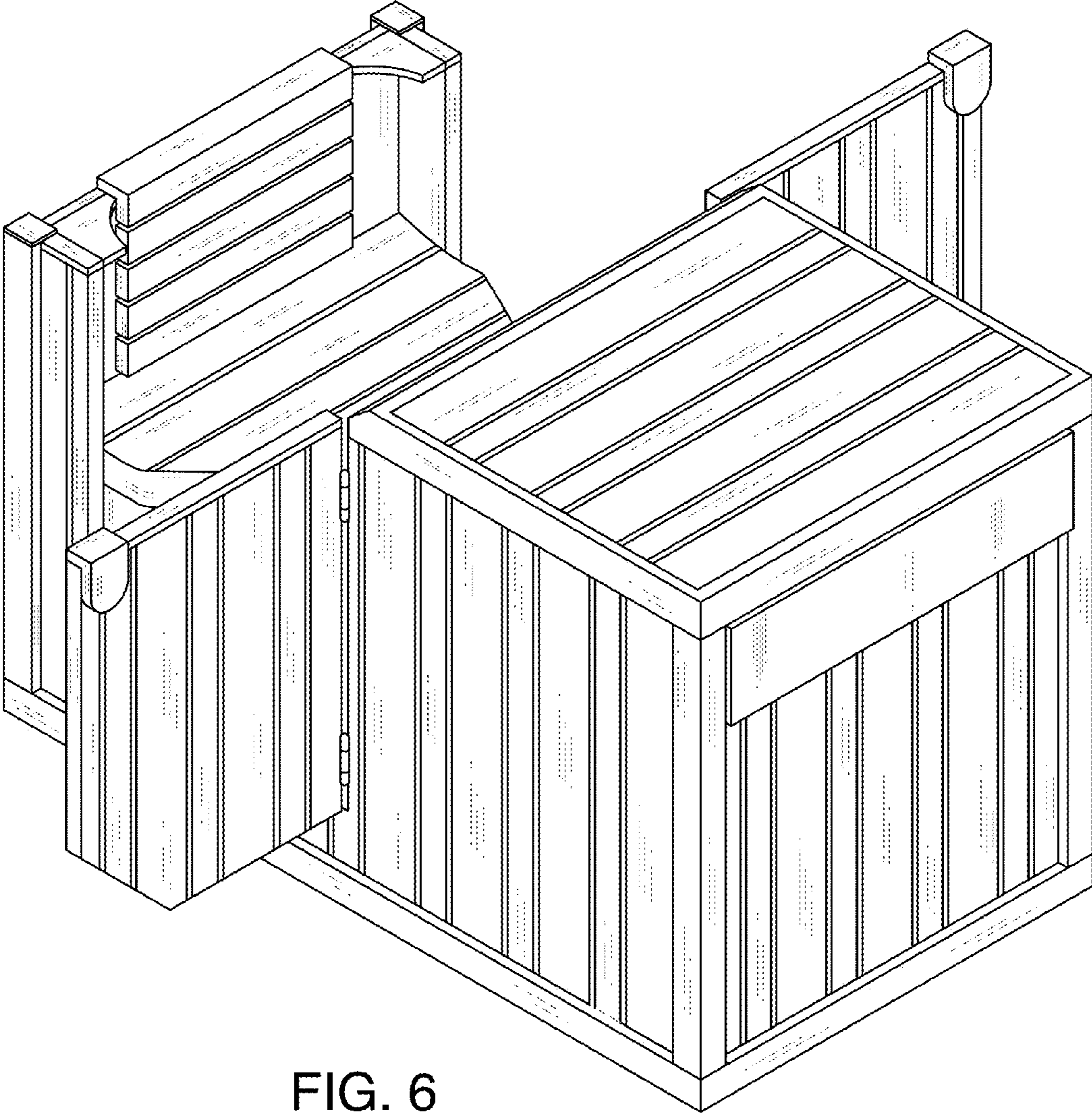

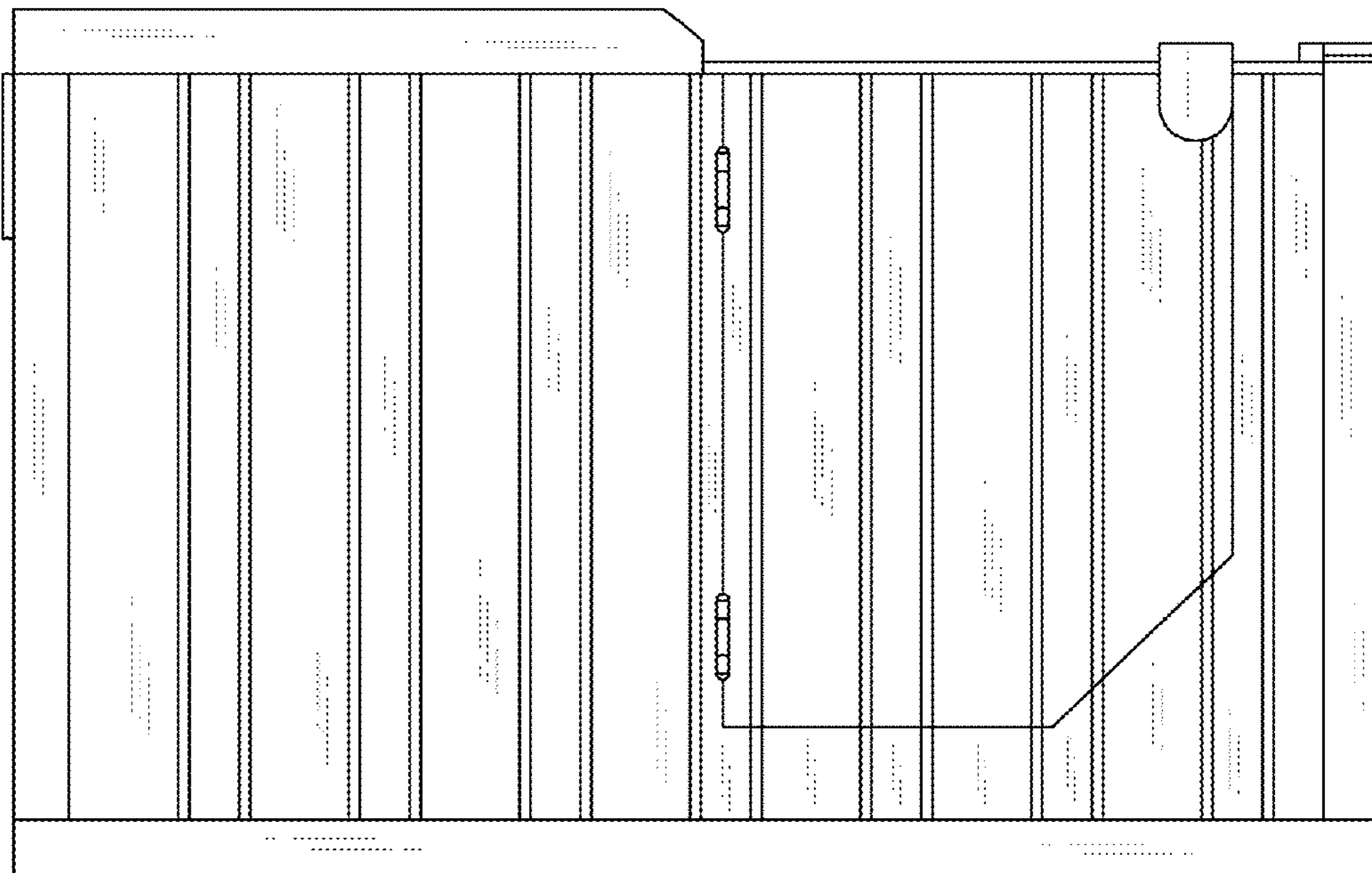

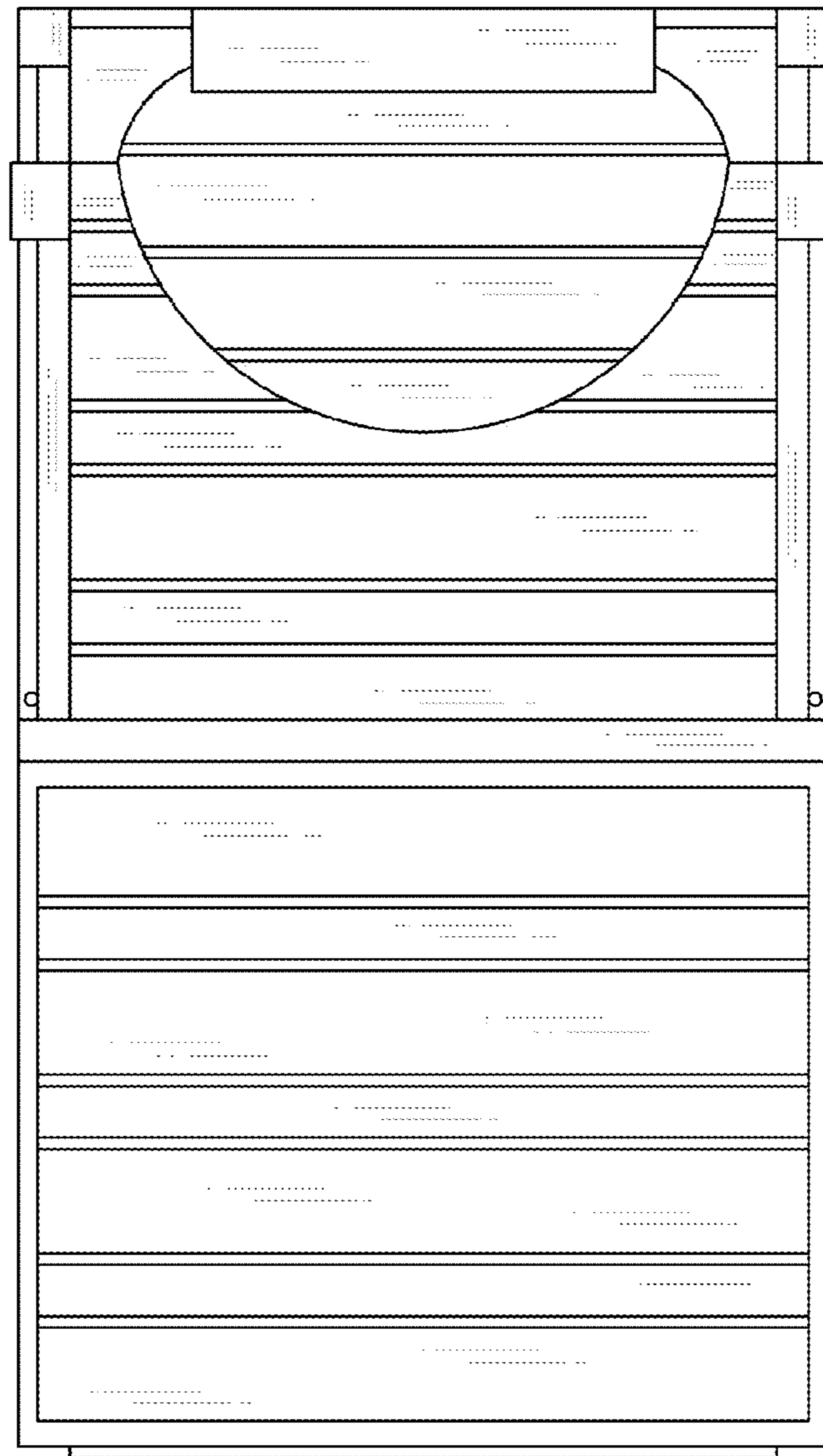
