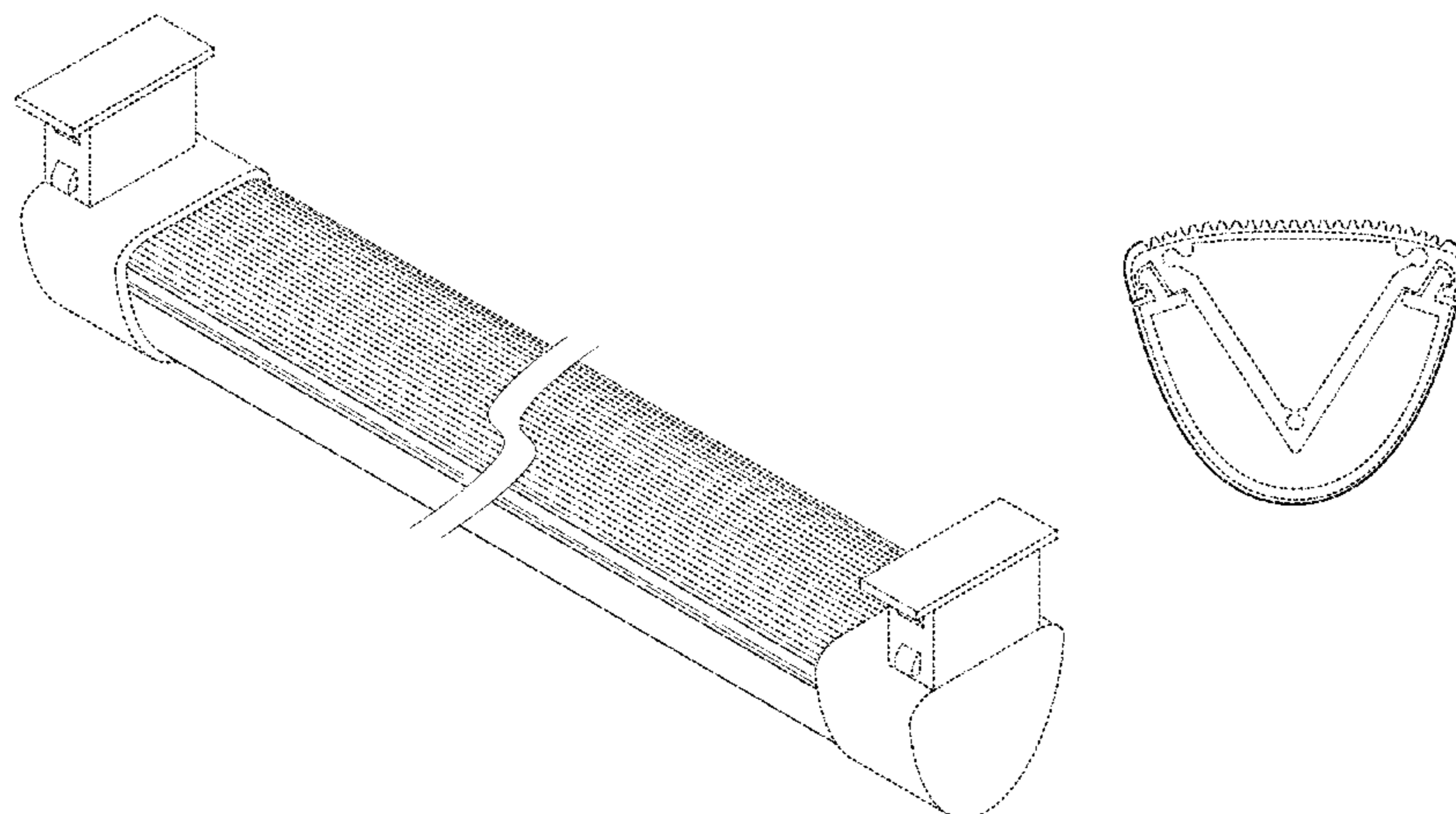
(57) **CLAIM**

The ornamental design for an illuminating assembly, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side, and end perspective view thereof; FIG. 2 is an enlarged, end elevation view thereof with the end cap connector assembly removed for greater clarity in depicting the lines constituting the claimed design; FIG. 3 is a side elevation view thereof; FIG. 4 is a top view thereof; and, FIG. 5 is a bottom view thereof. The view from the end opposite that in FIG. 2 is the same as that in FIG. 2. The view from the side opposite that in FIG. 3 is the same as that in FIG. 3. The broken lines (where present) in all Figs. illustrate portions of the illuminating assembly that form no part of the claimed design. The broken line in FIG. 2 immediately adjacent to the solid line illustrate a boundary line, with the broken lines as well as the area within the broken line immediately adjacent to the solid line forming no part of the claimed design.

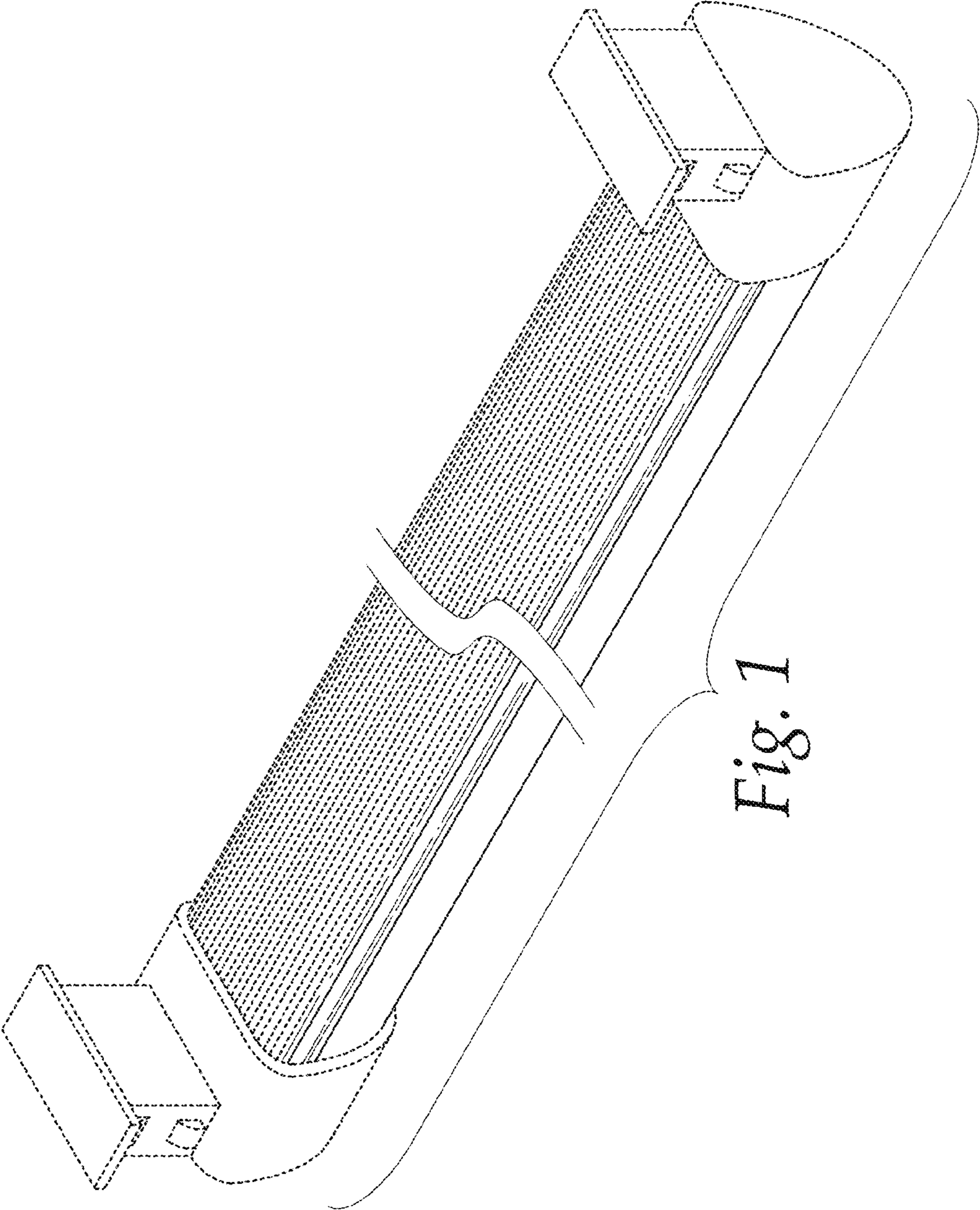
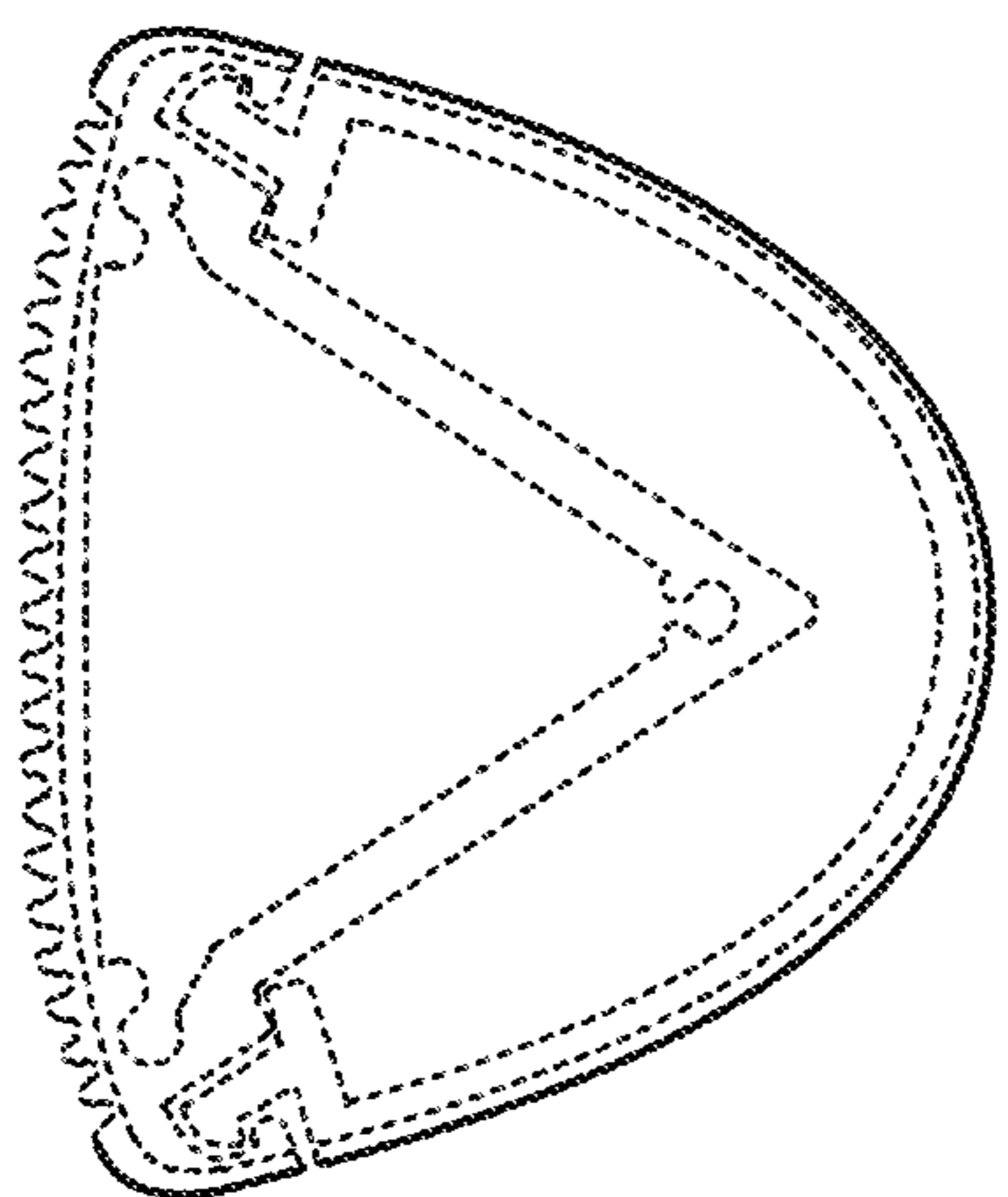
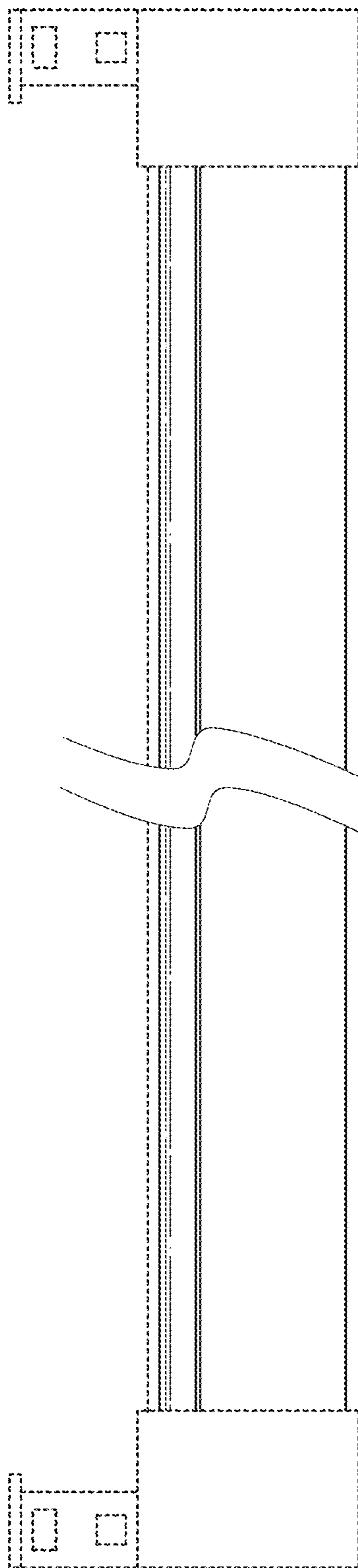


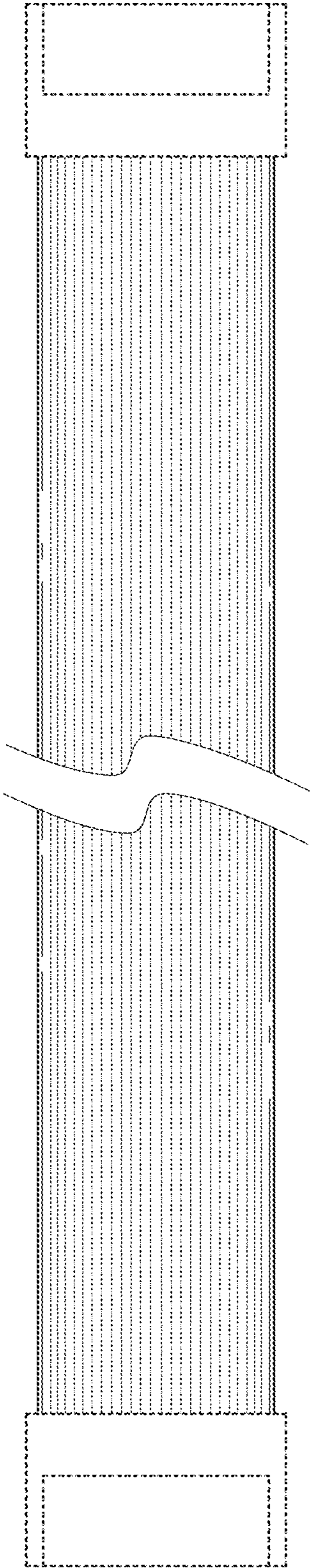
