(57) CLAIM

The ornamental design for a upper portion of a dishwasher door, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an upper portion of a dishwasher door according our new ornamental design;

FIG. 2 is a front view thereof;


FIG. 3 is a left side view thereof, with the right side view thereof being a mirror image thereof; and,




The dotted lines represent the border between claimed and unclaimed subject matter and do not form a part of the claimed design.
