(57) **CLAIM**

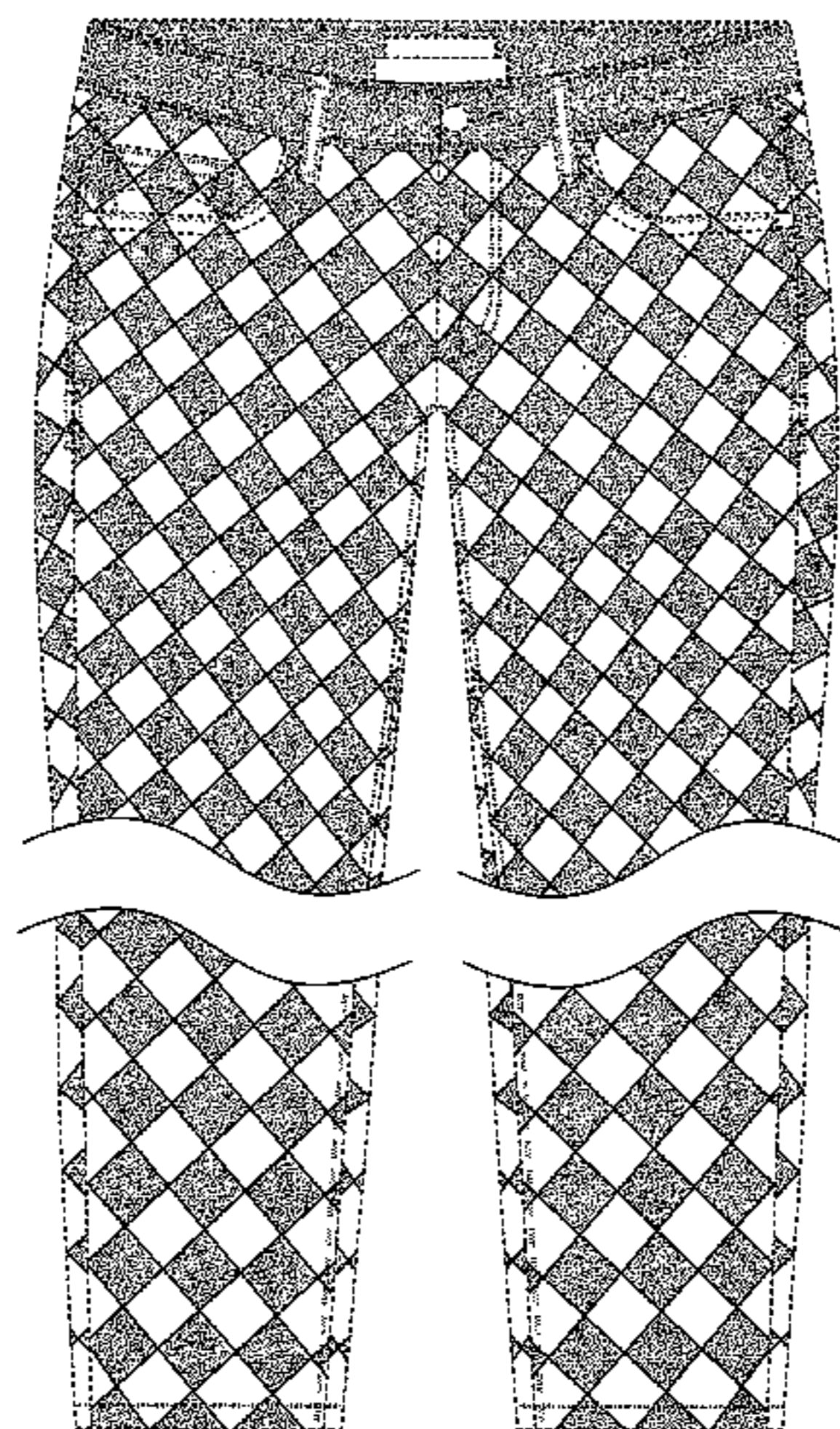
The ornamental design for trousers with a printed pattern, as shown and described in the accompanying drawings.

DESCRIPTION

FIG. 1 is a front view of the trousers with a printed pattern showing my new design; and, FIG. 2 is a rear view of the trousers with a printed pattern of FIG. 1, thereof.

The broken line forming a perimeter around the article depicts the boundaries of the claim and forms no part thereof. The broken lines within the broken line boundary illustrate portions of the trousers with a printed pattern that form no part of the claimed design. The trousers with a printed pattern are shown with symbolic breaks in their length. Any portion of the article between the break lines forms no part of the claimed design.

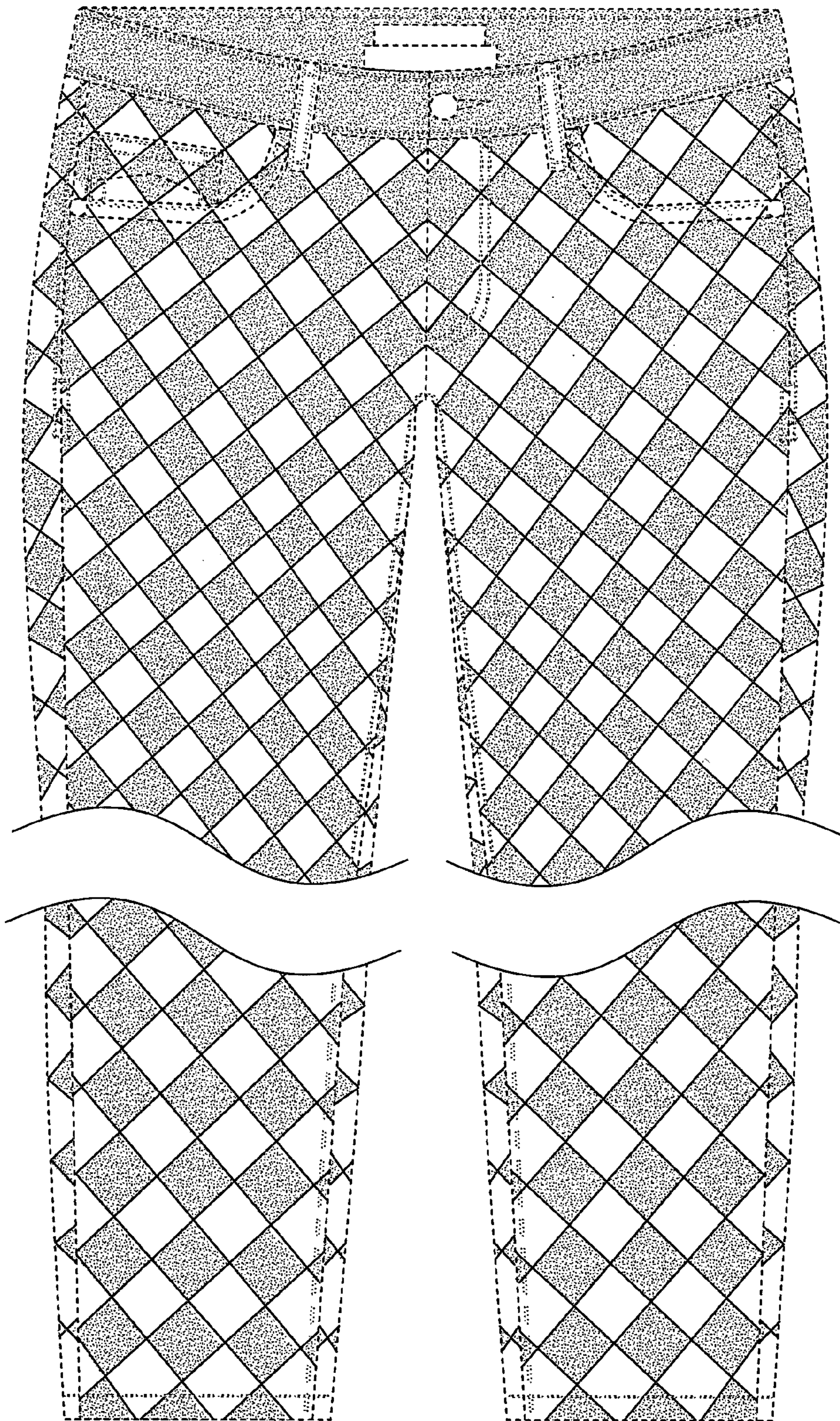

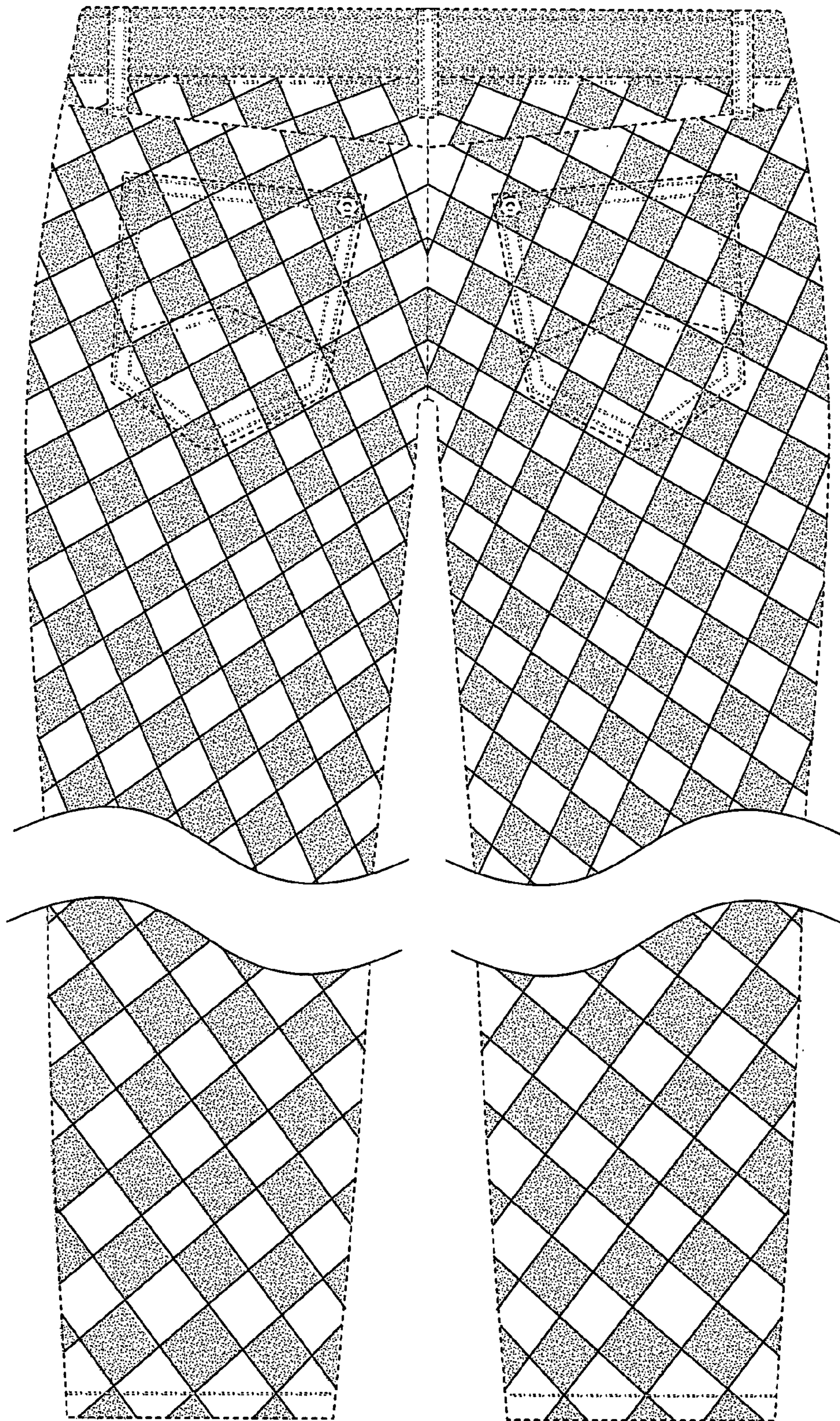
