
(57) **CLAIM**

The ornamental design for a work surface, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the work surface from the right side showing retractable holders in a retracted position. The left side is a mirror image of the right side;

FIG. 2 is a perspective view of the first embodiment of the work surface from the right side showing all retractable hold-



ers and all retractable dividers in an extended position. The left side is a mirror image of the right side;

FIG. 3 is a perspective view of the first embodiment of the work surface from the right side, showing all retractable holders and dividers in an extended position except for one central divider in a retracted position. The left side is a mirror image of the right side;

FIG. 4 is a perspective view of the first embodiment of the work surface from the right side showing the central retractable holder in an extended position and the side holders in a retracted position. The left side is a mirror image of the right side;

FIG. 5 is fifth perspective view of the first embodiment of the work surface from the right side showing the central retractable holder in an extended position and the side holders in a retracted position. One central divider is in a retracted position and the other central divider is in a retracted position. The left side is a mirror image of the right side;

FIG. 6 is a perspective view of the first embodiment of the work surface from the right side showing the central and left side retractable holders in a retracted position and the right side holder in an extended position;

FIG. 7 is a perspective view of the first embodiment of the work surface from the right side, showing the central and left side retractable holders in a retracted position and the right side holder in an extended position with the divider in a retracted position;

FIG. 8 is a perspective view of a second embodiment of the work surface from the right side, showing the central and right side retractable holders in an extended position and the left side holder in a retracted position;

FIG. 9 is a perspective view of the second embodiment of the work surface from the right side, the left side is a mirror image of the right side;

FIG. 10 is a perspective view of the second embodiment of the work surface from the right side, showing the central and right side retractable holders in an extended position with one central divider in a retracted position, and the left side holder in a retracted position;

FIG. 11 is a second perspective view of the second embodiment of the work surface from the right side showing the central retractable holder in an extended position and the side holders in a retracted position. The left side is a mirror image of the right side;

FIG. 12 is a perspective view of the second embodiment of the work surface from the right side showing the central retractable holder in an extended position and the side holders in a retracted position. One central divider is in a retracted position and the other central divider is in a retracted position. The left side is a mirror image of the right side;

FIG. 13 is a perspective view of the second embodiment of the work surface from the right side showing the central and left side retractable holders in a retracted position and the right side holder in an extended position; and,

FIG. 14 is a perspective view of the second embodiment of the work surface from the right side, showing the central and left side retractable holders in a retracted position and the right side holder in an extended position with the divider in retracted position.

The broken lines are for the purpose of illustrating the environment of the article only and form no part of the claimed design.




























