FIG. 24 is a rear view thereof.

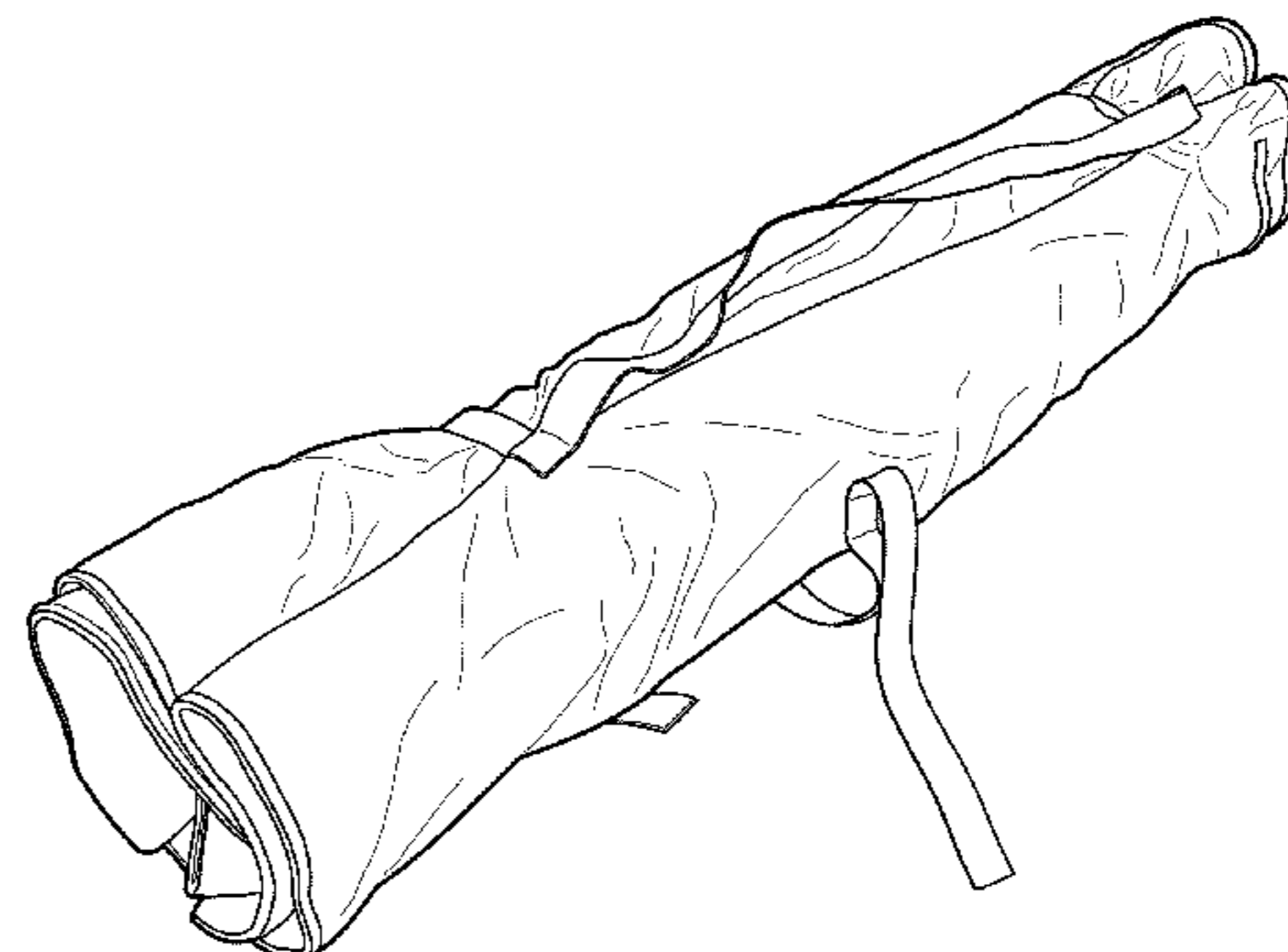
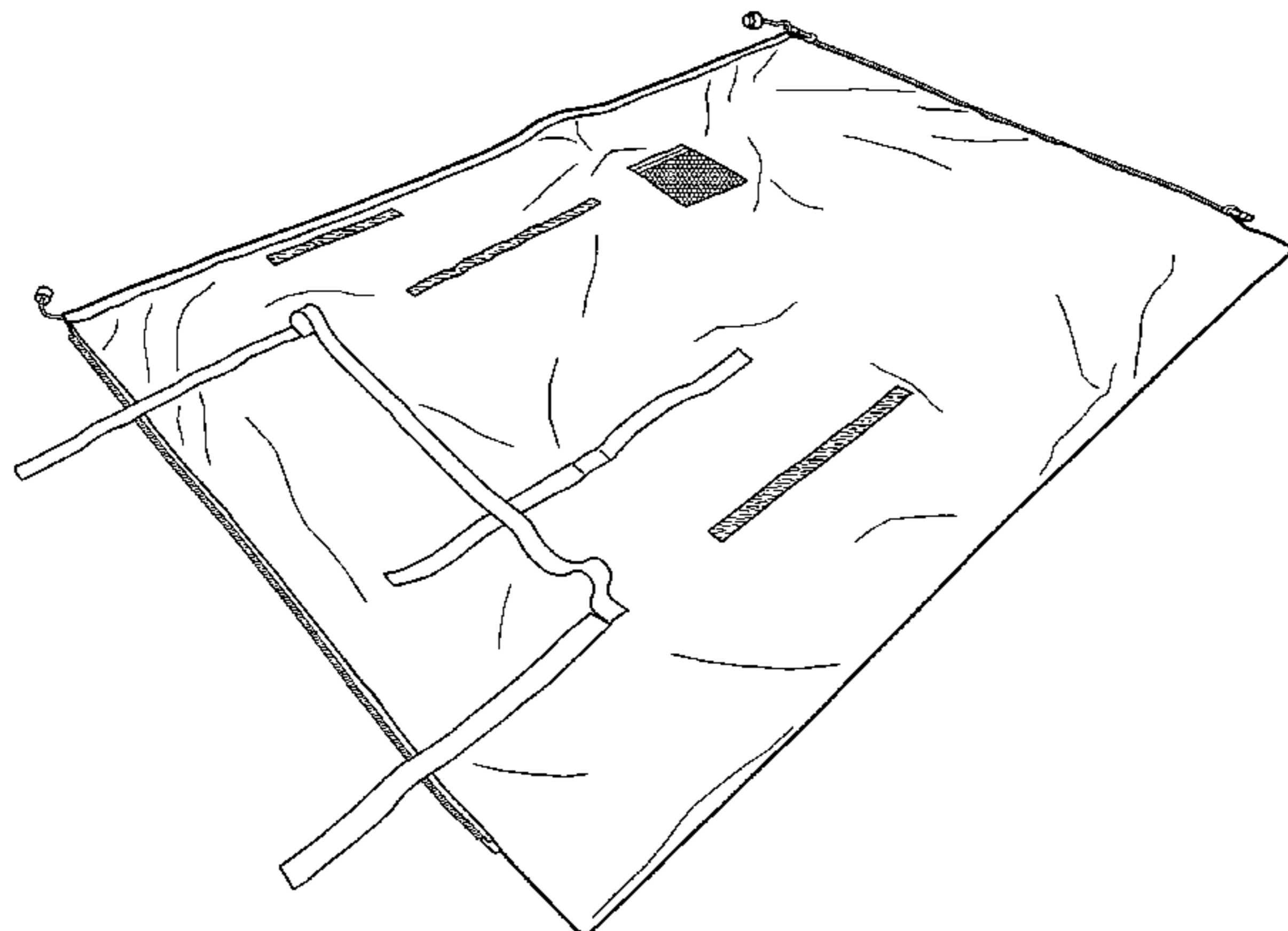
FIG. 25 is a top view thereof.

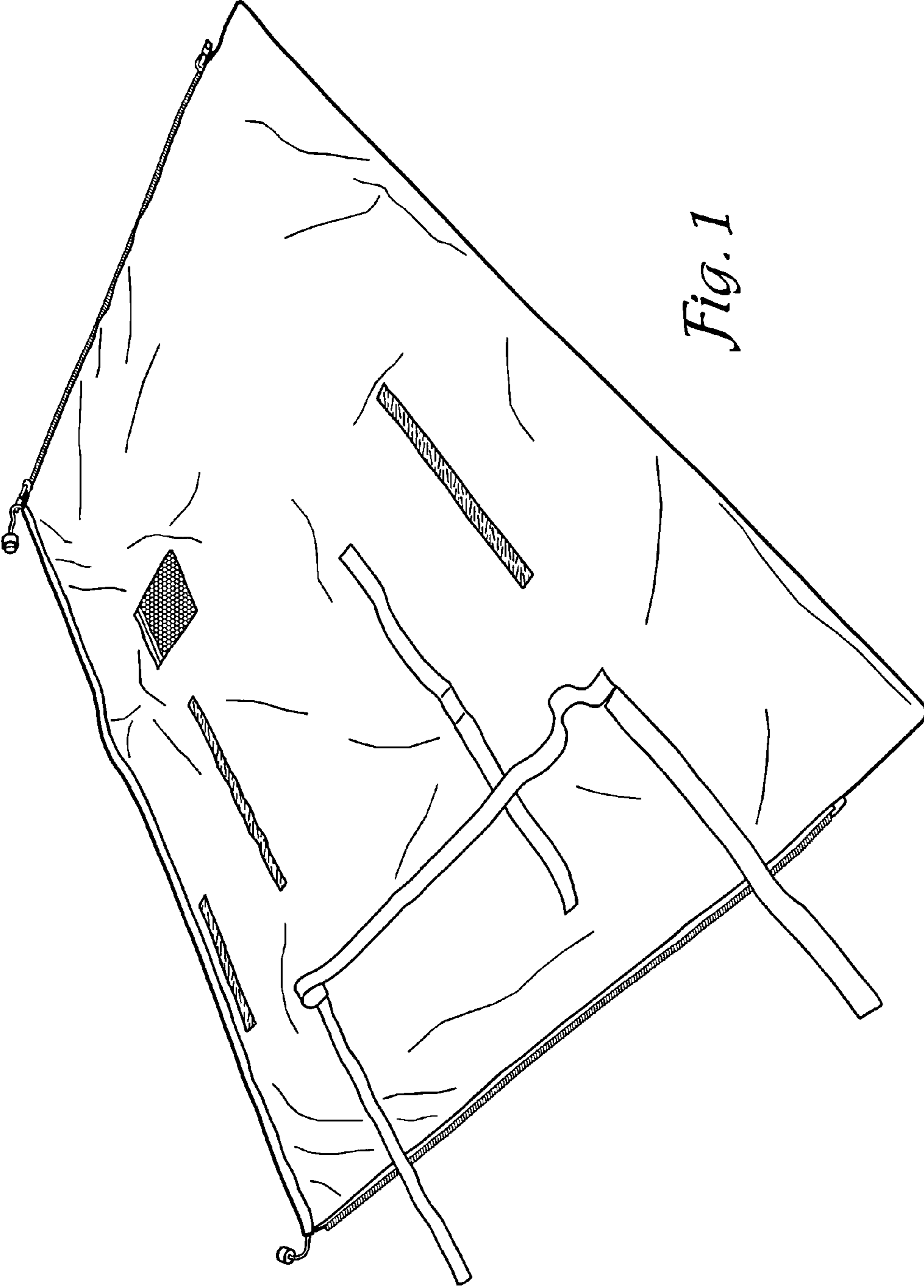

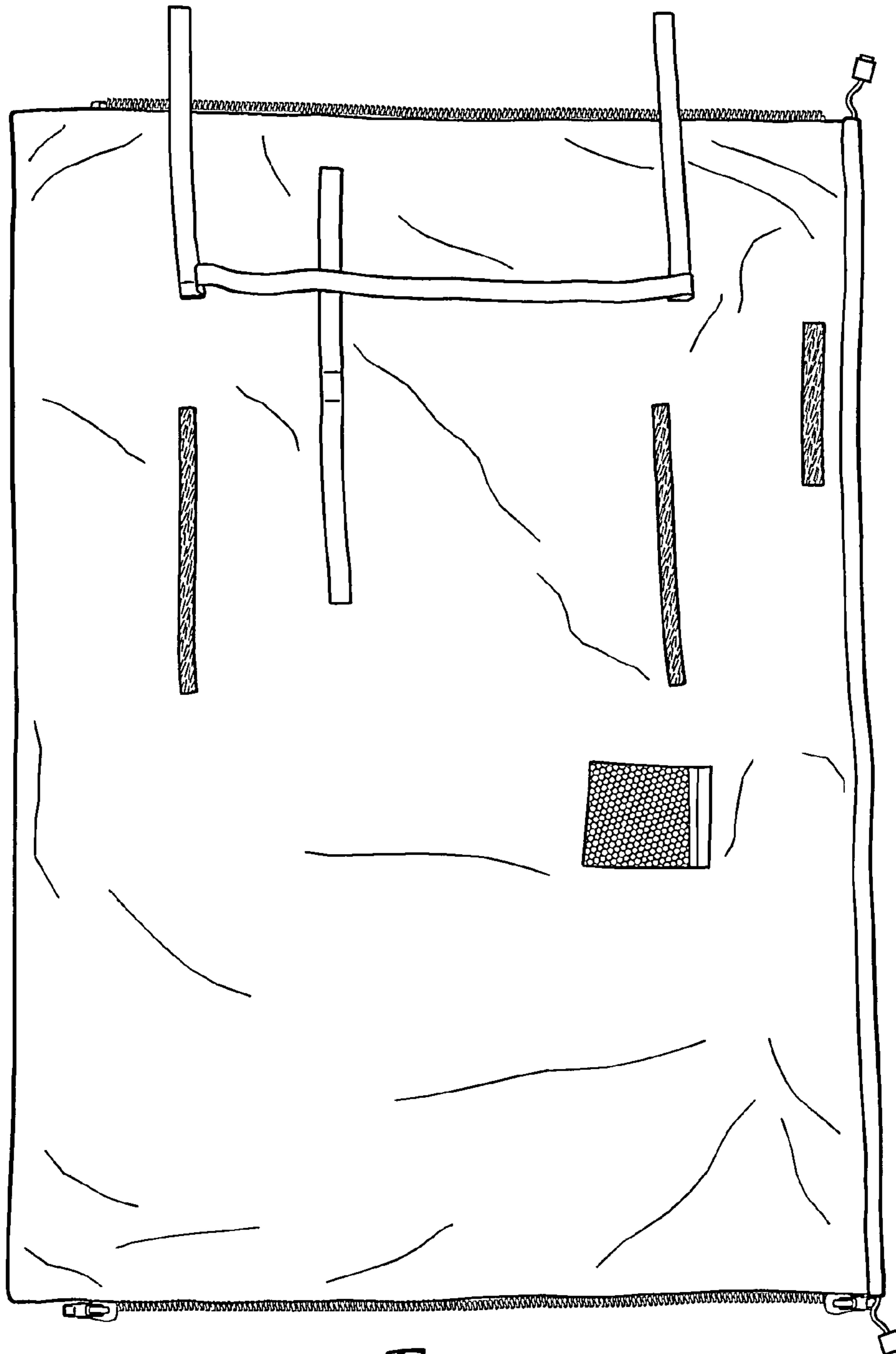

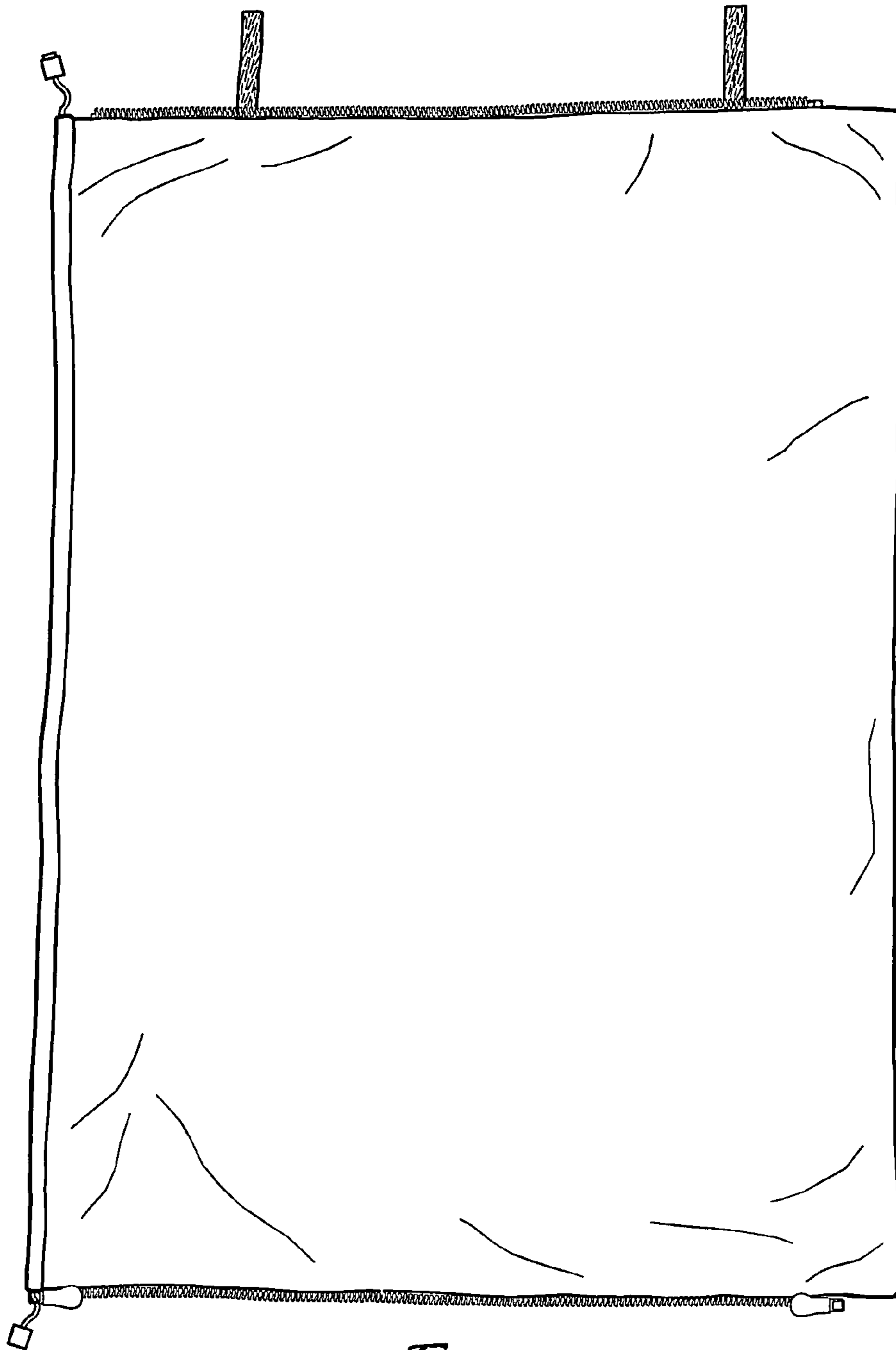

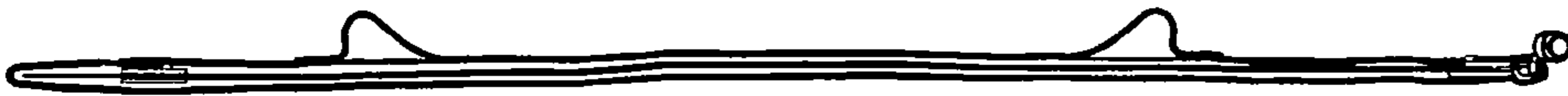

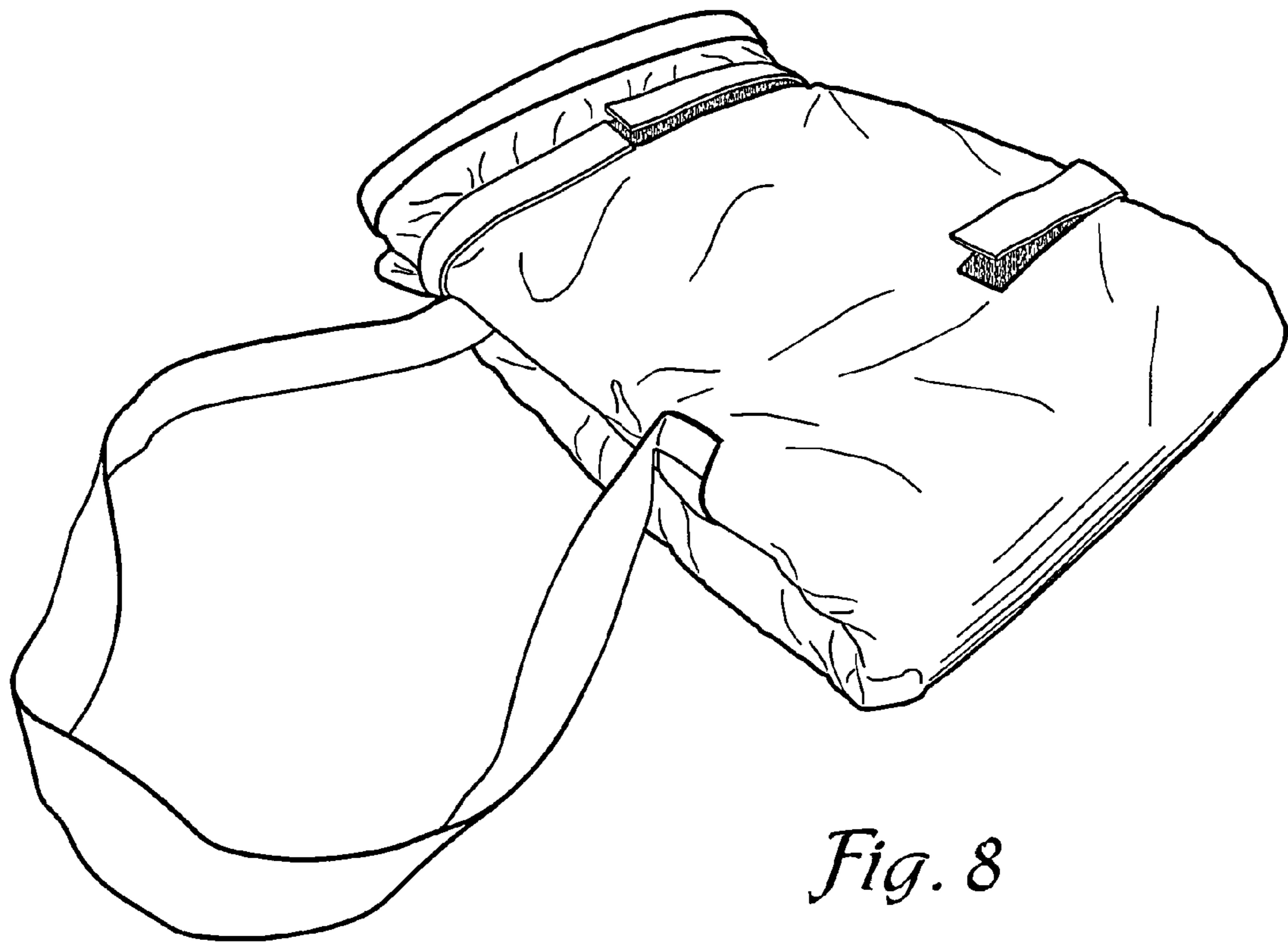

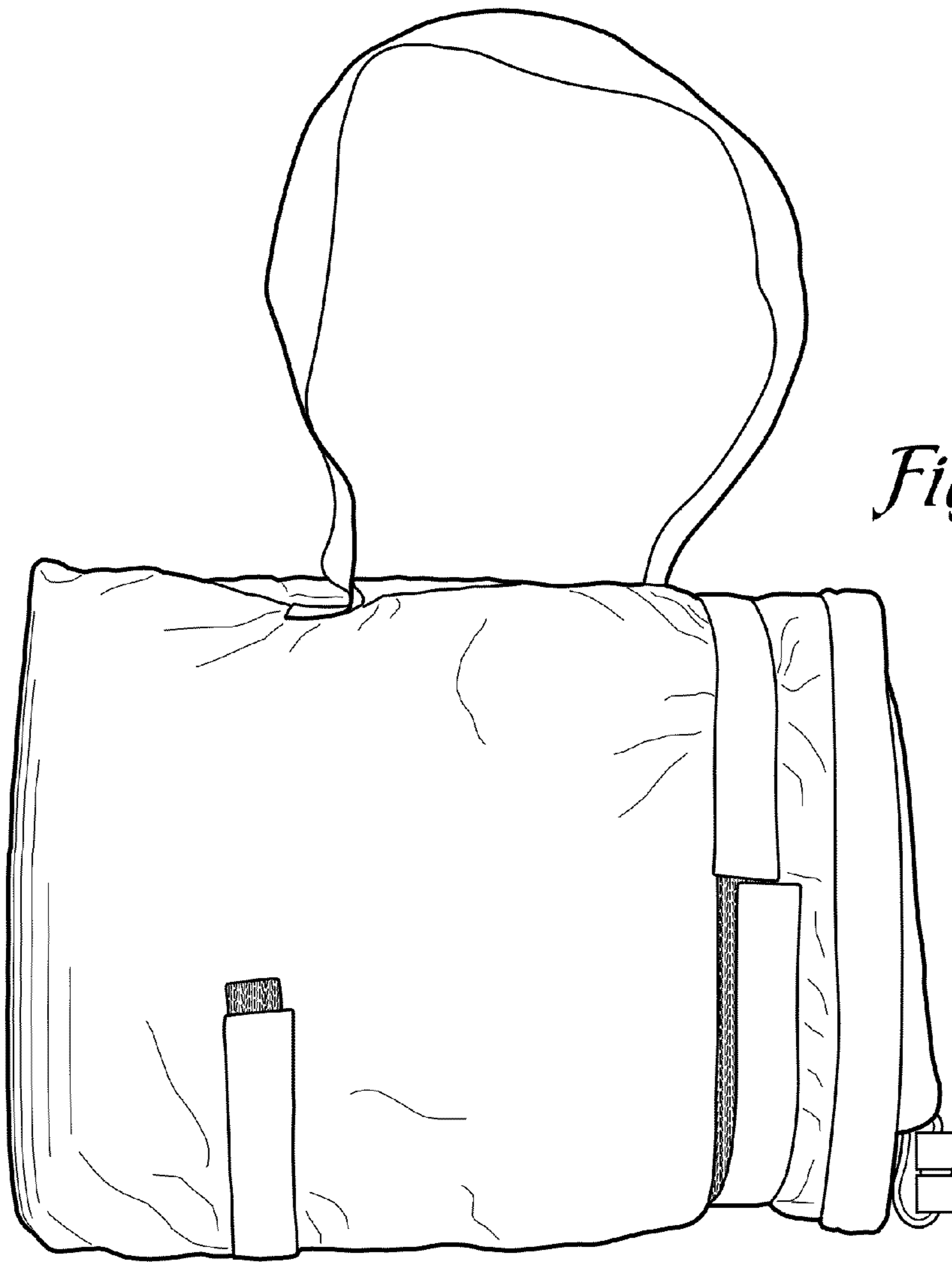

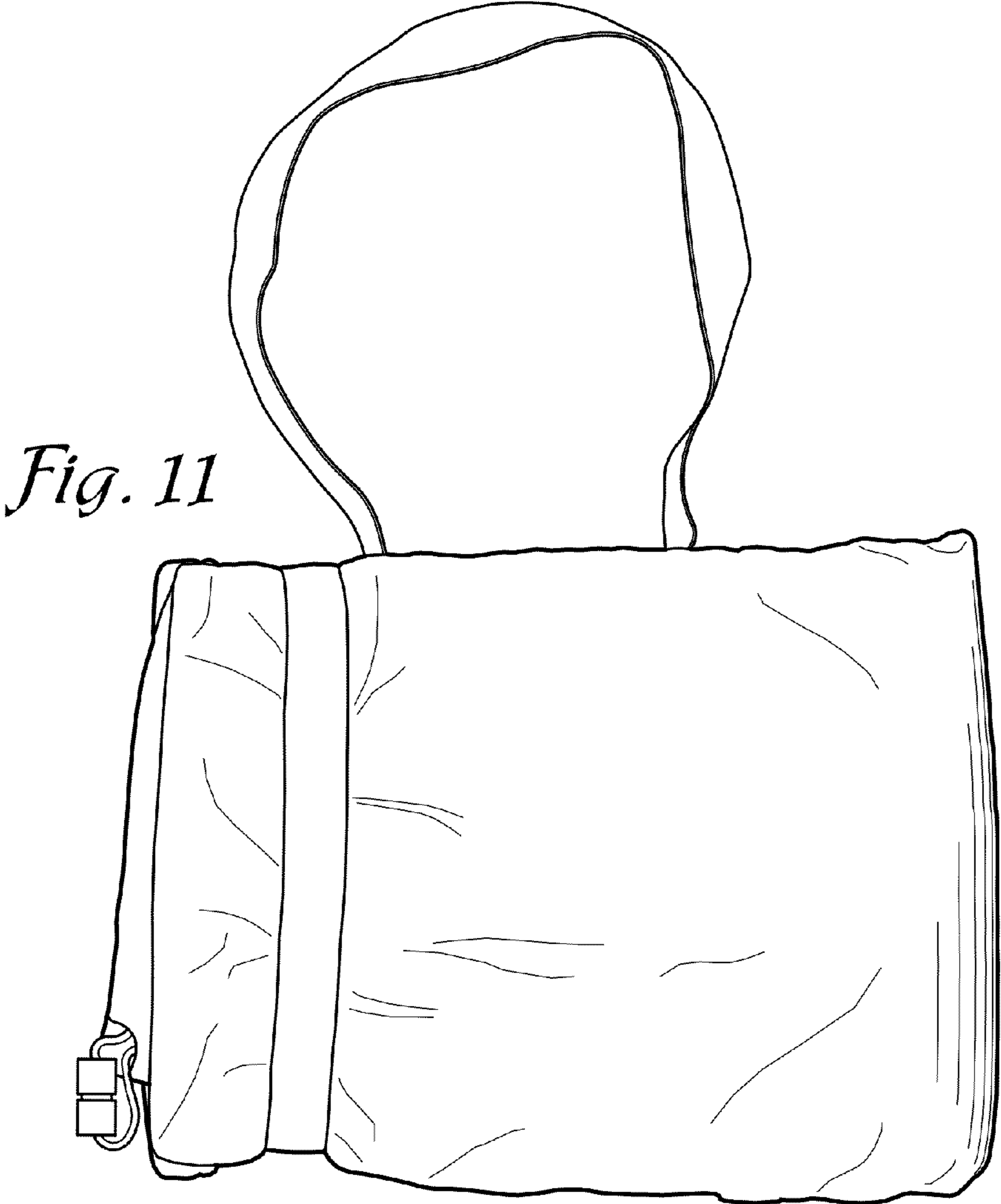

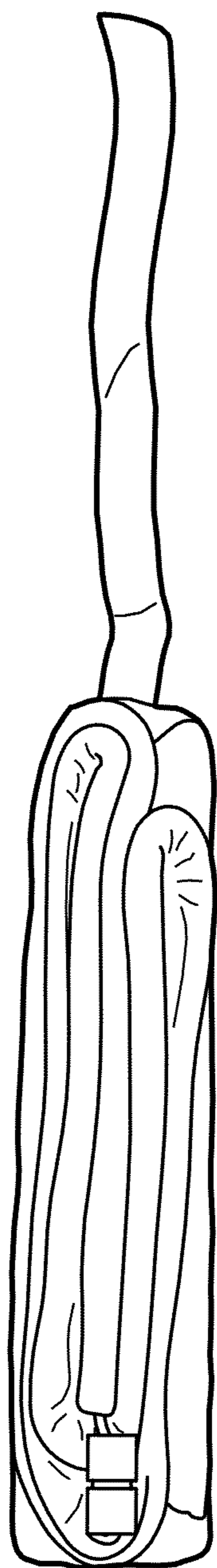

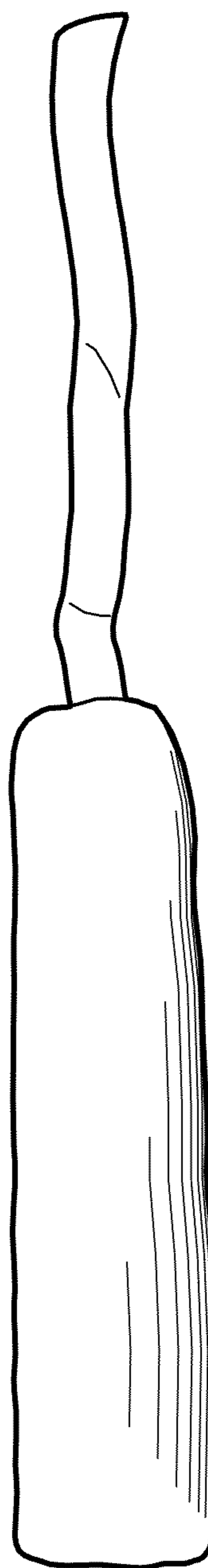

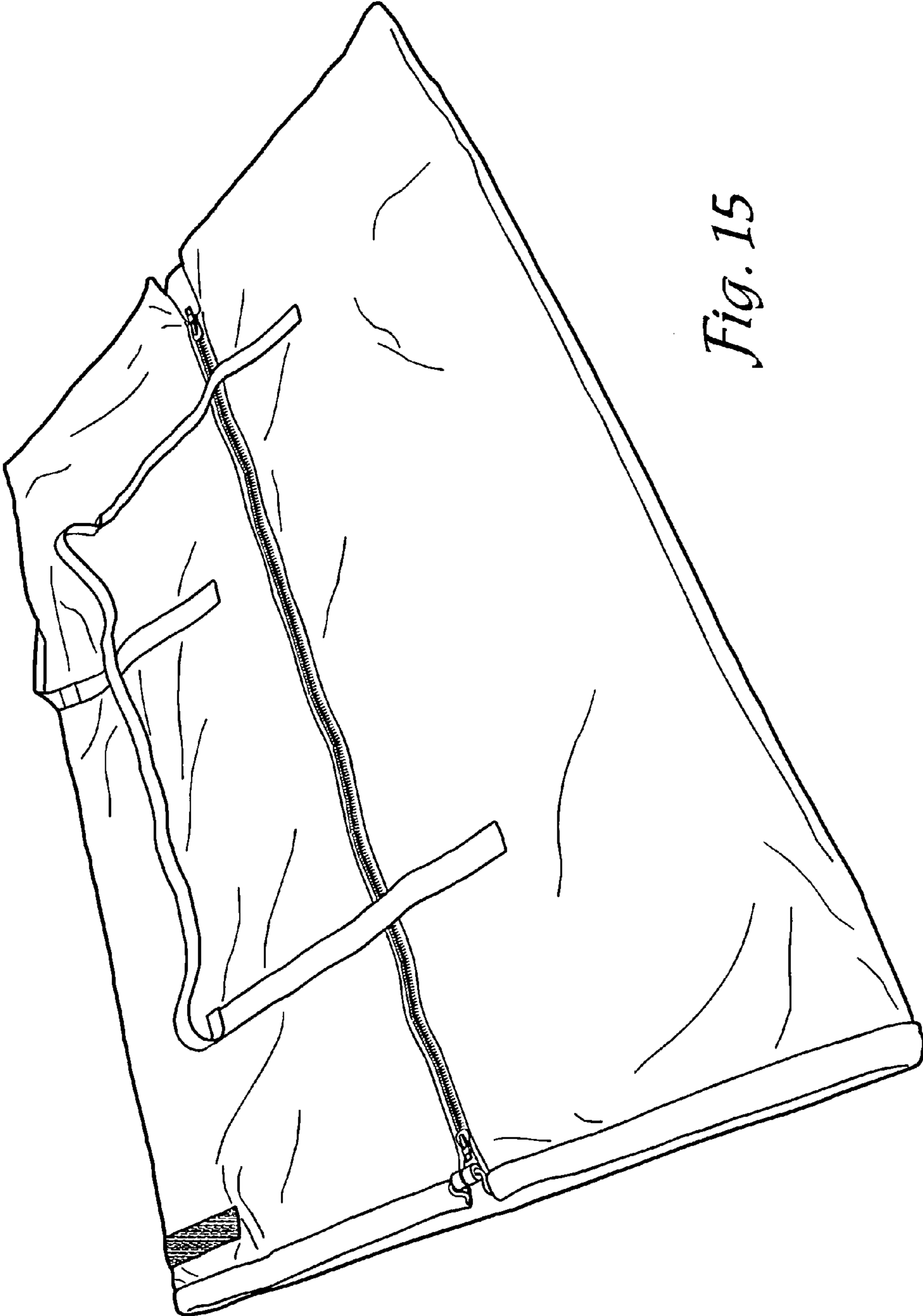

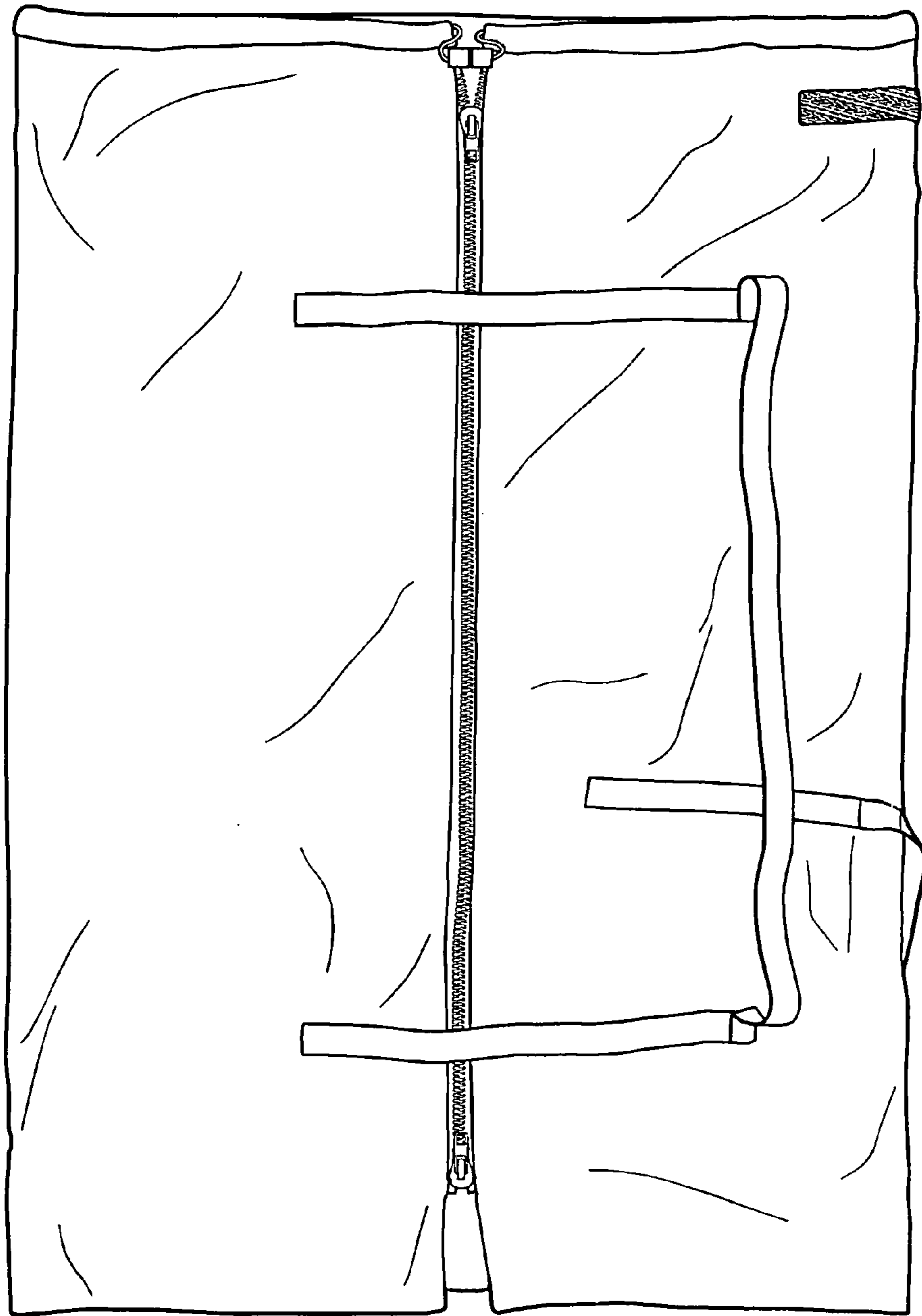

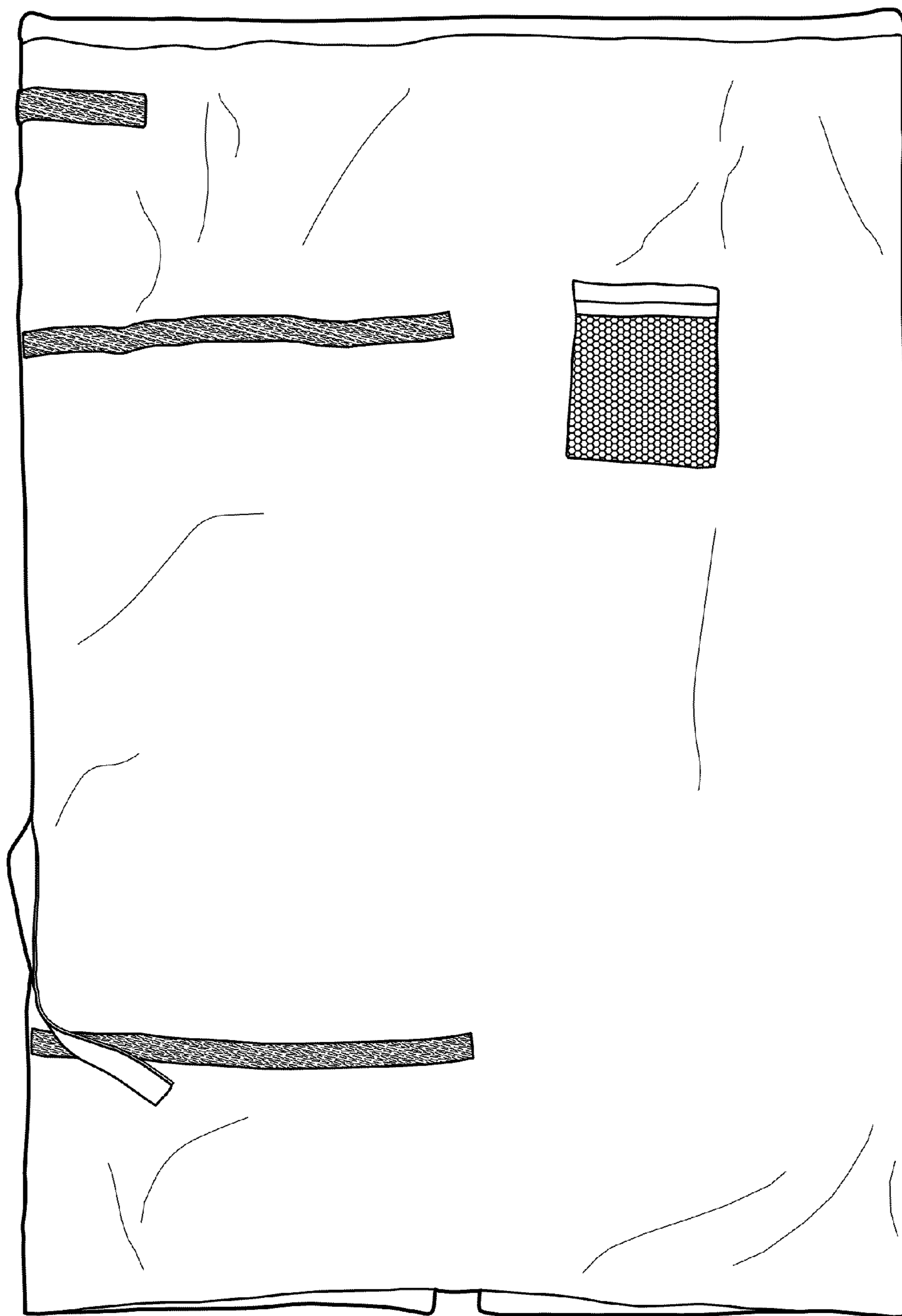

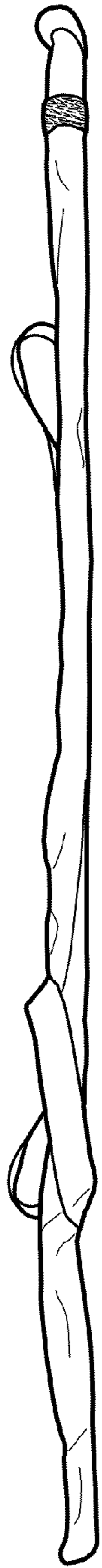

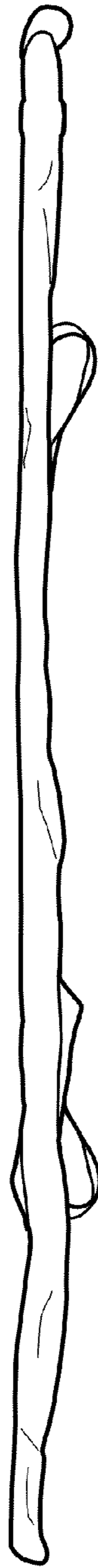

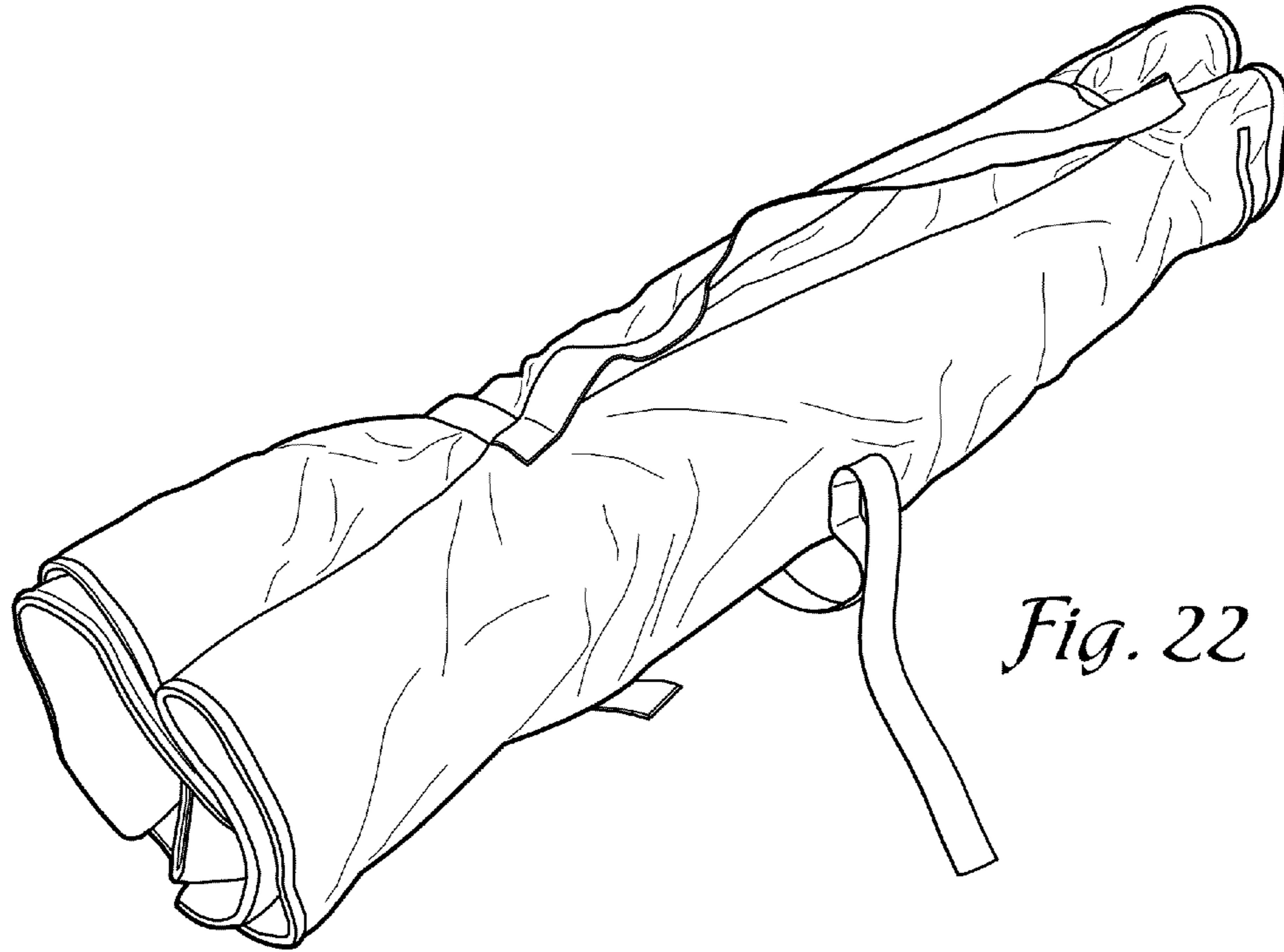

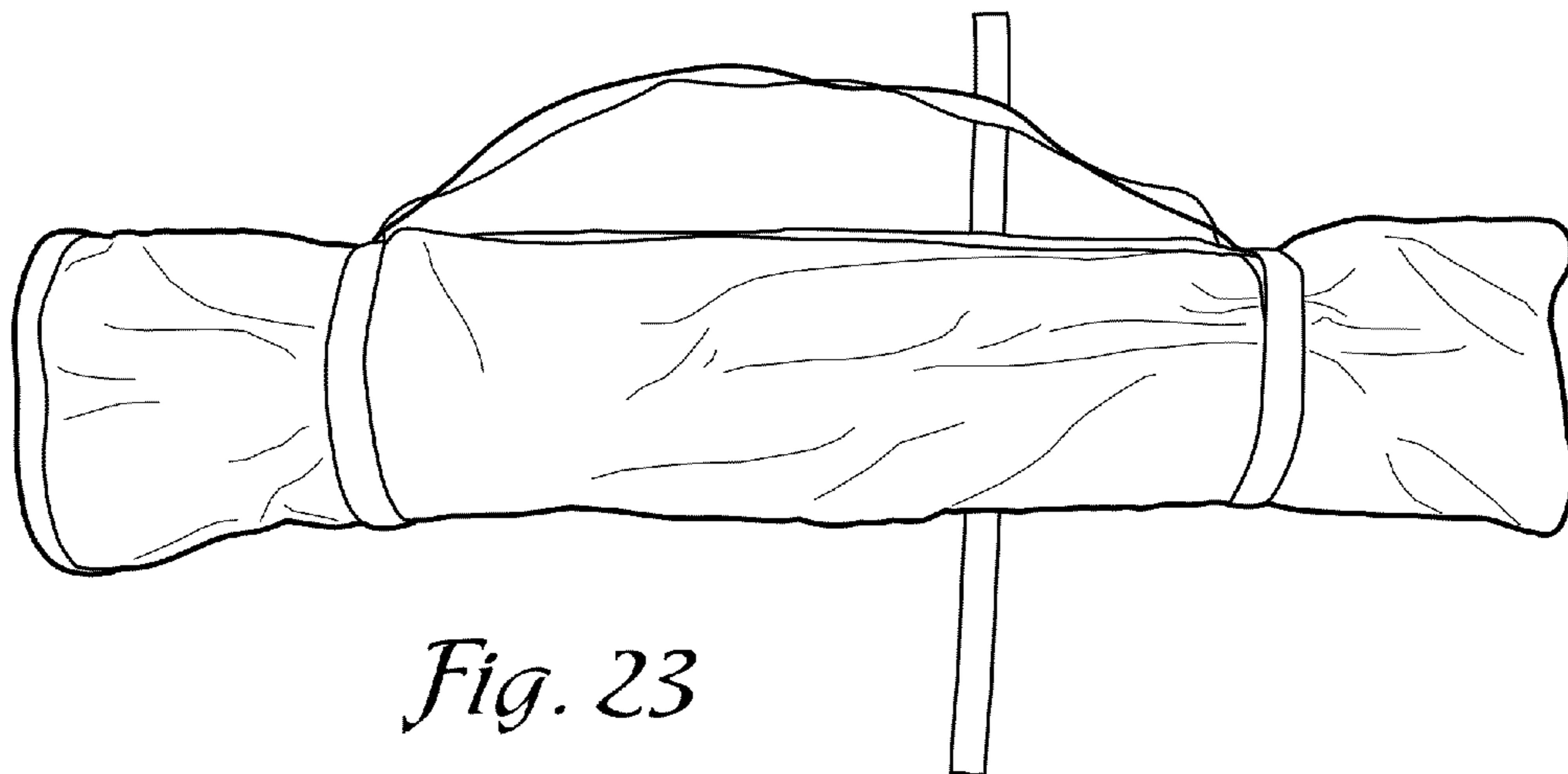

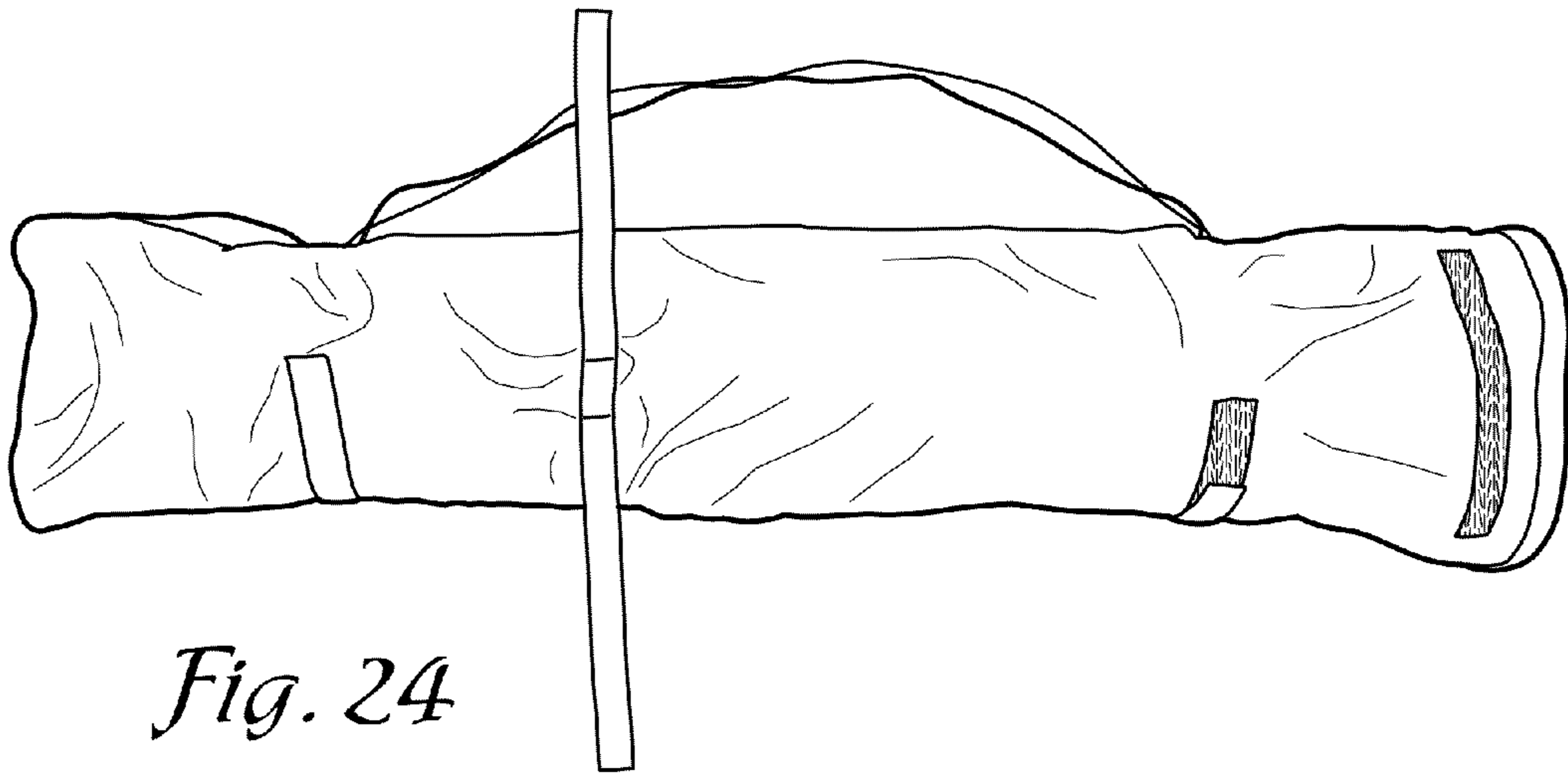

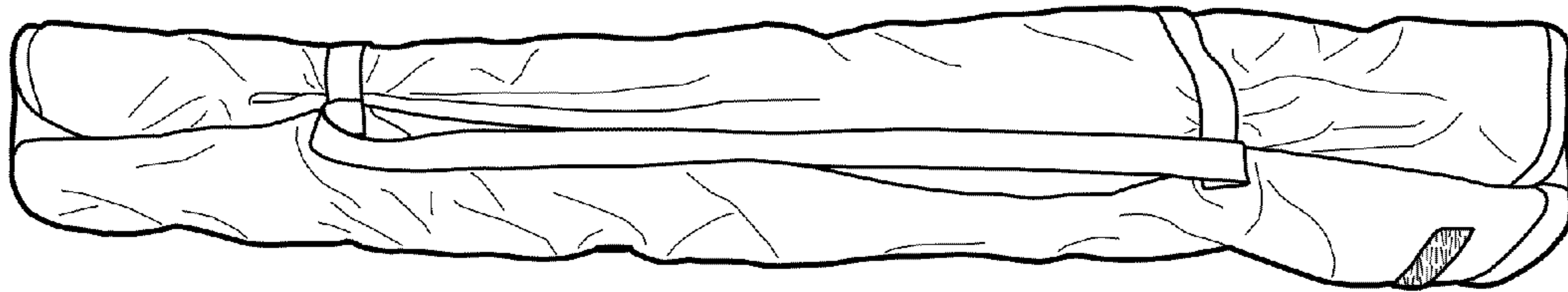

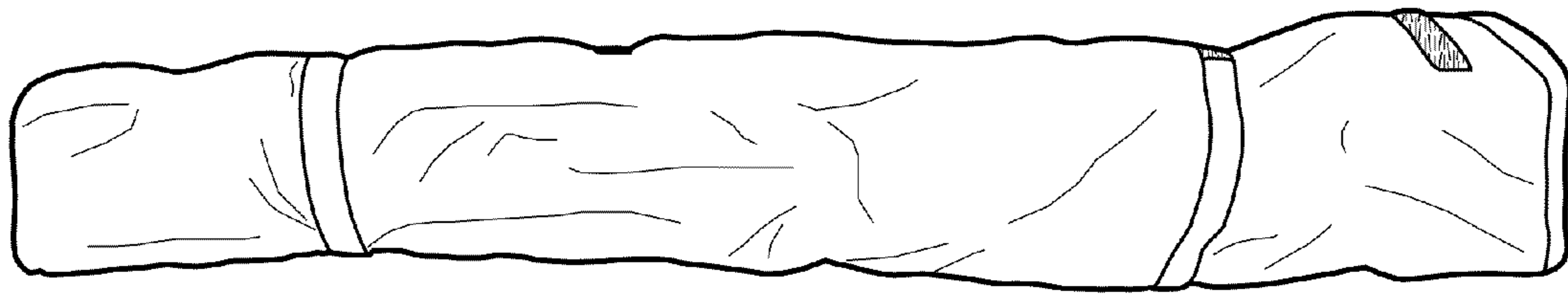

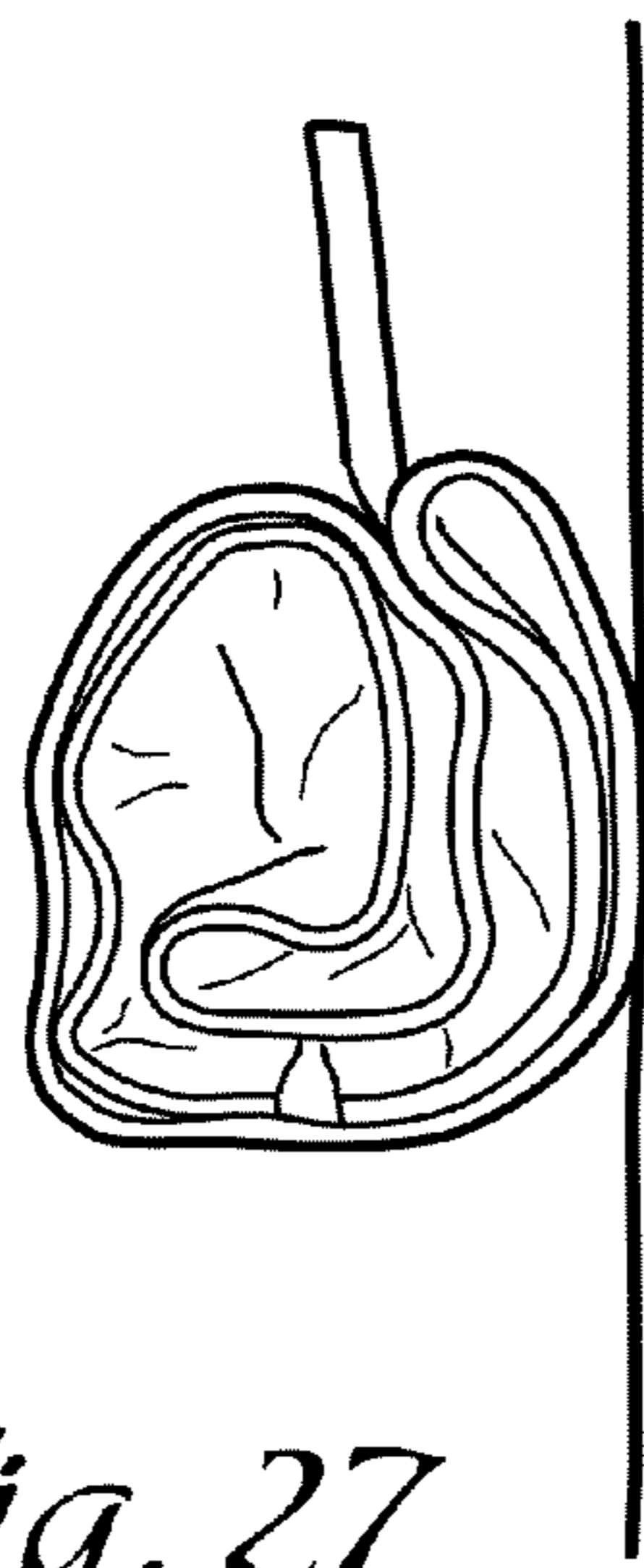

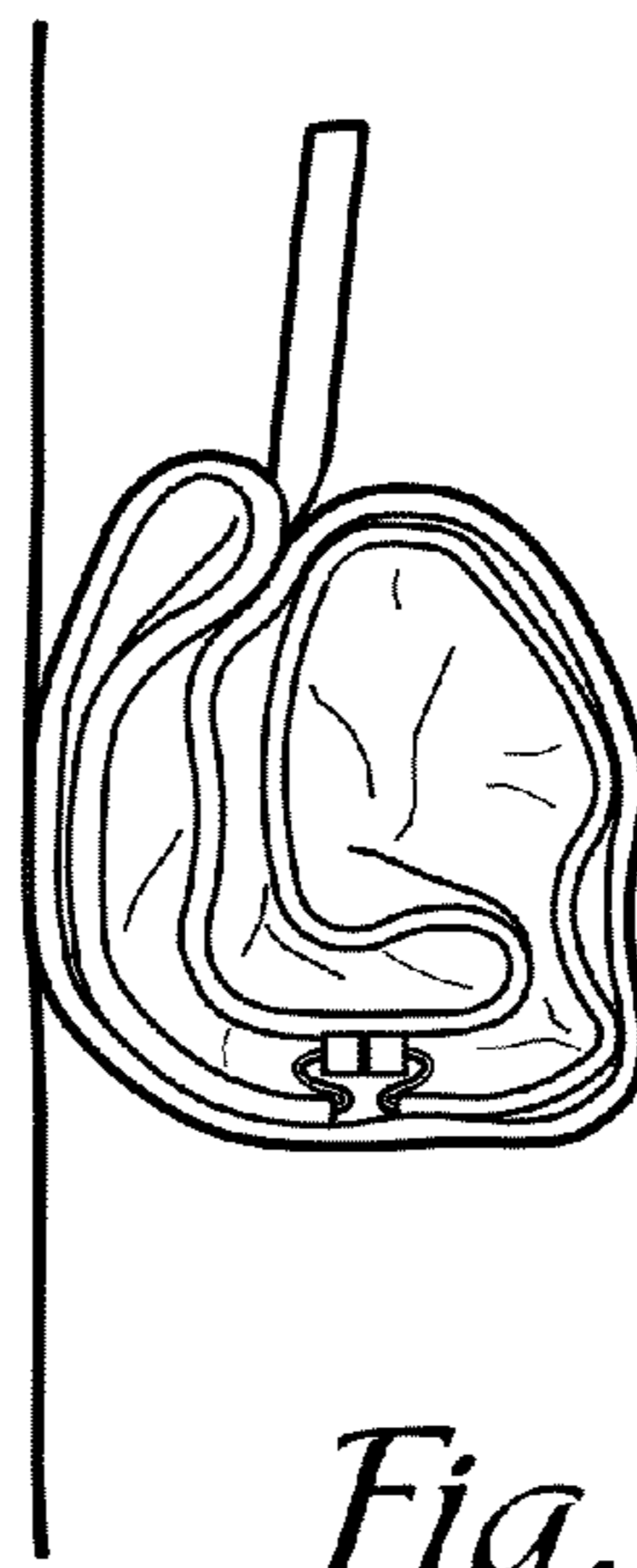
