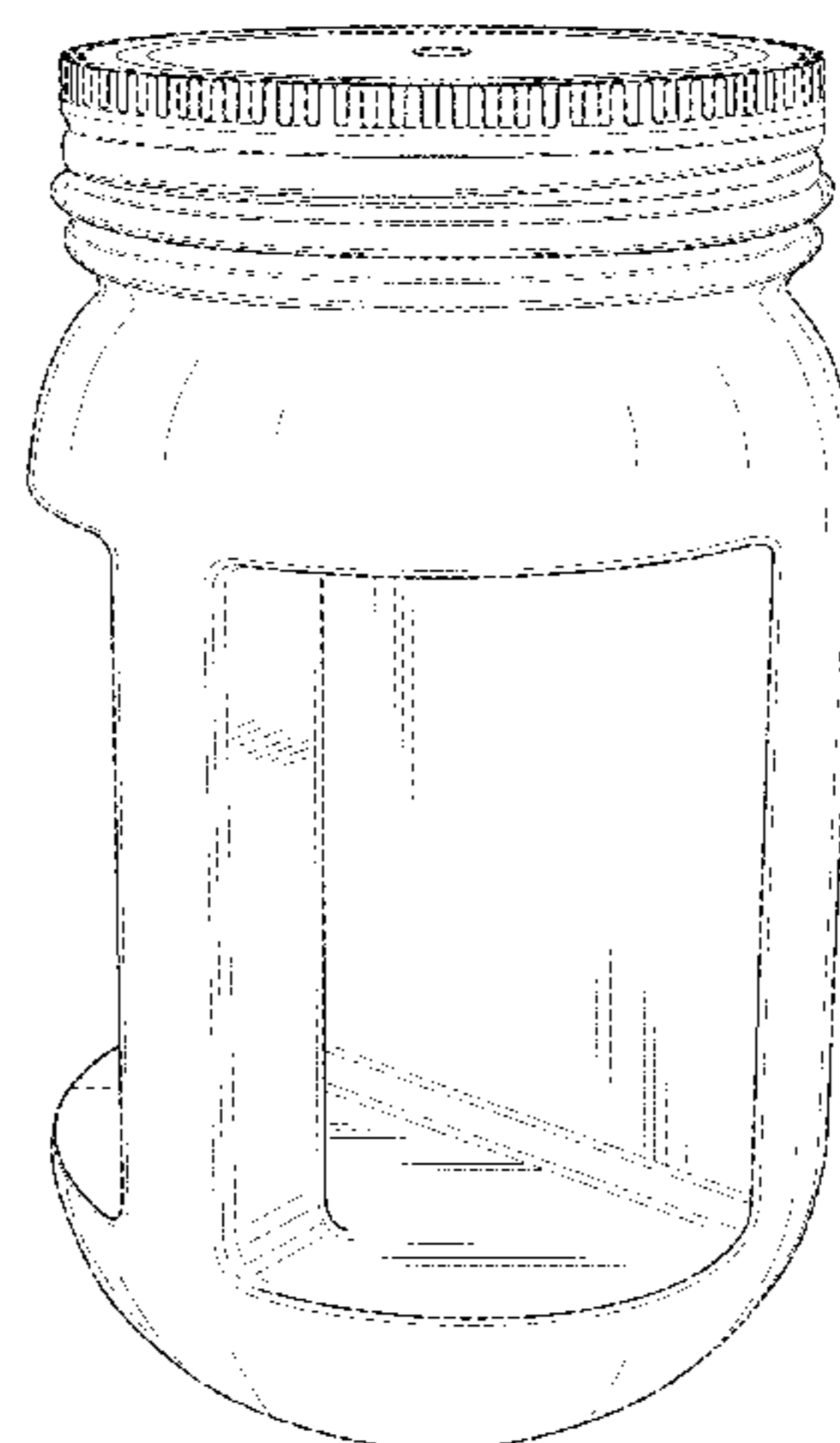
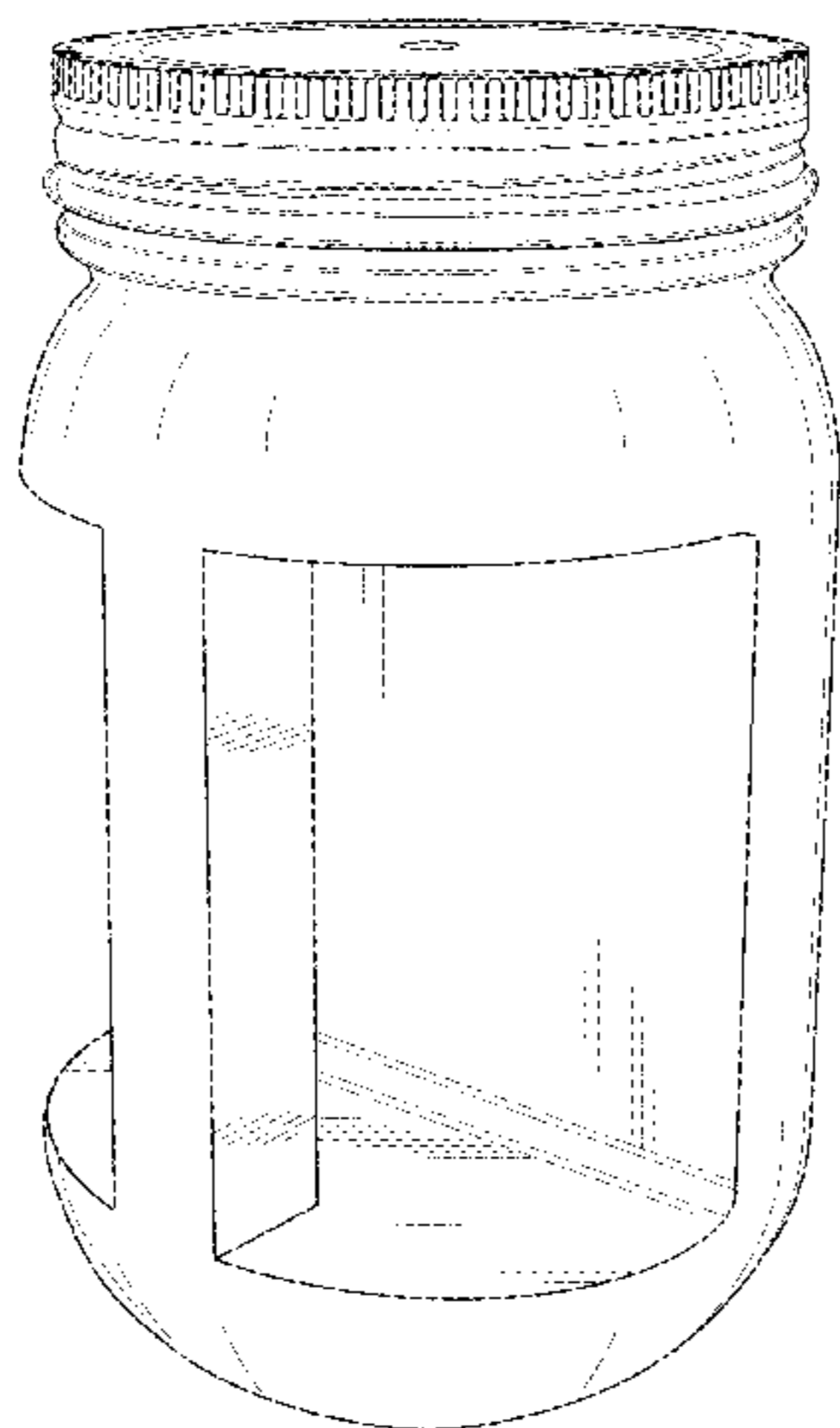
(57) **CLAIM**

The ornamental design for a mason jar pitcher, as shown and described.

DESCRIPTION

FIG. 1 is a top front isometric view of a first embodiment of a mason jar pitcher showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof the left side view being a mirror image;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a top front isometric view of a second embodiment of a mason jar pitcher;

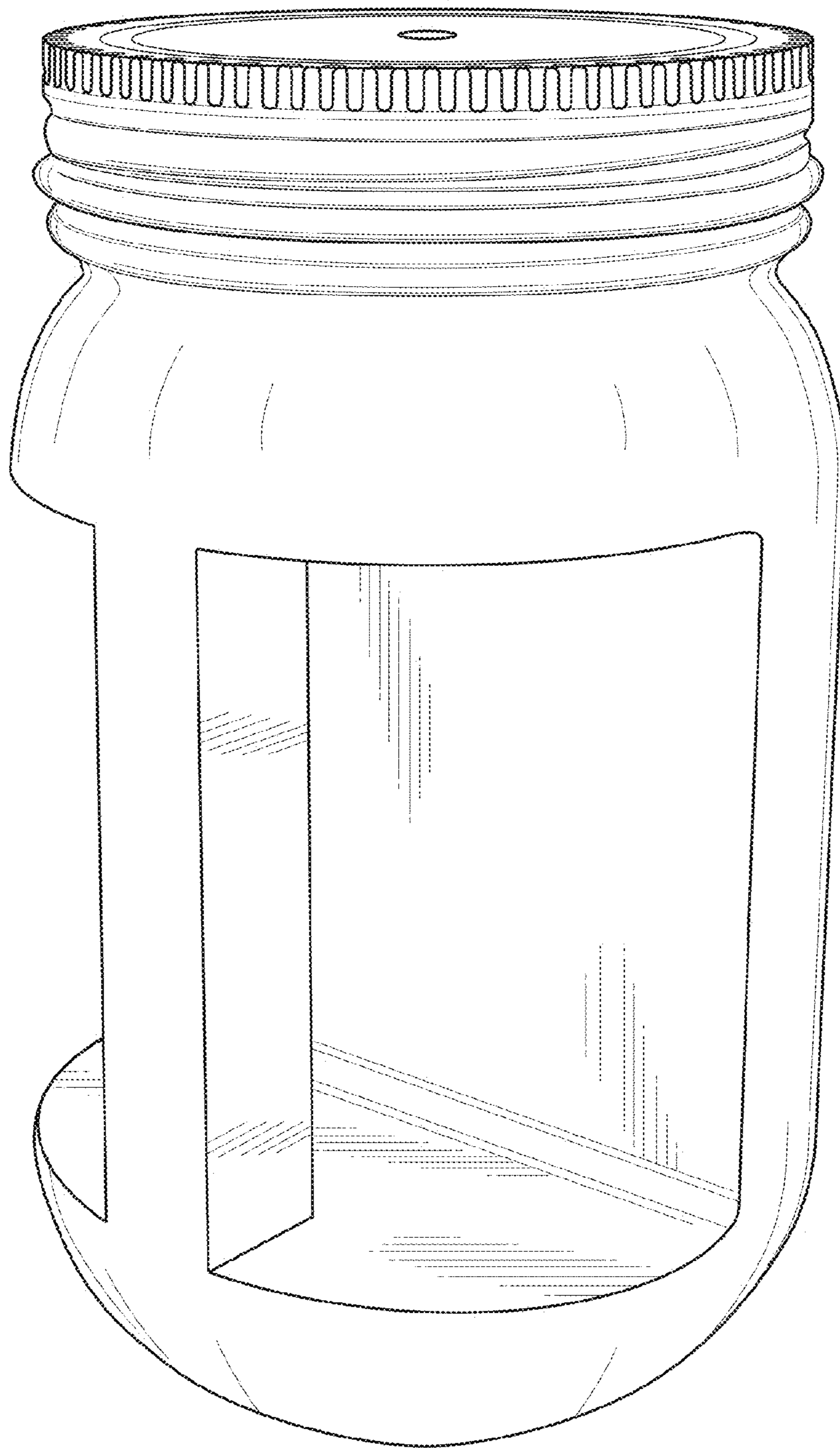

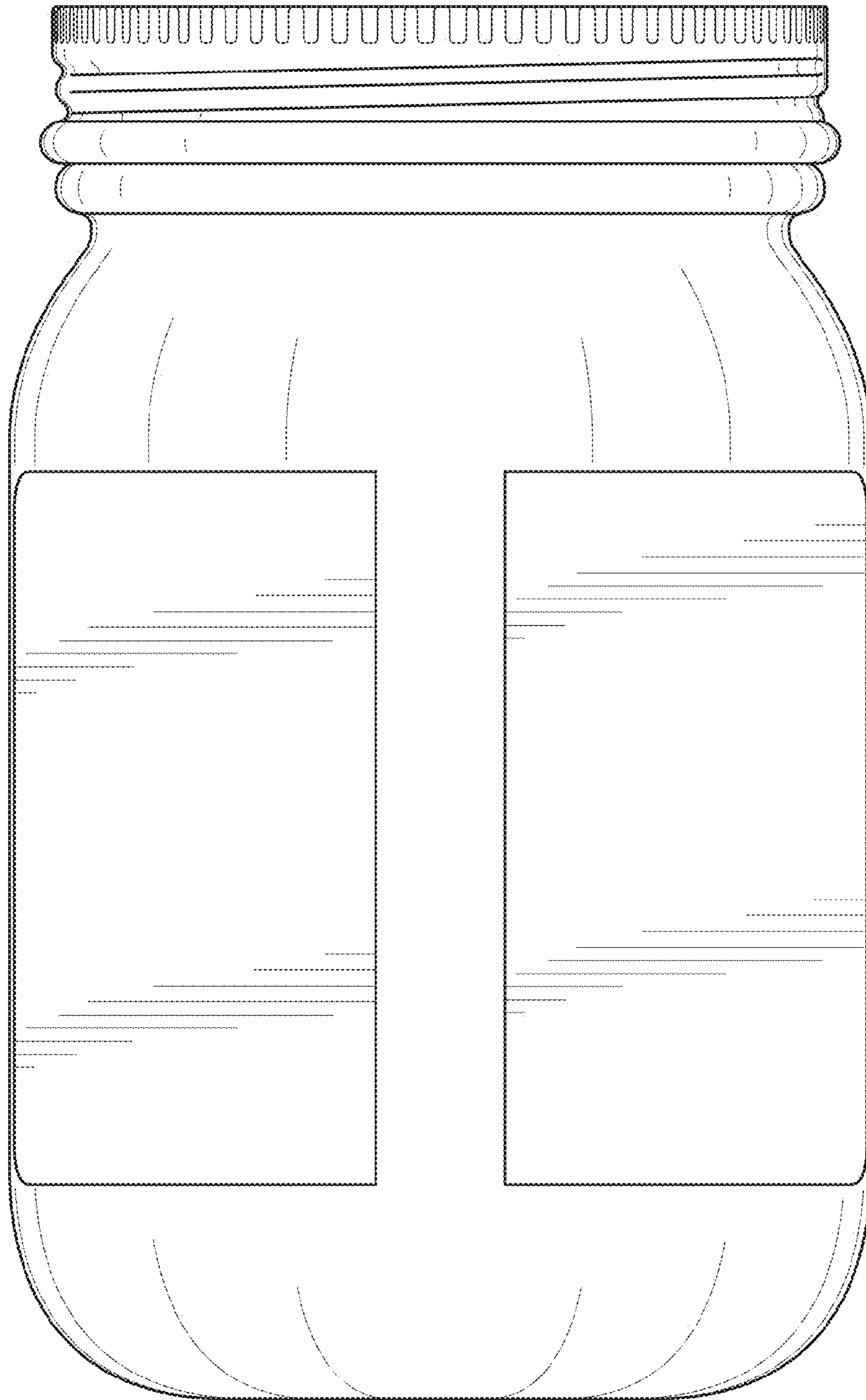

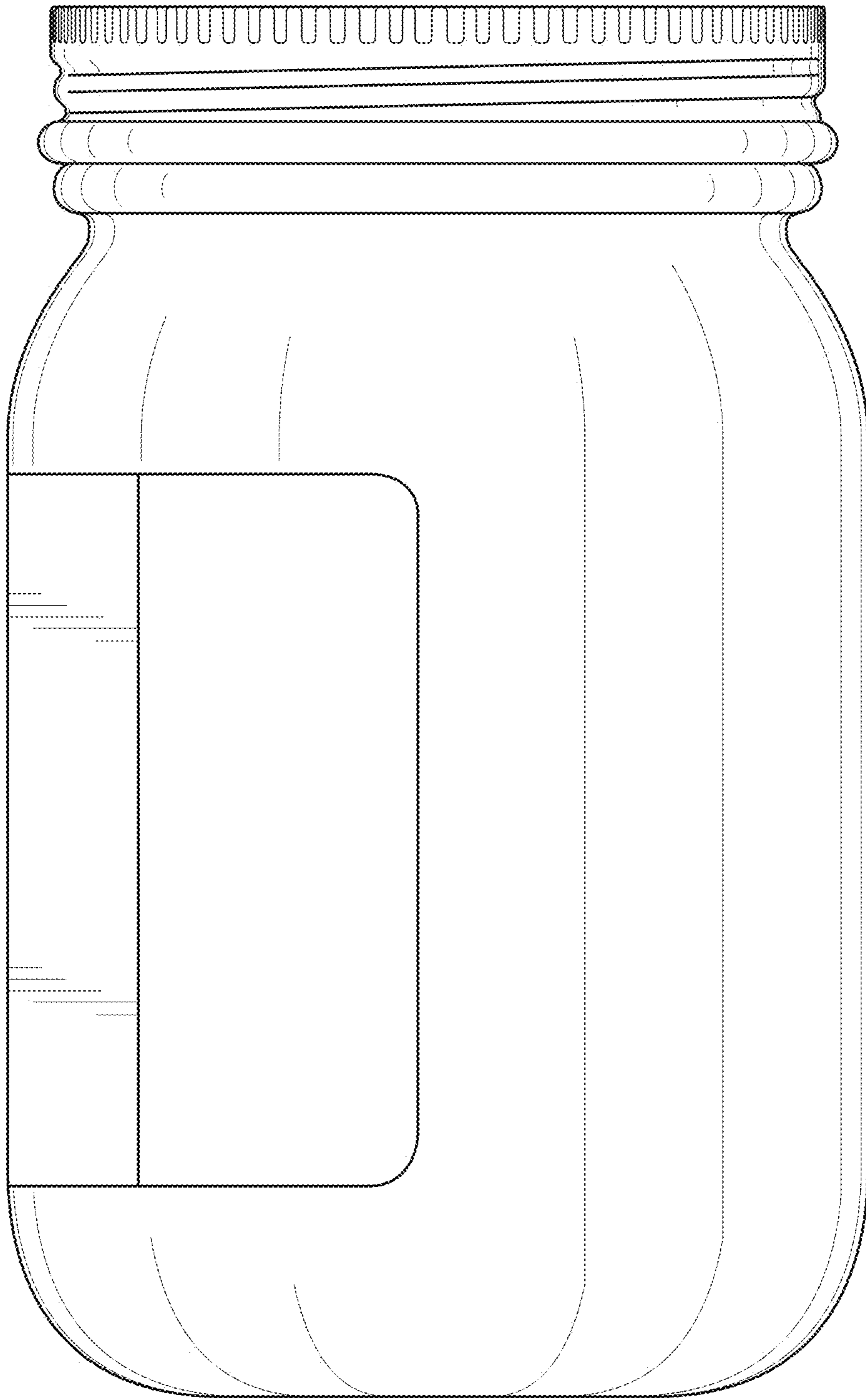

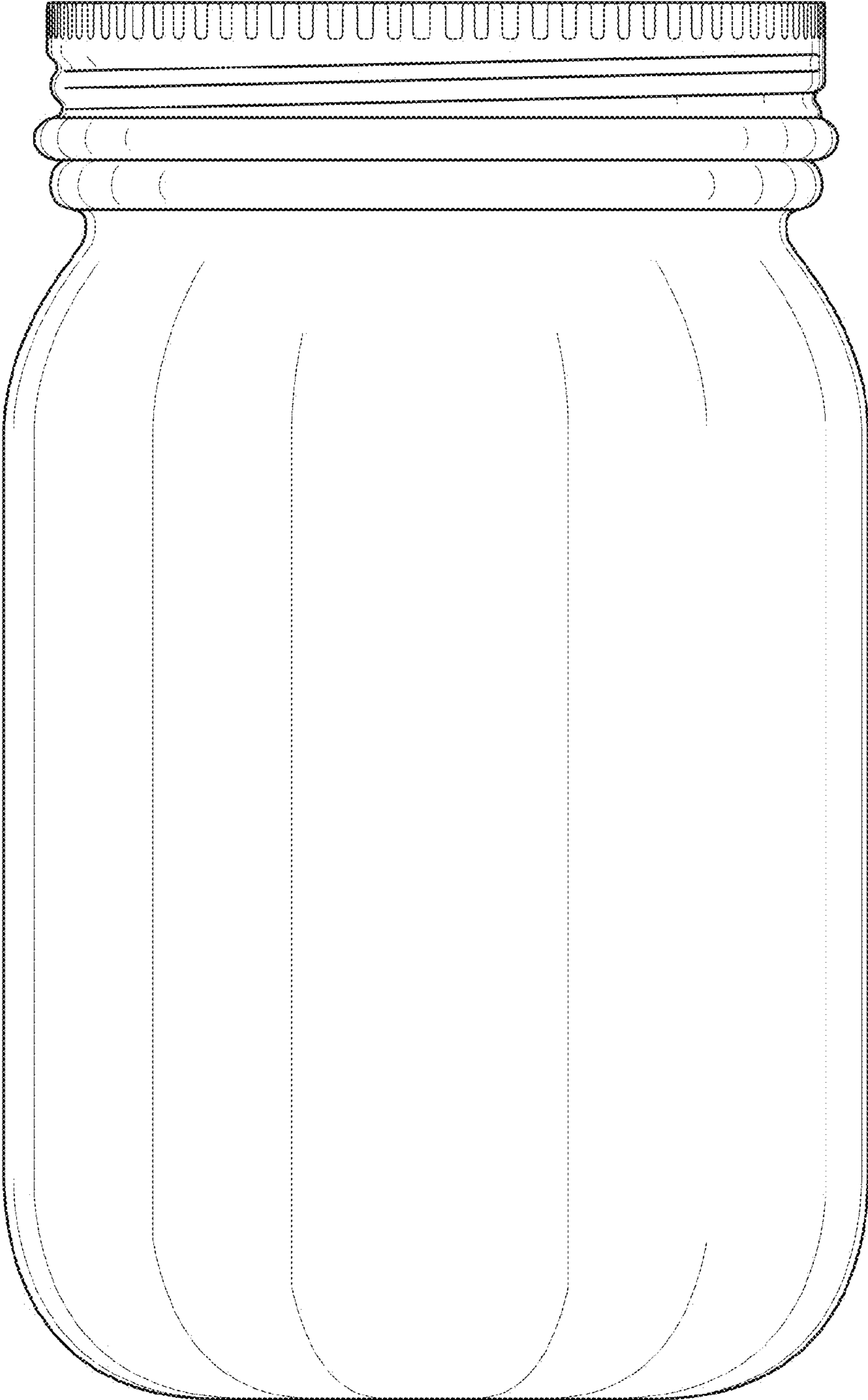

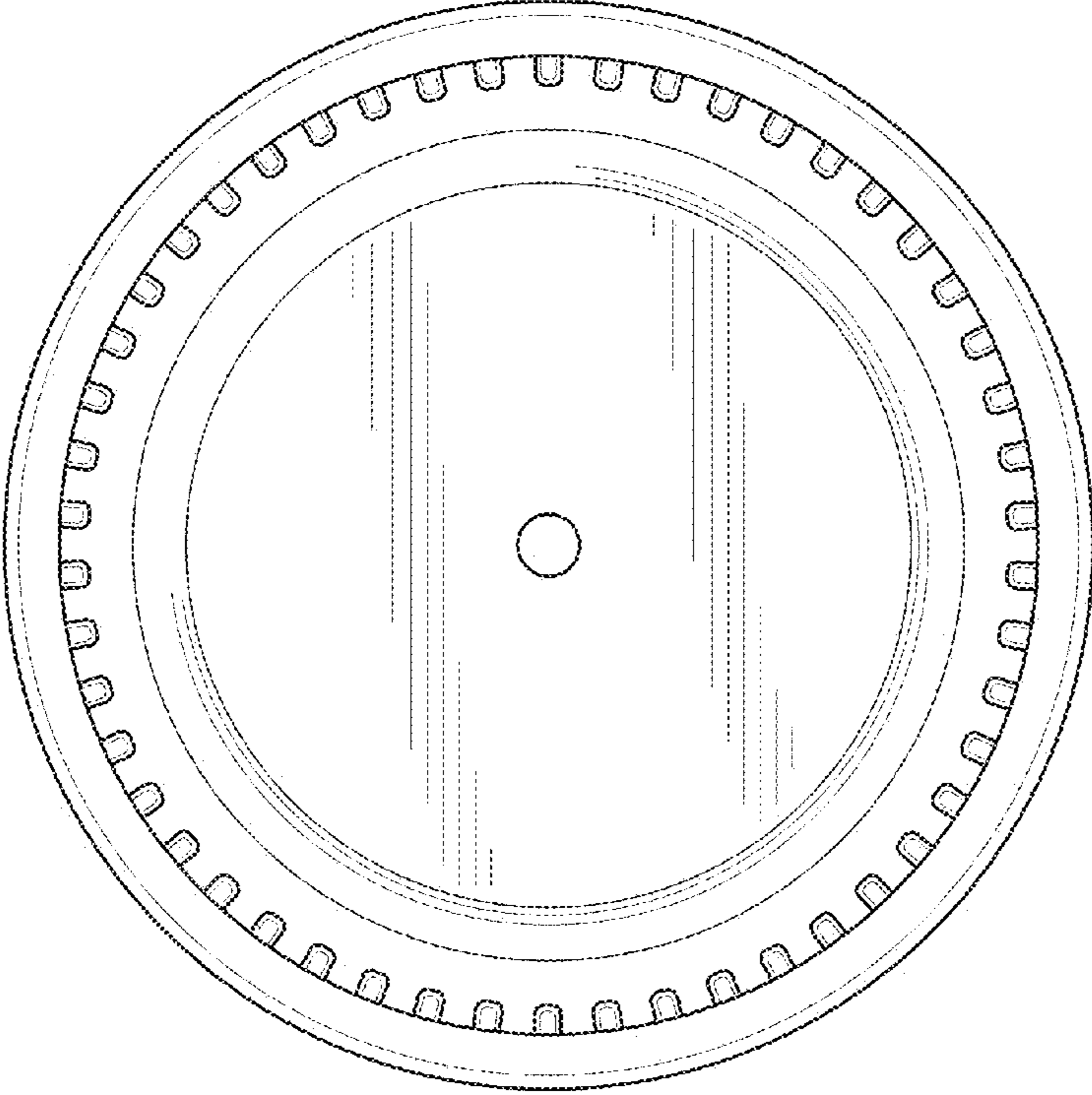

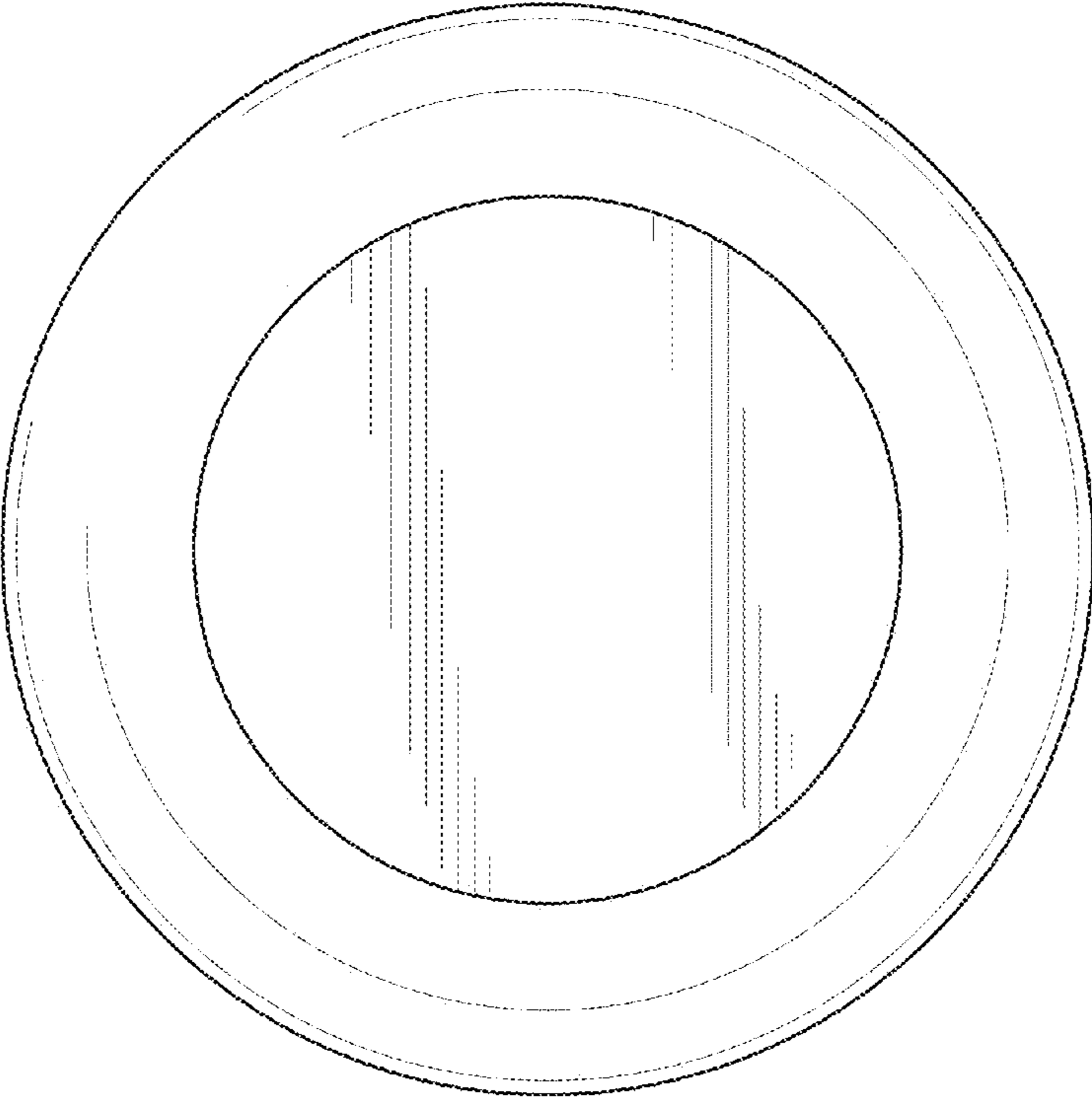

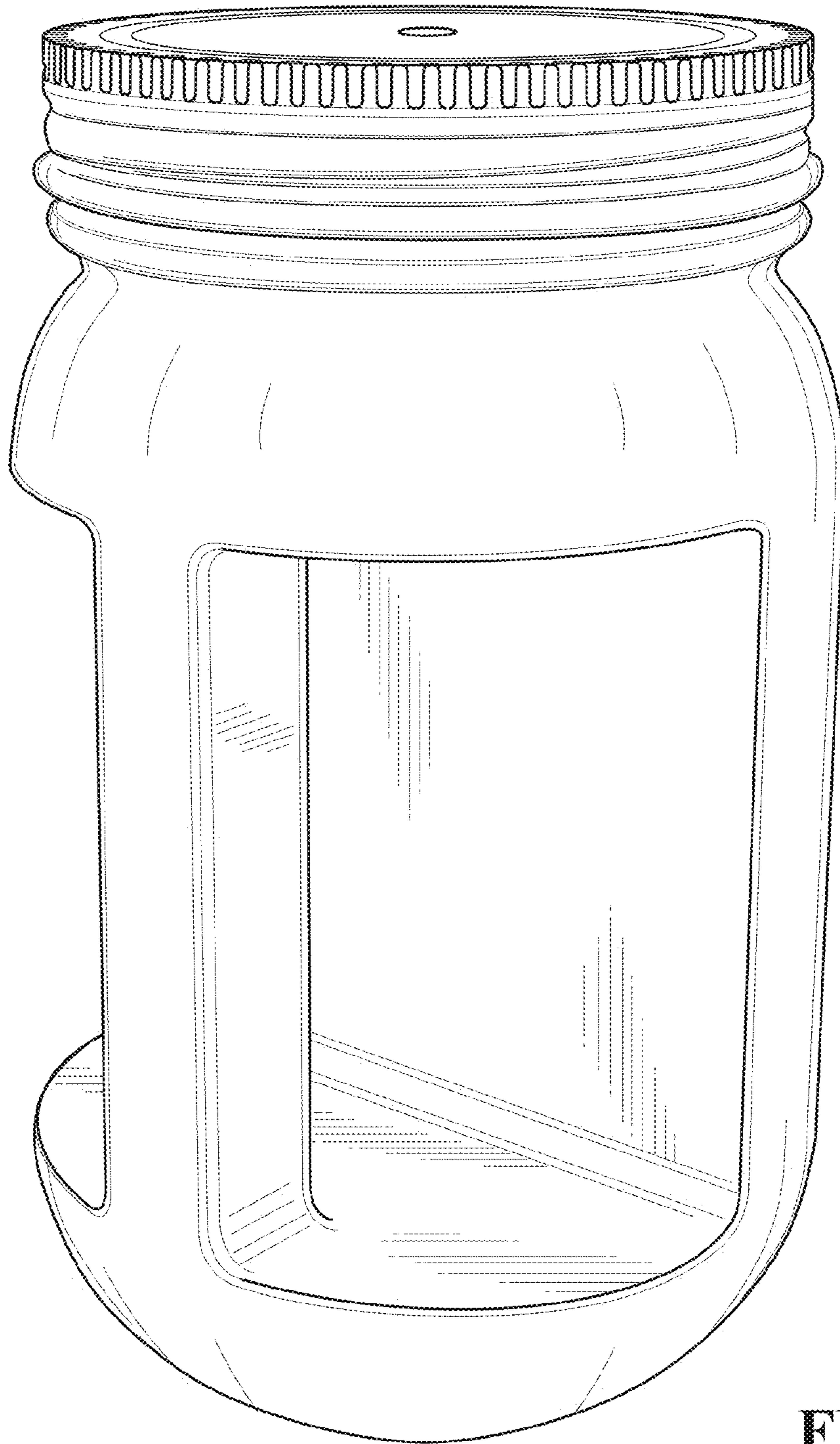

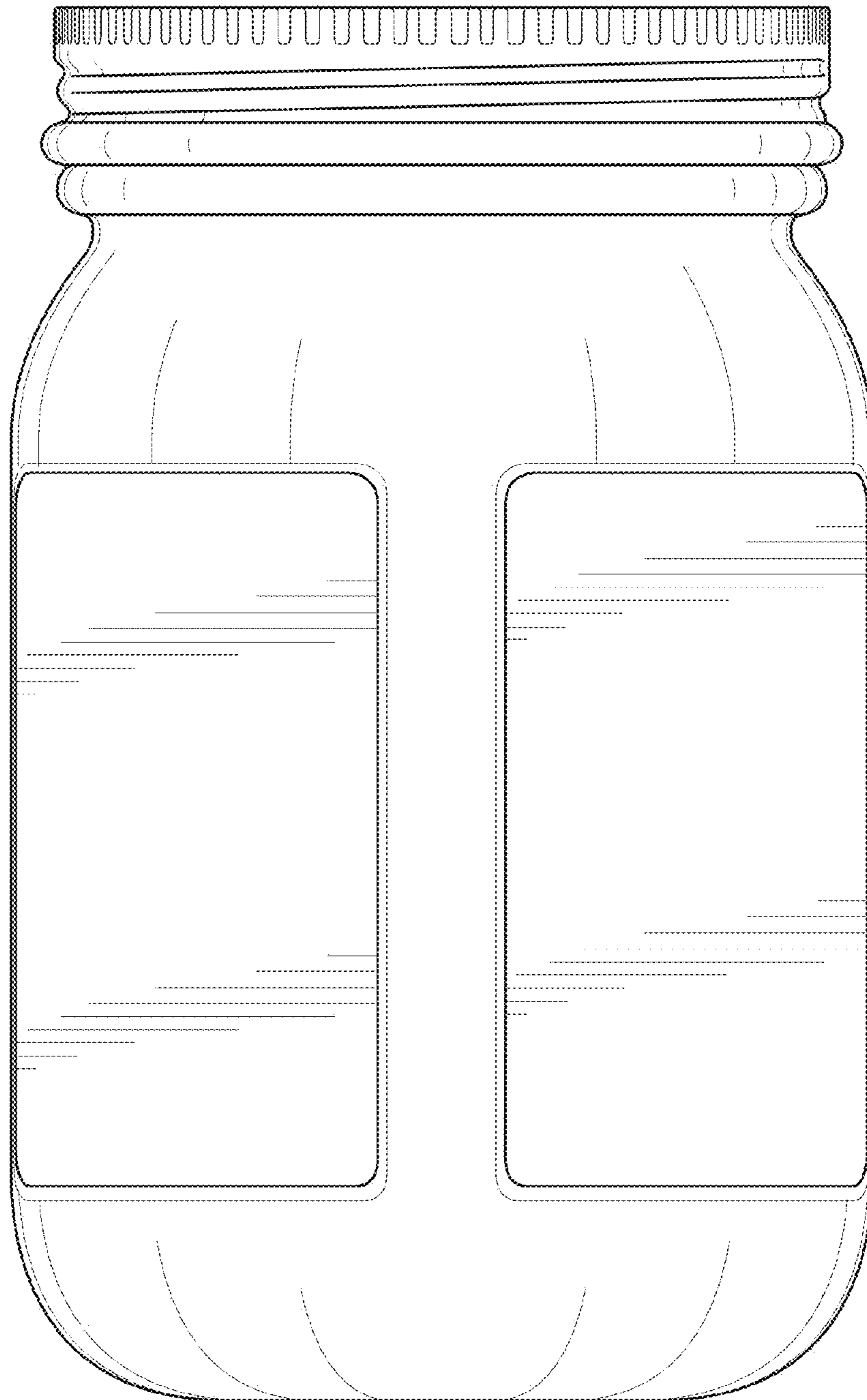

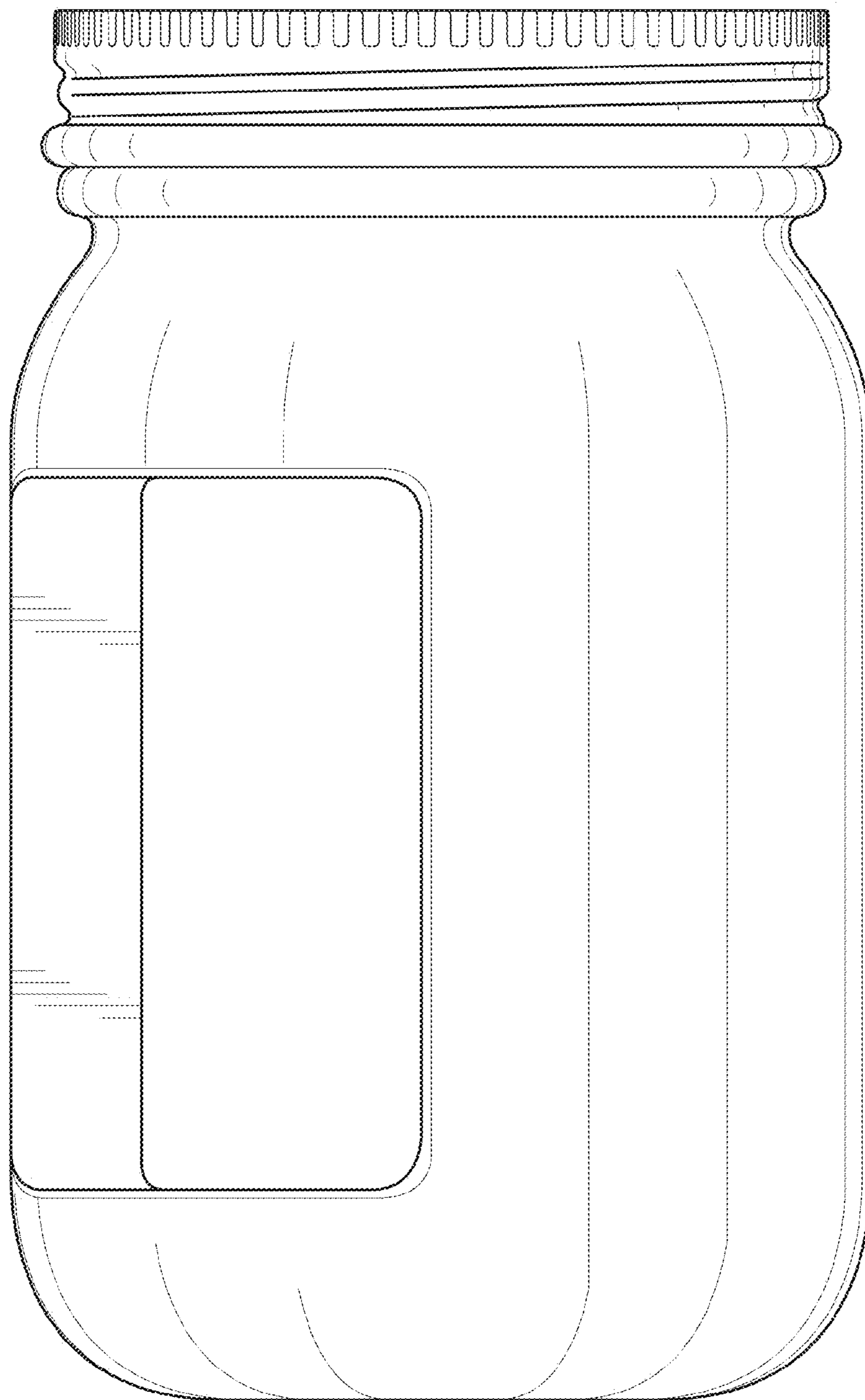

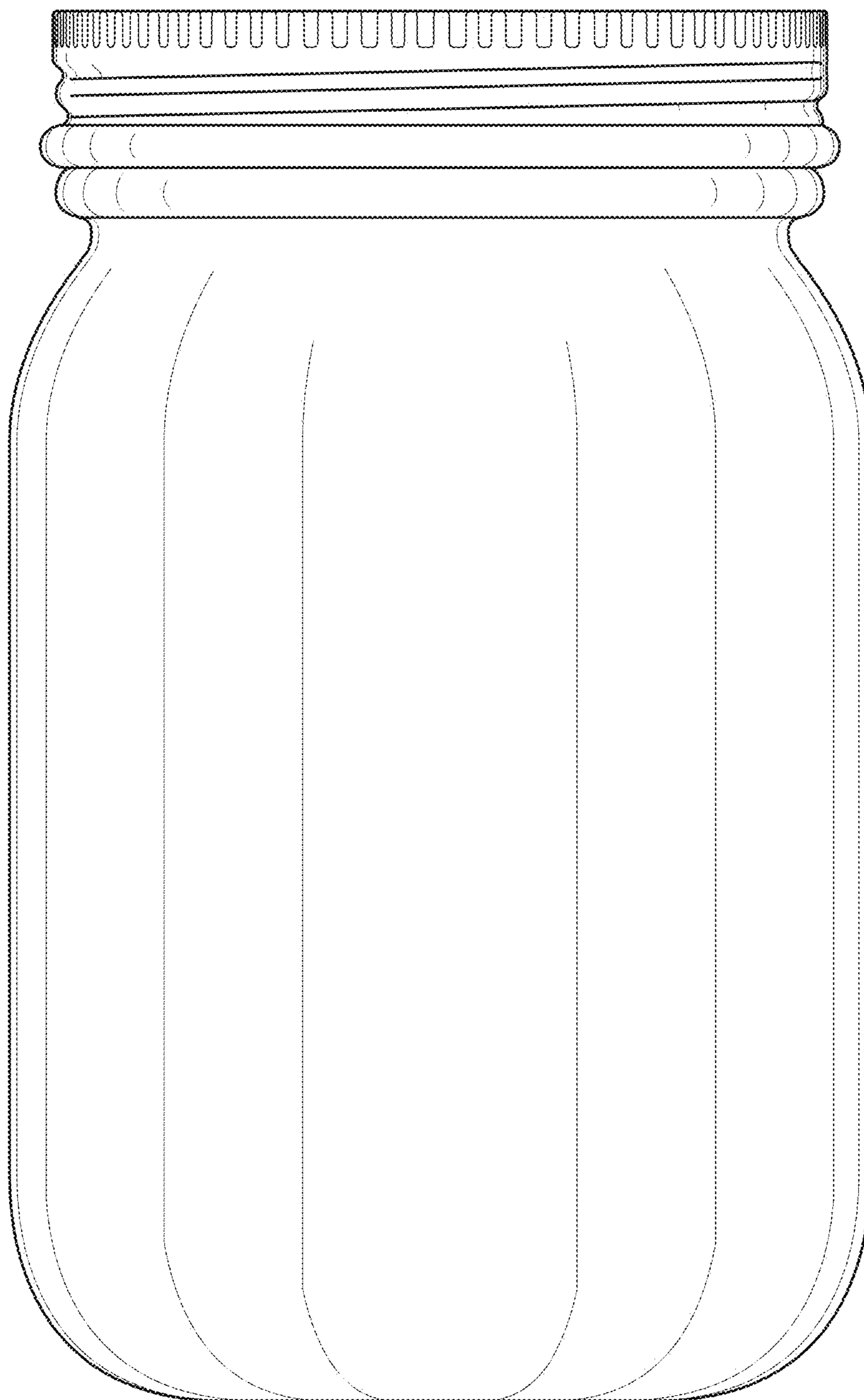

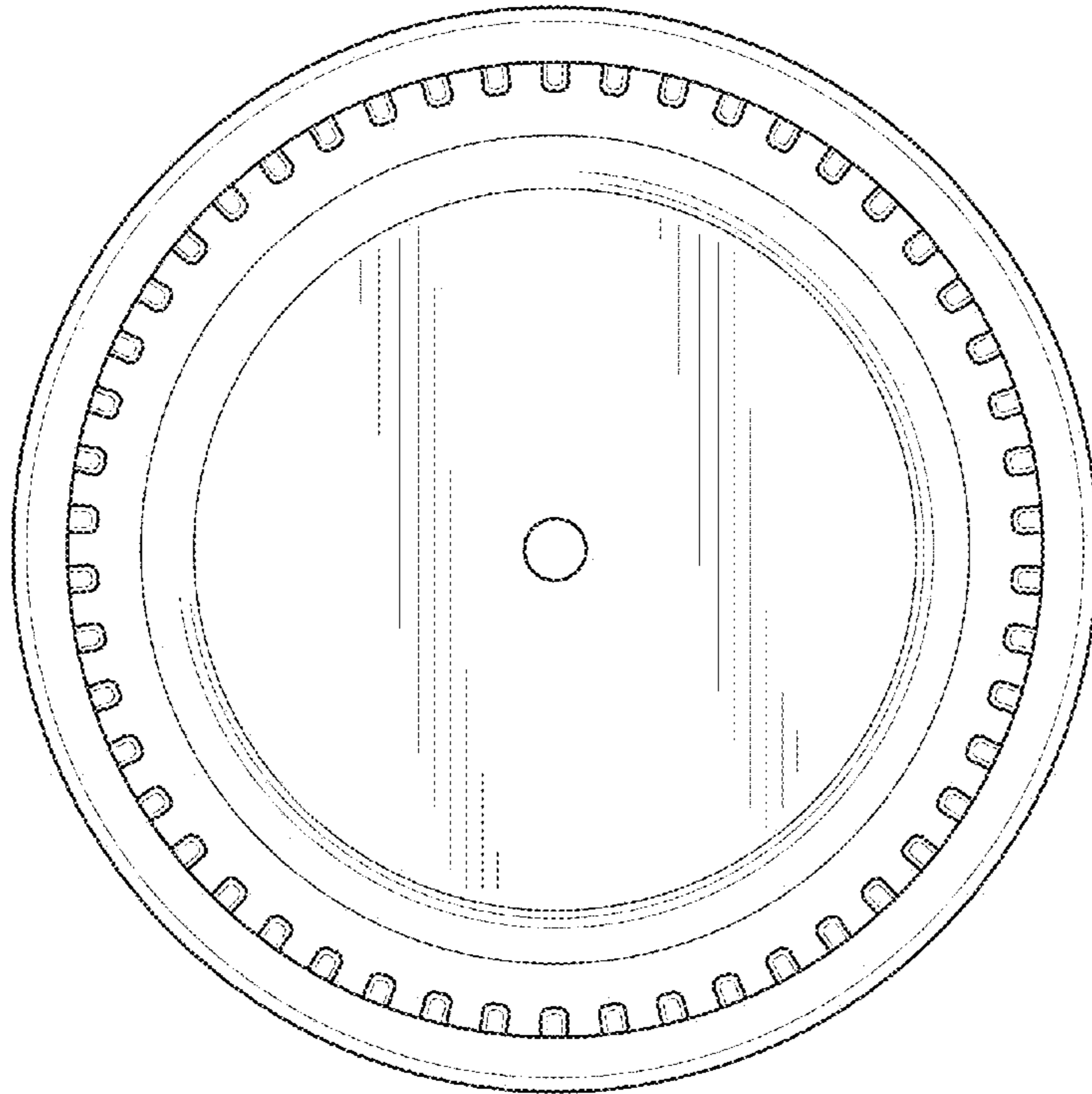

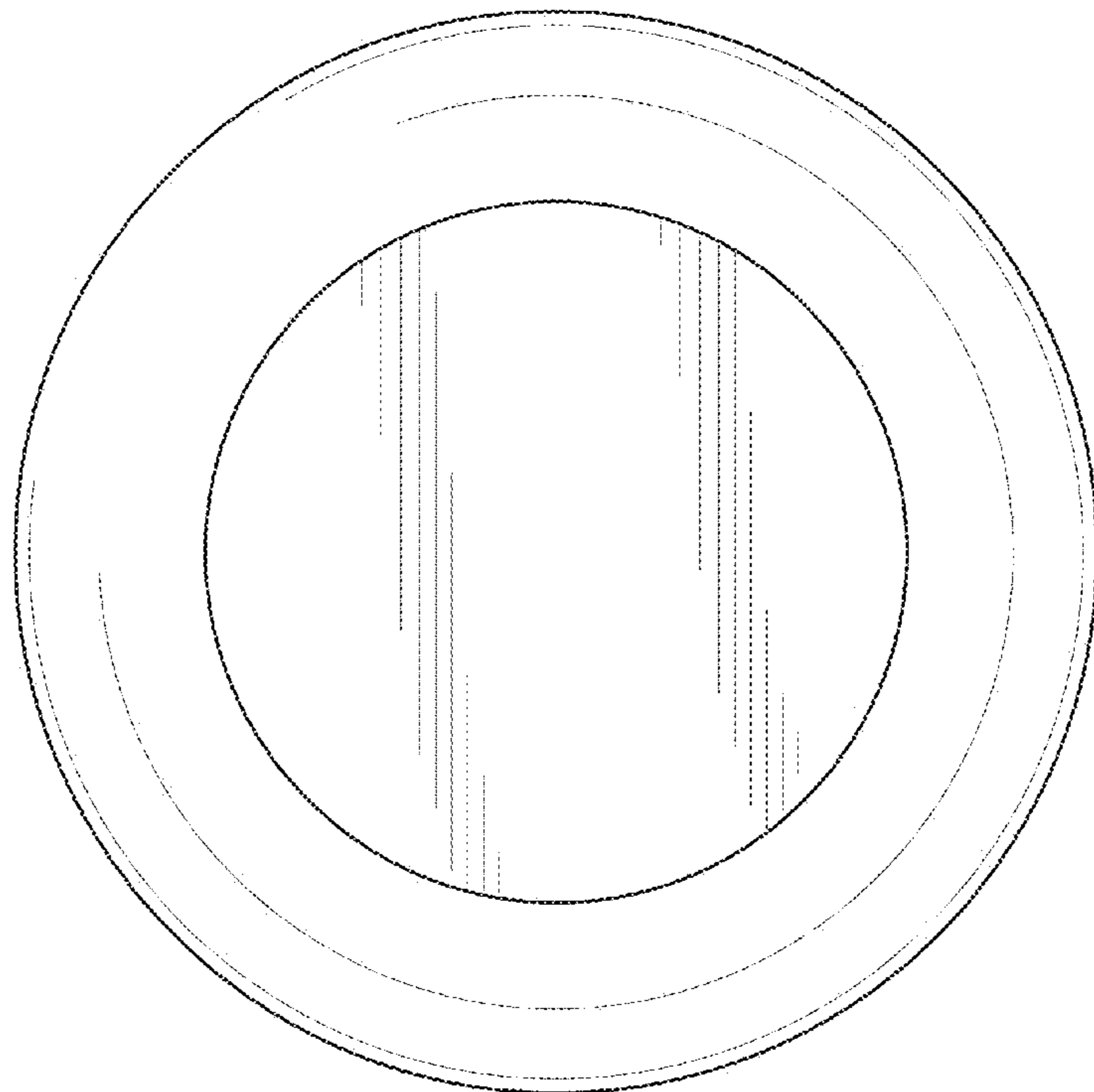
