(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with icon, showing my new design; and, FIG. 2 is a front view of a display screen or portion thereof with icon, showing an alternative embodiment of the new design.

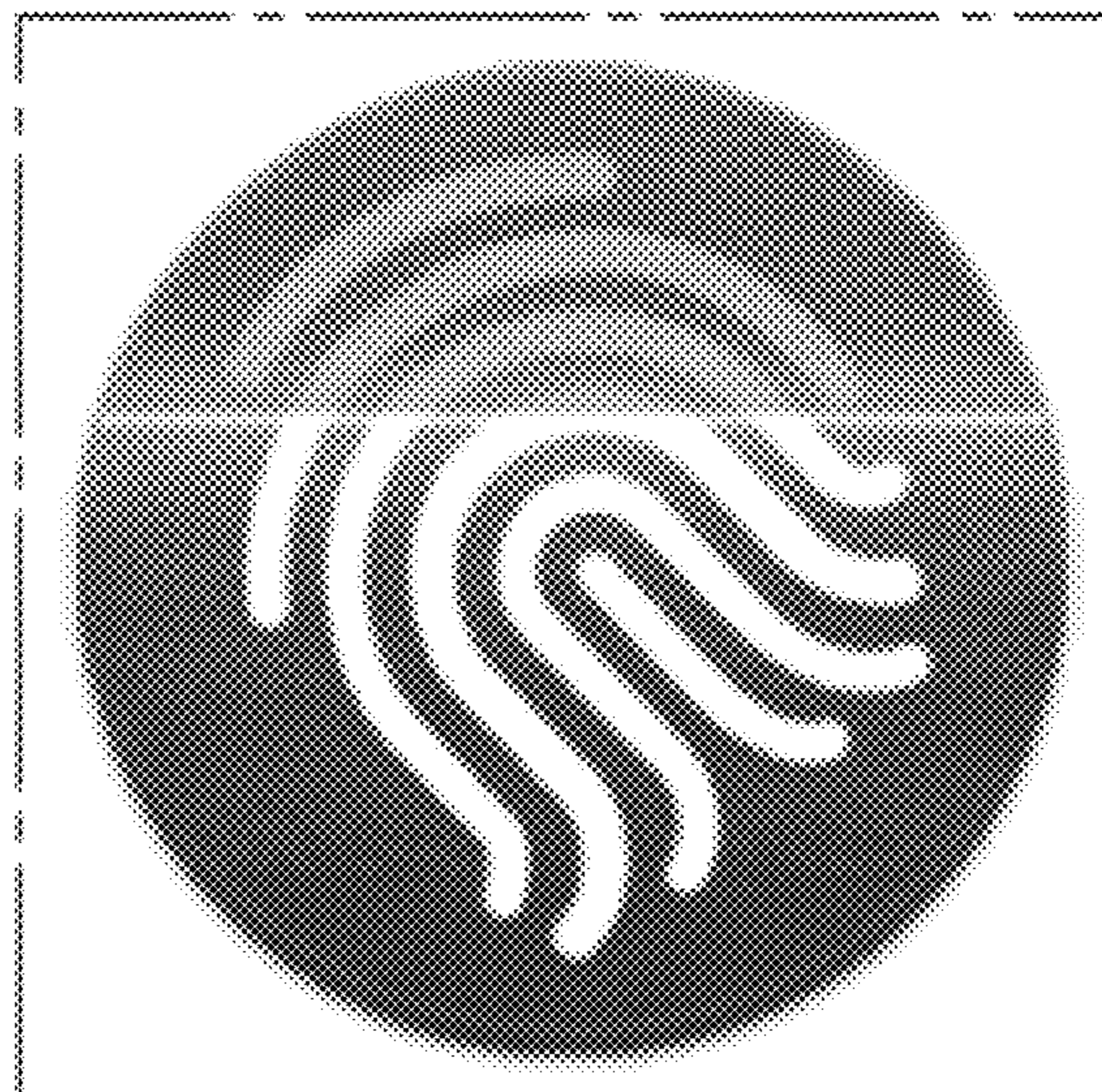

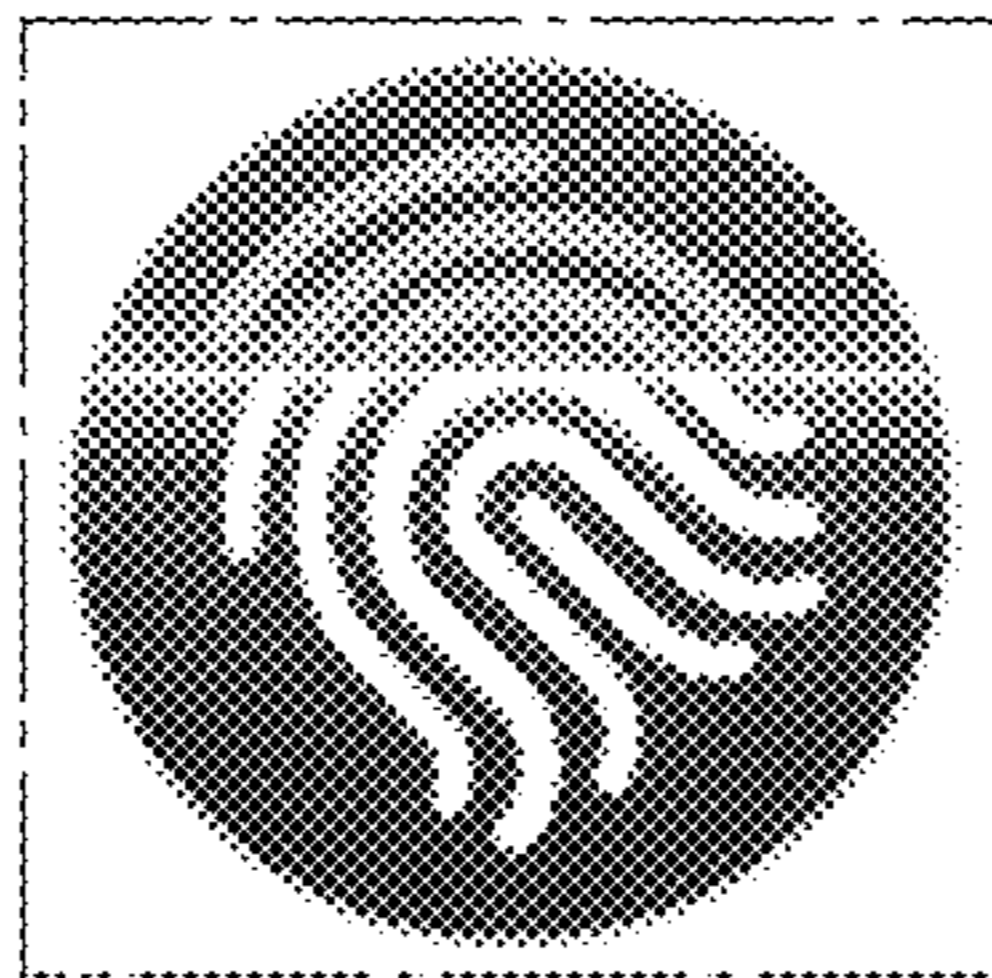
