(57) **CLAIM**

The ornamental design for an ambidextrous glove with circular depression surface texture, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an ambidextrous glove with circular depression surface texture wherein the dashed lines indicate the bounds of the detail view shown in FIG. 7;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a top plan view thereof;

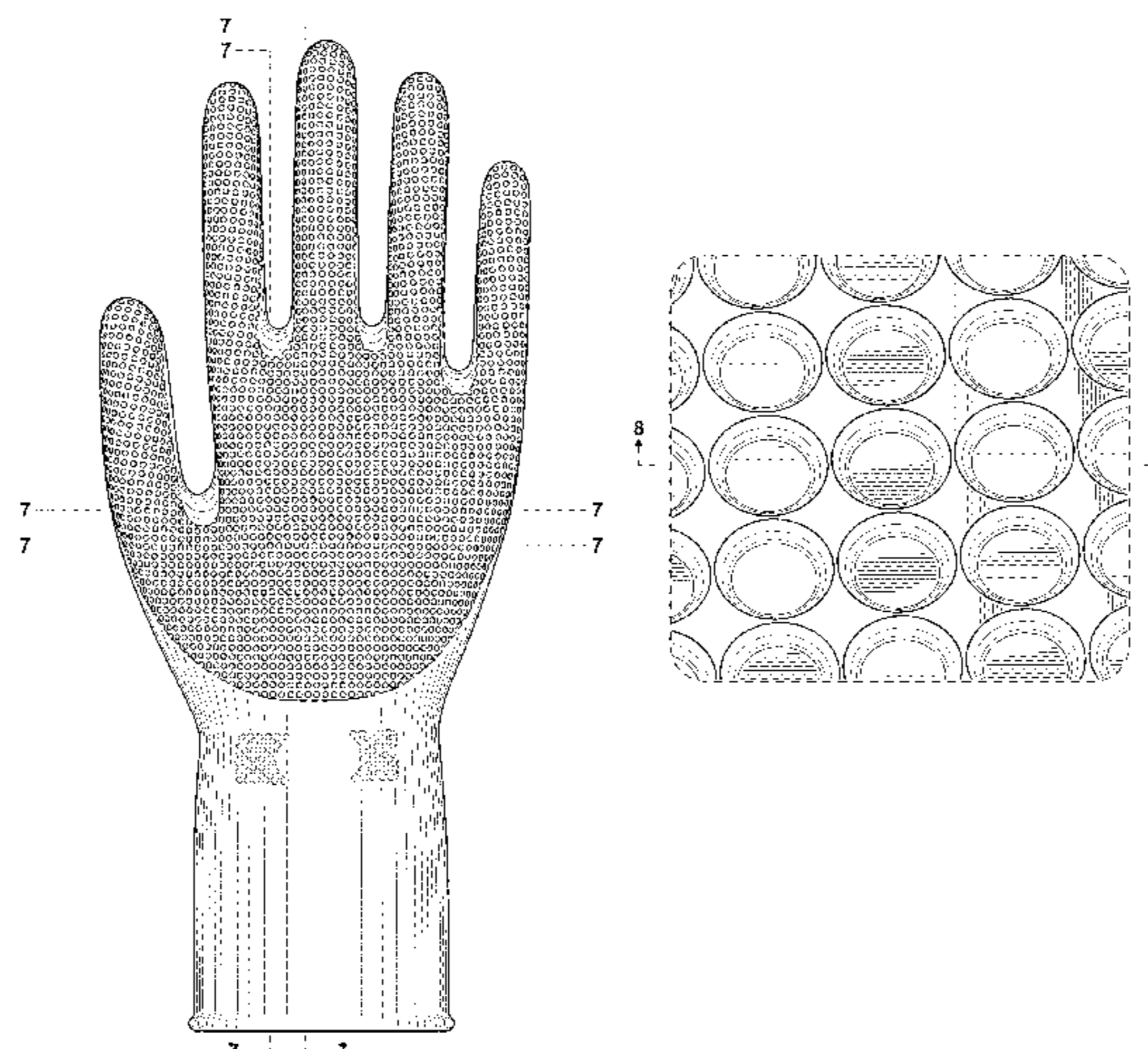
FIG. 6 is a bottom plan view thereof;

FIG. 7 is a close-up detailed view showing the textured surface of an ambidextrous glove with circular depression surface texture taken from line 7-7 of FIG. 1; and,

FIG. 8 is a close-up cross-sectional view showing the textured surface of an ambidextrous glove with circular depression surface texture taken from line 8-8 of FIG. 7.

The broken lines on the wrist portions in FIGS. 1-4 represent environmental structure and form no part of the claimed design. The broken line surrounding the enlarged detail view in FIG. 7 illustrates the boundaries of the detail view taken from line 7-7 of FIG. 1 and forms no part of the claimed design.

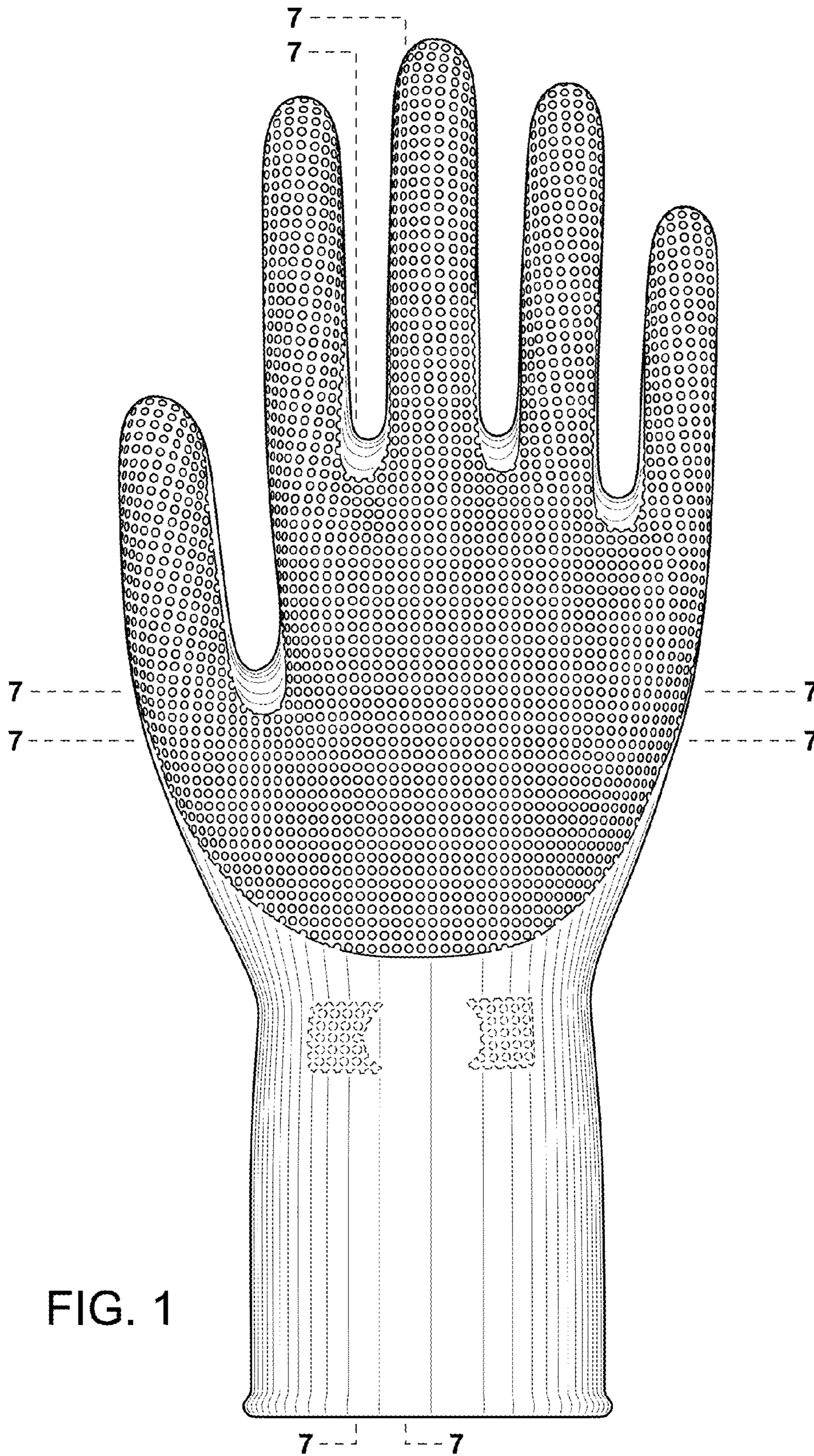

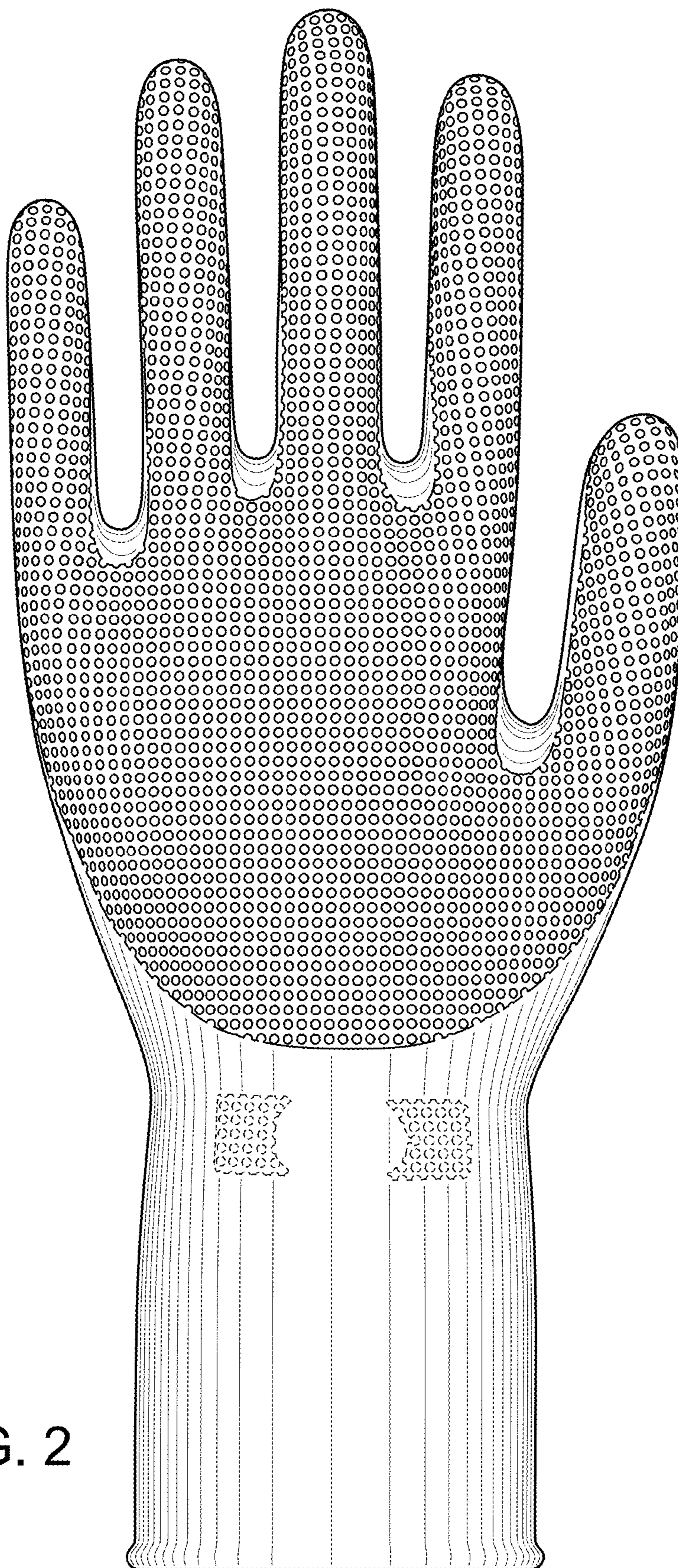

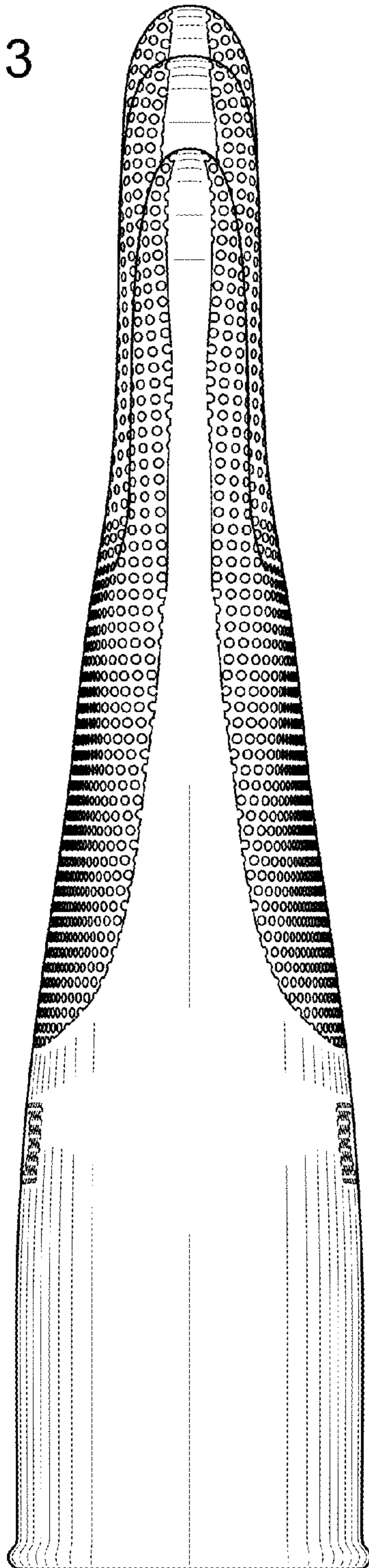
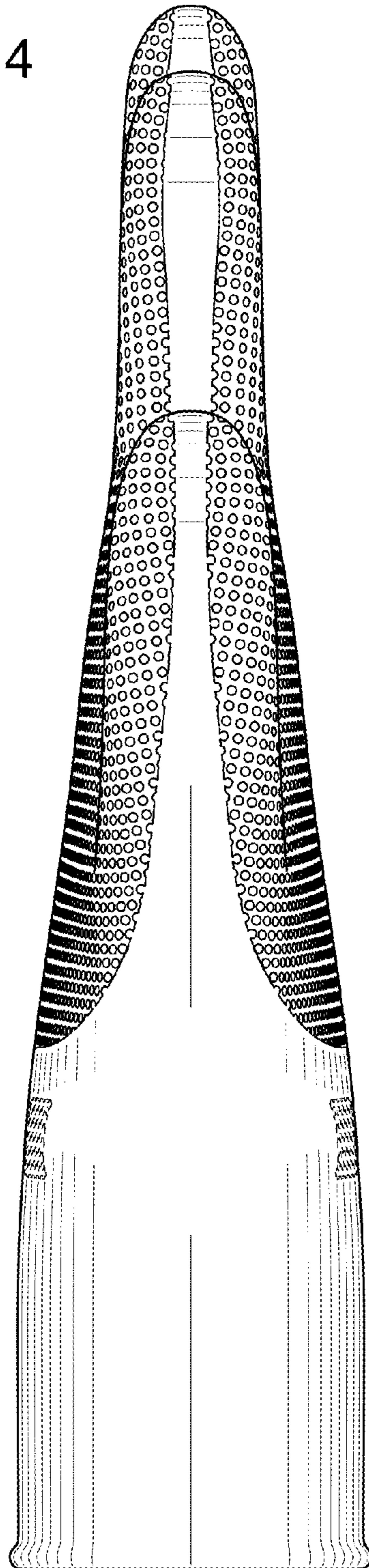

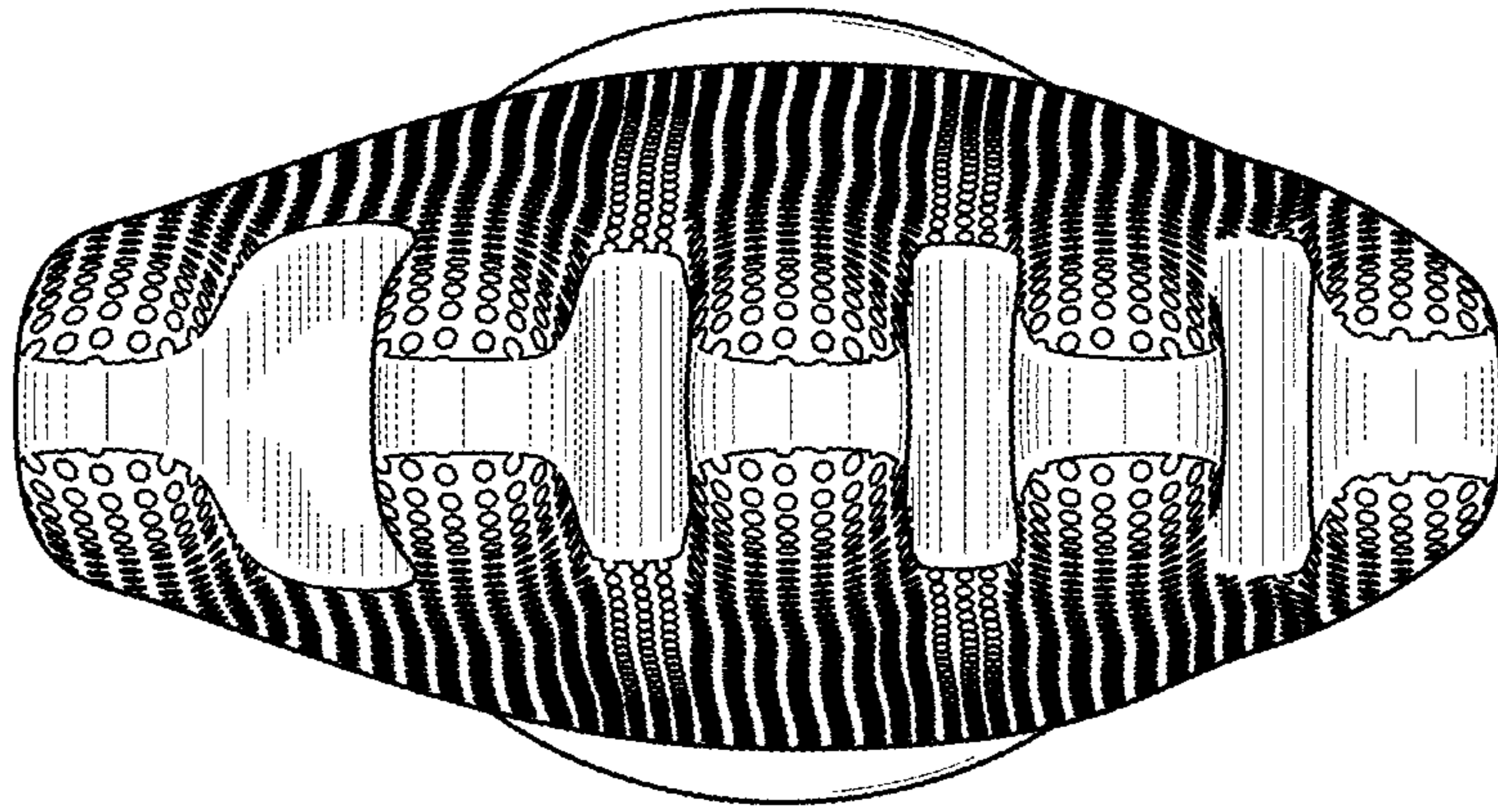

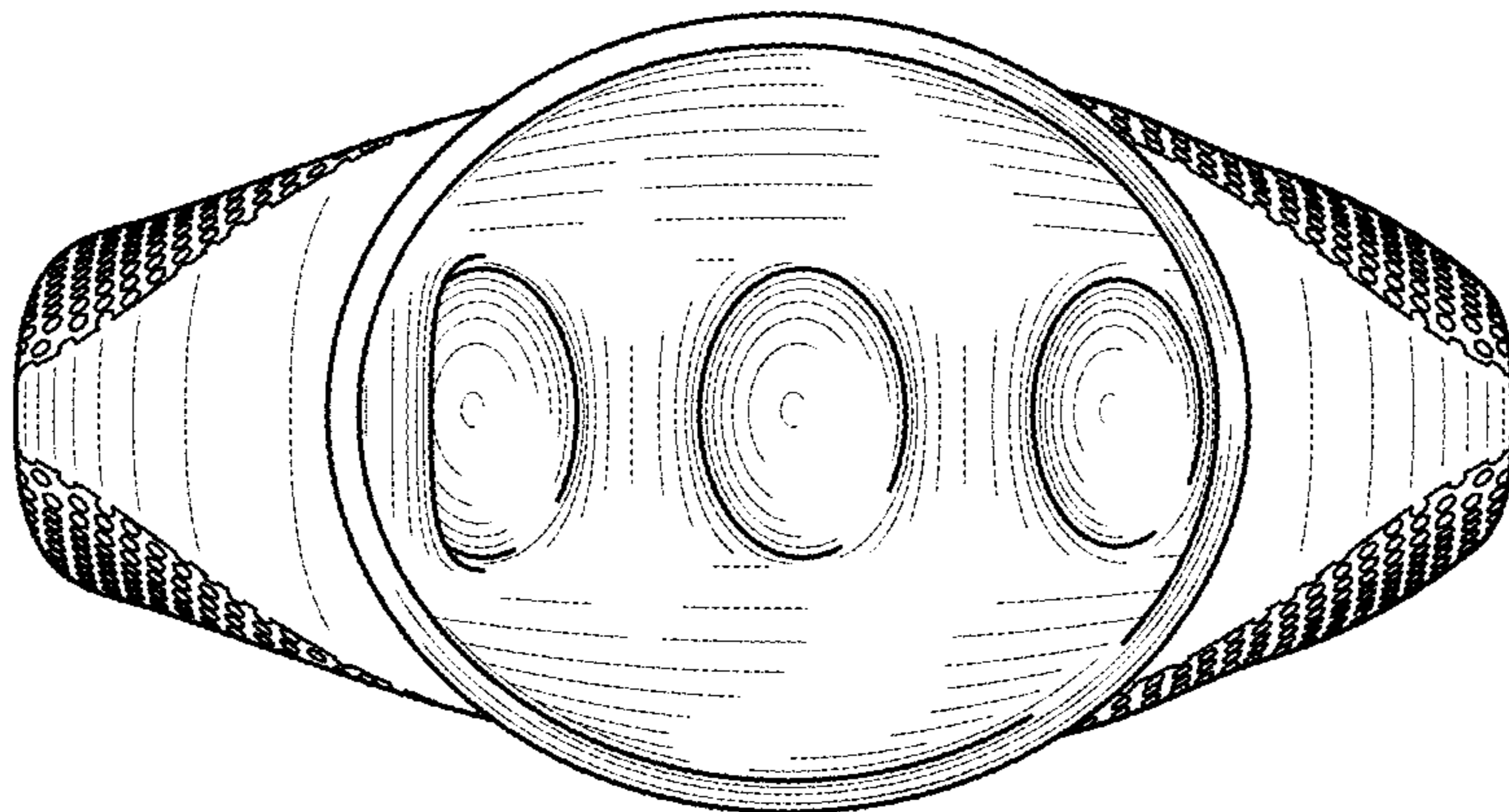

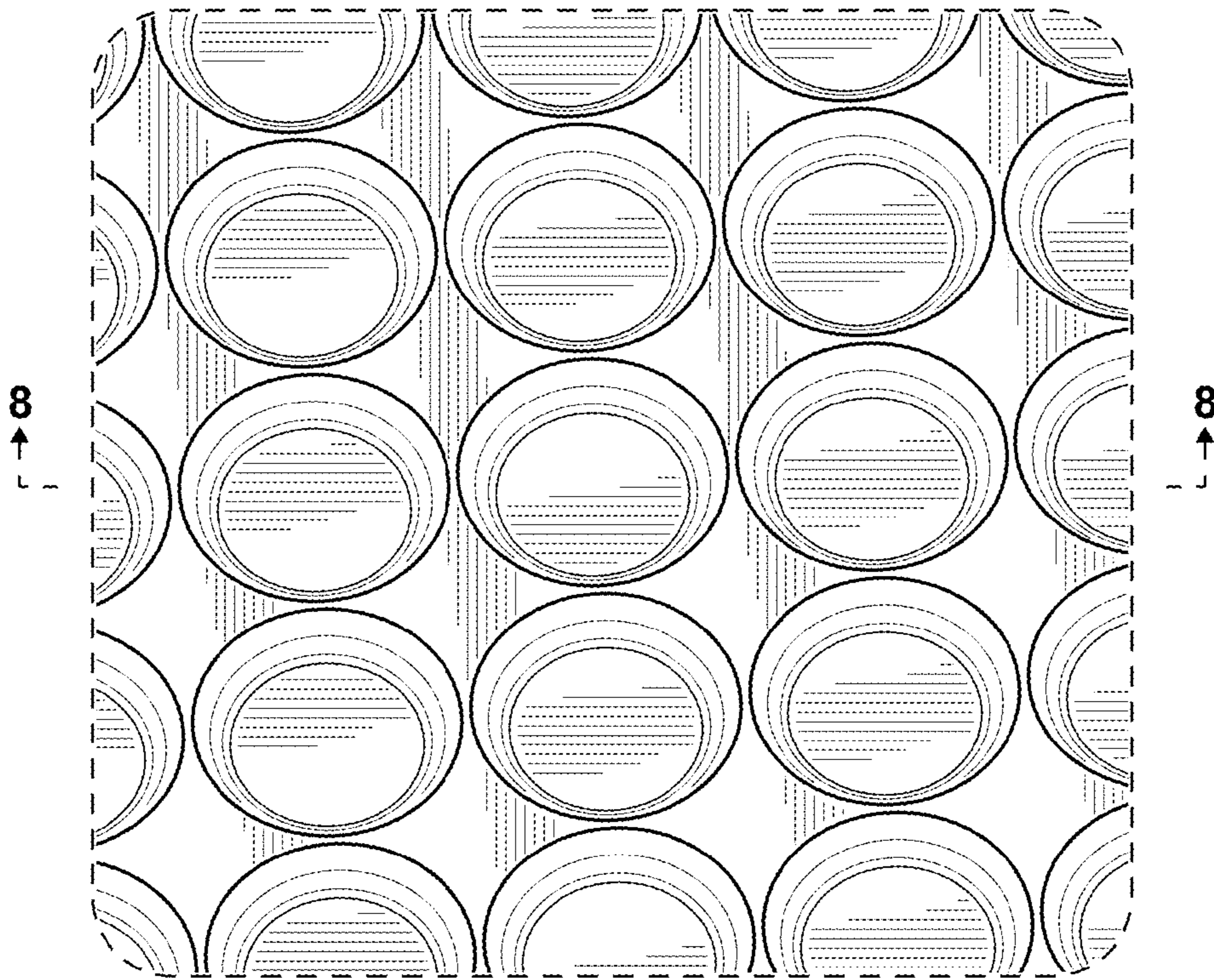
