(57) **CLAIM**

The ornamental design for a mitten with an opening at distal end, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mitten with an opening at distal end, according to my new design.

FIG. 2 is a front elevation view thereof;

FIG. 3 is a back elevation view thereof;

FIG. 4 is a right side elevation view thereof;

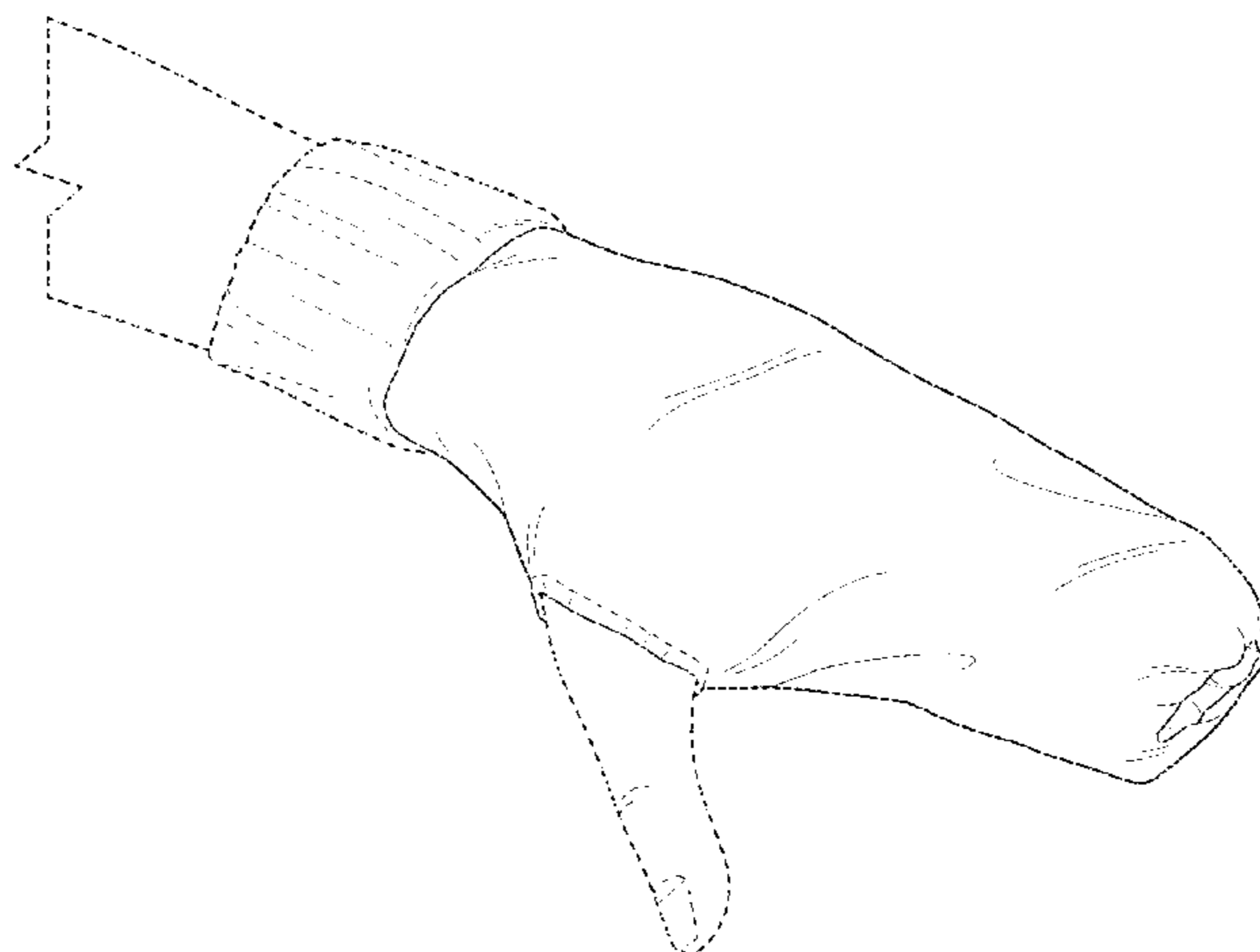
FIG. 5 is a top plan view thereof; and,

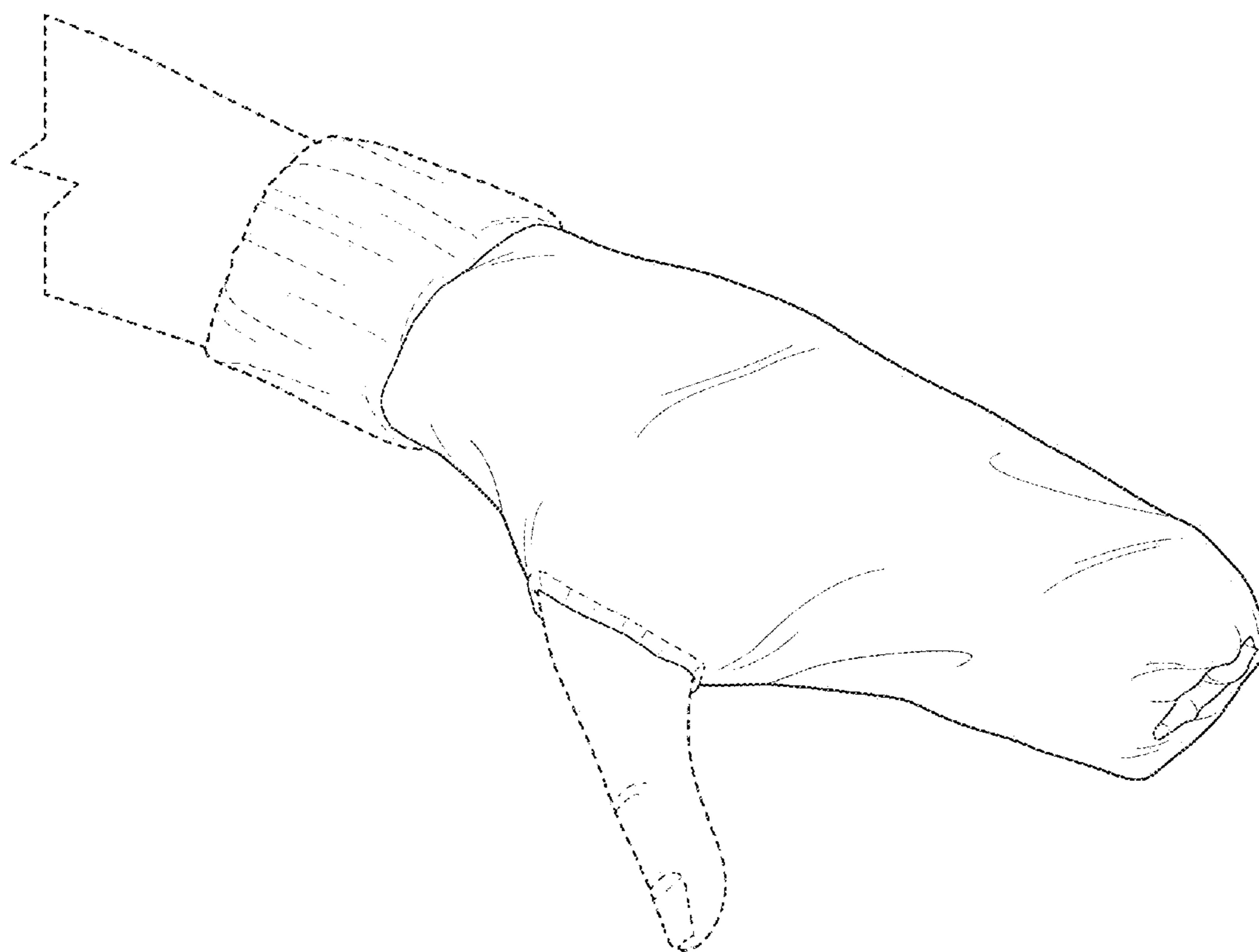

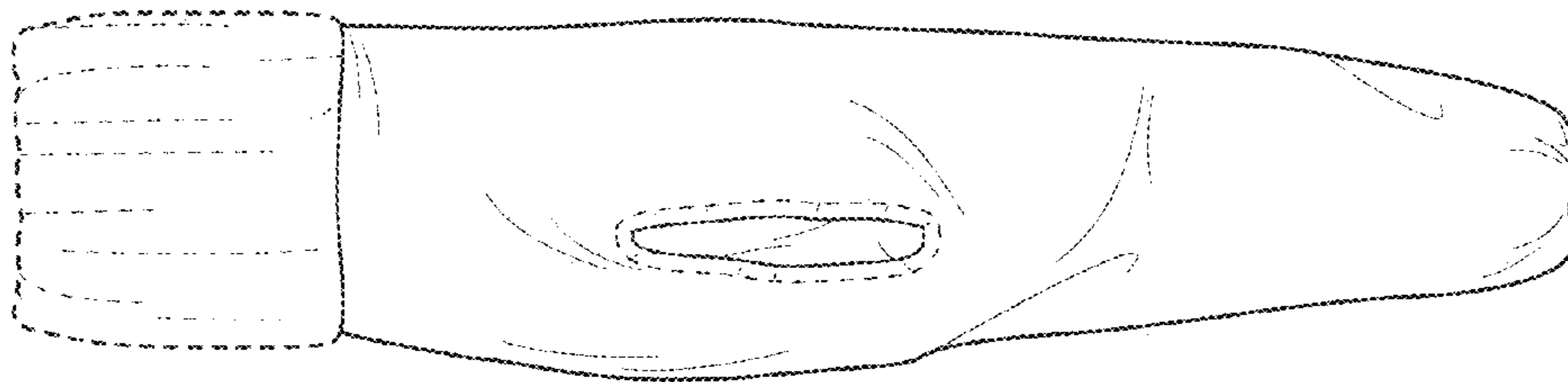

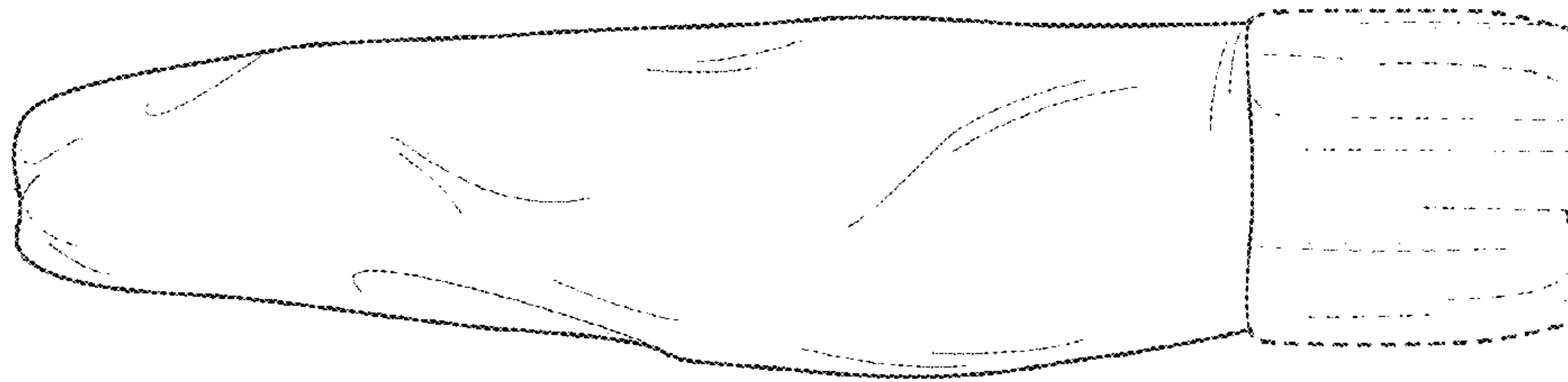

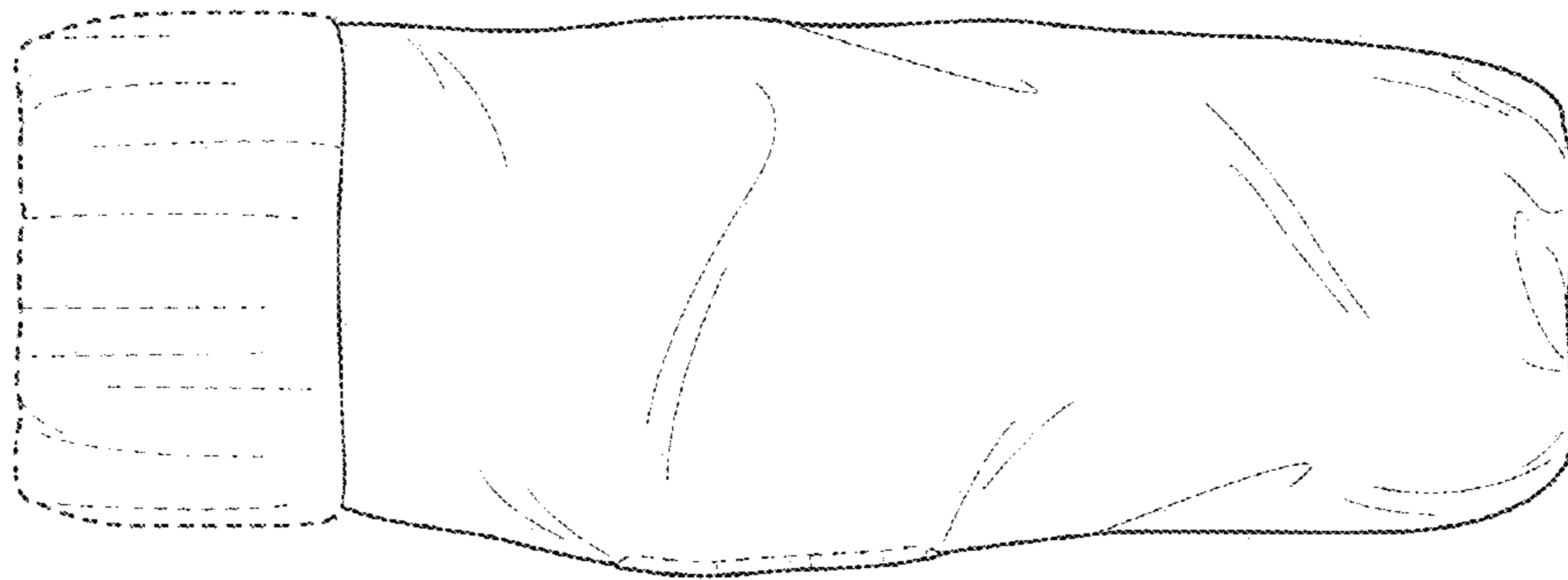

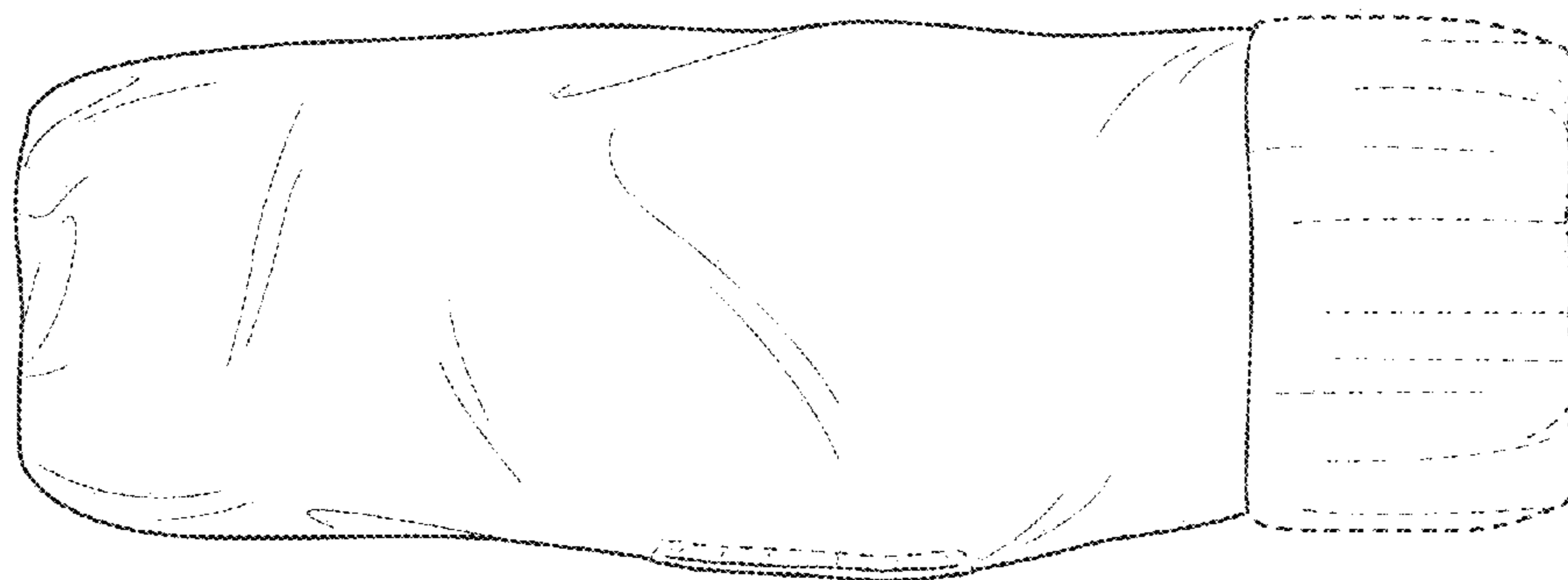
