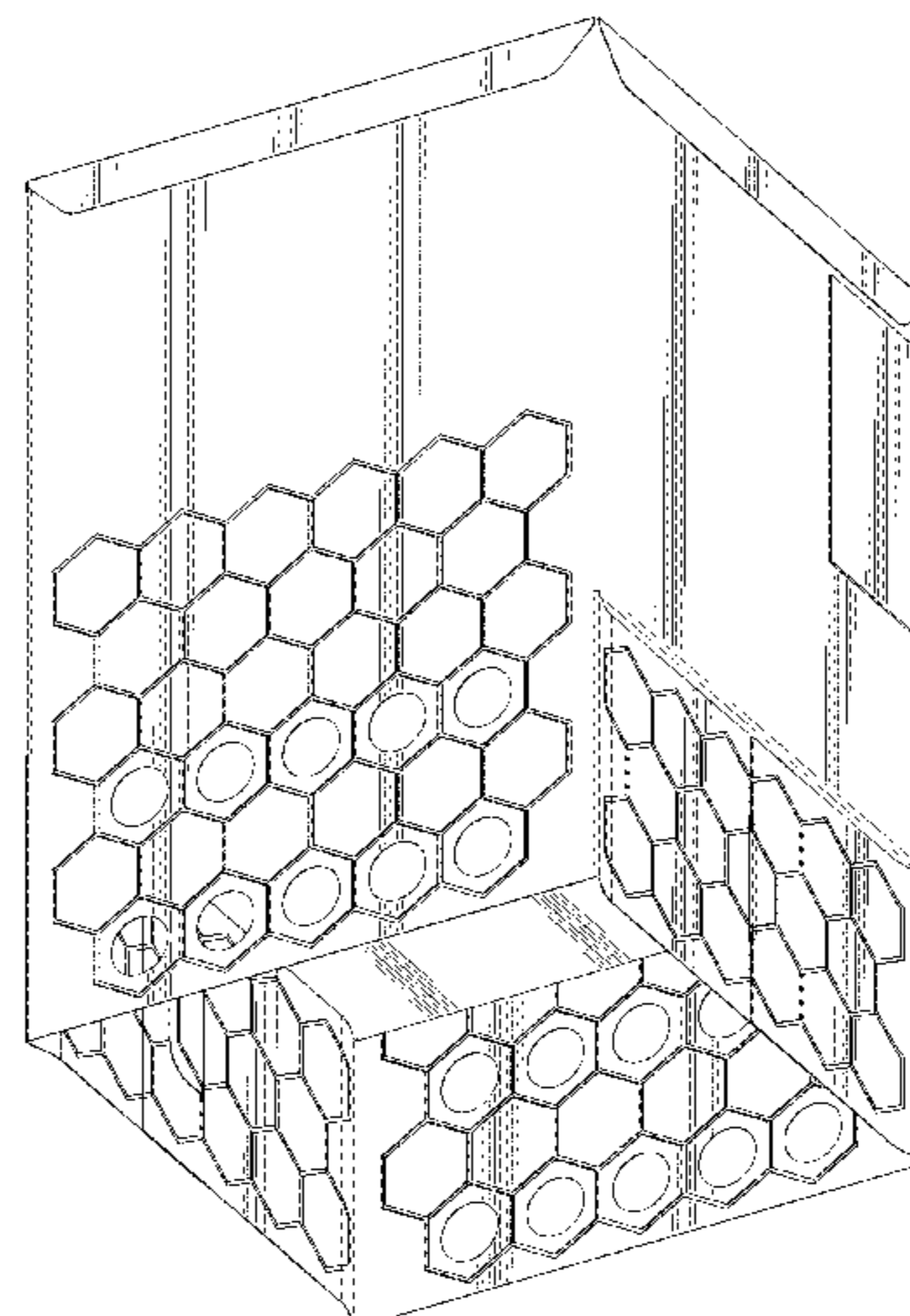
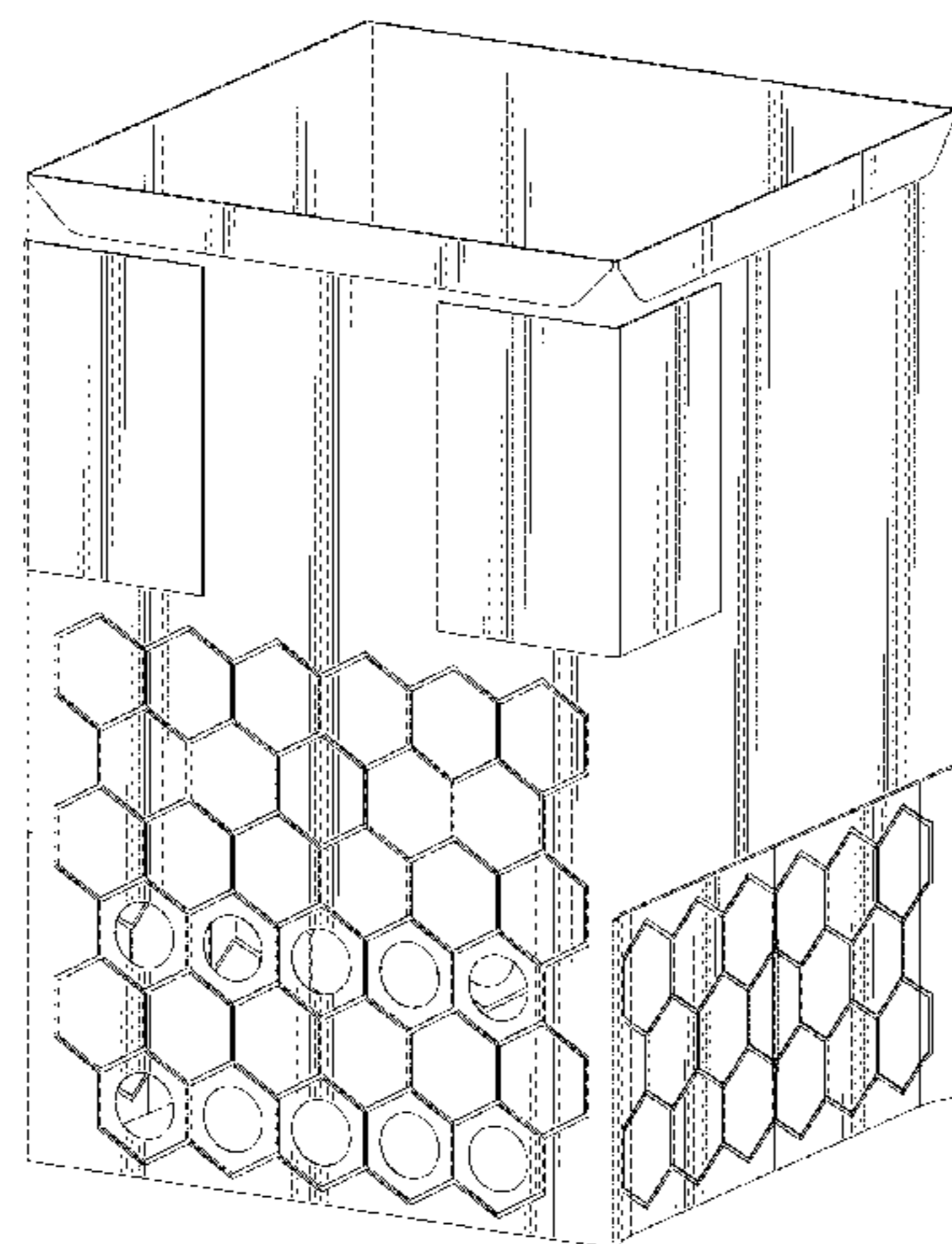
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first front perspective view of a cooking stove showing my new design;

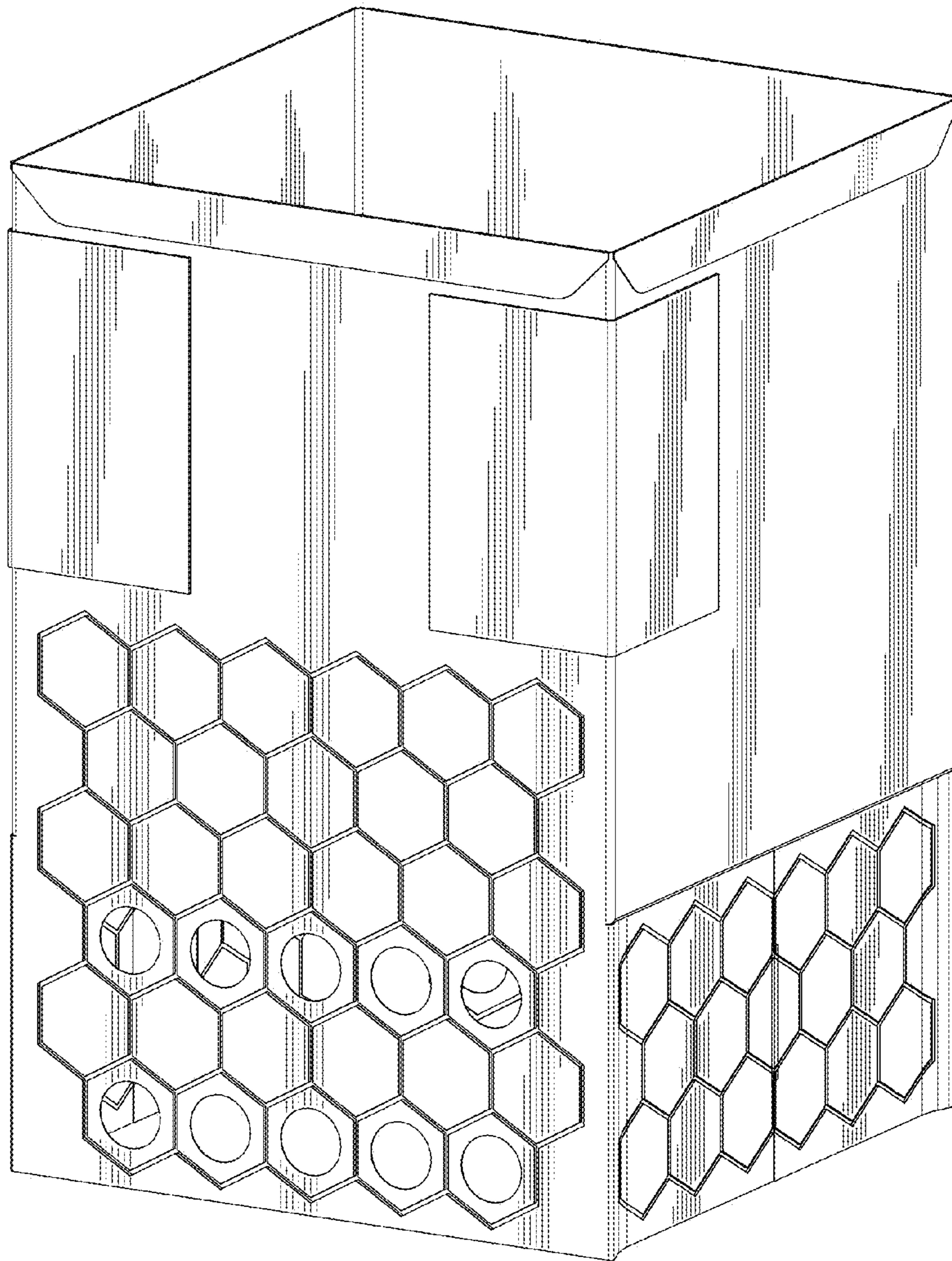

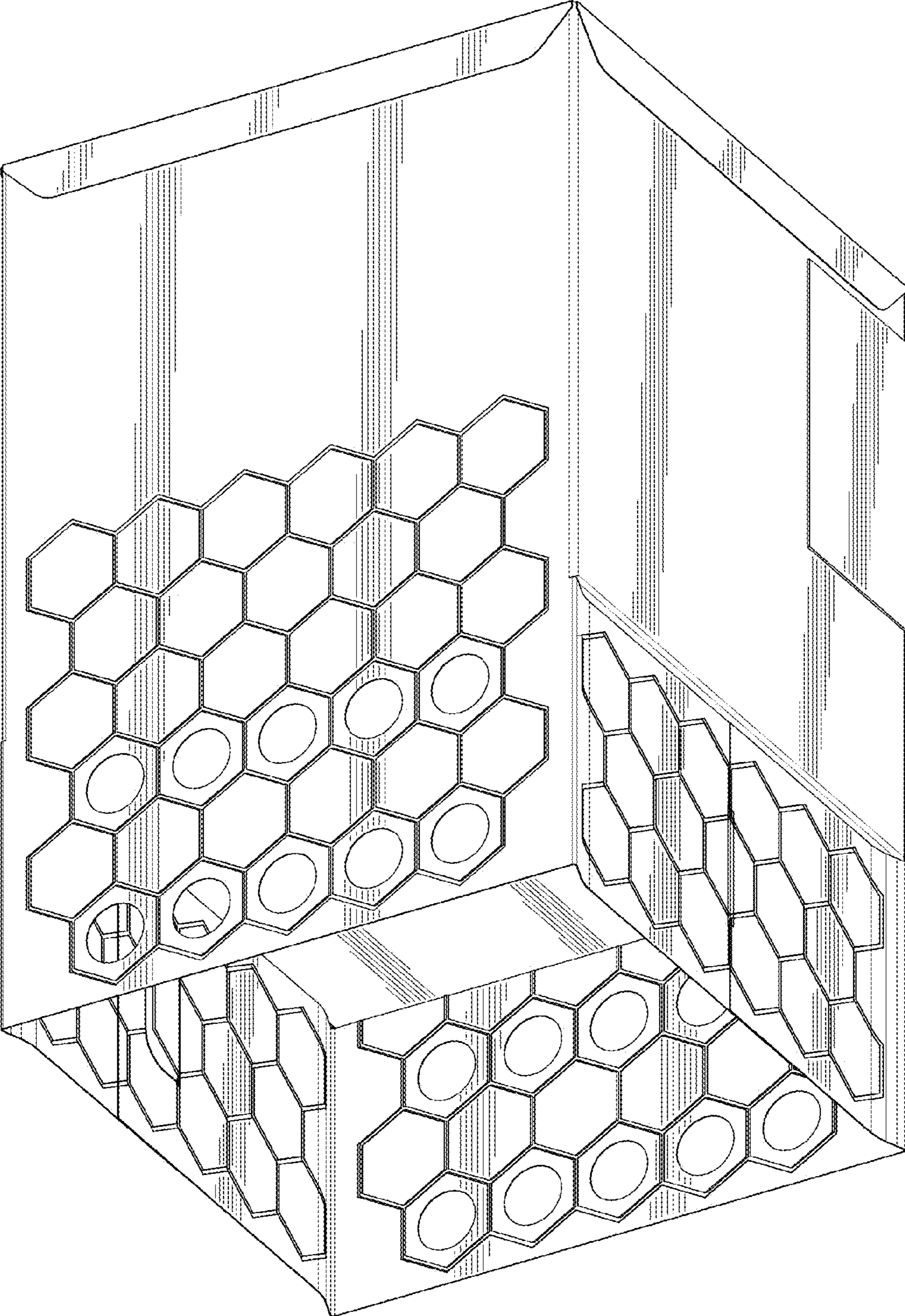

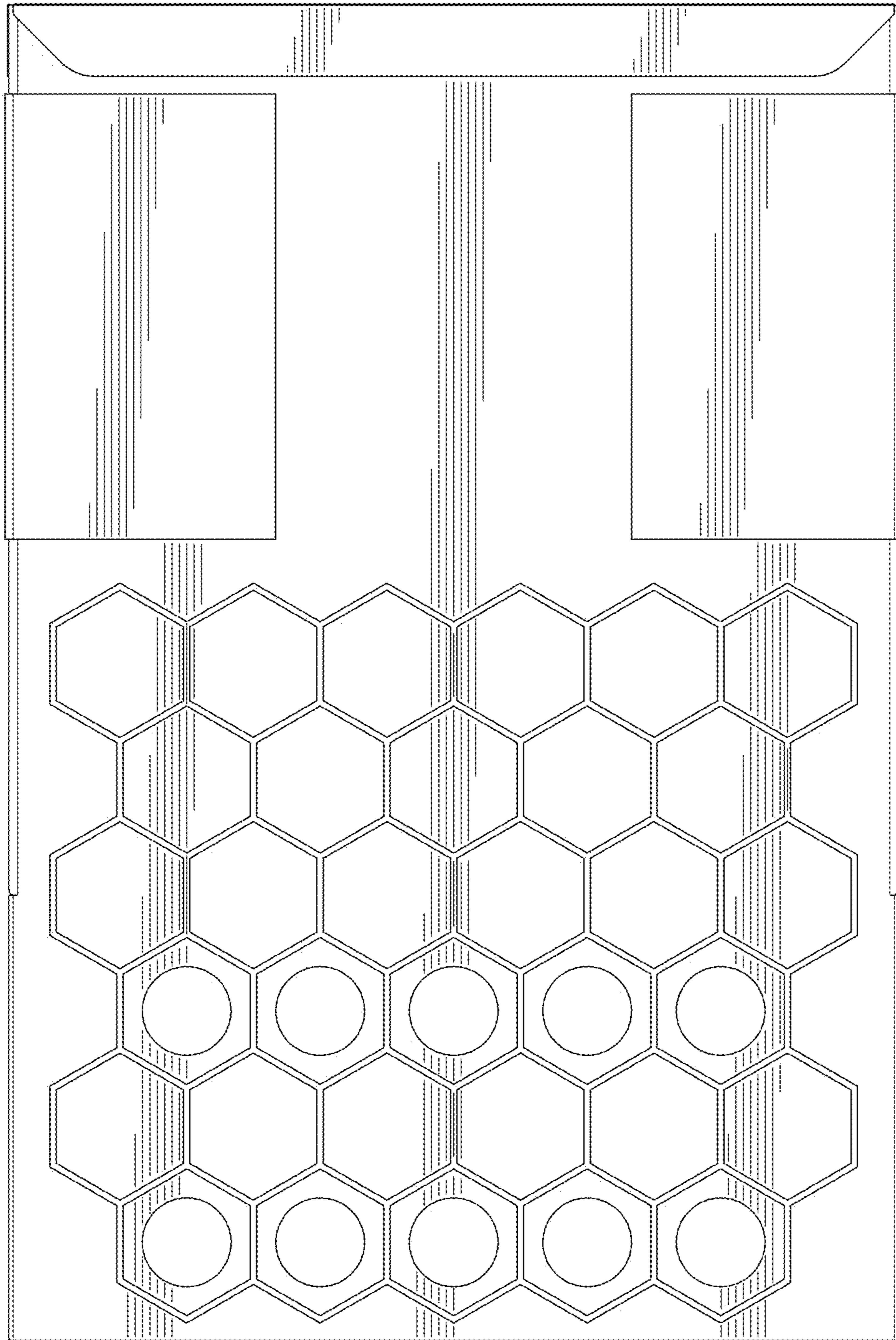

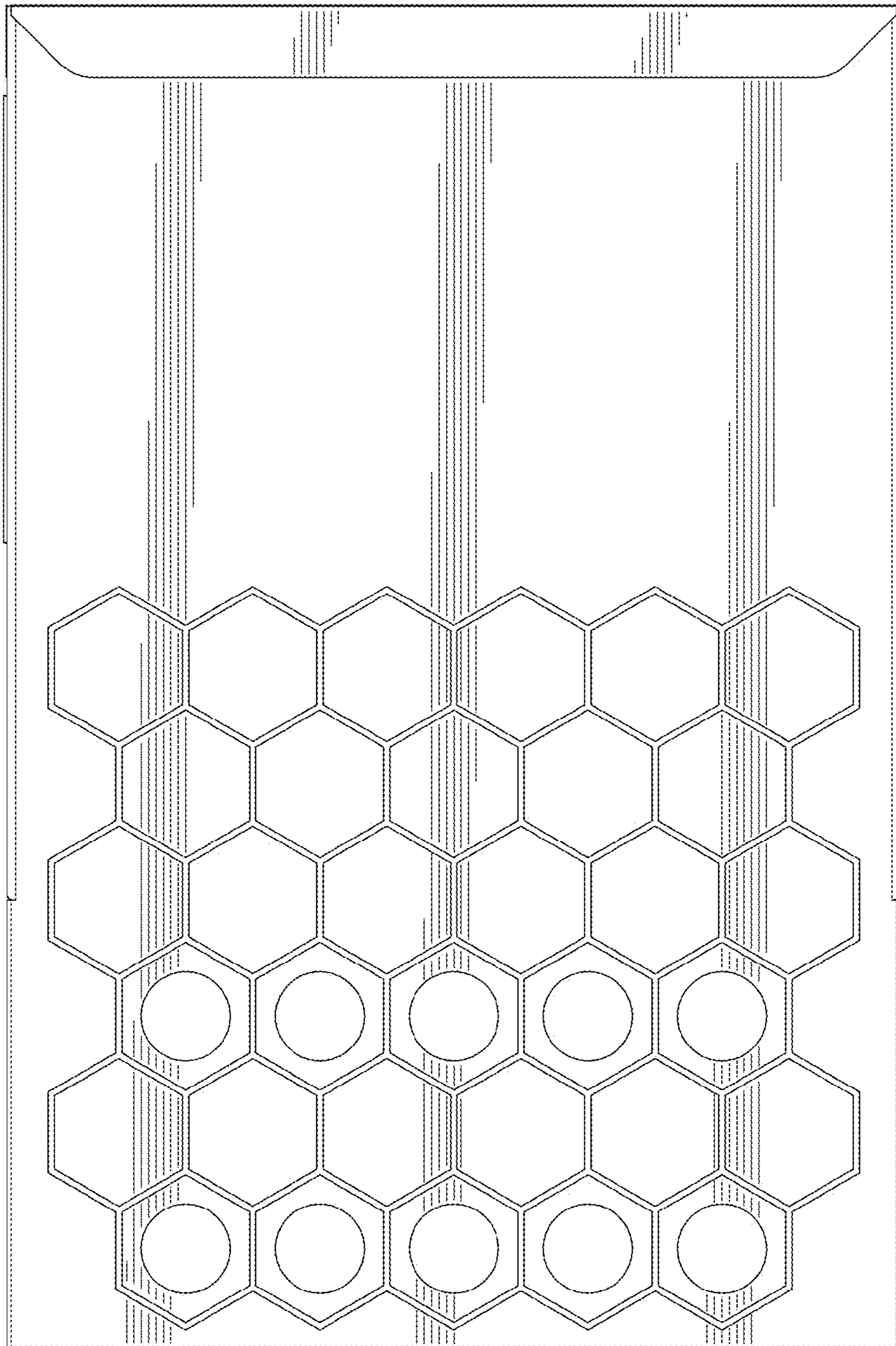

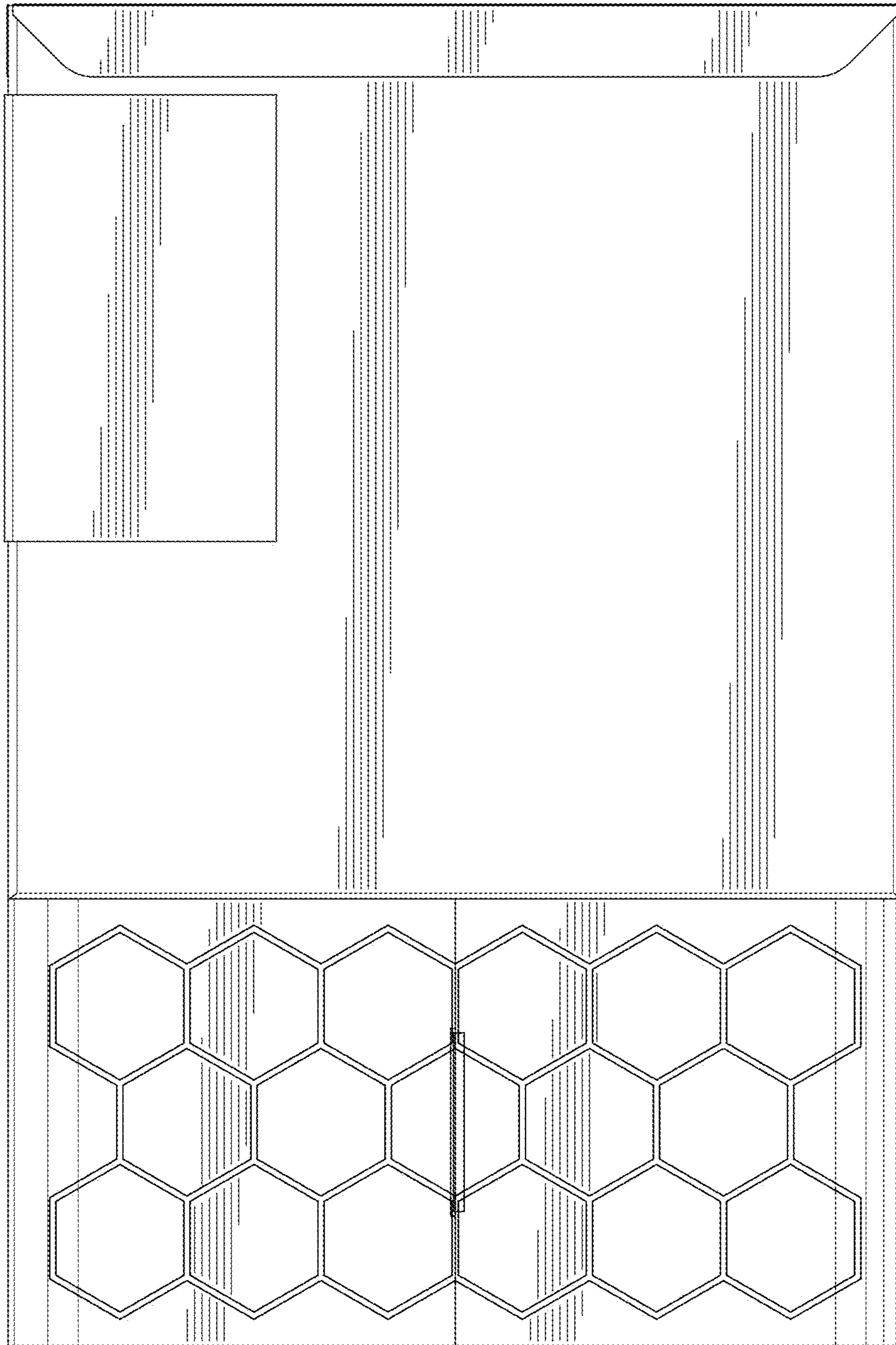

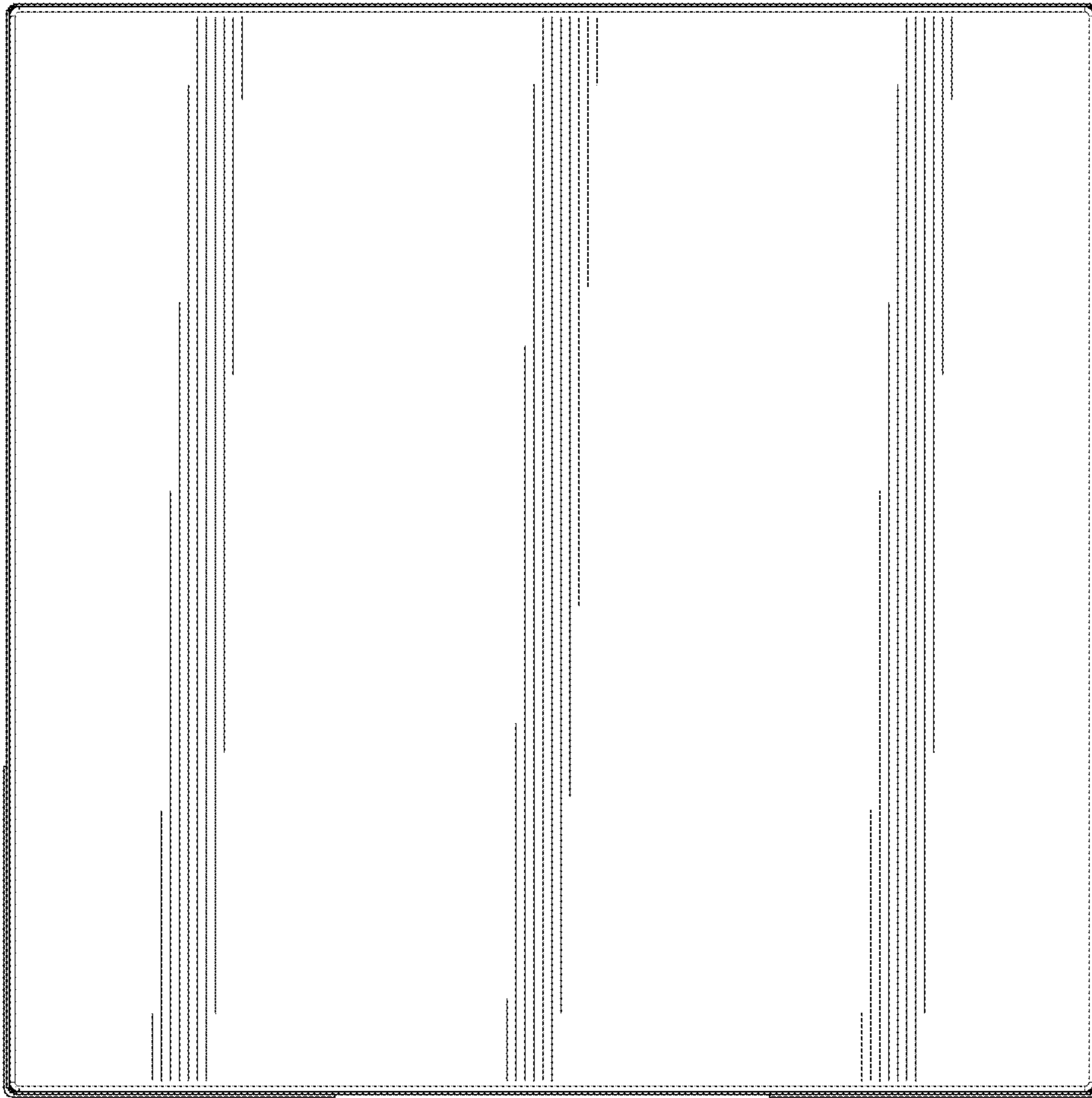

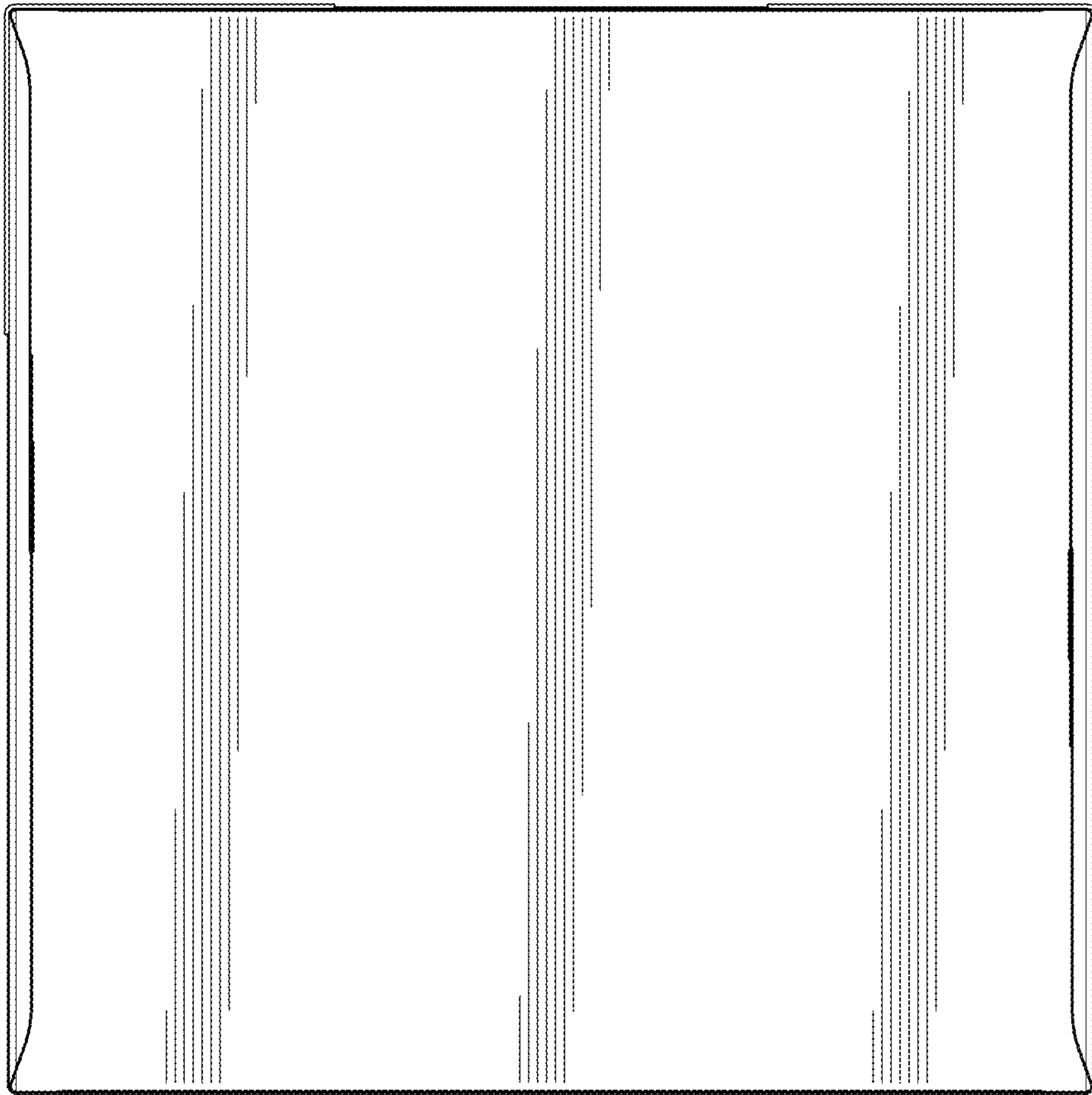
