**DESCRIPTION**

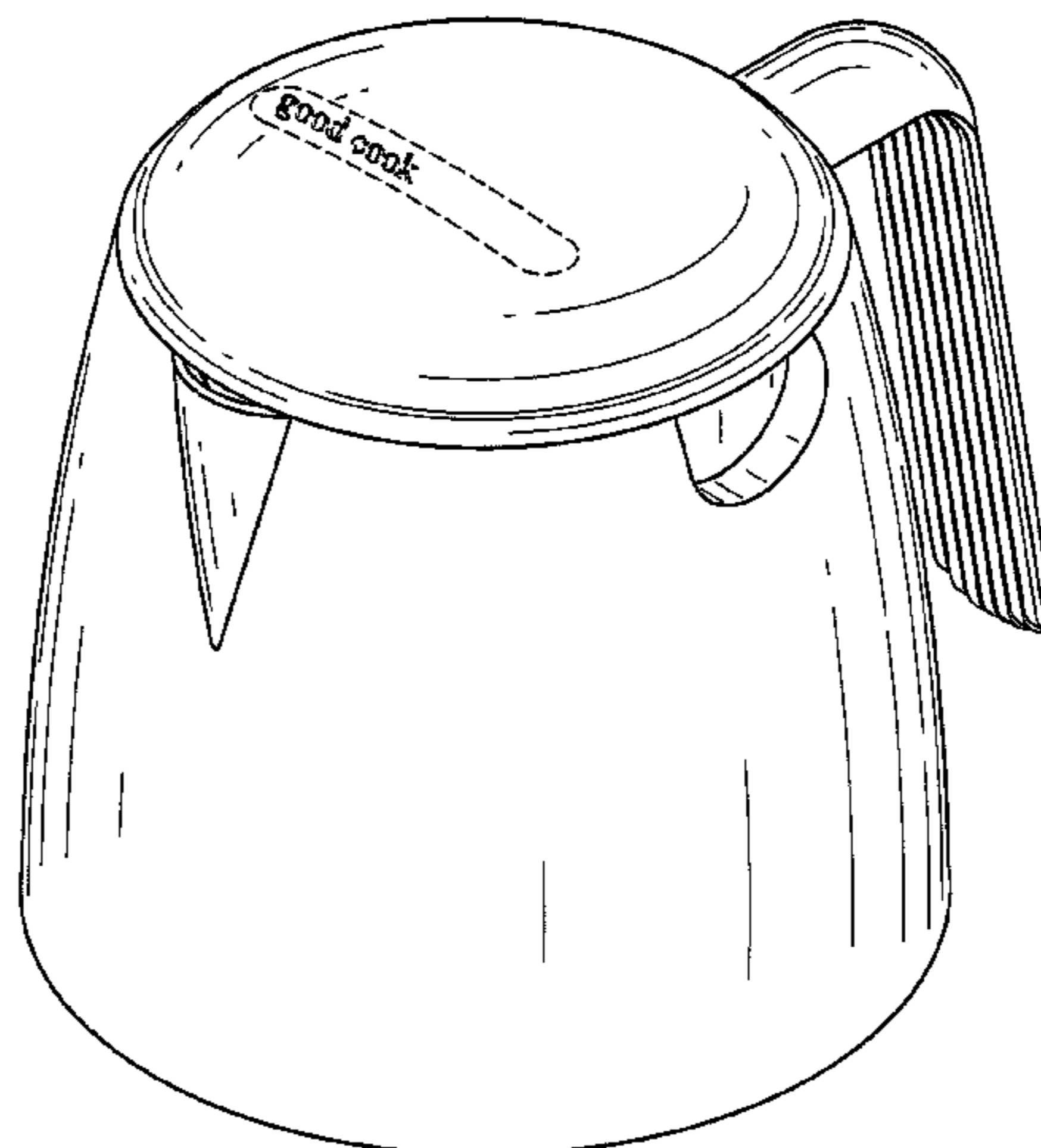
FIG. 1 is a top perspective view of the instant noodle holder, shown without a cover for ease of illustration;

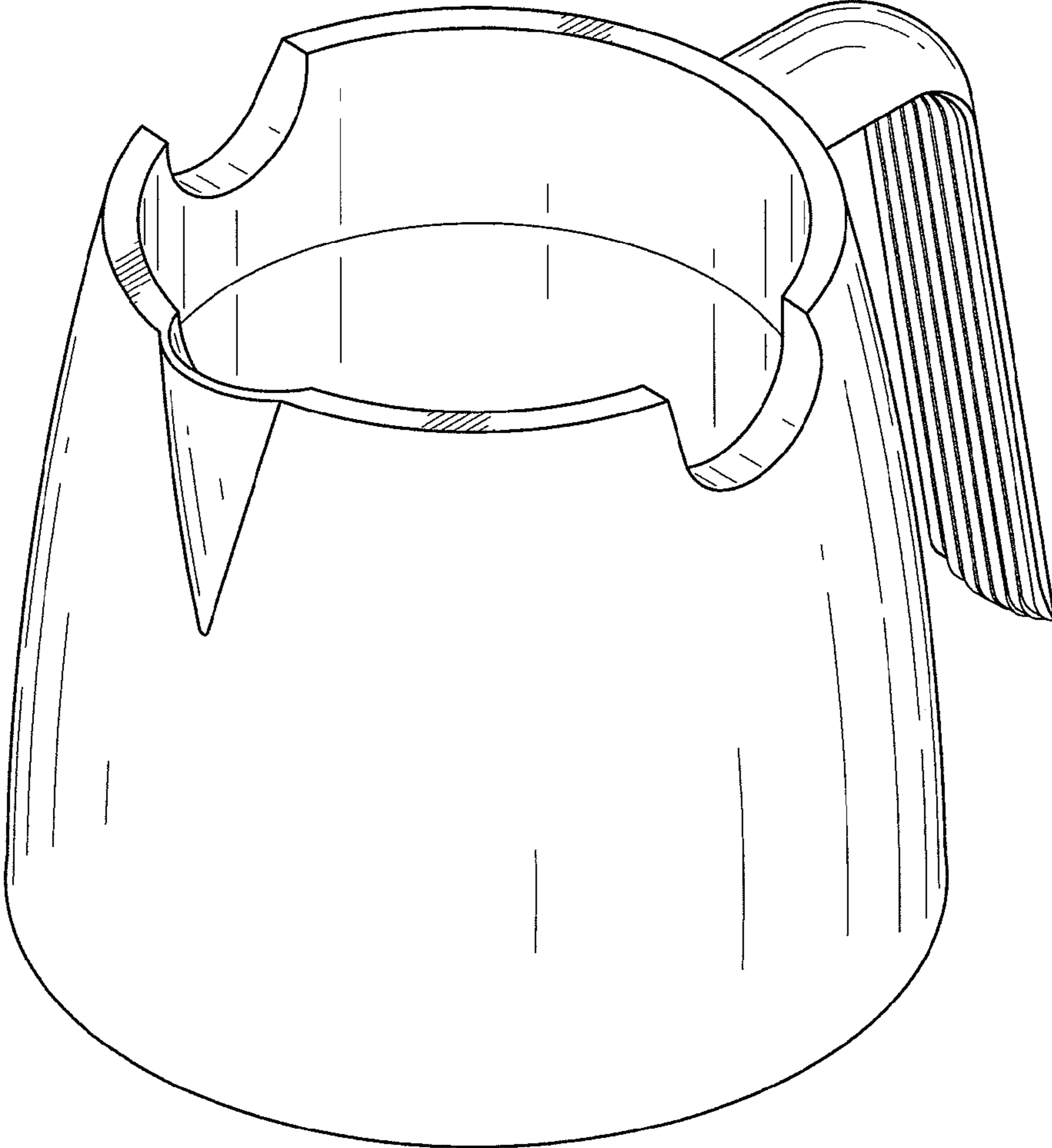

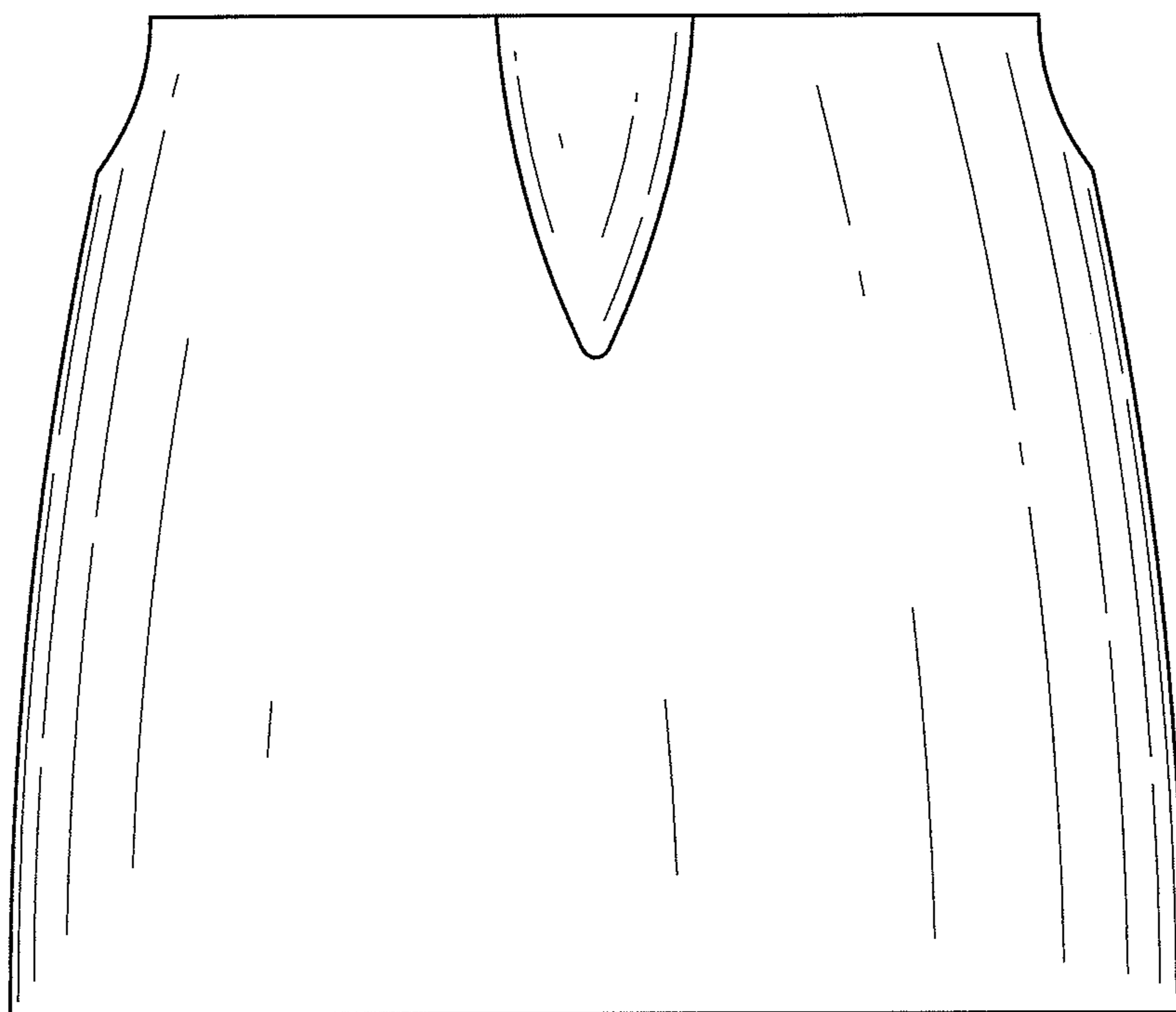

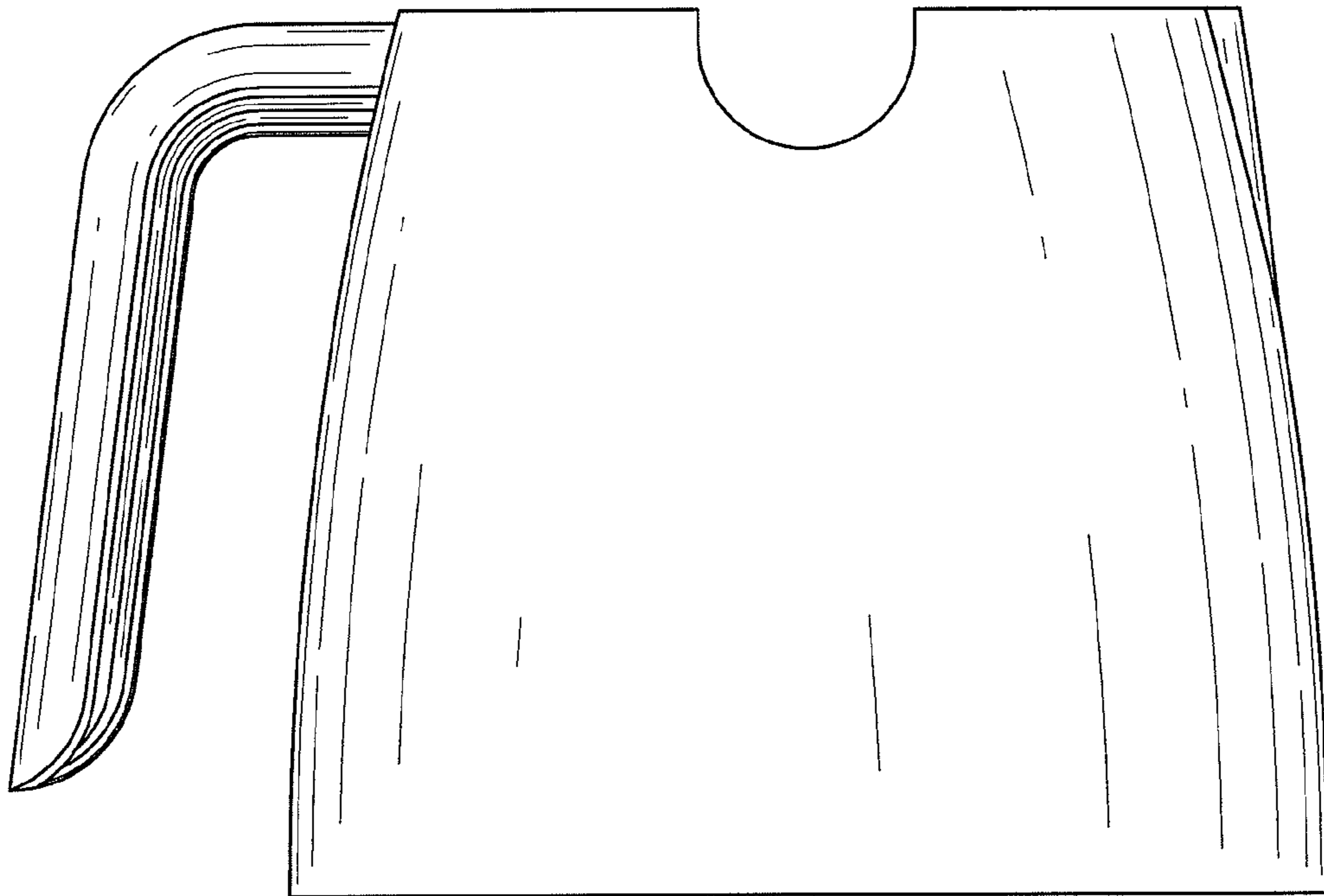

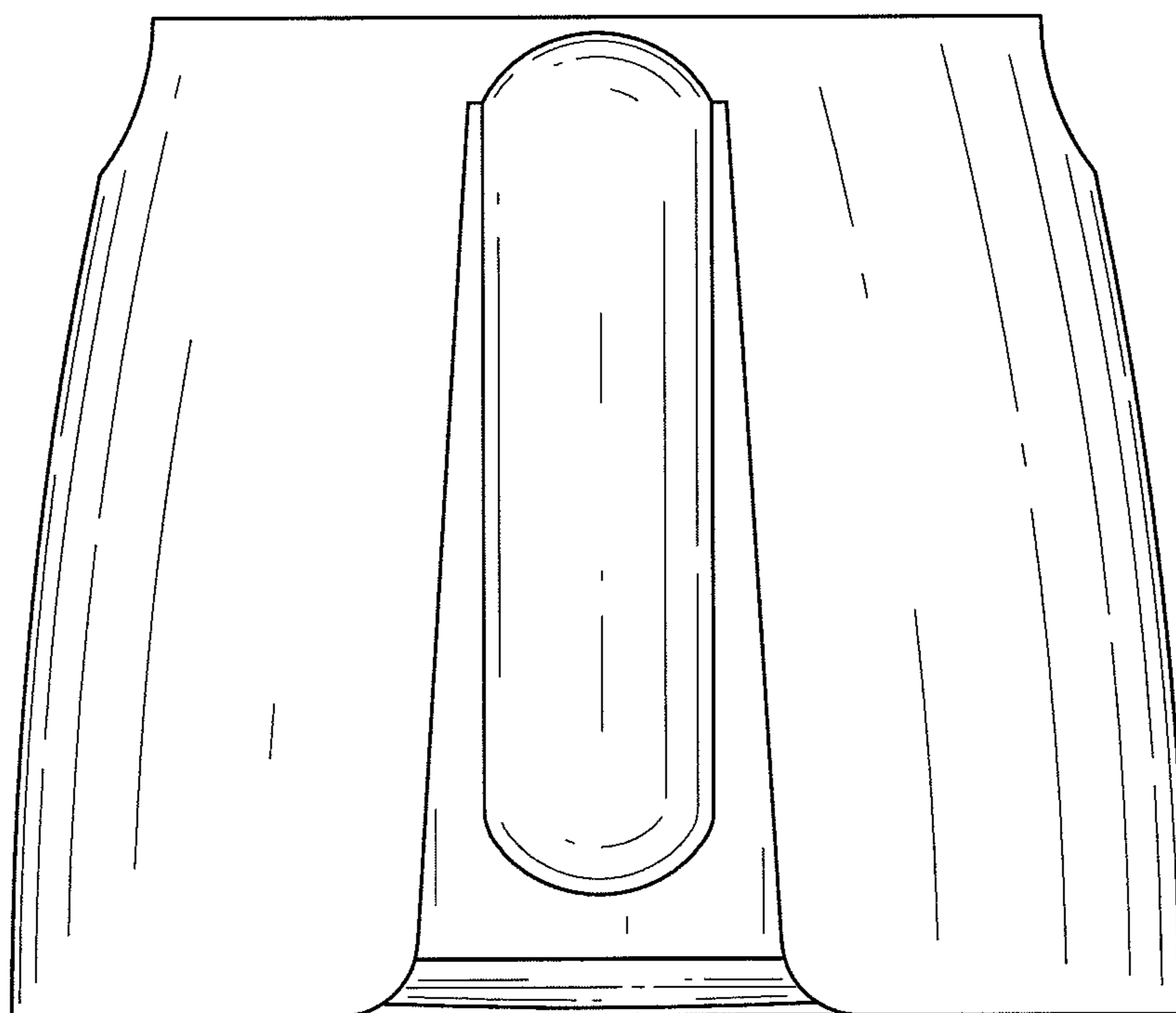

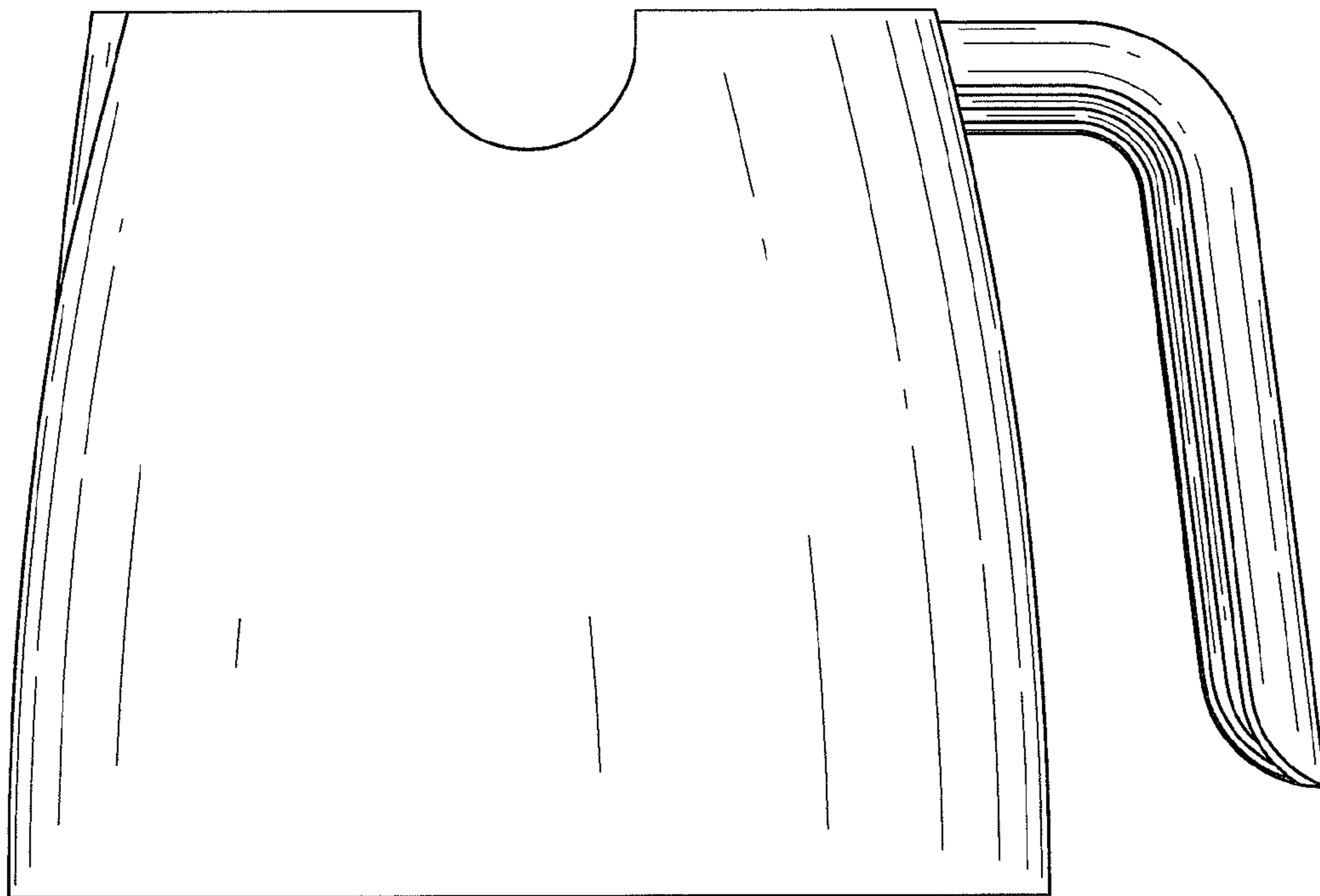

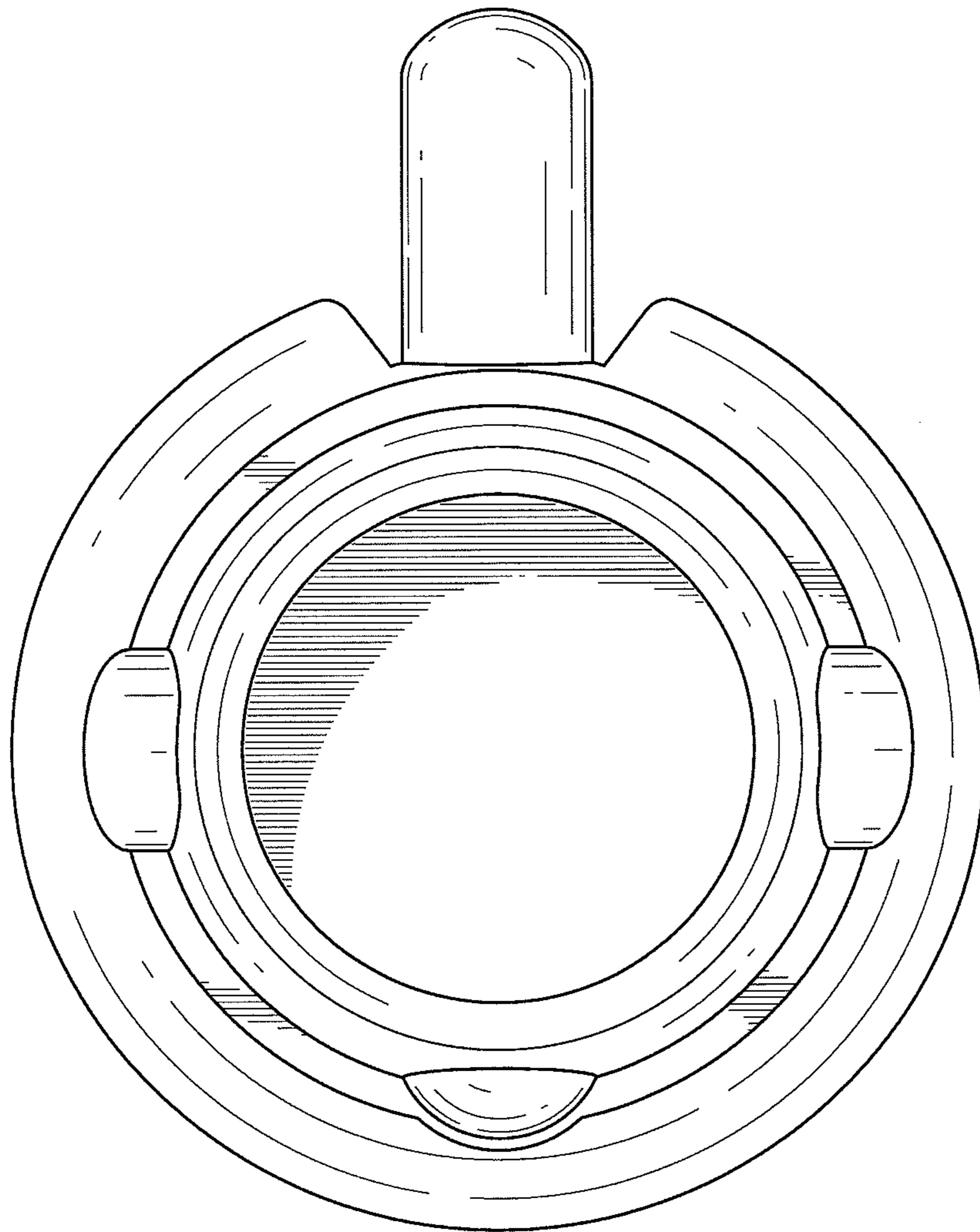

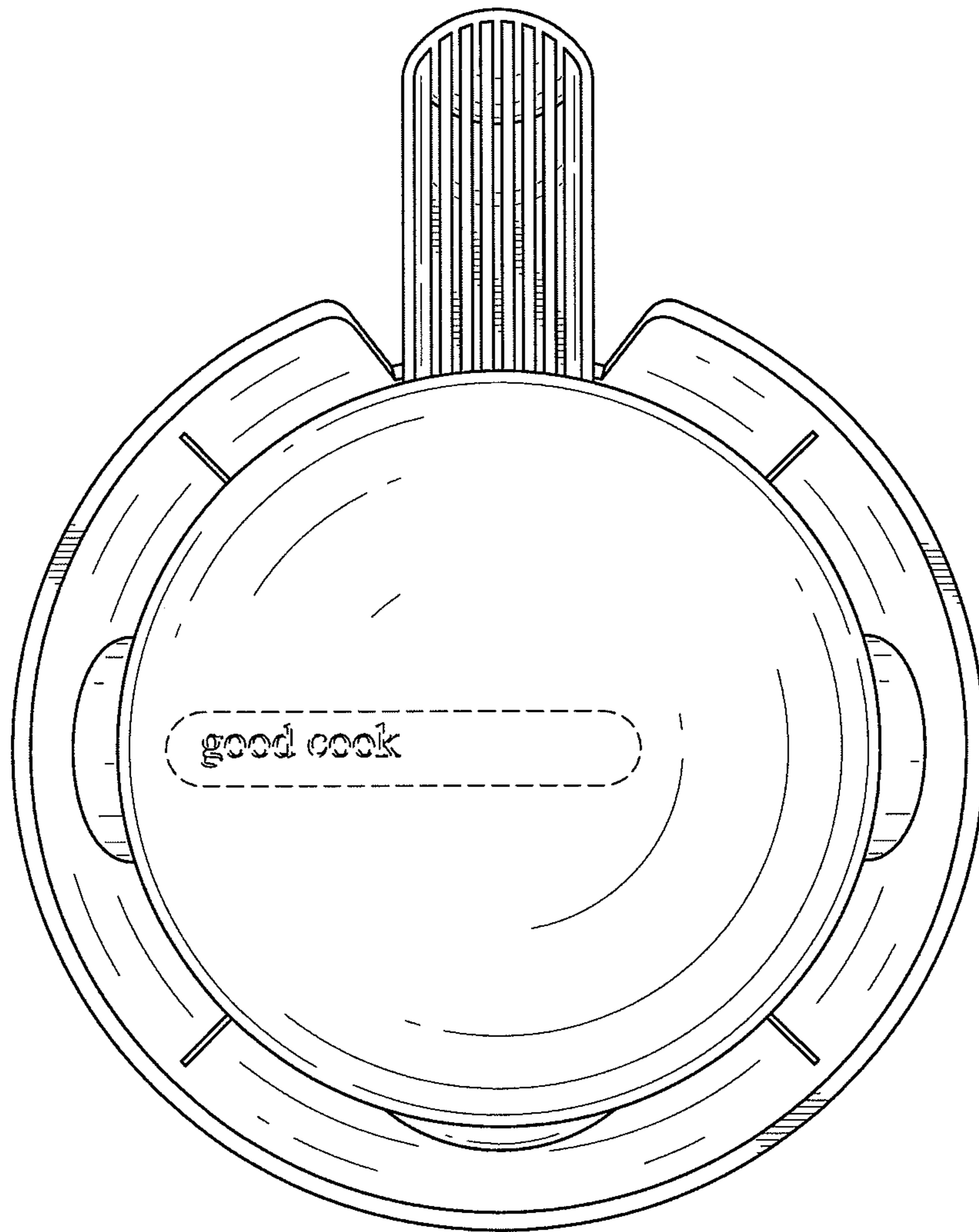

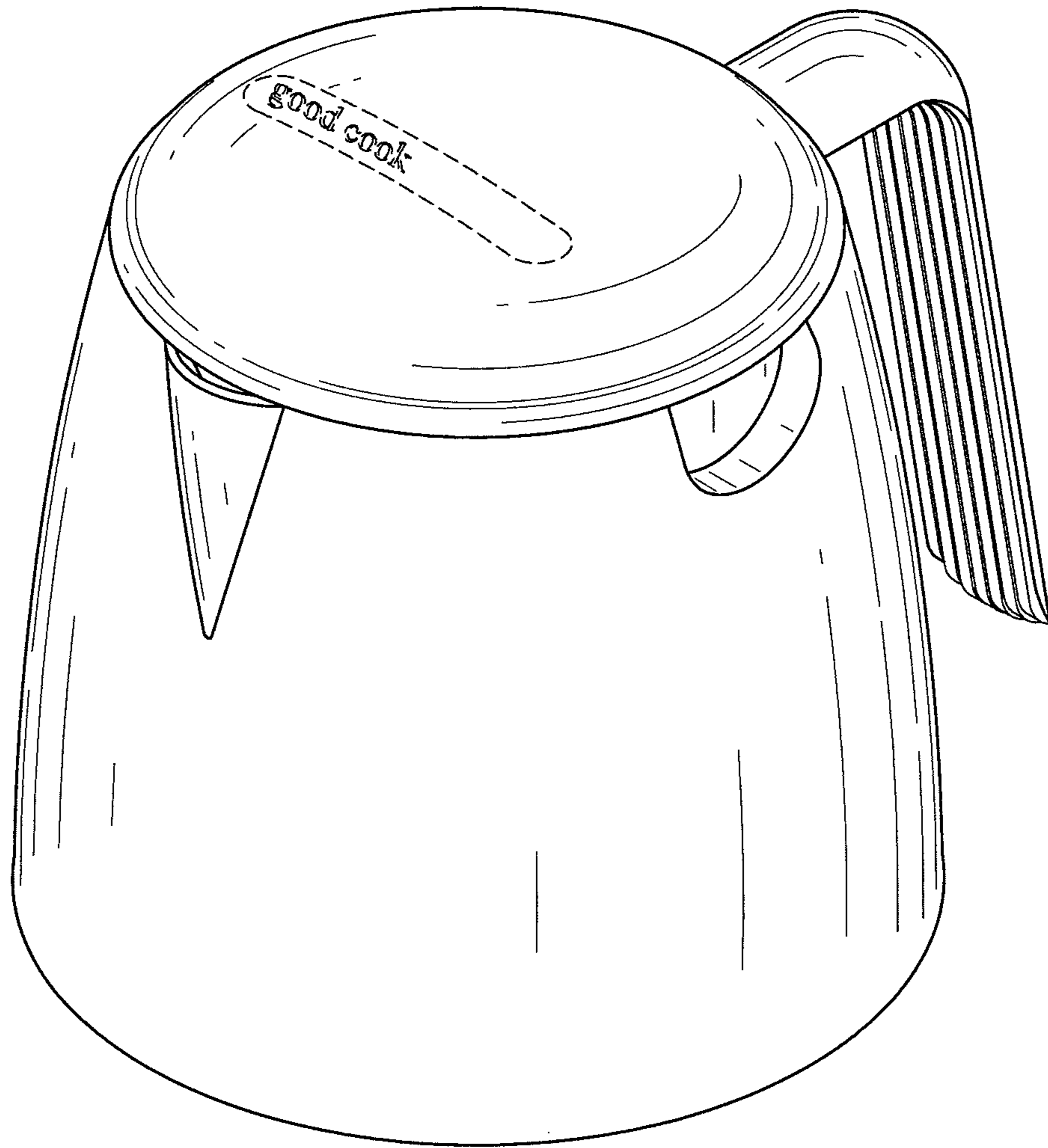
